E ects of inter-site C oulom b interactions on ferrom agnetism : Application to Fe, C o and N i

We reanalyze the condition for metallic ferrom agnetism in the framework of the tight-binding approximation and investigate the consequences of the inter-site C oulomb interactions using the Hartree-Fock approximation. We not consider a non-degenerate s band and we show that the inter-site interactions modify the occurrence of ferrom agnetism, and we derive a generalized Stoner criterion. We analyze the main elects due to the renormalization of the hopping integrals by the inter-site C oulomb interactions. These elects are strongly dependent on the relative values of the inter-site electron-electron interactions and on the shape of the density of states as illustrated by a study of cubic crystals from which we establish general trends. We then investigate a realistic spd tight-binding model, including intra (C oulomb and exchange) and inter-site charge-charge C oulomb integrals. This model is used to study the electronic structure (band structure, densities of states, m agnetic moment) of bulk ferrom agnetic 3d transition metals Fe (bcc), C o (hcp and fcc) and N i (fcc). An excellent agreement with local spin density functional calculations is obtained for the three metals, in particular concerning the relative widths of the majority and minority spin bands. Thus our tight-binding Hartree-Fock model provides a consistent interpretation of this elect.

I. IN TRODUCTION

The origin of ferrom agnetism in itinerant systems remains one of the open questions in the condensed matter theory. Even though spin-density functional theory gives correctly several predictions concerning the stability of ferrom agnetism,¹ it is interesting to develop sim ple models which point out the important physical parameters governing the ferrom agnetic instabilities. Ferrom agnetism may occur in two ways: either the param agnetic (PM) state gets unstable against the ferrom agnetic (FM) state for particular values of param eters (so-called Stoner instability), or the strongly polarized FM state, in most cases saturated ferrom agnetic (SF) state, has the lowest energy beyond some values of electron-electron interactions, but the PM state is still locally stable in a range of param eters.

It is certainly instructive to understand rst the possible mechanisms of ferrom agnetism in the case of a narrow s band studied in the tight-binding model using the Hartree-Fock approximation (HFA). When only the onsite matrix element U of the Coulomb interaction are taken into account the Stoner instability occurs when U satis es the well known Stoner criterion UN (E_F) > 1, where N (E_F) is the density of states at the Ferm i level per spin, and the majority and minority spin bands are rigidly shifted relative to each other. The in uence of the two-site matrix elements of the Coulomb interaction has

been thoroughly studied in the pioneering work by H irsch et al. already over a decade ago.^{2,3} These ideas were further developed and qualitatively new e ects were found, both within the HFA, and by going beyond it. 4,5,6,7,8 In particular, H irsch et $al^{2,3,4,5}$ have pointed out that the renorm alization of the hopping integrals resulting from the Hartree-Fock decoupling of the two-body inter-site term of the ham iltonian plays a role in the occurrence of ferrom agnetism by changing the bandwidths of majority and minority spin bands in a di erent way, thus modifying the Stoner condition. However, H insch et al.^{2,3,4,5} have mainly emphasized the e ect of exchange integrals and have only considered a constant density of states or that of a linear chain. Indeed, the non-degenerate m odel with exchange interactions was proposed to provide explanation of certain it inerant systems, such as EuB₆.⁹ O by jously, the conclusions that can be drawn from such a model depend critically on the num erical values of the parameters and we expect the classical charge-charge inter-site Coulomb interaction V to be larger than the exchange one. Consequently, we have found interesting to revisit thism odel by considering more realistic relative values of the Coulom b m atrix elements st in the case of a constant density of states, then for the densities of states of real cubic lattices. W e will see that in this last case the physics of FM instabilities is signi cantly modi ed. Therefore a quantitative study of the in uence of inter-site Coulomb interactions in FM transition metals

needs an accurate description of the density of states and realistic interaction parameters.

However ferrom agnetism is found usually in systems with degenerate orbitals and since the early work of Hubbard¹⁰ a variety of theoretical attempts have been undertaken to understand to what extent the orbital degeneracy might play an essential role in particular in the ferrom agnetism of Fe, Co and Ni. The dom inating point of view at present is that the degeneracy of d orbitals is crucial,^{11,12,13} since local m om ents can form ¹⁴ and survive above the Curie tem perature due to intra-atom ic exchange integrals. Here we will investigate the e ect of on-site and inter-site interactions in degenerate spd bands, considering realistic parameters. It is clear that the most important matrix elements of the Coulomb interaction involved in FM instabilities contain four d orbitals centered on at most two neighboring sites. The relative values of the matrix elements can be inferred from the results of explicit calculations using atom ic wave functions. From these calculations¹⁵ it turns out that the largest on-site matrix elements are those introduced already in our previous paper,¹⁶ while the only non negligible inter-site C oulom b interactions are of electrostatic (i.e., charge-charge) type, arising from the interaction between two electrons in orbitals centered at two neighboring sites. As for an s band, the Hartree-Fock decoupling of these latter term s renorm alizes the hopping integrals and we will show that they are responsible for the di erent d bandwidths for up and down spins which are obtained in local spin density functional calculations for the 3d FM elements (Fe, Co, Ni). Furthermore, the nearest neighbor distances being very close for the three m etals, it is expected that the nearest neighbor Coulom b interactions should not vary signi cantly from Fe to Co and N i. It will be seen that, under this assumption, an excellent agreem ent is found between local spin density and our tight-binding Hartree-Fock (TBHF) calculations for the band structure, the densities of states, as well as the m agnetic m om ent of the three elem ents.

The paper is organized as follows. We recall (Sec. II) the s band (extended Hubbard Hartree-Fock) model in which all interactions are limited to st nearest neighbors and derive an analytic generalized Stoner criterion. including electrostatic as well as exchange interactions. Then we revisit the simple model of a constant density of states which can be solved analytically 2,4,5 and we show that the onset of the Stoner instability and the condition of occurrence of saturated ferrom agnetism are strongly dependent on the ratio of the two-site electrostatic interaction and exchange interaction. Finally, in order to illustrate the role of the shape of the density of states, we consider the case of three-dimensional lattices: sim ple (sc), body centered (bcc) and face centered (fcc) cubic lattice for reasonable param eters, with particular em phasis on the role played by inter-site C oulom b interactions. In Sec. III, the multi-band spd TBHF model, already described by Barreteau et al.,¹⁶ is extended by including the electrostatic inter-site C oulom b m atrix elem ents, and

the determ ination of the parameters is discussed. This model is nally used in Sec. IV to analyze the band structures of FM transition metals: Fe, Co and Ni. We will show that the main elects which can be understood for the s band using some analytic arguments apply also qualitatively to 3d transition metals. The paper is concluded in Sec. V.

A. The tight-binding Hartree-Fock model

W e start from a tight-binding model for an s band and assume that the set of atom ic (s) orbitals $_{i}$ (r) centered at each site i is orthogonal. W e consider the same H am iltonian as H irsch⁵ with inter-site interactions limited to rst nearest neighbors which, in the second quantization form alism, can be written:

where a_i^{γ} is the creation operator of an electron with spin

in the atom ic orbital centered at site i, $n_i = a_i^y a_i$, and t is the hopping integral between nearest neighbors. The C oulom b interactions are described by the leading on-site term / U, and by the two-site term s: charge-charge interactions / V, exchange interactions / J, and the 'pair hopping' term / J^0 ,

W e will consider in m ost cases the realistic relation $J = J^0$, as obtained for realwave functions from Eqs. (4) and (5).

In the HFA the two-body term s are decoupled in the following way:

where the indices denote an atom ic spin-orbital. Note also that the spin conservation implies that any average $ha^{y}a$ i vanishes when and have di erent spins.

Consequently the HFA leads to a one-particle Ham iltonian:

 E_{dc} stands for the double counting energy term s and z is the number of nearest neighbors. Here we assume that the system consists of equivalent atom s, then the occupation numbers: $n = h_{i} p_{j}$ for electrons of spin and the total band lling n = n are the same at each site i. In this model $I = h_{i}^{y} a_{j}$ i do not depend on the bond and can be easily obtained from the density of states (per atom) N (E). Indeed, choosing the origin of energies at the center of gravity of N (E), it follows from Eq. (7) that:

where E_n are the eigenenergies for spin . Note that I = I(n) since the renorm alization of the hopping integrals leads to a simple energy rescaling of the density of states without changing its shape.

B. Generalized Stoner criterion and condition for saturated ferrom agnetism

The magnetic energy as a function of the magnetic moment $m = n_{\pi} \quad n_{\#}$:

where hH_s^{HF} (m)i is the Hartree-Fock energy of a state with m agnetic momentm, is easily expressed in terms of the function I. Let us introduce the following notations:

where I_0 refers to the PM state, i.e., $I_0 = I(n=2)$.

Let us st derive the condition under which the PM state becomes unstable (Stoner instability). This instability is obtained from the Taylor expansion of I for small magnetization m. Substituting this expansion for I_{*} and $I_{\#}$ into (13) one nds to second order in m:

where I_0^0 and I_0^{00} are the stand second derivatives of I at n = n=2. The Stoner instability occurs when the coe cient of m^2 is negative, i.e.,

>From Eq. (8) it is seen that the term between brackets is the hopping integral t_{PM} in the PM state. Using now Eq. (10) it can be shown, with obvious notations, that:

where $N_{PM} (E_F^{PM})$ is the density of states per spin in the PM state at the Ferm i level E_F^{PM} . Note that in these equations the energies must be referred to the center of gravity of the band. The inequality (15) can be now rew ritten as a generalized Stoner criterion:

This generalizes the criterion derived by H irsch (Eq. (22)) in Ref. 5] for the particular case of a constant density of states. A coordingly the in uence of the inter-site exchange integral J is to act in favor of the FM state for any band lling since it increases $U_{\rm eff}$ and decreases the bandwidth of the PM state [see Eq. (8)]. Let us now exam ine the e ect of V and J^0 . At low and high band

llings the renorm alization of the hopping integral in the PM state tends to zero since I_0 vanishes. As a consequence, due to the term proportional to $V + J^0$ in U_{eff} the PM state is more easily destabilized for low values of n since, in this case, the ratio $(E_F^{\rm PM} = zt_{\rm PM})^2$ is close to unity, the bottom of the band being at $E = zt_{\rm PM}$. This is also true when n approaches n = 2 for sim ple and body centered cubic lattices and this tendency is weakened for the face centered cubic lattice since $(E_F^{\rm PM} = zt_{\rm PM})^2 = 1=9$. A round half lling $E_F^{\rm PM}$ is small so that U_{eff} ' U + zJ and for realistic values of V (i.e., $V > 2J + J^0$) the PM band is broadened. M oreover its width, like I_0 , is there

at its maximum and increases with V. Consequently, the PM state is less easily destabilized around half lling.

Finally it is also interesting to derive the value of U above which the SF state with momentm $_{\rm s}$ (m $_{\rm s}$ = n when n 1, m $_{\rm s}$ = 2 n when n 1) becomes the most stable. This is done simply by looking for the minimum value of U for which the function $E_{\rm m ag}$ (m) (Eq.(13)) takes its minimum value at m $_{\rm s}$ in the domain [0;m $_{\rm s}$].

${\tt C}$. The magnetic instabilities for a constant density of states revisited

In order to obtain a physical insight into the mechanism of FM instability in the s band model (Eq. (7)), we discuss rst the case of a constant density of states (per spin, with the zero of energy at "),

Let us rst discuss the renorm alization of the hopping integrals for a more than half-led band, as in the late 3d transition m etals, in the PM phase as well as in the SF phase which becomes stable when U is large enough. It is clear that the maprity spin up band is narrow erthan the m inority spin down one and it can be shown easily that the hopping integral found in the PM phase lies always in between the ones for the maprity and m inority spins in the SF phase at least in the realistic case⁷ where V > J. W e will see in Sec. III that this holds also qualitatively for Fe, Co and N i.

The study of the stability of the PM and FM states can be done analytically for the constant density of states. For this density of states the magnetic energy (Eq.(13)) is a quadratic function of m^2 :

and W = 2zt. For a given value of n, the m inimum of $E_{m ag}$ (m) depends on the actual parameters A (n) and B. The PM state is unstable against the FM state when A (n) < 0; in the absence of inter-site interactions the well known Stoner criterion for the constant density of states, U > W is recovered. In the general case with V $\frac{6}{5}$ 0




FIG.1: Critical value of U=W (W : unrenorm alized band width) for the onset of the Stoner instability as a function of the band lling n for an s band and: (a) constant density of states, (b) sc lattice, (c) bcc lattice, and (d) fcc lattice. D i erent lines correspond to: V = J = 0 (dotted lines); V = 0:15U, J = 0 (dashed lines); V = 0:15U, J = 0:03U ($J^0 = J$) (solid lines).

and $J \notin 0$ the value of U = W above which the PM state becomes unstable depends on n, as seen in Fig. 1(a).

As shown above, the inter-site C oulom b interaction V promotes FM states for low numbers of electrons or holes, while around half lling (0.5 $^<$ n $^<$ 1.5), it tends to stabilize the PM state. The inter-site exchange matrix element J always favors the FM state since n² 2n 4 < 0 when 0 < n < 2.

If A (n) < 0 and B > 0, as considered by H irsch⁵ who assumes J > V, the PM state is unstable, and $E_{m ag}$ (m) has a minimum at m_m . If $m_m < m_s$ the most stable solution is a non-saturated FM state. In this case the condition $dE_{m ag}$ (m)=dm = 0, with $E_{m ag}$ given in Eq. (21), is equivalent to the condition of equal Fermi ienergies for the majority and minority spin sub-bands considered instead in Ref. 5. If $m_m > m_s$, the most stable solution is the SF state.

However, for realistic V and J param eters^{7,15} one has V > 3J, thus B is negative. In this condition if A (n) > 0 $E_{m ag}$ (m) has a minimum at m = 0, a maximum at m_M and vanishes at m = m₀. W hen m₀ > m_s the PM state is stable and when m₀ < m_s the SF state is the most stable solution but the PM state is m etastable. If A (n) < 0 the PM state becomes unstable while the SF state remains the most stable solution. Thus if B < 0 weak FM states are rigorously excluded and, as U=W increases, the SF state is stable before the Stoner instability of the PM state. The critical value of U=W above which the SF state becomes stable is given by:

The variation with n of this critical value is shown in




FIG. 2: Critical value of U=W (W : unrenorm alized band width) above which the SF phase becomes stable as a function of the band lling n and for: (a) constant density of states, (b) sc lattice, (c) bcc lattice, and (d) fcc lattice. The meaning of di erent lines and the parameters are the same as in Fig. 1.

Fig. 2 for the same set of parameters as in Fig. 1(a), and it can be veried that these curves are always below the corresponding ones for the Stoner instability, except at both ends where the values of U = W are the same.

D. M agnetic instabilities in cubic lattices

In the previous section we have discussed the FM instability for an s band assuming a constant density of states. However this density of states cannot be associated with any existing lattice. We now consider the case of cubic lattices: simple, body centered and face centered cubic lattices with a hopping integral lim ited to nearest neighbors. The corresponding dispersion relation is then:

where R_j (j = 1;::z) denote the set of vectors connecting an atom to its nearest neighbors. In this case the density of states, and consequently I (n), must be calculated numerically. The densities of states have been obtained from this dispersion relation by carrying out the summation over the Brillouin zone using the linear tetrahedron m ethod.¹⁷

However, in order to account accurately for the singularities of N (E) we have also used the analytical expressions given by Jelitto¹⁸ which approximate the actual densities of states with an excellent relative error (less than 10⁴). The function I (n) is derived from Eq. (10) and its derivatives I^0 (n) and I^{00} (n), which are necessary to study the Stoner instability (Eq. (15)) are determined by means of the relations (16). In the following




FIG. 3: E ective hopping integrals t (in units of t) as a function of the band lling n of an s band for: (a) boc and (b) for lattices. D i erent lines refer to: PM phase (long dashed lines), $t_{n} = t$ (full lines) and $t_{n} = t$ (dashed lines) in the SF phase (stable at su ciently large U, see Fig. 2). The parameters are: V = 0.15W (W = 16t), $J^{0} = J$, and: J = 0 (thin lines), J = 0.03W (heavy lines).

we will always assume $J = J^0$ and V > 3J.

The e ective hopping integral in the PM state \mathbf{t}_{M} has a maximum at n = 1 for the sc and bcc lattices, for which N (E) has a particle-hole sym metry, while the maximum is shifted to n ' 0:76 in the case of fcc lattice having asymmetric N (E) [see Fig. 3]. In all cases, the e ective hopping integral is reduced by J > 0. At di erent lling of spin sub-bands, as for instance in SF states, the effective up-and down-spin hopping elements and the corresponding bandwidths are di erent. For instance, for n < 1 the up-spin bandwidth increases when this subband is gradually led, has a maximum at n ' 0:38 for the fcc lattice, and then decreases back to the unrenormalized value at n = 1, while the down-spin sub-band is unrenormalized (narrowed) when J = 0 (J > 0), as shown in Fig. 3(b). The renorm alization of spin subbands is interchanged for n > 1 when the up-spin subband is lled and thus weakly narrowed in the SF states.

To illustrate the general trends we have determ ined the Stoner instabilities for sc, bcc, and fcc lattices using Eq. (15), and for three sets of parameters: (i) V = J = 0, (ii) V = 0.15U, J = 0, and (iii) V = 0.15U, J = 0.03U. The results are given in Fig. 1 and are in perfect agreement with the qualitative predictions derived above (see Sec. IIB). Indeed, V tends to stabilize the FM state for low and high band llings, while the reverse is found around half-lling. M oreover, when J is taken into account, it




FIG.4: M agnetic energy E_{mag} (in units of the unrenormalized band width W) as a function of the magnetic moment m for a fcc lattice with an s band for two band llings (a) n = 0:9 (b) n = 1:4 and increasing values of U=W. The other parameters are V = 0:15U, J = $J^0 = 0$. The inset shows the case n = 1:4, U=W = 0:418 with an enlarged energy scale, proving that the PM state is metastable.

acts in favor of FM states for any band lling. This result con rm the earlier ndings of H irsch².' 5

The regions of stability of the SF phase are shown in Fig. 2. W hen n approaches 0 or 2 the curves of Figs. 1 and 2 corresponding to the same values of V and J becom e closer and closer to each other since the magnetic moment is in nitesimal in both limits and the second order expansion of I is valid for any value of m ms. Furtherm ore, it is found that for all lattices and band 11ings, except for the fcc lattice with n > 1:3, the Stoner instability is found for a sm aller value of U = W than that needed to stabilize the SF state. This means that, contrary to the case of the constant density of states, the PM state is never m etastable except for the fcc lattice with n > 13 where a very narrow domain of metastability exists. This is illustrated for the fcc lattice in Fig. 4 where we have plotted E_{mag} (m) for several values of U=W (V = 0:15U, J = $J^0 = 0$) and two values of the band lling: n = 0.9 and 1.4. It is clearly seen that, when n = 0:9, as U = W increases the most stable phase is successively the PM, unsaturated FM and SF phase while, when n = 1:4, the PM phase is immediately followed by the SF phase but there is a narrow range of U=W where the PM phase is metastable.




FIG. 5: Critical value of U=W (W : unrenorm alized band width) for the onset of the Stoner instability in a boc lattice with an s band as a function of the band lling n for increasing values of V=U (0: full line, 0.35: dashed line, 0.55: dotted line) and $J = J^0 = 0$.

It is important to realize that the above results were derived using a rather small value of V=U and, consequently, the e ect of V is also small. However, it increases rapidly with V as shown in Fig. 5 for the Stoner instability in the fcc lattice. Note that the onset of the Stoner instability is independent of V for two band llings since, as seen in Eq. (14), E_{mag} does not depend on V when $I_{0}^{0} + I_0 I_{0}^{0} = 0$.

Finally, we must emphasize that all our results discussed so far have been obtained assuming interactions limited to rst nearest neighbors. When hopping integrals between farther neighbors are taken into account, the study of the in uence of interatom ic C oulom b inte-

grals on the electronic structure becomes more involved. Indeed, whereas in the rst nearest neighbor case the I function in Eq. (8) can be calculated once for all since the density of states N (E) scales with the hopping integral without changing its shape, this is no longer true when farther neighbor interactions are included and the solution of the problem becomes more tricky. Thus we have carried it out only in the study of the realistic valence spd band of transition metals presented in the next section.

III. FERROMAGNETISM FOR HYBRIDIZED spd BANDS

In the previous section we presented the e ect of interatom ic C oulom b interactions on the electronic structure and their in uence on the onset of ferrom agnetism in a tight-binding s band with interactions limited to rst nearest neighbors. From this study we can draw several conclusions. First, the relative num erical values of the param eters are critical to determ ine the FM instabilities. Then the shape of the density of states has also a strong in uence. Thus in order to derive reliable conclusions for FM transition m etals we m ust now generalize this m odel to hybridized s, p and d bands with farther interactions as well as realistic C oulom b m atrix elements.

A. The Ham iltonian

In the basis of reals; p, and d atom ic orbitals (denoted by and indices) the H am iltonian is determined by the bare atom ic levels ", the bare hopping integrals $t_{i,j}$, and by the matrix elements of the C oulom b interaction. In the following we keep the most in portant of these lat-

ter term swhich can be selected by com paring the num erical values of all the C oulom b m atrix elements obtained using explicit expressions of the s;p, and d atom ic orbitals. From these calculations,¹⁵ it turns out that the leading intra-atom ic C oulom b m atrix elements are:

i.e., the intra-atom ic Coulomb and exchange integrals involving two orbitals that we already introduced in a previous paper.¹⁶ These parameters satisfy an important relation for any pair of orbitals with the same orbital quantum number 1:

N ote also that all U elem ents are equal for orbitals with the same l. In what follow swe consider six C oulom b integrals: U_{ss} , U_{sp} , U_{sd} , U_{pp^0} , U_{pd} , U_{dd^0} , and ve exchange integrals: J_{sp} , J_{sd} , J_{pp^0} , J_{pd} , J_{dd^0} , with $p^0 \notin p$ and $d^0 \notin d$, i.e., we have taken the average value of som e sets of C oulom b integrals; for instance, U_{dd^0} is the average of all C oulom b integrals involving two di erent d orbitals. The corresponding values of U_{pp} and U_{dd} are determ ined from Eq. (28).

The most important Coulomb interatom ic interactions are:

i.e.,the electrostatic inter-site interactions. From atom ic orbital calculations,¹⁵ it is found that their bare value (before screening) is almost independent of the considered pair of orbitals and close to $e^2 = R_{ij}$, R_{ij} being the spacing between atom s i and j, so that we can approximate them by:

where R_0 is a reference distance which is chosen to be the $\,$ rst nearest neighbor bulk equilibrium spacing, V_0 is a parameter to be determ ined in order to take screening e ects into account, and R_c a cut-o distance. We must stress that in this calculation the other two-site matrix elements involving fourd orbitals (which are them ost in - portant in this problem), and in particular the exchange integrals, are at least two orders of magnitude smaller than $V_{\rm ii}$.

The spd band Ham iltonian is then written as follows,

 a_i^y and a_i are the creation and annihilation operators of an electron in the spin-orbital ji $i; n_i$ is the corresponding occupation number operator. The above multi-band Hubbard Ham iltonian can be solved in the fram ework of the HFA (Eq. (6)) which leads to a one particle TBHF Ham iltonian:

which is the direct generalization of Eq. (7) except for the appearance of new terms $h_{i \ ;i}$; , i.e., on-site but interorbital hopping integrals. The latter terms vanish in the bulk for cubic symmetry, and also in hexagonal symmetry except for smallsp contributions. They should be taken into account when the symmetry is reduced.¹⁹ The renorm alized matrix elements are given by:

N ote that there is a renorm alization of on-site levels due to the charge interaction V_{ij} , but in an hom ogeneous system where each site has the same charge $lm_j i = n$, it simply produces a rigid shift of the levels and can therefore be ignored for bulk calculations. A ctually the most important e ect of V_{ij} is the renorm alization of hopping integrals, and thus of the bandwidth, which is di erent for up and down spins in the FM case.

B. The param etrization of the TBHF H am iltonian

In order to perform realistic calculations for the FM 3d transition metals, we combined the tight-binding approach of Mehl and Papaconstantopoulos²⁰ for the PM state with corrections originating from the electronelectron interactions in the FM states. At this point, it is important to note that for any bulk geometrical con guration the HF renorm alization of the energy levels and of the hopping integrals in the PM state are implicitly included in the parameters of Mehl and Papaconstantopoulos.²⁰ Indeed, these parameters have been tted on electronic structure calculations carried out in the density functional form alism. It is therefore convenient to take the PM state as a reference. The H am iltonian H can then be written in the following way:

where H_0 is the PM H am iltonian parametrized in Ref. 20 and H is the perturbation due to the onset of ferrom agnetism. M ore details can be found in Ref. 16. Finally,

 E_{dc} is the variation of double counting term s between the FM and PM states. Note that this parametrizatiom assumes a non-orthogonal basis set. Consequently $n = hn_j i$ is the net population at site j and not the band

lling which is given by the gross atom ic population as de ned in Ref. 21. However, it is this latter population which should be used to calculate the magnetic moment per atom .

The Coulomb (U) and exchange (J) integrals have been determined from their atomic values and then reduced by appropriate screening factors as explained in Ref. 16. It is at present not possible to get a well controlled procedure which would describe the screening of the atom ic interactions when atom s build a crystal. Therefore, we introduce two multiplicative screening factors, U and J, operating on the U and J atom ic values, respectively. It is known that Coulomb interactions are strongly screened, while exchange interactions remain almost unscreened.²² This is the reason why we have kept the same value of $_J$ ($_J$ = 0:70) as in Ref. 16. Let us now discuss the values of $\ _U$ and $V_0\,.$ From Sec. II it is clear that the interaction V_{ij} modi es the onset of ferrom agnetism and, consequently, $_{\rm U}$ and V_0 should be determined in a correlated way. In addition these param eters should not vary signi cantly between Fe, Co and Niwhich have alm ost the same interatom ic spacing. We will see in Sec. IV that the values $_{\rm U}$ = 0:12 and $V_0 = 0.5 \text{eV}$ lead to bulk spin magnetic moments close to the experim ental values and to bulk electronic structures (in particular bandwidths and splitting of the two spin sub-bands) in good agreem ent with local spin density calculations for the three ferrom agnetic 3d elem ents. Note that the resulting values of U and J are sm all (see Table I) as usual in the HFA to simulate the correlation e ects and that the ratio $U_{dd}=V_0$ ' 4 seems quite reasonable.

IV. APPLICATION TO FERROMAGNETIC TRANSITION METALS

We have performed TBHF calculations on the three FM 3d transition m etals Fe(bcc), Co(hcp) and Ni(fcc) at their experimental equilibrium structure, i.e., $a_{bcc} = 2.87$




FIG. 6: Density of states as obtained for bcc Fe in the tightbinding Hartree-Fock modelw ith (solid lines, $V_0 = 0.5eV$) and without (dashed lines) Coulomb inter-site interaction, for "spin electrons (top), and #-spin electrons (bottom) in the FM ground state.

A for Fe (bcc), $a_{hcp} = 2.51 \text{ A}$, $c=a_{hcp} = 1.62 \text{ for Co}(hcp)$, and $a_{fcc} = 3.52 \text{ A}$ for N i(fcc). The cut-o radius R_c for the interatom ic C culom b interaction was chosen between second and third nearest neighbors.




FIG. 7: Variation of the magnetic moment of bcc Fe as a function of the Coulomb inter-site interaction V_0 .

A. Ferrom agnetic states of bcc Fe

As we have shown in Sec. II, the main e ect of the Coulomb inter-site interaction is to modify the width of the majority spin band with respect to the minority one. To illustrate this e ect in the case of Fe we have performed a self-consistent TBHF calculation with and without this interaction, as shown in Fig. 6. It appears very clearly that the bandwidth of the majority spin d electrons is signicantly smaller than that of the minority one when the Coulomb interaction is "switched on".

The other e ect of the C oulom b inter-site interaction is to modify the Stoner instability. In particular, it was shown in Sec. II in the analytic treatment of the s band model that V_{ij} tends to play in favor of the destabilization of the PM states for nearly led bands. Consequently we expect an increase of the magnetic moment when V_{ij} increases. This can be seen in Fig. 7, where the evolution of the magnetic moment is plotted for dierent values of V_0 ranging from 0 to 0.75 eV and xed values of U corresponding to $_{\rm U} = 0.12$. The spin magnetic moment obtained for $V_0 = 0.5$ eV is in very good agreement with the experimental results²³ (see Table II).




FIG.8: Density of states as obtained for bcc Fe in the tightbinding Hartree-Fock model (solid lines, $V_0 = 0.5 \text{ eV}$), and in the band structure calculation using the FLAPW method of Ref. 24 (dashed lines) for "-spin electrons (top), and #-spin electrons (bottom) in the FM ground state.




FIG. 9: Electronic structure as obtained for bcc Fe in the tight-binding Hartree-Fock model ($V_0 = 0.5eV$, black triangles), and in the band structure calculation using the FLAPW m ethod of R ef. 24 (solid lines) for "-spin electrons (left), and #-spin electrons (right) in the FM ground state.

Finally, in Figs. 8 and 9 we have compared the densities of states and band structures as obtained from our TBHF calculation with $V_0 = 0.5 \text{eV}$ and from an FLAPW LSDA calculation using the W EN code.²⁴ The agreement is almost perfect proving that the set of intra and inter-site C oulom b and exchange interactions that we chose, not only reproduces integrated quantities such as the m agnetic m om ent (see Table II) but is also able to describe very accurately the splitting and change of bandwidth between m a prity and m inority spins (see Table III).

B. Ferrom agnetic states of C o

W e now present our results for Co (hcp and fcc) keeping the same values for $_{\rm U}$ and V₀ as for Fe. The results of our TBHF and FLAPW LSDA calculations on hcp Co




FIG. 10: Sam e caption as in Fig. 8 but for hop Co.




FIG.11: Sam e caption as in Fig. 8, but for fcc Co.

are shown in Fig. 10, where the densities of states obtained with the twom ethods are represented. Once again the agreem ent is excellent for the magnetic moment (see Table II) and for the shape and the width of the majority and m inority spin densities of states. In particular the di erence in bandwidths between majority spin and minority spin d electrons is found to be alm ost the same as with the W IEN code (see Table III). How ever, there is a sm all quasi rigid shift of the d band for the majority spin density of states. Note that, Co being a saturated ferromagnet, this small shift has almost no in uence both on the magnetic moment and on the total energy. We have also carried out TBHF and FLAPW LSDA calculations on fcc Cowith a lattice parameter $a_{fcc} = 3:55 \text{ A}$, the densities of states are presented in Fig. 11, showing the sam e type of agreem ent between the two m ethods.

C. Ferrom agnetic states of fcc N i




FIG.12: Sam e caption as in Fig. 8, but for fcc Ni.

The same values of $_{\rm U}$ and V_0 were also used for N i. The result is extremely convincing since the magnetic moment is exactly the same with TBHF and the W IEN code (see Table II), and Fig. 12 shows an excellent agreement for the electronic structure. As for cobalt, there is a slight shift of the majority spin d sub-band without consequences on the magnetic moment and total energy since N i is also a saturated ferrom agnet, but the shape of the densities of states and the changes of the bandwidths

(Table III) are very sim ilar.

To conclude this section, the introduction of the intersite Coulomb interaction and the subsequent renorm alization of the hopping integrals in the spd TBHF m odel has enabled us to obtain an excellent overall agreem ent with calculations based on the density functional form alism for the band structure, the density of states and the magnetic moment of the three 3d FM elements. However the splitting between up and down spin bands is system atically slightly larger than in local spin density calculations. This di erence could be expected since with TBHF the self-interaction is forbidden, as it should, while it is allowed in the W EN code, as usual in the density functional theory. Indeed, if the self-interaction term is included in Eq. (33), i.e., hn; i is replaced by hni $i + hn_i$ i, the term proportional to U no m ore

contributes to the splitting between up and down spin bands.

V. CONCLUSIONS

To sum m arize, we have used a tight-binding Hartree-Fock m odel including the renorm alization of the hopping integrals due to inter-site C oulom b interactions in order m alization of the hopping integrals which originates from the inter-site C oulom b elem ents strongly m odify the conditions for ferrom agnetism . In agreement with earlier studies,^{2,3,4,5} ferrom agnetism is favored for nearly lled or empty bands by the nearest neighbor C oulom b interactions. As the actual FM instabilities are rather sensitive to the system parameters, an accurate description of the density of states and realistic interaction parameters are of crucial importance to understand the behavior of 3d transition m etals.

Next we have shown that the behavior found for the non-degenerate s band model has important consequences in realistic transition metals. We extended the model to the case of hybridized s;p and d bands and used it to investigate the electronic structure of FM Fe, C o and N i. It was found that the width of the majority spin band is always smaller than that of the minority spin one, as obtained in electronic structure calculations performed by ab initio methods. An excellent overall agreement (band structure, densities of states, magnetic moment) with the local spin density calculations is obtained for the three elements.

Finally, it has to be emphasized that this renorm alization of the hopping integrals is also present in the nonmagnetic case and is a function of the environment of the pair of atoms involved in the hopping. Here we have only considered the bulk geometry. It would be interesting to study the case of surfaces and especially of sm all clusters in which the elect of the change of environment is expected to be the strongest.
