Optical conductivity and the sum rule in the DDW state

A bstract

The density-wave with d wave order parameter (DDW) is possibly realized in the underdoped regime of high- $T_{\rm c}$ cuprates. The DDW state is characterized by two branches of low-lying electronic excitations, and the quantum mechanical current has in particular an inter-branch contribution. The latter component causes a nite-frequency response in the optical conductivity and a reduction of the D rude contribution. We show that this redistribution of the spectral weight leaves the optical sum mostly intact, so that the restricted optical sum rule is only weakly violated.

K ey words: density waves, optical conductivity, optical sum rule

Recently, the interest in charge density waves with unconventional order param eters has increased [1{3]. In particular, it has been shown that a charge density wave with d-wave symmetry (DDW) represents a stable state of the t J model in the large-N lim it in certain doping and temperature regions[2]. It thus may be intim ately related to the pseudogap phase of high-T_c superconductors[2,3]. The presence of a D D W state should also cause changes in transport coe cients[4]. In the previous paper [6] we showed that the usual expression for the Hall conductivity is modied in the DDW state, due to speci cm atrix elem ent for the current operator. In the present paper we show that this interband current is responsible for the optical response at higher energies and the reduction of the D rude contribution.

The mean-eld Hamiltonian in the DDW state is

Considering nearest and next-nearest neighbor hoppings t and t^0 and putting the lattice constant of the square lattice to unity, the electronic dispersion is k

The Ham iltonian (1) can be diagonalized [6] by a unitary transform ation U so that \hat{h} U \hat{H} U \hat{J} is diagonal and the new quasiparticle energies are

The current operator in the D D W state is de ned by di erentiating 0H =0k = 0 (U $^y\hat{h}U$)=0k . In the new quasiparticle basis it has the components

Here the velocities $v_{1\,(2)}$ correspond to the intraband current operator in the corresponding subband, $"_{1\,(2)}$. The o-diagonal current v_3 arises from the k-dependence of the unitary transform ation U , and is the matrix element of the total current operator connecting the two subbands $"_1$ and $"_2$. It corresponds to the interband transition operator—in the notation of




Fig. 1. The evolution of the shape of the optical response below the DDW transition. The function-like D rude peak is not shown here.

[5] and is needed for a proper description of the optical response.

The frequency-dependent conductivity has the form $(!) = {}^{(D)}(!) + {}^{(opt)}(!)$, where

is the D rude part of (!), written for a model with point-like impurities, and

is the optical conductivity. Here stands for the (large) scattering time, $n(x) = (e^{x-T} + 1)^{-1}$.

In rough agreem ent with [2], we modelled the gap by $_0=(T)$ (1+) (1+), where is the chemical potential, (0)=0.29t, a BCS temperature dependence is assumed for (T), and t is used as the energy unit. We show the results for the optical conductivity $_{\rm x}^{({\rm opt})}$ in Fig. (1) for $t^0=0.3$, =0.85 (doping '0.08), $T_{\rm c}=0.064$ and various temperatures.

First, the optical response is non-zero only above the threshold energy 2 $_{\rm hs}$, with $_{\rm hs}$ being the value of the gap at the so-called \hot-spots" in k space where $_{\rm k}$ ' $_{\rm k+\,Q}$ ' 0.0 ne has roughly 2 $_{\rm hs}$ 4 $_{\rm 0}$ for the above param eters. Beyond its maximum at ! 4 $_{\rm 0}$, one observes the decay $_{\rm x}^{\rm (opt)}$ / ! $^{\rm 3}$ up to energies of the order of the bandwidth . The weight associated with $_{\rm x}^{\rm (opt)}$ is j j+t as is suggested by the analysis below . R The restricted optical sum is given by the integral d! $_{\rm x}$ (!) which can be easily evaluated for the above $_{\rm (D)}^{\rm (D)}$, $_{\rm (opt)}^{\rm (opt)}$. It was shown in [6] that this sum should exhibit a deviation $_{\rm c}^{\rm 2}=E_{\rm F}$ in the DDW state. At the same time the change in the weight of the D nude peak, $_{\rm c}^{\rm 1}$ (! = 0), is a rst-ordere ect in the DDW state,




Fig. 2. The tem perature dependence of the optical sum and the D rude weight below the D D W transition at $T_{\text{c}}-0.064t$

 $_{\rm X}$ (! = 0) =E $_{\rm F}$. [6] W e illustrate these general ndings in F ig. (2). It is seen that the restricted optical sum is nearly unchanged by the form ation of the D D W gap, but that the D rude weight exhibits a signi cant variation below $T_{\rm c}$.

Our results for the optical sum dier from those in [7], because there a dierent spectrum with $t^0=0$ and a much larger value of $_0$ (T = 0) twere used.

In sum mary, we have shown that the DDW state leads to a shift of the optical spectral weight to higher energies 4 0, but to no change in the optical sum rule in leading order.
