M atrix Product Density Operators: Sim ulation of nite-T and dissipative system s.

We show how to simulate numerically both the evolution of 1D quantum system sunder dissipation as well as in them al equilibrium. The method applies to both nite and inhom ogeneous systems and it is based on two ideas: (a) a representation for density operators which extends that of matrix product states to mixed states; (b) an algorithm to approximate the evolution (in real or in aginary time) of such states which is variational (and thus optimal) in nature.

The physical understanding of quantum many {body system s is hindered by the fact that the number of param eters describing the physical states grows exponentially with the number of particles. Thus, even for a relatively sm all num ber of particles, m ost of the problem s becom e intractable. During the last decade, how ever, several num erical m ethods have been put forward which allow us to describe certain many {body systems. One such method is the so{called density matrix renormalization group (DMRG), which is very well suited to describe 1D systems on a lattice with short { range interactions and at zero tem perature [1, 2, 3]. In fact, DMRG has had a very strong in pact in the eld of condensed m atterphysics, allowing us to describe such system swith an unprecedent degree of accuracy and to extract their physical behavior.

Several years after its discovery, DM RG was extended to nite temperature 1D systems [4]. The method applies to translationally invariant in nite systems, since in that case the evaluation of the partition function can be recasted in terms of noting the maximum eigenvalue of a nite matrix, which in turn can be found using a variation of the original DM RG method to classical 2dimensional spin systems [5]. The main restriction of the method is that it does not work well for low temperatures and that it cannot be applied in situations in which the number of particles is nite and/or not hom ogeneous, as it is e.g. the case of atoms in optical lattices [6]. Recently, tim e{dependent versions of the DM RG method have been put forward [7, 8, 9, 11].

The success of the DM RG m ethod and its extensions is based on the fact that the m any {body states that appear in som e 1D problem s can be very well described in term s of the so{called m atrix product states (M PS) [12, 13, 14], i.e.,

Here, the A's are matrices whose dimension is bounded by some xed number D and d is the dimension of the Hilbert space corresponding to the physical systems. In fact, DMRG can be viewed, both for nite and in nite dimensions, as an iterative method that for a xed D determ ines the matrices whose state j mpsi minimizes the energy in a variational sense [12, 14]. On the other hand, the method introduced by G.V idal in the context of simulating the dynamics of weakly entangled quantum systems [10] and later developed in [8, 9, 11] prescribes a particular way to update the matrices A as a function of time. This method can be extended [10] to determ ine the evolution of mixed states by considering them as vectors in the d^{2N} (dimensional space of linear operators and thus doubling the number of matrices A.

In this paper, we introduce the notion of matrix product density operators (M PDO) which extend the M PS from pure to mixed states. We also present the optimalway in which the time evolution of pure and mixed states can be approximated within these two classes of states (M PS and M PDO). The corresponding evolution in in aginary time leads to a very versatile nite-T DM RG algorithm, not restricted to large temperatures or to hom ogeneous system s. We conclude by showing how dissipative system s governed by master equations can be e ciently simulated.

In [14, 15], a picture was introduced to analyze MPS and DMRG from a quantum information perspective (see Fig. 2 in [14]). The MPS (1) can be depicted as being built up by a collection of virtual D-level systems paired in maximally entangled states. The MPS is obtained by applying linear maps which transform the D² { dim ensional Hilbert space of pairs of virtual system s into the local Hilbert spaces associated to the physical system s. Thus, the MPS is completely specied by these maps which in turn can be reexpressed in terms of the matrices A of Eq. (1). A central result of this paper is that this picture can be extended to describe mixed quantum states. The idea is as follows: instead of applying a linear m ap to the Hilbert space associated to pairs of virtual system s, we apply a general completely positive map to the corresponding operator space, which is the most general map allowed by quantum mechanics [16]. W e hence de ne the class of M PDO as the states which can be obtained by this procedure. More speci cally, a M PD O of N d{level particles with $D_1; D_2;$ ΝĐ dim ensional bonds is de ned as

where M $_{k}^{s_{k},s_{k}^{0}}$ are D $_{k}^{2}$ D $_{k+1}^{2}$ m atrices that can be decomposed as

Here d_k is at most dD_kD_{k+1} , and the matrices $A_k^{s;k}$ are of size D_k D_{k+1} . Condition (3) is a semidenite constraint and is su cient to ensure that the associated map is completely positive. Relaxing this condition gives rise to operators which are not necessarily positive semidefinite (i.e., the picture introduced above also allow s one to represent general operators). Note also that for sufciently large D, Eq. (2) includes any density operator acting on the H ilbert space. For example, the maximally mixed state corresponds to the choice $M_k^{s;s^0} = s;s^01$, and a pure MPS is recovered when $M_k^{s;s^0} = A_k^s$ ($A_k^{s^0}$).

It is possible to express any M PDO in term sofa (pure) M PS by dening the latter over a larger H ilbert space, i.e. by using the concept of purication [16]. To each physical system we associate an auxiliary system (or ancilla) with a H ilbert space of dimension d_k , and after choosing an orthonorm albasis j_{k} ; a_k i for these particle ancilla pairs, we write the corresponding M PS state as

The MPDO is obtained after tracing over the ancillas, i.e. = Tr_a (j ih j). It is remarkable that for many interesting states the ancilla's dimensions can be chosen to be small (d_k ' d) and thus the puri cation (4) yields a very e cient representation of the MPDO. Note also that the ancilla matrices A_k in (4) can be easily recovered from the matrices M_k by means of an eigenvalue decom – position. On the other hand, given the matrices M_k , one can e ciently determ ine expectation values as follow s:

In order to m easure the error that we make when we approximate a density operator $_0$ by some other one , one can use di errent quantities. For instance [16], $E_F(;_0) = 1 F(;_0)$, where F extends the notion of - delity from pure to mixed states, it is de ned as them axim al overlap between all possible puri cations of and




FIG.1: Evolution of the ground (pure) state of an Ising model after switching on a small transverse magnetic eld. We plot the in delity, E = 1 , the transverse magnetic eld. We plot the in delity, E = 1 , the transverse magnetic eld. We plot the in delity, E = 1 , the transverse magnetic eld. We plot the in delity, E = 1 , the transverse magnetic eld. We plot the indelity, E = 1 , the transverse magnetic eld. We plot the indelity, E = 1 , the transverse magnetic eld. We plot the indelity, E = 1 , the transverse magnetic eld. We plot the indelity, E = 1 , the transverse magnetic eld. We plot the indelity, E = 1 , the transverse magnetic eld. We plot the indelity, E = 1 , the transverse magnetic eld. We plot the indelity, E = 1 , the transverse magnetic eld. We plot the indelity, E = 1 , the transverse magnetic eld. We plot the indelity, E = 1 , the transverse magnetic eld. We plot the indelity, E = 1 , the transverse magnetic eld. We plot the indelity, E = 1 , the transverse magnetic eld. We plot the indelity, E = 1 , the transverse magnetic eld. We plot the transverse magnetic eld. We plot the transverse magnetic eld. We plot the indelity, E = 1 , the transverse magnetic eld. We plot the transverse magnet eld. We plot the transverse magnetic eld. We p

0, and it is given by F (; 0) = $Tr(\begin{array}{c} p \\ 0 \end{array} \right)$. A lternatively, we may simply take E_{HS} (; 0) = $Tr[(\begin{array}{c} 0 \end{array})^2]$ which is related to the H ilbert Schm idt scalar product in the space of operators.

If we want to determ ine a H am iltonian tim e evolution of a m ixed state in real or in aginary tim e, we m ay instead simulate the evolution of the puri cation. Starting out from the M PS puri cation j (0)i (4), we take a sm all time step and compute the next puri cation j (t)i exactly. Unless the evolution is local, the dimension of the matrices A will increase, and we will have to nd a M PS that approximates the exact one, as in the method introduced in [8]. However, we do this here in an optim al way, i.e. we compute the M PS which, for given dimensions fD $_k$ g, maximizes the overlap with the exact state. This \truncated" puri cation is taken as our next initial data, and we repeat the process. At any time, the puri cation can be used to reconstruct the density operator and to compute expectation values of observables.

O urm ethod is based on an iteration which resembles the sweeps used in standard DMRG. Let us assume that we have j i, a MPS (1) and we want to nd the closest one, j⁰i in which the A's are replaced by A's and the corresponding dimensions are $D_k = D_k$. Starting with a guess of the A's (for example, the one of the previous step), on each step of the iteration we choose a site, k, and nd the optimal A_k such that the overlap between j i and the MPS is maximal. The optim alchoice is given by the solution of the system of equations




FIG.2: (a) M agnetization vs. transverse m agnetic eld of the therm al state of a XY m odel with 60 spins, for tem peratures T = 0.05; 0.5; 5; and 50 (bottom to top). (b) Error in the density m atrix of the therm al state of Eq. (9) com puted using M PDO, vs. tem perature, for a chain with N = 8 spins, D = 8 (solid) and D = 14; 20; 24 (dashed).

row and column , and $E_k = {P \atop s} A_k^s (A_k^s)$, and $G_k = {P \atop s} A_k^s (A_k^s)$. Sweeping from k = 1 to N and back several times we reach always a xed point with maximal overlap $j_1 j$ j. The method becomes most e cient for open boundary conditions (D₁ = D_{N+1} = 1), because we can then always in pose that on the optimized site k

Then C $;^{\circ}, \circ = ; \circ ; \circ$ and the new matrix A is just equal to H. In order to ensure conditions (7a) and (7b) in the following step, one can do use a singular value decomposition of \mathcal{K}_{k}^{s} in exactly the same way as it is done in standard DM RG.

We have illustrated the perform ance of our method for a simple case in Fig. 1. We chose an Ising Ham iltonian, $H_z = \int_{i}^{N-1} \int_{i}^{z} \int_{i+1}^{z+1} + \int_{i}^{N} h \int_{i}^{x} W$ e begin with the ground state of h = 0, and switch to h = 0.2 abruptly. We have made simulations of 6 spins with MPS of dimension D = 4. In Fig. 1 we plot the error of our method together with that of the method introduced in [8]. Since the variational procedure is optim allat each time step, it achieves a better result. For the cases studied below the use of our method was crucial to obtain very good accuracy.

Now we apply the previous ideas to approximate the density operator for a system at therm alequilibrium, i.e. / e^{-H} with = 1=T. For = 0 (in nite temperature), the state is a maximally mixed state 1. For any other temperature we use that [17]

This means that we can obtain by evolving according to the Hamiltonian in imaginary time, with time step t. This evolution can be performed with the optimal m ethod presented above, and in this case it is su cient to x the dimension of the ancilla to d.

U sing these techniques, we have computed the equilibrium states of a spin s = 1=2, XY m odel w ith transverse magnetic eld

In Fig. 2 (a) we plot the magnetization versus the magnetic eld for four di erent temperatures, N = 60 spins. The accuracy of the matrix product representation seems to increase with temperature. U sing smaller lattice sizes (N = 8 spins) and a xed magnetic eld (h = 3.0), we compared the exact diagonalization and the M PDO results for di erent dimensions, D. As Fig. 2 (b) shows, no large D's are needed to describe the therm al states accurately.

Let us now move on to the description of the evolution of spin systems in the presence of decoherence. For illustrative purpose, we consider a master equation of the form

where H $_z$ is the Ising H am iltonian m entioned before and characterizes the interaction with the environm ent.

Given an initial condition $(0) = _0$ written in MPDO form (2), we want to nd the MPO which best approxim ates (t). The procedure that we propose resembles the one for Schrödinger equations, in that we integrate almost exactly them aster equation for a short time t, and then nd the optim alMPDO of sm aller dimensions which is closest to (t+ t). Let us denote by E (L;t) = exp(tL) the CPM so that (t) = E (L;t) (0). We will decompose this operator as follows

where $L = L_o + L_e$ is a splitting of the Liouvillian into commuting terms which act on odd, (2k + 1; 2k), and even neighbors, (2k; 2k + 1), respectively.

The action of the operators $E(L_e; t=2)$ or $E(L_o; t)$ on a state of the form (2) can be computed exactly, and one obtains an operator $_{o} = E(L_o; t)$ of the same form but with the substitution $M_{2k}^{s_{2k},s_{2k}^{0}}M_{2k+1}^{s_{2k+1},s_{2k+1}^{0}}$! $M_{2k;2k+1}^{s_{2k},s_{2k+1}^{0},s_{2k+1}^{0}}$. Now we nd the optimal operator $_{L}$, which has the form of Eq. (2), and is built from matrices of xed dimension. A sbefore, by optimal we mean that the distance to the original one is minimized. This time we will use as a measure of the distance $E_{HS}(_{o}; _{L})$ and thus we will not impose the condition (3) (the use of E_{F} in this context is more complicated and will be explored in a future work). This leads to an optimization algorithm which is very much like the one introduced before at the level of puri cation, but in which now $_{o}$ and




FIG. 3: (a) E mors in simulations of a cluster state with N = 6;7 and 8 spins (solid, dash and dash-dot), under Eq. (10), for = 0:1, h = 0, matrices of size L = 14 and timestep t = 0:01. (b) D ecay of correlations, $c_{zz} = h_{i}^{z} \sum_{i+1}^{z} i h_{i}^{z} ih_{i+1}^{z} i$, for the site i = N = 2, on G H Z states with N = 10;20 and 30 spins (dots, crosses and solid line) for L = 10.

 $_{\rm L}$ are treated as vectors on a d^N dimensional space, where d = d d. This way, it is possible to use the same code for studying the evolution of both pure and mixed states. We remark that, while this method cannot guarantee the positivity of the truncated operator $_{\rm L}$ (t) obtained at the end of the algorithm, if the truncation error E_{HS} ($_{\rm o}$; $_{\rm L}$) is kept sm all, it will be possible to bound the errors made when using $_{\rm L}$ (t) to compute expectation values of any physical quantity. Note also that the matrices M $_{\rm k}^{\rm S_k \, iS_k^0}$ 2 C^{L_k} L_k do not need to have a size L_k = D $_{\rm k}^{\rm 2}$ (which is the square of a num ber).

As an illustration, we have simulated the decay of correlations of the G H Z state, j (0) i = $\frac{p^1}{2}$ (D i ^N + j l i ^N) and of a cluster state [18], under the evolution dictated by Eq. (10). In Fig. 3(a) we show the errors for sim ulations with up to N = 8 spins, a size for which we can compute the solution num erically with direct methods (a Crank-Nicholson which already has an error of the order of 10 10). There are two sources of errors in our method. One is the Trotter expansion (11), but as it is of order 0 (t^2), it can be decreased by making shorter time steps. The second source of error is the truncation of the MPDO to a lower dimension. In the problem s that we have simulated, truncation error only a ected the cluster state and did not grow much with the size of the system. In Fig. 3 (b) we plot some sim ulations made with GHZ states of up to 50 spins, from which an exponential decay law for the correlation functions, $c_{zz}(t) = h_{i}^{z} t_{i+1}^{z}$ i h_{i}^{z} ih t_{i+1}^{z} i' e^{4t} , can be extracted. The m ethod is rather e cient and can easily handle this and bigger problem s in ordinary com puters.

In sum m ary, we have introduced the concept of m atrix product density operators (M PDO) and their puri cation in terms of m atrix product states (M PS) in order to describe m ixed states in quantum m any {body system s. W e have also developed a m ethod to determ ine the M PS (M PDO) which optim ally describes another one which is composed of m atrices of higher dimensions. W e have used those ideas to introduce an algorithm which

allows us to study 1D systems in therm al equilibrium. In contrast to previous methods, it applies to nite systems, with general short range interactions (not necessarily translationally invariant) and works over the whole range of tem peratures T 2 [0;1). In fact, the algorithm is a very natural extension of DMRG to nite temperatures because for T ! 0 one recovers the sam e M P S that one would obtain with standard DMRG.We have also shown how to simulate the evolution of a system in the presence of dissipation, i.e. when it evolves according to a master equation which involves short range interactions. W e rem ark that in this last case an alternative possibility is to combine the concepts introduced here with the \quantum jum p" approach [19]. The idea is to perform several realizations of the evolution starting out with random ly chosen pure states in such a way that their mixture reproduces the initial MPDO (2). In each realization the pure state is evolved according to a stochastic Schrodinger equation consisting of a tim e evolution with an e ective H am iltonian which is interrupted by quantum jumps [19]. After each short time step (or quantum jump) the new pure state is determ ined using the method introduce here and which optim ally approxim ates the new state with a MPS.At the end, expectation values of physical observables are determ ined by averaging with respect to the di erent realizations. W hich of these two methods is more e cient will depend on the num ber of realizations one has to perform in practice in the latter in order to achieve a prescribed accuracy.
