# The end-to-end distribution function for a exible chain w ith weak excluded-volum e interactions

#### Abstract

An explicit expression is derived for the distribution function of end-to-end vectors and for the $m$ ean square end-to-end distance of a exible chain $w$ ith exchuded-volum e interactions. The Ham iltonian for a exible chain w ith weak intra-chain interactions is determ ined by two sm all param eters: the ratio " of the energy of interaction betw een segm ents (w ithin a sphere whose radius coincides w ith the cut-o length for the potential) to the therm alenergy, and the ratio of the cut-o length to the radius of gyration for a G aussian chain. Unlike conventional approaches grounded on them ean- eld evaluation of the end-to-end distance, the $G$ reen function is found explicitly (in the rst approxim ation w ith respect to "). It is dem onstrated that (i) the distribution function depends on " in a regular way, while its dependence on is singular, and (ii) the leading term in the expression for the $m$ ean square end-to-end distance linearly grow $s$ w ith " and rem ains independent of .

## 1 Introduction

This paper is concemed w th the distribution function of end-to-end vectors for a exible chain w ith weak excluded-volum e interactions. T hee ect of intra-chain interactions on the characteristic size of \real" exible chains has attracted substantial attention from the beginning of the 50s of the past century, see early studies [in] [ipi]. A notioeable progress has been reached in this area during the past ve decades, see $\left.\overline{\bar{D}_{1}}\right]\left\{\left[\bar{R}_{2}^{2} \overline{4}_{1}^{1}\right]\right.$, to m ention a few works, and the results of investigation have been sum $m$ arized in a num ber of $m$ onographs $\left[\bar{L}_{2} \bar{S}_{1}\right]\left\{\left[\bar{N}_{1} \bar{T}_{1}\right] . N\right.$ evertheless, the e ect of segm ent interactions on the statistics of $m$ acrom olecules has rem ained a sub ject of debate in the past ve years. This conclusion is con m ed by a large num ber of publications, where this phenom enon is discussed, see $[\underline{2} \overline{8}]\{$ [ description of such phenom ena as (i) protein folding and denaturation [3] $\bar{Z}_{1}$ ], (ii) unzipping ofD NA
 (iv) transport of exible chains through narrow pores [3"9]. T he account for intra-chain interactions (i) provides a consistent description of the dependence of intrinsic viscosity on $m$ olecular w eight in dilute polym er solutions $[\overline{1} \overline{3}, 1 \overline{1} \overline{1}, \bar{\prime}, \overline{2} \overline{2}]$, (ii) leads to an adequate characterization of tim e-dependent
 polym erm elts to be correctly estim ated [33i], and (iv) predicts rein forcem ents of interfaces betw een incom patible solvents by random copolym ens $\overline{[2} \overline{2}]$. Interactions betw een segm ents are assum ed to be responsible for (i) swelling of polym er gels $[1]$ anisotropy of polym er solutions, (iii) structure of polyelectrolyte chains [1] of globu lar proteins $\left[\underline{\underline{2}} \overline{2}, 1,1 \overline{3}_{1} \overline{1}\right]$, etc.

There are two conventional ways to describe excluded-volume interactions in a exible chain. A ccording to the rst, a freely jointed chain is thought of as a set of rigid segm ents with given length linked in sequel, whereas the intra-chain interactions do not perm it each pair of segm ents to occupy the sam e place. This m odelim plies that the distribution function for end-to-end vectors coincides $w$ th that for a self-avoiding random walk. A though an explicit expression for the latter function is unknow $n$, it is believed that the $m$ ain term in the expansion of the distribution function for a long chain (w th the num ber of segm ents $N$ 1) is described by either a stretched exponential function or a stretched exponential function multiplied by som e pow er of the end-to-end distance [ not precisely know n [4]

A ccording to the other $m$ ethod, a chain is treated as a sequence of beads bridged by (entropic) elastic springs $\left.\underline{2}_{2} \bar{S}_{-1}\right]$. T he H am iltonian of the system equals the sum of the conventionalH am iltonian for a G aussian chain and the exchuded-volum e functional, w here the energy of repulsive interactions betw een segm ents is approxim ated by the D irac delta-function. To assess the e ect of steric interactions on the $m$ ean square end-to-end distance, it is presum ed that the intensity of interactions is sm all com pared to therm al energy.

By applying various approxim ate techniques, the average end-to-end distance w as evaluated in a num ber of studies (to the best of our know ledge, only a few attem pts w ere undertaken to determ ine
 $m$ ean square end-to-end distance $B$ of a exible chain w ith segm ent interactions is determ ined by som e sm all dim ensionless param eter (which quantity coincides with the product " introduced later), (ii) the ratio $(B=b)^{2}$, where $b$ is the $m$ ean square end-to-end distance for a $G$ aussian chain, $m$ ay be expanded into a Taylor series in , and (iii) the leading term (proportional to ) in this expansion is positive, which m eans that excluded-volum e interactions are alw ays repulsive. The com $m$ on feature of the $m$ athem atical m ethods applied to develop these results $w$ as that all of them were grounded on the $m$ ean-eld approach (the propagator for an appropriate path integral was
evaluated on the classical path only).
The ob jective of the present study is to develop an explicit expression for the distribution function ofend-to-end vectors by evaluating the functionalintegral on ( $m$ ore or less) arbitrary paths (conform ations of a chain). O urm ain result is that conclusions (i) to (iii) appear to be questionable. It is dem onstrated that the $G$ reen function for a exible chain $w$ ith excluded-volum e interactions is characterized by two sm all param eters, one of which, ", describes the intensity of intra-chain interactions per sm allvolum e associated w ith the segm ent length, while the other, , determ ines the ratio of the segm ent length to the average end-to-end distance for a $G$ aussian chain. The di erence betw een these param eters is that the dependence of the distribution function on " is regular, $w$ hereas its dependence on is singular. It is found that the leading term $s$ in the expression for the $m$ ean square end-to-end distance is proportionalto ", the scaling that substantially di ers from the results of previous w orks. $T$ he grow th of the average size of a chain $w$ ith the intensity of segm ent interactions is ensured when the exchuded-volum e potential is included into the $H$ am iltonian w ith the sign di erent from the conventional one.

The exposition is organized as follow s. A $H$ am ittonian for a exible chain w ith excludedvolum e interactions is discussed in Section 2. This H am iltonian is calculated on the classical path in Section 3. M ean-eld approxim ations for the $G$ reen function and the end-to-end distance are given in Section 4. A perturbed H am iltonian is determ ined in Section 5. O ur analysis is based on the conventional approach, according to which the exchuded-volum e potential is expanded in a Taylor series in the vicinity of the classical path up to quadratic term $s$ (a sim ilar technique was recently em ployed in [ $[4 \bar{G}]$ ] for the screened C oulom b potential). A leading term (w ith respect to sm all param eters) in the expression for the $G$ reen function is determ ined in Section 6 . The m ean square end-to-end distance B is evaluated in Section 7 for weak (" 241 ) and in Section 8 for $m$ oderately strong (arbitrary values of this ratio) interactions. Som e concluding rem arks are form ulated in Section 9. M athem atical derivations are presented in A ppendiges $A$ to $F$.

## 2 Form ulation of the problem

A exible chain is treated as a curve w ith \length" L in a three-dim ensional space. An arbitrary con guration of the chain is determ ined by the function $r(s)$, where $r$ denotes radius vector and s $2[0 ; L]$. For de niteness, we assum e the end $s=0$ to be $x e d$ at the origin, $r(0)=0$, and the end $s=L$ to be free. A $n$ \intemal structure" of the curve is characterized by a segm ent length bo and the num ber of segm ents $N \quad 1$, which are connected w ith length $L$ by the form ula $L=b_{0} N$. In the absence of segm ent interactions, the H am iltonian

is ascribed to the chain. H ere $k_{B}$ is $B$ ollm ann's constant, and $T$ is the absolute tem perature. T he energy of intra-chain interactions is described by the functional

$w$ here $V(r)$ is a dim ension less potential energy of interactions, and $v_{0}$ is their intensity (which is assum ed to be positive for repulsive and negative for attractive interactions). W e con ne ourselves to isotropic functions $V(r)=V(r) w i t h r=j r j$. The entire $H$ am iltonian of the chain reads

A though Eq. (3) is em ployed in a num ber of studies, see $\left[\overline{2} \overline{S_{1}}\right]$ and the references therein, the sign of the second term in this form ula seem $s$ questionable, because $V \mathrm{~m}$ ay be considered as a w ork of som e ctitious extemal eld that prevents segm ents from being located at the sam e positions. T he latter im plies that the contribution of $V$ into $H$ should be negative (as, for example, that of the work of an extemal force at extension of a chain). W e postpone a discussion of the sign of $V$ to Section 7, and suppose at this stage that $v_{0} m$ ay have an arbitrary sign.

The Green function (propagator) for a chain $G(Q)$ is given by

The aim of this study is to develop an explicit expression for the $G$ reen function of a chain w ith relatively weak segm ent interactions, when the last term in Eq. (4) is \sm all" com pared to the rst. The derivation is perform ed for an arbitrary function $V(r)$, but our speci $c$ interest is in the excluded-volum e potential $V(r)=\widehat{D}(r)$, where $D(r)$ denotes the $D$ irac delta-fiunction, and $\hat{D}(r)$ stands for its regularization after cut-o at $s m$ all distances. To provide a rigorous de nition, we introduce the Fourier transform of $V(r)$,

The Fourier transform of the $D$ irac delta-function $D_{D}(r)$ reads $U_{D}(k)=1$. To avoid divergence of the integral in Eq. (4), this function is cut o at an appropriate length-scale b $=\mathrm{k}^{1}$,

and the potential $\hat{D}(r)$ is de ned as the inverse Fourier transform of $\hat{U}_{D}(k)$. To ensure that the potential $\hat{U}_{D}$ describes intra-chain interactions properly, we assum e the length-scale of cut-o $b$ to be substantially low er than the $m$ ean-square end-to-end distance for a $G$ aussian chain $b={ }^{\mathrm{P}} \frac{\mathrm{b}}{\mathrm{b} L} \mathrm{~L}$,

## 3 W eak excluded-volum e interactions

To characterize the $\backslash$ sm allness" of the potential $V$, we, rst, introduce a test function $r_{0}$ (the classicalpath) that $m$ in im izes functional (1) under conditions (6). Then the values of $H 0$ and $V$ are determ ined on the curve $r_{0}(s)$, and the dim ension less param eter " is chosen from the condition that $\mathrm{V}\left(r_{0}\right)$ is $s m$ all com pared $w$ th $H_{0}\left(r_{0}\right)$ for any properly scaled end-to-end vector $Q$. W e introduce a $C$ artesian coordinate fram e fx;y;zg, whose $z$ axis is directed along the vector $Q$, and present the $m$ inim ization problem for the non-perturbed H am iltonian $\mathrm{H}_{\mathrm{o}}$ as follow s :

The function $A(x)$ is plotted in $F$ igure 1 , which show sthat $A$ m onotonically decreases $w$ ith $x$. The lim its of $A(x)$ as $x!0$ and $x!1$ are given by (Appendix A)

It follow s from Eqs. (12) and (17) that the sm allness of the functional V compared with the non-perturbed $H$ am iltonian $H_{0}$ is tantam ount to that of the pre-factor

we conclude that the condition $J^{\prime \prime j} 1 \mathrm{~m}$ eans that the energy of excluded-volum e interactions at the length-scale of cut-o is sm all com pared w ith them alenergy. Substitution of expressions (12), (17) and (20) into Eq. (4) results in

A ccording to Eq. (21), in the m ean- eld approxim ation, the functional $H$ is determ ined by two dim ensionless quantities, " and . The form er characterizes the sm allness of excluded-volum e interactions, whereas the latter describes the length-scale where these interactions are im portant. T he param eter " is located in the num erator, which $m$ eans that it is responsible for regular perturbations of $H_{0}$, while stands in the denom inator, which im plies that it describes singular perturbations. This distinguishes the present approach from previous studies, where one sm all param eter was introduced, and its e ect was assum ed to be regular in the sense that the G reen function was expanded into a Taylor series $w$ ith respect to this quantity.

Before proceeding with the calculation of the $H$ am iltonian $H$ on an arbitrary curve $r(s)$, it is instructive to evaluate the $G$ reen function $G(Q)$ and its second $m$ om ent on the classical path $r_{0}(s)$.

## 4 M ean - eld approxim ation of the $G$ reen function

Our aim is to $n d$ an approxim ation of the $m$ ean square end-to-end distance $B$ when the set of adm issible curves $\mathrm{fr}(\mathrm{s}) \mathrm{g}$ contains the classical path $\mathrm{r}_{0}(\mathrm{~s})$ only. Substitution of expression (21) into Eq. (5) results in

(59) contradicts our intuition: repulsive interactions betw een segm ents result in a decrease in the end-to-end distance. Form ula (59) contradicts also the m ean-eld Eq. (31) : the ratio ( $\mathrm{B}=\mathrm{b})^{2}$ is proportional to " instead of the classical scaling " .
$T$ he latter discrepancy $m$ ay be explained if we recall that excluded-volum e interactions do not perm it di erent segm ents of a exible chain to occupy the sam e positions, which m eans that their $e$ ect is substantial only for \curved" con gurations of a chain, whereas the $m$ ean- eld approach is con ned to \straight" con gurations. This im plies that the mean-eld technique is inapplicable to the analysis of a exible chain w ith long-range interactions betw een segm ents, in agreem ent w ith the conclusion derived about 50 years ago $\overline{[2}]$ (based on di erent argum ents).

Equation (59) leads to a physically plausible result (an increase in the average end-to-end distance w ith intensity of excluded-volum e interactions) when " is negative. The latter is tantam ount to the negativity of contribution of $V$ into the $H$ am iltonian $H$ in Eq. (3). To dem onstrate the correctness of this assertion, it is instructive to com pare the values of $H$ on two paths: (P 1) a straight line (11) that connects the end-points, and (P 2) a sinusoidalpath (32) and (34) w ith the only non-zero term corresponding to a xedm 1. A ccording to the physicalm eaning ofexcludedvolum e interactions, the energy $H_{2}$ on path (P 2) should exceed the energy $H_{1}$ on the straight path (P1) as Q ! 0, i.e., when the chain is supenposed on itself several tim es. On the other hand, it follow s from Eq. (35) that

It has been found in the calculation of the path integral that the sign of the excluded-volume potential should be corrected in the conventional form ula (3) for the H am iltonian. It has also been shown that the $m$ ean square end-to-end distance cannot be expanded into a Taylor series with respect to $s m$ allparam eters (as it is traditionally presum ed), because even sub-leading term $s$ of the highest order in the form ula for $B^{2}$ include $\ln$, see Eq. ( $E-11$ ), and ${ }^{\mathrm{P}} \bar{\pi}$, see Eq. ( $\mathrm{F}-25$ ).
$T$ his work focuses on the analysis of the distribution function for a exible chain w ith excludedvolum e potential (9). H ow ever, the results can be easily extended to an arbitrary potential of intra-chain interactions by using Eqs. (15) and (47). In particular, these relations allow an explicit form ula to be derived for the distribution function of end-to-end vectors for exible polyelectrolyte chains.
