R enorm alization of the periodic Anderson model: an alternative analytical approach to heavy Ferm ion behavior

In this paper a recently developed projector-based renorm alization method (PRM) for manyparticle H am iltonians is applied to the periodic Anderson model (PAM) with the aim to describe heavy Ferm ion behavior. In this method high-energetic excitation operators instead of high energetic states are elim inated. We arrive at an elective H am iltonian for a quasi-free system which consists of two non-interacting heavy-quasiparticle bands. The resulting renorm alization equations for the parameters of the H am iltonian are valid for large as well as small degeneracy $_{\rm f}$ of the angular momentum . An expansion in 1= $_{\rm f}$ is avoided. Within an additional approximation which adapts the idea of a xed renorm alized f level ${\tt w}_{\rm f}$, we obtain coupled equations for the usual slave boson mean-eld (SB) treatment. In particular, for large $_{\rm f}$ the results for the PRM and the SB approach agree perfectly whereas considerable di erences are found for small $_{\rm f}$.

I. IN TRODUCTION

In comparison to ordinary metals metallic heavy ferm ion systems have remarkable low-tem perature properties [1]: both the conduction electron specic cheat and the magnetic susceptibility can be two or more orders of magnitude larger than in normal metals though the ratio of both quantities is similar to that of usual metals. U sually, in metals an increasing resistivity (T) with increasing tem perature is observed. In contrast, a much richer behavior is found in heavy ferm ion systems: At higher temperatures (T) only changes slightly and might even increase with decreasing temperatures. Below a characteristic coherence temperature a strong decrease of the resistivity with decreasing temperatures is observed. At very low temperatures, a T² dependence of the temperature is found. A nother important noting is that a correspondence between the low-energy excitations of heavy ferm ion systems and those of a free electron gas with properly renorm alized param eters can be established. Therefore, the high density of states at the Ferm i surface observed in heavy ferm ion systems is in plies an elective mass of the (heavy) quasiparticles which is some hundred times larger than the free electron mass.

P rototype heavy ferm ion system s like $C \in A_{1}$ and $U P t_{3}$ contain rare-earth or actinide elements. Thus, the basic m icroscopic m odel for the investigation of such m aterials is believed to be the periodic Anderson m odel (PAM) which describes the interaction between nearly localized, strongly correlated f electrons and conduction electrons [2]. W ithin a simplie of version the Ham iltonian of the PAM can be written as

Here, i is the 4f or 5f site index, k is the conduction electron wave vector, and V_k is the hybridization matrix element between conduction and localized electrons. "f and "k, both measured from the chemical potential, are the excitation energies for f and conduction electrons, respectively. As a simplication, both types of electrons are assumed to have the same angular momentum index m with f values, m = 1::: f. Finally, the local C oulom b repulsion U_f at f sites has been assumed to be in nitely large so that localized sites can either be empty or singly occupied, i.e., the Hubbard operators f_{im}^{γ} are dened by

where $n_{im}^{r} = f_{im}^{y} f_{im}$. The unexpected and exciting properties of the PAM (1) are mainly due to the presence of the strong correlations at f sites. In turn the strong correlations also cause the great di culties in any theoretical treatment of the model. In the present approach the correlations are taken care of by the Hubbard operators (2) which do not obey the usual ferm ionic anticom mutator relations. Instead one has

The quantity D_{im} can be interpreted as a local projection operator at f site i on f states which are either empty or singly occupied with one electron with index m. A loc it is helpful to introduce separately the projection operator P_0 (i) on the empty f state at site i and the projection operator \hat{n}_{im}^f on the singly occupied f state when one electron with index m is present. D_{im} can be rewritten as

The second equation in (4) is the completeness relation for f electrons at site i.

For the case of vanishing C oulom b repulsion U_f the PAM (1) is equivalent to the Fano-Anderson m odel [3, 4] which can be easily solved (see, for example, appendix A). However, much of the physics of the correlated m odel can also be understood in terms of a renormalization of the parameters of the uncorrelated Fano-Anderson m odel. Various theoretical methods have been developed in the past to generate such renormalized H am iltonians, for instance the Gutzwiller projection [5] or the slave-boson mean-eld (SB) theory [6, 7]. Here we use a recently developed [8] projector-based renormalization method (PRM) to map the PAM to a free system consisting of two bands of uncorrelated quasi-particles. Furtherm ore, we avoid an expansion with respect to the degeneracy f of the angular momentum and take all 1 = f corrections into account.

The PRM has already been applied before to the PAM in Ref. 8. However, in the present approach the treatment from Ref. 8 will be improved in various points: (i) The PRM is performed in a completely non-perturbative manner. (ii) All 1= f corrections are taken into account. (iii) The dispersion of both quasiparticle bands is considered.

Furtherm ore, we shall compare the results of the PRM with those of the SB treatment in much more detail.

The paper is organized as follows. First, in Sec. II we brie y repeat the recently developed PRM [8]. In Sec. III the PRM is applied to the PAM whereby the renorm alization equations for the model parameters are derived non-perturbatively. An analytical solution of the renorm alization equations is found in Sec. IV using a constant renorm alized f level \mathbf{n}_{f} . Furthermore, we compare our results with the solutions of the SB theory. Finally, our conclusions are presented in Sec. V.

II. PROJECTOR-BASED RENORMALIZATION METHOD (PRM)

The PRM [8] starts from a decomposition of a given many-particle Hamiltonian H into an unperturbed part H $_0$ and into a perturbation H $_1$,

W e assume that the eigenvalue problem of H $_{\rm 0}$ is known

Note that P is a super-operator acting on usual operators A of the unitary space. It projects on those parts of A which are formed by all dyads juilm jwith energy di erences $f_n^{(0)} = E_m^{(0)}$ jless or equal to a given cuto , where is smaller than the cuto of the original model. Note that in (9) neither juin or jn i have to be low energy eigenstates of H₀. However, their energy di erence has to be restricted to values . Furthermore, it is useful to de not the projection operator

which is orthogonal to P . Q projects on high energy transitions larger than the cuto .

The goal of the present method is to transform the initial H am iltonian H (with a large energy cuto) into an e ective H am iltonian H which has no matrix elements belonging to transitions larger than . This is achieved by an unitary transform ation so that the e ective H am iltonian w illhave the same eigenspectrum as the original H am iltonian H . However, as it will turn out, the method is especially suitable to describe low-energy excitations of the system . H is de ned by

The generator X of the transform ation has to be anti-H erm itian, $X^{y} = X$, so that H is H erm itian for any . We look for an appropriate generator X so that H has no matrix elements belonging to transitions larger than . This means that the following condition

has to be fulled. Eq. (12) will be used below to specify X . In contrast to Ref. [3], where H was evaluated perturbatively, the transformation (11) will be treated non-perturbatively.

Next we discuss the elimination procedure for the interaction H_1 . Instead of transforming the Hamiltonian in one step as in Eq. (11) the transformation will be done successively. Ormore formally spoken, instead of applying the elimination of high-energy excitations in one step a sequence of stepwise transformations is used in order to obtain an electively diagonalmodel. This procedure resembles W egner's ow equation method [9] and the similarity renormalization [10] in some aspects. In the PRM approach difference equations for the dependence of the parameters of the Hamiltonian are derived. They will be called renormalization equations. To ind these equations we start from the renormalized Hamiltonian

after all excitations with energy di erences larger than have been eliminated. Next we consider an additional renormalization of H by eliminating all excitations inside an energy shell between and a smaller energy cuto () where > 0. The new Ham iltonian H () is obtained by an unitary transformation similar to that of Eq. (11)

Note that there are two strategies to exploit Eq. (15) in order to determ ine the generator X ; of the unitary transformation (14). The most straightforward route is to analyze Eqs. (14) and (15) in perturbation theory as it was done in Refs. 8 and 11. Here, we want to perform the renormalization step from to () in a non-perturbative way.

Eqs. (14) and (15) describe the renorm alization of the H am iltonian by decreasing the cuto from to () and can be used to derive di erence equations for the -dependence of the H am iltonian. The resulting equations for the parameters of the H am iltonian will be called renorm alization equations. Their solution depends on the initial values of the parameters of the H am iltonian and xes the nal H am iltonian in the limit ! 0. Note that for ! 0 the resulting H am iltonian only consists of the unperturbed part $H_{0;(!0)}$. The interaction $H_{1;(!0)}$ vanishes since it is completely used up in the renorm alization procedure. Thus, an electively diagonal H am iltonian is obtained.

III. RENORMALIZATION OF THE PERIODIC ANDERSON MODEL (PAM)

The PRM described above will be applied in this section to the PAM (1). As an illustration of the method the Fano-Anderson model is discussed as a further application of the PRM in appendix A. This model can be considered as a PAM without electronic correlations. It turns out that the renormalization of the full PAM (1) is somewhat sim ilar to that of the uncorrelated model. However, in the Anderson-Fano model the elimination of excitations with energies larger than can be done in one step. For the PAM (1) the f electron one-particle energy "f will also be renormalized. This is due to the presence of strong local correlations at f sites in the PAM (1). Therefore, the elimination procedure has to be done stepwise by repeatedly integrating over small energy steps of width . In this way one is led to renormalization equations for the parameters of the model in terms of di erence equations which have to be solved.

A. Renorm alization ansatz

Let us start by form ally writing down the elective H am iltonian $H = e^{X}$ H $e^{X} = H_{0}$; $+ H_{1}$; for the periodic Anderson model after all excitations with energy differences larger than have been eliminated. By comparing with the starting model (1) one might be in favor of choosing an unperturbed part H_{0} ; which contains correlated feetrons f_{im}^{y} ; f_{im} as in Eq. (1). However, because the eigenvalue problem of such an H am iltonian would not exactly be solvable, we prefer to start from an uncorrelated H am iltonian where only usual Ferm inperators f_{im}^{y} ; f_{im} enter but keep the correlations in the renorm alized interaction H_{1} ; i.e.

f particle-hole excitations in order to properly take into account the strong C oulom b interaction at local f sites. D ue to renorm alization processes the one-particle energies " $_{f}$; and " $_{k}$; in Eq. (16) depend on the cuto energy . Moreover, two new parameters enter: $_{k}$; describes the f dispersion due to the hybridization of f electrons at di erent sites i ϵ j, and E is an additional energy shift. Finally, the projector P in (17) guarantees that only excitations contribute to H $_{1}$; which have energies (with respect to H $_{0}$;) which are smaller than . The initial parameter values of the originalm odel (at =) are

As it turns out, the hybridization V_k is not changed by the renorm alization procedure.

A sm entioned before, correlation e ects have been neglected in Eq. (16). First, this means that doubly occupancies of f-sites $(f_{im}^y \quad f_{im}^y)$ ($f_{im} \quad \hat{f}_{im}$) are assumed to be negligibly small though they are not properly excluded by the choice of uncorrelated f operators in H₀; . Note that this assumption is also used for the subsidiary condition within the SB approach [7]. Doubly occupied f-sites could in principle be generated by the non-local f-part of H₀; . As it turns out, this is explicitly excluded by keeping the correlations in the interaction part H₁; .

For the following, the commutator of the unperturbed H am iltonian H₀; with the operator $f_{k,m}^{y} c_{km}$ has to be evaluated. By introducing the unperturbed Liouville operator L₀; , which is de ned by L₀; A = [H₀; ;A] for any operator variable A, one nds

where contributions which lead to doubly occupied f sites have been neglected. The second and the third term on the rhs. of Eq. (22) follow from the special form of the anticommutator relations (3). Obviously, only f electron operators belonging to dimensions if ϵ j enter the second term on the rhs. of Eq. (22). Therefore, as approximation one may replace the operator D_{jm} by its expectation value

is the averaged occupation number of f electrons at site j. Note that D is independent of j and m. Furtherm ore, D f_{km}^{y} is replaced by f_{km}^{y} . Finally, we neglect the third term on the rh.s of Eq. (22), which represents spin- ip processes, and all contributions leading to doubly occupied f sites. (Sim ilar approximations will also be used later.) C onsequently, Eq. (22) simplifies to

B. G enerator of the unitary transform ation

In the next step let us evaluate a new elective H am iltonian H $_{()}$ which is obtained by a further elimination of excitations within a small energy shell between () and $According to (14) H_{()}$ is obtained from an unitary transformation

The operator form of X ; is suggested by its rst order expression which is easily obtained by expanding (14) in powers of H₁ and using Eq. (15) (compare Ref. 8). The yet unknown prefactors A_k (;) will be specified later and depend on and . It will turn out that A_k (;) contains contributions to all powers in V $_k$. Note that the ansatz (28) also corresponds to the operator structure of the exact generator of the uncorrelated Fano-Anderson model (see appendix A). We expect the ansatz (29) to be a good approximation also for the correlated model in which conduction and localized f electrons strongly couple. Finally, the -functions in (29) result from the restriction of H to particle-hole excitations with $J'_{f;}$ + $_{k;}$ = $''_{k;}$ and from the corresponding restriction $J'_{f;(-)}$ + $_{k;(-)}$ () = $''_{k;(-)}$ for the renormalized model H (). The two -functions in $_k$ (;) con ne the allowed excitations.

To determ ine the unknown parameters A_k (;) of the unitary transform ation [com pare (29)] we will use Eq. (15). First, we have to carry out the unitary transform ation (28) explicitly

Similar expressions can also be found for the transform ation of the remaining operators. In deriving (B 33) - (B 36) an additional factorization approximation was used in order to keep only operators which are bilinear in the ferm ionic creation and annihilation operators. Spin- ip contributions have been neglected. Moreover, it was assumed that the number of k points which are integrated out by the transform ation from to () is small compared to the total number of k points.

As already mentioned in the introduction, an expansion with respect to the degeneracy $_{\rm f}$ is utilized in the slaveboson mean-eld (SB) theory [6, 7]. In contrast, here we incorporate all 1= $_{\rm f}$ corrections which will be rejected by the expectation value D as defined in Eq. (23). As one can see from the two terms of the anticommutator of Eq. (3), new renormalization contributions are included by which a localized electron at an occupied f site is annihilated and instead a conduction electron is created. These processes are of order 1= $_{\rm f}$ sm aller than the usual processes included in the SB theory by which a conduction electron is annihilated and instead a localized electron is generated at a form enly empty f site.

In the next step let us determ ine the unknown parameters A_k (;). For that purpose, we insert H () from (31) into Eq. (15) and use the transform ed quantities (B 33) – (B 36). Thus, one nds

The condition (33) for A_k (;) guarantees that H () does not contain matrix elements with transition energies larger than (). Obviously, there is a strong similarity between (33) and the corresponding result (A11) of the Fano-Anderson model. However, the generator (33) of the PAM contains some deviations which reject the in uence of the strong electronic correlations at f sites. It is important to note that the expression (33) for A_k (;) is non-perturbatively in V_k and is not restricted to some low order in V_k . Moreover note that the values of A_k (;) are determined by Eq. (32) only for the case that the excitation energy " $_{f;} + k;$ " $_{k;}$ ts in the energy shell restricted by $_k$ (;). For all other excitations A $_k$ (;) can be set equal to zero. Thus, the parameter A_k (;) of the generator X ; is given by

C. Renorm alization equations

In the follow ing we derive the renorm alization equations for the parameters of the H am iltonian. For that purpose we compare two dimensions for H $_{()}$. The rst one is obtained by rewriting the renorm alization ansatz [Eqs. (16) and (17)] at cuto ()

Note that Eq. (39) for the energy shift E follows from the comparison of the remaining c numbers. The renormalization equations (36) - (38) still depend on the expectation values $c_{km}^{y} q_{km}$, $f_{km}^{y} q_{km}$ + hr:, and D [compare (23)] which have to be determined rst. In the following we will discuss an approximate evaluation for these quantities which enables us to solve the renormalization equations (36)-(39). The parameter A_{k} (;) is given by (34).

A factorization approximation was employed above to reduce all renormalization contributions to operator terms which are bilinear in the fermionic creation and annihilation operators. In principle, the expectation values are dened with the equilibrium distribution of H since the renormalization step was done by transforming H to $H_{(-)}$. H still contains hybridization terms between f electrons and conduction electrons [com pare(17)] so that there is no straight way to evaluate the expectation values. There are several approximations possible to circum vent this di culty. Firstly, one can evaluate the expectation values by using the unperturbed H am iltonian H ₀; which is diagonal. In this approximation the renormalization equations (36)-(39) can easily be evaluated numerically. The result for the renormalized f level found in this way is in good agreement with the slave-boson mean eld result. How ever, the quasiparticle energies turn out to be discontinuous as function of k. This behavior has to be interpreted as an artifact of this simple approximation and is caused by the vanishing of expectation values with respect to the full H am iltonian H instead of H . In this case the renormalization equations (36)-(39) can not be evaluated directly because the expectation values are not known. The starting point to not these quantities is the relation

which follows from unitarity (for any operator A). By setting up additional renorm alization equations for the transform ed operators A one can determ ine the expectation values A . Note that in the equations for A the unknown expectation values enter again so that they have to be solved self-consistently. This approach is rather involved but has the advantage that expectation values in (36)-(39) no longer depend on the cuto energy .

Renorm alization equations for transform ed operators also have to be used if dynam ical correlation functions are

evaluated. For example, to nd the densities of states of the f electrons

IV . A N A LY T IC A L SO LU T IO N

A Itematively, one can also nd approximate analytical solutions for the renormalization equations (36)-(39). For this purpose three approximations have to be used:

(i) All excitation values are calculated using the full H am iltonian H (see the discussion at the end of Sec. III), i.e.

The spirit of this approximation is similar to that used in the slave-boson theory. There a renormalized f level is used from the very beginning. Within the present treatment one might expect that " $_{\rm f}$; increases with decreasing from its initial value " $_{\rm f}$ and reaches its nalvalue " $_{\rm f}$ already at nite .

(iii) The averaged dispersion of f electrons will be neglected,

These approximation enable us to map the renormalization equations of the PAM to those of the exactly solvable Fano-Anderson model (see appendix A).

It is more di cult to solve the remaining renormalization equations (36) and (38). First, the approximations (43)–(45) lead to a decoupling of Eq. (36) for di erent k values. Thus, by eliminating excitations from large to small cuto values each k state is renormalized only once. Such a step-like renormalization behavior is also obtained in the Fano-Anderson m odel (see appendix A). A further similarity to this simpler m odel is found by inserting the approximations (43)–(45) into Eqs. (33) and (36)

Note that in the case of a step-like renorm alization the parameters A_k of the generator of the unitary transform ation do not depend on and . In particular, the equivalence of the one-particle energies can be seen by replacing DV_k by V_k . Note that in H[°] the hybridization was completely used up for the renorm alization of the parameters of H₀. Also the eigenmodes \hat{f}_{km} and q_{km} of H[°] do not change their character as function of the wave vector due to the presence of the sgn-functions in (51) and (53). Instead they remain f-like or c-like for all values of k. Furthermore, the one-particle energies (51) and (53) still depend on two unknown quantities, namely, the renormalized f level \mathbf{w}_{f} and the expectation value D [see Eq. (23)] which have to be determined in the following.

B. Free energy and equations of self-consistency

First, let us calculate the averaged f electron occupation number \hat{m}_i^f from the free energy F. Note that H is connected with the original Ham iltonian H by an unitary transformation. Therefore, the free energy can also be evaluated from H . In particular, the relation

We are interested in solutions of the renorm alization equations which describe mixed valence and heavy Ferm ion behavior. For these cases the derivatives in Eq. (58) are non-zero so that solutions can be found by setting both brace expressions equal to zero. In this way the following self-consistent equations for the renorm alized f level \mathbf{w}_{f} and the averaged f electron occupation number \mathbf{h}_{i}^{f} i are found,

Note that these equations are quite similar to those which are found in the slave-boson (SB) form alism [7]. In particular, the lim it $_{\rm f}$! 1 of Eqs. (59) and (60) perfectly agrees with the SB equations.

Next we calculate the densities of states of the f and c electrons [com pare Eqs. (41) and (42)]. For that purpose, we have to integrate the renorm alization equations (C 9) and (C 10) to determ ine the transform ed one-particle operators. In the case of the analytical solution, (C 9) and (C 10) can be exactly solved if the basic approximations (44) and (45)

are used. As a lready discussed above, in this case the di erent k values are not coupled with each other and we obtain a step-like renorm alization behavior. Thus, we nd

E. Results and comparison with slave-boson mean-eld theory

In this subsection we shall compare the results of our analytical solution discussed above with those of the slaveboson mean-eld (SB) treatment. As already mentioned, the lim it $_{\rm f}$! 1 of the derived self-consistent equations (59) and (60) is completely equivalent to the SB equations. Furthermore, in this lim it the expectation values of our analytical solution [see Eqs. (63) and (64)] and the SB treatment also perfectly agree. Therefore, we want to concentrate on the case of sm all degeneracy $_{\rm f}$. At this point it is important to notify that we have never exploited an 1= $_{\rm f}$ expansion in the derivation of the analytical solution of the PAM so that it is valid for large as well as sm all degeneracy $_{\rm f}$.

For simplicity, let us consider an one-dimensional PAM with 50000 lattice sites, a linear dispersion relation for the conduction electrons, and a k independent hybridization $V_k = V$ and compare our results with those of the slave-boson mean-eld (SB) theory. In particular, we are interested in the dependence of the results on the degeneracy f.




FIG.1: Dispersion relations of an one-dimensional PAM (N = 50000, $_{\rm f}$ = 4, $_{\rm f}V^2$ = 0.36, $_{\rm f}$ = 0.3, = 0, T = 0.0001). Here, the unrenormalized one-particle energies $_{\rm k}$ and $_{\rm f}$ are plotted with full and dashed thin lines. The renormalized quasiparticle energies $_{\rm k}$ and $_{\rm k}$ are shown with full and dashed thick lines. Furtherm ore, the quasiparticle energies of the SB approach are drawn by use of dotted lines.

At rst, let us x the degeneracy of the angular momentum to $_{\rm f} = 4$. The other parameters are chosen as follows $_{\rm f}V^2 = 0.36$, $"_{\rm f} = 0.3$, chemical potential = 0, and T = 0.00001 where all energies are given in units of the half bandwidth. As can be seen from Fig. 1, the renormalized quasi-particle energies, i.e. \mathbf{u}_k and \mathbf{t}_k , obtained from (51), (53), (59), and (60) (full and dashed thick lines), and the quasi-particle bands of the SB theory (dotted lines) seem to be quite similar. However, the averaged f occupation $\hbar_i^f i = 0.855$ and the renormalized f level $\mathbf{u}_f = 0.071$ di er signi cantly from the SB results ($\hbar_i^f i = 0.586$ and $\mathbf{u}_f = 0.115$). These di erences are mainly caused by the fact that we have taken into account all 1= f corrections which are absent in the SB treatment. Note that 1= f corrections




FIG.2: Density of states of the f electrons (upper panel) and of the c electrons (low er panel) where all param eters are chosen as in Fig.1. A broadening of the -functions of 0.0001 is used. The results of the analytical PRM solution (SB theory) are drawn as solid (dashed) lines.




FIG.3: Dependence of the renorm alized f level \mathbf{u}_{f} (left panel) and of the averaged f occupation h_{i}^{f} i (right panel) on the degeneracy f of the angular momentum where all other parameters are chosen as in Fig.1. The results of the analytical solution (SB theory) are drawn using solid (dashed) lines.




FIG. 4: Dependence of the renorm alized f level \mathbf{w}_{f} (left panel) and of the averaged f occupation $h\hat{\mathbf{n}}_{i}^{f}$ i (right panel) on the original f energy \mathbf{w}_{f} where all other parameters are chosen as in Fig. 1. The results of the analytical solution (SB theory) are drawn using solid (dashed) lines.




FIG.5: A veraged f occupation hf_i^f i as a function of tem perature T where all other parameters are chosen as in Fig.1. The result of the analytical solution (SB theory) is drawn using solid (dashed) line.

allow for additional renorm alization processes which lead to a lowering of the free energy for the whole parameter space.

It is well known that the quasi-particles of the SB theory change their character as function of k between a more f-like and more c-like behavior. As was mentioned before, in the present treatment excitations do not change their character as function of k. However, the quasi-particle energies show jumps in their k dependence where the renorm alization contributions change their sign from positive to negative values or vice versa. Note, that the various parts of the quasi-particle bands t perfectly together (see Fig. 1).

As compared to the dispersion relations plotted in Fig.1, the densities of states of the f-and c-electrons in Fig.2 show much better the di erences between the results of the present analytical solution and of the SB treatment. In particular, the smaller value for the renormalized f level \mathbf{u}_{f} obtained from our PRM treatment leads to much higher density of states at the Ferm i surface than the SB treatment. Note that such an enhanced density of states at the Ferm i energy is a clear signature of heavy ferm ion behavior.

Next, we discuss the dependence on the degeneracy parameter f. For that purpose we vary f by keeping $f V^2 = 0.36$ xed. In contrast to the SB results for $h_1^f i$ and \mathbf{n}_f , which are almost unchanged (see Fig. 3), the analytical solutions show a remarkable dependence on the degeneracy f. In particular, for small f, the 1= f corrections included in the PRM approach lead to serious deviations from the SB results. From these additional 1= f corrections follows a more pronounced heavy Ferm ion behavior. As a lready mentioned above, the limit f ! 1 of our analytical solution perfectly agrees with the SB theory. To perform this limit one has to replace the expectation value D by (1 $h_1^f i$) so that all processes are neglected by which a localized electron at an occupied f site is annihilated and instead a conduction electron is created [com pare discussion below Eq. (32)].

In Fig. 4, the renorm alized f level \mathbf{n}_{f} and the averaged f occupation $h\mathbf{n}_{i}^{f}$ i are plotted as functions of the original f energy \mathbf{n}_{f} . The momentum degeneracy has been xed at f = 4. As is seen, the l = f corrections do not only cause a dependence of the results on the degeneracy f (as shown in Fig. 3) but also lead to a reduction of the stability range of heavy Ferm ion type solutions.

The 1= $_{\rm f}$ corrections also a ect the therm odynamic properties of the system. In Fig. 5 the tem perature dependence of the averaged f occupation $\hbar_{\rm i}^{\rm f}$ is shown where $_{\rm f}$ has been xed to $_{\rm f}$ = 4. We observe that $\hbar_{\rm i}^{\rm f}$ i goes with increasing tem perature much faster to 1 than the SB results. Thus, the 1= $_{\rm f}$ corrections lead to a lowering of the

K ondo tem perature T_K which may be dened as that tem perature at which $h\hat{\tau}_i^{\dagger}$ i becomes 1.

As can be seen from Fig. 4, the analytical PRM solution breaks down when the unrenorm alized f level becomes smaller than some critical values. A similar behavior is also known from the SB solution. For instance, the solution for \mathbf{n}_i^f breaks down when for xed ", the chemical potential is increased beyond some critical value [12]. The reason for this breakdown is not completely clear. May be, it is due to some rough approximation used both in the PRM treatment and the SB theory, for instance those from Sect. IIIA which have their counterparts in the SB treatment. A lternative, the breakdown of the PRM and the SB solutions might be a signature of a genuine phase transition. Recently it was suggested [13] that in certain system s like CeCu2Si2 there m ight be a transition between an intermediate valence regime with uctuating f charges and a regime with integral f charge when the pressure is decreased. In the integral regime which is described by the K ondo H am iltonian there is no longer a renorm alized f level at the Ferm i level. This might be the reason that the self-consistent solution for \mathbf{u}_{f} no longer exists. Note however that such a phase transition does not appear in a recent alternative discussion of the PAM on the basis of Hubbard operators in Ref. 12. This approach is based on an extended chain approximation and gives the same quasi-particle energies (51) and (53). However, it leads to completely di erent equations for the renorm alized u_f level and for the averaged f occupation h_1^r i. Results have been found which are very sim ilar to the SB solutions for those param eter regim es where the SB solution exists. In contrast, the PRM solution leads to substantial deviations from the SB results in particular for sm all values of f. Note how ever that apart from the 1= f corrections we have used sim ilar approxim ations as in the SB theory to derive our analytical solution.

V. CONCLUSIONS

In sum m ary, in this paper we have applied a recently developed projector-based renorm alization m ethod (PRM) to the periodic Anderson m odel (PAM) in the limit of in nitely large C oulom b repulsion at f sites. By using an additional factorization approximation we have derived renorm alization equations for the parameters of the H am iltonian. In this way, the PAM is mapped to a free system consisting of two uncorrelated quasiparticle bands. Similar uncorrelated H am iltonians have been also derived before by di erent theoretical approaches, such as the Gutzwiller projection [5] and the SB theory [6, 7] where 1 = f expansions have been exploited. In contrast, the present approach is valid for any f. Due to the factorization approximation certain expectation values enter which prevent a direct numerical evaluation of the renorm alization equations. In principle, the expectation values could be determined self-consistently by deriving additional renorm alization equations also for the operators which enter the expectation values. This has not been done in this paper.

To obtain instead an analytical solution we have used a renorm alized f level which was assumed to be constant during the renorm alization process. The spirit of this approximation is similar to that used in the SB theory [6, 7]. We obtain self-consistent equations for the renorm alized f level n_f and the averaged f occupation m_i^f is which are quite similar to those of the SB theory [7]. In particular, in the limit f! our solution perfectly agrees with the SB result but strongly dilers from it for smaller values of f. To compare our results in more detail with those of the SB approach we have also considered an one-dimensional PAM with a linear dispersion relation of the conduction electrons and a k independent hybridization. Note that the character of the obtained two quasi-particle bands of the two treatments diler. We hereas the quasi-particles of the SB theory change their character as function of k from a more f-like to a more c-like behavior and vice versa the excitations of the PRM treatment do not change their character. Instead, the quasi-particle energies show jumps as function of k where, however, the various parts of the quasi-particle bands t perfectly together. The in uence of the degeneracy f has been studied by varying f with xed $f V^2$. We hereas the SB results are alm ost unchanged, our analytical results show a remarkable dependence on the degeneracy f. Especially, serious deviations are found for small values of f.

Finally, from a more technical point of view, note that in in this paper the PRM method was applied to a physical system for the rst time without using any perturbation theory.

In this appendix we illustrate the usefulness of the projector-based renorm alization m ethod (PRM) for the case of a simple m odel. W e apply the approach of Sec. II to the exactly solvable Fano-Anderson m odel [3, 4]. This m odel was already discussed in the fram ework of the present approach in R ef. 8. How ever, now this will be done in a consequent non-perturbative m anner.

1. M odel

The Fano-Anderson m odel consists of dispersionless f electrons which interact with conducting electrons. Thereby all correlation e ects are neglected. The H am iltonian reads

2. Renorm alization ansatz

In the renorm alization approach we integrate out particle-hole excitations of conduction and f electrons which enter due to the hybridization term H_1 . We expect to nally obtain from the PRM an electively free model. The starting point of the method is a renormalized Hamiltonian H which is obtained after all excitations with energies larger than a given cuto have been eliminated. As it turns out, no renorm alization of the hybridization V_k occurs so that V_k is assumed to be independent from the beginning. Like in the exact diagonalization di erent k states do not coupled during the renorm alization process. Thus, by elim inating excitations from large to low values, each k state is renorm alized only once leading to a step like renorm alization behavior. This means, for a given cuto all k states with excitations J'_k "fj> have already been renorm alized whereas those with J'_k "fj< have not. Note that the nalresult (A14) corresponds to the diagonal H am iltonian of eq.(A2). In particular, all expectation values completely agree between the two approaches. (To calculate expectation values by using Eq.(A14) one also has to transform the operators which enter the expectation values. Form one details see Ref. [8].) However, in contrast to the eigenmodes $\frac{y}{km}$ and $\frac{y}{km}$ of (A2) the present eigenmodes f_{km}^y and c_{km}^y do not change their character as function of the wave vector. Remember, $\frac{y}{km}$ was a more f-like excitation for $\mathbf{r}_k < \mathbf{r}_f$ and a more c-like excitation for $\mathbf{r}_k > \mathbf{r}_f$, and vice versa for $\frac{y}{km}$.
