Enhancem ent of Josephson phase di usion by microwaves

We report an experimental and theoretical study of the phase disusion in small Josephson junctions under microw ave irradiation. A peculiar enhancement of the phase disusion by microw aves is observed. The enhancement manifests itself by a pronounced current peak in the current-voltage characteristics. The voltage position V_{top} of the peak increases with the power P of microw ave radiation as V_{top} / $\frac{1}{P}$, while its current amplitude weakly decreases with P. As the microw ave frequency increases, the peak feature evolves into Shapiro steps with site slope. Our theoretical analysis taking into account the enhancement of incoherent superconducting current by multi-photon absorption is in good agreement with experimental data.

One of the most spectacular indications of the Josephson e ect is locking of Josephson oscillations to the frequency of external microwaves. As the Josephson frequency is proportional to voltage, the locking leads to appearance of steps at quantized voltages—so called Shapiro steps [1, 2]—in the current-voltage characteristic (I-V curve) of a Josephson junction. At the Shapiro step, the superconducting current owing through the junction oscillates coherently with the external microwave. In this letter, we describe a strong incoherent junction response to applied microwaves observed in small mesoscopic Josephson tunnel junctions in the presence of thermal uctuations and dissipative environment.

Sm all m esoscopic Josephson junctions have received a great deal of interest. They display such peculiar phenom ena as the quantum and therm all uctuation—induced escape [2, 3], Coulomb blockade elects [4], Josephson phase di usion [5, 6], to name just a few. The signicance of these various elects depends on the ratio of the Josephson energy \mathbf{E}_{J} to the charging energy \mathbf{E}_{C} and on the thermal uctuations. Here, we will deal with properties ofm oderately small Josephson tunnel junctions, with the ratio of $\mathbf{E}_{\mathrm{J}} = \mathbf{E}_{\mathrm{C}}$ 1, and \mathbf{E}_{J} ' \mathbf{k}_{B} T, which corresponds to the phase di usion regime induced by thermal uctuations.

The Josephson phase di usion in small junctions has been studied in detailboth experimentally [5,7] and theoretically [8,9]. Recently, the phase di usion regime has been observed also in layered high-temperature superconductors [10]. The characteristic feature of this regime is the absence of pure zero-voltage superconducting state accompanied, however, by a hysteresis in the I-V curve. The phase di usion behavior is a consequence of frequency dependent damping [5], i.e. the dissipation can be rather weak at zero frequency but it reaches a substan-

tial value at frequencies close to the plasm a frequency $!_{\,p}$ of the junction. That leads to a di usion of the junction state with time in the Josephson phase space.

The in vence of microwave radiation on Josephson tunnel junctions is, in general, well understood. There are such well-known e ects as Shapiro steps mentioned above, photon assisted tunneling of quasiparticles [2], and resonant escape of the Josephson phase [3,11]. However, the in vence of microwave radiation in the Josephson phase division regime got so far very little attention. While being interesting by itself, the microwave-driven phase division is also an implementation of a very general phenomenon as the ac driven division of a particle in a periodic potential [12, 13, 14].

In this Letter, we report on novel behavior induced by microwaves in small Josephson junctions. For low microwave frequencies, the autonomous I-V curves of the studied junctions display a characteristic phase diffusion branch close to zero voltage, which evolves into a pronounced peak shifting to higher voltages as the power P of the microwave radiation increases. We explain this behavior as an enhancement of the Josephson phase di usion by microwaves. Our analysis carried out for relatively low microwave frequencies!

!p takes into account both incoherent superconducting current and multi-photon absorption (emission). As the frequency of microwave radiation increases, a crossover to well-separated Shapiro steps with a nite slope is observed.

For the experiments, we have fabricated several sub-micron size Nb/A $\rm lO_x/Nb$ Josephson tunnel junctions. The junction area was de ned in a sputtered Nb/A $\rm lO_x/Nb$ trilayer by using electron-beam lithography and reactive ion etching. For insulation of the trilayer edges we used highly cross-linked PMMA [15]. The critical current density of the trilayer is about 220 A =cm 2 . We have measured several sub-micron junctions of comparable dimensions, which all showed similar behavior. Measurements presented in this paper have been performed on a junction having the area of

0:07 m 2 as estimated from its normal resistance R $_{\rm T}$. The Josephson coupling energy calculated from the estim ated uctuation-free critical current of $I_c = 150 \, nA$ (taken as a half of the current rise at the gap voltage V = 2 = e, which is close to the maximum expected Am begaokar-Barato critical current $I_{AB} = (2eR_T)$) was $E_J = I_{c=0} = (2) = 4.9 10^{23} J$, where $_0 = h = (2e)$ is the magnetic ux quantum. We estimated the speci c capacitance C $_{\rm s}$ = 46 fF/ m 2 of the Josephson tunnel barrier by measuring the voltages of Fiske steps in long junctions made of the same trilayer. The charging energy $E_C = e^2 = (2C)$ corresponding to the junction capacitance C was about 0:91 10^{23} J, yielding the ratio $ofE_J=E_C$ 5:4. M easurem ents have been perform ed at a tem perature $4.2 \, \text{K}$, yielding $k_B \, \text{T} = 5.8 \, \text{M} \cdot \text{M} \cdot$ the data presented here approximately fall into the param eter range of k_B T E_C. E_{J}




FIG. 1: Current-voltage characteristics of Nb/AlO $_{\rm x}$ /Nb Josephson tunnel junction at 42K.Dierent curves show the e ect of increasing microwave power of the frequency 0.859GHz (a) and 40GHz (b). The microwave power levels are referenced to the top of the cryostat.

The measured I-V curves of the junction under microwave irradiation are shown in Fig. 1. We present here data for one polarity of the bias current, as the curves were found to be symmetric with respect to the origin. M icrow aves induce a pronounced peak in the I-V curve which shifts towards larger voltages with increasing the microwave power. Simultaneously, we observe the suppression of the superconducting energy gap branch, which we interpret as the well-known photon-assisted quasiparticle tunneling [2]. For low frequency f of microw aves, as shown in Fig. 1(a), both the peak voltage position and its voltage range are much higher than the expected voltage spacing between the Shapiro steps. As the microw ave frequency fincreases, the low-voltage part of the peak splits into several well-separated steps with nite slope, as seen in Fig. 1 (b). The expected Shapiro step voltage spacing here is V = ٥f 83 V, which m atches the observed magnitude of the voltage jumps between the low-current features in the I-V curves in Fig. 1(b).




FIG. 2: Dependence of the voltages V_{top} (solid circles) and $V_{m\ id}$ (open circles) and the current I_{top} (triangles) on microw ave eld amplitude / P. The values of V_{top} and I_{top} are measured at the switching point on the top of the microw aveinduced peak on the I-V characteristics. The voltage $V_{m\ id}$ refers to the middle (half-height) point of the peak. Dashed line is a linear t to V_{top} (P)

The voltage of the peak increases with the power P of m icrow aves. Figure 2 shows the measured voltage $V_{\rm top}$ at the switching point on the top of the peak as a function of the microw ave eld amplitude / $\stackrel{\cdot}{P}$. One can see that the voltage $V_{\rm top}$ rises proportionally to the amplitude of the applied microw aves. The current amplitude of the peak decreases with power, as summarized in Fig. 2.

Next we turn to the analysis of the I-V curve of a small Josephson junction in the phase di usion regime. A Josephson junction is characterized by the Josephson phase ' (t) satisfying the equation:

In this equation, j is an external dc bias, and ! are am plitude and frequency of an external m icrow ave radiation, (t) is a random function of time t describing thermal uctuations. Here, we use dimensionless units, i.e. the time is normalized to I_p^{-1} , the dc bias is normalized to the critical current value I_c . The dissipative e ects

are described by parameter—that, in general, can be frequency dependent. The presence of hysteretic regime in the observed I-V curves allows to propose a simple model, assuming that the low frequency damping $_0$ determining the quasiparticle current is weak ($_0$ —1) but the high frequency damping—is large. As the Josephson coupling energy E $_{\rm J}$ is comparable with the energy of thermal uctuations $k_{\rm B}\,T$, the incoherent superconducting current can be found from the following analysis. In the absence of applied microw averadiation the Josephson

phase is written as

where (t) = $\frac{1}{2}\frac{R_t}{0}$ (t)dt determ ines the Josephson phase di usion. Here, the dc voltage drop across the Josephson junction V is normalized to $V_p = 0!_p = (2) = \frac{1}{2e}\frac{P}{8E_JE_C} = 0.187\,\text{mV}$ as $V = V = V_p$. In this case, the term V_1 (t) is expressed through the alternating part of the superconducting current

The dc component of the incoherent superconducting current is found as

where (t) = < cos((t) (0)) > is the correlation function of a random part of the Josephson phase. This

correlation function has been studied in detail for di erent models in [6, 8] and, in the simplest case of G aussian random function (t), the (t) has a di usive form (t) = $\exp($ t). Substituting this expression into (4) we obtain [2, 8]




FIG. 3: Comparison between our theoretical model and experiment for the frequency $f=0.859\,\mathrm{G\,H\,z}$. Dots are experimentally measured data; the dashed line corresponds to Eq. (5) and solid lines correspond to the theoretical prediction according to Eq. (9).

This dependence is tted to our P = 0 data by using = 0:53 and = 4:7. It is shown in Fig. 3 by dashed line. As expected, it is in a good agreement with the experimentally measured I-V curve in the absence of microwaves. We note that the above value of translates into the high frequency in pedance seen by the junction Z = V_p 0=(2 $k_B T$) 570, which is not far from the expectation that the bias leads in pedance is typically of the order of 100.

In the presence of m icrow ave radiation of a frequency f = ! = (2) the Josephson phase can be written as

Applying the procedure that is similar to the above treatment of the Josephson phase di usion without microw ave radiation, we obtain the enhancement of superconducting current. This enhancement is due to incoherent absorption (emission) of photons by Josephson phase

where J_n (x) is the Bessel function of index n, and n the number of photons. By making use of the properties of Bessel functions [16] and the lim it ofm ultiphoton absorption (n 1) the superconducting current can be written in the following form

where 0 = $^-$ / $^{\rm p}$. By substituting expression (5) into (8) we obtain that the superconducting current displays a pseudo-resonant feature, i.e. a peak with downward curvature. The voltage position V_0 of this peak increases with the power of microwave radiation as $V_0 = V_p^{-0}$ / $^{\rm p}$. The equation for I_s (V) can be presented in the analytical form :

where we introduced the notations $v = (V - V_0) = V_p$ and $f(x) = (\frac{p}{x^2 + 2} - x) = (x^2 + 2)$.

Thus, the maximum value of the superconducting current at V_0 V_p weakly decreases with the microwave power P as

The total I-V curve is the sum of the superconducting and quasiparticle currents I (V) = I $_{\rm S}$ (V)+ $_{\rm 0}$ V (note here that only the part of the curve with the positive derivative is stable). However, the low frequency damping $_{\rm 0}$ is small and we neglect the quasiparticle current $_{\rm 0}$ V in the following discussion.

Figure 3 presents a comparison of the experimental data with theory for the frequency $f=0.859\,\mathrm{G}\,\mathrm{Hz}$. Solid lines correspond to the theoretical prediction according to Eq. (9). Our analysis is in excellent agreement with the observations. The theoretical curves in the presence of microwaves are obtained by thing a single experimental data set for the microwave power level of $P_0=30\,\mathrm{dB}$ and by calculating all other curves according to their power levels relative to P_0 . Note that we used for this procedure the parameters and obtained from thing the P=0 data to Eq. (5) as mentioned above.

As the microwave frequency fincreases, the smaller values of n contribute to the expression (7) and the discrete Shapiro steps having the nite slope appear on the I-V curve, see Fig. 1 (b). Our analysis based on Eqs. (8) and (4) can be extended to describe the Josephson phase di usion in more complex cases. It can be applied to Josephson junctions embedded in a frequency dependent environment, e.g. in the presence of resonances in an extemal circuit [7], or to a weak Josephson phase di usion with voltage-dependent parameter . As the parameter is small, i.e. ! , the latter regim e is of particular interest because the analysis of Eq. (7) shows that at som e ac power zero-crossing steps can appear in the I-V curves [17]. M oreover, we have observed such incoherent zero-crossing steps at 4.2 K for Josephson junctions of an interm ediate size with E_J kg T [17]. Sim ilar incoherent zero-crossing steps have been also seen in have been also seen in intrinsic junctions based on high-tem perature superconductors.

In sum mary, we have measured the e ect of microwaves on mesoscopic Josephson junctions with characteristic energies $E_{\,\rm C}$ $E_{\,\rm J}$ $k_{\!\rm B}\,T$. In contrast to the behavior of larger Josephson junctions with $E_{\,\rm J}$ $k_{\!\rm B}\,T$, which display well-known discrete Shapiro steps due to locking of their Josephson oscillations to microwave frequency, for small junctions we not a smooth and incoherent enhancement of Josephson phase diusion by microwaves. This enhancement is manifested by a pronounced current peak at the voltage V_{top} / P . We have proposed here a theoretical model for the microwavestimulated phase diusion which showed excellent agreement with the measured data.
