Dynamical Correlations as Origin of Nonextensive Entropy

A bstract

We present a simple and general argument showing that a class of dynamical correlations give rise to the so-called T sallis nonextensive statistics. An example of a system having such a dynamics is given, exhibiting a non-Boltzmann energy distribution. A relation with prethermalization processes is discussed.

1 G eneralized statistics and correlations

In the recent paper by J.Berges et al. [1], the authors show that the dynam ics of a quantum scalar eld exhibits a prethern alization behavior, where the therm odynam ical relations become valid long before the real therm all equilibrium is attained. There, although the system is spatially hom ogeneous, the single particle spectra are different from those determined by the usual Boltzmann equilibrium. This means that the validity of them odynamics does not imply thermal equilibrium in the sense of Boltzmann.

Such a situation has also long been claimed by T sallis [2, 3], who introduced the q-entropy, de ned in terms of the occupation probabilities fpg of the microstate by

instead of the usual entropy S [fp g] = p ln p . All therm odynam ical relations are derived from the maxim ization of this q-entropy,




Figure 1: Schem atic illustration of the e ect of a strong correlation among two variables for m in im izing a function.

is the q-biased average of the energy. It is shown that, although the therm odynam ical Legendre structure is maintained, the energy spectrum for such a system is not given by Boltzmann statistics but behaves asymptotically like a power in E [2, 3]. In other words, the thermal equilibrium in the sense of Boltzmann is a su cient condition, but not a necessary one for the thermodynam ic relations to be valid. Extensive studies have been developed [3] and the applications of T sallis' entropy extend to biological systems, high-energy physics, and cosmology. However, in spite of these studies, the dynamical origin of the q-entropy and q-biased average of observables is not clear yet.

It has been suggested that T sallis' nonextensive statistics applies to a kind of m etastable state which is realized before the true therm all equilibrium, or to some stationary state having long-range correlation [3]. This is exactly another important result of J. Berges et al., that their preequilibrium state is attained long before the real equilibrium is reached, that is, the system seems to attain rst this preequilibrium, then slowly goes to the real equilibrium. This rem inds us somewhat of the following situation which we encounter frequently in optimization problems. For example, let us consider the problem of noting a minimum of a function of two variables, as shown in Fig. 1.

When the function has a narrow long valley, the usual steepest descent method always rst goes to the closest point of the valley instead of going directly to the real minimum, as indicated by the dashed curve. The narrow valley means that there exists a strong correlation between the two variables. In other words, if there exist any strong correlations among variables, the minimizing path always tries to satisfy the correlation rst, then follows downstream to the true minimum along the valley generated by the correlation. If the correlation is strong enough, non Boltzmann distribution may result as the stable con guration of the system (see Ref. [5]).

The above consideration suggests that a preequilibrium statem ay correspond to a kind of narrow valley of the free energy of some subsystem generated by dynamical correlations of the system. If such a local minimum stays for a very

long time, we may consider the system as in equilibrium, but the microscopic occupation probability is not that of the Maxwell-Boltzmann distribution. Then what characterizes such a local equilibrium? We suggest here that a general form of T sallis' statistics is one answer. Of course, prethern alization involves a broad range of phenomena, and has been studied for a long time in several works (for recent references, see [4]). Here we concentrate on the discussion of how the states described by the T sallis nonextensive statistics can be regarded as a kind of prethermalized states.

Let us consider a system composed of N particles and let fE g denote the single-particle spectrum of the system and fN g be the corresponding occupation numbers. We further assume that the system is dilute enough that the interaction energies are negligible. Then, by de nition, E = N E and N = N are, respectively, the total energy and total number of particles of the system. Suppose there exists a strong correlation among any q particles of N in any single-particle state. Then the number of possible ways of forming such correlated subsystems in each state is given by

for N $\,$ q. Note that here, q does not have to be integer. We call these correlated systems q-clusters. The total number of ways of forming q-cluster states for the whole system is

If the q-clusters are form ed w ith equala prioriprobability, thus proportional to the number of ways of forming them , then the average energy per cluster particle is $\frac{1}{2} \int_{-\infty}^{\infty} \frac{1}{2} \left(\frac{1}{2} \int_{-\infty}^{$

where $p = N \rightarrow N$ is the probability of a particle occupying state:

Now, we further assume that the dynamical evolution of the system is such that, for a given number of q-clusters, the conguration of the system tries to minimize the energy of the correlated subsystem. The narrow valley in Fig. 1 corresponds to these \ground states" of the subsystem formed by q-clusters. Neglecting the component perpendicular to the narrow valley, the equilibrium corresponds to minima of the expectation value he i $_{\rm a}$,

This is equivalent to the variational problem,

which determ ines the probabilities p. We obtain:

where Z $_{\alpha}$ = A $^{1=\,(1-\,q)}$ is a normalization factor. W e see that this expression is nothing but the T sallis distribution function, if we put $^{1} = (q 1)$. Note that there was no need to introduce the concept of entropy yet. The Tsallis entropy here corresponds to the simple normalization condition for the number of q-clusters.

It is important to note that the minimization condition, Eq.(10), of the energy of the correlated subsystems under the constraint Eq.(9) determines completely the occupation probabilities for the whole system as functions of A and of the single-particle spectrum, p = p (A; fEig). When we change the external param eters of the system, such as the volum eV, then the single-particle spectrum will su er a change. However, if the dynamics of the system is such that the number of correlated particles q is kept constant during slow changes of V and N, then we can consider V, N, and A independent \state" param eters, since the occupation probabilities for the system are completely determined by these variables. We can thus calculate the total energy as function of them as

Comparing the variation of this energy function with the First Law of Thermodynam ics, E = P V + T S + N, we can identify the pressure

Eq. (14), implies that we can relate the parameter A to the entropy of the system, up to an arbitrary function f(A),

If we take $f(A) = \ln A = (1 q)$; then

is the Renyi entropy. If instead we take f(A) = (A - 1) = (1 - q); S corresponds exactly to the T sallis entropy (1). This indeterm inacy is obvious also from Eq. (10), since the constraint term $(p^q - A)$ can also be taken as $p^q = p^q$ of (A) without changing its signicance, for any single-valued function f. Thus, it is clear that the exact form of f is not essential in our approach.

We should stress that the therm odynam ical properties of the preequilibrium state discussed above are not the nonextensive ones discussed by T sallis et al. [2, 3]. There, the therm odynam ical and statistical properties for q-m odi ed values are studied. In the present approach, the q-m odi ed quantities refer to the subsystem of q-clusters. When we want to calculate, for example, the internal energy of the system, the relevant quantity is not he iquilibrium between pressure and energy density given by Eq. (13), will apply in mediately as the real physical relation which can be used, for example, in hydrodynamical calculations. However, the \entropy here is not the real entropy of the whole system but just recent the total number of clusters among correlated particles. Thus, the time evolution of this quantity is not guaranteed to obey the Second Law of Thermodynamics, that is, dS=dt 0. Hereafter, in order to distinguish from the real entropy, we call this S the \pseudo-entropy" of the total system.

On the other hand, note that the variational equation Eq. (10) can also be obtained as that of maxim izing the cluster multiplicity M at a xed average energy per cluster. We would have the variational equation,

where $E_{\rm C}$ is the average energy per cluster, and and are Lagrange multipliers. This leads to the same equation as Eq. (10). Since M is the total number of possible ways to form clusters, we can de ne the \entropy" of the system of clusters by $S_{\rm q} = \ln M$; and this corresponds to the Renyi entropy, Eq. (17). Therefore, Eq. (10) is nothing but the maxim ization of the entropy de ned only

for the restricted subspace corresponding to the degrees of freedom of clusters in the entire phase space of the system .

In the above discussion, we considered the value of q, i.e., the number of strongly correlated particles as constant for any single-particle state. However, in a more general case, they may be dierent for each single-particle state and may even depend on the proper occupation numbers p. Therefore, for a more general form of the correlation pattern, the number of cluster states M should be written as

where F [fp g] are functionals of fp g: Then, the Eq. (10) should have the form

The resulting probabilities p will not be of the form of Eq. (11) anymore, yet functions of V , N , and M . This suggests that the preequilibrium state can be attained for a wide variety of single-particle spectra and the corresponding pseudo-entropy will be given as a function of M , S = f (M) = f (M). This is presumably the most general form of the pseudo-entropy. However, we should recall that it does not necessarily possess the properties of entropy required by the usual thermodynamics because the state specied by Eq.(20) does not correspond to the conventional equilibrium of the system .

2 Example

D iscussion in the previous section indicates what kind of dynam ical correlations m ay lead to T sallis type occupation probability distribution. Just to see a concrete example let us consider a very $\sin p$ let oy m odel described below.

- 2. Choose random by a pair of particles, say, i and j:
- 3. Energies of i and j are updated according to one of the following alternatives:
 - (a) The new energies are set to the lower one of E_i and E_j ; that is, E_i ; E_j ! $E_i^0 = E_j^0 = M$ in $(E_i; E_j)$, then choose another k-th $(k \in i; j)$ particle random ly and attribute $E_k^0 = E_k + M$ ax $(E_i; E_j)$ M in $(E_i; E_j)$ to conserve the total energy.
 - (b) Change the energies as E_i ! $E_i^0 = E_i$ E and E_j ! $E_j^0 = E_j$ E, where E is the level spacing. Here, if one of E_i^0 ; E_j^0 becomes negative, then this step is skipped. That is, we have to keep always E_i 0.

4. The alternatives (a) and (b) are chosen random ly, but the ratio of the average frequency of (a) to (b) is kept as a constant, r.




Figure 2: Energy spectrum after a large number of collisions per particle, starting from a distribution peaked at hE i = 22.5. The probability of cluster-forming collisions ranges from r=0.1 (top) to r=0.00001 (bottom). T sallis distributions tted to the calculated spectra are also shown, together with the corresponding q-values.

It is well-known that for r = 0 in the above model, the ultim at singleparticle spectrum will be the Boltzm ann distribution. When r > 0, the collisions of type (a) are forming a kind of cluster, while the collisions of type (b) may destroy a correlation formed before. Thus, we expect the number of correlated particles will reach some stationary value. Furtherm ore, by construction, the energy of a correlated pair always tends to dim in ish. In this way, we may expect that the above system will lead to the situation described by Eq. (10). In Fig. 2, we show the results of simulations, for several values of r from 0:00001 to 0:1. It is interesting to note that r > 0 leads to a non-Boltzm ann distribution which is well approximated by the T sallis distribution, $p_a = C = [1 + (q \quad 1) \quad E]^{1 = (1 \quad q)}$, where = 1=(3 2q) hE i and C = (2 q)=(3 2q) hE i are determined from the normalization condition and conservation of energy. One parameter ts with respect to qwere performed and the results are indicated by the continuous curves in this gure. For r! 0, the spectrum converges to the Boltzm ann distribution p_a ! $e^{E = hE i}$ as expected. Note that for a one dimensional case like the present model, the T sallis distribution is valid only for q < 3=2, otherwise the energy expectation value diverges. For larger values of r, the tted value of q tends to this limiting value, but the distribution begins to deviate substantially from the T sallis distribution in the low energy region.

It is important to note that these distributions are the stationary and stable ones. We can me that starting from any different initial conditions, the system always converges to the same and distribution, uniquely determined by the reparameter. Furthermore, the convergence for r>0 is much faster than for r=0. For example, taking r=0.01 we and that the distribution converges 10 times faster than for r=0.

In the above toy model, time reversal is violated in type (a) collisions. However, this is not the crucial factor to obtain the non-Boltzmann distribution. We have checked this in a more elaborate model which has time-reversal invariance.

3 Conclusions and perspectives

We have shown that a very simple mechanism of dynam ical correlations am ong particles may lead to a state described by the so-called nonextensive statistics of T sallis. It is shown that the nonextensive statistics can be interpreted as the statisticalm echanics for a subspace de ned by these strongly correlated clusters in the entire phase space of the whole system. Furtherm ore, the requirement of the minimum energy per cluster or the maximum \entropy" of the subspace de nes the thermodynamical properties of the whole system too. There, the energy is de ned by the usual sum of single-particle energies multiplied by their occupation probability, and not by the q-weighted average of the energy. We have also shown a toy model for which such a mechanism actually takes place.

In this exam ple, the stationary state is attained with a single-particle spectrum which is well represented by that of T sallis statistics. These stationary non-Boltzm ann distribution are attained much earlier than the case of no correlations, hence the Boltzm ann equilibrium. The reason for reaching the stationary distribution much earlier than the real thermal equilibrium is that the formation of correlated clusters serves as a kind of catalyzer to distribute the energy among particles more eciently, involving more than 2-body collisions. In this aspect, the dynamical mechanism responsible for the non-Boltzmann distribution is similar to that of the kinematical approach discussed by Rafelski et al. [6]. Many exam ples of systems for which T sallis statistics have been applied may also be interpreted in our scheme easily. We also found that this non-Boltzmann equilibrium may happen not only with a power type but with a much wider class of single-particle spectra.

The present work is rather phenom enological and so the conclusion is still speculative. More theoretical work based on realistic eld theoretical models should be developed. Further investigations in this line are in progress. This work has been supported by CNPq, FINEP, FAPERJ, and CAPES/PROBRAL.
