A lossy transmission line as a quantum open system in the standard quantum lim it

We system atically investigate how to quantize a transm ission line resonator (TLR) in a mesoscopic electrical circuit in the presence of the resistance and the conductance of the dielectric media. Developed from the quantum bath based electrive Hamiltonian method for single mode harmonic oscillator, the approach we presented in this article is a microscopic theory integrating quantum uctuation-dissipation relation. To qualitatively check the condition under which the TLR can behave as a quantum object we study the classical-quantum boundary characterized by the standard quantum limit.

An ideal one-dim ensional transmission line resonator (TLR) can be described by a classical wave equation and thus can be quantized [1] as usual by following a standard procedure - the canonical quantization approach [2]. Such a quantization formalism is not treated as a serious issue in the usual realities. Most recently, however, the situation has been changed radically due to the rapid progresses in solid state based quantum computing (QC). In one of such QC schemes a one-dimensional TLR is used to coherently couple one orm ore Josephson junction (JJ) qubits [3{6]. In order to create controllable quantum entanglem ents am ong these JJ qubits, the TLR has to work in a quantum manner as a quantum data bus linking these qubits. O therw ise the TLR can not induce an e ective inter-qubit interaction. One can imagine this in the conventional cavity QED: the classical cavity mode in the strong eld lim it do not induce inter-atom interactions to form quantum entanglement of the qubits.

The above arguments show that the validity of the TLR based quantum computing strongly depends on whether the mode of TLR is truly quantized, that is, has som e observable quantum e ects. In this sense, the way to quantize the modes of the TLR and the corresponding quantization condition become fundamentally important for applications of TLR in quantum inform ation processing. In this article we devote to answer this question in a more realistic situation taking into consideration of leakage. Furtherm ore, we will try to nd out what characterize the boundary between the quantum and classical regime for the lossy TLR by exam ining the so-called standard quantum lim it (SQL) [7,8], which, as a consequence of the Heisenberg uncertainty principle, is usually referred to as the fundam ental lim it of the precision of repeated position measurements. In the modern technology based quantum measurement it was recognized that if one can reach the SQL in the experim ents, the quantum behavior is observable even form acroscopic objects. Most recently LaHaye et. al. [9] described such an experiment with the goal to test SQL on a vibrating nano-mechanical beam that is about one-hundredth of a m illim eter. This excites our interest on the sim ilar prob $\mbox{\it lem}$ about the actual boundary between the classical and quantum $\mbox{\it regim}$ e for the T LR .

To start with we consider the quantization of the m odes of the one-dim ensional lossy TLR. In our model the lossy TLR is treated as an open system interacting with a bath, a therm alenvironment. It may be a background electrom agnetic eld interacting with the transm itted charge in the TLR, or the classical lead connected to the TLR, or other damping mechanism. Mathematically the lossy TLR can be well depicted by a wave equation with leakage and its Fourier components obey the typical dissipation equation. In this sense, the idea and m ethods developed in our previous works [10 {12] on quantum dissipative system can be applied to the present discussion. We will show that the interaction with the bath leads to an explicit description for the TLR in terms of the generalized Caldirora-Kani (CK) e ective Hamiltonian. We also examine how the quantum and therm al uctuations of the environm ent contribute to the uncertainty of the canonical variables of the lossy TLR.

To be universal we rstly revisit the derivation of the classical wave function for the lossy TLR in high dimensional case. The model is depicted by four lumped parameters, the distributed resistance r, the distributed conductance g of the dielectric media, the distributed inductance land distributed capacitance cper unit length. Let V = V(x;t) and I = I(x;t) be the distributions of the voltage and the current vector respectively. With the conservation of the current, the Kirchho's voltage law leads to the equations of motion [13]

E lim inating the current vector in the above two equations we obtain the high dimensional lossy wave equation for the voltage [14].

where $v = \frac{1}{lc}$ is the velocity of propagation or phase speed. For an isolated conductor there does not exist the current along the norm direction of the surface

of conductor and one thus have the boundary condition $I_n j_{boundary}$ I $n_b j_{undary} = 0$ where n is the direction of the norm of the boundary surface. Combining with the equations of motion, Eq.(1) leads to the boundary condition n $r V_b j_{undary} = n$ $r I = 1 \frac{\theta I}{\theta t} = 0$ for the voltage equation. To be speciations for the current I(x = 0; t) = I(x = L; t) = 0 of an isolated 1-d TLR of length L. The corresponding boundary conditions for voltage equation is $V_x(x = 0; t) = V_x(x = L; t) = 0$. In the following discussion we will focus on the quantization of the 1-d lossy TLR with such boundary conditions.

A canonical quantization scheme for an ideal 1-d lossless TLR can be found in Louisell's monograph with an implied Hamiltonian [1]. But for the lossy TLR as an open system the energy does not conserve and thus there does not exist a time-independent Hamiltonian a priori. Hence it is necessary to develope a quantization scheme only based on the classical equation of motion. In the very original paper of quantum mechanics by Heisenberg, however, without knowing the Hamiltonian or Lagrangian beforehand the classical equation of motion is su cient to solve the quantized energy levels of linear oscillator. The modern version of this idea was presented in the fam ous textbook by Landau and Lifshitz [15]. Following this method we even quantized the quantum dissipation system [10{12] to re-deduce the so-called CK e ective Hamiltonian [16{18] directly from the classical equation of motion for the open system with the linear coupling to the 0 hm ic bath [19].

Now we quantize the modes of the lossy TLR by developing our previous approach mentioned above. We can start from the lossy voltage equation

with boundary condition V_x (0;t) = V_x (L;t) = 0. The time-dependent Fourier's components V_n (t) of V (x;t) corresponding the normal mode $\frac{2}{L}\cos\frac{n-x}{L}$ just satises the dissipation equation

To $\,$ nd out the canonical com m utation relation for the dynam ical variables V_n (t) and $\frac{d}{dt}V_n$ (t) we calculate the time evolution of their commutator B (t) = $[\![V_n]\!]; \frac{d}{dt}V_n$ (t)] using the equation of motion (4), obtaining the close equation $\frac{d}{dt}B$ = $[\![B]\!]$. That means B / e t , or

Here we choose the elective mass M $_n=\frac{c}{l_n^2}$ so that we can get a correct expression for the energy of TLR. Therefore, we can define the canonical momentum operators

Here we have ignored a time-dependent c-number $h!_n \cosh(t)$

The above e ective H am iltonian H can force the TLR to evolve into the multim ode squeezed state when the TLR is initially prepared in a multim ode coherent state ji j₁; 2;:::; $_n$;:::i where ji $_n$ denotes the n-th mode. This conclusion can be proved by rewriting H $_n$ as

Here, fA_ng is a new set of bosonic operator de ned as the unitary transform ation of a_n $A_n = S_n^y$ (t) $a_n S_n$ (t) by the squeezing operators [20]

We can also write down the explicit expressions $A_n=a_n=a_n^y$ with $=\cosh(t=2)$; $=\sinh(t=2)$. Then we obtain the evolution operator

which gives the the nal state j_n (t) $i = U_n$ (t) $j_n = e^{i!_n t}$;; as a squeezed state de ned as the eigenstate of A_n with eigenvalue $e^{i!_n t}$.

Studying the above results carefully, it seems that the above results are not totally convincing due to the violation of the uncertainty principle about coordinate V_n (t) and momentum P_n (t) because the above arguments are too phenomenological and the source of dissipation is not considered microscopically. Thus the Brownian motion can not be analyzed in the frame of the elective CK Hamiltonian formalism. What's more, if we would use the above CK Hamiltonian without restriction, some ridiculous conclusions are to be reached. Fortunately, we can solve this problem by demonstrating the derivation of the phenomenological CK Hamiltonian, starting with

the conventional system -plus-reservoir approach. Suppose the environment is a bath of many harmonic oscillators linearly coupled to the open system. The bath and system constitute a conservative composite system and thus its quantization is rather straightforward. As shown in our previous works, the total wave function is partially factorized with respect to system and bath when the Brownian uctuation can be ignored under certain conditions [10]. the factorized part of the system is just the CK elective wave function governed by the CK Hamiltonian. With the these recalls we now consider the damping mode equation

is a B row nian driving force. Here, $x_{j0}~(\underline{x}_{j0})$ are the initial values of the canonical coordinate (its $~\rm rst$ derivative w ith respect to t) of the harm onic oscillators of the bath that coupled to the transm ission line, $!_{\,n\,j}$ is the frequency of the j-th oscillator of the independent reservoir coupling to the n-th m ode of Q T L w ith the corresponding coupling constant c_{jn} .

The solution V_n (t) Q_n (t) + $p_{j-n,j}$ (t) of the above motion equation (12) can be solved as a direct sum of the dissipative motion

To revisit the quantum e ect of QTL, we need to consider the standard quantum lim it (SQL). If the measurement that probes it can reach the accuracy of the SQL, then the quantum e ect is observable. Obviously the standard quantum lim it of V_n is contributed by the measurement of QTL and the bath uctuation

is just the width of B rownian motion. The rst part of the above equation is just an average over the pure quantum state of the TLR. Thus we can use the uncertainty principle to determ ine the value of SQL. A coording to the commutation relation Eq.(5), the uncertainty relation means




FIG. 1. The time evolution of the standard quantum \lim it of the system in low temperature \lim it. The solid line shows the evolution of the SQL of the TLR while the dashed line shows that of the environment. Here the time is scaled in the unit of $\frac{1}{2}$

It is easy to see that as time t! 1, the standard quantum $\lim it j Q(t)j! 0$ (see Fig.1). If the quantum uctuation caused by the bath uctuation $_{nj}$ (t) is ignored inappropriately, the standard quantum $\lim it$ is zero after a long time evolution! We will show as follows that the quantum uctuation contributes a nonzero part as compensation.

W e notice that the second part of Eq. (16) is the thermal average over the reservoir states and the uctuation $^2_{\ n}$ at temperature T is

where k_B is the Boltzm an constant and T is the temperature. This is just the width of the Brownian motion, which characterizes the extent of uctuation around the damping path $Q_{\rm n}$. In the classical limit, known as the "Ohmic friction" condition, the uctuation can be evaluated as




FIG .2. The time evolution of the standard quantum \lim it of the whole system at low temperature \lim it. Again the time is scaled in the unit of $\frac{1}{2}$

As can be seen from Fig.1, in the low temperature $\lim_n t \cdot \frac{2}{n}$ (t) is zero initially, and then approaches its nal equilibrium value in a time interval of the order of l=. The above results shows the important $\lim_n t$ on the standard quantum $\lim_n t$ of TLR caused by the environment uctuation. It seem ingly depends on the details of the reservoir, but they can be universally summed up to the observable quantities of the TLR in certain $\lim_n t$ case. When the time is large enough, the total uctuation of the whole system approaches (see Fig.2)

If the damping rate $\,$ is much smaller than the frequency of the oscillator $!_{\,n}$, this width happens to become the same as the width h=(2M $_{n}\,!_{\,n})$ of the ground state of the mode, which is just the SQL of the quadrature amplitudes of the oscillator mode V_{n} (t).

To conclude this article let us estim ate the above result num erically according to the param eters given in the experim ental proposal in ref [3,4]. The eigenfrequency of the TLR mode in resonant with the Josephson junction qubit is about $10~\rm G~H~z$ while the dissipation rate is about $6.25~10^6~\rm H~z$. Then

where L is the length of the TLR. Thus if the precision of the experim ent can reach this limit, the quantum elect can be observed. We also note that our exploration in this article reveals the close relation between the SQL of the open system and the quantum uctuation of the environment: starting from the initial semi-classical state, each mode of TLR experiences a damping squeezing (see Eqs.(9-11)) before it reach the SQL. Once near the the SQL the quantum uctuation take place to play as a quantum noise against the in nite squeezing by quantum dissipation.
