Helical an isotropy and magneto impedance of CoFeSiB wires under torsional stress

Recent m easurements of the magnetoim pedance (at a xed frequency of 1 M Hz) of cobalt-rich wires subjected to torsion stress show an asymmetry as a function of torsion angle stemming from residual anisotropies induced during wire fabrication. We interpret these measurements with a simple model based on the competition between a circum ferential magnetic anisotropy and another one induced by torsional and residual stress. This allows extraction of the physical parameters of the wire and explains the positive and negative torsion cases. The agreement between theoretical and experimental results provides a rm support for the model describing the behaviour of the anisotropy eld versus static magnetic eld for all torsion angles.

IN T R O D U C T IO N

The giant magneto-impedance e ect (GMI) in am orphous ribbons, wires and thin im shas become a topic of growing interest for a wide variety of prospective applications in storage information technology and sensors possessing high sensivity and fast response [1, 2].

M agneto-in pedance e ect (M I) consists in the change of in pedance introduced by a low-am plitude ac current I_{c} ow ing through a magnetic conductor under application of a static magnetic eld H_{dc} (usually parallel to the direction of the ac current). The origin of this behavior is related to the relative magnetic permeability $_{r}$ and the direction of the magnetic anisotropy eld H_{k} . When M I measurements are performed on wires, in jecting an ac current in the wire and applying a dcm agnetic eld H_{dc} along the wire axis, one probes the wire rotational permeability wire that controls the behaviour of the M I.

O rdinarily, the M I curve is symmetric with respect to the dcm agnetic eld H_{dc} with a single (at $H_{dc}=0$) or a double peak (when $H_{dc} = H_{max}$), the anisotropy eld of the wire being considered as the value of H_{max} . Applying a torsion stress to the wire alters its M I behaviour versus eld H_{dc} in a way such that one observes, for instance, a single peak only for positive stress and a double peak for negative stress.

Recent work by B etancourt and Valenzuela (BV) [3] tackled M Im easurem ents of C oFeB Siw ires subjected to torsion stress [10], at a xed frequency of 1 M H z, obtaining the aforem entioned asym m etry [4, 5] of the M I pro lew ith respect to torsion stress. Interpreting the asym m etry in terms of residual an isotropies induced during w ire fabrication [3] leads to an e ect that respectively counterbalances or enhances the w ire circum ferential an isotropy w ith positive or negative torsional stress.

The wires were prepared by the in-rotating water-quenching technique and have the nom inal composition $(C \circ_{94}Fe_6)_{72:5}Si_{2:5}B_{15}$. Their typical dimensions are 10 cm in length and 120 m for diameter. They possess a characteristic domain structure dictated by the sign of the magnetostriction coe cient $\frac{R}{s}$ which is expected to have a small value ($j_s^R j$ 10⁷ in these C obalt rich alloys). When $\frac{R}{s}$ is negative, an axially oriented magnetization core exists surrounded by circular domains [1, 2], whereas in the opposite case, radially oriented magnetization states exist such as those observed in Fe rich alloys [5]. A fler performing several measurements such as Barkhausen jump and magnetization reversal measurements [3], BV favor the negative sign for the $\frac{R}{s}$ coe cient and presence of helical anisotropy [10].

In this paper, a simple model for the anisotropy eld, based on the competition between an existing circum ferential anisotropy and a torsion-induced one with presence of residual torsional stress, is proposed. This model allows the extraction of the relevant physical parameters of the wire and explains the observed behavior in the cited work [3] as a function of the static magnetic eld for all torsion angles.

THEORY

In order to reveal the residual stress within the wires, positive and negative torsion stress [10] are applied and the e ect is analysed with M I response. Following the work of Favieres et al. [8] on cylindrical C oP am orphous multilayers electrodeposited on copper wires, we use a stress-induced easy axis making an arbitrary angle $_{T}$ [10] with the circum ferential direction (see g.1). We extend this model to include the presence of residual torsion stress induced by fabrication. The total magnetoelastic energy in presence of applied and residual torsional stress ($_{r}$) is:

where K_c is the fabrication induced circum ferential anisotropy of the wire and $\frac{R}{s}$ the rotational saturation m agnetostriction constant [11] (see g.1). We are in the linear case where the magnetoelastic energy is proportional to stress . Our energy functional does not include demagnetization nor Zeem an terms originating from the dc eld H_{dc} applied along the wire axis. Energy due to the ac circular eld H_{ac} created by the injected ac current I_{ac} is neglected. The anisotropy eld as a function of stress is determ ined by identifying it, experimentally, with the value of the dc eld H_{m ax} where the M I curve displays a peak. P reviously M akhnovskiy et al. [9] introduced explicitly these terms in the energy functional with a single helical anisotropy [10] term in contrast with our work dealing with several competing (intrinsic, residual and induced) anisotropies. The stress (on the surface of the wire) is related to the torsion angle through:

where G is the shear modulus, a is the radius of the wire and 1 the length (see g.2). In general, has a radial dependence since the wire has an inner core with an axial magnetization surrounded by circular domains [1, 2] when $\frac{R}{s}$ is small and negative. We neglect such dependence and consider, for simplicity, the value of stress on the surface [6] of the wire. Introducing the saturation magnetization of the samples M_s (measured with a vibrating sample magnetom eter [3] as $_{0}M_{s} = 0.8$ Tesla), the energy may be rewritten as:

This shows that we have a competition between a circum ferential anisotropy eld $H_K = 2K_c=M_s$ and a torsionstress induced one (called henceforth twist eld including the residual stress) $H = 3\frac{R}{s}(+ r)=M_s$. Using a Stoner-W ohlfarth approach [12, 13], this amounts to rotate the astroid equation from a set of perpendicular elds H_x ; H_y :

to another by an angle resulting in another astroid. This angle is the same that gives the new equilibrium orientation of the magnetization and is simply obtained from the condition minimizing the energy, i.e. $[0E = 0]_{=} = 0$. We obtain:

U sing this expression of , the resulting anisotropy eld H is written as:

The total energy after this transform ation is written as:

indicating the presence of helical [10] anisotropy (since we have an angle $_{\rm T}$ in general di erent from 0 and 90 degrees) resulting from the competing circum ferential and torsion (applied+ residual) induced one. In fact we ought to nd from the M I experiment the angles bounding the value of $_{\rm T}$.

The MI peak value versus eld and torsion angle should correspond to the anisotropy eld H given by the above form ula eq.6 as explored in the next section.

The MIm aximum value eld $H_{m ax}$ is to be tted to the theoretical expression of H. The latter depends on four parameters, H_{K} the zero-stress circum ferential anisotropy eld, $b = 3 \frac{R}{s} = M_{s}$ the normalised magnetostriction constant, the angle T and the residual torsional stress r. These can be reduced to three by normalising all quantities by H_{K} .

We use a procedure based on a least squares minimization procedure of the curve H versus to the set of experimental measurements $[i;y_i]_{i=1,n}$ where $y_i = H$ (; i). represents the set of parameters b; T and T. The slope of the curve H versus that appears to be linear is used in the tting. This choice is su cient for the description of the method we use, nonetheless our algorithm allows us to select any coherent set of criteria we choose to t the data.

Hence the couple of m in im um equations for the data points and the slope are:

where s_e is the overall experimental slope. The tting method is based on the Broyden algorithm which is the generalization to higher dimension of the one-dimensional secant method [14] and allow us to determ ine in principle two unknowns out of three b, r and T. Broyden method is chosen because it can handle underdeterm ined problem s (since we have 2 equations and 3 unknowns).

W e consider two cases:

Case A: Absence of residual stress ($_r = 0$), then H_K is determined as H_K = H (;0) and b, $_T$ are obtained with Broyden algorithm.

Case P:P resence of residual stress, then H_K is a norm alising parameter and b, $_r$ are evaluated with B royden algorithm .

The parameter Ga=1=60.82 M Pa/radian is obtained directly by averaging over the torsion angles and the torsionstress as done in [3]. Using a wire radius of a=60 m and a length of l=10 cm, we obtain G=100 GPa which is a little di erent from the value used in [3] (60 GPa).

The thing shown in gure 3 (corresponding to case P as explained in the next section) allows us to predict the anisotropy eld H, in the negative stress torsion case, from the experimental results of M I measurements; that is interesting enough, since the single peak is dominant (at $H_{dc}=0$) and the double peak is barely noticeable in the M I curve versus H_{dc} . As an example, we can infer that the anisotropy eld H is zero for a negative value of stress -150 M Pa.

RESULTS AND DISCUSSION

The tting procedure in case A, discrim inates among the positive and negative $\frac{R}{s}$ values in favor of the negative value (im plying presence of circular magnetization pattern in the wire). The tting quality (equivalent to a ² test) is 0.094 when b= 1.39 (A/m)/MPa (roughly equal to the slope of H versus) the angle T is almost 180 degrees and $\frac{R}{s}$ = 4.68 10⁷. On the other hand, the tting quality is 1.8 10³, with b= 1.70 (A/m)/MPa, and T 0. In this case $\frac{R}{s}$ = -4.55 10⁷ agreeing with the value found by BV [3].

In spite of the successful t, the result is not acceptable for at least two reasons: Firstly, with torsional stress the angle $_{\rm T}$ should be at least 45 (or between 45 and 90 as in Favieres et al. [8] and M akhnovskiy et al. [9]), Secondly the zero-stress anisotropy eld H_K (H_K = 320 (A/m) [3] is too large for these wires (For C obalt rich wires H_K is on the order of a few tens of A/m.

Then we move on to discuss the next case P.Starting with $H_{K} = 100 \text{ A/m}$, we perform B royden m inimization obtaining: b= 2.13 (A/m)/M Payielding $j_{s}^{R} \neq 7.1310^{-7}$ while $_{r}= 142.4 \text{ M}$ pa. For $H_{K} = 50 \text{ A/m}$ we obtain: b= 2.05 (A/m)/M Pa yielding $j_{s}^{R} \neq 6.8710^{-7}$ while $_{r}= 154.1 \text{ M}$ pa. It is remarkable to notice that the tting curve tapers o for negative stress (see g. 3) while getting better for smaller values of H_{K} . For $H_{K} = 25 \text{ A/m}$ we obtain: b= 2.03 (A/m)/M Pa yielding $j_{s}^{R} \neq 6.8310^{-7}$ while $_{r}= 156.5 \text{ M}$ pa. The value $j_s^R \neq 6.83 \times 10^{-7}$ is slightly larger than found previously by BV. How ever, we agree with BV [3] interpretation of the M I asymmetry in terms of a fabrication induced residual torsion stress (150 M pa) that is enhanced or counterbalanced (since H = 0 for = 150 M pa) with an applied positive or negative torsional stress.

We conclude that our results are similar to those obtained with the A case and agree as well with those obtained by BV despite the use in both cases of the linear t: $H = H_K + b$ that allows to extract from the slope of the H versus the magnetostriction coe cient with the formula [15]:

In order to exam ine the general case with $\cos(2_T) \in 1$, we observe that when the magnitude of the twist eld H is small with respect to the zero-stress anisotropy eld H_K one may expand, to fourth order (for instance), the anisotropy eld H with respect to obtaining:

O nem ay also derive a similar expansion for $\frac{R}{s}$ as a function of [15]. Using the above relationship eq. 10, one gets:

P reviously, this kind of expansion has been performed by several workers and particularly by Zhukov et al. [16] who made also a tting of the expansion coe cients as a function of frequency. This might be included easily in our approach by letting H vary with frequency.

Generally speaking, the linear regime $H = H_K$ b should not be observed when the angle $_T$ is dimensional from 0 and 90 (an integer multiple of 90). Then the relationship $H = \frac{1}{H_K^2 + H^2 + 2H_K H} \cos(2_T)$ should apply and when the twist eld is small ($H < H_K$), the above expressions eq. 11, and eq. 12 apply.

Experiments versus frequency involving wires with o -wire axis torsion stress conditions ought to be done in order to test the general non-linear case (where H not necessarily being very small with respect to H_K), and precision in measuring H versus should be increased (in the positive torsion angle case of BV [3]) in order to be able to locate accurately the peak of the M I versus eld H_{dc} and test the above form ula. This work is in progress.

- [10] Helical anisotropy is generally accounted for by introducing an anisotropy axis making an angle (45 < 90) with the wire axis (see for instance ref. [9]). Note that torsion stress is also called helical because it is modeled as tensile and compressive stresses acting perpendicularly on the wire surface with an angle of 45 with the wire axis [7].
- [11] The saturation magnetostriction constants in the tensile case ($\frac{T}{s}$) and in the torsion case ($\frac{R}{s}$) are, in general, di erent for a crystalline material. In am orphous materials $\frac{R}{s} = \frac{T}{s}$.




FIG.1: Geometry of the anisotropy and stress-induced easy axis. The circum ferential anisotropy axis induced by fabrication is along e and the torsion stress-induced easy axis makes an angle $_{\rm T}$ with e. The zero-stress circular anisotropy eld H $_{\rm K}$ is along e. In the helical anisotropy case, the magnetization M lies in the e;ez plane making a non zero angle with the circum ferential basis vector e , otherwise, both the magnetization M and anisotropy axis lie in the e;;e plane.




FIG.2: Applying a torsion stress to a wire moves the point B to B^0 by angle . The deformation is the displacement per unit length, i.e. = $BB^0=1=a$ =1where l is the length of the wire. By Hooke's law, stress and deformation are related by the shear modulus G, hence = G = G (a =1)




FIG.3: Experimental results of the anisotropy eld H versus stress as obtained by BV β from the eld value of H_{dc} at MI peak value and theoretical lines for variable circular anisotropy eld H_K at zero-stress. As H_K is decreased from 100 A/m (upper line) to 50 A/m and nally 25 A/m (lowest line) we get a weaker tapering o of the line for negative stress and better tting of the experimental results. The residual torsion stress is 150 M pa.
