# N etw orks and C ities: A n In form ation P erspective

#### Abstract

Tra cis constrained by the in form ation involved in locating the receiver and the physicaldistance betw een sender and receiver. W e here focus on the form er, and investigate tra $c$ in the perspective of inform ation handling. W e re-plot the road m ap of cities in term s of the inform ation needed to locate speci c addresses and create inform ation city networks $w$ ith roads $m$ apped to nodes and intersections to links betw een nodes. These netw orks have the broad degree distribution found in $m$ any other com plex netw orks. The $m$ apping to an inform ation city netw ork $m$ akes it possible to quantify the inform ation associated $w$ ith locating speci $c$ addresses.

Tra $c$ and communication between di erent parts of a com plex system are fundam entalelem ents in $m$ aintaining its overall cooperation. Because a com plex system consists ofm any di erent parts, it $m$ atters $w$ here signals are transm itted. Thus signaling and tra c is in principle speci $c, w$ th each $m$ essage going from a unique sender to a speci c recipient. O ne exam ple is living cells, where m acrom olecules are transported betw een cellular com ponents and along $m$ icro-tubular highw ays to perform ordirect actions on other particularm acrom olecules [1]. T his complicated cellular $m$ achinery is often sim pli ed to a $m$ olecular netw ork that $m$ aps out the signaling pathw ays in the system. We here will consider a city in a sim ilar perspective, w th comm unication de ned by people that travel from one speci c street to another. In $m$ any cases, the actual traveling distance could easily be less restrictive for com $m$ unication than the am ount of inform ation needed to locate the correct address. In this w ork wew ill take th is perspective to the extrem $e$, and assum e that the traveltim e/cost of just driving along a given road is zero. A ccordingly we rem ap a city $m$ ap to a dual inform ation representation [2]): an inform ation city netw ork ( $F$ ig. (1) . Subsequently we will use this network to estim ate the inform ation needed to navigate in a city, and thereby quantify and com pare the com plexity of cities.

Im agine that you want to get to a speci c street in the city you are living in. If you have lived in the city for som e time, you probably know how to nd the street, and driving to the destination does not cost any new inform ation. However, if you are new in the city, you need travel directions along the way to the target. In this paperwe discuss the inform ation value of such travel directions, or equivalently, we quantify the inform ation associated to know ing the city you live in.

A ssum e that you get your traveldirections in the form of the sequence of roads that $w$ ill lead you to the target road. These roads form a path of roads $w$ th subsequent intersections. In netw ork language, your trajectory can be $m$ apped to a path in an \inform ation city netw ork", where roads m ap to nodes and intersections

For exam ple, it is very easy to go from an north-south (ns) street to another parallelns street. A penpendicular east-w est street is rst reached w ith probability $1=4$. N ext a ns is reached $w$ ith probability $1=3$, if by assum ption a just visited street is not visited again. There are four possible paths to the target street and therefore one only needs $\log _{2}\left(4 \frac{1}{4} \frac{1}{3}\right)=\log _{2}(3)$ bits of in form ation to go betw een tw o parallel streets (see Eq. (4) ). In (c) we m ap \G am la stan" in Stockholm, Sweden, to an inform ation city network. N odes are roughly positioned at the geographical position of the corresponding street and color coded according to the typical am ount of in form ation $H$ needed to locate them .
between roads $m$ ap to links between the nodes. This netw ork represents an inform ation view of the city, where
distances along each road are e ectively set to zero because it does not dem and any inform ation handling to drive betw een the crossroads.

In Fig. 1 ( a and b) we present two sim ple exam ples of tw o caricature cities $m$ apped to such inform ation networks. Fig. 1(a) show sa particular sim ple city consisting of a $m$ ain road, that together w ith a collection ofsm aller roads de ne the city. T hism aps into a single hub, where all inform ation handling consists in specifying which of the 4 side roads that is the right one. In Fig. [1(b) we show a slightly m ore elaborate city, that resem bles m odem planned cities. In that case any street can be accessed from a random perpendicular street, and e ectively the inform ation associated to locate a speci c street is also sm all.

The random netw ork is constructed such that the degree of every node is conserved, and such that the netw ork rem ains globally connected [3]. (c) shows the sim ilarly norm alized num ber of loops of length 4,. B oth types of loops tend to be over-rep resented in realcity netw orks com pared to the random ized ones. $T$ h is re ects locality in the city netw orks.

In $F$ ig. [1 (c) we show a part ofa realcity, \G am la stan" in Stockholm [4], Sw eden, $m$ apped to an inform ation network. Long roadsw ith $m$ any intersections are $m$ apped to m ajor hubs: The netw ork representation nicely captures that the long roads are im portant for the overall tra c in the system. For a m ore system atic study we map a number of di erent cities to their inform ation netw ork counterpart, and exam ine their basic topological properties ( F ig. (2). For com parison we also show another
transportation netw ork, consisting of ainports in USA, connected by a link in case there is a direct ight betw een them [5]. In this netw ork, the traveldirections are decided in the airports and we therefore analyze it w ith the airports as nodes and the ights betw een airports as links.

For all city netw orks, and also for the aipport netw ork we observe broad connectivity distributions (Fig. Z(a). H ow ever, the local properties di er qualitatively betw een the city netw orks and the airport netw ork. W e quantify the locality by the num ber of sm all loops of length 3 (triangles 4 ), related to clustering [6, 7, 8], and length 4 (squares ) in Fig. 2 (b and c) norm alized by their expectation num ber in random netw orks w th conserved degree distribution [3, 9]. T he airport netw ork is close to its random counterpart, whereas the city networks di er substantially from their random expectations. The ainports are connected w th little regards to geographical distance, whereas in the cities, in particular the short roads have relatively m any loops and thus exhibit substantial degree of locality. M anhattan, selected to represent a planned city, di ers from the other cities in having few triangles and an overabundance of squares associated especially to the $m$ any streets of connectivity

15 and 100 that, respectively, cross the city in east-w est and north-south direction.

To characterize the ease or di culty of navigation in di erent networks, we use the \Search Inform ation" $S$ [10]. Im agine a netw ork, in this case an inform ation city netw ork, where we start on a node (a street) s and want to locate node $t$ (another street) som ew here else in a connected netw ork w th N nodes (streets). Further, we $w$ ant to locate $t$ through the shortest path, or if there are several degenerate shortest paths, we want to locate $t$ through any of them. W ithout prior know ledge, the inform ation needed for locating a given exit from a node of connectivity $k$, is $\log _{2}(k)$. For each path $p(s ; t)$ from $s$ to $t$ the probabillty to follow it is

with j counting all nodes on the path until the last node before the target $t$ is reached. The factor $k_{j} 1$ instead of $k_{j}$ takes into account the inform ation gained by follow ing the path, and therefore reducing the num ber of exit links by one. T hus, the total probability to locate node talong any of the degenerate shortest paths is

where the sum runs over all degenerate paths that connect $s$ and $t$. The total in form ation value ofknow ing any
one of the degenerate paths betw een $s$ and $t$ is therefore

W e im m ediately see that the existence ofm any degenerate shortest pathsm akes it easier to $n d t$. $W$ e stress that $S$ should not be confused with entropy $m$ easures associated to the degree distribution 11], or $m$ easures related to the dom inating eigenvector of the adjacency matrix [12]. Instead $S$ is related to speci ctra $c$ in the system.

Let us for illustration retum to the \square city" in Fig [1](b), w ith $N$ streets divided in $N=2$ north-south ( $n s$ ) streets, and $\mathrm{N}=2$ east-w est (ew ) streets. G oing from any ns street to a particular ew street dem ands inform ation about which of the $\mathrm{N}=2$ exits we m ust take. This inform ation is $\mathrm{S}(\mathrm{ns}!\mathrm{ew})=\log _{2}(\mathrm{~N}=2)$. On the other hand, ifwe want to go from one ns street to another ns street, we can take anyone of the $\mathrm{N}=2$ ew streets. Each path is thus assigned a probability $(2=N)[1=(\mathbb{N}=2 \quad 1)]$. But there are in fact $\mathrm{N}=2$ degenerate paths, and the total inform ation cost for locating parallel roads in this square city reduces to
$S(\mathrm{~ns}!\mathrm{ns})=\quad \log _{2}\left(\frac{\mathrm{~N}}{2} \frac{1}{\mathrm{~N}=2} \frac{1}{\mathrm{~N}=2 \quad 1}\right)=\log _{2}(\mathbb{N}=21)$; (4)
re ecting the fact that $\mathbb{I}$ does not $m$ atter which of the ew roads one will use to reach the target road.

To characterize the overallcom plexity in nding streets we calculate the average search inform ation

for a num ber of cities in $F$ ig. 3. To evaluate the $S$-values, we for each netw ork also calculate the corresponding $S_{r}$ for its random ized version. T his random netw ork is constructed such that the degree ofeach node is the sam e as in original netw ork, and also such that the overall network rem ains connected [3]. T hus, com paring $S$ with $S_{r}$ properly takes into account both the size of the netw ork, its totalnum ber oflinks as w ellas the degree distribution, but not the geom etrical constraints. The 2-dim ensional constraint of a realcity is absent in the random ization. In all cases, including the airline netw ork, we observe that $S>S_{r}$. Thus all netw orks are $m$ ore di cult to navigate than their random counterpart ( F ig. [3(a)).

To take size e ects into account we from Eq. (1) expect that $S$ scales as $\log _{2}(\mathbb{N})$. We therefore de ne
$=S=\log _{2}(\mathbb{N})$ to be able to com pare cities of di erent sizes ( $F$ ig. 3 (b)). Furthem ore, $=\left(S \quad S_{r}\right)=\log _{2}(\mathbb{N})$ is interesting, since it $m$ easures how e ectively the city is constructed given the length (degree) of the streets ( $F$ ig. 3(b)). A ccording to Fig.3(b) M anhattan is relatively easier to navigate in than the other cities. H ow ever, neither $M$ anhattan is optim ized. If $M$ anhattan was constructed

as a pure square city ( $F$ ig. $1(\mathrm{~b})$ ) the search inform ation would be $S \quad 9$ according to Eq. (4).

To investigate what it is that m akes it com plicated to navigate in cities, we in Fig .4 m easure the inform ation associated to nodes of di erent degrees in the netw ork. $W$ e de ne the access inform ation of a node $s$ by

where we sum over all target nodes $t$ in the netw ork. $T$ he quantity $A_{s} m$ easures the average num ber of questions one needs to locate a speci $c$ street in the network, starting from node $s$. Thus $A_{s}$ is a m easure of how good the access to the network is from node s. In F ig. 4 (a) we show hA $(k) i=h A_{r}(k) i$ averaged over all nodes of degree $k$ versus $k$. hA $r(k) i$ is the average expectation of A ( $k$ ) in a random ized netw ork. N ote that $H_{t}=\frac{1}{N}^{P}{ }_{s} S(s ; t) \in A_{t}=\frac{1}{N}_{s} S(t ; s)$. The di erence re ects the asym $m$ etry of the endpoints of a path. Im agine a sm all netw ork that consists of a hub w ith ve neighbors. The hub is easily reached from any of the neighbors. H ow ever, starting at the hub it is harder to reach a speci c neighbor. T he hub has low $H$ and high $A$ and the neighbors have high $H$ and low A.
$T$ he overall feature of $F$ ig. $4(a$ and $b$ ) is that the positioning of the roads $w$ ith respect to their degree does not explain the relatively high values of $H$ and A. H ow ever,

the degree plays another indirect role: The presence of long roads shortens the distances in the inform ation network and thereby decreases $S$, especially if degenerate paths exist. This is true for $M$ anhattan and the netw ork of airports, but not for the three Sw edish cities according to their degree distributions ( F ig. V(a)). In the context of city planning, this suggests that for easy navigation it is often favorable to replace a big num ber of shorter streets w ith a few long, provided that they connect rem ote parts of the netw ork.
$W$ hen considering $S(l)=h S(l) i_{\text {pairs }} \quad h S_{r}(1) i_{\text {pairs }}$ as function of distances 1 between nodes in the city netw ork [13] (not shown), we nd that $S(1)<0$ for distances 1 2. $T$ his suggests that local navigation to a neighbor parallel road is optim ized, whereas the

S(1) > 0 for $l>3$ re ects a tendency to protect local neighborhoods by hiding them. T hus the relatively large $S$ re ects a separation of these neighborhoods.

W ealso investigated the variance ofA (k) and $\mathrm{H}(\mathrm{k})$ and found that this typically is m uch larger in real netw orks, com pared to their random counterparts. This re ects the inhom ogeneity in the organization of cities ( $F$ ig. (2) (b and c)) with a fraction of streets being well hidden in rem ote comers of the cities. Such comers and local \islands", overrepresented in Stockholm as a consequence of real islands, are essentially never present in the random counterparts. $M$ any cities are organized hierarchical, where a few m ain streets connect to sm aller streets, which in tum connects to even sm aller streets. If a real City was organized purely hierarchical, w th each street connected to one larger and two sm aller streets, then $S=2 \log _{2}(\mathbb{N})$ for $N$ ! 1 . In practioe this hierarchical organization is partially broken by intersecting roads (decreasing S, e.g. M anhattan) and local neighborhoods or \islands" (increasing S, e.g. Stockholm). A s a consequence $S \quad 2 \log _{2}(\mathbb{N})$ is only a rough estim ate. $F$ inally we have $m$ easured that locality in the form of an excess
num ber of sm all loops ( F ig. Z(b and c)) also contributes to $S \quad S_{r}$, since sm all loops introduce redundant paths w ithout shortening distances substantially.

W e have discussed the organization of cities in the perspective of com $m$ unication and presented a way to rem ap a city $m$ ap to a dual inform ation representation. The inform ation representation of a city opens for a way to quantify the value of know ing it: A large $S$ m eans that you have to know a lot to nd yourw ay around in a city as a new com er. In another perspective it is an estim ate of the asym $m$ etry betw een traveling a way the rst and second tim e, when travel tim e is included.

W e have quanti ed the intuitive expectation that $M$ anhattan, and presum ably $m$ ost $m$ odem planned cities are sim ple. In contrast, historical cities with a com plicated past of cut and paste construction are m ore complex. $T$ he observation of a univensally large $S$ relatively to $S_{r}$ in allnetw orks we have investigated $m$ eans that the ability to obtain inform ation is relatively $m$ ore im portant in these real world netw orks. A lso it im plies that city netw orks are not optim ized for com m unication, as such an optim ization would provide a topology w th $S$ even sm aller than $S_{r}(F i g .1 b)$. R ather the topologies of real cities, w ith high $S$, re ect a localtendency to avoid being exposed to non-speci ctra c.
