c-axis transport in highly anisotropic m etals: role of sm all polarons

We show in a simple model of interlayer hopping of single electrons, that transport along the weakly coupled c-axis of quasi-two-dimensional metals does not always probe only the in-plane electron properties. In our model where there is a strong coupling between electrons and a bosonic mode that propagates in the c direction only, we mid a broad maximum in the c-axis resistivity at a tem perature near the characteristic energy of the bosonic mode, while no corresponding feature appears in the ab plane transport. At tem peratures far from this bosonic energy scale, the c-axis resistivity does track the in-plane electron scattering rate. We demonstrate a reasonable t of our theory to the apparent metallic to non-metallic crossover in the c-axis resistivity of the layered ruthenate Sr_2RuO_4 .

M any m etallic system s of current interest have highly anisotropic electronic properties with one or more directionsmuchmoreweakly conducting than the others. Exam ples include the cuprate m etals¹, som e ruthenates², and m any organics³, where a m easure of this anisotropy is the resistivity ratio, $_{c}=_{ab}$, which can be of order 10^{3} to 10⁵. (Henceforth, c will denote the weakly coupled direction with a and b the m ore conducting.) M any of these m aterials have unusualm etallic or superconducting properties which have been attributed to strong correlation e ects in the ab plane. A lthough the theoretical understanding of strongly correlated electrons is incom plete, the electron anisotropy can be used advantageously to give insights into the in-plane physics. By assum ing that the coupling up the c-axis occurs only by weak singleelectron tunneling, many workers^{4,5,6} have shown that c-axis resistivity depends only on the in-plane electron G reen's function.

This insight makes all the more puzzling the observation that in many of these materials the resistivityanisotropy ratio is strongly tem perature dependent with a cross-over from metallic behavior to insulating behavior in the out-of-plane direction only. For example, $Sr_2RuO_4^2$ show sT^2 resistivity both in the plane and outof-plane for T < 20K but _c shows a broad maximum at around 130K and above this tem perature the resistivity starts to decrease with increasing tem perature (see Fig.2 below). In m arked contrast, the in-plane resistivity shows Q = QT > 0 for all tem peratures. Evidently the low tem perature metal is a 3D Ferm i liquid, so this begs the question how the out-of-plane transport is being blocked while the in-plane transport rem ainsm etallic. In this paper we consider how an isotropic coupling of the in-plane electrons to bosonic degrees of freedom can give rise to this e ect. W e show that if the electron-boson coupling is stronger in the inter-plane direction then, at the characteristic energy scale of the boson mode, there can be a maximum in the c-axis resistivity with no corresponding transport feature for currents in the plane.

0 ther approaches to this puzzle have been o ered previously. One possibility is that the in-plane m etal is a non-Ferm i liquid^{7,8} or otherw ise re ects unusual in-plane physics⁹ such as superconducting uctuations¹⁰. These approaches have generally been argued to apply to the cuprate m etals, but our m otivation com es from the layered strontium nuthenate com pounds where the appeal to unusual in-plane physics is less well grounded. A lternatively the c-axis coupling m ay consist ofm ore than single electron tunneling: with disorder and boson-assisted hopping¹¹ or perhaps inter-plane charge uctuations¹².

In this paper we also go beyond single particle hopping as the only coupling between the planes and consider electrons coupled to a bosonic mode. However, in contrast to the above work, we use a canonical transform ation¹³ to treat the electron-boson coupling, and thus can deal with the strong coupling regime. Our assumptions are, rst, that there is a well de ned separation of energy scales: t_{ab} ! ₀ t_c, where t_{ab} is the in-plane kinetic energy scale, $!_0$ is the characteristic energy of the bosonic mode (e.g. the D ebye tem perature) and t_c is the single particle tunneling between layers. This assum ption is certainly well founded for Sr_2RuO_4 , as shown, for example, in Ref. [14]. With this assumption it is sufcient to compute conductivity to leading order in t_c. Our second assumption is that electron-electron correlations dom inate over the in-plane coupling to the bosonic mode such that the form ation of a sm all polaron in the planes is suppressed by the electronic interactions. We will therefore be considering a lim it where the quasiparticle excitations of the system are insensitive to bosonic m odes whose wavelength in the plane is short com pared to the size of a quasiparticle (assum ed to be large). W ith these assumptions we show that an isotropic coupling can lead to di erences between the in-plane and out-of-plane conductivities that are consistent with the experiments. A broad maximum can appear in the c-axis resistivity as a function of tem perature, while no such feature exists in the in-plane resistivity ab. Only away from the broad maximum, does c track the intrinsic in-plane scattering rate. W e shall also show that our model calculations can t reasonably the Sr_2RuO_4 data of Tyler et al², using physically plausible param eters.

Strictly our assumption that the electrons couple strongly only to out-of-plane bosonic modes should be regarded as phenom enological, and in this paper we com pute the consequences of such an approach and com pare with experiment. Nevertheless we can o er som e justi cation for it. In a quasi-2D m etal, the anisotropy of the crystalstructure has in portant consequences for both the electronic structure and the bosonic modes the electrons can couple to. U sually the anisotropy in the characteristic energies of phonon m odes are m uch sm aller than those than the electronic structure: the ruthenate that we will be concerned with is thought to be an ionic (not covalentbonded) crystal. W here signi cant anisotropy can arise is in the strength of the electron-phonon couplings for these di erent phonons. K rakaueret. al.15 have found in an LDA calculation that the electron phonon coupling is much stronger when atom ic displacem ents are perpendicular to the Cu-O plane in LSCO, while K im et. al.¹⁶ and Grilli and Castellani¹⁷ found that strong in-plane electronic correlation suppresses in-plane electron phonon coupling. U sually strong electron-phonon coupling leads to the well-studied sm all polaron regime, where electronic motion becomes a ected by the accompanying large cloud of $phonons^{13,18}$. (For a review, see [19].) In this paper, our assumptions will lead to a small polaron forming only between the layers.

OurmodelHamiltonian is then:

The model system consists of a stack of 2D planes described by H⁽ⁿ⁾ containing arbitrary intra-planar interactions. In this work it will be su cient to characterize these planes by a phenom enological 2D G reen's function. In H_c, electrons are assumed to hop from one plane directly to a neighboring plane only, at the same in-plane coordinate x. For sim plicity, we have om itted the spin index on the electron operators $c_n(x)$. Many approaches^{4,5,6} assume only this coupling between the planes in a quasi-2D system . We go beyond that by including a bosonic mode that also couples the layers

Our analysis can be applied to any gapped neutral bosonic mode with long wavelength in the plane, such as a magnetic collective mode, but we have in mind the (strong) coupling to a phonon mode with displacement in the c direction and long (in nite) wavelength in the plane. Here q is along the c-axis, with c the inter-layer distance. In this lim it, only the total charge $d^2 x c_n^y (\mathbf{x}) c_n (\mathbf{x})$ of the n'th plane couples to the boson creation and annihilation operators a_{α}^{y} ; a_{α} so, by construction, these bosons do not dom inate charge transport within the plane.

spreading the in-plane correlation from one plane to another, especially since the in-plane correlations are supposed to be strong for a pure single layer in the cuprates and also the ruthenates. How ever, this requires the interlayer hopping to be coherent, which means the tem perature must be low compared to t_c: otherwise, the c-axis transport is di usive and cannot propagate correlations between the layers. In this paper, we have assumed a phenom enological form for the in-plane spectral weight, and so we cannot address the issue of the strongly correlated three dim ensional state at T t.

 $_{\rm P}$ The Hamiltonian for the c-axis bosons, H $_{\rm b}$ = $_{q} !_{q} a_{q}^{y} a_{q}$, de nes a dispersion $!_{q}$. In this paper we shall look closely at the Einstein phonon $!_q = !_0$. This is both because optical phonons tend to have little dispersion relative to acoustic ones, and also we are able to obtain analytic results for this case. We shall also discuss, som ew hat m ore qualitatively, the opposite case of a generic dispersion where the phonon density of states does not have any sharp features. For the data tting to Sr₂RuO₄, we will use a simple form that allow sus to test if the putative m ode does indeed disperse.

Of course electron-phonon systems have been well studied, but our ndings will be shown to be clearly different to ones found in the small polaron models studied in the classic papers^{13,18,19}: small anisotropy in electron-boson coupling cannot lead to the properties we shall dem onstrate below. In particular, at tem peratures greater than the tem perature of the maximum in $_{c}$ (T), our model has c (T) tracking the intrinsic in-plane scattering rate while in standard sm all polaron theory (even if generalized to some degree of an isotropic coupling),

c (I) keeps on decreasing (exponentially) with increasing T. In short, in our model, the sm all polaron broad m axin um in $_{\rm c}$ (T) is \grafted" on top of the background inplane scattering. W e note that K ornibvitch²⁰ has studied a sim ilar anisotropic model: he did not calculate the d.c. conductivity, and, with the e ective mass approach em ployed, he cannot access the non-m etallic regim e beyond the broad maximum of $_{c}$ (T)]. After completion of our theory, we became aware of the related work of Lundin and M cK enzie²¹ who also studied a sm allpolaron m odel for an isotropic m etals. Their m odel is di erent to ours in an essential way: they take the boson m ode to be uncorrelated from one layer to another, while we have a boson m ode that propagate coherently along the c-axis.

The key physics we are considering is the e ect of strong electron-phonon coupling on the charge transport in the weakest direction, the c-axis. Physically, the motion of the electron is accompanied by the emission and absorption of a large number of phonons due to the strong coupling, form ing the so-called sm all polaron 18 . W e treat H $_{\rm e}$ $_{\rm b}$ exactly by the canonical transform ation, $H = \exp(S) + \exp(S)$, a straightforward generalization of the transform ation well known in the small polaron

Thus strong electron-phonon coupling leads to (1) a renorm alization of the in-plane chem ical potential (rst term of H_c), which we shall henceforth ignore, and (2) an e ective vertex correction for the c-axis hopping t_c (second term of H_c). At tem peratures low er than the characteristic energy of the boson, electrons can hop coherently from one plane to another, with some suppression due to the \dragging" of the boson cloud. W ith increasing T, the hopping electron gets inelastically scattered by m ore and m ore bosons: inter-layer hopping is now m ore di usive. Hence a crossover to non-m etallic behavior occurs.

We consider the d.c. conductivity and the orbital magnetoconductivity for elds in the ab plane. For the conductivity, since the charge in the n'th plane is $Q_n^c = e^{-1} d^2 x c_n^y$ (x), the current in the c-direction is just $j_n^c = e_t Q_n^c = -i Q_n^c$; H]. The orbital e ect of a magnetic eld can be included using a Peierls substitution²². The mathematical details of our derivation follow our analysis reported in Ref. 23. Using the Kubo formula and expanding to $O(t_c^2)$ gives the conductivity, i.e., the linear response to an applied electric eld in the c-direction $_c = j^c = E^c$:

 $G_n^{(2D)}(\tilde{K}_k)$ is the in-plane (dressed) G reen's function for plane n at in-plane momentum \tilde{K}_k , and $q_B = ee$ B with e being the inter-plane lattice vector. The temperature dependent factor U () in Eq.7 leads to the c-axis conductivity being no longer simply a convolution of the in-plane electron G reen's functions and we explore the consequences in the following.

To make further progress we use a phenomenological in-plane electron G reen's function in the spectral representation: $G_n^{(2D)}(K_k;!_m) = \frac{R}{dz} \frac{A^{(2D)}(K_k;z)}{i!_m - z}$, and $U(n) = \frac{R}{dz} \frac{b(z)}{i_n - z}$, then the M atsubara sums can be done. We shall take the in-plane electron spectral function to have the form: $A^{(2D)}(K;!) = \frac{1}{(! - \frac{k!}{k})^{2+}(T;!)^{2}}$, where we assume that the scattering rate (T;!) has no in-plane momentum dependence. Then, integrating over K_k , the zero-frequency, zero-momentum c-axis conductivity becomes:

where D (!;T) = $!b(!)n_B(!)[1 + n_B(!)], n_{F;B}$ are the Ferm i and Bose distributions and N is the electron density. D (!;T) can be calculated²³ following Ref.19. We now analyze this equation in detail for Einstein modes and, more qualitatively, for a general dispersing mode.

For Einstein modes, $!_q = !_0$, the function D (!;T) is made up of delta functions at the harmonics $! = n!_0$; n = 0; 1; 2;::!⁹. It can be shown that for experimental temperatures, one needs only the rst few harmonics. We now discuss the three temperature regimes (T !_0;T < !_0;T !_0) separately, and show that the low and high temperature regimes basically tracks the in-plane scattering rate, just like in previous studies of interlayer transport^{4,5,6}. Only in the regime where the temperature is near the boson scale !_0 can the electron-boson scattering dom inate over the in-plane scattering contribution, and instead, leads to a small polaron like broad maximum in resistivity.

At low tem peratures (T $!_0$), the asymptotic form for the c-axis resistivity is the same as for band electrons, but with an electron hopping parameter t_c^e = $t_c e^{-\frac{2}{2}2!_0^2}$, where $^2 = \frac{2}{q} 2M_q^2$ (1 $\cos q$) characterizes the strength of the electron-phonon interaction:

For T $!_0$, then $_c$ T $\frac{1}{2}$, using the scattering rate (T) / T . (= 2 for a Ferm i liquid, while for the marginalFerm i liquid, = 1.) Thus the low ten perature B = 0 conductivity directly probes the in-plane scattering, while the high tem perature conductivity still re ects the in-plane scattering with an extra T $^{1=2}$ factor²⁴.




FIG.1: The zero-eld c-axis resistivity with in-plane marginal Ferm iliquid scattering = ! coth (!=T) for electrons coupled to c-axis E instein phonons for di erent values of electron-phonon coupling (=!_0). Inset: as above but for a dispersing mode $!_{g} = !_{0} [1 \quad 0.4 \cos(q)].$

However, beyond a critical phonon coupling ($_{\rm c}$) there is an interm ediate temperature region where a broad maximum appears in the c-axis resistivity at temperature $T_{m\,ax}$ (Fig. 1). Beyond $T_{m\,ax}$, the resistivity dips to a (broad) minimum at $T_{m\,in}$ before nally joining onto the asymptotic T $!_0$ regime mentioned above. We

estim ate, by using only the zeroth harm onics n = 0, that if the in-plane scattering rate has the form (T) = T, then the maximum appears when

The position of the resistivity peak for $^{>}$ _c is found to be T_{crit} !₀=3.0. For only slightly larger than _c, $T_{m ax}$ and $T_{m in}$ is given by:

Note that both T_{max} and $_c$ depend mainly on phonon parameters; one can show that the in-plane scattering rate enters only in the form of the exponent . Hence the width of the broad maximum is governed by the scale ! $_0$.

For illustration, we consider $!_q = !_0 [1 \quad 0.4 \cos(q)]$, and set the electron-phonon coupling M_q to be qindependent. Eq. 13 is then evaluated numerically and plotted in the inset to Fig. 1. = $_q F_q !_q = 2$ characterizes the strength of the electron-phonon interaction in this case. The result is qualitatively sim ilar to that of a non-dispersing mode.

Now we consider the magnetic eld dependence of the conductivity for the Einstein mode. At low temperatures T $!_0$ we not that the magnetoresistance rejects the usual cross-over from quadratic to linear eld dependence²⁷ at a scale determined only by the in-plane electron scattering rate

where $!_{\rm c}$ = $v_{\rm F}$ ecB is the cyclotron frequency. At higher temperatures (T > $!_{\rm 0}$), the weak-eld m agnetoresistance is quadratic in eld $_{\rm c}$ / $(!_{\rm c}=_{\rm e})^2$, and de nes a new scattering rate, $_{\rm e}$, depending on both the electronic scattering and the phonon frequency. Taking into account only up to n = 1 harmonics, with $_{\rm 0}$ = (T;0), and $_{\rm 1}$ = (T;!_{\rm 0}), we nd

As for the zero eld resistivity, the magnetoresistance for the dispersing mode case is qualitatively similar to that for the Einstein mode and is positive for all temperatures.

We now consider in more detail how this model might apply to real materials and, in particular, the ruthenate system s. The 2D electronic nature of these m aterials re ects the crystal structure and so it is natural that the electron-phonon interaction should be anisotropic. W hile there are to date no calculation for the electronphonon interaction param eters for the ruthenates, in the iso-structural LSCO cuprate fam ily, K rakauer et. al.15 have calculated that there is a strong electron-phonon coupling only for modes corresponding to atom ic displacements perpendicular to the Cu-O plane, (partly) because of weak screening of the resulting electric elds in this direction. M oreover it has been argued that in the perovskite structure the coupling to c-axis vibrations is enhanced²⁰. There exist optical phonons with the appropriate symmetry for c-axis transport²⁸ in Sr_2RuO_4 , and experim entally the broad maximum in the c-axis resistivity has been linked to a structural phase transition²⁹ in Ca1:7Sr0:3RuO 4 at around the broad maximum temperature. Thus one should consider the possibility of electronphonon interaction a ecting the c-axis transport. In particular, both the Sr₂RuO₄ and Ca_{1:7}Sr_{0:3}RuO₄ system s exhibit^{2,29} qualitatively this broad maximum structure found in our simple model, in the c-axis resistivity near to their characteristic (c-axis) phonon energy.

A full quantizative m odeling of Sr_2RuO_4 is beyond the scope of the sim pli ed m odel presented here. D espite all




FIG.2: Fitting the zero-eld c-axis resistivity to the data of Tyler et.al.². See the text for the explanation of the theoretical curve (thin line) and the parameters used for the tting. The data are plotted as points: for clarity, we have plotted only 3% of the total number of available data points.

these simplifying assumptions, our model does a reasonable t to the resistivity data of Sr_2RuO_4 as we shall show, perhaps indicating some degree of universality of the mechanism for c-axis transport studied in this paper. Here for reference, we list the simplications we have assumed in our modeling: 1) the in-plane scattering rate can be deduced directly from $_{ab}$, 2) the main interlayer coupling is single particle hopping from one layer to another and 3) a simple phonon dispersion is employed (see later).

For 1), this amounts to ignoring vertex corrections to in-plane transport. In Ferm i liquids, the vertex correction leads to an extra cosine of the angle between in-and out-going electrons thereby correctly penalizing back-scattering in conductivity. However, the qualitative trend is still correct. A sm entioned already, we have taken an in-plane spectral function that has no in-plane momentum dependence. This ignores the complicated multiple Ferm i surfaces in Sr₂RuO₄. For 2), this means we ignore interlayer coulomb interaction. Also, we ignored the multiband nature of Sr_2RuO_4 and the dependence of t_? on in-plane m om enta. For 3), we have taken the limiting case of an optical phonon mode where the atom ic displacem ents are perpendicular to the plane, and all the atoms in the plane move together. We envisage that just as in LSCO, there will be strong electronphonon coupling only for phonons propagating mainly in the c direction¹⁵. Now in reality, because of the nontrivial perovskite structure of Sr₂RuO₄, these modes that can a ect c-axis transport will have relative atom ic displacements both in-plane and out of plane. But this makes electron hopping from one to another plane even m ore di cult, as the polaron has to create disturbances both in-plane and out-of-plane.

To some extent, these simplifying assumptions may

only lead to some quantitative changes in the t param – eters, because the calculation of $_{\rm c}$ (Eq. 7) involves an integral over in-plane m om enta and thus averages out such dependences.

We now show in Fig.2 a t to the Sr_2RuO_4 data of Tyler et al.². The theoretical curve is the thin continuous line, the data are the points. The theoretical curve is generated as follows: the in-plane scattering rate is approxim ated as being proportional to the in-plane ab (also taken from the data of [2]): (T;!) A $(_{ab}(T) + _{0})$, where A and $_0$ are thing parameters. We take a sim ple optical boson dispersion ! (q) = $!_0$ (1) cosq) with and the characteristic energy the boson bandwidth (T;!) and !(q) are then $!_0$ as thing parameters. fed into Eq. 13, where the overall scale of $_{\rm c}$ is found by tting ^{m ax} 33m on to the peak of the theory curve. Despite the simplicity of the model and the lack of know ledge of the exact boson dispersion form, the theory curve is almost indistinguishable from the data points, except at high T.³² The tting is relatively insensitive to the precise values of the parameters: some ne tuning (mainly, and) is needed to get the positions of the maximum, minimum and nalupturn correctly. Furtherm ore, the param eters used are physically plausible: 0**:**67;!₀ 515K, =! 0 1:4;A=!0 0**:**1 (m cm) $^{1};_{0}$ 0:17 m cm. The value of $!_0$ is consistent with the available phonon data of Braden et.al.²⁸, while the size of the boson bandwidth suggests that the bosons do disperse in the interplane direction. Note that the dispersion ! (q) always enter the conductivity expression under a q-integral (see Eq.13), and is the reason why our sim pli ed boson dispersion can stillm odel the broad maximum in the c-axis resistivity successfully. The size of the electron-boson coupling parameter indicate that Sr_2RuO_4 is just slightly above threshold for obtaining the maximum in c.

The c-axis m agnetoresistance seen in Sr_2RuO_4 is unusual³⁰, becoming negative for both transverse (B jjab) and longitudinal (B jjc) elds above 80K and maximally so at around 120K | coinciding with the peak position. In this paper we have only considered orbital magnetoresistance and, as might be expected, found it to be positive³¹. This is not inconsistent with the data since the transverse magnetoresistance is always less negative than the longitudinal one. If the change of sign is linked to the origin of the resistivity maximum then, within the fram ew ork presented here, it indicates that the frequency of, or coupling to, the bosonic mode is eld dependent. At present, we have no microscopic picture of how this might occur.

In conclusion, we have show n that c-axis transport in a quasi-2D m etal does not always probe only the in-plane electron properties. Strong coupling between electrons and a bosonic mode polarized in the c-direction in a highly anisotropic metal can lead to a broad maxim um | an apparent metallic to non-metallic crossover | in the c-axis resistivity with no corresponding feature in the ab plane properties. The position in the temperature axis,

and the shape of this broad maximum are determined mainly by boson parameters and not on the magnitude of the in-plane scattering rate. We have discussed the potential application of the model to Sr_2RuO_4 and its relative $Ca_{1:7}Sr_{0:3}RuO_4$. Despite certain simplifying features of the model, the qualitative (and even quantitative) properties of this crossover in these layered ruthenates are captured succinctly.
