# M any-body e ects betw een unboson ized excitons

#### Abstract

W e here give a brief survey of our new m any-body theory for com posite excitons, as well as som e of the results we have already obtained using it. In view of them, we conclude that, in order to fully trust the results one nds, interacting excitons should not be bosonized: Indeed, all e ective bosonic $H$ am iltonians (even the herm itian ones !) can $m$ iss term $s$ as large as the ones they generate; they can even $m$ iss the dom inant term, as in problem s dealing w ith optical nonlinearities.


W e have recently developed a new many-body theory for interacting com posite bosons [1-8], which is actually an im portant break-through: Indeed, up to now, the existing $m$ any-body theories were appropriate to interactions betw een ferm ions or bosons [9-11]. A though essentially all bosons known in physics are com posite bosons, there were no $m$ any-body procedures adapted to them, $m$ ost probably because it is far $m$ ore subtil to handle com posite bosons properly than to handle true bosons or true ferm ions.

In order to \do som ething" in problems in which interactions between com posite bosons obviously play a role, it is a com m on practioe to replace com posite bosons by true bosons, provided that their interactions are \dressed by exchange" \{ which is considered as a way to take care of their com posite nature. The production of such e ective bosonic H am iltonians is the aim of the wide literature on bosonization $[12,13]$.

This pragm atic idea is after allperfectly acceptable. The real ( $m$ a jor) trouble in sem iconductor physics, is that the e ective bosonic H am iltonian which has been produced $[14,15]$ \{ and widely used \{ to treat interactions between excitons, should have been rejected long ago because it is not even hem titian: T his failure, which com es from unconsistent $m$ anipulations in producing this e ective $H$ am ittonian, has apparently been $m$ issed by everyone for 35 years ! A swe were the rst to point it out, it is easy to understand why our new theory for interacting com posite excitons has not been weloom ed by the experts in the eld.

W ith a rst line $\{$ the $H$ am iltonian \{ physically unacceptable, there is no reason for the last line \{ the deduced results $\{$ to be correct, except if som e cancellations in the $m$ issed term smiraculously take place. Unfortunately, they don't ! Even if herm ticity is forced $\{$ which is always possible \{ essentially the sam e am ount of term $s$ is $m$ issing. In all the physicalquantities we have studied up to now using our new theory for com posite excitons, the $m$ issed term $s$ are as large as the ones whidh appear. In som e cases, in particular the ones in which photons are involved, i. e., in optical nonlinearities, the m issed term s can even be the dom inant ones, as obvious from a dim ensional argum ent explained below . Excitons are deeply m ade of two ferm ions; there is no way to get rid of their com posite nature, as we do when we bosonize them.

Survey of our new m any-body theory
O ur new many-body theory for com posite bosons relies on four nioely sim ple com m u-
tators $[1,3]$ :

In the case of excitons, $H$ is the sem ioonductor $H$ am iltonian, $B_{i}^{y}$ the creation operator of one exciton in the i state, i.e., ( $\mathrm{H} \quad \mathrm{E}_{\mathrm{i}}$ ) $\mathrm{B}_{\mathrm{i}}^{\mathrm{j}} \mathrm{j} \mathrm{j}=0$. In term s of free electrons and holes, it reads

The above com $m$ utators generate two \scatterings":
(i) The rst one dir $\underset{m}{n} \underset{i}{j}$, which has the dim ension of an energy, corresponds to a direct Coulomb scattering between the $\backslash$ in" excitons ( $i ; j$ ) and the \out" excitons ( $m ; n$ ), the excitons $m$ and ibeing $m$ ade $w$ ith the sam e electron-hole pair (see g.(1a)). It precisely reads
where $i\left(r_{e} ; r_{h}\right)$ is the iexciton wavefunction in $r$ space and $V_{i j}=e^{2}=j r_{i} \quad r_{j} j$. (ii) The second scattering, $h h_{m}^{n} \underset{i}{j}+e_{m}^{n}{\underset{i}{j}}^{i}=2 \mathrm{mnij}$, which is dimensionless, is the sum of the possible carrier exchanges between the \in" excitons ( $i ; j$ ) and the \out" excitons ( $m$; n ), without any Coulomb process. $W$ ith these four com $m$ utators, we can calculate any physical quantities we wish. Indeed, physical quantities involving $N$ excitons can alw ays be written in term s of m atrix elem ents like

To calculate thesem atrix elem ents, we rst push $f(H)$ to the right, to end with $f(H)$ jvi $=$ $\mathrm{f}(0) \mathrm{jvi}$, if the vacuum energy is taken as zero. T his is done using eq. (1). In the sim plest case, $\mathrm{f}(\mathrm{H})=\mathrm{H}$, we have

O nce $f(H)$ is pushed to the right, we start pushing the $B$ 's to the right, according to eqs. $(3,4)$, to end with $B_{m} j v i=0$ and $D_{m} \dot{j} j i=0$, which follows from eq. (4) applied to jvi.

In problem $s$ dealing $w$ th $m$ any excitons, $m$ ost of them are usually in the sam e state 0 . It is then convenient to note that the treration of eqs. $(1,4)$ leads to [17]

The real \{ challenging \{ di culties in problem s dealing with interacting excitons, is not so $m$ uch the calculation of these $m$ atrix elem ents, which after all, can be tedious but is alw ays conceptually trivial; the real di culty is the determ ination of the appropriate
$m$ atrix elem ents we have to calculate to get the physical quantity we want. Indeed, all our background and practioe in problem s dealing w ith interactions, rely on perturbation theory, i. e., on the possibility to isolate an interacting potentialV $=\mathrm{H} \quad \mathrm{H}$ 0, from the H am iltonian. In the case of com posite excitons, this is not possible: W e cannot isolate from the $C$ oulomb potential, the part corresponding to interactions betw een two excitons. Indeed, if we see them as made with (e;h) and ( $e^{0} ; h^{0}$ ), we would say that the Coulomb potentialbetw een these excitons is $\left(V_{e e^{0}}+V_{h h} 0 \quad V_{\text {eh }} 0 \quad V_{e^{0} h}\right)$, while ifwe see them asm ade w ith (eh ${ }^{0}$ ) and ( $(e h)$, this potential should be $\left(V_{e e^{0}}+V_{h h^{0}} V_{\text {eh }} V_{e^{o} h^{0}}\right)$. Since the electrons (holes) are undistinguishable, there is no way to know ! A ctually, the quantity $V_{i}^{y}$, de ned in eq. (1), plays the role of this interacting potential. It how ever has the dim ension of a pair creation operator, this is why we have called it \C oulomb creation potential". To support this idea, we can note that the rst term s of the right hand side of eqs. $(9,10,11)$, which contain ( $\mathrm{H}+\mathrm{E}_{\mathrm{i}}$ ), are in fact the \zero order term s " of the left hand side of these equations, i. e., the term s in the absence of C oulom b interaction between the exciton i and the rest of the system .

The real di culty to get the physics of interacting excitons, is thus to write the quantities we look for, not in term s ofV, as we usually do, but in term sof the H am iltonian H. The H am iltonian a priori contains all the neoessary inform ations on the interactions existing in the system. C onsequently, even if this may not appear as obvious at rst, there should be a way to w rite all quantities dealing with interacting excitons in term $s$ of $H$ only. (N ote that, since there is no $V$, there is no $H_{0}$ \{ because its existence would $m$ ean that we could de ne $V$ \{ so that there is no \unperturbed state" j0i).

A s an exam ple of such a possible new w riting, we have recently considered the lifetim e and scattering rates of excitons [18]. In the usual case, when $H=H_{0}+V$, they are given by the Ferm igolden nule, which reads in term sofV. W e have shown that the lifetim e of an initial state $j$ oi can also be written as

D iagram $s$ associated to this new $m$ any-body theory
The construction of a new m any-body theory has for nal goal, to w rite all processes in which enter interactions, at any order. O fcourse, to reach this goal, we alw ays start in a pedestrian way, by generating the corresponding term $s$, through som ekind of recursion procedure, in order to obtain their m athem atical expressions. H ow ever, if we go to high orders, $m$ ost of the tim e, these expressions becom e so com plicated that we do not \see" their physicalm eaning anym ore. This is why $m$ any-body theories are usually associated to diagram $s$ which are just the visual representation of these $m$ athem atical quantities. T hese diagram s are really usefulbecause they allow to \see" the physics involved in the corresponding term s , in an easy way.

In our new $m$ any boody theory for interacting excitons, enter tw o conceptually di erent scatterings. The direct C oulom b scattering between two excitons dir $\underset{m}{\underset{m}{j}} \underset{i}{j}$ is basically sim ilar to the C oulom b scattering betw een free carriers. It gives rise to diagram swhich look very much like the Feynm an diagram $s$. On the opposite, the Pauli scatterings, h
$h{\underset{m}{n}}_{i}^{j}+e_{m}^{n}{\underset{i}{j}}_{i}^{i}$, are the conceptually new part of our theory. A though they appear as scatterings between two excitons $(i ; j)$, transform ing them into $(m ; n)$, they originate from Pauliexclusion, which $m$ akes the excitons close-to-bosons only, as can be seen from eqs. $(3,4)$. H ow ever, P auli exclusion being $N$ toody \at once" | an additional excition having to be $m$ ade $w$ th carriers in states di erent from all the ones involved in the excitons already present | it is clear that these P auli scatterings betw een two excitons only, cannot be the quantities which appear at the end, in physical e ects in which $N$ excitons are involved. N evertheless, they are quite convenient in the interm ediate stages of the theory, because they allow to write recursion relations betw een scalar products of $\mathrm{N} ;(\mathbb{N} 1) ;(\mathbb{N} 2) ; \quad$ exciton states.

U sing eq. (14), we can in particular show that

Ifwe iterate this equation and perform the sum sover the dum $b$ indices ( $p ; j ;:::$, through closure relations, we end with the \skeleton Paulidiagram s" [8] shown in g2.
$T$ his gure essentially says that the scalar product ofone exciton $m$ along w ith $(\mathbb{N}$ 1) excitons 0 on the left, and one exciton ialong with ( $\mathbb{N} 1$ ) excitons 0 on the right, can be separated into a term in which the excitons 0 do not play any role, and term s in which one, two, ...excitons 0 out of $N$, exchange their carriers $w$ ith the excitons $m$ and $i$, in any possible way. The $N$-dependent prefactors are just the number of ways to choose these excitons 0 am ong ( $\mathbb{N} 1$ ), on each side, while the sign is related to the parity of the num ber of exchanges involved in the diagram, as usual.
$T$ his diagram $m$ atic representation of the $m$ atrix elem ent of $N$-exciton states $w$ th one exciton di erent from 0 on each side, can be extended to any other scalar products [17] having $m$ ore than one exciton di erent from 0. A though this extension $m$ ay appear as reasonable, it did not appear to us obvious, at rst! It in fact relies on heavy calculations which use recursion relations sim ilar to the one of eq. (17). This \reasonable" extension has actually been $m$ ade possible due to the introduction of the \skeleton P aulidiagram s" [8], which allow to get rid of the relative positions of the Pauli scatterings m nij, and which $m$ ake disappearing all the aw kw ard factors 2 due to $e\left(\begin{array}{ll}n & 0 \\ m\end{array}\right)=h\left(\begin{array}{ll}(10 & 0 \\ m\end{array}\right)=h\left(\begin{array}{ll}m & 0 \\ h & 0\end{array}\right)$.

U sing these \skeleton Pauli diagram s", in which can possibly enter som e additional direct Coulom.b scatterings between two exciton lines, due to possible H contributions to the $m$ atrix elem ents of interest, we can represent any quantily we $w$ ish, dealing $w$ ith interacting excitons, in a transparent way.

Som e applications of th is new $m$ any-body theory
W e have used this new many-body theory in a few problems in which interacting excitons are involved:

1) Link with the e ective bosonic $H$ am iltonian for excitons

In order to $m$ ake the link $w$ th the results obtained from the usuale ective bosonic H am iltonian for excitons, we have shown [1] that the scattering $V_{m} n i j$ which appears in
the interaction term of this $H$ am iltonian, $(1=2)^{P}{ }_{m n i j} V_{m n i j} B_{m}^{Y} B_{n}^{Y} B_{i} B_{j}$, where the $B_{i}$ 's are true boson operators, $\left.\mathbb{B}_{i} ; B_{j}^{y}\right]={ }_{i ; j}$, is just

w ould have allowed the e ective H am iltonian to be at least herm itian.
This herm iticity is how ever not enough to get correct results on interacting excitons, because dir and e;h are conceptually independent scatterings: They $m$ ay appear in $m$ any other ways than the ones w ritten in eqs. $(19,20)$. In particular, in problem s dealing $w$ ith photons, e;h can appear alone [16,19], so that the corresponding term $s$ are sim ply $m$ issed by any e ective bosonic H am iltonian, whatever these scatterings are. Indeed, $\mathrm{V}_{\mathrm{m}}$ nij m ust have the dim ension of an energy, while e;h is dim ensionless. M oreover, C oulom b processes which $m$ ay enter these physicale ects, have to appear with energy denom inators, in order to have the sam e dim ension as the pure P auliterm S , which contain e,h only. In problem s dealing w ith photons, these energies are in fact the exciton detunings, so that the C oulom b processes are negligible in front of the pure $P$ auli term $s$ \{ $m$ issed by the e ective bosonic Ham iltonians \{ in the large detuning lim it.
2) Scattering rates and lifetim e of excitons

We have show $n$ that the lifetim e of an exciton state in which all the excitons are in the sam e state 0 , is related to the scattering rates tow ards other exciton states in which two excitons di er from 0, by the relation [18]

where $=1$ if the excitons are bosonized and $=1=2$ if their com posite nature is kept. This show s that it is im possible to nd e ective scatterings for the e ective bosonic H am iltonian, giving both the lifetim e and scattering rates correctly.

This type of sum nule com es from closure relation. W e have show $n$ that, while the one for bosonized excitons is of course the standard closure relation for elem entary particles,
a closure relation also exists for com posite excitons, in spite of the fact that these states form a non-orthogonal overcom plete set [20]. It actually reads [21]

C onsequently, all sum nules $w$ ill appear di erently for exact and boson excitons, $m$ aking the corresponding quantities irretrievably di erent.
3) The trion as an exciton interacting with a carrier

This new $m$ any-body theory for excitons interacting $w$ ith excitons can be adapted to excitons interacting $w$ th free carriers [22-24].

The sim plest of these problem $s$ is surely the trion: $T$ he exciton interacts $w$ ith one electron either by C oulom b interaction or by electron exchange. U sing this approach, we can calculate the trion oscillator strength in a quite easy way [25]. W e have show $n$ that it is one excition volum e divided by one sam ple volum e sm aller than the exciton one, $m$ aking the trion im possible to see in the linear response of a $m$ acroscopic sem ioonductor sam ple.

This approach should allow us to face the m uch harder problem of the linear response of a doped sem iconductor quantum well. Our old work on this problem [26] is quite unsatisfactory, not at all.because C oulom b screening is missing, but because the electronelectron repulsion has been neglected. In order to include it, i. e., in order to study the rearrangem ent of a Ferm isea to the sudden appearance of an exciton \{ not simply to a hole, as we did \{ we have to handle not only C oulom b interaction between the exciton and the Ferm i sea electrons, but also all possible electron exchanges. This again makes our new $m$ any-body theory for interacting excitons rather unavoidable.
4) Optical nonlinearities

The optical nonlinearities com e from interactions with the virtualexcitations induced in the $m$ atter by the photons. In the case of sem iconductors, these excitations are the excitons. C onsequently, in order to derive the optical nonlinearities in sem ioonductors properly, it is necessary to know how to handle interactions between excitons in a secure way. This is why our new $m$ any-body theory for com posite excitons is going to be all the $m$ ost useful for sem iconductor optical nonlinearities.

We have rst reconsidered the calculation of the third order susceptibility (3) [16]. This calculation contains a m ajor di culty, unsolved before our work, which com es from the fact that ${ }^{(3)}$ appears as the sum of 16 term swhich allincrease linearly w ith the sam ple
volum e. O fcourse, as the susceptibility is an intensive quantity, these volum e-linear term s have to cancel. H ow ever, this cancellation has to be shown very carefully in order to get the correct volum e-free term $s$ which rem ain once the volum e-linear term $s$ are rem oved. O urm any-body theory allow s to calculate these 16 tem sexplicitly and to com bine them in order to show that the volum e-linear term $s$ do disappear as expected. H ow ever, this clean cancellation in fact generates volum e-free term sm issed by the previous approaches, which come from pure Pauli interactions between the virtual excitons coupled to the photons. A gain, these $m$ issed pure $P$ auli term $s$ are the dom inant ones at large detuning.

A nother nonlinear e ect in sem iconductor physics is the exciton optical Stark e ect [27]. The seeds of our new $m$ any-body theory were actually in our old works on this e ect, in particular the C oulom b creation potential $V_{i}{ }^{Y}$. The introduction of the two scatterings dir and e;h however $m$ ake the study of this exciton optical Stark e ect quite easy, in particular if we are interested in subtle polarization e ects.

O ur many-body theory is also very convenient to study spin manipulations by laser pulse [19]. W e have recently predicted the spin precession of an electron bound to an im purity, when the sample is irradiated by a pump beam tuned in the transparency region. This precession, which is due to exchanges between the electron bound to the im purity and the electron of the virtual exciton coupled to the pump photon, lasts as long as the laser pulse, so that it can be used for ultrafast spin $m$ anipulation.

## C onclusion

W e have developed a new m any-body theory adapted to interactions betw een com posite excitons.

It relies on two \scatterings": O ne is associated to C oulom.b processes, the other is associated to carrier exchanges induced by Pauli exclusion. This P auli scattering can appear alone or $m$ ixed $w$ ith $C$ oulomb processes, in $m$ any $m$ ore subtle ways than the one appearing in the e ective bosonic Ham iltonian for excitons. W hen it appears alone, the corresponding term s are a priori m issed by the e ective bosonic H am iltonians, whatever are the scatterings they use. T hese $m$ issed term s are often the dom inant ones, due to dim ensional argum ents.

W e have generated a diagram $m$ atic representation of this theory. The direct $C$ oulom $b$
scattering gives rise to diagram s sim ilar to the Feynm an diagram s. On the opposite, the P auliscattering gives rise to diagram swhich are conœeptually new : P auliexclusion being N -body \at once", the corresponding \skeleton Paulidiagram s" show all possible carrier exchanges betw een 2,3,4...excitons, in a quite transparent way.

This new $m$ any boody theory is going to be of great interest for all problem $s$ dealing w ith interactions betw een excitons and betw een excitons and free carriers, as well as for all optical nonlinearities in sem iconductors, because, for the rst tim e, it allow s a clean treatm ent of the possible carrier exchanges.

This new theory is also going to be of im portance in $m$ any other elds than sem iconductor physics, because essentially all particles considered as bosons, are in fact com posite bosons.
