E ect of Spin Current on Uniform Ferrom agnetism : Dom ain Nucleation

Large spin current applied to a uniform ferrom agnet leads to a spin-wave instability as pointed out recently. In this paper, it is shown that such spin-wave instability is absent in a state containing a dom ain wall, which indicates that nucleation of magnetic dom ains occurs above a certain critical spin current. This scenario is supported also by an explicit energy com parison of the two states under spin current.

M agnetization dynam ics driven by spin torque from a spin polarized current (spin current) has been studied extensively after the theoretical prediction [1, 2] that a spin current can be used to ip the magnetization in pillar (or spin valve) structures [3, 4, 5, 6, 7, 8]. As a theoretical framework to describe such current-induced magnetization dynam ics, Bazaliy, Jones and Zhang (BJZ) [9] derived a modi ed Landau-Lifshitz-G ilbert (LLG) equation for a fully-polarized ferrom agnet (halfmetal) with a new term proportional to j r n. This new term represents a spin torque that a current of density j exerts on a localm agnetization n. Later on, it was generalized to the partially polarized case with an interpretation of j as the spin current density, j_s [10, 11]. In the Ham iltonian, the e ect of spin torque appears in a form

where and are polar angles which parameterize n. As seen from this form, spin current favors a magnetic con-

guration with spatial gradient, or more precisely, with nite Berry-phase curvature. It is thus expected that a large spin current destabilizes a uniform ferrom agnetic state. This is indeed seen from the spin-wave energy [9, 10, 11],

where = $\sqrt[P]{J=K}$ and = K_?=K, with J, K and K_? being exchange constant, easy-and hard-axis anisotropy constants, respectively, of localized spins. The rst term is the well-known spin-wave dispersion with anisotropy gap. The e ect of spin current appears in the second term as the \D oppler shift" [10], where v_s (/ j_s) represents drift velocity of electron spins. For su ciently large v_s , k^{ni} becomes negative for a range of k. This means that there exist states with negative excitation energy, indicating the instability of the assumed uniform lymmagnetized state [9, 10, 11]. The true ground state under spin current, how ever, remains to be identified.

In this Letter, we point out that possible ground state is a state containing dom ain walls. N am ely, the energy of a dom ain wallbecom es low er than the uniform ferrom agnetic state when a spin current exceeds a certain critical value j_s^{cr} . The behavior of nucleated dom ains depends much on the magnetic anisotropy parameters; F low ing dom ain wall is stable when the anisotropy is of uniaxial type. For the case of large hard-axis anisotropy, static dom ain wall is stable at the nucleation threshold, but when it starts to ow under larger current, even a state with a dom ain wallbecom es unstable. The nature of the resulting state is still unknown.

Our prediction of dom ain form ation by spin current may be related to the very recent experimental observations in metallic and sem iconducting pillars and Im s [12, 13, 14, 15, 16, 17], which suggest spatially inhom ogeneous magnetization reversal. Dom ain nucleation is also suggested by recent numerical simulation [18].

We start by extending the form ulation of BJZ [9] to arbitrary degree of polarization, and derive the elective Lagrangian for magnetization which is slow ly varying in space and time by assumption. With this elective Lagrangian, we calculate spin-wave dispersion around a domain wall solution in the presence of spin current. The spin-waveD oppler shift term now has the form, $k(v_s X_{-})$, where X- is the speed of the domain wall. From this result, we nd that the spin-wave instability does not occur around a dom ain wall for any large spin current if the anisotropy is of uniaxial type (K > K $_2$). This suggests that the true ground state is a multi-dom ain state with dom ain walls. These dom ain walls turn out to be owing with average speed equal to drift velocity $v_{\rm s}$ of electron spin determ ined by the spin current. The stability is then understood from G alilean invariance, since a dom ain wall at rest and in the absence of spin current.

The situation is slightly di erent in the case of large hard-axis anisotropy, K₂ >> K. Domain walls created by the spin current above $j_s^{\rm cr}$ are at rest if the current is below depinning threshold, $j_s^{\rm depin}$ / K₂ (> $j_s^{\rm cr}$). At higher current, the walls start to ow, but this triggers another spin-wave instability. Thus multi-domain state collapses for j_s > $j_s^{\rm depin}$ into another new ground state which is still unknown [19]. We defer this new state to future studies.

W e consider a ferrom agnet consisting of localized spins and conduction electrons. The spins are assumed to have an easy z-axis and a hard y-axis, and described by the Lagrangian

We have adopted a continuum description for localized spins, S(x;t) = Sn(x;t), with unit vector n(x;t) =(sin cos; sin sin; cos) and the magnitude of spin, S. The J is the exchange constant, and a the lattice constant. The easy-axis (K) and hard-axis (K;) anisotropy constants generally incorporate the elect of dem agnetizing eld. The exchange interaction between localized spins and conduction electrons is given by

where 2 and \hat{c} (\hat{c}^{y}) are the energy splitting and annihilation (creation) operator of conduction electrons, respectively, and is a Pauli-matrix_pvector. The freeelectron part is given by $\hat{H}_{el}^{0} = \begin{bmatrix} r \\ k \end{bmatrix}_{k} \hat{C}_{k}^{V} \hat{C}_{k}$ with $k = h^2 k^2 = 2m$. We perform a local gauge transform ation [20, 21] in electron spin space so that the quantization axis is parallel to S (x;t) at each point of space and time; $\hat{c}(x;t) = U(x;t)\hat{a}(x;t)$, where $\hat{a}(x;t)$ is the two-component electron operator in the rotated fram e, m (x;t) is an SU(2) matrix with and U (x;t) m(x;t) = (sin(=2)cos;sin(=2)sin;cos(=2)). The electron part of the H am iltonian is now given by $\hat{H}_{el} =$ $k = k a_k^y a_k$ with $k = h^2 k^2 = 2m$, and the interaction H am iltonian \hat{H}_{int} by

Here, A $(q;t) = {}^{R} d^{3}xe^{iq \cdot x}A(x;t)$ with A (x;t) = m @ m represents SU (2) gauge eld with space (= x;y;z) and time (= 0) components.

For slow ly varying magnetic congurations, the elective Lagrangian can be derived by a perturbative expansion with respect to A. This is the gradient expansion. In conformity with L_s , we retain terms up to second order in spatial gradient or in A_i (i = x;y;z), and

rst opder in time derivative or in A_0 . The spin-torque term , $_x \frac{h}{e} j_s$ Å, arises from the rst-order contribution hf_{int} i. Here $j_s = \frac{e}{V} {}^k_k \frac{hk}{m} f_k$ is the spin current density in the rotated frame, with a distribution function $f_k = h a_k^y$ (t) a_k (t) i specifying the state carrying current. O ther term s just give renorm alizations of J and S [20]. The elective Lagrangian is thus given by

The second term, given by Eq. (1), with j_s is identical to that derived by BJZ [9] for the half-m etallic case. It is seen that spin current favors a nite Berry phase curvature along the current. The modil ed LLG equation can be obtained by taking variations of L_e with respect to and . It has the same form as in BJZ, and is applicable to general slow ly-varying spin texture, and to the case of arbitrary degree of polarization.

Let us now study the spin-wave excitation around a domain-wall solution under spin current by using the m ethod of collective coordinate [22]. The wall is assumed to be planar and m oving in the direction perpendicular to the plane (chosen as x-direction). It is convenient to use a complex eld $(x;t) = e^{i(x;t)} \tan \frac{(x;t)}{2}$ to represent m agnetization. We decompose it into the domain-wall conguration and spin waves around it:

where $_{dw} = \exp[(x \quad X \ (t)) = + i_0 \ (t)]$ represents a dom ain-wall con guration. The wall position X (t) and the angle $_0$ (t) between wall spins and the easy plane are proper collective coordinates [21, 23, 24, 25, 26]. The spin-wave part is expanded with modes $'_k(x) = \frac{p-1}{k^2-2+1}$ (ik + tanh^x)e^{ikx} [23, 26], whose amplitude k precisely corresponds to the Holstein-Prim ako boson. (L is the length of the system in the x-direction.)

Substituting (8) into (7), we obtain the spin-wave Lagrangian L_{sw} , up to the quadratic order in , as

where N = 2 A = a^3 is the number of spins in the wall (A is the cross-sectional area of the wall), ${}_{k}^{(0)} = \frac{K \cdot S}{h} (k^2 + 1 + 2)$ and $v_c = \frac{K \cdot S}{2h}$. Details of the calculation will be presented in a separate paper. From Eq. (9), we nd the spin-wave dispersion around a current-driven dom ain wall:

The most important di erence from the case of uniform ferrom agnet is that the drift velocity $v_s = \frac{a^3}{2eS} j_s$ of spin current appears as a relative velocity, v_s X-, with respect to the moving wall.

Equation (10) shows that the spin-wave energy depends strongly on the walldynamics (through X- and $_0$). From the equations of motion for the domain wall [21], $_0 + X_- = 0$ and X- $_0 = v_c \sin 2_0 + v_s$, where

1 is a damping parameter, we have $(1 + {}^2)X_{-} = v_c \sin 2_0 + v_s$. Neglecting terms of 0 (²), we have,

which depends on j_s in plicitly through $_0$.




FIG.1: Schem atic phase diagram under spin current $j_{\rm s}$ in the absence of pinning potential. (a) K $_{\rm ?}$ < K . Above $j_{\rm s}^{\rm cr}$, uniform ferror agnetism collapses into multi-dom ain structure in which dom ain walls are owing due to spin current. The threshold, $j_{\rm s}^{\rm depin}$, for "depinning" from K $_{\rm ?}$ is below $j_{\rm s}^{\rm cr}$. (b) K $_{\rm ?}$ 8K . Energy of the single-wall state (E $_{\rm dw}$) is com – pared with that of the uniform ly m agnetized state, E $_{\rm uni}$ = 0. Multi-dom ain state here remains at rest. In the gray region, $(j_{\rm s}>j_{\rm s}^{\rm depin})$, the dom ain wall starts to ow but is unstable, suggesting a new ground state.

For K > K_?, it is easy to see that $_{k}^{dw}$ remains positive for all values of k and j_{s} [27]. Thus a domain-wall state is stable irrespective of the magnitude of the spin current in this case. This indicates that a uniform ferrom agnetism collapses into a multi-domain con guration for $j_{s} > j_{s}^{cr}$, where $j_{s}^{cr} = \frac{2eS^{2}}{ha^{3}}K$ (1+ $\frac{P}{1+}$) is the critical spin current density for the instability of a uniform ferrom agnet [9, 10, 11]. Since the domain wall ows for $j_{s} > j_{s}^{depin}$ $\frac{eS^{2}}{ha^{3}}K$ [21], which satis es $f_{s}^{rr} > j_{s}^{depin}$, it starts to ow as soon as it is created (Fig.1(a)). The stability of moving domain wall state is natural from G alilean invariance since domain wall with velocity of v_{s} is equivalent to the static domain wall without spin current.

In the opposite case, K $_2$ > K , the spin wave shows no anomaly as long as $j_s < j_s^{\rm depin}$, where the wall remains static with constant $_0 \ (= \ \frac{1}{2} \sin^{-1} (v_s = v_c))$. Hence,

for $j_s^{cr} < j_s < j_s^{depin}$ ($j_s^{cr} < j_s^{depin}$ is realized when $K_? > 8K$), the static multi-domain state is realized. In contrast, as soon as the wall starts to move under larger spin current ($j_s > j_s^{depin}$), the spin wave becomes unstable (Eq.(11)). Thus another ground state would appear. The wavelength of the unstable mode around the uniform magnetization, $k = (K (K + K_?) = J^2)^{1=4}$ [11], suggests that this unknown ground state has a spatial structure with short length scale of $(K K_? = J^2)^{1=4} = (K = K_?)^{1=4} < .$

W e have thus shown that the spin-wave instability under spin current is avoided by the existence of dom ain wall. This may indicate that dom ain nucleation occurs under spin current. W e cannot, how ever, answer here how many dom ains are created. The above argument holds for each segment larger than the wall thickness, , and thus the dom ain wall can be nucleated with spacing of . For a correct estim ate of the spacing, how ever, we need to consider the dipolar interaction among dom ains. W e will not pursue this point in this letter.

W e here present a supporting argum ent for the above scenario of domain formation by evaluating explicitly the total energy of a domain wall in the presence of spin current. We consider only the case K K_? and $j_s^{cr} < j_s$ j_s^{depin} , where the wall can remain static and thus the energy comparison has physical meaning. A static domain wall con guration is given by (x;t) = $s(x) = 2 \tan^{1} \exp(x = 0)$, (x;t) = s(x), where 0 = 1= $\frac{1}{1 + \sin^2 0}$ includes the e ect of contraction of domain wall [28] ($_0 \qquad \frac{1}{2} dx_s (\theta_{x s}) sin_s$). Note that s (x) is not spatially constant when there is a spin current. For large hard-axis an isotropy, K $_{?}$ $\frac{ha^{3}}{eS^{2}}$ js, substitution of the static solution s and s into the modi ed LLG equation leads to $_0$ ' (h³=2eS² K_?)j_s 1. The total energy, $H_{S} + H_{ST}$, of this static dom ain wall is then given by [29]

Since the energy E_{uni} of the uniform state is zero independently of j_s , we nd that $E_{dw} < E_{uni}$ when $j_s > \frac{2eS^2}{ha^3} \frac{p}{2K K_2}$ (Fig.1 (b)). This critical value is of the same order of magnitude as j_s^{cr} for K_2 K. Thus, the uniform ly magnetized state is a Yalse vacuum', which collapses into a multi-dom ain state via rst order phase transition under spin current above a critical value.

The domain form ation may be understood from the spin wave around uniform ferrom agentism. In fact, the spin wave energy, $_{k}^{uni}$, given by Eq. (2), indicates that the typical wavelength of the spin wave excitation (determined by the minimum of the spin wave energy) is given by k¹ $_{2}^{2}(\frac{1}{1+}$ K S)=(hy) for small j_s. As the current increases, the wavelength becomes shorter and

the critical current is given by the condition it becomes comparable to the wall thickness.

The above estimate of the critical current density obtained for a planar wall would be applicable also to the case of nucleation in lms such as in Ref.[15], at least for an estimate of order of magnitude.

Let us estim ate the critical current num erically. The m agnitude of the current needed for nucleation in a wire 3 $1\theta^3 A = m^2$ by using the materials is estim ated as j_s parameters of Co: a = 2:3 A, S = 1, $J = 3 = 10^{40} \text{ Jm}^2$, 10^{24} J, (= J=K = 76 A), under the K = 62assumption that K $_{?}$ is mostly due to the dem agnetizing 10²³ J. Recent experi $eld, K_{2} = M_{s}^{2}a^{3} = 0 = 3$ ment on a Co layer with a current through a point contact with dom ain suggests a dom ain wall form ation for a maximum current density close to the contact region of 5 10^{2} ¹³ A/m² [13, 14, 15]. This value is in rough i agreem ent with our estim ate. O ther recent experim ents on m etallic and sem iconducting pillar structures indicating inhom ogeneous magnetization reversalm ay also be due to dom ain (or dom ain-like) structure created by spin current [12, 16, 17].
