Rapid rotation of a Bose-Einstein condensate in a harm onic plus quartic trap

A two-dimensional rapidly rotating Bose-Einstein condensate in an anhamonic trap with quadratic and quartic radial con nement is studied analytically with the Thomas-Ferm i approximation and numerically with the full time-independent Gross-Pitaevskii equation. The quartic trap potential allows the rotation speed to exceed the radial harmonic frequency !_?. In the regime & !_?, the condensate contains a dense vortex array (approximated as solid-body rotation for the analytical studies). At a critical angular velocity $_{\rm h}$, a central hole appears in the condensate not in the Thomas-Ferm i limit. The behavior is also investigated at larger angular velocities, where the system is expected to undergo a transition to a giant vortex (with pure irrotational ow).

I. IN TRODUCTION

The developm ent of experim ental techniques to create a single vortex in a dilute trapped Bose E instein condensate (BEC) [1, 2] rapidly led to larger arrays containing up to several hundred vortices [3, 4, 5, 6]. Typically, these condensates rotate rapidly, with angular velocities that approach the radial trap oscillator frequency $!_{?}$. The resulting centrifugale ect signi cantly weakens the radial con nem ent, so that the condensate expands radially and shrinks axially [4, 5, 7].

In a pure harm onic radial trap, the lim it $! !_?$ is singular, because the Thom as Ferm i (TF) radius diverges and the central density decreases tow and zero. Consequently, the angular momentum also diverges, and it becomes increasingly di cult to spin up the condensate as it approaches this lim it. In addition, the single-particle H am illonian reduces to that of a charged particle in a uniform magnetic eld [B], and the ground state can be constructed from the low est-Landau-level wave functions. Recent experiments have explored the crossover region between these two regimes [9, 10].

For this combined potential, the system is expected to have no vortices at su ciently slow rotation speeds . W ith increasing , there is a sequence of states with an increasing number of vortices that eventually form a relatively large vortex lattice. This behavior is not qualitatively di erent from that in a pure harm onic trap. The new feature of the quartic con ning potential is that the condensate continues to expand radially for $> !_?$, with a central hole appearing at a critical angular velocity h. For still larger values of , the condensate has an annular form with a mean radius that continues to expand with increasing . Ultimately, a giant vortex is expected to appear when the singly quantized vortices disappear from the Thom as Ferm i condensate, leaving an axisymm etric state with pure irrotational ow in the annulus. O ne reason for the interest in the additional quartic potential is that the central hole and giant vortex do not occur for a pure harm onic trap potential.

P revious theoretical work on this system has been mainly numerical [14, 15] or for weak interactions and small anham onicities [16], and here we report an analytical study of the TF regime, approximating the actual super uid velocity of the dense vortex array by solid-body rotation $v_{sb} = r$. In addition, we perform a full numerical study of the two-dimensional G ross-P itaevskii equation for dimention the remainder the two-dimension of the numerical study analytical studies conmost the qualitative features of the TF analysis. Section II summarizes the basic TF procedure. This approach predicts the critical angular velocity $_{h}$ for the initial appearance of a central hole, surrounded by a dense vortex lattice (Sec. III). The corresponding numerical study is described in Sec. IV, conmon ing the TF result for $_{h}$. For larger values of $> _{h}$, the TF approximation predicts that the annular condensate expands radially with constant area. Thus the width of the annulus decreases, and eventually the vortices are expected to retreat into the central hole (Sec. V), leaving a pure irrotational state with m acroscopic circulation (offen called a \giant vortex") [14, 15, 17]. Since solid-body rotation alwaysminimizes the energy in the rotating frame, this transition to a giant vortex depends essentially on the discrete character of the quantized super uid vortices. C om parison with our numerical studies shows that the theoretical analyses are less successful in modeling this transition [15]. The problem of interest is the equilibrium state of a rapidly rotating trapped Bose-E instein condensate in a twodimensional con ning potential that has both quadratic (harm onic) and quartic components. In terms of the usual dimensional quantities, the trap potential has the form

where $d_2 = \sqrt{-4M_2}$ is the harmonic-oscillator length, r is the two-dimensional radial coordinate and is a dimensionless constant that characterizes the admixture of the quartic component. For simplicity, it is convenient to treat an electively two-dimensional system, uniform in the z direction over a length Z. K avoulakis and B aym [15] considered the same two-dimensional system, especially in the lim it of rapid rotation where the condensate develops a central hole and becomes annular.

In a fram e rotating with angular velocity , the energy is given by the functional

where is the condensate wave function, the integral is over the three-dimensional volume, a > 0 is the s-wave scattering length and $L_z = R$ [2 (r p)] is the z component of angular momentum. Once \hat{E} is evaluated for xed particle number N = $dV j j^2$ and xed , the chemical potential and angular momentum follow from the therm odynamic relations

Equivalently, the free energy $F = E^0$ N incorporates the constraint of xed N with the chemical potential as a Lagrange multiplier.

For the speci c two-dimensional case studied here, the condensate wave function can be chosen as $= \frac{p}{N-Z}$ (r), and the normalization condition becomes

It is convenient to use dimensionless harmonic-oscillator units, with $!_2$ setting the scale for frequency and energy, and d_2 setting the scale for length. In addition, we use a dimensionless coupling parameter g = 4 N a=Z, so that Eq. (2) has the dimensionless form

while Eq. (4) is unchanged. Using the replacement $= \frac{p_{n}}{n}e^{is}$, we can rewrite the rst term in Eq. (5) as $jr_{n} = jr_{n} + jr_$

Variation of the free energy with respect to j f yields the fam iliar TF density

which allows a direct determ ination of from the norm alization condition (4) and E^{0} from (6); as a check, (N;) must also follow from the rst therm odynamic relation in (3).

The aim is to study the system for di erent annular condensates.

- 1. The rst is an annulus containing a vortex lattice, for which the super uid ow is approximated as solid-body rotation $v_{sb} = r$. This approach has the principal advantage that all the physical properties can be evaluated analytically, in contrast to the more elaborate trial wave function and num erical approach used in Ref. [15]. The approximation of replacing the vortex lattice by uniform vorticity works well when the W igner-Seitz circular cell radius l = 1 = 1 (in dimensional units, l = 1 = -1) is much smaller than all the dimensions of the annulus.
- 2. As increases, the annular condensate becomes increasingly narrow, with the width d proportional to 1 = .Eventually d becomes comparable with the intervortex spacing 21. Near this angular velocity, elementary considerations [18] suggest that the vortex lattice would disappear, indicating a transition to a giant vortex with irrotational ow enclosing the central hole. Note that this transition depends crucially on the nonzero quantum of circulation = h=M, which determ ines $1 = \frac{1}{2} - \frac{1}{2}$. A quantitative study of this transition rst requires an analysis of an annulus with pure irrotational ow, when the condensate wave function has the form $= j je^i$, with a large integer. The irrotational velocity is azim uthal with $v_{irr} = -r$.
- 3. A detailed theory of the critical angular velocity for the transition to a giant vortex requires the inclusion of the additional energy associated with the local deviation of the velocity from solid-body rotation in the vicinity of an individual vortex core [15, 17, 19]. P revious num erical studies of the G ross-P itaevskii equation suggest that the relevant com parison state in a narrow annular condensate is a one-dimensional vortex array combined with m acroscopic circulation [14, 20]. For simplicity, our present theoretical analysis treats only a single vortex at the m idpoint of the annular gap. This TF m odel yields a value g for this transition that is considerably larger than that predicted by K avoulakis and B aym [15], but our num erical results indicate that the actual transition occurs at still larger values.

III. UNIFORM VORTEX LATTICE W ITH CENTRAL HOLE

A single vortex located at the point r_0 induces a circulating ow velocity \hat{z} $(r = p) = \frac{1}{r_0} r_0 \frac{1}{2}$. Thus, an array of vortices located at the points fr_1g induces a total ow

In the lim it of a dense vortex array with dimensionless areal density = (= $M = \sim in \text{ conventional units}$), the sum can be approximated by an integral over the area of the annular region $R_1 = r R_2$, yielding

for the velocity induced by the vortices in the annular region. The rst term is the expected solid-body rotation, but the second term represents the hole in the center of the annulus. Thus it is necessary to add the irrotational ow $v_{irr}(r) = (R_1^2 = r)^2$ arising from the phantom vortices in the hole. In the TF approximation, these vortices can be considered either to have the same uniform density = or to combine into a single macroscopic circulation with R_1^2 quanta concentrated at the origin, since the interior of the annulus lies outside the physical region. Thus the total super unid ow velocity in the annular region becomes $v = v_a + v_{irr} = r = r^2$.

The solid-body ow velocity greatly simpli es the TF density in Eq. (7) to yield

For < 1, the density has a local maximum near the center, but it changes to a local minimum for > 1. The central density is proportional to , which decreases continuously with increasing [7]. For su ciently large rotation speeds, the central density and can both vanish, which corresponds to the point at which the central hole rst appears, as discussed in the next subsection.

A. Onset of form ation of a central hole

The simple form of Eq. (10) allows a direct solution for the \classical" turning points where the TF density vanishes

Here the upper (plus) sign denotes the outer squared radius R_2^2 for any value of the chem ical potential . In contrast, the lower (m inus) sign yields a physical inner radius R_1^2 only if is negative.

The central hole in the uniform vortex lattice rst appears when = 0 (so that R $_1^2$ also vanishes). For this value, the normalization condition (4) gives the explicit condition $12g = R_2^6$. This equation determ ines the critical rotation frequency h at which the central density rst vanishes (namely the rst appearance of a central hole in the vortex lattice). It can be written in the equivalent form s

Note that $h = h a l w a y s exceeds 1 (namely <math>h > !_{?}$ in dimensional units).

B. Properties of the vortex lattice with central hole

If > h, then the chem ical potential is negative, and the squared TF radii obey the simple relations

The norm alization condition (4) yields $R_2^2 = R_1^2^3 = 12g$, and comparison with Eqs. (12) and (13) in mediately gives the (negative) chemical potential

Equations (13) show that the mean squared radius grows with increasing angular velocity, while, in contrast, the di erence remains xed

for all > $_{\rm h}$. This relation shows that the area $R_2^2 = R_1^2$ of the annular condensate with a vortex array remains constant for all $_{\rm h}$. Since the areal vortex density is = , the number of vortices in the annular region itself is $N_a = R_2^2 = R_1^2 = \frac{2}{h} = 1 =$, which increases linearly with . In contrast, the number of phantom vortices associated with the irrotational ow is $N_{\rm irr} = R_1^2$ so that the elective total number of vortices becomes

It is not di cult to manipulate the expressions for $R_2^2 = R_1^2$ to obtain the mean radius $R = \frac{1}{2}(R_2 + R_1)$ and the width $d = R_2 = R_1$ of the annular region, for example

This expression reduces to R_2^2 in the limit ! h, where the hole just form s, and d decreases continuously as increases, which is an obvious consequence of the xed area of the annular condensate. For large h, Eq. (17) shows that

The energy E^{0} of the rotating condensate with a central hole follows by integrating the corresponding chem ical potential in Eq. (14) using the rst therm odynamic relation in (3) and noting that g / N

The rst factor relects the usual linear relation between the angular velocity and the angular momentum. The second factor (2 1)=(2) is the mean squared radius from Eq. (13). Comparison with Eq. (16) for the elective total number of vortices shows that the angular momentum per particle per vortex is 0.5 when the hole rst appears, but it increases monotonically toward 1.0 for $_{\rm h}$. This behavior is readily understood. For any annular TF condensate with approximate solid-body rotation v r, density n (r) in the interval 0 R r R and total number of vortices N $_{\rm v}$ = R $_2^2$, the angular momentum per particle per vortex is the average of $r^2=R_2^2$ with n (r) as weight factor.

It follows from Eq. (10) that the maximum density occurs at the mean squared radius

which is constant for h, namely for the annular condensate with a dense vortex array. In contrast, Eq. (18) shows that the width d of the condensate decreases like 1 for large .

C. Validity of the Thom as-Ferm i approxim ation

The Thom as Fermi approximation assumes that the healing length is much smaller than the width of the annulus d. Since is independent of in the present model, this condition will fail for su ciently large . A fler some algebra, the condition 2 d² yields the explicit restriction

For large , the constraint (24) reduces to ${}^{2} 2\beta^{p-} g=(2)$]⁴⁼³. If 2 violates this restriction, the width of the condensate becomes too small to satisfy the TF approximation. Since also characterizes the size of the vortex core, the condition ${}^{2} d^{2} m$ eans that a vortex no longer ts in the annular gap, suggesting that at large angular velocities the system will exhibit a transition to a conguration with pure irrotational ow (a giant vortex). This transition will be discussed in Sec.V.

The Thomas-Ferm i approximation also assumes that the healing length is small compared to the circular-cell radius l = 1 = 1 in harm onic-oscillator units. Equations (18) and (23) together imply that

Thus $d = \frac{p}{2l^2} = \frac{2}{r}$, so that the inequalities d and lare closely related.

In this section we study rapidly rotating condensates num erically, using the full G ross-P itaevskii equation, and com pare our results directly to those derived analytically in the previous section. The dimensionless two-dimensional time-dependent G ross-P itaevskii equation is

where $r^2 = x^2 + y^2$, and is again normalized to unity.

Equation (26) can be solved numerically by propagating some initial wavefunction in imaginary time, where one simply makes the replacement ! it. Then, over an appropriate time scale, the system relaxes to the ground state at the given angular velocity . For su ciently large angular velocities, this ground state will contain one or more vortices, ultimately arranged in a triangular lattice. In order to break any residual symmetries in the system, we add random noise to the initial wavefunction. In imaginary time, vortices then appear at the edge of the condensate before penetrating into the bulk and relaxing into the lattice, similar to the real-time simulations of [14]. In some cases, more than one random initialization was tried in order to check whether we have reached the true ground state [21].

Figure 1 shows the density $j(x;y)\dot{f}$ of the condensate as one increases the angular velocity, for g = 80 and g = 0.5. For this quite small interaction strength, the Thom as Ferm i approximation should not be particularly good (for example, the nonzero density extends beyond the usual TF radii). At small angular velocities [Fig.1(a)], one observes a vortex lattice similar to that seen in harm onic traps, with one singly quantized vortex at the center surrounded by six others in a ring. As increases, another vortex appears near the central one [Fig.1(b)], until, for > 2.25 they m erge to form a doubly quantized vortex surrounded by a ring of singly quantized vortices [Fig.1(c)]. This situation roughly corresponds to the case of a vortex lattice with hole that is expected in the large-interaction limit. Then, as

increases still further, the size of the hole and the circulation around it both increase [Fig.1(d)]. Eventually, the vortices in the outer ring recede into the hole. Figure 1(e) at = 3.0 shows the resulting density pro le, where all the vortices lie inside the hole. However, not all of the circulation is contained in a central multiply quantized vortex, since other vortices are distributed around the center. Thus, this state cannot be truly term ed a giant vortex. Then as increases further, the circulation is entirely absorbed into the giant vortex, as shown in Fig.1(f) at = 3.5. In this small-g regime, the preceding discussion highlights that the transitions between the three phases (vortex lattice, lattice with hole, and giant vortex) are somewhat gradual. In Sec. V, we use the Thom as Ferm i approximation to discuss the transition to the giant-vortex state in m ore detail.




FIG. 2: Density prodes of a rotating condensate at g = 1000 and = 0.5, for (a) = 2.0, (b) = 3.0, (c) = 3.5, (d) = 4.0, (e) = 4.5, (f) = 5.0, showing the stable vortice lattice con gurations. The scale of each gure is 6 6 in units of d_2 .

We have also performed calculations for stronger interactions (g = 1000). In this case one nds a vortex lattice at = 2.0, as before [Fig. 2(a)]. However, as increases, a density depression appears in the center of the condensate, with an associated increase in the core size of the central vortices [Fig. 2(b)]. At approximately ' 3.3, the density dips to zero at the center, which can be taken to be the numerical value of $_{\rm h}$. Figure 2(c) shows a typical con guration with a central hole surrounded by two rows of vortices. As increases, the inner row is absorbed by the expanding hole until, in Fig. 2(f) (= 5.0) only one row of vortices remains. For larger , we nd that the inner and outer radii of the condensate both increase in size, but the basic structure (a hole with a single ring of vortices) remains the same. We see no transition to the giant-vortex state up to = 7:0, above which unfortunately the numerics become

very di cult. N evertheless, this value sets a low er bound on $_{\rm g}$ for the transition to the giant vortex. For this angular velocity, the TF gap width and healing length from Eqs. (17) and (23) are d 1:43 and 0:144, so that the TF approximation is well justified. A loo note that the density distributions discussed here are qualitatively similar to the radial proles found in a three-dimensional calculation of R ef. [20].

To make a quantitative comparison of the numerical results in Fig.2 with the analytical results, we have measured the intervortex spacing $b_{m \ eas}$ for the nearly triangular lattices in Figs.2 (a)-(d) and compared them with the predicted values for an ideal triangular lattice using the expression $b_{tri}^2 = 2 = (\frac{1}{3})$. Table I shows that they agree very well, but the measured values $b_{m \ eas}$ decrease som ew hat more slow ly than would be expected for an ideal lattice at the same angular velocity.

TABLE I: Comparison of numerical values for intervortex lattice spacing $b_{m eas}$ in a rotating condensate with g = 1000 and = 0.5 (obtained by direct measurements from Fig.2) to the theoretical intervortex spacing b_{tri} for an ideal triangular lattice.

For larger angular velocities, the vortex array is one-dimensional and the annular condensate becomes increasingly narrow. The mean radius R_{meas} and width d_{meas} can be measured from the numerical solutions by dening a reference density (in this case j f = 10 4) and noting the radii at which the density is equal to this reference. Note that the inner and outer radii derived from this technique will di er from those calculated using the TF approximation, since in the latter case the density vanishes at well-de ned points, while for the num erical results it does not. Nevertheless, the value of the measured mean radius is not likely to be a ected too much by this detail and can be compared with the TF prediction R_{TF} , which follows from an expression similar to Eq. (17). In addition, from $R_{m eas}$ and the num ber N $_{\rm a}$ of vortices in the array, we can readily calculate the intervortex spacing $b_{\rm n \ eas}$ (Fig. 2 contains only the condensate for = 5.0, but those for = 6.0 and 7.0 are qualitatively sim ilar). Finally, the measured width d meas of the annular condensates can be compared to the TF prediction in Eq. (17). Note, however, that d_{meas} is a ected by the num erical technique used to extract the radii, so only the dependence can be checked when comparing to d_{TF} . Table II contains these quantities. The most striking feature is that the measured intervortex spacing actually increases with increasing , in contrast to the 1= dependence for an ideal triangular lattice. This behavior, which can be considered an extrapolation of that in Table I, may be a precursor of the transition to a giant vortex. The values of N_a found in our num erical solutions are much lower than those calculated from (15), which may re ect a non-uniform vortex density near to the edge of the condensate. In addition, Eq. (15) assumes a dense vortex array and therefore gives only a sem i-quantative estim ate of the num ber of vortices in the annulus when the array becom es one dim ensional.




FIG. 3: Phase diagram of a condensate rotating with angular velocity versus interaction strength g, with = 0:5, where the solid line is the critical frequency $_{\rm h}$ [Eq. (12)] derived from our TF analysis. Going from left to right, the rst state (denoted VL) is a vortex lattice without a hole, while above $_{\rm h}$ (solid line) a hole appears (denoted VLH). Then, for $> _{\rm g}$ (dashed line) the TF analysis predicts a giant vortex state (denoted GV). In addition, the dotted line indicates the crossover region where the TF approximation fails [de ned here by the som ewhat arbitrary criterion d² 10², where d and are given by Eqs. (17) and (23)]. For comparison we also show the results of K avoulak is and Baym [15], where the lled and open circles represent $_{\rm h}$ and $_{\rm g}$ respectively. Finally, our num erical results for these quantities are plotted as lled and open triangles.

Figure 3 compares the -g phase diagram resulting from this numerical analysis to the analytical TF results presented earlier. One can see that the value of $_{\rm h}$ found in the numerical calculations is very close to the analytical result in Eq. (12). This is true not only for the value of g = 1000 presented in Fig. 2; even for g = 80 the agreement is very good, which is somewhat surprising since the Thom as Ferm i approximation assumed in the numerical value of $_{\rm h}$ quoted here is approximate, with an error of 0:1. In addition one can see that both the analytical and numerical results are very close to those of K avoulakis and B aym [15]. Near the horizontal axis, Fig. 3 also show s the crossover to a region where the Thom as Ferm i approximation is expected to fail, as estimated by the criterion $d^2 = 10^2$ with d and given by Eqs. (17) and (23).

W e have also calculated the energies of these vortex-lattice con gurations. The num erical and analytical results will be discussed in the next section.

V. IRROTATIONALFLOW IN ANNULAR REGION (\GIANT VORTEX")

The vortex array considered in Sec. III has the uniform vortex density = in dimensionless oscillator units, which de nes an elective vortex radius l = 1 = 1. In any rotating super uid, this quantity decreases with increasing angular velocity. The new feature of the present system is that the geometry itself also depends on . In particular, Eq. (18) shows that the width of the annulus decreases proportional to 1 = and eventually becomes comparable with the intervortex distance 21. Near this critical angular velocity, the vortex array rst becomes one-dimensional and then should disappear in a transition (perhaps a crossover) to pure irrotational ow, as seen in the numerical simulations

of Sec. IV and Ref. [14] and studied in an approximate TF theory in Ref. [15].

A. Pure irrotational ow

To study this behavior in detail, it is rst necessary to rst consider the case of pure irrotational ow, when $(r) = e^{i} j(r)jw$ ith the quantum of circulation (and is the angular momentum in units of ~). The resulting velocity is azim uthalw ith $v_{irr}(r) = =r$. Since will be large, it can be treated as a continuous variable, ignoring the discrete transitions between adjacent large integral values. The TF density is now given by

where $\sim = +$ is a constant [15, 17] and

can be considered an elective potential that combines the centrifugal barrier and the original trap potential (here, $x = r^2$). This function U (x) has a single minimum at x_0 determined by U⁰(x_0) = 0, so that x_0 is also the position of the localm aximum in the TF density. The density vanishes at the two classical turning points $x_1 = R_1^2$ and $x_2 = R_2^2$, determined by the condition

The norm alization condition can be written

Here, the physical quantities N (;;) and F (;;) depend explicitly on the chemical potential and the angular velocity; equivalently, the normalization condition (30) can also be obtained from the thermodynamic derivative N = @F = @. The equilibrium value of the circulation, which is an additional parameter in the calculation, follows by minimizing the free energy, @F = @ = 0, yielding [15]

For a given N and , Eqs. (29), (30) and (32) must be evaluated to nd the energy E 0 (N;) in the rotating frame. Comparison with the corresponding quantity for the condensate containing a one-dimensional vortex array then determ ines the phase diagram. In Ref. [15], this procedure was carried out numerically, which does not emphasize the relevant parameters needed for a physical interpretation. Instead, we recall that the annulus expands radially and become as increasingly narrow for large , as seen in Eqs. (18) and (19). Thus an expansion in the small parameter d=R [2 g=(4)] ${}^{1=3}$ characterizes the irrotational state in the relevant limit of rapid rotation.

The m inimum x_0 of the potential U (x) in Eq. (28) satis es the cubic equation

which makes a direct analysis quite intricate. Instead, the large value of $x_0 = R^2$ relative to $x_2 = x_1 = 2R d m$ akes it natural to expand U (x) around x_0 , and it is necessary to include corrections through order $(x = x_0)^4$. To make this procedure precise, let $x = x_0 = x_0$, where j = 1, so that the inner and outer boundaries are given by $x_i = x_0 (1 + i)$. In addition, let

which de nes $_{0}$ in terms of the other parameters. It is not dicult to determ ine $_{1}$ and $_{2}$ as series in powers of $_{0}$, and it is su cient to keep terms of order $_{0}^{3}$. In this way, Eqs. (30) and (31) reduce to integrals of the form $_{1}^{2}$ d where denotes a function that is readily expanded in powers of .

A lengthy analysis eventually leads to useful and physical expressions. For example, the ratio of Eqs. (30) and (32) yields the som ew hat implicit expression for the quantum of circulation

A sexpected, the leading term here is simply the quantum number associated with the angular momentum $x_0 = R^2$ of a narrow annulus, and the term of order $\frac{2}{0}$ arises from the small TF corrections.

The next step is to solve the cubic equation (33) for x_0 by expanding it for large values of (${}^2=2$) ${}^{1=3}$. The resulting power series for x_0 can be combined with (35) to give the mean squared radius

Note that the leading term for x_0 reproduces (13) for the mean squared radius of an annulus with a uniform vortex array and the leading term for reproduces the angular momentum (21) for an annulus with a uniform vortex array; in both cases, the corrections involve the small parameter $\frac{2}{0}$. A combination of Eqs. (34) and (37) then gives the chem ical potential

The remaining step is to determ ine the sm all parameter $_0$ from Eqs. (30) and (36), leading to

Since $_0$ is small, this result requires $[{}^2g=(4)]^{1=3}$, which ensures that d=R 1. These relations readily provide the inner and outer squared radii $R_1^2 = x_0 + x_0_{12}$ and $R_2^2 = x_0 + x_0_{22}$. To leading order, the mean squared radius is x_0 and the width is given by $d^2 = x_0^2 (2 = 2) [\frac{1}{2}g=(2)]^{2=3}$. In more detail,

C on parison with Eqs. (13) and (15) shows that the mean squared radius here slightly exceeds that for the annulus with a uniform vortex array, whereas the width here is smaller by a factor 3 $^{1=3}$.

Substitution into Eq. (38) expresses the chem ical potential for the irrotational giant vortex in terms of the appropriate variables N and

Integration of the therm odynam ic relation (3) then yields the energy in the rotating fram e

It is not surprising that the energy (20) for an annulus with uniform and continuous vorticity 2 is low er than (43) for pure irrotational ow. Indeed, a uid in solid-body rotation necessarily has a low energy in the rotating frame than other velocity distributions, which follows by minimizing the functional $E^{0}[v] = dV \frac{1}{2}v^{2}$ r vw ith respect to v(r).




FIG.4: Energy per particle vs. rotation rate , where our num erical results are presented as open circles (vortex-lattice state) and crosses (giant-vortex state). For comparison, the analytical results are plotted as a solid line (Thom as Ferm i vortex lattice with hole) and a dashed line (giant vortex). The inset shows the energies in a small region of the graph around = 5. The parameters used here are g = 1000 and = 0.5.

A good test of the analytical TF results is to compare the TF energy per particle to the values extracted directly from our numerical calculations, as is shown in Fig. 4 for g = 1000 and = 0.5. The open circles are the energies corresponding to the vortex-lattice states calculated numerically as shown in Fig. 2. These are compared to the analytical result from Eq. (20), which was derived assuming a Thomas-Ferm ipro le and uniform vorticity. We nd a small but signi cant discrepancy between them, where the analytical result is smaller by typically E 6. This is not surprising because (20) assumes solid-body rotation which provides a lower bound to the energy. In detail, we attribute this discrepancy to the energy associated with the vortex cores, which will give a correction to the analytical result due to the irrotational ow and density dip near to each vortex.




FIG. 5: Density proles of a rotating condensate at g = 1000 and = 0.5, showing the giant-vortex states corresponding to the angular velocities in Fig. 2: (a) = 2.0, (b) = 3.0, (c) = 3.5, (d) = 4.0, (e) = 4.5, (f) = 5.0. The scale of each gure is 6 6 in units of d_2 .

We also calculate the energy of the giant-vortex state by numerically solving Eq. (26) with = 0 and replacing V_{tr} with $V_{tr} + 2 = (2r^2)$, where is the quantum of circulation of the macroscopic ow. We calculate the energy E for each , which in the rotating frame becomes $E^0 = E$. The energy as a function of is then the minimum possible E^0 for that particular , which also xes the relevant . The density profess of the giant-vortex states corresponding to the same angular velocities as in Fig. 2 are plotted in Fig. 5, while the energies are plotted as the crosses in Fig. 4. Note that the energy of the vortex lattice is always lower than the corresponding giant vortex for the range of covered, which recon rms the conclusion from Fig. 2 that no transition occurs to the giant-vortex state that the giant vortex state can indeed become energetically favorable at high angular velocities (as seen in Fig. 1). We also compare our results to the analytical energy of the giant vortex Eq. (43) and nd quite good agreement for larger values of , with the analytical result being smaller by around E 2.

B. Transition to a giant vortex

The assumption of uniform vorticity is reasonable as long as the intervortex distance is much smaller than any of the dimensions of the annulus. It fails when the discrete character of the quantized vortex lines becomes signicant, in particular, when the width d of the annulus becomes comparable to the intervortex separation b 21=2=.

As background, it is instructive to review the analogous transition in rotating super uid ⁴He in an annulus. Here, the width d is xed by the geometry of the container, and vortices rst appear with increasing when b is of order d. To be more precise, the irrotational ow in an annulus has the characteristic feature that the velocity $v_{irr} = -r$ decreases with increasing r, whereas the preferred solid-body ow $v_{sb} = -r$ increases. For a xed gap width, this discrepancy grows as increases, and it eventually becomes favorable to insert a one-dimensional array of quantized

vortices at the midpoint of the annulus. On average, the circulating velocity around each core combines with the overall irrotational ow to min ic more closely v_{sb} , thus low ering the energy in the rotating frame. A detailed analysis of the free energy of the various relevant states [18] predicted that a one-dimensional vortex array appears with increasing at a (dimensional) critical angular velocity $_0 = (= d^2) \ln (d=)$, where d is the width of the annular gap and is the vortex core radius. The theory indicated that the vortices appear one by one in a very narrow interval of , rapidly building up a one-dimensional vortex array in the center of the gap. Experiments on super uid ⁴H e using second-sound attenuation veri ed this predicted critical angular velocity in considerable detail [22] (including the location at the midpoint of the gap).

In the present case of a rotating annular condensate, the width d decreases like 1 =, which is faster than the decrease of the intervortex spacing. Hence the transition here is expected to occur in the reverse order, with the irrotational giant vortex appearing for large . The relevant comparison state is a one-dimensional vortex array in addition to the irrotational ow, as seen in Fig.2(f). For a prelim inary estimate, it is convenient to study only the case of a single vortex located at the midpoint of the gap combined with m acroscopic circulation. The analysis is lengthy and will not be given here because the resulting critical angular velocity does not agree well with the numerical work. Thus it su ces merely to state that the transition from one vortex with irrotational ow to the pure irrotational ow is predicted to occur at a critical angular velocity

as the angular velocity increases.

Figure 3 also compares the critical angular velocity $_g$ for the transition from the vortex lattice to the giant-vortex state. First, we see that our analytical $_g$ is much larger than that of Ref. [15] (open circles). In addition, our numerical result (open triangle) is much larger than even our analytical prediction (in Fig. 3 we plot the low er bound on $_g$ in the case of g = 1000 since the numerical methods place constraints on using higher rotations, as discussed above). Note that we plot (44) only for large g, since logarithm is accuracy is expected to be poor for sm all g. Even for larger than $_g$, the low est energy solution of the GP equation does not correspond to a giant vortex, which suggests that for these values of the giant vortex is stable against the form ation of a single vortex, but is unstable against the form ation of an array of vortices (see Fig. 2).

VI. DISCUSSION

This work has considered a two-dimensional rapidly rotating Bose-E instein condensate in a radial trap with both quadratic and quartic con ning components, which allows the external rotation to exceed the harmonic trap frequency $!_2$. Both an analytical Thomas-Ferm i description and a full numerical study of the Gross-Pitaevskii equation show the formation of a central hole at essentially the same critical angular velocity _h (the analytical value apparently remains quite accurate even for small values of the coupling constant g = 4 N a=Z where the Thomas-Ferm i approximation is less valid). For larger angular velocities, the numerical work for g = 80 indicates a transition

to a pure irrotational state (a giant vortex), but our approxim at analytical model predicts too sm all a value for this transition.

Experimental work at the Ecole Normale Superieure, Paris [12, 13] created a quartic connement with a blue-detuned G aussian laser directed along the axial direction. For their trap, the nonrotating condensate was cigar shaped, and the strength of the quartic admixture was 10^3 . For dimensionless rotation speed 1, the condensate was nearly spherical, and it remained stable for 1:05. Near the upper limit, the condensate exhibited a denite local minimum in the central density, conming the general features of our TF analysis. Throughout the stable range of

, the measured shape of the condensate was t to the TF prediction, which served as a direct determ ination of . They also used surface wave spectroscopy [23, 24] to provide an independent measure of the angular velocity (even though the visible number of vortices appeared to be too small for 1).

These experiments are very puzzling when compared to the previous numerical studies [14, 20], to previous analytical studies [15] and to the present work. Why do the experiments fail to reach higher angular velocities, when the simulations readily reach the regime when the condensate becomes annular? One possible source of the discrepancy is that the experimental condensate is de nitely three-dimensional, whereas the simulations are two-dimensional (apart from [20]). It is notable that even the experimental papers [12, 13] suggest repeating the experiments with a condensate that is tightly conned in the z direction. In addition, the low temperature of the experiments eliminates most dissipative processes that can equilibrate the system. This feature may make it dicult for the condensate to acquire more angular momentum as increases. In contrast, the numerical simulations work in imaginary time for a given , which leads to a state that is at least a local minimum in the energy.

A nother di erent question concerns the transition to the giant vortex. O ur num erical sin ulations indicate that this transition occurs well beyond our analytical estim ate $_{\rm g}$ in Eq. (44). This estim ate is obtained by comparing the energy of the irrotational giant vortex with a sim ilar irrotational state containing one additional quantized vortex at the m idpoint of the annulus. Based on the num erical sim ulations [especially Fig. 2 (f)], it seems probable that adding m ore quantized vortices in a one-dimensional ring and/or allowing the radius of the ring to vary would lower the energy of this state relative to the irrotational state, because the speci c choice of one vortex at the m idpoint seems s som ewhat arbitrary for a dilute trapped condensate. For super uid ⁴He in a rotating annulus, the im age vortices raise the energy if a vortex approaches either wall, but such an e ect is absent in the present case. If so, such an improved analysis would increase the estim ated critical angular velocity for the transition to a giant vortex. It is also conceivable that the m ean radius of the one-dimensional vortex array simply shrinks inside the inner TF radius R₁. This latter situation would suggest a crossover instead of a sharp transition, because the actual condensate necessarily extends into the classically forbidden region. These questions rem ain for future investigation.
