Therm oelectricity of URu₂Si₂: giant Nemste ect in the hidden-order state

We present a study of Nemst and Seebeck coecients in the heavy-ferm ion compound $U R u_2 S i_2$, which hosts a phase transition of unsettled origin. A giant Nemst signal of unprecedented magnitude was found to emerge in the ordered state. Moreover, our analysis of the Seebeck and Hall data indicates that the ordering leads to a sudden increase in the entropy per itinerant electron and to a drastic decrease in the scattering rate.

Among heavy-ferm ion superconductors, URu2Si2 is distinguished by the presence of a mysterious electronic order below $T_0 = 17.5 \text{K} [1, 2, 3]$. A large amount of magnetic entropy (S_{mag} 0:2R ln2) is lost in this phase transition [1]. Nevertheless, the intensity of the emerging m agnetic Bragg peaks im ply an anti-ferrom agnetic order with a very weak magnetic moment (0.03 B/U)[4]. With the application of pressure, the them agnetic Bragg peaks intensify and a conventional AF ground state em eges [5, 6]. At am bient pressure, the small moment resolved cannot account by itself for the amount of entropy lost at the transition. However, ordering opens a sizeable gap in both spin and charge excitations. This unusual case of large m acroscopic anomalies leading to a tiny magnetic moment has nourished an extensive investigation during the last two decades. Many proposals[7, 8, 9, 10, 11, 12] regarding the nature of what is now commonly called the hidden order of UR u_2 Si₂ [13] have em erged. Som e of these invoked exotic order param eters such as three-spin-correlator[7], quadrupolar ordering of localized m om ents[8] or an unconventional spindensity-wave[11]. In some others, weak antiferrom agnetism is explained by considering the dual (i.e. localized and itinerant) character of the 5f electron in the context of a Ferm i surface with nesting [9, 10, 14].

Several recent experiments indicate that the hidden order and Large-Moment-Anti-ferrom agnetism (LMAF) are in competition [15, 16, 17]. A nomalies indicating a phase transition between two thermodynamically-distinct states have been reported in thermal expansion studies [16]. A coording to ²⁹SiNMR measurements [17], the hidden-order state is spatially inhomogeneous with coexisting LMAF and paramagnetic regions. The apparent weakness of anti-ferromagnetism would be a consequence of the tiny fraction of the volume occupied by the magnetically-ordered electrons at ambient pressure. This result provides a strong case for an electronic phase separation between the two order parameters [18].

In this paper, we report on the therm celectricity of URu_2Si_2 which provides new pieces to this puzzle. The hidden-order state was found to host a Nernst coe cient of an exceptionally large magnitude. This giant Nernst coe cient decreases smoothly with the application of a

magnetic eld and the extrapolation of data indicates that it would not survive the destruction of the hidden order at high magnetic elds[19]. On the other hand, the onset of the ordering is accompanied with an enhancement of the absolute value of the Seebeck coe cient. This is in sharp contrast with the concomitant decrease in the electronic specicheat[1,3,20]. We will argue that it can be understood by taking into account the change in the carrier density induced by the transition.

Single crystals of UR u_2 Si $_2$ were prepared in a three arc furnace under puri ed argon atmosphere and annealed under UHV for one week at 1050 C. Four longitudinal and two lateral contacts were m ade on each crystal. Nemst and Seebeck coe-cients were measured using a one-heater-two-therm om eters set-up which allowed us to measure therm aland electric conductivities as well as the Hall coe-cient of the sample in the same conditions. The results reported here were reproduced on two dierent samples.




FIG. 1: Tem perature dependence of the Nemst signal (upper panel) and coe cient (lower panel) for dierent magnetic elds in URu_2Si_2 . Upper inset shows the tem perature dependence of the transverse to longitudinal voltages produced by a longitudinal thermal gradient. Lower inset presents the eld dependence of the peak value of . The arrow presents the eld corresponding to the destruction of the hidden order[19].

Fig.1 presents the temperature dependence of the Nemst e ect for various magnetic elds in UR ySi2. The upper panel displays the ratio of the transverse electric eld to the longitudinal therm algradient (N = - $E_v=r_xT$), while the lower panel presents the Nemst coe cient(=N/B). As seen in the gure, below T_0 17.5K, the Nemst signal (which is negligibly small above this tem perature) begins to grow steadily and attains its maximum value at T 3K. This Nemst signal presents an sublinear eld-dependence as indicated by the induced decrease of seen in the lower panel of the qure. P lotting $_{\text{m ax}}$ as a function of magnetic $_{\text{m eld}}$, one can estim ate the eld scale associated with the destruction of the giant Nemst signal (see the lower in set of the gure). A simple linear extrapolation of $_{\text{m ax}}$ (B) to higher elds 32T. Since this is comparable to puts this eld at B the magnitude of the eld required to destroy the hidden order (35T), it is safe to assume that the giant Nemst signal is another property of the ordered state.

The magnitude of the Nernst coe cient is remarkably large. In the zero-eld limit, it attains $_{\rm max}$ 42 V/KT, and easily exceeds what is reported in any other metal[21] including NbSe₂ [22]($_{\rm max}$ -0.12 V/KT) or CeCoIn₅ [23]($_{\rm max}$ -0.95 V/KT). At B=12T, the sig-

nal is even larger than what is observed in the vortex state of any superconductor. In the zero-eld lim it, however, the N emst coe-cient in a cuprate superconductor, Ba $_2$ Sr $_1.5$ La $_0.5$ CuO $_6$ is reported to attain a comparable magnitude ($_{\rm max}$ 4.5 V/KT)[24].




FIG. 2: Temperature-dependence of the Seebeck coe cient divided by temperature as a function of temperature for different magnetic eld. The arrowspoint to the expected S=T given the electronic specic heat of URu2Siz for dierent carrier densities (see text). The inset shows the same data in a more traditional fashion.

The phase transition which leads to the emergence of a Nemst signal of such a magnitude a ects also the [longitudinal] them opower[25]. As seen in Fig 2, the Seebeck coe cient, S, presents a sharp anomaly at T_0 and becomes strongly eld dependent in the hidden order state. As seen in the inset of Fig 2, a new low temperature maximum in S(T) emerges in elds exceeding 6T. However, in order to resolve the magnitude of temperature-linear therm opower in the zero temperature limit, a plot of S=T as a function of temperature [26] is more instructive. As seen in the main panel of the gure, the application of a magnetic eld leads to a steady increase in the magnitude of S=T down to the lowest temperatures investigated. In many metals, the absolute value of a dimension less ratio, $q = \frac{s}{T} N_{Av}e$, linking the Seebeck coe cient to the elec-

 $tronic speci cheat (= C_{el}=T) is close to unity [26] in the$ T=0 lim it. [Here N $_{\mbox{\scriptsize A}\mbox{\tiny V}}$ is the A vogadro num ber and e is the elem entary charge.] This is not the case of URu2Si2. Taking the zero- eld values of S=T (-2.8 V/K²) and (60 m J/m olk 2) [20]) at the onset of superconductivity yields q = 4:5. The enhancem ent of the absolute value of S=T with the application of the magnetic eld (which leaves unchanged in this range [20]) leads to an even larger q at higher elds (q -14 at B = 12T). The low carrier density in URu2Si2 provides a natural explanation for this large magnitude of q. The conversion factor, $N_{Av}e$, between therm opower and speci c heat assumes that there is a single carrier per formula unit. Trivially, a proportionally larger q is expected when the density of carriers is lower than this. The case for a small carrier density in the hidden-order state of URu2Si2 is supported by several other experim ental observations. It can be directly deduced from the magnitude of the Hall coe cient in the zero-tem perature lim it which was found to be $R_H = 9.5 10^3$ cm 3 =C in agreement with previous studies[27, 28]. While at nite temperatures, the magnitude and the tem perature-dependence of the Hall coef-

cient of the Heavy-Ferm ion compounds depend largely on skew scattering [29], the extraordinary Halle ect vanishes in the zero-temperature limit. Assuming a one-band model, the magnitude of the Hallcoe cient yields a carrier density of 0.05 holes per Uranium atom, as previously reported [27, 28]. Such a low carrier density implies a Ferm i surface occupying a small portion of the Brillouin zone which is consistent with the results of band calculations based on the spin-polarized Dirac equation [30]. Direct evidence for small [and almost spherical] Ferm i sur-




FIG. 3: a) Tem perature-dependence of the Hall coe cient. b) Sam e for therm opower divided by tem perature. Note the concommitant jumps in the vicinity of T $_0$.

faces com es from de H aas-van A lphen and Shubnikov-de H aas m easurem ents [31, 32, 33]. In the m ost com plete set of these studies, K eller et al. [33] identi ed four di erent orbits with the largest occupying less than 5 percent of the B rillouin zone.

A nalysis of the behavior of them opower and Hall coe cient in the vicinity of To leads to a subtle reconsideration of what occurs to itinerant electrons at T_0 . As seen in Fig.3 which compares the anomalies in $R_{\,\mathrm{H}}$ and in S=T, the absolute value of both shows a step-like increase in a rather narrow temperature window (3K). The three-fold increase in the magnitude of S=T contrasts with the concomitant decrease of which passes from $180 \text{ m J/K}^2\text{m olabove T}_0$ to $60 \text{ m J/K}^2\text{m olbelow}$. Therefore, the transition leads to a reduction of the entropy per volum e yet an enhancem ent of the entropy associated to each carrier. This is con med by the sharp change in the Hallcoe cient at To. The ve-fold increase in R_H corresponds to an even larger drop in carrier density since a sizeable fraction of the Hall signal at this tem perature com es from skew scattering. Since the magnetic susceptibility is barely a ected by the transition [27, 28], the contribution of skew scattering to Halle ect between 20K and 15K remains unchanged. An analysis based on the Fert-Levy model[29] yields a carrier density of 0.4 holes per U above To and ten times less below [28]. The three-fold decrease in $\,$ at T $_{0}$ appears, therefore, to m ask two opposing tendencies: a ten-fold reduction in carrier density and a three-fold increase in entropy per carrier. In other words, while 90 percent of the carriers condense at the transition, those which survive carry a larger entropy.

Thus, instead of being a light-weight heavy ferm ion, URu_2Si_2 in the hidden-order state emerges from this analysis as a system with a very low density of carri-

ers but a fairly large am ount of entropy per carrier. A carrier density of 0.05 holes per fu. in plies q 20. For 60m J/m olK 2 , this yields an expected S=T = 12.5 V/K 2 . As seen in Fig.2, the low-tem perature m agnitude [of the absolute value] of S=T at zero-m agnetic eld is considerably lower than this. W ith the application of m agnetic eld, S=T is enhanced and approaches the expected m agnitude w ithout attaining it. Since R $_{\rm H}$ (and consequently the carrier density) shows little variation w ith m agnetic eld in this range, the strong change in S=T w ith m agnetic eld at nite tem perature seem s to re ect the eld dependence of the scattering time.

Let us now consider the emergence of a giant Nemst signal in such a context. For this, it is useful to focus on a very simple relationship which relates the Nemst coe cient to the Hallangle in the Boltzm ann picture and recently put forward by Oganesyan and Usshishkin [35]:

Since the Hallangle, $_{\rm H} = \frac{_{\rm xy}}{_{\rm xx}}$, is a convenient m easure of the scattering time, (namely, $_{\rm H}$ = ! $_{\rm c}$, where $!_{c}$ is the cyclotron frequency), then, Eq. 1 states that the Nemst signalm easures the energy-dependence of the scattering time at the Fermi energy. The latter quantity is small in common metals, leading to a negligible Nemst signal, a phenom enon also called Sondheim er cancellation [24]. The situation becomes more complicated in multi-band metals where the thermal gradient creates a counter ow of carriers with opposite signs creating a nite Nemst signal. Such an ambipolar Nemst e ect was observed in NbSe which happens to present a sign-changing Hall coe cient in its Charge Density Wave state [22]. The giant Nemst signal in URu2Si2, however, is more than one order of magnitude larger. Moreover, it em erges in presence of a large and non-vanishing Hall angle. In order to explore other possible sources of enhanced N ernst signal in a B oltzm ann picture, let us ${\tt m}$ ake a crude approximation and replace the energy derivative $\frac{\theta}{\theta}$ at the Ferm i level by $\frac{\theta}{\theta}$. In this case, Eq.1 yields:

A number of elementary insights are provided by this simple expression. First of all, compared to simple metals, the heavy-ferm ion compounds are expected to display an enhanced Nernst signal simply because of the small magnitude of their Fermi energy. Experimentally, this is the case: in the two heavy-fermion metals studied until now, Nernst coecient is found to be in the 0.2-5 V/KT range, several orders of magnitude larger than the isothermal Nernst coecient of gold (0.1 nV/KT)[36]. In the second place, the expression indicates that any increase in $_{\rm H}$ (or more fundamentally, in the quasi-particle lifetime) would also lead to an enhancement of the Nernst coecient. Interestingly,




FIG. 4: Nemst coe cient divided by tem perature and the Hall angle as a function of tem perature. The dashed vertical line marks the transition tem perature T $_0$.Inset: the temperature dependence of the ratio of the Nemst to Seebeck coe cients.

in both $\text{UR}\,u_2\,\text{Si}_2$ and $\text{CeC}\,\text{oIn}_5$, the giant Nemste ectem erges with a concomitant enhancement in the amplitude of $_{\text{H}}$.

This brings us to another remarkable feature of electronic transport in the hidden-order state of URu₂Si₂. Fig.4 displays the temperature dependence of the Hall angle in a logarithmic scale. As seen in the gure, the phase transition at T₀ leads to an almost thirty-fold increase in the Hall angle. At B=12T, the system is close to the !_c 1 limit[34]. Following the thread of Eq.1, it is instructive to compare this with the temperature dependence of N=T (T). As seen in Fig.4, both quantities

are considerably enhanced below T $_0$. However, their behavior is not identical. When the sample is cooled from 17K to 1.5K, Hincreases by a factor of 30 and saturates rapidly. On the other hand, N=T increases by a factor of 500 and continues to increase smoothly.

Therefore, a smallFerm iEnergy combined with a long scattering time provides a partial explanation for the magnitude of the Nemst coe cient in URu2Si2. Num er-20 V=K and $_{\rm H}$ ically, at B = 6T and T = 3K, Nand expression 2 implies F 17K. However, a reduced Ferm i energy would enhance the Nemst and Seebeck coe cients in exactly the same way. This is, however, not the case. As seen in the inset of gure, in the low - eld regime, upon cooling the ratio =S displays a diverging behavior in a manner analogous to the one observed in CeCoIn₅ [23]. In both cases, the large Nemst signal is accompanied with an [anomalously] small Seebeck signal. M oreover, as seen in Fig.4, N = T continues to increase at low temperature while H has already attained a constant value. These features are vet to be understood. These features point to a missing ingredient for understanding this enhanced Nemst signal which may be a generic feature of heavy ferm ions physics.

We note that a link between unconventional density wave order and Nemst signal has been recently proposed [37]. On the other hand, given the experimental evidence in favor of electronic phase separation in the hidden order state of UR $u_2 Si_2$ [17, 18], one is tempted to speculate in other directions. For example, magnetic droplets inside a paramagnetic uid may couple a magnetic ux line to an entropy reservoir in an manner similar to superconducting vortices.

In sum m ary, our results indicate that the ground state of UR u_2 Si $_2$ is one with a low density of itinerant electrons with large entropy and long lifetime. Most remarkably, we found that a Nemst signal of exceptionally large magnitude emerges in this context.
