# sd-type Exchange Interactions in N onhom ogeneous Ferrom agnets

#### Abstract

M otivated by a need to understand spin-m om entum transport in CPP (current perpendicular to the plane) structures, a quantum eld theoretical treatm ent of spin-spin interactions in ferro$m$ agnets is presented. The sd interaction of the conduction electrons and the $m$ agnetic $m$ edium is treated non-perturbatively from rst principles in real space. The localized $m$ agnetic $m$ om ents also interact with each other through a H eisenberg exchange potential. To take into account correlation e ects, a second quantized form ulation is used. The sem i-classical lim it is taken by using a coherent-state path-integral technique which also allow s us to go beyond a linear-response approach. W e derive a set of coupled equations of $m$ otion for the nonuniform m agnetization, the spin current and the two-point correlation functions of the $m$ agnetization. The rate of change of the $m$ agnetization is show $n$ to obey a generalized Landau- ifshitz equation that takes into account interaction w ith the conduction electrons. W ithin the relaxation tim e approxim ation it is show $n$ that the polarization of the conduction electrons obeys a di usion equation. The di usion tensor, which has o -diagonal term s due to the sd exchange interaction, is now explicitly dependent on the $m$ agnetization of the $m$ edium . We also show that the $m$ agnetization uctuations satisfy a di usion-type equation. The derived equations are used in two illustrative exam ples.

## I. INTRODUCTION

Spin-spin interactions in ferrom agnetic $m$ etals are of param ount im portance in today's GMR recording heads. There is also currently great interest in the $m$ agnetic recording industry in using spin currents, instead ofm agnetic elds, to sw itch the m agnetization in a w riter devige. In this case a polarized electronic current is needed, such that the net spin of the polarization becom es e ectively another magnetic source which induces an interaction $w$ ith the $m$ agnetic $m$ om ents of the $m$ edium. O ne $w$ idely used approxim ation is to separate the degrees of freedom of the current from those of the localm agnetic $m$ om ent. This latter separation is not justi ed in conducting metals but it nevertheless produced good results in som e cases ${ }^{[1]}$ This paper explores in detail the consequences for the spin accum ulation problem in ferrom agnets of assum ing that the interaction betw een the conduction electrons and the localm om ents is of the sd exchange type. This interaction can give rise to what is now known as spin m om entum transfer ( SM T ) in magnetic multilayers. This latter m echanism has.been predicted by B ergerín and Slonczew sk ${ }^{n} \underline{n}^{\prime}$ and laterveri ed experim entally by various groupsing the $m$ agnetization vector have been proposed since the B erger-Slonczew ski w ork previous work, the interaction of the polarized current with the $m$ agnetization has not been treated self-consistently. In fact the equations of $m$ otion were based on those of a sim ilar system, that of a current interacting $w$ ith $m$ agnetic im purities ${ }^{\circ} \mathrm{F}$ e believe that this approach is not suitable for transition $m$ etals.

In this work, we start from a microscopic description of the conduction electrons and the ferrom agnetic $m$ edium and then take the sem i-classical lim it to derive equations for $m$ acroscopic quantities of physical signi cance to experim ent and other phenom enological approaches. A though the derivations are som ew hat com plex, one can go to them ain results (e.g., Eqs. ' $\overline{6} \overline{6} \overline{6}$ and ${ }^{18} \overline{4} \bar{\prime}$ which are generalized B oltzm ann-type equations) and see that the correct physics is contained in them.

O ur results include those of reference ${ }_{1}{ }_{2}^{\prime-1}$ and in fact our treatm ent should provide a basis for the $m$ ore phenom enological work. W e do not assum $e$ that the $m$ agnetization is uniform as in previous work and wew ill focusm ainly on the di usive regim e. W e use m anybody eld theoreticalm ethods to describe the system ofm agnetic $m$ om ents plus conduction electrons. Even though only a single particle picture is needed, the $m$ ethods we use perm it
us to treat them agnetic part of the problem and the conduction electrons on the sam eform al level. This allow s us to derive transport equations for the conduction electrons and the local $m$ agnetic $m$ om ents and inchude relaxation e ects $w$ thout recourse to $m$ ore phenom enological modeling. Exchange e ects, which are im portant in transition $m$ etals, are also inchuded self-consistently. Finite-tem perature properties are naturally included through the use of a path-integral form ulation of the problem "̄ad Including spin-dependent interactions in a transport problem $m$ eans that we have to deal $w$ th $m$ any indexes. Path-integrals are helpfiul w th book-keeping and hence sim plify the discussion considerably as com pared to Ref. ${ }_{1} 9.1$. F inally a path-integral representation helps in $m$ aking consistent approxim ations to the derived transport equations.

The paper is organized as follow s . In Sec. II, we introduce the H am iltonian of the interacting electron-m agnetization system in second quantized form. In Sec. III, a functionalz, which we call the universal generating functional, is de ned in term sof the density $m$ atrix of the system and extemal sources. This functional has a path-integral representation and w ill generate all possible correlation functions. For the localm agnetic $m$ om ents we adopt a coherent state representation which is most suitable for a sem i-classical treatm ent of the $m$ edium such as presented here. In Sec. IV, we derive equations of $m$ otion for the $m$ agnetization (a modi ed Landau-Łifshitz equation) and the spin accum ulation. These latter equations are then used to derive equations for the correlation functions of the $m$ agnetization. W e also show that non-uniform $m$ agnetization of the $m$ edium gives rise to a spin accum ulation e ect sim ilar to that due to interfacesi' $T$ his is one of the $m$ ain results of this work. In Sec. $V$, we show how to solve these equations perturbatively and derive the term $s$ that give rise to the spin $m$ om entum transfer e ect for a system $w$ ith non-uniform $m$ agnetization. Finally, we derive a di usion-type equation for the magnetization uctuations where the di usion coe cient is dependent on the exchange integral. In section VI, we show som e applications of the derived spin accum ulation equations in sim ple cases where the $m$ agnetization is nonuniform in the direction of ow of the current. In the last section, we sum $m$ arize our results.

## II. THE M ODEL

W e start from a quantum eld picture of the electronic current and them agneticm om ents of the localized electrons in a thin slab of thidkness com parable to the $m$ ean free path, $F$ ig. '11. In the follow ing we do not include explicitly an electric eld, but we assum e that it is part of the spin-independent part of the H am iltonian. Its inclusion has been done in R ef. ,ī1. For the $m$ agnetic $m$ edium, a $H$ eisenberg $H$ am iltonian is assum ed. $W$ e explicitly take into account only exchange e ects am ong the $H$ eisenberg spins. O ther im portant e ects such as the dem agnetization eld term can be added phenom enologically. T he conduction electrons w ill be assum ed to be in equilibrium w ith the $m$ agnetic $m$ edium since they relax $m$ uch faster than the $m$ agnetic $m$ om ents. This is the case in assisted spin-m om entum transfer sw itching. In fact the $m$ agnetic $m$ om ents can be regarded as in contact with a Ferm ibath w ith spin degrees of freedom. In this case sw itching $m$ ay be regarded as a dissipative e ect accom panied by a shift in the magnon energiesti O ur work is a natural generalization of the $m$ odelused by Langreth and $W$ ilkinid to study spin resonance in ditute $m$ agnetic alloys. The conduction electron eld s satis es the usual anti-com mutation relations,

In this system, the electrons are treated as non-interacting, i.e. no C oulomb interaction, and hence the electron eld can be expanded in term $s$ of single particle wave-functions:

$w h e r e a_{s}\left(a_{s}^{Y}\right)$ is the annihilation (creation) operator for a particle of spin $s$. The total H am iltonian of the system is com posed of a conduction electron part, $\mathrm{H}_{\mathrm{s}}$, a m agnetic part, $H_{d}$ and an interaction part, $H_{s d}$,

The conduction electron part in a ferrom agnet, such as Fe , is due to 4 s-type electrons. The $m$ agnetic part is how ever due to 3d-type electrons. For the free conduction electrons we have

Them agnetic $m$ edium is $m$ icroscopically a lattice $w$ ith a spin vector $S_{i}$ at each lattice point i. Since we are interested in the continuum lim it ofthism odel, we can de ne a m acroscopic spin vector for the $m$ edium

W e em ploy units such that $g_{\mathrm{B}}=\sim=1$. H ence the $m$ agnetization w ill have opposite sign to that usually de ned in the literature. The H am iltonian of the spins is taken to be of the H eisenberg type,

W e take account of exchange only and assum e the spins to be in an extemal eld B. In the continuum lim it, we can write the exchange term in an integral form,

Contributions from the magnetostatic eld can also be included. For the typical thin structures we are interested in, the $m$ agnetization of the $m$ edium is usually held in-plane by the $m$ agnetostatic eld. The energy term associated $w$ ith this eld is usually non-local but for a thin $\quad \mathrm{m}$ it can be well approxim ated by a local term proportional to the norm al com ponent of the $m$ agnetization,

w here n is a nom al unit vector to the surface and K is a constant depending on the shape of the slab. This latter term will lower the sym $m$ etry of the problem even further. For sim plicity in the follow ing we leave out this term and discuss it elsew here ${ }^{12}=1$

The interaction between the electrons and the localized spins is taken to be of the $s-d$ type, of the form

where we have inchuded a spin-independent extemalpotentialu (r) for the conduction electrons. The extemalm agnetic eld B can be taken to be tim e-dependent and/or spatially dependent in the follow ing treatm ent.

## III. THE UNIVERSAL GENERATING FUNCTIONAL

In this section, we introduce what we call a universal generating functional from which we derive equations of $m$ otion for the $m$ agnetization and the spin current. This functional is de ned in term s of the density $m$ atrix of the current-m edium system and can be used to study equilibrium as well as non-equilibrium properties ${ }^{〔}$ ?3 W e are at present interested only in the near-equilibrium case. A general overview of the m ethod appeared in Ref. in Application of this $m$ ethod to spin system $s$ is how ever alm ost absent. A sfar as we know, Refs. ' ${ }_{-1}^{-1}$ and ${ }_{1}^{1} \overline{1} \overline{-}$, are the only work that apply non-equilibrium m ethods to spin system $s$. O ne of the other advantages of this $m$ ethod is that it allow s equal treatm ent of therm ale ects and non-therm ale ects. The extension beyond a linear-response approach is also easily achieved, at least form ally. This becom es essential when we are interested in questions that involve sw itching of the $m$ agnetization '114 W ew ill give a general outline of the $m$ ethod as we apply it to the particular $s$-d exchange system since the steps used in the derivation of the equations ofm otion are hard to nd in one place. The im portance of these $m$ ethods, which are hardly used in $m$ agnetism, is potentially very great.

To m otivate the structure of the functional we are about to introduce, we recall the structure of the density $m$ atrix elem ents. In quantum $m$ echanics, we usually use the energy $m$ ethod to solve a problem. H ow ever, in transport problem $s$, tim e-dependent $m$ ethods are essential. Hence the evolution of the density $m$ atrix com es into play. O ne of the ways to calculate density $m$ atrix elem ents is through a path-integral representation $1 / 17 \mathrm{l}$ ( W e have recently used such a form alism to treat the problem of uctuations and dissipation

The propagators $G^{(+)}$and $G^{()}$are then written in term sofpath-integrals. This is equivalent to using the Schröedinger equation to solve for the evolution of the density $m$ atrix. In a transport problem, we instead introduce a functional of the density $m$ atrix. This functional is then $m$ ade to depend on new virtual sources $1,1,2,2, J_{1}$ and $J_{2}$. These sources are coupled to the conduction electrons' eld and the $m$ agnetic $m$ om ents of the $m$ edium which $w$ ill enable us to generate all kinds of correlation functions and their tim e-evolution. The functional is then given in term s of a trace form ula,

where $T$ is the tim e-ordering operator. It orders operators $w$ ith the earliest tim e argum ent to the right. $\mathrm{T}^{1}$ is the inverse of T . The extemal sources 1 and 2 are two-com ponent classical (i.e. G rassm ann) sources where $1\left({ }_{2}\right)$ and $1\left({ }_{2}\right)$ are treated as independent. The operators are all wrilten in the $H$ eisenberg representation. The need for both tim eordering operators is clearly seen through the Feynm an-Vemon In uence form alism, Eq. (픔). The coe cients of the expansion of the functional $Z$ in term $s$ of its argum ents give all possible correlation functions of the system. A few of the lowest order correlations are stated below. They can be easily veri ed by di erentiating the functionalZ with respect to the virtual souroes. For exam ple, to get the expectation values of the conduction electrons' eld, we di erentiate Z w ith respect to $1_{1}$ or 2 ,

The H ibert space for the conduction electrons and the localm agnetic $m$ om ents of the $m$ edium is the product of the corresponding H ibert spaces,

The m agnetic m om ent states w ill be represented in term s of spin-coherent states (SC S) ${ }^{2}=1$ (and references therein). Since the operators are initially taken to be in the $H$ eisenberg picture, then in the presence of the additional extemal sources, 1 , 2 , and $J$, the states are no longer tim e independent. N ow we write the functional form ula in term s of a path-integral. Since we are not interested in the transient behavior of the interaction betw een the current and the $m$ agnetic $m$ om ents, we assum $e$ that the extemal electric eld was tumed on a long tim e ago and we willeventually set $\ddagger=1$. Reference i' $12 \overline{-1}$ treats the case where $t_{0}$ is kept nite in a nite size thin $m$. M oreover, we assum e that the density $m$ atrix is separable in itially, ie.,

The action A is given as the di erence of two actions; one due to the elds propagating forw ard in tim e and the other due to elds propagating backw ard in tim e,

B oth term son the right are obtained in the usualw ay. The electron contribution is standard. The $m$ agnetic $m$ om ent contribution can be obtained in the same way, but it involves a geom etrical part com ing from the SU (2) sym m etry. Hence the forward part of the action is given by

It is im portant to observe that thise ect is present even in the absence of a current as is the case for the spin accum ulation e ects due to interfaces put forw ard by Berger.' In fact param agnetic-ferrom agnetic interfaces are naturally included in our treatm ent since we are dealing w ith nonhom ogeneous m agnetization. A $n$ interface sim ply corresponds to an abrupt change of the $m$ agnetization from $a$ non-zero value to a zero value. These particulare ects will be treated below .

' $1(\overline{1} \overline{1})$ is due to a gradient $w$ ith respect to $X_{j}$. R ather, the p -com ponent of $\mathrm{M}_{\mathrm{c}}$ is rotated into the k th direction by the e ective eld H, while transport takes place in the direction of the gradient. The di usion tensor, Eq. ${ }^{\prime}(\overline{7} \overline{2})$, has striking sim ilarities to the di usion tensor of charged species in a plasm aisal If we restrict ourselves to the case where the locale ective eld is constant and along the $z$ axis only, then the transvense di usion coe cients are sim ilar to those found by H instil: and K aplanlin using very di erent $m$ ethods from the one presented here. Their work showed that in the direction perpendicular to the e ective eld, di usion of polarization of the electron gas is much slower than along the eld. The o -diagonal term $s$ have their origin in the strong exchange interaction am ong the conduction electronsw hich can not be treated perturbatively for a transition $m$ etal. In a m agnetic $m$ etal such as $N i$, the $o$ diagonal term s can be two orders ofm agnitude larger than the diagonal ones. $1-1$
V. SPIN-MOMENTUM TRANSFER:A SELF-CONSISTENT TREATMENT

To solve the above equations of $m$ otion, we retain a subset of the term $s$ arising in the full spin propagator. This approxim ation is essentially sim ilar to the random phase approxim ation in the calculation of the ground state energy of an interacting electron gas'. The zero order propagator is taken to be that of the electrons in the extemal B - eld and the localized spins interacting through the exchange interaction in the presence of the $B$
eld. Since the $m$ agnetic $m$ om ents constitute a $m$ any-body problem, a full solution is not possible in general. H ence an explicit solution to the problem requires rst a calculation of the badkground $m$ agnetization. The $m$ agnetization satis es a generalized Landau-Lifshitz equation which follow s from Eq. ( $\left.\overline{5} \overline{5},{ }_{1}\right)$. First we observe that w hen the extemal sources are
tumed o , we have

The last term gives rise to dissipation and a contribution to the precession for $m$ agnetic multilayerst" A swe w ill see below, this term becom es $J$-dependent in the non-uniform case. This latter equation, Eq. (긍) , is the equivalent of the Landau-Lifshitz equation (LL) for the $m$ agnetization in the presence of a current. This form is still valid even in the presence of an electric eld. The solution ofe q. ' Fig. ${ }_{-}^{4}-\mathrm{F}$. irst, we de ne the propagator of a non-interacting electron in an extemalm agnetic eld B and zero electric eld,
and expand G in powers of using Eq. ( $\left.{ }^{(5)} \overline{\bar{\sigma}}\right)$. K eeping only term sup to order ${ }^{2}$, we have

This is a m atrix equation and hence integrations over tim e, space and spin degrees of freedom are im plicit in the above notation. Recently $M$ ills calculated the dam ping contribution to
order of the system in this case. This follows from the fact that the spin propagator of the conduction electrons in a ferrom agnet is not $O$ (3)-invariant, to rst order in and higher since it depends explicitly on M .

Equation $\left(\underline{5}_{-1} \overline{7}_{1}\right)$ gives the dependence of correlations on the exchange interaction and on the $s-d$ interaction betw een the current and the $m$ edium. O ur assum ption is that exchange interactions are much stronger than the spin-spin interaction. H ence to lowest order, we neglect the latter in the equation for the uctuations. To understand the m eaning of such an equation, we study the case w ith strong exchange interactions, i.e., we take the average $m$ agnetization to be a constant and assum e the extemalB eld to be sm all. In this case Eq. ( $\left.5 \overline{-1} \bar{n}_{1}\right)$ becom es

N ow if we average over the variable $z$, we get an equation that gives the tim e variation of the uctuations of the magnetization around M. These uctuations will in tum cause uctuations in the current through the last term in Eq. ( $\left.\overline{\text { Bl }} \overline{1}_{1}\right)$. N ext we show how this latter equation gives rise to a B oltzm ann-type equation for the $m$ agnetization uctuations $M$ il. First we expand $M \quad k(x ; z)$ around the position $y$,

These integrals converge since the exchange coupling is short ranged. T he rst m om ent vanishes since we are assum ing isotropic exchange coupling. H ence treatm ent of the coupling of the conduction electrons to the am bient $m$ agnetization at low tem peratures or tem peratures close to $T_{c} m$ ust inchude Eq. ( $(\bar{\delta} \overline{4})$ to account for the uctuations of the magnetization.

## VI. APPLICATION S

In this section, wem ainly show how this form alism can be applied to $m$ ultilayers. In $R$ ef. 'iñ ī, we showed how our results extend those of Zhang, Levy and Ferti' by taking into account the indirect exchange e ect of the $m$ agnetization on the conduction electrons. This is an im portant e ect in transition $m$ etals and can not be treated by a Bom approxim ation. In the follow ing we study two types of structures w ith nonhom ogeneous m agnetization. F irst we exam ine CPP -type structures w th very thin param agnetic spacers and no interfacial scattering. Second we consider structures which are topologically equivalent to a torus. These exam ples clearly ilhustrate the origin of spin accum ulation to be directly related to inhom ogeneities in the $m$ agnetization. It is also obvious from these exam ples that dom ain walls are another physical exam ple where the results presented here can be applied. The interface will not be represented by a step function in the exam ples below and will instead take the shape shown in Fig. 'is which plots the mean eld a $(x)$ due to the $m$ agnetization.

For a localm agnetization which is a function only of distance $x$ in the direction of the current, $M=M \quad(x) z$, the spin accum ulation obeys the sm pli ed equations

These equationsw illbe solved fordi erent con gurations ofthem agnetization M.Weadopt the follow ing param eters for our calculations: The spin di usion length $\xi_{\mathrm{dl}}=\mathrm{P} \overline{\mathrm{D}} \mathrm{sf}=$ $100 \mathrm{~nm}, \mathrm{D}=10^{3} \mathrm{~m}^{2}=\mathrm{sec}, \mathrm{D}_{\mathrm{yx}}=100 \mathrm{D}_{\mathrm{xx}}$, and $=0: 1 \mathrm{eV}$. It should be noted that in these equations, the torque term has the opposite sign to that which appears in e.g., Zhang et alli'l since we have taken the electron charge to be positive in our de nitions of the magnetic m om ents.
$F$ irst we consider a con guration with in-plane $m$ agnetization. The $m$ agnetization is assum ed to vary w ith position along the direction of the current. T he spacer has practically zero thickness, which is a reasonable approxim ation for m ost GMR devices. Fig. . a (x) for a typical interface. We do not explicitly inchude a non-m agnetic spacer but we set the $m$ agnetization to zero at the center. At the ends it is parallel to the local $z$-axis, the local direction of the equilibrium $m$ agnetization. The transverse com ponents of the spin accum ulation are set to zero at the outer ends. The respective $z$-axes $m$ ake a nonzero angle in order for the spin accum ulation to be non-zero. First we dem onstrate the e ect of inhom ogeneities on the spin accum ulation; we keep the relative angle between the $m$ agnetizations the sam e but we vary the size of the 'dom ain wall', the transition region of the localm ean eld. It is seen from Fig ${ }_{2}^{-\bar{\phi}}$ and $F$ ig ${ }_{2}^{\prime} \overline{7}$ that the larger the inhom ogeneities the larger is the spin accum ulation. This e ect is independent of the relative orientations and was not predicted before. Therefore spin accum ulation can be enhanced by having a layer $w$ ith constant direction $m$ agnetization but with spatial inhom ogeneities. Such a structure can be achieved by e.g. having a tem perature gradient across the slab or controlled doping that changes the $m$ agnetic saturation along the direction of the current. Figures '
show the variation of the $z$-com ponent of the spin accum ulation $w$ ith respect to the relative angle of the $m$ agnetizations and size of the sam ple. Figures'ī10 and 1 y com ponents for the sm aller sam ple. H ere, the spin accum ulation is largest for the case where the two m agnetizations are orthogonal to each other and the size of the sample is sm allest. In all these results, the equilibrium spin accum ulation is norm alized to -1 on the left hand side and nom alized to +1 on the right hand side. The com ponents of the spin accum ulation are taken w ith respect to a global fram $e$, that of the layer on the left.

A s our second exam ple, we choose a Ying' structure. This can be part of a long solenoid w ith a square cross section. Hence we now solve our equations w ith periodic boundary conditions. In each side of the square cross section, the pro le of the $m$ agnetization $w$ ithin a period is show in 9 . 12 . The relative angle of the $m$ agnetization between neighboring sides is 90 degrees. W e study the spin accum ulation as a function of the size of the sides.
 equilibrium spin accum ulation is taken to be norm alized to one. The solutions show the expected behavior. The spin accum ulation tries to reach its equilibrium value near the $m$ iddle of each side. The spin accum ulation is largest when the length of each side is sm allest, as expected. This geom etry shows how spin accum ulation can be transported over large distances and also $m$ odulated by controlling the size of the cross section, sim ilar to what happens in a regular transfom er except here we are working with spin charge.

V II. CONCLUSION

W e have introduced a m any-body form alism based on path-integral techniques capable of handling a system of both localmagnetic $m$ om ents and conduction electrons in a selfconsistent $m$ anner. Transport properties can be obtained through the calculation of the two-point functions of the current and the $m$ agnetization respectively. O ne of the im portant outcom es of this treatm ent is that we were able to derive a set of new equations that are needed when the $m$ agnetization of the $m$ edium is no longer hom ogeneous. First we showed that the polarization of the current is no longer hom ogeneous and satis es a generalized di usion equation where the di usion tensor is dependent on the direction of the $m$ agnetization. W e have hence show $n$ that exchange e ects are im portant in a ferrom agnet and need to be taken into account properly. The uctuations of the $m$ agnetization were
also shown to obey a di usion-type equation whid depends on the direction of the local $m$ agnetization. This latter equation is in addition to recovering a Boltzm ann equation for the current which follow s from Eq. ( $\overline{6} \overline{2} \mathbf{2})$ ) and a Landau-Lifshitz equation for the average of the m agnetization, Eq. ( $\overline{\text { IT}} \mathbf{- 1})$. W e have also show $n$ how the non-uniform magnetization a ects both the conduction electrons and the spin -m om entum transfer term. W e gave a sim ple physical picture for ourm ain results. We nally showed how our results can be applied in various con gurations. O ur results show that spin accum ulation can be enhanced by inhom ogeneities at the interface.

In this work we focused on spin accumulation and we did not deal with its e ect on the dynam ics of the localm agnetization. We showed how to recover the Landau-屯ifshitz equation but we discussed the e ect of the collisions on the classical m agnetization only in qualiative term s . The use of the relaxation tim e approxim ation is another shortcom ing of this work. Its im provem ent will com plicate the treatm ent further. W e believe these issues should be addressed in the future.
