M agnetic F luctuations in the M etallic State of N $a_{0.7}$ C oO $_2$ R evealed by 23 N a N M R

Nuclear-m agnetic-resonance (NMR) studies were performed in N $_{\rm 0.7}$ C oO $_{\rm 2}$ to investigate its magnetic properties from the microscopic point of view . N $_{\rm 0.7}$ C oO $_{\rm 2}$ is a starting compound of the recently discovered superconductor N $_{\rm 0.35}$ C oO $_{\rm 2}$ $1\,3\text{H}_{\rm 2}\text{O}$, in which Co atoms form a triangular structure. Although 23 N a-NMR results show no magnetic anomaly down to 1.5 K, K night shift (23 K) and 23 (1=T1T) of 23 N a continue to increase, suggestive of the vicinity of the magnetic phase. From the relation between 23 K and 23 (1=T1T), it is shown that ferrom agnetic uctuations are dominant below 100 K. In addition to the ferrom agnetic correlations, antiferrom agnetic uctuations are also developed in a low temperature region below 4 K . Magnetic uctuations suggested by our experiment are discussed.

KEYW ORDS: superconductivity, hydrous sodium cobalt oxide, NQR, spin uctuations

Since the superconductivity in NaxCoO2 yHO (x 0.35, y 1.3) with the transition temperature T_c was discovered by Takada et al, understanding of magnetic properties in the CoO2 plane is one of the most im portant topics in strongly correlated electron system s. This is because the magnetic properties in the plane m ight be related to the mechanism of the unconventional superconductivity in the compound. In addition, the Co atoms form a triangular lattice in the plane, which is anticipated to possess the geom etrical frustrations. Novel types of magnetic transitions and ground states are expected due to a suppression of a long-range magnetic ordering by the geom etrical frustrations associated with the triangular structure. In particular, only a few compounds have been known to date which possess a metallic property down to the lowest temperature with the geom etrical frustrations, e.g. $(Y Sc)M n_2^{2}$ and LiV $_2O_4$. The Na_xCoO₂ (0:5 < x < 0:78) compound is considered to be one of the promising metallic compounds with the geom etrical frustrations at low temperature.4)

In this paper, we report the magnetic properties in Na $_{0.7}$ CoO $_2$ revealed by our 23 Na-NMR experiments. Powder samples of Na $_{0.7}$ CoO $_2$ were prepared from Na $_2$ CO $_3$ (99.9%) and Co $_3$ O $_4$ (99.9%) by solid-state reaction. Its quality was checked by X-ray powder diraction. The Na content, which is very sensitive to physical properties, is estimated to be 0.702 by the inductive-coupled plasma atomic emission spectroscopy (ICP-AES) method. Using this well-characterized powder sample, 23 Na-and 59 Co-NMR measurements were performed.




Fig. 1. Tem perature dependence of bulk susceptibility of $\,$ in 10 kO e.The inset shows a plot of the inverse of - $_0$ against T.The param eters tted by (T) $_0$ = N $_A$ P $_e^2$ = (T +) are shown in the inset D eviation from the CW behavior is seen below 25 K .

The main panel of Figure 1 shows temperature dependence of magnetic susceptibility in 10 kOe. increases with decreasing temperature, following the Curie-Weiss (CW) behavior. The inset of Fig. 1 shows the inverse magnetic susceptibility ($_{0}$) 1 as a function of

tem perature. Fairly good CW type behavior is observed above 50 K. Fitting param eters by the CW form ula are shown in the inset. These values are in good agreement with previous reports. Find As pointed out by G avilano et al., the size of the elective moment can be accounted for by the mixed-valence con gurations that Co^{4+} (S = 1/2) and Co^{3+} (S = 0) are the ratio of 0.38:0.62. This ratio is not so inconsistent with the mixed-valence state suggested from the Na content (Co^{4+} Co^{3+} = 0.3:0.7).




Fig. 2. Temperature dependence of resistivity in polycrystalline sample below 300 K measured in zero eld. The insets of (a) and (b) show the T dependence of below 10 K, and T^2 plot in various elds, respectively.

Figure 2 shows the tem perature dependence of resistivity measured by the polycrystalline N $a_{0.7}$ C oO $_2$. A bove 220 K, shows a hysterisis behavior, which suggests a rst order transition. Quite recently, neutron powder direction measurements revealed that structual transition ascribed to N a rearrangement occurs in N a_x C oO $_2$

0.7.7) The anomaly in above T_s due to this crystal anomaly. The resistivity shows metallic behavior below 200 K, especially, is proportional to T below 8 K as shown in the inset (a) of Fig. 2. It seems that the application of a magnetic eld leads to a gradual recovery of a T² behavior as shown in the inset (b) of Fig. 2. These resistivity results rem ind us of the non-Ferm i-liquid behavior seen in the heavy-ferm ion system .8) Resistivity measurement using a high-quality single crystal is, however, needed for the fully identi cation of the intrinsic behavior of . We point out that the m ixed-valence state suggested by is inconsistent with this m etallic behavior because the resistivity would show the insulating behavior in such the ionic mixed-valence state. In order to investigate magnetic properties in the low-tem perature m etallic state, we perform ed NMR m easurements on the same polycrystalline sample in which and were measured.

NMR spectra were measured at a xed frequency of 21.1 MHz using the random by oriented powdered sample. Figure 3 shows ⁵⁹Co- and ²³Na-NMR spectra, in which the spin-echo intensity was recorded during sweeping m agnetic $\,$ eld. First, we measured the $^{59}{\rm C}\,{\rm o} ext{-NM}\,{\rm R}\,$ quantities since its signal is so strong as to be observed even at room temperature. The $^{59}\mathrm{Co}\ \mathrm{K}\ \mathrm{night}\ \mathrm{shiff}\ ^{59}\mathrm{K}$ was measured at the sharp peak (H $_{\rm res}$ 20.6 kO e in Fig. 3) in the 59 Co-NMR spectrum. The 59 Co-Knight shift shows a weak temperature dependence up to 50 K and is nearly constant above 50 K. The temperature dependence of 59 K is not scaled at all with . It seems that NMR quantities obtained from the sharp peak in the Co-NMR spectrum is not directly a ected by the Co-3d electrons, thus we perform ed N a NMR m easurem ents in-




Fig. 3. Na and CoNMR spectra in Na $_{0.7}$ CoO $_2$ obtained at 21.1 MHz and at 10 K.TheNMR spectrum obtained at = 50 sec (bottom) and 200 sec (upper) are shown, where is a time intervalbetween two pulses for the NMR spin-echom easurement. The inset shows the central peak of Na spectrum corresponding to 1=2 \$ 1=2 transition measured in various temperatures.

stead. The $^{59}\mathrm{C}\,\text{o-NM}\,\mathrm{R}\,$ results will be sum marized in a separated paper.

A lthough the ²³Na-and ⁵⁹Co-NMR signals are overlapped as seen in Fig. 3 when we recorded the spin-echo signal at = 50 sec, the Co NMR spectrum becomes undetectably small and we can observe only Na spectrum when is 200 sec as shown in the upper gure of Fig. 3. Here is the time interval between two pulses by m eans of spin-echo m ethod. This is because the nuclear spin-spin relaxation time (T2) of the Co site is so short that NMR spin-echo intensity I is negligibly small at = 200 sec since I () decreases following exp (2 = T). We adopt = 200 sec for the Na-NMR measurement to avoid the e ect from the Co-NMR signal. The NaNMR spectrum with = 200 sec consists of an intense peak arising from 1=2\$ 1=2 transition, two small satellite peaks arising from 1=2 \$ 3=2 transitions and broad background signal over a few kOe. From the split of the two satellite peaks, the electric eld gradient (EFG) frequency was estimated to be 1.71 MHz. This value is in good agreem ent with the EFG frequency at \Na1" site reported by Mukham edshin et al. 10) where the \Na1" site is the (0,0,1/4) site which is vertically aligned to two Co atoms. When we compare this Na-NMR spectrum to a typical powder-pattern NMR spectrum, we notice that the peak of the central transition in our spectrum is much more intense than that expected from the satellite peaks. $^{11)}$ It is considered that the N a signal from other site overlaps in the central-transition peak. A ccording to the paper, 10) a Na-NMR signal from \Na2" site at (2/3,1/3,1/4), which is the center of Co triangle in the neighboring CoO2 planes, are identied using




Fig. 4. T dependence of Knight shift of 23 N a 23 K derived from the central NMR spectrum shown in the inset of Fig. 3. The inset shows the plot of the 23 K against with temperature as an implicit parameter.

an aligned powder sample under strong magnetic eld. It was revealed that the central peak of the Na2-NMR spectrum is very close to that of the Na1-NMR spectrum. Therefore, it is considered that the central peaks of the Na1 and Na2-NMR spectra are overlapped in our random ly oriented powder sample. The inset in Fig. 3 shows the overlapped central peak at various temperatures. Appreciable splitting of the Na1- and Na2-peaks was not observed in the measured temperature range. This is consistent with the previous experimental results that temperature dependence of 23K at Na1 and Na2 sites are the same, since the central peaks of the Na1and Na2-NMR spectra shift in the same way. Therefore the Knight shift estimated from the overlapped central peak in our powder sample is regarded as an isotropic component of the averaged Knight shift of the Nal and Na2 sites.

Figure 4 shows the temperature dependence of the 23 K. The 23 Na-Knight shift increases continuously with decreasing temperature, and the temperature dependence is quite similar to that of . The inset of Fig. 4 shows the plot of the 23 K as a function of . As seen in the gure, a good relation holds between two quantities in the temperature range between 3 and 200 K. The deviation above 200 K is due to the structural anomaly seen in . The good linear relation between 23 K and in plies that the microscopic susceptibility at the Na sites are governed by the bulk susceptibility originating from the Co-3d electrons. It is noteworthy that the uptum of

below 20K is not due to some impurity phase, but an intrinsic behavior. From the linear relation between $^{23}\rm K$ and between 3 and 200 K, the hyper ne coupling constant and the intercept of the y axis are evaluated to be 8:69 0:44 kOe/ $_{\rm B}$ and K $_{\rm 0}=0.061$ 0:007 % . Taking into account that this shift corresponds to the isotropic




Fig. 5. T dependence of $1=T_1$ m easured at the Na-NMR central peak. $1=T_1$ above 50 K m easured by G avilano et al. is shown for comparison. $1=T_1$ below 10 K approximately follows T $^{0:73}$ $^{0:02}$ relation.

term of the K night shift, the hyper ne coupling constant arises from the covalency between Na-2s and Co-3d orbitals by way of the O atom . The temperature independent term of the $^{23}{\rm K}$ is considered to arise mainly from the EFG e ect at the Na site since $^{23}{\rm K}$ does not have an orbital term in most cases.

F igure 5 shows the temperature dependence of $1=T_1$ of Na 23 (1=T₁). 23 T₁ was determined by thing the nuclear m agnetization m (t) after the saturation to the theoreticalcurve for the central transition of $I = 3=2.23 T_1$ was evaluated to be a unique value in the whole temperature range. As shown in the gure, our 1=T1 result above 50 K is in good agreem ent with the previous report by G avilano et al., $^{6)}$ although we did not measure T_1 above 250 K \cdot 1=T₁ shows a clear anomaly around room tem perature, which is due to a structural anomaly seen in and 23 K .W ith decreasing tem perature, $1=T_1$ is nearly constant down to 50 K, and starts to decrease below 50 K. It is noteworthy that the resistivity shows a steep decrease around 40 K. It is considered that some change in the electronic states occurs around this tem perature. In the low temperature range, $1=T_1$ seems to follow a Tⁿ relation below 10 K. From the tting of the data, n is estimated as n = 0.73 0.02. The $T_1T = constant$ relation, which is the characteristic feature of the Ferm iliquid state, is not observed down to 1.5 K, suggestive of the existence of the strong magnetic uctuations at low tem peratures.

Now, we discuss the spin- uctuation character at low tem perature region in N $a_{0.7}\text{CoO}_2$ from the results of the spin part of ^{23}K and $^{23}\left(1\text{=}T_1\text{T}\right)$. When NMR shift and $1\text{=}T_1\text{T}$ arise from selectrons as in the present case, the Korringa relation is known to be satisfied when the electronic interaction is negligibly small. The noninteracting Korringa relation is expressed by $(T_1\text{TK}_{\text{spin}}^2)_0 = \left(\begin{array}{cc} e & n \end{array} \right)^2 (\sim\!\!=\!4~k_B)$ So, where $_e$ and $_n$ are the electronic and nuclear gyrom agnetic ratios. In the presence




Fig. 6. T dependence of R $S_0=T_1TK_{sp\,in}^2$ (left axis) and $1=T_1TK^{3=2}$ (right axis) (see in the text). The inset shows T dependence of $^{23}K_{sp\,in}$ (left axis) and $1=T_1T$ (right axis).

 $S_0 = T_1 T K_{spin}^2$ provides of interactions, the ratio R an important information about magnetic correlations. Since 1=T1T is related to the low-energy part of the qdependent dynamical susceptibility in compounds, it can be enhanced by either ferrom agnetic (FM) and antiferrom agnetic (AFM) spin correlations, while only FM correlations strongly enhance the spin shift. Therefore, the value of R is much small (larger) than unity when FM (AFM) correlations become signicant. Using the experim ental values of 23 K $_{\rm sp\,in}$ and 23 (1=T $_{1}$ T), R is estim ated as shown in the main qure of Fig. 6.R enhances above 200 K due to the additional dynamics associated with the Na rearrangement. Below 150 K, R remains at a 0:3 down to 4 K, which points to a sm all value of R predom inance of FM correlations. The FM correlations revealed by NMR are consistent with the larger Wilson ratio R_w

In addition, when we plot experimental data of $1=T_1TK^{3=2}$ against T as shown in Fig. 6, we found that $1=T_1TK_s^{3=2}$ is nearly constant up to 100 K within our experim ental accuracy. This constant relation in plies a linear relation between $1=T_1T$ and $\sup_{\text{spin}}^{3=2}$. A coording to the self-consistent renormalization (SCR) theory for weak or nearly FM metals, $^{12)}$ it was predicted that $1=T_1T$ is proportional to $_{\rm sp\,in}$ and $_{\rm sp\,in}^{3=2}$ under the predom inance of three-dim ensional (3-D) and 2-D FM correlations, respectrively. The relation of 1=T $_1\text{T}$ / $^{3=2}_{\text{spin}}$ and the small value of R suggest that a 2-D FM correlations are dom inant in Na_{0:7}CoO₂.Quite recently, it was reported from a neutron scattering (NS) experim ent that a prominent inelastic signal at low energies is localized around Q 2D (0,0) in the 2-D reciprocal space. 13) The observation of this peak is a direct evidence for the existence of the FM spin uctuations in the CoO₂ layers.Our results are in good agreem ent with this NS result.

W e also point out that single component of 23 (1=T1)

down to 1.5 K suggests a hom ogeneous magnetic state. If the mixed valence state suggested from the result, $^{6,10)}$ 1=T₁ would have two components at low temperatures. O byiously, it is not a case. O ur 23 (1=T₁) result strongly suggests that the magnetic properties in the CoO $_2$ plane should be understood by a hom ogeneous it inerant magnetic state. Therefore, the deviation from the CW behavior below 20 K is considered to be due to the development of the FM correlations.

In addition, it is noteworthy that $1=T_1T$ continues to increase down to $1.5\,\mathrm{K}$ although $^{23}\mathrm{K}_{\mathrm{spin}}$ levels o below 4 K. The R increases below 4 K but is still less than unity at $1.5~\mathrm{K}$. This disparate behavior between $1=T_1\mathrm{T}$ and 23 K $_{
m spin}$ at low tem peratures shows that the AFM correlations also develop below 4 K in the predom in ance of the FM correlations. Our Na-NMR study suggests that the FM and AFM correlations compete with each other at low tem peratures. The competing magnetic uctuations would be related to the Ferm isurface (FS) of N $a_{0:7}$ C oO $_2$. A coording to the band calculation, 14) two di erent kinds of FS's are shown: small six hole pockets near the K point which have an egorbital character, and large cylindrical hole FS which has a dom inant a_{1q} -orbital character. It is considered that the form er FS's favor the FM uctuations and the latter FS would induce the AF ones. We suggest that the these FS's with the di erent character are essential to understand the magnetic properties in $Na_{0:7}CoO_2$.

In conclusion, the 2-D FM correlations are shown from the small K orringa ratio of R $\,$ 0:3 and the relation of 1=T_1T / $_{\rm spin}^{\rm 3=2}$. Our NMR results are consistent with the large W ilson ration R $_{\rm W}$ $\,$ 2:8 and the recent NS result. In addition to this FM correlations, the AFM correlations are also shown from the di erent behaviors between 1=T_1T and K $_{\rm spin}$ below 4 K . W e suggest that the competing magnetic uctuations at low temperaturs are due to the two hole FS's in N a_{0:7}C cO $_2$, which have di erent characters each others.
