#### Abstract

W e apply standard, rst-principles calculations to a com plete treatm ent of lattice dynam ics in the harm onic approxim ation. The algorithm $m$ akes use of the straightforw ard \frozenphonon" approach to the calculation of vibrational spectra and addresses som e lim itations of the m ethod. O ur prescription's validity is independent of crystal structure. It treats polar crystals in a general way, and it incorporates interatom ic-force constants reaching beyond the supercell that is considered. For a range ofm aterials, phonon dispersion exhibits the close agreem ent w ith experim ent that is now characteristic of rst-principles schem es. R esults for graphite, Si and GaA s are presented.


## I. Introduction

Severalyears ago, density-fiunctionaltheory (D F T ) [1] [1] opened the w ay to detailed know ledge of phonon spectra from rst principles. The two m ost com m on approaches today are density-functional perturbation theory (D FP T) [2] $]$, where linear corrections to the equilibrium electronic wave functions are calculated w ith respect to som e perturbation, in this case ionic displacem ents, and the \frozen-phonon" m ethod, which solves for the ground state w ith the displacem ents \frozen" in [3]. T he latter is taken up here.

D irect-m ethod calculations, in con junction w th the $H$ ellm an Feynm an force theorem $\left[\begin{array}{l}{[\overline{1} 1]}\end{array}\right]$ have evaluated restoring forces and phonon frequencies by em ploying two di erent types of supercells. In itial w ork utilized w ave-com m ensurate supercells, which $m$ ap the phonon's periodicity to the supercell. This allowed for the evaluation of dynam ical matrices for a very $s m$ all set of wave vectors where the phonon polarizations were known a priori Later, supercells were designed to com pute interplanar forces. Transform ing the planar forces into the real-space interatom ic-force constants ( $\mathbb{F} C \mathrm{~s}$ ) m ade possible the expansion of the dynam icalm atrix throughout the Brillouin zone (BZ) [G]. O ur strategy retums to $w$ ave-com $m$ ensurate supercells, but displaces ions along $C$ artesian rather than along norm al coordinates.

In this respect, our m ethod resembles that of DFPT, where the dynam ical matrices are derived directly in $m$ om entum space, and then interpolated $\left.\underline{i}_{1}\right]$. A ccordingly, sim ilar techniques can be exploited to account for the longitudinaltransverse ( $\mathrm{LO}-\mathrm{TO}$ ) optical phonon splltting, which are som ew hat di erent than those often combined w ith frozen-


The present schem e, at the level of DFT, exploits the periodicity of the supercells and includes all the interactions, while requiring no prior know ledge of phonon modes. The com putation of planar-force constants discounts interactions extending beyond the supercell, even if they are num erically represented in a calculation $[1]=12]$. 12 suggest the possibility of a full dispersion calculation $w$ ith sm aller supercells than have been necessary until now.

The $m$ ethod described here proceeds in two steps: rst, a set of high-sym $m$ etry wave vectors, fkg , is chosen, and the corresponding reciprocal-space, interatom ic-force constant $m$ atrices $f C(k) g$ are com puted; and second, the counterpart real-space $m$ atrioes are extracted through a $t$. A $t$ is perform ed, rather than the fam iliar Fourier transform, to conven iently accom odate an irregular w ave-vector grid while abiding by crystal sym m etry. $T$ his distinction from the intenpolation in $R$ ef. $\left[\overline{[ }_{1}\right]$ re ects the di ering requirem ents of each treatm ent. W thin DFPT, the phonon and electron grids m ust be equivalent and are typically regular, whereas in the present treatm ent there is freedom to select the wave-vector grid, provided that the corresponding periodicities are com $m$ ensurate $w$ ith carefilly chosen supercells.

If, at the $B$ ravais lattioe site indicated by the vector $R$, the $a^{\text {th }}$ coordinate of the th ion's position is given by:

where $V$ is the $B$ om-O ppenhem er energy surface. The translationalsym $m$ etry of the crystal requires that the $\mathbb{F C}$ s are independent of $\mathrm{R}^{0}$.

The above expression establishes the general $t$ condition on the real-space $m$ atrices, and gives an expression for the reciprocal-space $m$ atrices at arbitrary $k$ once the real-space $m$ atrices are know $n$.

The dynam ical matrix is obtained by dividing the reciprocal-space $\mathbb{F C}$ s by the ionic m asses:

Polar crystals, or those in which sub-lattice shifts are accom panied by macroscopic electric dipoles, exhibit splitting of the sm allm om entum, LO -T O phonon degeneracy. This e ect requires additional consideration to be inconporated into the above procedure. In this work, such e ects are inconporated with a m ethod analogous to that used in earlier work, where a distinction is $m$ ade betw een \covalent" and dipole-dipole contributions to the real-space FF m atrices $[\underline{\underline{T}}, 1$, 1

## II. Sam pling of the B rillouin Zone

The periodic ionic displacem ents entering a frozen-phonon calculation are constructed w ith cells larger than the prim itive cell, or supercells. In particular, cells are constructed such that ionic positions are given by

In the case that $k$ is along certain high-sym m etry directions and is half of $a$ recip rocal-lattice vector, $k \quad R^{\infty}$ is a multiple of for all $R^{\infty}$. At these points the condition $C(k)=C(k)$ is valid, and by Eq. 131, the equality $C(k)=C(k)$ follow $s$, dem onstrating that the reciprocal-space tensorm ust be purely real at any such point.

The practical result of Eq. 8 is that an entire row of the reciprocal-space $m$ atrix is known from two calculations, each equivalent to a supercell calculation of total energy. Typically, know ledge of the reciprocal-space IFC s at tw o or three wave vectors along each high-sym m etry direction is su cient for a good phonon dispersion throughout the BZ. A lthough complications arise from the tting to a real-space representation, and the interpolated dynam icalm atrices do depend on real-space cuto $s$, at least at the level of D FT, the form alism here incoporates interactions betw een ions that are not local to a supercell. W hile the standard approxim ations to the electronic ground state are present in the DFTcalculated dynam ical m atrioes, through construction of supercells representing standing w aves m apped to the B Z point considered, Eq. ${ }_{-1}^{-9}$ form ally accounts for all the $\mathbb{F} C$ s.

In order to carry out the interpolation of the dynam icalm atrix, a discrete Fourier transform on the com plete set of vectors $w$ ithin a parallelopiped box $m$ ay appear tem pting. Ifone $w$ ishes to respect the sym $m$ etry of the crystal, how ever, this tactic $w$ ill not w ork. G enerally, the set of vectors spanned by such a box $w$ illinclude som e vectors $w$ ith in a sym $m$ etry-related subset, and not others. If the set is inclusive enough, the arti cial asym $m$ etry introduced $m$ ay be negligible, because $C(R)$ is expected to dim in ish reasonably quickly $w$ ith $R$, and the set can include all $m$ em bers of any subset $w$ hose com ponents have signi cant $m$ agnitude.
$R$ ather than perform ing a Fourier transform, by overdeterm ining the real-space $\mathbb{F} C$ $m$ atrices used in Eq. $\bar{i}$ and then tting them, the crystal sym m etry is preserved here, and no nu isance is posed by the choige ofw ave-vector sam pling. T he follow ing section details how this procedure is im plem ented. K ey features of the form ulation are that allsym $m$ etries of the crystal are respected, the sym $m$ etries are exploited to $m$ in im ize the num ber of param eters to be $t$, and frequencies of the acoustic phonons are guaranteed to go to zero in the lim it of $s m$ all $w$ ave vector.

The next section assum es that the real-space $m$ atrices are short-ranged, and do not include the long-range C oulom bic, ion-ion interactions. As a result, the treatm ent, without being supplem ented, can be applied only to nonpolar crystals. A separate section subsequently extracts the contributions from the Coulombic interactions and extends the form alism to polar crystals.

## III. F itting A lgorithm

The B om-O ppenhein er energy surface of a lattioe is given by $V(f x \quad(R) g$ ), where $x(R)$ denotes the displacem ent from equilibrium of the atom located at $R+s$, or at basis vector $s$ indexed by in the cell speci ed by the lattioe vector $R$. Them atrioes, $f C \quad 0(R) g$, are the $3 \quad 3 \mathrm{~m}$ atriges denoting the $\mathbb{F C}$. They satisfy

## IV .M acroscopic F ields and Polar C rystals

For nonpolar crystals, and hence those w th no optically active phonons, the $m$ ethod described above is su cient for the calculation of fill phonon dispersion. H ow ever, polar m aterials, in which distortions interior to the prim itive cell can generate electric dipoles, require further consideration. This is because the boundary conditions of DFT calculations w ill not allow any physics associated with m acroscopic electric polarizations or elds. $T$ he latter are connected to the LO modes, and the D F T calculations are relevant only to the acoustic and TO phonon branches. Them acroscopic elds can sti en the sm all-w avevector, LO m odes in a m anner that can depend on the direction from which the wave vector approaches zero

The situation is further com plicated by the fact that it is only at the B Z center that supercell D F T calculations do not include all the lattioe- eld interactions. So the tting procedure m ust reintroduce these interactions at the B Z center while leaving the dynam ical $m$ atriges at other points una ected.

To do this, the B om e ective charges are rst calculated $\underline{2} \overline{0} \overline{0}]$. T hese charges are de ned as

The distinction betw een the two cases is alw ays clear, because we are only considering the sam pled BZ points, and all of these points, except for the point itself, are far from the BZ center. W thin the tting procedure, the real-space and reciprocal-space IFCs are now replaced by $\hat{C}(R)$, and $C^{D F T}(k) \quad T(k)$, respectively.

## V.C om putationalD etails

D ispersion curves for $\mathrm{Si}, \mathrm{G}$ aA s and graphite are presented in F igs. listed which phonon $k$ points are used in each $t$, and which real-space triplet $m$ atrioes are included. These particular selections are som ew hat arbitrary, so long as the BZ is adequately sam pled and the triplet $m$ atrices are overdeterm ined. For the case of graphite, extra weight is given to the point in the $t$ to ensure that at very sm all $k$ the very sm all eigenvalues of the dynam icalm atrix, ! ${ }^{2}$, do not go negative.
$T$ he sym $m$ etries are determ ined from lattige structure: for $G a A s$ and $S i$, the lattice vectors are

## V I. C onclusions

W e have $m$ ade som e innovations $w$ thin the direct approach to the com putation of lattice dynam ics. T hese include the calculation of dynam icalm atrioes w ithout resort to real-space atom ic force constants, which $m$ ay reduce the supercell size necessary for a full dispersion calculation; the generalextension to polar crystals; and a sym m etry-preserving talgorithm for interpolation throughout the B Z. T he direct $m$ ethod is show $n$ to render a com plete, rstprinciples characterization of the phonon spectrum for a range ofm aterials. A ccordingly, the direct $m$ ethod can be considered com plim entary to density-functional perturbation theory as a $m$ eans of com puting a variety of fundam ental, phonon-related solid-state properties.
