## Critical Scaling of Extended Power Law I-V Isotherm s near Vortex G lass Transition

In view of the question about the vortex glass theory of the freezing of disordered vortex m atter raised by recent experim ental observations we reinvestigate the critical scaling of high  $T_c$  superconductors. We nd that dc current-voltage characteristic of m ixed state superconductors has the general form of extended power law which is based on the G inzburg-Landau (GL) functional in the sim ilar way as the vortex glass theory. Isotherm s sim ulated from this nonlinear equation t the experim ental I-V data of Strachan et al. PhysRev Lett. 87, 067007 (2001)]. The puzzling question of the derivative plot for the I-V curves and the controversy surrounding the values of critical exponents are also discussed.

The hypothesis of a vortex glass in disordered high temperature superconductors[1] has spurred much research and many discussions during more than one decade and continued to be a very controversial issue[2, 3]. Though the striking dc current-voltage(I-V) data collapse shown by K och et al.[4], and found by other groups on other samples, strongly supports the consensus that a glass transition occurs in high-temperature superconductors(H T S)[5], this widely accepted evidence has met serious doubt recently. Strachan et al. show wide range accurate isotherm al I-V measurements over 5 or 6 decades on a high quality 2200 A thick Y B  $a_2$ C  $u_3$ O  $_7$ 

91:5K and transition width about 0.5K [3] lm with T<sub>c</sub> and nd although the I-V isotherm sm easured in a magnetic eld can be collapsed onto scalling functions proposed by F isher et al.[1] as is widely reported in the literature, these excellent data collapse can also be achieved for a wide range of exponents and glass tem peratures  $\mathrm{T_q}$  as dem onstrated in their F ig 2 (a), 2 (b) and 2 (c) [3]. Since the critical tem perature T<sub>q</sub> cannot be determ ined uniquely, they argued that necessary evidence for a vortex-glass transition to zero resistance is still not seen in their I-V experim entaldata, as wellas in all the ones they know of in the literature which scale. Therefore, the correctness of the vortex glass picture has to be reinvestigated. In this work, we try to settle this remarkable controversy by introducing a general extended power law form of the current-voltage isotherm s.

In analogue with the vortex glass theory [1], our extended power law equation is also based on the GL free energy functional of a system of N ux lines with a eld H along the z direction in a sample length L which can be described with the free energy represented by the trajectories  $fr_{j}$  (z)g of these ux lines and the pinning potential  $V_P$  (r) arising from inhom ogeneities and defects in sample [1, 5, 6, 7] as

Here V  $(\mathbf{r}_{ij}) = V (j\mathbf{r}_i \quad \mathbf{r}_j \mathbf{j}) = 2\mathbf{"}_0 K_0 (\mathbf{r}_{ij} = ab)$  is the interaction potential between lines with in-plane London penetration depth ab and  $K_0$  (x) is the modil ed Bessel function  $K_0$  (x)  $(=2x)^{1=2} e^x \cdot \mathbf{"}_1$  is the linear tension of ux line and  $\mathbf{"}_0$   $(_0=4 ab)^2$  is the energy scale for the interaction.

Them ally activated ux motion can be considered as the sequence of them ally activated jumps of the vortex segments or vortex bundles between the metastable states generated by disorder. Every elementary jump is viewed as the nuclearation of a vortex loop, and the mean velocity of the vortex system is determined by the nuclearation rate [1, 7]

Here F is the free energy for the form ation of the critical size loop or nucleus which can be found by means of the standard variational procedure from the free energy functional due to the in-plane displacement  $\frac{1}{2}$  (z) of the moving vortex during loop form ation

where  $f_L = J$   $e_z = c$  is the Lorentz force due to applied current J and f is the viscous drag force on vortex,  $f = v_{vortex}$ , with  $v_{vortex} = du = dt$  and viscous drag coe cient ( ${}_{0}B_{c2}$ ) =  ${}_{n}c^{2}$  as estimated by Bardeen and Stephen [8].

There are two essential di erences between our equations (1) and (3) and the corresponding ones used in previous vortex glass theories:

(i)W e considered both the Lorentz force  $f_L$  and the viscous drag force f on the vortex loop during its formation while in present vortex glass theories only bare Lorentz force  $f_L$  has been taken into account[1, 5, 7].

(ii) The e ect of the real sample size L on the currentvoltage response is explicitly estimated in our case. The in uence of the nite size e ects on the I-V isotherms is recently revealed even in thickest lms at zero magnetic eldg].

These two factors result in a new form for the I-V isotherm s of superconducting vortex m atter.

In stead of the barrier energy found by the vortex glass m odel[1] as

now we have the barrier energy

which in plies a current-voltage characteristic of the form

where  $U_c$  is a tem perature- and eld-dependent characteristic pinning energy related to the sti ness coe cient and  $J_c$  is a characteristic current density related to  $U_c$ , is an num erical exponent.

Considering the real size e  $\cot \text{Eq.}(7)$  leads to a general norm alized form of the current-voltage characteristic [10] in the form

with  $J_L$  the transport current density corresponding to the case where the critical size of loop form ation is equal to the real sample size L. The f in Eq.(7) is the ux

ow resistance of a pinning free m ixed state as derived by Bardeen and Stephen. Its relation with the normal resistance is of the form

In an earlier work [11], equation (8) has also been shown in connection with the Anderson-K im model. Compared with the widely used power law nonlinear response  $E / J^n$  (see Ref.5), equation (8) can also be nearly equivalently expressed in an extended power law form

with n a numerical factor depending on the parameters and p in Eq.(8), which can be determined from solving

the equation




FIG.1: Comparison of solutions of Eq.(8) (solid symbols) and Eq.(10) (curves).

where the subscript idenote the corresponding values at the in ection point of lny lnx curve for Eq.(8) with the maximum derivative  $S_{max}$  so

In Fig.1 we show the num erical solutions of Eq.(8) and Eq.(10) for comparison.

The complex experimental current-voltage data are usually described phenomenologically with a form [5]

Equation (8) in plies that e ective barrier can be explicitly expressed as

Incorporating it into the commonly observed scaling behavior of magnetic hysteresis M (H) in superconductors, it can be shown that  $U_c(B;T)$  and  $J_c(B;T)$  in Eq.(13) must take the following form s[5]


with T (B) being the irreversibility temperature where tilt modules and sti ness of vortex matter vanish. Considering  $_{\rm f}$  / T, one nds from Eq.(8) the following temperature dependent relations for and I V isotherms of optimally doped YBCO samples in a given magnetic eld as






FIG.3: : Collapse of the simulated I-V isotherm s in Fig.2(a) using various critical parameters compared with

C om bination of equations (8) and (15) enables us to sim – ulate the experim entally measured I V isotherm s of Strachan et al.[3] as shown in Fig.2, where the param – eters used in (8) and (15) are = 3.0; = 0.5; p = 1.75;  $_0$  =  $3.21 \quad 10^{21}$  and the irreversibility temperature T (B = 4T) is assumed 88K similar to the Fig.1 in Ref.[3]. On the basis of nearly 100 simulated I V isotherm s from 68K to 88K with temperature intervals of 0.2K, we obtain three di erent scaling data collapse analyses with assumed critical temperature T<sub>g</sub> of 81K ,75K and 70K respectively. In Fig.3 we show the comparison of our result with the data collapses of measured I V curves of Strachan et al. in Ref.[3] and nd fair agreement.

In Fig.3 of the Ref.[3] another serious puzzle is m entioned with plotting the derivatives of the lnV vs lnI for

experimental isotherms following Repactet al.[12]. All isotherms seem to have a maximum slope at about some current with 0 hm ic tails developing to the left of the peaks. This behavior is inconsistent with the scaling function of vortex-glass transition [4] which should predict a horizontal line in the  $[dlnV=dlnI]_T$  s lnI plot at  $T = T_g$ . Nevertheless, our extended power law I V equations may give it a reasonable explanation.




FIG.4: Empirical scaling of the derivatives of the experim ental hV lnI isotherm s. A data from Ref.12 B: data from Ref.3. The solid curve is the results simulated from Eq.(17).

In Fig.4 we plot the slope of experimental I V

isotherm s of R ef. [3] and [12] in an empirical scaling form

and nd that these experimental data are collapsed, where the subscript i denotes the value at in ection point of  $\ln V$   $\ln I$  curve, S  $[d\ln V = d\ln I]_T$  and n denotes  $S_{m \ ax}$  at in ection. This empirical scaling function can be derived from extended power law nonlinear I-V isotherms. Starting from our equation (8) one nds analytic equation

shown by the solid curve in Fig.4.

The agreem ent of the simulated I-V isotherm s derived from Eqs.(8) and (15) with the wide-range experimental data of Ref.[3] as shown in our Fig.2,3 and 4 dem onstrates that extended power law is the general form of I-V isotherms. Though, in principle, each I-V curve can have both positive and negative curvature parts joined at the in ection point, the actually used current-voltage window in measurements limits the observable part of each I-V isotherm s and results in the previous reasonable scaling analysis [1, 2]. Using wider I-V windows of measurem ents, Strachan et al. nd that non-0 hm ic-powerlaw-like behavior can be t to all T < 81K isotherms over at least four decades of voltage data and thus insightfully reveal that the conventional I-V scaling cannot determ ine a unique Tg with corresponding critical exponents. The successful reproduce of their experim ental data collapses with our simulated I-V isotherm s from equations (8) and (15) with the uniquely assumed param eters the irreversibility tem perature T (B = 4T) = 88K and = 3:0, = 0:5, p = 1:75,  $_0 = 3:21$   $10^{21}$  shows that extended power law is helpful in settling the controversy surrounding critical phenom ena in high tem perature superconductors.

In conclusion, we show that dc current-voltage characteristic of mixed state superconductors has the general form of extended power law. Isotherm s simulated from this nonlinear equation t the recent experimental I-V data of Strachan et al. This equation also gives a reasonable explanation to the critical scaling relation recently observed in the derivatives of the lnV vs lnI.
