# A nalytical Studies on a M odi ed N agel-Schreckenberg M odel with the Fukui-Ishibashi A cceleration R ule

We propose and study a one-dimensional trac ow cellular automaton model of high-speed vehicles with the Fukui-Ishibashi type (FI) acceleration nule for all cars, and the Nagel-Schreckenbergtype (NS) stochastic delay mechanism. By using the car-oriented mean eld theory, we obtain analytically the fundamental diagrams of the average speed and vehicle ux depending on the vehicle density and stochastic delay probability. Our theoretical results, which may contribute to the exact analytical theory of the NS model, are in excellent agreement with numerical simulations.

## I. IN TRODUCTION

Tra c ow that displays various com plex behaviors is a kind ofm any-body system s of strongly interacting vehicles. O ne of the approaches to m icroscopic tra c processes is based on cellular autom aton (CA) [1], which treats the m otions of cars as hopping processes on one-dimensional lattices. In the past few decades, CA m odels for tra c

ow have attracted much interest of a community of physicists [1, 2]. Compared with other dynamical approaches, for instance the uid dynamical approach, CA models are conceptually simpler, and can be easily implemented on computers for numerical investigations [3].

Two popular one-dimensional (1D) CA models are the Nagel-Schreckenberg (NS) model [4] and the Fukui-Ishibashi (FI) model [5], where periodic boundary conditions are used to minic the trac ow on highway. An exact caroriented mean eld theory (COMF) have been developed to study the FI model, with an arbitrary limit on the maximum speed  $v_{max}$ , cardensity, and the delay probability f [6]. So far as we know, however, there has been no established exact analytical theory for the NS model, due to the complications in the time evolution of the ow caused by the acceleration and stochastic delay rules. In order to comprehend how these rules a left the evolution and the corresponding asymptotic steady state, we study a 1D trac ow CA model which combines the NS stochastic delay rule and the FI acceleration mechanism.

This paper is organized as follows. In Sec. II, we give the de nition of the model and the evolution equations for the inter-car spacings. Next, we present the fundam ental diagram s of the average speed and vehicle ux depending on the vehicle density and stochastic delay probability, compared with the num erical simulations. In Sec. IV, we sum mary with a discussion of our results in connection with the FI and NS models.

## II. THE MODEL AND ANALYTICAL SOLUTION OF A SYM PTOTIC AVERAGE VELOCITY

The modi ed Nagel-Schreckenberg model with the Fukui-Ishibashi acceleration rule is a probabilistic autom aton, in which space and time are discrete and hence also the velocities. The road of length L is divided into cells of certain length, each of which can either be empty or occupied by just one car. The state of the nth car (n = 1;:::;N) is characterized by the momentary velocity  $v_n$  (t); in this model, the maximum speed is xed as  $y_{nax} = M$ , and the vehicle density is = N = L. Let  $C_n$  (t) represent the number of empty sites in front of the nth vehicle at the time step t, then we have

As a function of the inter-car spacing  $C_n$  (t) and the stochastic delay probability f, the velocity of the nth car at time step t can be written as:

Here, as one can see, we have approximately adopted the acceleration rule introduced by Fukui and Ishibashi. The FIm odel can be considered as a NS m odel for \aggressive driving", since the rules of the FI are nearly identical to the NS m odel, except that the acceleration rule has been changed from \the vehicle speed is at most increased by 1 at each step" to \every car accelerates to  $v_{m ax}$ " (which is adopted in the present model) and the stochastic delay mechanism has been modiled as \only cars with  $v_{m ax}$  will delay stochastically" (which is not adopted here). For  $v_{m ax}$ = 1, this may not change anything, how ever, for higher velocities it will lead to a considerable enhancement of the ow. A likely the model is less realistic than the NS, it is still of interest due to its sim plicity. The analytical description of the present model is of course much sim pler than that of the NS, and hence it might serve as a testing ground for new analyticalm ethods as well as new models.

If  $N_i(t)$  represents the number of inter-car spacings with length i at time t, then the probability of nding such a spacing at time t is  $P_i(t) = N_i(t) = N_i(t) = N_i(t)$ . Hereafter,  $P_i(t)$  will indicated by  $P_i$  for simplicity, except if specied otherwise. Let  $Q_i$  denote the probability that an arbitrary vehicle moves i sites during a given time step, then we have:

Obviously,  $P_i = 0$  when i > L N, since the maximum inter-car spacing must be less than L N. To obtain the nonvanishing  $P_i$ , we introduce W<sub>i!j</sub> to denote the probability of nding an inter-car spacing with length i at a given time which changes into length j at the next time. A coording to the Eqs. (1)-(4), one can write all the nonzero W<sub>i!j</sub> as follow s:

W hen the system approaches its asymptotic steady state, all the  $P_j$  will case to change; thus the detailed statistical equilibrium condition for the steady state holds:

Since there are L N + 1 variables  $P_0; P_1; L R$  in Eqs. (6), which satisfy the following two normalization equations:

we should truncate Eqs. (6) and obtain other L N 1 equations. In the present paper, we will choose the L N 1 equations with m from 0 to L N 2. Thus, we will have L N + 1 independent equations, from which one can readily work out the values of  $P_0$ ;  $P_1$ ; L R, then the average speed of the trace in the steady state is:

Based on the above discussions, one can easily obtain the tra c ux of the steady state:




FIG.1: The fundam ental diagram of the average speed with the maximum speed M = 2 and for di erent stochastic delay probabilities f. The solid curves are num erical simulations while the points with di erent symbols represent theoretical results. The curves from the top down along the vehicle velocity axis correspond to di erent values of f ranging from 0 to 0.9, in steps of 0.1.




FIG.2: The fundamental diagram of the vehicle ux with the maximum speed M = 2 and for different stochastic delay probabilities f. The solid curves are numerical simulations while the points with different symbols represent theoretical results. The curves from the top down along the traculation of ux axis correspond to different values of f ranging from 0 to 0.9, in steps of 0.1.

# III. NUMERICAL SIMULATIONS IN COMPARISON WITH THEORETICAL RESULTS

In order to compare with the analytical results, we perform ed numerical simulations on a 1D CA with length L = 1000 and the maximum car velocity M = 2. The number of vehicles N is adjusted so as to give the desired vehicle density . The rst 5000 time steps are excluded from the averaging procedure so as to remove the transient behavior. The average values are taken over the next 1000 time steps. Figure 1 and 2 show comparisons between results obtained from numerical simulations and car-oriented mean-eld theory over the entire range of the vehicle density . The curves are the simulation results, while the symbols represent the theoretical results. Theoretical results are in excellent agreement with numerical simulations.

### IV. DISCUSSION

In sum mary, we propose and study a one-dimensional CA model of high-speed vehicles with the FI acceleration rule and the NS stochastic delay mechanism. The analysis of the dynamical evolution of our model give us a clearly physical picture of how the acceleration and stochastic delay rules a lect the evolution and the corresponding asymptotic steady state. A though cellular autom at a are designed for e cient computer simulation studies, an analytical description is possible, though di cult all too offen. The method presented here can also be applied to other CA models. Our study may shed some new light on developing analytical approaches to other one-dimension trac ow models, especially the NS model, for which until now, no exact analytical approach has been established. The investigation of the NS model has lead to a better understanding of its advantages and limitations, so that it is easier to choose the approach most suitable for a given problem. The question, how the stationary state is approached, is still an important open issue, which is currently under investigation and promises to yield new insights into the physics of the NS model.
