# A pparent fractal dim ensions in the H M F m odel

#### Abstract

W e show that recent observations of fractal dim ensions in the -space of $N$ body H am ittonian system $s$ w th long-range interactions are due to nite N and nite resolution e ects. W e provide strong num erical evidence that, in the continuum ( $V$ lasov) lim it, a set which initially is not a fractal (e.g. a line in 2D) rem ains such for all nite tim es. W e perform this analysis for the $H$ am iltonian $M$ ean $F$ ield ( $\mathrm{H} M \mathrm{~F}$ ) m odel, which describes the $m$ otion of a system of $N$ fully coupled rotors. The analysis can be indirectly con $m$ ed by studying the evolution of a large set of in itial points for the $C$ hirikov standard $m$ ap.

It has been recently claim ed [1,2] that structures characterized by a non integer fractaldim ension [3] form spontaneously in the -space ofsom eN łoody $H$ am iltonian system s , even when starting from a set of initial conditions (points in -space) that does not show any fractality.

[^0]Them odelanalysed in Ref. [1] is the one-dim ensionalself-gravitating system [4] and the initial condition is a line in -space, corresponding to a vanishing virial ratio (zero velocity for allm ass sheets). T hem odelstudied in $R$ ef. [2] describes the m otion of a fully coupled system of $N$ rotors and goes under the nam e of H am iltonian $M$ ean Field (HMF) m odel 5]; the initialcondition is such that all rotors are xed at som e given angle (conventionally zero) and angular velocities are uniform ly spread in an interval, sym $m$ etric around zero.

There is a strong analogy between the two results since: i) both models possess a continuum mean-eld $\lim$ 止 $(\mathbb{N}$ ! 1 at xed volum e) forwhich the single particle distribution function (SPDF) f(q;p;t) evolves according to a V lasov-Poisson system [6], ii) both initial states are lines in -space when the continuum lim it is taken.

In this short note we analyse the HMF m odel, considering the same initial state as the one studied in Ref. [2]. W e give com pelling num erical evidence that, as the num ber of rotors grow s and as the resolution increases, the collection of initialpoints lies on a set ofdim ension one in the -space (which is tw o-dim ensional for thism odel) at all nite tim es.

W e will explain that this is a som ew hat trivial consequence of the fact that the SPDF obeys a V lasov equation in the mean-eld lim it. M oreover, we will show that apparent fractaldim ensions can be indeed observed at low resolutions, justifying the observations ofR ef. [2]. For com parison, we w ill show what happens for the standard C hirikov's map [7], which shares the sym plectic property w ith the HM F m odel, for which we can push the analysis to a larger num ber of initial points.

The H am iltonian of the HM F m odel is

where $q_{i} 2$ [ ; [ is the position (angle) of the $i$-th particle on a circle and $p_{i}$ the corresponding conjugate variable. This system can be seen as representing particles m oving on a unit circle interacting via an in nite range attractive cosine potential, or as classicalX Y rotorsw ith in nite range ferrom agnetic couplings (form ore details see Ref. [8]). Them agnetization, de ned as

is the $m$ ain observable that characterizes the dynam ical and therm odynam ic state of the system.

In the continuum lim it, that is keeping the volum e (here the interval [ ; D and the energy per particle xed as the num ber of particles $N$ ! 1 , the dynam ics govemed
by $H$ am iltonian (1) is described by a $V$ lasov equation. Indeed, the state of the nite N system can be described by a single particle tim e-dependent distribution function

where is the D irac function. W hen N is large, it is natural to approxim ate the discrete density $f_{d}$ by a continuous SPDF $f(q ; p ; t)$. U sing this distribution, one can rew rite the two com ponents of the $m$ agnetization $M$ as

W ithin this approxim ation the potential that a ects all the particles is

$T$ his potential enters the expression of the $V$ lasov equation

which govems the spatio-tem poral evolution of the SPDF f.
The initial condition considered in [2] is $q_{i}=0 ; 8 i$ and $p_{i}$ random i.i.d. uniform ly distributed in the interval [ p;p]. As usual, we call this class of intitial conditions water bags ( $W \mathrm{~W}$ ). The value of $p$ is chosen such that the energy per particle is $\mathrm{U}=\mathrm{H}_{\mathrm{HMF}}=\mathrm{N}=0: 69$ and $\mathrm{N}=10000$, but these data w ill be varied in this paper. For such an energy this initial state is V lasov unstable [9], and hence the SPDF evolves in time (see g. 3 in Ref. [2]).

H ow ever, since initially the state is a line in the two-dim ensional -space ( $q ; p$ ), it will rem ain a line for all nite tim es, although intricately stretched and folded. This is a trivial property related to the fact that $V$ lasov equation de nes a ow $t$ for the particles (points $x=(q ; p)$ in the -space continuum )

which is a di eom or $s m$. M oreover, since the Jacobian $J=@ x(t)=@ x(0)$ is a sym plectic $m$ atrix, areas $m$ odify their shape but are conserved.

The reason why the set does not appear to be a line is due to the nite particle num ber in the sim ulation. The line is stretched and folded by the tw o m ain phasespacem echanism $s$ : the form ation ofw horls around elliptic xed points and oftendrils in the hom oclinic tangle [10]. M oreover, local hyperbolicity in phase-space produces a dispersion of the initialpoints. A s a consequence, the set of initial points, appears
by visual inspection, in the course of tim $e$, to be partly distributed along lines and partly dispersed onto the two-dim ensional -space (see again g. 3 in Ref. [2] or $g$. 2 in Ref. [1]) This is why the authors of Refs. [1,2] have used fractal dim ension to chacterize this set, $m$ ore speci cally box dim ension [1] and correlation dim ension [2].

The num ber ofboxes $\mathrm{N}_{\mathrm{b}}($ ) of linear size which cover the set of $\mathrm{N}=10$ points at timet $=75$ when starting the HMF model in a W B initial condition at $U=0: 69$ is shown as a function of resolution $1=$ in log-log scale in 9.1 . These data are not qualitatively di erent from the ones in $g .3$ of Ref. [1] and onem ight then $t$ the central part of them $w$ ith the A nsatz $\mathrm{N}_{\mathrm{b}}=\mathrm{D}_{0}$ (since the m axim al box size which contains all the set is norm alized to one), obtaining Do 1:930 0:002 and concluding that the set is a fractal, with dim ension D o close to tw o, but de nitely distinct from two within num erical accuracy. $T$ his is a consequence of the set being a $m$ ixture of a set w ith one-dim ensional features (the initial line) and two-dim ensional ones caused by chaotic spread.

H ow ever, as rst rem arked in Ref. [11] the slope of the curve in 9.1 is not constant and depends on the resolution. It is already evident in this gure that, as the resolution increases ( ! 0), the local slope tends to zero (on this scale $m$ ost of the points are surrounded by very few neighbours). This is better shown in $g .2 a$, where the discrete approxim ation of the local slope in logarithm ic scale

is plotted as a function of for the sam e set of points. Going from low to high resolution, all dim ensions from 2 to 0 are covered continuously and sm oothly. A $l l$ are apparent fractal dim ensions of a set which has indeed dim ension 1 . It might look strange that one does not observe any signal of dim ension 1 at any resolution. This is due to the inhom ogeneity, as shown in g. 3, where one represents in black the occupied boxes at increasing resolutions. W hile at low resolutions all.boxes are
occupied indicating a set of dim ension 2, when the resolution increases, the set concentrates on a sm aller set of boxes, but already at resolution $1==2^{2}$ one observes structures of dim ension 1 (lines). H ow ever, their weight in the -space is negligible and, as the resolution is increased even $m$ ore, the fraction of the set $m$ ade by spread points dom inates and consequently dim ension 0.A com pletem ultifractal [3] analysis should be realized to highlight such inhom ogeneities.

For com parison, we have perform ed a sim ilar experim ent for the C hirikov standard map [7]

where the index $t=0 ;:::$ denotes tim $e$ and the index $i=1 ;::: ; \mathrm{NP}$ the number of initial particles. P articles are put at $t=0$, as above, at $q=0$ and $w$ ith $m$ om entum uniform ly spread in the interval [ p;p]. The phase space is closed by periodizing in 2 both the $q$ and the $p$ directions and nom alized in the unit square. T he results of num erical experim ents conducted above the chaos threshold, at $K=12$, i.e. a param eter region $w$ ith a m ixed (chaotic and regular) phase space, are shown in g. 2 b (local slopes) and $g .4$ (occupied boxes in phase space at di erent resolutions) . The behavior of allm easured quantities is qualitatively the sam e as the one of the HM F m odel.

Can one get from straight box-counting an indication of the presence of sets of dim ension 1? To obtain this results it is enough to perform experim ents at lower energies for the HM F m odel and at sm aller values of param eter K in the standard $m a p . B y$ doing this, one decreases the fraction of phase space which is occupied by chaotic orbits and, hence, reduces particle dispersion. In 9.5 we plot the local slopes for the HM F m odel at $U=0: 1(\mathrm{~g} .5 \mathrm{a})$ and at $\mathrm{K}=0: 2$ for the standard m ap ( g .5 b ). In these cases, the local slope, and hence fractaldim ension, show s an evident plateau at the value 1 as the resolution increases, before dropping to zero when the individual points of the set are detected. Let us rem ark that the number

of particles is the sam e as before $\mathrm{N}=\mathrm{NP}=10^{6}$. This is a strong evidence that the line rem ains a line during tim e evolution, as expected.

Having understood that the lim ited number of particles is crucial in determ ining the results, we show in 9.6 and $g .7$ the dependence of the local slopes on the num ber of particles forboth the HM F m odeland the standard m ap. In all cases, s is an increasing function of the num ber of particles, and, at xed num ber of particles, as the resolution increases, the slope decreases. H ow ever, for a m ore chaotic phase space ( g .6 ), i.e. HM F at $\mathrm{U}=0: 69$ and standard m ap at $\mathrm{K}=1: 2$, the curves corresponding to the higher resolution show only a slight increase from zero slope and one cannot de nitely conclude that, as the num ber of particle increases, they will tend to slope 1 (while those which converge, clearly point to dim ension 2). On the contrary, for a less chaotic phase space (HMF at U $=0: 1$ and standard m ap at $K=0: 2$ ), the curves corresponding to the higher resolutions converge to slope (dim ension) 1 as the num ber of particles increases, approxim ately to $(1=)^{2} .4$
$\overline{4}$ For the standard $m$ ap we have perform ed experim ents for up to $10^{8}$ particles. W e have obtained a m ore evident levelling o of the slope as the num ber of particles increases and a convergence to 1 from above as the resolution subsequently increases. For the HM F m odel the convergence to 1 is follow ed by a further drop to sm aller values at higher resolutions, as also show $n$ in $g .5 a$ : this is again a nite $N$ e ect.

W e think that we have solved the puzzle of the existence of a fractal set generated in a nite tim e when starting with a one-dim ensional set (a line) in the phase space of H am iltonian system s . T he fractal is not there and is a feature of the resolution w ith which the set is observed.

O f course this does not dim inish the role played by fractal concepts in system $s$ w ith long-range interactions. C ertainly, when the initial set is already a fractal [12], it's

well possible that the set rem ains fractal during tim e evolution. M oreover, when studying evolving universe models, one e ectively introduces dissipative term s in the equations of $m$ otion $[12,13]$ and one can indeed observe fractal sets generated from non fractals. A nother situation is the one of the advection of passive tracers [14] or vector elds [15], where one indeed can observe fractalsets in $H$ am iltonian phase spaces. This is due to the presence of non escaping orbits inside the mixing region, which form a zero $m$ easure fractal repeller [14] or, in the kinem atic dynam o problem [15], to the concentration of the magnetic ux onto a singular set ast! 1 .
