M icrow ave response of a two-dim ensional electron stripe

E lectrom agnetic response of a nite-width two-dimensional electron stripe is theoretically studied. It is shown that retardation and radiative e ects substantially modify the absorption spectrum of the system at microwave frequencies, leading to a non-trivial zigzag behavior of the magnetoplasm on-polariton modes in magnetic elds, similar to that recently observed by Kukushkin et al. Phys. Rev. Lett. 90, 156801 (2003)].

I. IN TRODUCTION

Plasm a oscillations in low-dimensional electron systems (ES), { inversion layers, systems on the surface of liquid helium, quantum wells, wires and dots, { were experimentally studied since 1976^{1,2,3} and seem ed to be well understood (see e.g.4,5,6,7,8,9,10,11). Far-infrared transmission, as well as Raman spectroscopy experiments quantitatively con med theoretically predicted^{12,13} plasm on and magnetoplasm on spectra, both in two-dimensional (2D) electron layers, and in systems with lower dimensionality (wires and dots). However, recent experimental studies^{14,15} of the microwave response of macroscopic 2D electron disks with the diam eter ' 1 m m revealed very interesting and fully unexpected features of the magnetoplasm on spectra. Response of relatively sm all disks (with the diam eter < 0.1mm) was very similar to that of microscopic dots. The spectrum consisted of two sharp resonances corresponding to the bulk and edge_am<u>agnetoplas</u>m on modes with the frequencies ! (B) = $!_{p}^{2} + !_{c}^{2} = 4$ $!_{c}=2$, where $!_{c}$ is the cyclotron frequency and ! p the plasm a frequency at zero magnetic eld B = 0. In larger sam ples, how ever, the upper (bulk-magnetoplasmon) mode exhibited substantial changes. At a certain nite value of B this mode intersected the cyclotron resonance (CR) line $! = !_{c}$ and disappeared experiencing a dram atic broadening. A second, and in som e cases a third m ode, with com parable or even larger am plitude, appeared in the absorption spectrum at higher frequencies and showed sim ilar behavior. As a result, the B - eld dependence of the bulk m agnetoplasm a modes exhibited intriguing zigzag behavior as a function of magnetic eld at $! > !_p^{14,15}$.

It was shown $in^{14,15}$ that the observed features of the m agnetoplasm on spectra are due to the in uence of retardation e ects. At B = 0 the m easured resonance frequencies turned out to be in a good quantitative agreem ent with Ref.¹², and at nite B calculations did reveal a certain zigzag behavior of the resonant bulk m agnetoplasm on m odes. However the physical reasons of such a strange behavior of the m odes at nite B, as well as the overall behavior of the linew idth of resonances, have not been explained.

The goal of this paper is to theoretically study elec-

trom agnetic response of a nite-size m acroscopic 2DES. We consider a 2D stripe of a nite width W and focus on the regime, where the retardation and radiative e ects become important⁶ (for mm-size 2D samples this corresponds to m icrowave frequencies { the parameter range where very interesting m icrowave experiments^{17,18,19,20,21,22,23,24} have been recently done). A lthough the stripe geometry di ers from the experimental one (disks), our calculations reproduce all the experimental ndings^{4,15} and allow one to understand the physics of the observed e ects. It will be shown that the unusual zigzag behavior of the bulk-m agnetoplasm on m odes (m ore exactly, m agnetoplasm on-polaritons) is explained by an interplay of radiative and dissipative contributions to their linew idth.

In an in nite sample the spectrum of 2D m agnetoplasmons has been considered (taking into account retardation but ignoring the damping of modes) by Chiu and Quinn¹³ in 1974. Their results are applicable for the description of far-infrared response, when the size of the sample is large as compared to the m agnetoplasm on and radiation wavelength, and the issue of linew idth is not very important. We consider a nite-size geom etry, m ore relevant in view of the recent m icrow ave experim ents^{14,15,17,18,19,20,21,22,23,24}, where the radiation and the plasm on wavelengths exceed or comparable with the sam ple dimensions, and where the linew idth ofm odes essentially determ ines the observed non-trivial features of the absorption spectra.

II. THEORY

A ssume that the 2D electron-gas stripe (W = 2 < x < W = 2, 1 < y < 1) lies in the plane z = 0, the external magnetic eld B = (0;0;B) is directed along the z-axis, and the dielectric constant of surrounding medium is uniform in all the space. Let an external plane electrom agnetic wave with the frequency ! and the electric eld $E^{\text{ext}}(r;t) = E^{\text{ext}}e^{i!(z^{1} - c - t)}$ be norm ally incident upon the structure. It induces in the 2D system oscillating charge, current j, and { around the 2DES { electric and magnetic elds. The total electric eld $E^{\text{tot}} = E^{\text{ext}} + E^{\text{ind}}$, given by the sum of the external and the scattered (induced) elds, satis es the M axwell

Looking for a solution, proportional to $e^{i!t}$, and assuming that elds and currents do not depend on the y-coordinate, we rewrite Eq. (1) in an integral form for the x-and y-components of the induced electric eld

Here = $p_{q_x^2}$ $!^2 = d$ determ ines the z-dependence of elds (/ e $j^{z,j}$). Dependent on the interval of the dg_xintegration, Eqs. (2) (3) describe both the evanescent induced elds (at $q_x^2 > !^2 = d$) and the scattered outgoing wave (at $q_x^2 < !^2 = d$); the sign of Im should be properly chosen to satisfy the scattering boundary conditions at $j_z j! 1$.

Now we need to relate the current and the total electric eld inside the stripe. We do not consider in this paper possible nonlocale ects and use the relation $j(r) = E^{tot}(r)$ (W =2 jx), where is the conductivity tensor of the 2DES, dependent on the frequency, m agnetic eld and the momentum relaxation rate, and (x) is the step function. Together with Eqs. (2){(3) this gives a system of two integral equations for the electric current inside the stripe jxj< W =2,

These equations are solved by reduction to a matrix form . Expanding the currents in a complete set of functions,

The part of the integrals in (13) from Q = to Q = gives in aginary contribution to the matrix elements in (7) { (8) and physically corresponds to the radiative decay.

Having solved equations (7) { (8) and having got the coe cients A_n , B_n in terms of the external eld E^{ext} , we can calculate the current, Eq. (6), and the elds, Eqs. (2) { (3), inside the stripe. Then, calculating the Joule heat $Q = \begin{bmatrix} R_{W=2} \\ W=2 \end{bmatrix}$ (j E + jE)=4 and dividing it by the energy ow $S_z = c^{p-} (E_x^{ext} f + E_y^{ext} f)=8$, we get the absorption cross section $Q=S_z$ (dimensionality on). All plots of the next Section show the frequency, magnetic eld and other dependencies of the dimensionless \absorption coe cient"

de ned as the absorption cross section $Q = S_z$ norm alized by the width of the sam ple.

III. RESULTS

A. Prelim inary notes

The plasm a frequency in a 2DES, calculated in the quasi-static approximation is given by the form ula^{12}

where n_s , e and m[?] are the density, the charge and the e ective mass of 2D electrons, and q is the plasmon wavevector. In a stripe of a nite width W the lowest quasistatic eigen-mode frequency is expected at q =W. Therefore we choose for the frequency unit the quantity

for a typicalm acroscopic (mm -size) G aA s 2D sample its value lies in the tens-ofgigahertz range,

(for the e ective mass we use $m^2 = m_0 = 0.067$). Everywhere below we measure the frequencies in units $!=!_0$, magnetic elds in units $!_c=!_0$, and the momentum relaxation rate $= e=m^2$ in units $=!_0$ (is the mobility),

W e also introduce the retardation parameter , de ned as the ratio of the frequency of the quasi-static 2D plasmon (16) with the wavector q = =W to the frequency of light c = W with the same wavector,

in the considered case of the uniform dielectric constant the retardation parameter does not depend on . Its num erical value is negligibly sm all form icroscopic 2DES (for instance for quantum wires and dots), but can be of order unity form m -size 2D samples,

is the radiative decay rate in an in nite sample (see a discussion in^{16}).

We solve the system of equations (7){(8) numerically, restricting ourselves by a nite number $N_{\rm h}$ of harm onics in the expansions (6). The matrix equation (7){(8) then has the size 2N_{\rm h}=2N_{\rm h}. Convergence of the solution with respect to N_{\rm h} has been checked. All results shown below have been obtained with N_{\rm h}=16. For the conductivity tensor we have used the D rude model

B. Zero magnetic eld

We begin the presentation of results with the case of B = 0. We assume that the incident electrom agnetic wave is linearly polarized, and show results only for the perpendicular polarization ($E_y^{ext} = 0$). The case of the parallelpolarization is less interesting for the goals of this work.




FIG.1: Absorption spectra of a 2D stripe at $=!_0 = 0.05$ and at di erent retardation param eters. 16 curves are shown in Fig. (a) with varying from 0.1 up to 1.6 with the step 0.1. Fig. (b) provides a more detailed view on the same spectra around the rst and the second modes.

Figure 1 exhibits the absorption spectra of a stripe as a function of frequency, at $=!_0 = 0.05$ and a few values of the retardation parameter . One sees that at sm all (the quasistatic limit) the absorption spectrum is similar to that of quantum wires: a strong peak corresponding to the fundamental 2D plasm on mode with q

=W is accompanied by a number of very weak higherharmonics peaks, corresponding to q (2n 1) =W with n = 2;3;:::. Due to the symmetry of the external electric eld $E_x^{\text{ext}}(x) = E_x^{\text{ext}} = \text{const}$, the even 2D plasmon modes with q 2n =W are not excited. When

increases, the fundam entalm ode st increases in am plitude, reaches its maximum, and then decreases, additionally experiencing a very strong broadening. The behavior of the second mode is similar, but it reaches its maximum at a larger value of . As a result, at a certain

the second-mode peak has a larger amplitude and a smaller linewidth than the stone (see e.g. the curve for

= 0.8). The third, fourth and all other modes behave similarly, but each subsequent mode reaches its maximum (and becomes the dominant one in the spectrum) at a higher value of the retardation parameter. In general, as seen from the Figure 1, at > 1 the absorption spectrum has the shape qualitatively di erent from that in the quasistatic limit: it consists of m any peaks with quite com parable am plitudes, in contrast to the quantum wire/dot spectra, when the higher modes are hardly visible and only the low est one is dominant. All the modes, as seen from Fig. 1, experience quite essential red-shift, in agreem ent with^{12,14,15}.

C. Finite magnetic elds




FIG. 2: Absorption spectra of a 2D stripe as a function of frequency and magnetic eld, at =! $_0$ = 0:05 and at a few representative values of the retardation parameter = 0:1, 0.4, 0.8 and 1.4. Each plot contains 21 curves for ! $_c$ =! $_0$ varying from 0 to 4 with the step 0.2.

Figure 2 illustrates the behavior of modes in nite magnetic elds. If is small, Figure 2a, the absorption spectrum is, again, very similar to that of quantum wires. The fundamentalmode approaches the CR line according to the simple law $!_{m p}$ (B) = $\frac{1}{!_{p}^{2} + !_{c}^{2}}$, slightly increasing in the linewidth and decreasing in the am - plitude. All the higher modes behave similarly; no one of them becomes stronger than the fundamentalmode. Such a behavior wasmany times observed in experiments on quantum-wire arrays, see e.g.^{8,10}.

If becom es larger, Fig. 2b, the lowest, fundam entalm ode losses its am plitude very quickly approaching the CR line, and the second m ode becom es stronger. At even higher frequencies, and at larger values of , Fig. 2c, the same happens with the second m ode: it disappears, approaching and intersecting the CR, and releases its strength to the next m ode. Experim entally, this m anifests itself as a zigzag behavior of resonances^{14,15} (we rem ind that in experim ents the absorption was measured as a function of magnetic eld at a xed m icrow ave frequency): when ! increases, the lower-m ode peak gets broader and disappears, intersecting the CR line, while a new, stronger peak, corresponding to the next, higher m ode, arises at sm aller B. At even larger values of , Fig. 2d, such a relay-race of oscillator strengths between the m odes becom es m ore and m ore pronounced, especially for higher m odes. The frequency of the lowest m odes exhibits a very weak magnetic- eld dependence at large , Fig. 2d.




FIG. 3: Absorption spectra of a 2D stripe as a function of frequency and magnetic eld, at =! $_0 = 0.2$ and = 0.4.

It should be emphasized that the predicted features can be observed only in samples with a su ciently high electron mobility. Figure 3 exhibits the absorption spectra at = 0.4 (like in Figure 2b), but for a 4 times higher scattering rate ($=!_0 = 0.2$). One sees that the non-trivial exchange by oscillator strengths between the di erent modes alm ost disappears and the whole spectrum reminds now the one shown in Fig. 2a (with broader linewidths).

D. D iscussion

A sknown, in an in nite 2DES the CR has a maximum when the radiative and dissipative decay rates equal to each other. The absorption coe cient in this case (for a wave circularly polarized in the CR direction) has the form 16,25

which shows that the CR peak decreases and tends to zero both at = ! 0 and = ! 1, and reaches its maximum (= 1=2) at = = 1. Sim ilar situation is the case in a nite-width stripe, and it is the competition between the radiative and non-radiative processes that explains the zigzag behavior of modes.

Consider rst the case B = 0, Fig. 1. In the quasistatic limit ! 0 the linew idth of the n-th mode is determined by , while its amplitudes { by the radiative decay rate n, which gradually decrease with n because of the gradual decrease of the corresponding dipole matrix elements (we stress that n are not identical to the radiative decay rate (23) in an in nite sample). The grow th of leads to the increase of the radiative losses. When the radiative decay rate n of the n-th mode becomes equal to the dissipative decay rate , the amplitude of this mode reachs its maximum. As n is a decreasing function of n, the absorption maxim a for the higher modes are observed at larger values of . This explains the behavior of resonances at B = 0, Fig. 1.




FIG. 4: The frequency versus magnetic eld dependence of magnetoplasm on-polariton modes, as obtained in R ef.¹³. The units $!=!_p(q)$, $!_c=!_p(q)$, and $? = =!_p(q)$ are used on this plot; for explanations see the text. At large $!_c=!_p(q)$ the curves tend to the asymptotes $!=!_p(q) = 1 = ?(q)$, which correspond to the dispersion of light ! = cq = ?.

In order to understand the behavior of modes at nite magnetic elds, it is helpful to compare our results with those of Ref^{13} . Figure 4 exhibits the calculated in¹³ dependence of frequency on magnetic eld. As in¹³ the

eigen-value problem with a continuous magnetoplasm on wavevector q was considered, we norm alize (only on this plot) the frequencies ! and $!_c$ to $!_p$ (q), Eq. (16), and use the retardation parameter de ned as

 $!_p(q)$ and ?(q) are reduced to $!_0$ and , if q = =W. As seen from Fig. 4, the magnetoplasm on dispersion exhibits two dimensions. If $!_c = !_p = 1 = ?$, it follows the quasistatic behavior $! = !_p^2 + !_c^2$. The interaction of magnetoplasm ons with light in this regime is small. If $!_c = !_p > 1 = ?$, the magnetoplasm on mode intersects the CR line and tends to the asymptote $! = !_p = 1 = ?_p Which corresponds to the dispersion of light <math>! = cq = 1$. In this regime, the magnetoplasm on strongly interacts with light. In the in nite-sample geometry¹³ the interaction of plasm a modes with light thus manifests itself in the change of the dispersion of m odes.

In the nite-size geometry, strong interaction of magnetoplasmons with light in this regime manifests itself in the strong radiative decay of modes. As in a stripe the n-th mode corresponds to q =(2n 1)=W, the strong interaction regime should be expected at $!=!_0$ 1)= . A s seen from Fig. 2, a substantial broaden-(2n ing of the modes is observed, indeed, when the n-th mode frequency $! = !_0$ approaches (2n 1)= . As is also seen from these considerations, the modes with smaller n approach the strong interaction regime and die at lower frequencies, releasing their oscillator strength to the higher modes. This explains the non-trivial zigzag behavior of the magnetoplasm on-polariton resonances, which is seen in Fig. 2 and was experim entally observed in $Refs.^{14,15}$.

W e com plete our discussion by answering the question, what happens with the spectra of F igure 2 in the lim it of a large sam ple. How the com plicated structure of modes, shown in F ig. 2, is transform ed to a sim ple, single mode

IV. CONCLUSIONS

As seen from our analysis, the most interesting e ects, related to retardation, can be observed in 2DESs under the condition

This in plies, rst of all, that the parameter = should be small. The condition = 1 in poses the upper boundary on the zero-B resistance of 2D samples: it should be much smaller than the wave resistance of vacuum, 377 0 hm (it is so, if the electron m obility in typical G aAs samples exceeds 10^6 cm²/V s). Second, Eq. (28) in plies that the typical size of the sam ples should lie in a certain w indow, which extends (for typical m aterial param eters) from about 1 mm up to a few cm (dependent on the m obility). Recently published very interesting m icrow ave experiments on the 2D E S^{14,15,17,18,19,20,21,22,23,24} have been done in this range of parameters, and hence the phenomena discussed here should be important for their proper interpretation¹⁶.

To summarize, we have theoretically studied microwave absorption spectra of a nite-width 2D stripe, taking into account retardation e ects. We have shown that retardation substantially modil es the microwave response of macroscopic 2D ESs, especially in the very-highmobility sam ples. Our results are in very good agreement with experimental observations, and explain the mysterious zigzag dispersion of magnetoplasm on modes, discovered in^{14,15}. Further experimental studies of the predicted features in a broader range of parameters would be very interesting.
