Quantum Mechanics of Spin Transfer in Ferrom agnetic Multilayers

We use a quantum mechanical treatment of a ballistic spin current to describe novel aspects of spin transfer to a ferrom agnetic multilayer. We demonstrate quantum phenomena from spin transmission resonance (STR) to magnetoelectric spin echo (MESE), depending on the coupling between the magnetic moments in the ferrom agnetic thin lm s.0 ur calculation reveals new channels through which the zero spin transfer occurs in multilayers: the STR and MESE.We also illustrate that counter-intuitively, a negative spin torque can act initially on the second moment in a bilayer system.

The phenom enon of spin transfer [1, 2] has resulted in a recent wave of progress [3, 4, 5, 6, 7, 8, 9, 10, 11] to study interactions between spin-polarized electrons and a magnetic moment in a ferrom agnetic lm. However, the physics of spin transfer still has not been fully appreciated quantum mechanically. The underlying principle for this phenom enon is angularm om entum conservation. Since the incoming electrons are spin-litered by the magneticm om ent, as a reaction to the ltering e ect them agnetic m om ent becom es tilted to align along the direction of the incoming spin. This alignment is also known as the spin torque because of the associated moment change. However, spin is a quantum mechanical concept while torque is a classical quantity. These disparate views are reconciled since spin is transferred quantum mechanically from the incom ing electrons to the magneticm om ent, but the e ect on the moment appears in a classical manner. In this paper, we dem onstrate som e quantum mechanical aspects of the spin transfer in a ferrom agnetic multilayer by adopting an adiabatic approximation to describe the dual electron spin/ferrom agnetic m om ent system .

Two very interesting quantum mechanical phenomena in these problems are the spin transmission resonance (STR) [12] and the magnetoelectric spin echo (MESE) e ect [13]. The STR is due to quantum interference of the right-moving (transmitted) and left-moving (re-

ected) electron wave functions in the ferrom agnetic lm. On the other hand, the MESE is a consequence of the time reversal symmetry between the two magnetic moments. The STR and MESE have some similarities as well as di erences between them. Both phenomena occur with e ectively zero spin transfer to the moments. However, as we elucidate below, the physics governing the two phenomena is quite di erent.

First, STR can occur not only in a multilayer system but also in a single ferrom agnetic lm while the MESE can only take place in a multilayer system . For STR, resonance of the electron wave function is essential, while for the MESE we require an anti-symmetric con guration between the two magnetic moments all the time. In this way the spin current, once absorbed by the rstmom ent, can be generated by the second m om ent. That is, the second m om ent plays the role of a spin battery. C onsequently, a strong interaction between the two m om ents is necessary for the M E SE while STR is m ore or less insensitive to the m om ent-m om ent interaction. M oreover speci c values of the kinetic energy of the incom ing electrons are required for STR; this is not the case for the M E SE.

To account for both STR and the MESE, we consider a simple model H am iltonian for two single-dom ain ferromagnetic lm s with all key interactions included

where m is the electron m ass, J_H is the coupling between the magnetic m om ent and the incoming electron spins, J_M is the coupling between the m om ents, and $_0$ is the gyrom agnetic ratio. We consider the ballistic regime as in Refs. [12, 13].

The magnetic m om ents M $_1$ and M $_2$ in the magnetic multilayers are assumed to originate from the local spins in the same ferrom agnets with a constant magnitude M $_0$. The directions of M $_1$ and M $_2$ at a given time are ($_1$; $_1$) and ($_2$; $_2$), respectively, and are subject to the interactions. In the Ham iltonian Eq. (1), the second term transfers the electron spin to the magnetic moments via the spin ip process while the third term controls the relative orientation of M $_1$ and M $_2$.

O rigins of the coupling between the magnetic moments are the exchange interaction and a magnetic dipole interaction. The elective coupling is determined by the competition between the two interactions depending on the distance between the magnetic moments. A simple evaluation of the magnetic interaction energy shows that the anti-parallel conguration is more stable than the parallel case when the distance between the two ferrom agnetic lms is larger than the atom is scale. For example, for one-dimensional uniform ferrom agnets of length L separated by the distance d, the magnetic dipole interaction energy is approximately $2M_0^2=L^2d$ for paral-




FIG.1: (Color online) Quantum mechanical problem associated with the spin transfer to a ferrom agnetic multilayer. Here m_i = M_i=M₀. Regions II and IV represent the ferromagnetic lm s with thickness L₁ and L₂, respectively. Note that $x_1 = L_1, x_2 = L_1 + d$, and $x_3 = L_1 + d + L_2$ where d is the thickness of a spacer. Regions I, III, and V are non-ferrom agnetic.

lel (+) and anti-parallel () con gurations. For twodimensional uniform ferrom agnets with size of L L, the energy is about $8M_0^2 \ln (L=d)=L^3$. As we mentioned earlier, a necessary condition for the MESE is that the two moments remain anti-parallel for all times. Thus J_M must be negative with magnitude large compared to J_H . O therw ise, the spin torque will align easily both moments parallel to the initial direction of the incom ing spin; the MESE can no longer occur.

We show in Fig.1 the geometry of the problem. The incident direction of the electrons is in the positive X direction, and the two Im same placed perpendicular to this direction, in the YZ plane. Translational sym m etry is assum ed in the plane. Therefore, the problem is e ectively one-dimensional as in Refs. [9, 12]; this is a reasonable approximation in the ballistic regime. It is also assumed that regions I, III, and V are non-ferrom agnetic and are the same in nature for simplicity. W hen we solve for the dynam ics of the magnetic moments we use the adiabatic approximation. W hile this is applicable in most cases, it should be used with caution for the MESE because the magnetic moments will oscillate rapidly if the m om ent-m om ent coupling is large. The applicability of the adiabatic approximation requires the time scale for the electrons to be much shorter than that of the moments.

In principle, one can use any basis set to represent the wave functions in each region. For example, one could use the spin-up/down state j i in the lab frame for the basis. However, using the right basis makes the calcu-

lations much easier. We introduce eigenstates j i and j i of the interactions $2J_H \ s \ M_1$ and $2J_H \ s \ M_2$ such that $2J_H \ s \ M_1 \ j \ i = \ J_H \ M_0 \ j$ i and $2J_H \ s \ M_2 \ j \ i = \ J_H \ M_0 \ j$ i. Using the eigenstates of the interaction, we can represent the wave function in each region. We emphasize that this procedure can be system atically generalized to a system with more ferrom agnetic lm s.

The wave functions in regions I, II,III, IV, and V can be written as follows:

The coe cients R to T⁰ are determined by the boundary conditions at x = 0, L_1 , $L_1 + d$, and $L_1 + d + L_2$. In general, the coe cients depend on the directions of the moments in the magnetic multilayer. If dienert bases are used to expand the wave functions of each region, the coe cients will be changed. How ever, the wave functions remain the same. Since expressions of the coe cients are too long, we do not show them here. Instead, we explain important properties associated with the coe cients and the wave functions, below, for the extrem e cases: i) the STR with no dipole interaction and ii) the MESE with a strong dipole interaction.

Under the STR condition, the ferrom agnetic Im becomes transparent to the incoming spins [12]. One set of conditions that is required is that $L_1 = 2nL_{00}$ = 5=4. Here (n = 1;2;) for an energy ratio $L_{00} = = 2m J_H M_0$ is a typical length scale of the ferromagnetic lm and is the ratio of the incom ing electron energy $k^2=2m$ to the interaction energy $J_H M_0$. If we have the STR condition only for the rst lm in region $II_r T_* = T_{\#}$ so that the spin state of the forward-m oving wave in region III is the same as that of the incident wave. But, unlike the single layer case, R 🗧 0 because the wave function in region III is partially re ected at $x_2 = L_1 + d$ and the rejected wave can then pass through the rst lm in reverse (the same STR condition applies). W e point out that even in this case R $\in \mathbb{R}^0$ because the m agneticm om ents are not necessarily parallel to each another. Suppose STR takes place only in region IV where the second Im resides. Then clearly $R^0 = 0$ so that no wave is rejected at x_2 . Nevertheless, $T_{*}^{0} \in T_{*}^{0}$ because the forward-moving wave in region III has both j+ i and

j i components. Each spin component passes through the second lm freely due to the STR condition in region IV.Thism eans that the lm is transparent to two di erently spin-polarized electron beam s under the same STR condition. W hen we have the STR condition for both

In s, $\mathbb{T}_{\#} = \mathbb{T}_{\#}$ as well as $\mathbb{T}_{\#}^{0} = \mathbb{T}_{\#}^{0}$ and $\mathbb{R} = \mathbb{R}^{0} = 0$ as expected.

The other interesting limit results in the MESE. In this case the coupling between moments is very large, and antiferrom agnetic. We nd $T_n^0 = T_{\#}^0$ so that the net spin transfer is zero because the spin state in region V is the same as that of the incoming electrons. It is in this sense that the MESE is similar to the STR for both

In s. However, if the two $\ln s$ also satisfy the STR condition, then the moments no longer rotate in response to the spin current, so the result is more properly thought of as an STR, occurring twice, once in each \ln . In all cases we have discussed so far the ux is conserved in each region while the spin current is not because the spin torque acting on the magnetic moment in region II(IV) is equivalent to the spin current di erence between region I and III (and between III and V). The net spin torque acting on the multilayer system is the spin current di erence between region I and V. Later, we will describe the dynam ics of the magnetic moments in term of the spin current.

The equations of motion of the two magnetic moments M $_{\rm 1}$ and M $_{\rm 2}$ are

Note that di erent wave functions are used to evaluate the spin expectation values for the equations of the moments. We use dimensionless units as in Ref. [12], where m_i = M_i=M₀ and the time is = jt, where $j_0 = N_e L_{00} = (m S_{local})$ is the one-dimensional current with the number of incoming electrons N_e per unit length and S_{local} = M₀= $_0$. In these units, the coupling constant due to the magnetic dipole interaction becomes

= (S $_{\rm local} = 2N \,_{e}L_{\,00}\,)J_{\rm M}$ =J $_{\rm H}$. Now the equations of motion form $_{\rm i}$ become




FIG.2: (Color online) The time evolution of the magnetic moments (solid curves) and the spin torque (dashed curves) on the moments for = 5=4, $L_1 = 2.6L_{00}$, $L_2 = 2.4L_{00}$, and $d = L_{00}$. No magnetic dipole interaction is included (= 0). The initial value of the moments is $m_1 = m_2 = (0;1;0)$. The spin torque on m_{1z} is $N_{1zx} = Q_{1jzx}$ Q_{111jzx} and the torque on m_{2z} is $N_{2zx} = Q_{111jzx}$ Q_{vjzx}

with $C_1 = A e^{ik \cdot x} + B e^{ik \cdot x}$, $C_2 = A^0 e^{ik \cdot x} + B^0 e^{ik \cdot x}$. The integration range for $_i$ and $_i$ is given by the thickness of the corresponding ferrom agnetic lm.

As we mentioned earlier, another way to understand the dynam ics is using the spin current tensor;

where s = 1=2 is the electron spin. The spin current in a particular region can be calculated using the wave function in the region. The time evolution of the magnetic m om ent is governed by the spin torque which is the net spin ux absorbed by the moment [9]. For example, the time evolution of m $_{1z}$ and m $_{2z}$ is determined by N $_{1zx}$ and N_{2zx} , respectively, where $N_{1zx} = Q_{1;zx}$ Q_{III};zx and $N_{2zx} = Q_{III;zx}$ $Q_{V;zx}$. For a wave function a_1 b_1 e^{ikx} + e ^{ikx}, the spin current beji= com es

The components a_i and b_i are given by the wave functions in the regions I, III, and V; namely, a_i (b_i) is the forward-moving (backward-moving) component, respectively. For example, in region III, $a_1 = T$ $\frac{1}{2}$, $\frac{1}{2}$, $a_2 = {P \atop P}$ Th j ih j+i, $b_1 = {P \atop R^0}$ R⁰ j+ j if, and $b_2 = {R^0}$ h j ih j+i.

We solved Eq. (4) for a typical case with = 5=4, $L_1=L_{00} = 2:6$, $L_2=L_{00} = 2:4$, and $d=L_{00} = 1$. The magnetic dipole interaction is set to zero (= 0) but a small interaction (j j < 1) gives a similar result. The initial direction of $m_1 = (0;1;0)$ and $m_2 = (0; 1;0)$. In Fig.2, we plot m_{1z} and m_{2z} as the solid curves with the corresponding labels. Based on the single layer analogy, one could expect that m_1 and m_2 end up aligning with the electron spin current along the Z direction. The behavior of m_1 does follow this naive expectation except for a dip near = 22, How ever, the initial dynam ics of m_2 is unexpected; the m agnetic m om ent initially acquires a m om ent in the negative Z direction, anti-parallel to the incom ing spin current.

W e also plot the spin torque acting on the m om ents as dashed curves with labels. The behavior of the torques explains the dynam ics of the m agnetic m om ents. M ostly a positive spin torque is applied to m_1 so that it aligns along the Z direction m ore or less m onotonically (there is a sm all dip in the torque which corresponds to the dip in the m_{1z} curve m entioned above). On the other hand m_2 m oves below the XY plane due to a negative torque up to = 8. Then a positive torque begins acting on m_2 until the m agnetic m om ent aligns to the Z direction.




FIG. 3: (Color online) The time evolution of m_{1z} and m_{2z} (solid curves) for MESE with = 500, = 15, L₁ = 2L₀₀, L₂ = 2L₀₀, and d = L₀₀. The dashed line is the spin current in region I and V while the dashed curve is the spin current in region III_p The initial value of the moments is m₁ = m₂ = (1 = 3; 1 = 3; 1 = 3).

A second case is one in which a strong magnetic dipole interaction exists between the two lm s: M E SE. In Fig. 3, we plot the numerical results for = 500,

= 15, $L_1=L_{00} = L_2=L_{00} = 2$, and $d=L_{00} = 1$. We use a large energy for the incoming electron to ensure the applicability of the adiabatic approximation. The solid oscillatory curves with labels are the tim e evolution of the magnetic moments. The dashed line is the spin current in region I and V while the dashed (oscillatory) curve is the spin current in region III. For the MESE, the spin torque is not completely equivalent to the spin current di erence because the magnetic dipole interaction also contributes to the torque. Nevertheless, the spin current still provides useful inform ation for the dynam ics of the moments. As shown in Fig. 3, Q_{I;zx} Q_{III;zx} is positive. This indicates that the spin current is absorbed by m 1.0 n the other hand, Q III;zx Q V;zx is negative but $\mathfrak{V}_{III;zx}$ $\mathfrak{Q}_{V;zx} \mathbf{j} = \mathfrak{V}_{I;zx}$ $\mathfrak{Q}_{III;zx} \mathbf{j}$. Consequently, the exactly same value of the spin current is generated by m $_2$ because of the time reversal symmetry between the two m om ents. This is why e ectively zero spin is transferred for the M E SE.

A s discussed in R ef. [13], the thickness of the two lm s should be the same. B rata et al. estimated the e ect of the thickness m ism atch. We quantify this e ect by calculating $(Q_{I,zx} \quad Q_{V,zx})=Q_{I,zx}$ for given parameters. For the same parameters except for = 10, we found that a 2% m ism atch $(L_2=L_{00} = 2.04)$ gives 0.3% of the spin transfer on the time scale of Fig. 3 (= 20) while a 5% m ism atch yields 1:7% of the spin transfer on this

time scale. A longer time scale of course leads to more spin transfer. We also found that the spin transfer is insensitive to (for large values), and that if is increased, the spin transfer is decreased for the same time scale.

In sum m ary we have studied quantum m echanical aspects of the spin transfer to ferrom agnetic bilayers. Our form ulation is readily generalized to multilayers. The physics of the spin transfer in the multilayers is generically di erent from that of a single layer. We demonstrated novel quantum m echanical features which can occur only in the multilayer system such as negative spin torque and m agnetoelectric spin echo (M E SE). The spin transm ission resonance (STR) in a multilayer is also illustrated. Our calculation reveals new channels through which the zero spin transfer occurs in multilayers: the STR and M E SE. In spite of irregularities in realm aterials, we expect to see some of the qualitative features described here.
