Optically induced spin polarization of an electric current through a quantum dot

A bstract

We exam ine electron transport through sem iconductor quantum dot subject to a continuous circularly polarized optical irradiation resonant to the electron – heavy hole transition. Electrons having certain spin polarization experience Rabi oscillation and their energy levels are shifted by the Rabi frequency. Correspondingly, the equilibrium chemical potential of the leads and the lead-to-lead bias voltage can be adjusted so only electrons with spin-up polarization or only electrons with spin-down polarization contribute to the current. The temperature dependence of the spin polarization of the current is also discussed.

Recently, spin electronics, so-called spintronics, has become a focal point of intense research interest (see, for example, review [1] and references therein). Electronic devices employing the additional spin degree of freedom, as well as purely spin-based devices, can increase the speed of performance, consume less power, and provide novel modes of operation in comparison with conventional counterparts. Creation, control, and transmission of spin polarization constitute the principal tasks of spintronics. To polarize electron and nuclear spins, one can apply, for example, an external magnetic eld (or put spin particles in contact with ferromagnetic materials) [2, 3]. Other possibilities for creation of the spin polarization include optical orientation of electron spins by a circularly polarized light [4] and polarized spin injection from the ferromagnetic/normal semiconductor junction [5].

In the present paper we propose to combine the optical spin polarization technique with electron transport through sem iconductor quantum dots to produce a spin polarization of the electron current. C reating electron-hole pair with an electron having certain spin projection, we prevent the tunneling of electrons with the same spin projection to the quantum dot, breaking the spin symmetry of the current. Electron spin polarization in the dot can be achieved by the circular polarized light. In particular, the photons with the positive helicity create heavy holes with spin 3/2 and electrons with spin -1/2, whereas the photons having negative helicity create heavy holes with spin -3/2 and electrons with spin 1/2. For the self-assembled quantum dots (for example, InGaAs/GaAs), the lattice mismatch leads to the rem oval of the degeneracy between heavy and light hole energy levels, and the electronheavy hole pairs can be created resonantly. Under resonant continuous optical irradiation, electron-hole pairs (with certain electron spin projection) exhibit Rabioscillations [6], and the energy level for the electrons having this spin projection is shifted by $_{R}$, where $_{R}$ is the Rabi frequency. We show that in this case the conductance peaks occur not when the chem ical potential of the leads is in the resonance with the energy of the quantum dot level, E_c , but when it is in the resonance with the energy E_c R (h = 1). However, for electrons having the spin projection which is not a ected by the light, the conductance peak position rem ains the same. A coordingly, for appropriate values of the Rabi frequency, the equilibrium chem ical potential of the leads, and the lead-to-lead voltage bias, the spin polarization of the electron current through the quantum dot can be achieved and, moreover, the direction of the polarization can be controlled by these param eters.

We exam ine a self-assembled InG aAs/GaAs sem iconductor quantum dotwhich is electri-

cally coupled to two leads (sim ilar structure was exam ined experimentally, for example, in Ref. [7]) and is subject to a continuous circularly polarized light having frequency resonant to the electron-heavy hole transition and negative helicity. In this case, photons create an electron-hole pairs in the dot with electrons and holes having spin projections 1/2 and -3/2, respectively. Electrons with both spin projections can tunnel from the leads to the dot with spin-independent tunneling rates, whereas the hole tunneling is assumed to be suppressed.

The Hamiltonian of the system has the form

For the resonant electrom agnetic eld with the frequency $!_0 = E_c + E_v$, the rotating wave approximation (RWA) can be applied and, accordingly, F (t) $e^{i(E_c + E_v)t}$, F; F (t) $e^{i(E_c + E_v)t}$, F: Correspondingly, the equation for the amplitude A₁ has the form

The response of the leads is described by the relation [8]

are the G reen functions of electrons in the leads, (t t_1) is the unit H eaviside function, and f (E) = $\exp \frac{E}{T} + 1$ is the Fermi distribution with temperature T. Here, L = + eV = 2 and R = eV = 2; where is the equilibrium chemical potential of the leads and V is the voltage bias applied to the leads.

Substituting Eq. (5) into Eq. (4), we obtain

The electron current through the quantum dot is given by

It should be noted that the total current has two components, I_1 with spin projection + 1/2 and I_2 with spin projection -1/2. Substituting Eq.(5) into Eq. (11), we obtain


- Figure 1. Zero-tem perature conductances for the electrons having di erent spin projections as a function of the equilibrium chem ical potential of the leads.

where we assume symmetric coupling to the leads with $= L_{\rm eR} = L_{\rm eR} (! =)$: This resonant behavior is illustrated by Figure 1 for the Rabi frequency $_{\rm R} = 2$. One can see from this gure that the conductance peaks for the electrons having spin projection 1/2 (a ected by the optical irradiation) are shifted from the equilibrium resonant condition $(=E_{\rm c})$ by $_{\rm R}$. Furthermore, it is evident that with variation such parameters as the equilibrium chemical potential of the leads, the Rabi frequency, and the lead-to-lead voltage bias, regimes with dierent spin polarization of the current through the quantum dot can be achieved.

To describe the spin polarization of the current and its dependence on the system parameters, we introduce the polarization coe cient as

The lead-to-lead voltage dependencies of the total current and the polarization coe cient are shown in Figure 2 for $E_c=5$, $_R=20$, and T=0.43. It is evident from this gure that there are several steps in the current-voltage characteristics. The rst one occurs when the chemical potential of the right lead, $_R=-eV=2$, passes through the electron level with the energy E_c and this level becomes conductive. The electrons in this level have spin projection -1/2 and the current is strongly polarized. The second step corresponds to the voltage at which the chemical potential of the left lead, $_L=-+eV=2$, passes through the electron level with the energy E_c+_R and electrons from this level having spin projection +1/2 start to contribute to the current. Accordingly, current becomes only partially polarized. Finally, the third step occurs when the chemical potential of the right lead passes through the electron level with the energy E_c-_R and the spin polarization of the current is fully compensated.

The tem perature dependence of the polarization coe cient is presented in Figure 3 for small applied lead-to-lead bias and two values of the equilibrium them ical potential of the leads associated with the resonances with electron levels having dierent spin polarization. One can see in this Figure that at tem peratures comparable to the Rabi frequency, the spin polarization of the current vanishes.

Finally, we consider the conditions necessary to observe the calculated e ects in experim ent. If we assume the lead-dot coupling constant to be = 20 eV, than $_{\rm R}$ = 20 = 400 eV, which corresponds to the excitation density of 350kW =cm 2 , and temperature used for Figure 2 is T = 0:43 = 100m K.

In conclusion, we have shown that the spin polarization of the electron current through the quantum dot can be achieved, if the dot is irradiated continuously by the resonant circularly polarized light. In this case electron-hole pairs with electrons having certain spin polarization experience Rabi oscillations and the energetic level of these electrons is shifted by $_{\rm R}$. With appropriate choice of the equilibrium chemical potential of the leads and the lead-to-lead bias voltage, the current through the dot is spin-polarized and the direction of this polarization can be controlled.




