### Self-focusing magnetostatic beams in thin magnetic Ims

The possibility of generation of stable self-focusing beams in in-plane magnetized thin magnetic In s is considered and theoretical conditions for the existence of such localized solutions are discussed. It is shown that for the de nite direction between static magnetizing eld and preferential direction of radiation from microwave antenna the problem reduces to the one-dimensional nonlinear Schrodinger equation. For such angles it is possible to generate stable self-focusing beams. Particular values of beam width and propagation angles versus magnitude of magnetizing eld are calculated in order to suggest the realistic experimental setup for the observation of discovered e ect.

#### I. IN TRODUCTION

Observations of magnetostatic solitons in thin magnetic Im s together with experim ents in nonlinear optics are major testing grounds for the nowadays advances in nonlinear physics. In full accordance with theoretical predictions<sup>1</sup> m agnetostatic bright envelope solitons have been observed in both in-plane2,3,4,5 and perpendicularly magnetized<sup>6,7,8</sup> quasi-one-dimensionalyttrium iron gamet thin lm s (m agnetic waveguides). On the other hand, as expected, dark surface wave magnetostatic solitons have been observed only in in-plane m agnetized  $\ln s^{9,10,11}$ . M oreover, in full analogy with light bullets in nonlinear optics<sup>12,13</sup> spin-wavem etastable bullets have been found in wide magnetic lm s<sup>14,15</sup>. The only dierence between nonlinear processes in magnetic Ims and optical devices is that self-focusing m agm etostatic beam s are unstable at relatively long distances unlike their opticalanalogies. In particular, in case of magnetic Im s the focusing into one spatial point takes place in stationary regim e<sup>16</sup>. This is explained by the fact that longitudinal dispersion could not be neglected in magnetic lms. In the present paper it is shown that even that gap could be lled considering in-plane magnetized lm swhere carrier wave vector is not either parallel or perpendicular to the static magnetic eld direction. The conditions when stationary and stable self-focusing m agnetostatic beam s can be observed in wide magnetic Im s are found.

A lthough the linearized spin-wave solutions are well known for arbitrary directions between wave vector and magnetizing  $eld^{18,19}$ , the nonlinear situation has been studied only for the cases when carrier wave vector is either parallel or perpendicular to the magnetizing eld direction<sup>1,2,3,4,5,6,7,8,9,10,11,14,15,16</sup> (one exception is Ref.<sup>20</sup> where magnetized eld is tilted from the lm normal in order to control the nonlinear coe cient, but this study does not pertain to the present consideration). O nly very recently the nonlinear e ects characterizing general case has been investigated<sup>21</sup> and soliton solutions have been found for the angles between wave vector and magnetic eld other than 0 or 90 degrees. How ever, such solutions are stable only in quasi-one-dimensional case and they become unstable considering wide sam – ples. As it will be shown below in two dimensional case only self-focusing beam solutions are stable. Note that bullet like solutions are metastable and they decay after either edge re ection or interaction with other moving localization<sup>14,15</sup> (metastability takes place due to the compensation of instability by dissipation).

It should be especially m entioned that the wave processes are easily accessible from the surface by variety of the m ethods such as inductive probes<sup>22</sup>, therm o-optical m ethods<sup>23</sup> and recently developed m ethod of space and time resolved B rillouin light scattering<sup>24</sup>. Therefore it does not seem problem atic to detect nonlinear localizations predicted in this paper.

### II. PROBLEM GEOMETRY AND REDUCTION TO 1D NLS

For arbitrary direction of the carrier wave vector  $\tilde{k}$  with respect to a static magnetic eld H the problem of nonlinear wave process (magnetostatic and Landau-Lifshitz equations) in in-plane magnetized thin lm reduces to the following nonlinear equation for the wave envelope u (see e.g. Ref.<sup>21</sup>):

where r stands for the radius vector lying in the sample plane yz, x is a coordinate along the direction perpendicular to the lm, and z is a direction of static m agnetic eld;  $v_y$  and  $v_z$  are the components of group velocity and they could be calculated from the linearized dispersion relation (but see below) v = (0! = 0k; !) and k are carrier frequency and wave vector of m agnetostatic spin wave;  $!^{(0)} = 0k (k) (indexes)$  and take the values y and z). u is a complex envelope of relative m agnetization vector  $m = M = M_0 (M_0)$  is a static m agnetization along z coinciding with the direction of m agnetizing eld):

The above expressions (2) have been derived^{21} in the lim it kd 1 (d is a lm thickness) and this condition will be used further in this paper in order to sim plify analytical calculations. Then the dispersion relation could be expressed as expansion over sm all param eter kd and keeping only the term s up to the second order of this param eter the following expression is obtained^{21}: \end{array}$

The phenom enological dissipation parameter !<sub>r</sub> in (1) is weak, but it plays in portant role in stabilization of localized solutions (see e.g. Ref.<sup>16</sup>) and nally, the nonlinear coe cient N in case of in-plane magnetized lms is always negative and reads as follows<sup>1</sup> N = !<sub>H</sub> !<sub>M</sub> =4!<sub>0</sub>.




FIG.1: Geometry of the problem in case of stationary selffocusing beam . a) O mentations of wave vector K, static m agnetic eld H, group velocity v and diagonalizing frame of references . Thin line indicates the direction of the beam . b) The possible experimental setup for observation of stable m agnetostatic self-focusing beam . indicates an angle between static m agnetizing eld and preferential radiation direction of antenna (see also Figs. 5a and 6b in Ref.<sup>16</sup>).

In order to vanish the nondiagonal term with  $\cos - \operatorname{cient} !_{yz}^{00}$  in Eq. (1) a new frame of references should be introduced (see Fig. 1a). Let us rotate the frame of references yz by the angle # de ned from the following relation:  $\tan (2\#) = 2!_{yz}^{00} = (!_{zz}^{00} \quad !_{yy}^{00})$ . Then from (1) (2+1) dimensional (two spatial and one tem poral dimensions) nonlinear Schrodinger (NLS) equation is obtained:

which reduces to the standard form (without rst spatial derivatives) after introducing the following coordinate transform (moving frame) ! vt and ! vt. In Eq. (4) coe cients R and S are dispersion and di raction coe cients, respectively, explicit form of which are given in Ref.<sup>21</sup> and v and v are group velocity com ponents with respect to new reference frame . U sually in isotropic systems transversal component of group velocity v is equal to zero (the same happens in case of nonlinear magnetostatic waves when carrier wave vector is either parallel or perpendicular to a static magnetic  $eld^{1,2}$ ). But in general for anisotropic system s v is not equal to zero.

As well known (2+1) NLS equation does not perm it<sup>25,26</sup> stable localized solutions irrespective to the relative sign of the coe cients S, R and N. Only the m etastable bullet like localizations appear<sup>12,13,14,15</sup> due to the compensation of wave instability by the dissipation. However, in restricted geom etries (waveguides) transverse instabilities do not develop and di raction term could be neglected allow ing thus reduction to (1+1) NLS equation. Such geom etries have been used in order

to observe solitons in optical bers and magnetic lm waveguides.

Another possibility to see localized solution is the absence of dispersion term R = 0. Such a situation is realized in nonlinear optics where dispersion is negligible in comparison with the diraction. In this case spatial soliton solution (self-focusing beam) is stable  $1^7$ . How ever, in case of magnetic Im s dispersion coe cient could not be neglected and beam like solutions have not been observed in the experim ental conditions considered till now . In the present paper it is suggested the experim ental setup where the angle between carrier wave vector and magnetizing eld gets the value for which dispersion coe cient is nearly zero (R ' 0). As far as all the coefcients of (2+1) NLS equation (4) are de ned from the dispersion relation (4), they could be expressed as functions of wave number k and the angle  $\cdot$ . Particularly, in the lim it of small k (kd ! 0) dispersion coe cient R does not depend on k. Therefore the problem is reduced to nding such which makes R equal to zero for given static eld and sam ple param eters. A s num erical sim ulations show, for each magnitude of static magnetic eld it is possible to nd such an angle.

A ctually it is not necessary to have such -s for which R is exactly zero. One can neglect the role of dispersion in form ation of nonlinear wave if the following inequality holds R  $!_r=k^2$ , i.e. the wave dissipates faster than dispersion e ects take place. Sim ilarly one can neglect higher order dispersion term s in comparison with dissipation as far as they are proportional to the factor  $(kd)^3$  (kd 1 in this paper). At the same time the diraction term in my calculations is much larger than dissipation one. Thus only the diraction and nonlinearity determine the dynamics of nonlinear wave and reduction to (1+1) NLS equation is justified.

# III. STAT IONARY SELF FOCUSING BEAM SOLUTION

Considering standard stationary situation @=@t = 0and using coordinate transform ! (v=v) in case of close to zero dispersion (R ' 0) Eq. (4) reduces to (1+1) NLS equation ( plays a role of the time) with stable spatial soliton solutions. For instance one soliton solution could be presented analytically as follow s:

corresponding to the self-focusing beam along the direction of group velocity  $\mathbf{v}$ . Here beam width is de ned as follow s:

Note that the amplitude  $j_{ijn}$  ax decays and beam width increases with distance taking into account the weak dissipation e ects.




FIG.2: Range of angles for which self-focusing beam regime could be realized. (dashed borders) stands for the angle range between carrier wavevector and static magnetic eld, while (solid line) is a corresponding angle between direction of group velocity and static magnetic eld.

K nowing angles for which the dispersion e ect could be neglected, it is easy to calculate di raction coe cient S and group velocity  $\mathbf{v}$ . Then the angle between  $\mathbf{v}$ and axis z for that particular values of angles could be found. The observation of stationary self-focusing is possible only for the mentioned radiation direction. In Fig. 2 the dependences of angles and versus static magnetic eld are presented.

### IV. DISCUSSION OF POSSIBLE EXPERIMENTAL SETUP

The following values for the imparameters are used in the calculations: Im thickness d = 5 m; dem agnetizing eld  $H_M = !_M = g = 1750 \text{ O} e$  and dissipation parameter is taken  $!_r = 5 \quad 10^{\circ} \text{ s}^{-1}$  as in Ref.<sup>16</sup>. As it is discussed above the beam self-focusing process is realized if dispersion e ects could be neglected, i.e. if the following inequality is satis ed R  $!_r = k^2$ . The calculations are




FIG.3: Self focusing beam width versus detuning of the carrier frequency  $! = !_0$  ! and static magnetic eld. Inset shows the projection of the plot on the horizontal plane where the lled area indicates considered range. static magnetic eld is restricted by the boundaries  $0.3!_{\rm M} < !_{\rm H} < 2.37!_{\rm M}$  (see the text), while the upper limit corresponds to the condition kd < 0.1. The following parameters are used for the calculations: relative amplitude of the beam  $j_1j_{\rm hax} = 0.1$ ; Im thickness d = 5 m and dem agnetizing eld H  $_{\rm M} = 17500$  e.

m ade for carrier wave number k = 50 cm<sup>-1</sup>. In Fig. 2 the angle range between K and static magnetic eld is presented for which the above inequality holds (dispersion e ects could be neglected) and, besides that, the range of angles corresponds to the single direction of group velocity. As seen for the values of static magnetic eld H<sub>0</sub> > 25000 e alm ost the same direction of group velocity corresponds to the wide range of validity of beam

generation regime. That direction must coincide with a preferential direction of magnetostatic wave radiation from short antenna or point like source. The ways to vary experimentally the preferential direction of radiation in linear regime has been suggested in Ref.<sup>16</sup> and now we suggest here to use the sam e m ethod in nonlinear regim e in order to observe self-focusing beams. Thus the antenna should be oriented by such a way that the angle between its preferential direction of radiation and static magnetic eld coincides with the derived angles for beam group velocity (angles in Figs. 1 and 2). It should be mentioned that as calculations show in the considered lim it kd ! 0 the required angles between radiation direction and static magnetic eld do not depend on k jand consequently on the carrier frequency ! of the excitation (note that this happens when dispersion coe cient R is negligible). While the diraction coe cient S and as a result beam swidth is inverse proportional to kd.

In Fig. 3 three dimensional plot of beam width versus detuning of carrier frequency  $! = !_0 !$  and m agnitude of static magnetic eld is presented. M agnetic eld varies within the boundaries  $0.3!_M < !_H < 2.37!_M$

where the lower boundary appears from the requirement that three m agnon processes should not take place<sup>1</sup> (otherwise the localizations will decay rapidly), while above a upper limit the di raction coe cient S becomes negative and consequently according to the Lighthill criterion<sup>27</sup> self-focusing process does not take place.

## V. CONCLUSIONS

Concluding it could be stated that the conditions for the observation of stationary self-focusing beam s in m agnetic lm s are found. It is suggested that such localizations could be observed along preferential direction of antenna's radiation.
