## N eural N etw orks P rocessing M ean Values of R andom Variables

W e introduce a class of neural networks derived from probabilistic models in the form of B ayesian belief networks. By imposing additional assumptions about the nature of the probabilistic models represented in the belief networks, we derive neural networks with standard dynamics that require no training to determ ine the synaptic weights, that can pool multiple sources of evidence, and that deal cleanly and consistently with inconsistent or contradictory evidence. The presented neural networks capture m any properties of B ayesian belief networks, providing distributed versions of probabilistic models.

### I. IN TRODUCTION

Strong feedforward, feedback, and lateral connections exist between distinct areas of the cerebral cortex, but such connections are not observed in cerebellar, sensory, or m otor output circuits. The anatom ical structure of the cerebral cortex m ay facilitate a m odular approach to solving com plex problems [1], with di erent cortical areas being specialized for di erent inform ation processing tasks. To perm it a m odular strategy of this sort, coordinated and e cient routing of inform ation m ust be m aintained between m odules, which in turn dem ands extensive connections throughout the cortex.

It has been proposed [2] that cortical circuits perform statistical inference, encoding and processing inform ation about analog variables in the form of probability density functions (PDFs). This hypothesis provides a theoretical fram ew ork for understanding diverse results of neurobiological experiments, and a practical fram ew ork for the construction of recurrent neural network m odels that im – plement a broad variety of information-processing functions [3, 4, 5].

P robabilistic form ulations of neural inform ation processing have been explored along a number of avenues. O ne of the earliest such analyses showed that the original Hop eld neural network in plements, in e ect, Bayesian inference on analog quantities in terms of PDFs [6]. As in the present work, Zem el et al. [7] have investigated population coding of probability distributions, but with di erent representations and dynam ics than those we will consider here. Several extensions of this representation scheme have been developed [8, 9, 10] that feature information propagation between interacting neural populations. Additionally, several \stochastic machines" [11] have been formulated, including Boltzm ann machines [12], sigm oid belief networks [13], and Helm holtz machines [14]. Stochastic machines are built of stochastic neurons that occupy one of two possible states in a probabilistic manner. Learning rules for stochastic machines enable such system s to model the underlying probability distribution of a given data set.

The putative m odular nature of cortical processing ts well in such a probabilistic fram ework. Cortical areas collectively represent the joint PDF over several variables. These neural \problem -solving m odules" can be m apped in a relatively direct fashion onto the nodes of a B ayesian belief network, giving rise to a class of neural network network m odels that we have term ed neural belief networks [3, 15].

In contrast, recent work based on population-tem poral coding [4, 5] indicates that the modeling of low-level sensory processing and output motor control do not require such a sophisticated representation: manipulation of mean values instead of PDFs is generally su cient. Further, the representations can be simplied to deal with vector spaces describing the mean values instead of function spaces describing the probability density functions.

In this work, we develop neural networks processing m ean values of analog variables as a specialized form of the m ore general neural belief networks. We begin with a brief sum m ary of the key relevant properties of B ayesian belief networks in section II. We describe a procedure for generating and evaluating the neural networks in section III, and apply the procedure to several examples in section IV.

## II. BAYESIAN BELIEF NETW ORKS

Bayesian belief networks [16, 17] are directed acyclic graphs that represent probabilistic models (Fig. 1). Each

node represents a random variable, and the arcs signify the presence of direct causal in uences between the linked variables. The strengths of these in uences are de ned using conditional probabilities. The direction of a particular link indicates the direction of causality (or, m ore simply, relevance); an arc points from cause to e ect.

Multiple sources of evidence about the random variables are conveniently handled using BBNs. The belief, or degree of con dence, in particular values of the random variables is determ ined as the likelihood of the value given evidentiary support provided to the network. There are two types of support that arise from the evidence: predictive support, which propagates from cause to e ect along the direction of the arc, and retrospective support, which propagates from e ect to cause, opposite to the direction of the arc.

B ayesian belief networks have two properties that we will nd very useful, both of which stem from the dependence relations shown by the graph structure. First, the value of a node X is not dependent upon all of the other graph nodes. R ather, it depends only on a subset of the nodes, called a M arkov blanket of X, that separates node X from all the other nodes in the graph. The M arkov blanket of interest to us is readily determ ined from the graph structure. It is com prised of the union of the direct parents of X, the direct successors of X. Second, the joint probability over the random variables is decom posable as

$$P(x_1;x_2;:::;x_n) = P(x jPa(x)); (1)$$

where Pa(x) denotes the (possibly empty) set of directparent nodes of X. This decomposition comes about from repeated application of Bayes' rule and from the structure of the graph.

# III. M EAN -VALUE NEURAL BELIEF NETW ORKS

We will develop neural networks from the set of marginal distributions f (x;t)g so as to best match a desired probabilistic model (x<sub>1</sub>;x<sub>2</sub>;:::;x<sub>D</sub>) over the set of random variables, which are organized as a BBN. One or more of the variables x must be specified as evidence in the BBN. To facilitate the development of general update rules, we do not distinguish between evidence and non-evidence nodes in our notation.

O urgeneral approach will be to m in in ize the di erence between a probabilistic model  $(x_1;x_2;\ldots;x_D)$  and an estim ate of the probabilistic model  $(x_1;x_2;\ldots;x_D)$ . For the estim ate, we utilize

This is a so-called naive estimate, wherein the random variables are assumed to be independent. We will place

further constraints on the probabilistic model and representation to produce neural networks with the desired dynamics.

The rst assumption we make is that the populations of neurons only need to accurately encode the mean values of the random variables, rather than the complete PDFs. We take the ring rates of the neurons representing a given random variable X to be functions of the mean value x (t) (Fig. 2)

where  $A_i$  and  $B_i$  are parameters describing the response properties of neuron i of the population representing random variable X . The activation function g is in general nonlinear; in this work, we take g to be the logistic function,

W e can make use of (3) to directly encode mean values into neural activation states, providing a means to specify the value of the evidence nodes in the NBN.

U sing (3), we derive an update rule describing the neuronal dynamics, obtaining (to rst order in )

Thus, if we can determ ine how x changes with time, we can directly determ ine how the neural activation states change with time.

The mean value x (t) can be determined from the ring rates as the expectation value of the random variable X with respect to a PDF (x;t) represented in terms of som e decoding functions f<sub>i</sub> (x) g The PDF is recovered using the relation

The decoding functions are constructed so as to m inim ize the di erence between the assumed and reconstructed PDFs (discussed in detail in [3]).

W ith representations as given in (6), we have

where we have de ned

A lthough we used the decoding functions  $_{\rm i}$  (x ) to calculate the parameters  ${\rm x_i}$ , they can in practice be found directly so that the relations in (3) and (7) are mutually consistent.

We take the PDFs (x ;t) to be normally distributed with the form (x ;t) (x ;x (t)) = N (x ;x (t);  $\frac{2}{x}$ ). Intuitively, we might expect that the variance  $\frac{2}{x}$  should be small so that the mean value is coded precisely, but we will see that the variances have no signi cance in the resulting neural networks.

The second assumption we make is that interactions between the nodes are linear:

$$\mathbf{x} = \mathbf{K} \mathbf{x} : \tag{9}$$

U tilizing the causality relations given by the B ayesian beliefnetwork, we require that K  $\notin$  0 only if X is a child node of X in the network graph. To represent the linear interactions as a probabilistic m odel, we take the norm al distributions (x jPa(x)) = N (x ; K x ; <sup>2</sup>) for the conditional probabilities.

For nodes in the BBN which have no parents, the conditional probability (x jPa(x)) is just the prior probability distribution (x). We utilize the same rule to de ne the prior probabilities as to de ne the conditional probabilities. For parentless nodes, the prior is thus norm ally distributed with zero m ean, (x) = N (x;0;<sup>2</sup>).

We use the relative entropy [18] as a measure of the \distance" between the joint distribution describing the probabilistic model (x<sub>1</sub>;x<sub>2</sub>;:::;x<sub>D</sub>) and the PDF estimated from the neural network ^(x<sub>1</sub>;x<sub>2</sub>;:::;x<sub>D</sub>). Thus, we minimize

with respect to the mean values  ${\bf x}$  . By making use of the gradient descent prescription

$$\frac{\mathrm{d}x}{\mathrm{d}t} = \frac{\mathrm{@E}}{\mathrm{@x}} \tag{11}$$

and the decomposition property for BBNs given by (1), we obtain the update rule for the mean values,

$$\frac{dx}{dt} = \frac{1}{2} \begin{pmatrix} 0 & X \\ K & X & X \end{pmatrix}$$

Because the coupling parameters K are nonzero only when X is a parent of X, generally only a subset of the m ean values contributes to updating x in (12). In terms of the belief network graph structure, the only contributing values come from the parents of X, the children of X, and the parents of the children of X; this is identical to the M arkov blanket discussed in section II.

The update rule for the neural activities is obtained by combining (5), (7), and (12), resulting in

The quantity  $\int_{j}^{r} S_{ij}a_{j}(t) + B_{i}$  serves to stabilize the activities of the neurons representing (x) (similar to neural integrator models [3, 5, 19]), while

drives changes in  ${\rm a_i}$  (t) based on the PDFs represented by other nodes of the BBN . The synaptic weights of the neural network are

The foregoing provides an algorithm for generating and evaluating neural networks that process mean values of random variables. To sum marize,

- 1. Establish independence relations between model variables. This may be accomplished by using a graph to organize the variables.
- 2. Specify the K to quantify the relations between the variables.
- 3. A ssign network inputs by encoding desired values into neural activities using (3).
- 4. Update other neural activities using (12).
- 5. Extract the expectation values of the variables from the neural activities using (7).

#### ${\tt IV}$ . A P P L IC A T IO N S




FIG.1: A Bayesian belief network. Evidence about any of the random variables in uences the likelihood of, or belief in, the remaining random variables. In a straightforward term inology, the node at the tail of an arrow is a parent of the child node at the head of the arrow, e.g.  $X_4$  is a parent of  $X_5$  and a child of both  $X_2$  and  $X_3$ . From the structure of the graph, we can see the conditional independence relations in the probabilistic model. For example,  $X_5$  is independent of  $X_1$  and  $X_2$  given  $X_3$  and  $X_4$ .




FIG.2: The mean values of the random variables are encoded into the ring rates of populations of neurons. A population of twenty neurons with piecew ise-linear responses is associated with each random variable. The neuronal responses  $a_i$  are fully determined by a single input , which we interpret as the mean value of a PDF. The form of the neuronal transfer functions can be altered without a ecting the general result presented in this work.

As a rst example, we apply the algorithm to the BBN shown in Fig. 1, with ring rate proles as shown in Fig. 2. Specifying  $x_1 = 1=2$  and  $x_2 = 1=2$  as evidence, we nd an excellent m atch between the mean values calculated by the neural network and the directly calculated values for the remaining nodes (Table I).




FIG. 3: Sim pler BBNs. A lthough the underlying undirected graph structure is identical for these two networks, the direction of the causality relationships between the variables are reversed. The neural networks arising from the BBNs thus have di erent properties.

W e next focus on som e sim pler BBN s to highlight certain properties of the resulting neural networks (which will again utilize the ring rate pro les shown in Fig. 2). In Fig. 3, we present two BBN s that relate three random variables in di erent ways. The connection strengths are all taken to be unity in each graph, so that  $K_{21} = K_{23} = K_{12} = K_{13} = 1$ .

W ith the connection strengths so chosen, the two BBNs have straightforward interpretations. For the graph shown in Fig. 3a, X<sub>2</sub> represents the sum of X<sub>1</sub> and X<sub>3</sub>, while, for the graph shown in Fig. 3b, X<sub>2</sub> provides a value which is duplicated in X<sub>1</sub> and X<sub>3</sub>. The di erent graph structures yield di erent neural networks; in particular, nodes X<sub>1</sub> and X<sub>3</sub> have direct synaptic connections in the neural network based on the graph in Fig. 3b, Thus, specifying x<sub>1</sub> = 1=4 and x<sub>2</sub> = 1=4 for the rst network produces the expected result x<sub>3</sub> = 0.5000, but specifying x<sub>2</sub> = 1=4 in the second network produces x<sub>3</sub> = 0.2500 regardless of the value (if any) assigned to x<sub>1</sub>.

To further illustrate the neural network properties, we use the graph shown in Fig. 3b to process inconsistent evidence. Nodes X<sub>1</sub> and X<sub>3</sub> should copy the value in node X<sub>2</sub>, but we can specify any values we like as network inputs. For example, when we assign  $x_1 = 1=4$  and  $x_3 = 1=2$ , the neural network yields  $x_2 = 0.1250$  for the rem aining value. This is a typical and reasonable result, m atching the least-squares solution to the inconsistent problem .

# V. CONCLUSION

W e have introduced a class of neural networks that consistently m ix multiple sources of evidence. The networks are based on probabilistic models, represented in the graphical form of Bayesian belief networks, and function based on traditional neural network dynam ics (ie., a weighted sum of neural activation values passed through a nonlinear activation function). We constructed the networks by restricting the represented probabilistic models by introducing two auxiliary assumptions.

F irst, we assumed that only the mean values of the random variables need to be accurately represented, with higher order moments of the distribution being unim – portant. We introduced neural representations of relevant probability density functions consistent with this assumption. Second, we assumed that the random variables of the probabilistic model are linearly related to one another, and chose appropriate conditional probabilities to implement these linear relationships.

U sing the representations suggested by our auxiliary assumptions, we derived a set of update rules by minim izing the relative entropy of an assumed PDF with respect to the PDF decoded from the neural network. In a straightforward fashion, the optim ization procedure yields neural weights and dynam ics that im plement speci ed probabilistic relations, without the need for a training process.

The restricted class of neural belief networks investigated in this work captures many of the properties of both Bayesian belief networks and neural networks. In particular, multiple sources of evidence are consistently pooled based on local update rules, providing a distributed version of a probabilistic model.

TABLE I: The mean values decoded from the neural network closely match the values directly calculated from the linear relations. The coe cients for the linear combinations were random ly selected, with values K  $_{31} = 0.2163$ , K  $_{32} =$ 

0.8328, K  $_{42}$  = 0.0627, K  $_{43}$  = 0.1438, K  $_{53}$  = 0.5732, and K  $_{54}$  = 0.5955.
