# G eom etric theory of defects

#### Abstract

A description of dislocations and disclinations defects in term $s$ of $R$ iem ann $\{$ $C$ artan geom etry is given, w ith the curvature and torsion tensors being intenpreted as the surface densities of the Frank and Burgers vectors, respectively. A new free energy expression describing the static distribution of defects is presented, and equations of nonlinear elasticity theory are used to specify the coordinate system. A pplication of the Lorentz gauge leads to equations for the principal chiralSO (3)eld. In the defect-free case, the geom etric $m$ odel reduces to elasticity theory for the displacem ent vector eld and to a principalchiralSO (3)-eld m odelfor the spin structure. A s ilhustrated by the exam ple of a wedge dislocation, elasticity theory reproduces only the linear approxim ation of the geom etric theory of defects. It is show $n$ that the equations of asym $m$ etric elasticity theory for the $C$ osserat $m$ edia can also be naturally incorporated into the geom etric theory as the gauge conditions. A s an application of the theory, phonon scattering on a wedge dislocation is considered. $T$ he energy spectrum ofim purity in the eld of a wedge dislocation is also discussed.


## 1 Introduction

M any solids have a crystalline structure. H ow ever, ideal crystals are absent in nature, and $m$ ost of their physical properties, such as plasticity, $m$ elting, grow th, etc., are de ned by defects of the crystalline structure. Therefore, a study of defects is a topical scienti c question of im portance for applications in the rst place. A broad experim ental and theoretical investigations of defects in crystals started in the 1930s and continues now adays. At present, a fundam ental theory of defects is absent in spite of the existence of dozens ofm onographs and thousands of articles.

O ne of the $m$ ost prom ising approaches to the theory of defects is based on $R$ iem ann $\{$ C artan geom etry, which involves nontrivialm etric and torsion. In this approach, a crystal is considered as a continuous elastic $m$ edium $w$ ith a spin structure. If the displacem ent

[^0]vector eld is a sm ooth fiunction, then there are only elastic stresses corresponding to di eom onphism s of the Euclidean space. If the displacem ent vector eld has discontinuities, then we are saying that there are defects in the elastic structure. Defects in the elastic structure are called dislocations and lead to the appearance ofnontrivial geom etry. $P$ recisely, they correspond to a nonzero torsion tensor, equal to the surface density of the Burgers vector.

The idea to relate torsion to dislocations appeared in the 1950s [1 \{4]. This approach is still being successfully developed (note review s 5 \{11]), and is often called the gauge theory of dislocations. A sim ilar approach is also being developed in gravity [12]. It is interesting to note that E C artan introduced torsion in geom etry [13] having the analogy w th m echanics of elastic m edia in m ind.

The gauge approach to the theory of defects is being developed successfiully, and interesting results are being obtained in this way [14\{17]. W e note in this connection tw o respects in which the approach proposed below is essentially di erent. In the gauge m odels ofdislocations based on the translationalgroup or on the sem idirect product of the rotational group w ith translations, one usually chooses the distortion and displacem ent elds as independent variables. It is always possible to x the invariance under local translations such that the displacem ent eld becom es zero because it transform sby sim ple translation under the action of the translational group. In this sense, the displacem ent eld is the gauge param eter of localtranslations, and physicalobservables are independent of it in gauge-invariant m odels.
$T$ he other disadvantage of the gauge approach is the equations of equilibrium . E instein type equations are usually considered for distortion or vielbein, $w$ th the right hand side depending on the stress tensor. This appears unacceptable from the physical point of view because of the follow ing reason. C onsider, fre exam ple, one straight edge dislocation. In this case, the elastic stress eld di ers from zero everyw here. T hen the torsion tensor (or curvature) is also nontrivial in the whole space due to the equations of equilibrium . $T$ his is wrong from our point of view. Indeed, we can consider an arbitrary dom ain of $m$ edium outside the cutting surface and look at the creation process for an edge dislocation. The chosen dom ain was a part of the E uclidean space w ith identically zero torsion and curvature before the defect creation. It is clear that torsion and curvature rem ain zero because the process of dislocation form ation is a di eom onphism for the considered dom ain. In addition, the cutting surface $m$ ay be chosen arbitrary for the defect creation, leaving the dislocation axis unchanged. Then it follows that torsion and curvature m ust be zero everyw here except at the axis of dislocation. In other words, the elasticity stress tensor can not be the source ofdislocations. To avoid the apparent contradiction, we propose a radicalw ay out: we do not use the displacem ent eld as an independent variable at all. This does not $m$ ean that the displacem ent eld does not exist in real crystals. In the proposed approach, the displacem ent eld exists and can be com puted in those regions of $m$ edium that do not contain cores of dislocations. In this case, it satis es the equations of nonlinear elasticity theory.

The proposed geom etric approach allow s considering other defects that do not relate directly to defects of elastic $m$ edia.

T he intensive investigations of other defects were conducted in parallelw ith the study of dislocations. The point is that $m$ any solids have not only elastic properties but also a spin structure. For exam ple, there are ferrom agnets, liquid crystals, spin glasses. In this
case, there are defects in the spin structure which are called disclinations [18]. They arise when the director eld has discontinuities. The presence ofdisclinations is also connected to nontrivial geom etry. N am ely, the curvature tensor equals the surface density of the Frank vector. The gauge approach based on the rotational group SO (3) was also used for describing disclinations [19]. SO (3)-gauge models of spin glasses with defects were considered in [20, 21].

The geom etric theory of static distribution of defects which describes both types of defects \{ dislocation and disclinations \{ from a single standpoint was proposed in [22]. In contrast to other approaches, it involves the vielbein and SO (3) connection as the only independent variables. T he torsion and curvature tensors have direct physicalm eaning as the surface densities of dislocations and disclinations, respectively. C ovariant equations of equilibrium for the vielbein and SO (3) connection sim ilar to those in a gravity model w ith torsion are postulated. To de ne the solution uniquely, we must $x$ the coordinate system ( $x$ the gauge) because any solution of the equations of equilibrium is de ned up to general coordinate transform ations and local SO (3) rotations. The elastic gauge for the vielbein [23] and Lorentz gauge for the $S O$ (3) connection [24] w ere proposed recently. $W$ e stress that the notions of a displacem ent vector and rotational angle are com pletely absent in our approach. These notions can be introduced only in those dom ains where defects are absent. In this case, equations for vielbein and SO (3) connection are identically satis ed, the elastic gauge reduces to the equations of nonlinear elasticity theory for the displacem ent vector, and the Lorentz gauge leads to the equations for the principalchiral SO (3) eld. In other words, to $x$ the coordinate system, we choose two fundam ental m odels: the elasticity theory and the principal chiral eld model.

To show the advantages of the geom etric approach and to com pare it w ith the elasticity theory, we consider in detaila wedge dislocation in the fram ew orks of the elasticity theory and the proposed geom etric $m$ odel. $W$ e show that the explicit expression for the $m$ etric in the geom etric approach is sim pler and coincides $w$ ith the induced $m$ etric obtained $w$ ithin the elasticity theory only for m all relative deform ations.

A s an application of the geom etric theory of defects, we consider two exam ples in the last sections of the present review. First, we solve the problem of phonon scattering on a wedge dislocation. The problem of phonon scattering is reduced to the integration of equations for extrem als for the $m$ etric describing a wedge dislocation (because phonons m ove along extrem als in the eikonal approxim ation). A s a second application, we consider the quantum $m$ echanical problem of im purity or vacancy $m$ otion inside a cylinder whose axis coincides w ith a wedge dislocation. The wave functions and energetic spectrum of the im purity are found explicitly.

The presence of defects results in nontrivial $R$ iem ann \{C artan geom etry. This m eans that for describing the phenom ena that relate ingeniously to elastic m edia, wem ust $m$ ake changes in the corresponding equations. For exam ple, if a phonon propagation in an ideal crystal is described by the wave equation, then the presence of defects is easily taken into account. For this, the at Euclidean $m$ etric has to be replaced by a nontrivial $m$ etric describing the distribution of defects. The sam e substitution $m$ ust be $m$ ade in the Schrodinger equation to describe other quantum e ects. It is shown now adays that the presence of defects essentially in uences physical phenom ena. The Schrodinger equation in the presence of dislocations was considered in [25\{46] for di erent problem s. P roblem s related to the wave or Laplace equations were considered in [47\{54]. The in uence of the
nontrivial $m$ etric related to the presence of defects was investigated in electrodynam ics [55] and hydrodynam ics [56]. Scattering of phonons on straight parallel dislocations w as studied in 57\{59].

A nother approach to the theory of defects based on a ne geom etry w th nonzero nonm etricity tensor was considered recently in [60].

## 2 E lastic deform ations

W e consider in nite three dim ensional elastic media. W e suppose that the undeform ed $m$ edium in the defect-free case is invariant under translations and rotations in som e coordinate system. Then, the $m$ edium in this coordinate system $y^{i}, i=1 ; 2 ; 3$, is described by the Euclidean $m$ etric $i_{i j}=$ diag $(+++)$, and the system of coordinates is called C artesian. $T$ hus, in the undeform ed state, we have the Euclidean space $R^{3} w$ ith a given C artesian coordinate system. W e also assum e that torsion (see the A ppendix) in the m edium equals zero.

Let a point of the $m$ edium has coordinates $y^{i}$ in the ground state. A fter deform ation, this point has the coordinates

in the initial coordinate system, see F ig. [1]. The inverse notation is used in the elasticity theory. O ne usually w rites $x^{i}!y^{i}=x^{i}+u^{i}(x)$. $T$ hese are equivalent because both coordinate system $s x^{i}$ and $y^{i}$ cover the whole $R^{3}$. H ow ever, in the theory of defects considered in the next sections, the situation is di erent. G enerally, the elastic m edium lls the whole Euclidean space only in the nalstate. H ere and in what follow, we assum e that elds depend on coordinates $x$ that are coordinates of points of the $m$ edium after the deform ation and cover the whole Euclidean space $R^{3}$. In the presence of dislocations, the coordinates $y^{i}$ do not cover the whole $R^{3}$ in the general case because part of the $m$ edia $m$ ay be rem oved or, conversely, added. T herefore, the system of coordinates related to points of the $m$ edium after an elastic deform ation and defect creation is m ore preferable.

In the linear elasticity theory, relative deform ations are assum ed to be sm all ( $@_{j} u^{i}$ 1). The functions $u^{i}(x)=u^{i}(y(x))$ are then com ponents of a vector eld that is called the displacm ent vector eld and is the basic variable in elasticity theory.

In the absence of defects, we assum e that the displacem ent eld is a sm ooth vector eld in the Euclidean space $R^{3}$. The presence of discontinuities and singularities of the displacem ent eld is interpreted as a presence of defects in elastic $m$ edia.

In what follow S, we consider only static deform ations w ith the displacem ent eld $u^{i}$ independent of tim $e$. Then the basic equations of equilibrium for $s m$ all deform ations are
(see, e.g., [61])

$w$ here ${ }^{i j}$ is the stress tensor, which is assum ed to be sym $m$ etric. The tensor of sm all deform ations $i_{i j}$ is given by the sym $m$ etrized partialderivative of the displacem ent vector:

Low ering and raising of the Latin indices is perform ed with the Euclidean $m$ etric $i j$ and its inverse ${ }^{\text {ij }}$. The letters and denote constants characterizing elastic properties of $m$ edia and are called Lame coe cients. Functions $f^{i}(x)$ describe the total density of nonelastic forces inside the $m$ edium. We assum $e$ in what follows that such foroes are absent: $f^{j}(x)=0$. Equation (2) is $N$ ew ton's law, and Eqn (3) is Hook's law relating stresses to deform ations.

In a C artesian coordinate system and for sm all deform ations, the di erence between upper and lower indiges disappears because raising and low ering of indices is perform ed $w$ th the help of the Euclidean $m$ etric. O ne usually forgets about this di erence due to this reason, and this is fully justi ed. But in the presence of defects, the notion of C artesian coordinate system and Euclidean metric is absent, and the indiges are raised and lowered w th the help of $R$ iem annian $m$ etric. Therefore, we distinguish the upper and lower indioes as is accepted in di erential geom etry, having the transition to elastic $m$ edia $w$ ith defects in $m$ ind.

The $m$ ain problem in the linear elasticity theory is the solution of the second-order equations for the displacem ent vector that arise after substitution of (3) into (2) $w$ ith som $e$ boundary conditions. M any known solutions are in good agreem ent with experim ent. Therefore, one $m$ ay say that equations (3), (2) have a solid experim entalbackground.

W e now look at the elastic deform ations from the standpoint of di erential geom etry. From the $m$ athem atical standpoint, $m$ ap (1) is itself a di eom onphism of the Euclidean space $R^{3}$. The Euclidean $m$ etric $i j$ is then induced by the $m a p y^{i}!x^{i}$. It $m$ eans that in the deform ed state, the $m$ etric in the linear approxim ation is given by

i.e., is de ned by the tensor of sm all deform ations (4) . W e note that in the linear approxim ation, $\left.\mathrm{ij}^{(\mathrm{x}}\right)=\mathrm{ij}(\mathrm{y})$ and $@ \mathrm{u}_{\mathrm{j}}=@ \mathrm{x}^{\mathrm{i}}=@ \mathrm{u}_{\mathrm{j}}=@ \mathrm{y}^{\mathrm{i}}$.

In $R$ iem annian geom etry, the metric uniquely de nes the Levi\{C ivita connection $e_{i j}{ }^{k}(x)$ (Christo el's symbols), Eqn 115). W e can com pute curvature tensor (119) for these sym bols. This tensor equals identically zero, $\mathbb{F}_{i j k}{ }^{1}(x)=0$, because the curvature of the Euclidean space is zero, and the $m$ ap $y^{i}!x^{i}$ is a di eom onphism. The torsion tensor is equal to zero for the sam e reason. Thus, an elastic deform ation of the $m$ edium corresponds to the trivial $R$ iem ann \{C artan geom etry, w ith zero curvature and torsion tensors.

The physical interpretation of $m$ etric (5) is as follow $s$. The extemal observer xes C artesian coordinate system corresponding to the ground undeform ed state of them edium .
$T$ he $m$ edium is then deform ed, and extemal observer discovers that the $m$ etric becom es nontrivialin this coordinate system. Ifwe assum e that elastic perturbations in them edium (phonons) propagate along extrem als (lines ofm inim al length), then their tra jectories in the deform ed medium are de ned by Eqns 118). Trajectories of phonons are now not straight lines because the Christo el's sym bols are nontrivial ( $\left.e_{j k}{ }^{i} \in 0\right)$. In this sense, $m$ etric (5) is observable. H ere, we see the essential role of the $C$ artesian coordinate system $y^{i}$ de ned by the undeform ed state, $w$ th which the $m$ easurem ent process is connected.

W e assum $e$ that the $m$ etric $g_{i j}(x)$ given in the C artesian coordinates corresponds to som e state of elastic $m$ edia without defects. The displacem ent vector is then de ned by the system of equations (5), and its integrability conditions are the equallity of the curvature tensor to zero, in accordance with theorem [2 in the Appendix. In the linear approxim ation, these conditions are know n in elasticity theory as the Saint\{Venant integrability conditions.

W em ake a rem ark that is im portant for the follow ing consideration. For appropriate boundary conditions, the solution of the elasticity theory equations (2), (3) is unique. From the geom etric standpoint, this $m$ eans that elasticity theory xes di eom onphism $s$. $T$ his fact is used in the geom etric theory of defects. Equations of nonlinear elasticity theory w ritten in term sof the m etric or vielbein are used for xing the coordinate system.

## 3 D islocations

W e start with the description of linear dislocations in elastic m edia (see, e.g., [61, 62]). $T$ he sim plest and $m$ ost undespread exam ples of linear dislocations are show $n$ in $F$ ig. (2. We cut the $m$ edium along the half-plane $x^{2}=0, x^{1}>0, m$ ove the upper part of the $m$ edium located over the cut $x^{2}>0, x^{1}>0$ by the vector $b$ tow ards the dislocation axis $x^{3}$, and glue the cutting surfaces. The vector b is called the Burgers vector. In the general case, the Burgers vector $m$ ay not be constant on the cut. For the edge dislocation, it varies from zero to som e constant value $b$ as it $m$ oves from the dislocation axis. A fter the gluing, the $m$ edia com es to the equilibrium state called the edge dislocation, see Fig. Zia. If the B urgers vector is parallel to the dislocation line, it is called the screw dislocation (F ig. (2b).

The sam e dislocation can be $m$ ade in di erent ways. For exam ple, if the Burgers vector is perpendicular to the cutting plane and directed from it in the considered cases, then the produced cavity must be led with medium before gluing. It is easy to im agine that the edge dislocation is also obtained as a result, but rotated by the angle $=2$ around the $\mathrm{x}^{3}$ axis. This exam ple show $s$ that a dislocation is characterized not by the cutting surface but by the dislocation line and the Burgers vector.

From the topological standpoint, the $m$ edium containing several dislocations or even the in nite num ber of them is the Euclidean space $R^{3}$. In contrast to the case of elastic deform ations, the displacem ent vector in the presence ofdislocations is no longer a sm ooth function because of the presence of cutting surfaces. At the sam e tim $e$, we assum e that partial derivatives of the displacem ent vector $@_{j} u^{i}$ (the distortion tensor) are sm ooth functions on the cutting surface. This assum ption is justi ed physically because these derivatives de ne deform ation tensor (4). In itstum, partialderivatives of the deform ation tensor m ust exist and be sm ooth functions in the equilibrium state everyw here except,

possibly, the dislocation axis, because otherw ise equations of equilibrium (2) have no $m$ eaning. $W$ e assum $e$ that the $m$ etric and vielbein are $s m$ ooth functions everyw here in $R^{3}$ except, $m$ ay be, dislocation axes, because the deform ation tensor de nes the induced $m$ etric (5).

The $m$ ain idea of the geom etric approach am ounts to the follow ing. To describe single dislocations in the fram ew ork of elasticity theory we m ust solve equations for the displacem ent vector w ith som e boundary conditions on the cuts. This is possible for sm all num ber of dislocations. But, with an increasing num ber of dislocations, the boundary conditions becom e so com plicated that the solution of the problem becom es unrealistic. Besides, one and the sam e dislocation can be created by di erent cuts which leads to an ambiguity in the displacem ent vector eld. A nother shortcom ing of this approach is that it cannot be applied to the description of a continuous distribution of dislocations because the displacem ent vector eld does not exist in this case at allbecause it m ust have discontinuities at every point. In the geom etric approach, the basic variable is the vielbein which by assum ption is a sm ooth function everyw here except, possibly, dislocation axes. W epostulate new equations for the vielbein (see section(5). In the geom etric approach, the transition from a nite number of dislocations to their continuous distribution is sim ple and natural. In that way, the sm oothing of singularities occurs on dislocation axes in analogy with sm oothing ofm ass distribution for point particles in passing to continuous m edia.

W e now develop the form alism of the geom etric approach. In a general defect-present case, we do not have a preferred C artesian coordinate fram e in the equilibrium because there is no sym $m$ etry. Therefore, we consider arbitrary coordinates $\mathrm{x}, \quad=1 ; 2 ; 3$, in $\mathrm{R}^{3}$. $W$ e use $G$ reek letters for coordinates allow ing arbitrary coordinate changes. Then the $B$ urgers vector can be expressed as the integral of the displacem ent vector

where C is a closed contour surrounding the dislocation axis, F ig. 3 .

This integral is invariant under arbitrary coordinate transform ations $x \quad!\quad x^{0}(x)$ and covariant under globalSO (3)-rotations of $y^{i}$. Here, com ponents of the displacem ent vector eld $u^{i}(x)$ are considered w ith respect to the orthonorm al basis in the tangent space, $u=u^{i} e_{i}$. If com ponents of the displacem ent vector eld are considered $w$ ith respect to the coordinate basis $u=u$ @ , the invariance of the integral (6) under general coordinate changes is violated.

In the geom etric approach, we introduce new independent variable \{ the vielbein \{ instead of partial derivatives @ $u^{i}$

The vielbein is a sm ooth function on the cut by construction. W e note that if the vielbein was sim ply de ned as the partial derivative @ $y^{i}$, then it would have the -function singularity on the cut because functions $y^{i}(x)$ have a jum $p$. The Burgers vector can be expressed through the integral over a surface $S$ having contour $C$ as the boundary

where $d x{ }^{\wedge} d x$ is the surface elem ent. A s a consequence of the de nition of the vielbein in (7), the integrand is equal to zero everyw here except at the dislocation axis. For the edge dislocation w ith constant B urgers vector, the integrand has a -fiunction singularity at the origin. The criterion for the presence of a dislocation is a violation of the integrability conditions for the system of equations @ $y^{i}=e^{i}$ :

If dislocations are absent, then the functions $y^{i}(x)$ exist and de ne transform ation to $a$ C artesian coordinates fram e.

In the geom etric theory ofdefects, the eld $e^{i}$ is identi ed with the vielbein. Next, we com pare the integrand in (8) w ith the expression for the torsion in $C$ artan variables (125). They di er only by term scontaining the SO (3) connection. This is the ground for the introduction of the follow ing postulate. In the geom etric theory of defects, the Burgers vector corresponding to a surface $S$ is de ned by the integral of the torsion tensor:

This de nition is invariant with respect to general coordinate transform ations of $x$ and covariant w th respect to global rotations. Thus, the torsion tensor has straightforw ard physical interpretation: it is equal to the surface density of the B urgers vector.

The physical interpretation of the $S O$ (3) connection is given in section 4, and now we show how this de nition reduces to the expression for the Burgers vector (8) obtained w ithin elasticity theory. If the curvature tensor for the $S O$ (3) connection is zero, then, according to theorem 3, the connection is locally trivial, and there exists such SO (3) rotation such that ! $i^{j}=0$. In this case, we retum to expression (8).

If the SO (3) connection is zero and vielbein is a sm ooth function, then the Burgers vector corresponds uniquely to every contour. It can then be expressed as a surface integral of the torsion tensor. The surface integraldepends only on the boundary contour but not on the surface due to the Stokes theorem .

W e have shown that the presence of linear defects results in a nontrivialtorsion tensor. In the geom etric theory of defects, the equality of the torsion tensor to zero $T{ }^{i}=0$ is naturally considered the criterion for the absence of dislocations. Then, under the nam e dislocation fall not only linear dislocations but, in fact, arbitrary defects in elastic m edia. For exam ple, point defects; vacancies and im purities, are also dislocations. In the rst case we cut out a ball from the Euclidean space $R^{3}$ and then shrink the boundary sphere to a point ( $F$ ig. (4) . In the case of im purity, a point of the Euclidean space is blown up to a sphere and the produced cavity is lled with the $m$ edium. P oint defects are characterized by the $m$ ass of the rem oved or added media, which is also de ned by the vielbein [22]

where $y^{i}(x)$ are the transition functions to a C artesian coordinate fram $e$ in $R^{3}$ and 0 is the density of the $m$ edium which is supposed to be constant. The $m$ ass is de ned by the di erence of two integrals, each of them being separately divergent. The rst integral equals to the volum e of the $m$ edium $w$ ith defects and the second is equal to the volum e of the Euclidean space. The torsion tensor for a vacancy or im purity is zero everyw here except at one point, where it has a -fiunction singularity. For point defects, the notion of the Burgers vector is absent.

A coording to the given de nition, the $m$ ass of an im purity is positive because the $m$ atter is added to the $m$ edia, and the $m$ ass of a vacancy is negative because part of the $m$ edium is rem oved. The negative sign of the $m$ ass causes serious problem $s$ for a physical intenpretation ofsolutions of the equations ofm otion or the Schrodinger equation. H ence, we m ake a rem ark. Strictly speaking, the integral (10) should be called the \bare" $m$ ass because this expression does not account for elastic stresses arising around a point dislocation. The e ective $m$ ass of such a defect $m$ ust contain at least two contributions: the bare $m$ ass and the free energy com ing from elastic stresses. T he question about the sign of the e ective $m$ ass is not solved yet and dem ands a separate analysis.

Surface defectsm ay also exist in three-dim ensionalspace, in addition to point and line
dislocations. In the geom etric approach, all of them are called dislocations because they correspond to a nontrivial torsion.

## 4 D isclinations

In the preceeding section, we related dislocations to a nontrivial torsion tensor. For this, we introduced an SO (3) connection. N ow we show that the curvature tensor for the SO (3) connection de nes the surface density of the Frank vector characterizing other well-know n defects \{ disclinations in the spin structure ofm edia [61].

Let a unit vector eld $n^{i}(x)\left(n^{i} n_{i}=1\right)$ be given at all points of the $m$ edium. For exam ple, $n^{i}$ has the $m$ eaning of the $m$ agnetic $m$ om ent located at each point of the $m$ edium for ferrom agnets ( $F$ ig. [5a). For nem atic liquid crystals, the unit vector eld $n^{i} w$ ith the equivalence relation $n^{i} \quad \dot{n}$ describes the director eld ( $F$ ig. [5b).

If a media has a spin structure, then it $m$ ay have defects called disclinations. For linear disclinations parallelto the $\mathrm{x}^{3}$ axis, the vector eld $n$ lies in the penpendicular plain $x^{1} ; x^{2}$. The sim plest exam ples of linear disclinations are shown in $F$ ig. ©. Every linear disclination is characterized by the Frank vector

and the integral is taken along closed contour $C$ surrounding the disclination axis. The length of the Frank vector is equal to the totalangle of rotation of the eld $n^{i}$ as it goes around the disclination.
$T$ he vector eld $n^{i}$ de nes a $m$ ap of the Euclidean space to a sphere $n: R^{3}!S^{2}$. For linear disclinations parallel to the $x^{3}$ axis, this $m$ ap is restricted to a $m$ ap of the plane $R^{2}$ to a circle $S^{1}$. In this case, the total rotation angle $m$ ust obviously be a m ultiple of 2 .

For nem atic liquid crystals, we have the equivalence relation $n^{i} \quad \dot{n}$. Therefore, for linear disclinations parallel to the $x^{3}$ axis, the director eld de nes a $m$ ap of the plane into the projective line $n: R^{2}!R P^{1}$. In this case, the length of the Frank vector m ust be a multiple of . The corresponding exam ples of disclinations are show n in F ig. 7 .

A s for the displacem ent eld, the eld ! ${ }^{i j}(x)$, taking values in the algebra so (3), is not a sm ooth function in $R^{3}$ in the presence of disclinations. $W$ e $m$ ake a cut in $R^{3}$ bounded by the disclination axis. Then the eld ! ${ }^{i j}(x) m$ ay be considered smooth in the whole space except the cut. W e assum e that allpartial derivatives of ! ${ }^{i j}(x)$ have the sam elim it as it approaches the cut from both sides. Then we de ne the new eld

This de nition reduces to the previous expression for the Frank vector 15) in the case where rotation of the vectorn occures in a xed plane. In this case, rotations are restricted by the subgroup $S O$ (2) $S O$ (3). The quadratic term $s$ in the expression for the curvature in (126) disappearbecause the rotation group SO (2) is A belian, and we obtain the previous expression for the Frank vector (15).

Thus, we described the $m$ edia $w$ th dislocations (defects of elastic $m$ edia) and disclinations (defects in the spin structure) in the fram ew ork of $R$ iem ann \{C artan geom etry, the torsion and curvature tensors being identi ed w ith the surface density of dislocations and disclinations, respectively. The relations betw een physical and geom etrical notions are sum $m$ arized in the $T a b l e 1$.

The same physical interpretation of torsion and curvature was considered in [63]. Several possible functionals for the free energy were also considered. In the next section, we propose a new expression for the free energy.

## 5 Free energy

U ntil now, we discussed only the relation betw een physical and geom etrical notions. To com plete the construction of the geom etric theory of defects, we have to postulate equations of equilibrium describing static distribution of defects in media. The vielbein $e^{\text {i }}$ and SO (3) connection! ij are basic and independent variables in the geom etric approach. In contrast to previous geom etric approaches, we com pletely abandon the displacem ent eld $u^{i}$ and spin structure ! ${ }^{\text {ij }}$ as the elds entering the system of equilibrium equations. In a general case of a continuous distribution of defects, they sm ply do not exist. Nev ertheless, at som e level and under de nite circum stances they can be reconstructed, and we discuss this in the follow ing section.

The expression for the free energy was derived in [22]. W e assum e that equations of equilibrium m ust be covariant under general coordinate transform ations and local rotations, be at $m$ ost of the second order, and follow from a variational principle. The expression for the free energy leading to the equilibrium equations m ust then be equal to a volum e integral of the scalar function (the Lagrangian) that is quadratic in torsion and curvature tensors. There are three independent invariants quadratic in the torsion tensor and three independent invariants quadratic in the curvature tensor in three dim ensions. It is possible to add the scalar curvature and a \oosm ological" constant . W e thus obtain a general eight-param eter Lagrangian

The particular feature of three dim ensions is that the full curvature tensor is in a one-to-one correspondence w ith R icci tensor (129) and has three irreducible com ponents. $T$ herefore, the Lagrangian contains only three independent invariants quadratic in curvature tensor. W e do not need to add the H ibert\{E instein Lagrangian $\mathbb{F}$, also yielding second-order equations, to the free energy (18) because of identity (130).

Thus, the m ost general Lagrangian depends on eight constants and leads to very com plicated equations of equilibrium. At present, we do not know precisely what values of the constants describe this or that $m$ edium. T herefore, we m ake physically reasonable assum ptions to sm plify $m$ atters. $N$ am ely, we require that equations of equilibrium m ust adm it the follow ing three types of solutions.

1. There are solutions describing the $m$ edia $w$ ith only dislocations,

The rst condition on the class of solutions of the equilibrium equations is that they perm it solutions describing the presence of only dislocations in $m$ edia. This $m$ eans the

O ther quadratic Lagrangians were considered, for exam ple, in [9, 63]. W e note that they also contain the displacem ent vector as an independent variable along $w$ ith the vielbein.

Expression (26) de nes the free energy density in the geom etric theory of defects and leads to the equilibrium equations (the Euler\{Lagrange equations). In our geom etric approach, the displacem ent vector and spin structure do not enter expression (26) for the free energy.

## 6 Gauge xing

In the geom etric approach, the vielbein $e^{i}$ and $S O$ (3) connection ! $i^{j}$ are the only variables. The displacem ent eld $u^{i}$ and the spin structure $!{ }_{i}{ }^{j}$ can be introduced only in those regions of $m$ edia where defects are absent. As the consequence of the absence of disclinations R $i_{i}^{j}=0$, the $S O$ (3) connection is actually a pure gauge (127), i.e., the spin structure $!_{i}{ }^{j}$ exists. If, in addition, dislocations are absent ( $T^{i}=0$ ) then there is the displacem ent eld such that the vielbein equals its partial derivatives [128). In this and only in this case can we introduce the displacem ent eld and spin structure. W e show below that this can be done such that the equations ofnonlinear elasticity theory and the principal chiralSO (3) eld are fiul lled.

For free energy in (26), the Euler\{Lagrange equations are covariant under general coordinate transform ations in $R^{3}$ and localSO (3) rotations. Thism eans that any solution of the equilibrium equations is de ned up to di eom orphism s and localrotations. For the geom etric theory of defects to $m$ ake predictions, we have to $x$ the coordinate system (to $x$ the gauge in the language of gauge eld theory). This allow s us to choose a unique representative from each class ofequivalent solutions. W e say afterw ards that this solution
of the Euler\{Lagrange equations describes the distribution of defects in the laboratory coordinate system .

W e start w ith gauge- xing the di eom onphism s. For this, we choose the elastic gauge proposed in [23]. This question is of prim ary im portance, and we discuss it in detail.

Equations (2), (3) of elasticity theory for $f^{i}=0$ yield the second-order equation for the displacem ent vector

W e note that the gauge condition is not uniquely de ned because the induced $m$ etric is nonlinear in the displacem ent vector, and di erent equations for the $m$ etric $m$ ay have the sam $e$ linear approxim ation. W e give two possible choices,

Them etric $g$ is the Euclidean $m$ etric w ritten in an anbitrary coordinate system, for exam ple, in the cylindrical or spherical coordinate system. The covariant derivative $r$ is built from the Christo el symbols corresponding to the $m$ etric $g$, and $r g=0$ as a consequence. The $m$ etric $g$ is the $m$ etric describing dislocations [an exact solution of the equilibrium equations for the free energy (26)]. The gauge conditions di er because in the rst and second cases the contraction is perform ed $w$ th the $m$ etric ofdislocation $g$ and the Euclidean $m$ etric $g$, respectively, w thout changing the linear approxim ation. B oth gauge conditions yield Eqn (27) in the linear approxim ation in the displacem ent vector (5). This is $m$ ost easily veri ed in C artesian coordinates.

From the geom etric standpoint, we have the follow ing. The medium with dislocations is di eom orphic to the Euclidean space $R^{3}$ equipped $w$ th two $m$ etrics $g$ and $g$. The $m$ etric $g$ is a at Euclidean $m$ etric $w$ ritten in an anbitrary coordinate system. The $m$ etric $g$ is not at and describes the distribution of dislocations in the sam e coordinate system. In fact, the $m$ etric $g$ is used only to $x$ the coordinate system in which the $m$ etric $g$ is $m$ easured.

If the solution of the equilibrium equations satis es one of the gauge conditions (28), (29), w rilten, for exam ple, in cylindrical coordinate system then we say that the solution is found in the cylindrical coordinates. W e suppose here that the distribution of dislocations in elastic $m$ edia in the laboratory cylindrical coordinate system is described by this particular solution. A nalogously, we m ay seek solutions in a C artesian, spherical, or any other coordinate system.
$G$ auge conditions $m$ ay also be written for the vielbein $e^{i}$, which is de ned by Eqn (120). This involves additional arbitrariness because the vielbein is de ned up to local rotations. T his invariance leads to di erent linear approxim ations for the vielbein in term s of the displacem ent vector. W e consider tw o possibilities in C artesian coordinates:

We note that in a curvilinear coordinate system, the covariant derivative $r$ m ust also include the at SO (3) connection acting on indioes $i ; j$. O ne can also w rite other possible gauge conditions having the sam e linear approxim ation. The question of the correct choice is unanswered at present and outside the soope of this review. At the $m$ om ent, we want only to dem onstrate that the system of coordinates must be xed, and that the gauge condition depends on the P oisson ratio, which is the experim entally observed quantity.

G auge conditions (32) \{ (33) are rst order equations by them selves and have some arbitrariness. Therefore, to x a solution uniquely, we m ust im pose additionalboundary conditions on the vielbein for any given problem .

If the defect-free case, $T^{i}=0, R \quad j^{i}=0$, and the equilibrium equations are satis ed because the Euler\{Lagrange equations for (26) are satis ed. In this and only in this case, we can introduce a displacem ent vector, and the elastic gauge reduces to the equations of nonlinear elasticity theory. In the presence of defects, a displacem ent eld does not exist, and the elastic gauge sim ply de nes the vielbein.

In choosing the free energy functional, we required that the conditions $R \quad{ }^{i j}=0$ and $T^{i}=0$ satisfy the Euler\{Lagrange equations. This is im portant because otherw ise we would obtain an additional condition on the displacem ent vector (the Euler\{Lagrange equations) besides the elasticity theory equations follow ing from the elastic gauge.

W e stress an im portant point once again. In the geom etric theory ofdefects, we assum e that there is a preferred laboratory coordinate system in which $m$ easurem ents are $m$ ade. $T$ his coordinate system is related to the $m$ edium $w$ ithout defects and elastic stresses and corresponds to the at Euclidean space $R^{3}$. G auge conditions (28), (29) and (32), (33) are w ritten precisely in this Euclidean space $R^{3}$ and contain a $m$ easurable quantity, the Poisson ratio. This property essentially distinguishes the geom etric theory of defects from the $m$ odels of gravity in which all coordinate system $s$ are considered equivalent.
$T$ he elastic gauge is used to $x$ di eom onphism $s$. The expression for the free energy in (26) is also invariant under local SO (3) rotations, and they m ust also be xed. For this, we recently proposed the Lorentz gauge for the connection [24]

This gauge is w ritten in the laboratory C artesian coordinate system and has deep physical $m$ eaning. That is, let disclinations be absent $\left(R_{j}{ }^{i}=0\right)$. Then the SO (3) connection is a pure gauge:

for the spin structure $!^{i j}(x)$. P rincipal chiral eld models (see, e.g., [64\{68]) for di erent groups and in a di erent num ber of dim ensions attract $m$ uch interest in $m$ athem atical physics because they adm it solutions of topological soliton types and nd broad applications in physics.

Thus, the Lorentz gauge (34) m eans the follow ing. In the absence of disclinations, equations of equilibrium are identically satis ed, and there exists a eld! ${ }^{i j}$ that satis es equations for the principal chiral eld. By this we $m$ ean that the spin structure of the $m$ edium is described by the $m$ odel of the principal chiral eld in the defect-free case.

The principal chiral eld $m$ odel is not the only one that can be used for xing local rotations. T he Skym e m odel [69] can also be used for this purpose. T he Euler\{Lagrange equations for this m odel are not di cult to rew rite in term sof the SO (3) connection and use as the gauge conditions.

T here are otherm odels for spin structures. For describing the distribution ofm agnetic m om ents in ferrom agnets or the director eld in liquid crystals, one uses the expression for the free energy depending on the vector $n$ - eld itself 70, 61]. Lately, $m$ uch attention is paid to the Faddeev m odel of the $n$ - eld 71]. T he question whether there are gauge conditions on the $S O$ (3) connection that yield these $m$ odels in the absence ofdisclinations is unansw ered at present.

Thus, we pose the follow ing problem in the geom etric theory of defects: to nd the solution of the Euler\{Lagrange equations for free energy (26) that satis es the elastic gauge for the vielbein and the Lorentz gauge for the $S O$ (3) connection. In sections 8 and 11, we solve this problem for the wedge dislocation in the fram ew ork of the classical elasticity theory and the geom etric theory ofdefects, respectively, and afterw ards com pare the obtained results.

## 7 A sym m etric elasticity theory

In the preceeding section, we used the elasticity theory and the principalchiralSO (3)- eld $m$ odel to $x$ the invariance of free energy (26) in the geom etric theory of defects. This is not a unique possibilly, because other m odels $m$ ay be used for gauge xing. In the present section, we show how another m odel \{ asym m etric elasticity theory \{ can be used for xing di eom onphism $s$ and local rotations.

At the beginning of the last century, the C osserat brothers developed the theory of elastic m edia, every point of which is characterized not only be its position but also by its orientation in space [72], ie., a vielbein is speci ed at every point (Fig[8).

From physical standpoint, this $m$ eans that every atom in the crystalline structure is not a point but an extended object having orientation. In this case, the stress tensor is no longer a sym $m$ etric tensor, and the corresponding theory is called the asym $m$ etric
elasticity theory. C ontem porary exposition of this approach is given in 73]. In the present section, we show that the asym $m$ etric theory of elasticity is naturally inconporated into the geom etric theory of defects.
$T$ he $m$ ain variables in the asym $m$ etric theory of elasticity are the displacem ent vector $u^{i}(x)$ and the rotation angle ! ${ }^{i}(x)$. The direction of the pseudovector ! ${ }^{i}$ coincides with the rotation axis of the $m$ edium elem ent and its length is equal to the angle of rotation. T he angle of rotation discussed in section 4 is dual to the spin structure eld ! ${ }^{i j}(\mathrm{x}):!_{\mathrm{ij}}="_{\mathrm{ijk}}!{ }^{\mathrm{k}}$.

The C osserat $m$ edium is characterized by the stress tensor ${ }^{i j}(\mathrm{x})$ (the density of foroes acting on the surface w ith norm ali in the direction $j$ ) and the torque stress tensor ${ }^{i j}(x)$ (the density of torques acting on the surface

where $f^{i}(x)$ and $m^{i}(x)$ are the densities of nonelastic extemal forces and torques. As a consequence of Eqn (36), the stress tensor is sym m etric if and only if the condition $@_{j}{ }^{j i}+m^{i}=0$ is satis ed.

The rst term vanishes as a consequence of Eqn (27). Thus, for spin structure (40) and $m^{i}=0$ we retum to the sym $m$ etric elasticity theory.

Equations (35), (36), (38), and (39), together w th the boundary conditions, de ne the equilibrium state of $C$ osserat $m$ edia. W e now show how this $m$ odel is included in the geom etric theory. First, we note that in the absence of defects ( $T^{i}=0, R \quad{ }^{i j}=0$ ), the elds $u^{i}$ and ! ${ }^{i j}$ exist. Then the vielbein and the $S O$ (3) connection are de ned by the deform ation and $t w$ ist tensors in the linear approxim ation:

W e note that relations (37) can be regarded as equations for the displacem ent vector and rotation angle. The corresponding integrability conditions were obtained in 74]. $T$ hese integrability conditions are the linear approxim ations of equalities $T^{i}=0$ and $R \quad{ }^{i j}=0$ de ning the absence of defects.

If nonelastic foroes and torques are absent ( $f^{i}=0, \mathrm{~m}^{i}=0$ ), then the asym $m$ etric theory of elasticity reduces to second-order equations for the displacem ent vector and rotation angle:

O f course, these are not the only equations that coincide with Eqns (43) and (44) in the linear approxim ation. At present, we do not have argum ents for the unique choioe. $T$ he derived nonlinear equations of the asym $m$ etric elasticity theory can be used as gauge conditions in the geom etric theory of defects. Here, we have six equations for xing di eom orphism s (three param eters) and localSO (3) rotations (three param eters). Thus, the asym $m$ etric theory of elasticity is naturally embedded in the geom etric theory of defects.

In section 6, we considered the elastic gauge for the vielbein and the Lorentz gauge for the SO (3) connection. In this case, the spin structure variables do not interact w ith elastic deform ations when defects are absent. In the asym $m$ etric elasticity theory, the elastic stresses directly in uence the spin structure and vioe versa.

## 8 W edge dislocation in the elasticity theory

By wedge dislocation, we understand an elastic $m$ edium that is topologically the Euclidean space $R^{3}$ w thout the $z=x^{3}$ axis $\{$ the core of dislocation, obtained in the follow ing way. We consider the in nite elastic $m$ edium without defects and cut out the in nite wedge of angle 2 . For de niteness, we assum e that the edge of the wedge
coincides w th the $z$ axis ( $F$ ig (9). The edges of the cut are then $m$ oved sym $m$ etrically one to the other and glued together. A fter that, the $m$ edium $m$ oves to the equilibrium state under the action of elastic forces. If the wedge is cut out from the $m$ edium, then the angle is considered negative: $1 \ll 0$. For positive , the wedge is added. Thus, the elastic $m$ edium initially occupies a dom ain greater or lesser than the Euclidean space $R^{3}$, depending on the sign of the de cit angle $;$ in the cylindrical coordinates $r ;{ }^{\prime} ; z$ this dom ain is described by the inequalities

W e note that the wedge dislocation is often called disclination. In our approach, this term seem s unnaturalbecause the wedge dislocation is related to a nontrivialtorsion. M oreover, the term disclination is used for defects in the spin structure.

W e now proceed with them athem atical formulation of the problem for the wedge dislocation in the fram ew ork of elasticity theory. To avoid divergent expressions arising for in nite m edia, we suppose that the wedge dislocation is represented by the cylinder of a nite radius R . This problem has translational sym $m$ etry along the $z$ axis and rotational sym $m$ etry in the xiy plane. Therefore, we use cylindrical coordinate system . Let

This $m$ eans that we are able to expect correct results for the displacem ent eld for sm all de cit angles ( 1) and near the boundary of the cylinder ( $r \quad R$ ).

We nd the m etric induced by the wedge dislocation in the linear approxim ation in the de cit angle. Calculations can be perform ed using the general form ulas (5) or the known expression for the variation of the form of the $m$ etric

## 9 Edge dislocation in the elasticity theory

W edge dislocations are relatively rarely $m$ et in naturebecause they require a m uch am ount of a medium to be added or rem oved, resulting in a vast quantity of energy expenses. N evertheless, their study is of great im portance because other linear dislocations can be expressed as a superposition of wedge dislocations. In this respect, wedge dislocations are elem entary. W e show this for an edge dislocation \{ one of the $m$ ost $w$ idely spread dislocations, as an exam ple. A $n$ edge dislocation $w$ ith the core coinciding $w$ ith the $z$ axis is shown in Fig .10a. It appears as the result of cutting the $m$ edium over the half-plane

$y=0, x>0, m$ oving the low er edge of the cut tow ards the $z$ axis on a constant (far from the core of the dislocation) Burgers vector b, and subsequently gluing the edges. To nd the displacem ent vector eld for the edge dislocation, we m ay solve the corresponding boundary value problem for the equilibrium equations (49) [61]. H ow ever, we follow another way, know ing the explicit form of the displacem ent vector for a w edge dislocation. T he edge dislocation is represented by the dipole of tw o wedge dislocations w ith positive, 2 , and negative, 2 , de cit angles as shown in $F$ go. W e assum e that the axes of the rst and second wedge dislocations are parallelto the $z$ axis and intersect the x;y plane at points $w$ ith the respective coordinates $(0 ; a)$ and $(0 ; a)$. The distance between the wedge dislocation axes is equal to 2 a . It follow s from the expression for the displacem ent
eld 51) that far away from the origin (r a), the displacem ent eld for the wedge dislocations has the follow ing form in the rst order in sm all and $a=r$ :

## 10 P arallel w edge dislocation s

In the absence of disclinations $\left(R_{i}^{j}=0\right)$, the $S O(3)$ connection is a pure gauge, and equations of equilibrium for the $S O$ (3) connection (20) are identically satis ed. In this case, the explicit form of the $S O$ (3) connection is uniquely determ ined by the spin structure ${ }^{i j}$. The eld ! ${ }^{\text {ij }}$ satis es equations for the principal chiral eld as a consequence of the Lorentz gauge in (34). Solution of this system of equations de nes the trivial SO (3) connection. Thus in the absence of disclinations, the problem is reduced to solution of the $E$ instein equations for the vielbein in the elastic gauge and solution of the principal
chiral eld $m$ odel for the spin structure. A fter that, we can com pute the torsion tensor through the form ulas (125), which de nes the surface density of the B urgers vector.

B ecause disclinations are absent (the curvature tensor is equal to zero), we have the space of absolute parallelism. The whole geom etry is then de ned by the vielbein e ${ }^{i}$, which uniquely de nes the torsion tensorvia 125) for vanishing SO (3) connection. H ere, we assum e that a trivialSO (3) connection is equal to zero. The vielbein $e^{i}$ satis es the three-dim ensionalE instein equationsw ith a Euclidean signaturem etric, which follow from the expression for the free energy (26) for $R j_{j}=0$,

Here, we have added the source of dislocations $T$ to the right hand side of E instein equations (进 is the energy m om entum tensor in gravity).

W e note that w thout a source of dislocations, the m odel would be trivial. Indeed, the scalar curvature and R icci tensor are equal to zero: $\mathbb{F}=0$, $\mathbb{P}=0$ for $\mathrm{T}=0$ as a consequence of $E$ instein equations (58). Then, the full curvature tensor w ithout sources is also equal to zero because in three-dim ensional space, it is in a one-to-one correspondence w ith R iccitensor (129). T he vanishing of the full curvature tensor m eans the triviality of the m odelbecause defects are absent in this case. T he sim ilar statem ent in three-dim ensional gravity is well known. It is usually form ulated as: \Three-dim ensional gravity does not describe dynam ical, i.e., propagating degrees of freedom ".

For our purposes, we have to nd the solution of Einstein equations (58) describing one wedge dislocation. The E instein equations are a system of nonlinear second-order partialdi erentialequations. N ot too many exact solutions are know $n$ at present, even in a three-dim ensional space. T he rem arkable exact solution describing an arbitrary static distribution of point particles is well know $n$ in three-dim ensional gravity for the Lorentz signature metric (+ ) [75\{77]. W e nd this solution for the Euclidean signature m etric and show that it describes an arbitrary distribution of parallel wedge dislocations in the geom etric theory of defects. H ence, we rst consider the m ore general case of an arbitrary num ber of wedge dislocations and then analyze in detail one wedge dislocation whidh is of interest to us. We do this deliberately because the solution in a m ore general case does not involve essential com plications. At the sam e tim e, an arbitrary distribution of wedge dislocations is $m$ uch $m$ ore interesting for applications. For exam ple, the edge dislocation was show $n$ in the preceeding section to be represented by a dipole of tw o w edge dislocations of di erent signs.

W e consider elastic m edium w ith arbitrary distributed but parallelw edge dislocations. W e choose the coordinate system such that the $z=x^{3}$ axis is parallelto dislocations axes, and axes fx $g=f x ; y g,=1 ; 2$ are penpendicular to the $z$ axis. Then the $m$ etric has the block-diagonal form

This is indeed the exact solution of the E instein equations describing arbitrary distribution of parallel w edge dislocations. This statem ent is $m$ ade clear from the follow ing consideration.

W e note that transition to a continuous distribution of dislocations in the geom etric approach is sim ple. For this, we have to substitute a continuous distribution of sources in the right hand side of the E instein equations instead of -sources.

W e consider one wedge dislocation with the source at the origin in m ore detail to show that $m$ etric (63) indeed describes an arbitrary distribution of wedge dislocations

The transform ation to coordinates $r_{;}^{\prime}$ in (66) $m$ eans the gluing of the edges of the wedge that has appeared, which produces a cone. T herefore, both $m$ etrics (65) and 67) describe the sam e geom etric ob ject \{ conical singularity. The torsion and curvature tensors are obviously zero everyw here excopt at the origin.

C reation of a conical singularity coincides exactly w th creation of the wedge dislocation in the geom etric theory ofdefects. It is not di cult to show that general solution (63])
describes an arbitrary distribution of conical singularities with de cit angles $n$ at points $r_{n}$. Thus, this solution describes an arbitrary distribution of parallel wedge dislocations.

In the next section, we consider one wedge dislocation in detail. For this, we perform one $m$ ore coordinate transform ation

## 11 W edge dislocation in the geom etric approach

W e now consider a wedge dislocation from the geom etric standpoint. From the qualitative standpoint, the creation of a wedge dislocation coincides with the de nition of conical singularity. H ow ever, there is a quantitative di erence because $m$ etric 69) depends only on the de cit angle and cannot coincide $w$ ith the induced $m$ etric (53) obtained $w$ ithin the elasticity theory. The di erence arises because we require the displacem ent vector in the equilibrium to satisfy equilibrium equations after rem oving the wedge and ghing its edges (creating conical singularity) in the elasticity theory. At the sam e time the x;y plane for a conical singularity after the gluing can be deform ed in an arbitrary way. Form ally, this $m$ anifests itself in that $m$ etric (53)) obtained $w$ thin the elasticity depends explicitly on the Poisson ratio, which is absent in gravity theory.

W e proposed the elastic gauge for solving this problem [23]. W e choose elastic gauge (331) as the sim plest one for a wedge dislocation. This problem can be solved in two ways. $F$ irst, the gauge condition can be inserted in the E instein equations directly. Second, we can nd the solution in any suitable coordinate system and then nd the coordinate transform ation such that the gauge condition is satis ed.

It is easier to follow the second way because the solution for the $m$ etric is know n, E qn (69). The vielbein can be associated $w$ th $m$ etric (69) as

This is the solution of the posed problem. The derived solution is valid for all de cit angles and for all $0<r<R$. The obtained $m$ etric depends on three constants: , , and $R$. The dependence on the de cit angle is due to its occurrence on the right hand side of $E$ instein equations (58). The dependence on the Poisson ratio com es from elastic gauge (33), and, nally, the dependence on the cylinder radius com es from boundary condition 731) .

If a wedge dislocation is absent, then $=0,=1,1=1$, and $m$ etric (75) goes to the Euclidean one $d l^{2}=d r^{2}+r^{2} d^{\prime 2}$, as expected.

W e com pare m etric (75) obtained within the geom etric approach w ith the induced $m$ etric from elasticity theory in Eqn (53). First, it has a sim pler form. Second, in the linear approxim ation in

W e see that induced metric (53) provides only the linear approxim ation for the $m$ etric obtained w ithin the geom etric theory of defects, which, in addition, has a sim pler form. Beyond the perturbation theory, we see essentialdi erences. In particular, $m$ etric (53) is singular at the origin, whereas $m$ etric (75) obtained beyound the perturbation theory is regular.

The stress and deform ation tensors are related by H ook's law (3). There is an experim ental possibility to check form ulas (75) because the deform ation tensor is the linear approxim ation for the induced $m$ etric. For this one has to $m$ easure the stress eld for a single wedge dislocation. In this way, the geom etric theory of defects can be experim entally con med or discarded.

The problem of reconstruction of the displacem ent eld for a given $m$ etric reduces to solution ofdi erentialequations (5) w th m etric (75) on the right hand side and boundary conditions (50) . We do not discuss this problem here. W e note that in the geom etric theory of defects, a com plicated stage of nding the displacem ent vector where it exists is sim ply absent and is not necessary.

Two-dim ensionalm etric (75) describes the conicalsingularity in the elastic gauge. The relation betw een con ical singularities and wedge dislocations w as established in [22,78\{80]. In these papers, the $m$ etric was used in the other gauges (coordinate system $s$ ).

## 12 E lastic oscillations in $m$ edia w ith dislocations

E lastic oscillations in elastic $m$ edia without defects are described by a tim e-dependent vector eld $u^{i}(t ; x)$ that satis es the wave equation (see, e.g., 61])

Particles arising after the secondary quantization of Eqns 81) are called phonons in solids. Therefore, strictly speaking, the problem of scattering of phonons on dislocations is a quantum mechanical one. In the present review, we consider only classical aspects of this problem.

W ave equations 81) contain second and rst derivatives of the displacem ent eld. The latter are contained in the covariant Laplace\{B eltram i operator 4 . The term $\mathrm{s} w$ ith second derivatives can be wrilten in the four-dim ensional form $g$ @ @ where $g$ is the inverse $m$ etric to

W e retum now to propagation ofphonons in $m$ edia $w$ ith defects. A $s$ in geom etric optics [81], there are useful notions of $w$ ave fronts and rays in the analysis of the asym ptotic form of solutions for wave equations (81). W e do not consider $m$ athem atical aspects of this approach, which is nontrivial and com plicated [82], and instead give only a physical description. In the eikonal (high frequency) approxim ation, phonons propagate along rays coinciding with null extrem als for the four-dim ensionalm etric $g$. Form s of rays, which are identi ed w ith trajectories of phonons, are de ned by the three-dim ensional $m$ etric $g$. This $m$ eans that in the eikonal approxim ation, tra jectories of transverse and
longitudinalphonons in a $m$ edium w ith defects are the sam e and are de ned by Eqn 84). The di erence reduces to the velocities of propagation for transverse and longitudinal phonons being di erent and equal to $c_{t}$ and $c_{1}$, respectively.

## 13 Scattering of phonons on a wedge dislocation

C alculations in the present section coincide, in fact, w ith the analysis perform ed in Section 3 of [59]. The di erence is that in what follow $s$, we use the $m$ etric written in the elastic gauge. This is im portant because we assume that trajectories of phonons seen in an experim ent coincide $w$ ith extrem als for the $m$ etric precisely in this gauge.

In the presence of one wedge dislocation, the space $m$ etric in the cylindricalcoordinates $r_{;}{ }^{\prime} ; \mathrm{z}$ is

For positive de cit angles, the scattering angle is positive, which corresponds to repulsion of phonons from the wedge dislocation. C orresponding extrem als are show $n$ in Fig [11a, and they have asym ptotes as $r$ ! 1 . W e note that for positive de cit angles, no two points on the $r^{\prime}{ }^{\prime}$ plane can be connected by an extrem al, ie., there is a dom ain to the right of the wedge dislocation that cannot be reached at all by a phonon falling from the left.

A llextrem als shown in the gures in the present section are calculated num erically. The values of the de cit angle, the scattering angle, and the $m$ inim al distance $r_{n}$ to the dislocation axis are shown in the gures. For de niteness, we choose ' $0=$ corresponding to the fall of phonons from the left.


F igure 11: (a) E xtrem als for the wedge dislocation w ith a positive ( $>0$ ) de cit angle. Two extrem als and their re ectionsw ith respect to the $x$ axis are show $n$ for the sam e $>0$ but di erent $r_{m}$. (b) Extrem als for the wedge dislocation w ith a negative ( $1=2<0$ ) de cit angle. Two extrem als are show $n$ for the sam $e r_{m}$ but di erent de cit angles.

For negative de cit angles the scattering angle is negative and is de ned by the sam e form ulas (96). This corresponds to the attraction of phonons to the dislocation axis. In Fig [11], we show two extrem als w ith the sam e param eter $r_{m}$ but for two dislocations w ith di erent de cit angles. For $1=2 \ll 0$, the scattering angle varies from 0 to 2 (Fig 11b). For $=1=2$, the scattering angle is equal to $2 . W$ e note that for negative de cit angles, phonons have no asym ptotes as r! 1 , i.e., for $=1=2$, phonons fall from in nity ( $x$ ! $1 ; y!+1$ ) and retum to the in nity ( $x!1$;y! 1 ).

W hen the de cit angle is su ciently sm all ( $1 \ll 1=2$ ), a phonon $m$ akes one or several rotations around the dislocation and then goes to in nity. Exam ples of such tra jectories are shown in $F$ igs. 12, 14.

In the present section, we have showed how the problem of scattering of phonons on the simplest wedge dislocation is solved in the geom etric approach. The results of calculations can be checked experim entally. The m ore general problem of scattering of phonons on an arbitrary distribution ofw edge dislocations, including the edge dislocation and continuous distribution ofdislocations, is solyed in [59]. Solution ofthisproblem in the geom etric approach is sim pler than in the fram ew ork of classical elasticity theory, where we have to solve partial di erential equations w th com plicated boundary conditions. In [59], calculations were perform ed in the conform al gauge for the $m$ etric. For com parison w ith experim ent, the results m ust be recalculated in the elastic gauge, which has physical m eaning in the geom etric approach.

## 14 A n im purity in the eld of a wedge dislocation

W e consider elastic $m$ edia $w$ ith one wedge dislocation containing one atom of im purity or vacancy. If we consider the in uence of im purity on the distribution of elastic stresses sm all com pared w th the elastic stresses induced by the dislocation itself, then the otion of the im purity can be considered as taking place in three-dim ensional space w ith the nontrivialm etric (75). In the geom etric approach, we assum e that the potentialenergy of the interaction equals zero, and all interactions are due to changes in the kinetic energy, which depends explicitly on the nontrivialm etric.

W e solve the corresponding quantum m echanicalproblem. W e considerbounded states of im purity $m$ oving inside a cylinder of radius $R$ in the presence of a wedge dislocation. $W$ e assum $e$ that the cylinder axis coincides $w$ th the core of dislocation. The stationary Schrodinger equation is

If the $m$ ass of im purity and vacancy is de ned by integral [10), then $M>0$ for im purity and the energy eigenvalues are positive. For vacancy, M < 0 and the energy eigenvalues are negative. In this case, the energy spectrum is not bounded from below, which causes serious problem s for physical interpretation. It seem s that one has to insert in the Schrodinger equation not the bare $m$ ass (10) but the e ective $m$ ass, $w$ ith the contribution ofelastic stresses arising around a vacancy taken into account. This question presently rem ains unansw ered.

The presentation in the present section is close to that in [28]. In contrast to that paper, we use the elastic gauge for the $m$ etric. Therefore, our results depend not only on the de cit angle of a wedge dislocation but also on the elastic properties of the $m$ edium .

Calculations of the energy levels of an im purity in the eld of a wedge dislocation are actually equivalent to the calculations of bounded-state energies in the A haronov \{B ohm e ect [84] (see review s [85, [86]). The di erence reduces only to changing the order of the B essel functions,

The considered exam ple show show the in uence of the presence of defects is taken into account in the geom etric approach in the rst approxim ation. If calculations in som e problem w ere perform ed in elastic m edia $w$ thout defects, then to take the in uence of defects into account we have to replace the at Euclidean m etric $w$ ith a nontrivial $m$ etric describing the given distribution of defects. T his problem may appear com plicated $m$ athem atically because we have to solve the three-dim ensionalE instein equations to nd the $m$ etric. H ow ever, there are no principal di culties: the e ect of dislocations reduces to a change in the $m$ etric.

## 15 C onclusion

T he geom etric theory ofdefects describes defects in elasticm edia (dislocations) and defects in the spin structure (disclinations) from a single point of view. This model can be used for describing single defects as well as their continuous distribution. T he geom etric theory of defects is based on the R iem ann- C artan geom etry. By de nition, torsion and curvature tensors are equal to surface densities of B urgers and Frank vectors, respectively.

Equations de ning the static distribution of defects are covariant and have the sam e form as equations ofgravity $m$ odels $w$ ith dynam icaltorsion. To choose a solution uniquely, one must x the coordinate system. For this, the elastic gauge for the vielbein and the Lorentz gauge for the SO (3) connection are proposed. In the defect-free case the displacem ent vector eld and the eld of the spin structure can be introduced. Equations of equilibrium are then identically satis ed, and the gauge conditions reduce to the equations of elasticity theory and the principal chiral SO (3)- eld. In this way, the geom etric theory of defects inconporates elasticity theory and the model of principal chiral eld.

In a certain sense, the elastic gauge represents the equations of the nonlinear elasticity theory. N onlinearity is introduced in elasticity theory in tw o ways. First, the deform ation tensor is de ned through the induced $m$ etric

instead of being de ned by linear relation (4). Then the stress tensor is given by an in nite series in the displacem ent vector. Second, Hook's law can be modi ed assum ing nonlinear dependence of the stress tensor on the deform ation tensor. H ence, the elastic gauge condition is the equations of the nonlinear elasticity theory where the deform ation tensor is assum ed to be de ned through the induced m etric and Hook's law is kept linear. A generalization to the nonlinear dependence of the deform ation tensor on the stress tensor is obvious.

A s an exam ple, we considered the wedge dislocation from the standpoint of the elasticity theory and the geom etric theory of defects. W e show ed that the elasticity theory reproduces only the linear approxim ation of the geom etric approach. In contrast to the induced $m$ etric obtained w ithin the exact solution of the linear elasticity theory, the expression for the $m$ etric obtained as the exact solution of the Einstein equations in the elastic gauge is sim pler and is de ned on the whole space and for all de cit angles. T he obtained expression for the $m$ etric can be checked experim entally.

T wo problem s are considered as applications of the geom etric theory of defects. The rst is the scattering of phonons on a wedge dislocation. In the eikonal approxim ation, the problem is reduced to the analysis of extrem als for the $m$ etric describing a given dislocation. Equations for extrem als are integrated explicitly, and the scattering angle is found. The second of the considered problem $s$ is the construction of the wave fiunctions and energy spectrum of im purity in the presence of a wedge dislocation. This requires solving the Schrodinger equation. This problem is $m$ athem atically equivalent to solving the Schrodinger equation forbound states in the A haronov \{B ohm e ect 86]. The explicit dependence of the spectrum on the de cit angle and elastic properties of the $m$ edium is found in the presence of a wedge dislocation.

The geom etric theory of static distribution of defects can also be constructed for $m$ em branes, i.e., on the plane $\mathrm{R}^{2}$. For this, one has to consider the E uclidean version [87] oftwo-dim ensionalgravity with torsion [88\{90]. This m odel is favored by its integrability [91\{94].

The developed geom etric construction in the theory of defects can be inverted, and we can consider the gravitational interaction ofm asses in the universe as the interaction of defects in elastic ether. Point $m$ asses and cosm ic strings [95, 96] then correspond to point defects (vacancies and im purities) and wedge dislocations. In this interpretation of gravity, we have a question about the elastic gauge, which has direct physicalm eaning in the geom etric theory of defects. If we take the standpoint of the theory of defects, then the elastic properties of ether correspond to som e value of the P oisson ratio, which can be $m$ easured experim entally.

It seem $s$ interesting and im portant for applications to include tim e in the considered static approach for describing $m$ otion of defects in the $m$ edium. Such a model is lacking at present. From the geom etric standpoint this generalization can be easily perform ed, at least in principle. It is su cient to change the Euclidean space $R^{3}$ to the M inkow ski space $R^{1 ; 3}$ and to w rite a suitable Lagrangian quadratic in curvature and torsion, which corresponds to the true gravily $m$ odel with torsion. O ne of the arising problem $s$ is the physical intenpretation of the additional com ponents of the vielbein and Lorentz connection that contain the tim e index. The physical meaning of the tim e com ponent of the vielbein $e_{0}{ }^{i}$ ! $@_{0} u^{i}=v^{i}$ is simple $\{$ this is the velocity of a point of the $m$ edium. This interpretation is natural from the physical standpoint because the $m$ otion of continuously distributed dislocationsmeans a ow ing of the $m$ edium. In fact, the liquid can be im agined as the elastic $m$ edia $w$ ith a continuous distribution of $m$ oving dislocations. $T$ his $m$ eans that the dynam ical theory of defects based on the $R$ iem ann \{C artan geom etry $m$ ust include hydrodynam ics. It is not clear at present how this can happen. Physical interpretation of the other com ponents of the vielbein and the Lorentz connection $w$ ith the tim e index also rem ains unclear.

## A ppendix. Som e di erential geom etry

In the appendix, we brie y present them ain facts from di erentialgeom etry and introduce the notation used in this review. The description is given in local coordinates, which is su cient for our purposes. W e recom $m$ end [97] as a textbook on di erential geom etry.

If the $m$ etric $g$ and the a ne connection are given, then we say that the geom etry is de ned on a di erentiable $m$ anifold $M$, dm $M=m$. We assume that all elds on the $m$ anifold are given by $s m$ ooth $C^{1}(M)$ functions except, possibly, som e singular points, and do not stipulate that in what follow s . $W$ e also assum $e$ that them anifold $M$ is topologically trivial, i.e., di eom onphic to the Euclidean space R ${ }^{m}$.

In general, the connection has no sym $m$ etry in its indices and is not related to the $m$ etric $g$ in any way because these notions de ne di erent geom etric operations on a $m$ anifold $M . W$ e then say that the a ne geom etry is given on $M . W$ e em phasize that the $m$ etric and the a ne connection are de ned arbitrarily and are com pletely independent geom etric notions. Therefore, in the construction of physical m odels, they can be considered independent elds having di erent physical interpretations.

If the a ne geom etry is given on a $m$ anifold, then we can construct the nonm etricity tensor $Q$ that is by de nition equal to the covariant derivative of the $m$ etric:

W e stress once again that all three ob ject can be speci ed in a com pletely arbitrary way, and they can be considered di erent dynam ical variables in $m$ odels of $m$ athem atical physics.

A geodesic line is a curve such that a vector tangent to it rem ains tangent under parallel transport along the curve. In $R$ iem annian geom etry, geodesics and extrem als alw ays coincide.

The prim ary role in di erential geom etry is played by the curvature tensor of the a ne connection, which arises in di erent contexts. In local coordinates, it is de ned by the expression

C ontraction of the curvature tensor in the two indioes yields the R ioci tensor $\mathrm{R}=$ $R \quad$, which is also de ned entirely by the connection. In $R$ iem annian geom etry, the $R$ iocitensor for the Levi-C ivita connection is sym $m$ etric $w$ ith respect to the perm utation of indices: $\mathbb{P}=\mathbb{R}$. In a $R$ iem ann $\{C$ artan geom etry, this sym $m$ etry is generally absent for a nonzero torsion tensor.

If a m etric is also given on a $m$ anifold, then we can construct the scalar curvature $R=R \quad g$.

The a ne connection is called locally trivial if in the neighborhood of every point one can choose the coordinate system in which all com ponents of the connection are zero. Now we form ulate two im portant theorem s.

Theorem 1. For the localtriviality of the a ne connection it is necessary and su cient that its torsion and curvature tensors are equal to zero on M.

The proof of this theorem is reduced to an analysis of the transform ation rule for the a ne connection com ponents in (106). If in the new coordinate system the sym $m$ etric part of the connection com ponents is equal to zero, then the system of di erential equations for the transition functions appears. The local integrability condition for this system of equations is provided by the equality of the curvature tensor to zero.

A $m$ ore thorough statem ent is proven in (99].
Theorem 2. If for a given a ne geom etry the torsion, nonm etricity, and curvature tensors are equal to zero on the whole $m$ anifold, then this $m$ anifold is isom etric either to the whole (pseudo-)E uclidean space $R^{m}$ or to the quotient space $R^{m}=G$, where $G$ is a discreet transform ation group acting freely.

In the last theorem, we suppose that both the $m$ etric and a ne connection are given on a manifold.

The $R$ iem ann \{C artan geom etry de ned by the $m$ etric and torsion provides the basis for the geom etric theory ofdefects. In the analysis of such $m$ odels, it is $m$ ore convenient to introduce the C artan variables: the vielbein and SO ( $m$ ) connection instead of the $m$ etric and torsion. W e assum e here that a m etric on a $m$ anifold is positive de nite. If a $m$ etric were not positively de nite then the SO $(p ; q)$ connection would appear, where $p+q=m$.

For a R iem annian $m$ etric, the orthonorm alvielbein $e^{i}(x), i=1 ;::: ; m$, is de ned by the system of quadratic equations

There are also other topological restrictions for the global existence of a vielbein that we do not discuss here.

The coordinate basis @ of the tangent space in every point of $M$ is called holonom ic. $C$ om ponents of tensors of an arbitrary type $m$ ay also be considered $w$ ith respect to the unholonom ic basis $e_{i}$ of tangent spaces de ned by the vielbein. For exam ple, a vector eld has the com ponents

For a given vielbein, this relation provides a one-to-one correspondence between com ponents of the connections and ! $j^{i}$. The SO ( $m$ ) connection de nes covariant derivatives for com ponents of tensor elds relative to an unholonom ic basis. For exam ple,

The covariant derivative is naturally de ned for a tensor eld having both $G$ reek and Latin indiges. Taking the covariant derivative of Eqn (120) leads to the antisym $m$ etry of the components ! ${ }^{i j}=!{ }^{\text {ji }}$. Thismeans that the 1 -form $d x!j^{i}$ takes values in the Lie algebra so ( $m$ ), and this indeed corresponds to the SO (m) connection.

In the general case of an a ne geom etry, the $C$ artan variables can also be de ned by relations (120) and (121). For this, we have to replace the K ronecker sym bol on the righthand side of (120) w ith an arbitrary nondegenerate sym $m$ etric $m$ atrix $i j^{i j}$. In this case, relation (121) de nes a linear GL( $m$; $R$ ) connection. In the R iem ann \{C artan geom etry $w$ ith the Lorentzian-signature $m$ etric, we would have the Lorentz $S O(1 ; m \quad 1)$ connection.

W e consider local rotationsw th a m atrix $S_{j}{ }^{i}(x) 2 S O(m)$ to show that the com ponents $!{ }_{j}{ }^{i}$ do de ne an SO $(m)$ connection in the R iem ann \{C artan geom etry. By de nition, the com ponents of vector elds and 1-form stransform under local rotations according to the nule

This is the transform ation law for the SO ( $m$ ) connection, indeed. The sam e transfor$m$ ation law follows from de nition [121) if the vielbein $e^{i}$ transform $s$ as a vector $w$ th respect to the index $i$, and the C hristo el sym bols rem ain unchanged.

O f course, we can introduce the $m$ etrical and $S O(m)$ connections on $M$ in an independent way. If we require afterwards that the $S O(m)$ connection acts on tensor eld com ponents relative to an unholonom ic basis de ned by the vielbein, we obtain a one-toone correspondence betw een the com ponents of the connections (121).

W e now express the com ponents of the $m$ etric connection through the vielbein $e^{i}$ and $S O(m)$ connection ! $j^{i}$ w th the help of relation (121) and substitute them into the de nitions of torsion (109) and curvature (119). As a result, we obtain expressions for torsion and curvature in term s of the C artan variables

An SO (m) connection ! $j^{i}$ is called locally trivial if every point has a neighborhood containing this point such that it has the form

O bviously, after local rotation w the the atrix $S{ }^{1}{ }_{j}{ }^{i}$, all com ponents of the connection becom e zero. This connection is also called a pure gauge. O ne can easily verify that the curvature ofa locally trivialconnection identically vanishes. The inverse statem ent is also valid.

Theorem 3. An SO (m) connection is locally trivial if and only if its curvature form is identically zero on M.

This theorem is valid for any structure Lie group. The proof is reduced to an analysis of transform ation rule (124). If the left-hand side of this equation is zero, then we have a system of equations for the eld $S_{j}{ }^{i}(x)$ for which vanishing of curvature tensor is the local integrability condition.

The space w ith zero curvature tensor $R \quad j^{i}=0$ is called the space of absolute parallelism because the paralleldisplacem ent of a vector does not depend on the path connecting two xed points of the $m$ anifold.

W e can perform a localSO (m) rotation for the locally trivialSO (m) connection such that it becom es zero: ! $j^{i}=0$. Then, the zero-torsion equality becom es

form functions $y^{i}(x)$. A solution of this system ofequations yields the transition functions to $C$ artesian coordinates. Thus, the equalities of curvature and torsion tensors to zero are the necessary and su cient conditions for the existence of the elds $S j_{j}^{i}(x)$ and $y^{i}(x)$, i.e., the existence of such a local rotation and coordinate system where the connection vanishes and the $m$ etric becom es Euclidean. W e note that equality of torsion tensor to zero alone is not enough for the existence of a C artesian coordinate system.

Three-dim ensional space is considered in the geom etric theory of defects. W e m ake two rem arks conceming this. In lower dim ensions, the algebraic structure of the curvature tensor w ith all low ered indexes becom es much sim pler. In two dim ensions the full curvature tensor in the R iem ann \{C artan geom etry is in the one-to-one correspondence w ith its scalar curvature:

These form ulas are also correct for nonzero torsion.

The R iem annian scalar curvature on the right-hand side of this equality is constructed only from the vielbein for zero torsion.
