E ect of the Casim in-Polder force on the collective oscillations of a trapped Bose-Einstein condensate

Abstract

W e calculate the e ect of the interaction between an optically active material and a Bose-E instein condensate on the collective oscillations of the condensate. W e provide explicit expressions for the frequency shift of the center of mass oscillation in terms of the potential generated by the substrate and of the density prole of the gas. The form of the potential is discussed in details and various regimes (van der W aals-London, C asim in-P older and therm al regimes) are identified as a function of the distance of atoms from the surface. Numerical results for the frequency shifts are given for the case of a sapphire dielectric substrate interacting with a harmonically trapped condensate of 87 Rb atoms. We nd that at distances of 4 8 m, where therm all e ects become visible, the relative frequency shifts produced by the substrate are of the order 10 ⁴ and hence accessible experimentally. The elects of non linearities due to the nite amplitude of the oscillation are explicitly discussed. Predictions are also given for the radial breathing mode.

I. IN TRODUCTION

The study of the force felt by an atom near a surface has recently become a popular subject of research (see for example [1],[2] and references therein) both in view of nanotechnological applications [3] and because of the possibility of investigating fundamental forces at the submicron scale [4]. These studies extend previous investigations of the generalized van der W aals forces between macroscopic bodies [5] to more microscopic systems. Experiments with Bose-Einstein condensates near a surface [6, 7, 8] are very promising in this respect because of the high accuracy of the measurements achievable with ultracold gases.

H istorically the interatom ic forces were inst introduced in 1873 by van der W aals in order to explain the deviations of the therm odynam ic behaviour of real gases from the ideal laws. Only in 1930 London [9] provided a inst quantitative description of the force. He applied second order perturbation theory to the quantum H am iltonian to evaluate the electrostatic interaction between two dipoles, induced by the inclusion of the electrom agnetic eld. He succeeded in deriving the most fam ous power law $1=d^6$, usually known as the van der W aals-London interaction, where d is the interatom ic distance. A lm ost twenty years later, in 1948, C asim ir and Polder [10], taking into account relativistic retardation elects within fourth order perturbation theory, found that, at large distances, the potential decays like $1=d^7$ rather than like $1=d^6$.

The existence of these attractive forces between neutral atoms gives rise to analogous forces between a single atom and a dielectric or a metallic wall, as well as to forces between m acroscopic bodies separated by small distances [11]. Between the end of the files and the beginning of sixties Lifshitz developed the general theory of the van der W aals forces [12, 13] for inhom ogeneous media, taking into account the quantum uctuations of the electrom agnetic eld and their perturbation produced by the media. The theory describes the interaction between continuous media in terms of their dielectric functions and of the tem perature. The van der W aals-London and C asim in Polder forces are recovered as limiting cases of the more general theory, which also accounts for the elects induced by the them al

of the interaction at distances much larger than the therm alwave length of photons.

The purpose of the present work is to show that the study of the collective oscillations of a Bose-E instein condensate of ultracold atom s can provide a useful probe of such forces.

Bose-E instein condensates are very dilute sam ples and consequently the force produced by the surface can be safely calculated starting from the interaction felt by the individual atom s in the condensate [11]. In this paper we will be mainly concerned with the center of m ass oscillation of a condensate con ned by a harm onic trap. The center of m ass motion has the main advantage of being independent of two-body interactions and its frequency consequently provides an ideal probe of the additional force generated by the wall. The e ect of the force on the frequency of the center of m ass oscillation depends on the distance of the condensate from the surface, on the temperature of the surface as well as on the optical properties of the condensate which in actual con gurations can be of the sam e order as the distance from the wall. In some limiting cases, corresponding to short and large distances, it is possible to obtain analytic or sem i-analytic predictions that will be discussed system atically in ourpaper. They can serve as a natural guide for rst quantitative estim ates and as useful tests of m ore complete num erical approaches.

The paper is organized as follows:

In sect 2 we derive some general results for the shift of the collective frequencies of a harm onically trapped B ose-E instein condensate subject to an additional weak external force.

In sect.3 we employ Lifchitz theory to calculate the force acting on a dilute atom ic gas placed near a surface.

In sect. 4 we discuss the transition from the van der W aals-London potential, holding at very short distances from the surface and decaying like $1=d^3$, to the Casim ir-Polder potential which accounts for relativistic retardation e ects and holds at larger distances where it decays like $1=d^4$.

In sect. 5 we discuss the transition from the $1=d^4$ law characterizing the Casim ir Polder potential to the behaviour of the potential at much larger distances from the surface (larger than the therm alwavelength of photons) where it decays like $1=d^3$ as a consequence of the therm al uctuations of the electrom agnetic eld.

In sect. 6 we discuss the role of the optical properties of the interacting media with specic c emphasis to the case of the dielectric sapphire (A l_2 O $_3$) substrate and of the Rubidium atom s which form the condensate.

In sect. 7 we provide results for the shifts of the collective frequencies as a function of the distance of the condensate from the surface, calculated at di erent tem peratures.

F inally, in Appendix A1 we provide results for the frequency shift of the radial compression m ode in very elongated harm onic traps.

II. CENTER OF MASS OSCILLATION OF A TRAPPED GAS IN THE PRES-ENCE OF A WEAK PERTURBATION.

A fier the rst experimental realization of Bose-E instein condensation in dilute vapours of alkali atoms the experimental and theoretical research in the eld of ultacold quantum gases has grown in an impressive way (for general reviews see, for example, [14, 15, 16, 17]). Bose-E instein condensed gases are dilute, ultracold samples characterized by unique properties of coherence and super uidity. They give rise, among others, to interference phenomena [18, 19] as well as to a variety of collective oscillations [20, 21, 22]. The relatively high density of Bose-E instein condensed samples (compared to the one of non condensed trapped gases), as well as the possibility of in aging the atom ic cloud after expansion, where the measured sizes become an acroscopically large, permit to achieve very accurate determinations of the frequencies of the collective oscillations, thereby providing interesting opportunities for precision measurements.

In this section we will calculate the e ect of a weak perturbation on the center of m ass oscillation of a harm onically trapped gas. The frequency of this oscillation, in the absence of the perturbation, coincides with the frequency of the trap. This result, also known as K ohn theorem [23], is independent of the amplitude of the oscillation, interatom ic forces, tem perature as well as of the quantum nature of the sample. D eviations of the m easured frequency from the oscillator value can then be used as a useful probe of additional interactions, like the one generated by the surface. In Fig.1 we show a schem atic representation of the geometry considered in the present work. A dilute gas trapped by the harm onic potential

is placed close to an ideal wall generating a potential $V_{surf}(z)$ so that the full potential felt by each atom is given by

In the follow ing we will calculate the changes in the frequency of the center of mass oscillation along the z-th direction caused by the presence of the surface. In the appendix we provide results also for the radial breathing mode in the case of very elongated axi-sym metric traps

The equations for the center of mass coordinate $Z_{CM} = (1=N)h^{P} \sum_{i=1}^{N} z_{i}i$ and the total momentum $P_{z} = h^{P} \sum_{i=1}^{N} p_{z_{i}}i$ along the z-th direction (N is the number of atoms of the trapped gas) can be written in the general form

where we have used expression (1) for V_{ho} and we have expressed the average of the external force $\mathcal{Q}_z V_{surf}$ in terms of the density n of the gas here assumed to be normalized to unity $\stackrel{R}{(}$ drn = 1). Notice that the equation for the total momentum is not a ected by the twobody potential. In the absence of the perturbation ($V_{surf} = 0$) one recovers the equations of the harmonic oscillator and the center of mass oscillation corresponds to a rigid oscillation of the density. The e ect of the perturbation V_{surf} can then be calculated, in rst order perturbation theory, using the scaling ansatz n (r;t) = n_0 (x;y;z Z_{CM} (t)) in (4), where n_0 is the equilibrium density of the gas. The equation for the center of mass coordinate nally takes the simple form

where, in the integral, we have m ade the substitution $(z Z_{CM})$! z. Equations (3) and (5) have now a closed form. In the lim it of sm all oscillations we can expand the perturbation term up to term s linear in Z_{CM} (t) and the equation for the center of m ass takes again a harm onic form with the renorm alized oscillator frequency

It is worth stressing that result (6) is exact up to f rst order corrections in V_{surf} and holds independently of the quantum or classical nature of the gas which instead determ ines the

actual form of the density pro $le n_0$. Eq.(6) can be further simplied by introducing the so called 1D column density

Equation (8) shows that the ingredients needed to calculate the e lect of the perturbation on the shift of the center of m ass frequency are the explicit form of the potential V_{surf} , which will be discussed in the following sections, and the 1D column density (7). For a Bose-Eintsein condensate in its ground state the density prole is easily evaluated in the so called Thom as Ferm i approximation. This approximation holds for large condensates where, for gases interacting with positive scattering length, the kinetic energy of the trapped condensate can be neglected and one inds the analytic result $[14] n_0 (x;y;z) = g^{-1}$ ($V_{ho}(r)$) when $n_0 = 0$ and 0 elsewhere. Here $= (\sim !_{ho}=2) (15N = a_{ho})^{2=5}$ is the chemical potential, N is the number of atom s, $!_{ho} = (!_x !_y !_z)^{1=3}$ is the geometrical average of the three trap frequences, $a_{ho} = \frac{p}{\sim = (m !_{ho})}$ is the oscillator length and $g = 4 \sim^2 a=m$ is the interaction coupling constant is well by the swave scattering length a. Integration of n with respect to x and y yields

where R_z is the Thomas-Fermi radius in the z-th direction, xed by the relation = $m \frac{1}{2}R_z^2=2$. Typical values for R_z in standard experimental conditions can be of the order of a few microns [25].

Equations (8) and (9) are the key result of this section and will be used in the second part of the paper to calculate the e lect of the force produced by the surface on the frequency shift of the center of m assoscillation. The integral (8) should be in general carried out num erically. There are, how ever, in portant cases where the integration can be found analytically. This is the case, for example, if one can approximate the potential with the algebraic decay $V^{(n)}(z) = a_n = (d + z)^n$ where d is the distance between the wall and the center of the harm onic trap [24]. In this case we not the result

for the most relevant n = 4 and n = 3 cases, respectively, where $R_z=d$. Results (10) and (11) explicitly point out the role played by the nite size of the condensate. In particular, only in the limit R_z d (1) will the above equations approach the power law behaviours $1=d^6$ and $1=d^5$ for the frequency shift expected for a point-like condensate.

The above results have been derived in the linear regime. If the amplitude of the oscillation is comparable to the distance from the surface non linear elects become important and modify the value of the frequency shift. Non linear elects result in a frequency shift as well as in the occurrence of higher harmonics. They can be calculated starting from the general equations (3) and (5) for the center of mass coordinate. Notice that, due to the harmonic nature of V_{ho} , both elects are absent if $V_{surf} = 0$. Due to the perturbative nature of the problem we can use the periodic law $Z_{CM} = a \cos(!_{CM} t)$ to evaluate the integral of (5), where a is the amplitude of the oscillation. One can then introduce the periodic function

which can be conveniently expanded in a Fourier series. For the calculation of the frequency shift only the term proportional to $\cos(!_{CM} t)$ is important and one can write

Expansion of (13) up to term s quadratic in a and use of the 1D column density nally yield the result

for the frequency shift which generalizes eq.(8) by including the non linear correction in a^2 .

III. FORCE BETW EEN THE SURFACE AND A SINGLE ATOM .

The interaction produced by a surface on a single atom includes, in its general form, non trivial relativistic e ects as well as quantum and therm al uctuations of the eld. The force can be calculated starting from the general theory devoloped by Lifchitz for the free energy

associated with inhomogeneous media. For two plates separated by a distance d and in them all equilibrium with the therm all radiation at tem perature T, the force F_{surf} per unit surface can be written as [13]

where, with respect to the usual presentation of the force, we have separated a set term behaving like $k_B T = d^3$ from the other term s with n 1. In eq.(15) we have de ned

where $"_1 = "_1(i_n)$ and $"_2 = "_2(i_n)$ are the relevant dielectric functions of the two plates, evaluated for imaginary values $! = i_n$ of the frequency, with $_n = 2 k_B T n = ~$. The function "(i_) is a monotonic and real function of , obtained by analytic continuation of the non monotonic and complex function "(!) evaluated for real values of the frequency !. Furthermore in eq.(15) we have introduced the static values of the dielectric functions $"_{10} = "_1(0)$ and $"_{20} = "_2(0)$. Som e general properties of these functions will be illustrated in sect V I.

The force produced by a surface on a single atom can be easily derived by assuming that one of the two walls (wall 2) is made of a very dilute material (for example a gas) so that one can expand eq.(15) for small values of $_2$ 1 = 4 n where n is the density of the gas and is the corresponding atom ic polarizability. The potential V_{surf} felt by a single atom is then simply given by $V_{surf} = F_{surf} = n$ and can be written in the form [13]:

where we have introduced the function f (p) de ned by

In eqs.(17) and (18) we have om itted the index 1 in the dielectric function characterizing the optical properties of the surface while $"_0$ and $_0$ are the static values of the dielectric

function and of the atom ic polarizability, respectively. Equation (17) perm its to describe both the interaction generated by a dielectric and by an ideal metal (in the latter case the function (!) behaves like 1=! at small ! and $\begin{pmatrix} 0 \\ 0 \end{pmatrix} = \begin{pmatrix} 0 + 1 \end{pmatrix} = 1$.

Eqs. (15) and (17) have been derived assuming that the whole system is in them odynamic equilibrium and in particular that its components have the same temperature T. In the experiments with Bose-E instein condensates the atom ic gas is cooled down to extremely low temperature, while the substrate remains at room temperature. Result (17) is still expected to be valid in this case, T being the temperature of the substrate. In fact atom s, independently of being at zero or at room temperature, do not contribute to the therm al radiation, their lowest excitation energies being much higher than $k_B T$.

It is useful to identify the relevant length scales of the problem (see g_2). A rst important length is the therm alwavelength of the photon:

where k_B is the Boltzm ann constant. At room temperature (T = 300K) one has $_T = 7.6 \text{ m}$. For distances d larger than $_T$ the force is dominated by the thermal uctuations of the electrom agnetic eld. In this limit the leading contribution is given by the rst term in eq.(17), due to the occurrence of the exponential factor in the other terms, and the potential takes the characteristic form

Notice that in this regime only the static value of the dielectric and polarizability functions contribute to the force. It is also worth noticing that in this lim it the force is independent of the P lanck constant as well as of the velocity of light.

For distances d smaller (or of the same order) than $_{\rm T}$ the quantum uctuations of the electrom agnetic eld become important and the terms of the sum (17) should be taken into account. If d $_{\rm T}$ and T is su ciently small, one can replace the sum with an integral (see sect.IV). In this regime one can introduce a second length scale, hereafter called $_{\rm opt}$. This length is related to the relevant wavelengths characterizing the optical properties of the interacting media. One can identify two distinct regimes. For distances d $_{\rm opt}$ the potential exhibits the familiar 1=d³ van der W aals-London dependence. In the interval $_{\rm opt}$ d $_{\rm T}$ one instead enters the Casim in-Polder regime where the potential decays

like 1=d⁴. The possibility of identifying the Casim in-Polder regime depends crucially on the value of the temperature. The temperature should be in fact su ciently low in order to guarantee the condition $_{T}$ $_{opt}$ (see discussion at the end of sect. V). Di erently from the therm alwawelength, given by the simple expression $_{T}$, the explicit evaluation of $_{opt}$ is not immediate because the optical properties of the media are not characterized by a single frequency (see sect.VI). In the case of Rubidium atoms interacting with a dielectric sapphire substrate we nd $_{opt}$ 0:1 m.

IV. THE FORCE AT SHORT DISTANCES: FROM THE VAN DER WAALS-LONDON TO THE CASIM IR-POLDER REGIME.

A santicipated in the preceding section at distances smaller than the thermal wavelength also the term s in the sum (17) contribute to the force and, if d P_n^T and the term perature is su ciently low, the sum is conveniently replaced by an integral: P_n^R ! (~=2 k_BT)^R d . One then nds the useful expression

for the potential, also called short range (SR) approximation. It is worth noticing that result (21) does not depend on the value of T [26] and coincides with the zero temperature limit of the general form (17) of the potential. Equation (21) admits two important limits. For large d one nds the most famous expression

which is equal to 1 in the case of an ideal metal (" $_0 = 1$). For sapphire ($_0 = 9:4$) one nds (" $_0$) = 0:8

In the opposit lim it of smalld one instead nds the dierent law

also know as the van der W aals-London (VL) interaction. The coe cient characterizing this force is xed by the optical properties of the media. The matching between the two laws (22) and (24) provides a useful estimate of the optical length $_{opt}$ according to

In g. 3 we show the potential (21) (dashed-dot line) calulated using the dielectric functions of Rubidium atom and of sapphire. The asymptotic laws $V_{surf}^{VL} = 68:1=d^{3}[nK (m)^{3}]$ for the van der W aals (see eq.(24)) and $V_{surf}^{CP} = 8:34=d^{4}[nK (m)^{4}]$ for the C asim ir-Polder (see eq. (22)) potentials, as well as the asymptotic therm al law $V_{surf}^{T} = 2:86=d^{3}[nK (m)^{3}]$ evaluated at T = 300K (see eq.(20)), are also shown (d is here expressed in m icrons). It is worth noticing that the potential (21) approaches the asymptotic C asim ir-Polder force only at distances signing cantly larger than opt.

V. THE FORCE AT LARGE DISTANCES AND THE STATIC APPROXIMA-TION:QUANTUM VSTHERMAL EFFECTS.

At large distances from the wall the potential (17) can be safely evaluated in the so called static approximation (SA) which consists of replacing the dielectric functions " and with their static values " $_0$ and $_0$ respectively. In the static approximation the potential generated by the surface can be written in the useful form

The asymptotic behaviours of the function G (y) are well established: for y ! 0 one nds G (y) ! 3 ("_0)=(2 y). Viceversa for y ! 1 one nds G (y) ! 1. For a xed value of T the two lim its apply, respectively, to distances larger and smaller than the therm alwavelength (19). It then follows that the static approximation (26) provides the transition from the Casim in Polder law (22) holding for $_{opt}$ d $_{T}$, to the thermal law (20) holding for d $_{T}$. In g.4 we show the scaling function G (y) together with the two asymptotic lim its y ! 0 and y ! 1 in the case of sapphire where we have used the value $_{0}$ = 9.4. The function G (y) depends rather smoothly on the actual value of the static dielectric function, provided the value "_0 is signil cantly larger than 1.

In g. 3 we compare the prediction for the potential given by the static approximation with the exact result evaluated starting from eq.(17). The comparison shows that for distances larger than 2 m the static approximation is rather accurate. This explains why the predictions of this approximation for the frequency shifts are also accurate (see gs 5 and 6).

At shorter distances the static approximation fails and one should instead use the short range description developed in sect.IV. If $_{\rm T}$ $_{\rm opt}$ the long range description based on the static approximation matches the short range description of sect IV in the Casim ir-Polder regime (22). In this case the matching procedure completes the determination of the potential at all distances. If instead the condition $_{\rm T}$ $_{\rm opt}$ is not well satisfied one should calculate explicitly the potential using the general expression (17) and the potential will not exhibit the intermediate Casim ir-Polder behaviour (22). For example in the case of g.3, where the potential is calculated at T = 300K, the matching between the two curves is not very good and consequently the system never exhibits the Casim ir-Polder behaviour [27].

VI. OPTICAL PROPERTIES OF THE ATOM AND OF THE SUBSTRATE

The functions (i) and (i), which are crucial ingredients for the calculation of the potential generated by the surface, obey the K ram ers-K ronig relations

where $"^{0}$ is the in aginary part of the dielectric function $" = "^{0} + i"^{0}$ evaluated on the real axis. For the polarizability one has the analogous relationship

where ⁰⁰ is the imaginary part of the atom ic polarizability = 0 + i 00 .

The imaginary part of the dielectric function can be related to the measurable real an imaginary parts of the refraction index $n(!) = n^{0}(!) + in^{00}(!)$ according the equation $"^{(0)}(!) = 2n^{(0)}(!)n^{(0)}(!)$. The values of $"^{(0)}(!)$ (data taken from [30]) and (i) for sapphyire are reported on gs. 7 and 8. From the optical point of view, crystalline sapphire is an uniaxial crystal and one should distinguish between the ordinary and extraordinary refraction indices. Since the optical properties for sapphire are not completely known, in our calculations we have used only the data for ordinary waves. We expect that this approxim ation will not signi cantly a ect the analysis in both crystalline and melted sapphires. In g. 9 we report the corresponding values for (i) for⁸⁷Rb [29]. The static value of the polarizability is $_0 = 47.3$ 10^{24} cm³. Figure 7 shows that the optical properties of sapphire are rather complex so that the actual value of opt governing the transition from the van der W aals-London to the Casim in-Polder regimes cannot be simply inferred from the form of 00 , but requires the explicit calculation of the integral (25). The typical \two plateau" behaviour exhibited by "(i) in solid dielectrics is the consequence of the concentration of the strength " $^{(0)}(!)$ in two distinct regions of frequencies (see gs 7 and 8). This behaviour is absent in the atom ic polarizability (see g. 9). Using eq. (25) it is possible to calculate the value of opt. In the case of the sapphire substrate interacting with Rubidium atom swe nd $_{opt} = 0:1 \text{ m}$.

VII. RESULTS FOR THE SHIFT OF THE CENTER OF MASS OSCILLATION

We are now ready to calculate the shifts of the center of mass frequencies of the condensate caused by the force generated by the surface. We will consider a condensate of nite Thom as-Ferm i radius R_z located ad distance d from the surface (see g.1). We will evaluate the fractional frequency shift

with $!_{CM}$ given by eq.(8), as a function of the distance d at di event temperatures. As discussed in the preceding sections, the behaviour of the potential V_{surf} at short distances is tem perature independent and coincides with the zero tem perature value. Conversely, at distances of the order of the therm al wavelength, or larger, the potential exhibits an in portant tem perature dependence. This behaviour is rejected in the shift of the center of mass frequency of the condensate for which we provide our predictions in g. 10 at di erent tem peratures. The curves of this qure have been calculating using the general espression (17) for the potential. In the calculation we have used the values !=2 = 220 Hzfor the harm onic trapping frequency along the z-th direction and $R_z = 2.5$ m for the zth radius of the condensate. These are typical values employed in current experiments with Bose Einstein condensates. We have used a sapphire substrate and the condensate is made of ⁸⁷Rb atom s. Our predictions show that at distances d 4 8 m, where the therm al e ects start becoming in portant at room tem perature, the frequency shifts are of the order of 10⁴. These results are promising in view of the possibility of system atic measurem ents of the interplay between quantum and therm ale ects in the generalized van der W aals forces.

It is also interesting to compare the predictions for the shifts of the collective frequencies with the results obtainined using the static approximation, holding at large distances (see sect.V). The comparison (see gs. 5 and 6) shows that the static approximation (26) provides an accurate decription of the shifts for distances larger than 4 m, even at zero temperature. At shorter distances the deviations become m ore important. One should actually notice that at short distances the width of the condensate plays an important role amplifying the e ects of the short range component of the potential.

Let us nally discuss the e ects of non linearities on the frequency shift. If the amplitude of the oscillation is not small additional corrections due to the external force should be taken into account (see sec.II). The corresponding corrections can be estimated using result (14). For example, by choosing a = 0.5 m and making the same choices for the other parameters ($R_z = 2.5 \text{ and } !_z=2 = 220 \text{ H z}$), we not that the prediction for the frequency shift (32) is increased, in absolute value, by 20% at d = 6 m. This result shows that for larger choices of the amplitude of the oscillation and for smaller values of d the extension linearity can become every in portant. In general they should be calculated starting directly from eq.(12) and (13).

VIII. CONCLUSIONS

In this work we have applied Lifshitz theory of generalized van der W aals interactions to investigate the e ect of a substrate on the collective oscillations of a trapped quantum gas. We have st developed the general theory for the frequency shifts of the center of mass oscillation caused by a perturbative force of general form. We have hence characterized the potential generated by the surface identifying various relevant regimes. A rst approxin ation, holding at short distances d from the surface, permits to describe the transition from the van der W aals-London $1=d^3$ law to the C asim ir-Polder $1=d^4$ regime characterized by quantum and relativistic e ects. A second approximation, holding at larger distances, perm its to describe the transition from the Casim ir-Polder law to the large distance $k_{\rm B} T = d^3$ behaviour, dom inated by the therm al uctuations of the electrom agnetic eld. We have also identi ed the relevant length scales of the problem and explored the matching conditions for the various approximations. Due to the nite size of the condensate the calculation of the frequency shifts requires a num erical integration, although analytical expressions can be obtained in some limiting cases. The calculation requires the explicit know ledge of the optical properties of the interacting media and in particular the dieletric function of the substrate and the atom ic polarizability of the atom s in the condensate. We have also exploited the e ects of nonlinearity and shown that, due to the nite width of the condensate, they can provide large corrections to the frequency shifts and should be consequently taken into account in the comparison with future experiments. We have nally derived (see the Appendix) results for the frequency shifts of the radial breathing mode.

O ur predictions are rather promising and suggest that Bose-E instein condensates can become e cient sensors of very weak forces. In particular the oscillation of the condensate perm it to explore the interplay between quantum and them all uctuations of the electromagnetic eld in the relevant region of 4 8 m. For such distances the relative shifts are predicted to be of the order of 10⁴ and are hence measurable experimentally.

X. APPENDIX: FREQUENCY SHIFT OF THE RADIAL BREATHING MODE.

The radial breathing oscillation in elongated traps is a fundamental mode exhibited by Bose-Einstein condensates. For an interacting Bose-Einstein condensate, harmonically trapped in two dimensions, this mode exactly occurs at twice the trapping radial frequency (we assume here symmetric trapping: $!_x = !_z$!?), irrespective of the amplitude of the oscillation, number of atoms and value of the scattering length [31]. In a 3D conguration this mode can be realized in the limit of a very elongated axi-symmetric trap ($!_y$!?) corresponding, in the geometry of g. 1, to a condensate very elongated along the direction orthogonal to the gure. The radial breathing oscillation has been measured with high accuracy in [32].

The radial breathing mode can be described by deriving the time-dependent equations for the average square radius $hx^2 + z^2 i w$ ithin G ross-P itaevskii theory [17] in 2D. A fler som e straightforward algebra one nds the equation

where $V_{2 \text{ body}}$ is the average values of the m ean eld interaction energy and V is the external potential. By introducing the energy per particle $E = N = hV i + hp_x^2 + p_z^2 i = 2m + hV_{2 \text{ body}} i$, which is conserved in time, and separating in V the axi-symmetric harmonic potential V_{ho} from the surface potential V_{surf} , eq.(33) can be rewritten as:

In the absence of the surface perturbation ($V_{surf} = 0$) eq.(34) gives oscillating solutions with $! = 2!_{?}$.

The e ect of the perturbation is simply calculated noticing that the unperturbed solution corresponds to a scaling transformation where the density varies as $n(x;y;t) = {}^{2}n_{0}$ (x= ;y=) and n_{0} is the equilibrium density distribution. The time dependent scaling parameter xes the value of the square radius according to $hx^{2} + z^{2}i = {}^{2}hx^{2} + z^{2}i_{0}$. U sing the scaling transformation to evaluate the integrals $hV_{surf}i = {}^{R}$ drn (x;y;t) V_{surf} (z) and $hz Q_z V_{surf} i = {R \atop Mrn} (x; y; t) z Q_z V_{surf} (z)$ one can rewrite eq.(34) as a simple equation for the parameter . In the following we will be interested in the limit of sm all amplitude oscillations. By expanding the integrals up to rst order in (1), one nally obtains the result

for the frequency shift of the radial breathing (B) mode, where n_0^z is the 1D column density (7). Similarly to the case of the shift of the center of mass frequency (see eq.(32)), also result (35) is exact up to institute or restorder corrections in the perturbation. In fact the radial scaling ansatz is an exact solution of the G ross-P itaevskii equation in 2D. It is also a good approximation in 3D if the harmonic trap is suiciently elongated. Result (35) for the radial breathing mode may provide a further tool to investigate the elects of the generalized van der W aals force on a B ose-E instein condensate.
