Solution for the dynam ics of the BCS and central spin problems

We develop an explicit description of a time-dependent response of ferm ionic condensates to perturbations. The dynam ics of Cooper pairs at times shorter than the energy relaxation time can be described by the BCS model. We obtain a general explicit solution for the dynam ics of the BCS model. We also solve a closely related dynam ical problem { the central spin model, which describes a localized spin coupled to a \spin bath". Here, we focus on presenting the solution and describing its general properties, but also mention some applications, e.g. to nonstationary pairing in cold Ferm i gases and to the issue of electron spin decoherence in quantum dots. A typical dynam ics of the BCS and central spin models is quasi-periodic with a large number of frequencies and stable under small perturbations. We show that for certain special initial conditions the number of frequencies decreases and the solution simplies. In particular, periodic solutions correspond to the ground state and excitations of the BCS model.

I. INTRODUCTION

Recent experiments on cold ferm ion pairing in the vicinity of a Feshbach resonance of er a unique opportunity to control the strength of pairing interactions between ferm ions by a magnetic ed. This opens up an exciting possibility to explore fundamentally new aspects of the nonequilibrium pairing following an abrupt change of the coupling strength.

Interestingly, the dynam ical pairing in this regime can be linked to a seem ingly unrelated spin model. The latter describes the interaction of a localized (central) spin with a \spin bath" of environmental spins. The central spin model has reemerged recently in the context of experiments^{2,3} on electron spin dynamics due to the hyper ne interaction with nuclei in GaAs quantum dots. Since single electron quantum dots are now experimentally accessible³, and are considered one of the most promising candidates for solid state qubits, it is also important to understand the electron spin.

In this paper, we present a theory that provides an accurate description for a range of phenom ena in the dynam icalpairing and central spin problem s. As we will see below, there is an intim ate connection between these two problems that will enable us to treat them on an equal footing.

The study of the dynam ics of the superconducting state in metals founded on microscopic principles has begun during the decade following the advent of the BCS theory (see Ref. 5 for a review). The simplest theory for nonstationary processes in superconductors is based on the time-dependent G inzburg-Landau (TDGL) equation 6,7,8 for the order parameter (t). The TDGL approach is valid when quasiparticles are able to reach a local equilibrium quickly on the characteristic time scale of the order parameter variation (' 1 at zero tem –

perature). This requirem entusually lim its the applicability of the TDGL theory to situations where mechanisms destroying Cooper pairs are elective, such as a narrow vicinity of $T_{\rm c}$ or a large concentration of magnetic impurities.

An alternative theory^{9,10} is the Boltzm ann kinetic approach, which describes the dynamics in terms of a kinetic equation for the quasiparticle distribution function coupled to a self-consistent equation for (t). However, this scheme is justified only when external parameters change slow by on the time scale.

As pointed out in Ref. 11, cold ferm ionic gases can be in a regime where the notion of the excitation spectrum is irrelevant and neither TDGL nor the Boltzmann kinetic equations are valid. Indeed, in these systems external parameters such as the position of a Feshbach resonance can change on a time scale $_{0}$; , where is the quasiparticle energy relaxation time. On the other hand, the energy relaxation is slow, while the lifetime of the samples is \lim ited. It is therefore desirable to develop a theory that describes nonstationary pairing elects in this regime.

The nonequilibrium Cooper pairing at times t is non-dissipative and in a translationally invariant system can be described by the reduced BCS model

It is interesting to note that the use of this model for describing the dynam ics of a hom ogeneous superconducting state in metals in the non-dissipative regime, the matter of the positive regime, the contraction of the distinct of the contraction of the con

Here, we are interested in a situation when a system at zero temperature is out of an equilibrium at t=0. The goal is to determ ine the subsequent evolution of the initial state. In particular, this includes the case when at

t=0 the coupling constant has been abruptly changed from g^0 to g.

In the absence of translational invariance, e.g. in a dirty superconductor or in a nite system , H am iltonian (1.1) has to be appropriately generalized 13 . First, let us discuss the fam iliar case of electron-electron interactions. If there are no spatial sym m etries, but the time-reversal invariance is preserved, single-particle orbitals $_{\rm j}$ are degenerate only with respect to spin. For each orbital $_{\rm j}$ there is a pair of states, jj "i and jj #i, related by time reversal sym m etry. The pairing occurs between time reversed states, ie.

D eviations of the coupling strength g from a constant in q and j are small and sample-dependent 13,14 .

For a two species Ferm i system, such as a two-component mixture of ferm ionic atoms in a trap, spin up and down states in $(1\,2)$ have to be identified with the two species of ferm ions. With this replacement, arguments 13,14,15 leading to Hamiltonian $(1\,2)$ are valid in the weak coupling regime.

Ham iltonian (1.1) is obtained from (1.2) by specializing to a translationally invariant situation. In this case, time reversed states are p "i and p #i. One can also take a therm odynam ic limit by taking the number of orbital levels to in nity. However, in view of applications where the elective number of levels is nite and even small (see below), we deal with the general Hamiltonian (1.2) here.

Rem arkably, the BCS model turns out to be closely related to a model describing the Heisenberg exchange interaction of a single localized spin (the central spin) with a number of environmental spins. The Hamiltonian reads

where \hat{K}_0 is the central spin, \hat{K}_j are environm ental spins, j are (nonuniform) coupling constants, and B represents the magnetic eld^6 .

The central spin m odel has an interesting history of its own. For example, it emerged in the studies of electron spin dynamics in disordered insulators and of coherent spin tunnelling in ferrom agnetic grains . More recently, it attracted considerable attention as a model for decoherence of qubits 19,20,21,22 . In particular, it can be used to model 19,20 the hyper ne interaction of a localized electron spin with nuclear spins and the spin-dependent transport 23 in GaAs quantum dots. In these cases, it provides an adequate description of spin dynamics at times shorter than the nuclear spin relaxation time in the regime where the orbital level spacing in the dot is much larger than the temperature and typical interaction energies.

The main result of this paper is an explicit general solution for the dynamics of the BCS and central spin mod-

els. In particular, we determ ine as functions of time the order parameter (t) and the expectation value of the central spin (equations (3.22) and (3.24)) as well as the dynamics of the remaining degrees of freedom for arbitrary initial conditions. Here, we concentrate on presenting the solution and describing its general properties. We also mention several applications to special cissues such as nonequilibrium pairing and that of decoherence due to the hyper ne interaction, but leave a detailed discussion for the future.

The solution is based on the integrability^{24,25,26} of the BCS and central spin models. This important property has been largely underestimated in part because it was discovered outside the main physical context of these m odels. Besides, due to the in nite range of interactions in Hamiltonians (12) and (13), the mean eld approxim ation is $exact^{27,28}$ for these m odels in the lim it of large num ber of particles. In this approxim ation, the BCS and central spin models can be mapped onto a classical nonlinear system (see below). However, while the mean eld simpli es the description of equilibrium properties to an extent where no advanced techniques are required, it is the integrability of the resulting classical system that enables us to solve dynamical problems. The BCS solution4 for the ground state and excitations of the BCS model is recovered as a periodic case of the general solution (see the discussion following (2.6) and Section IV). It is also interesting to note that, as we will see, models (1.2) and (1.3), being in many respects classical, have distinct robust features that are preserved when the integrability is destroyed.

The D icke models that describes an ensemble of two-level systems coupled to a bosonic mode is also within the scope of our construction. In fact, it belongs to the same class of integrable models as the BCS and central spin models. The D icke model has been recently adopted to the study of a dynamical coexistence of atoms and molecules in cold Fermi gases. In the strong coupling regime, it seems to be an appropriate alternative to the BCS model for these systems.

The general nonstationary solution of the BCS and central spin models is in terms of hyperelliptic functions { multiple variable generalizations of ordinary elliptic functions. These functions frequently arise as solutions of integrable equations and have well known analytical properties 31 .

We show that form ost initial conditions the dynam ics is quasi-periodic with a number of independent frequencies equal to the number of degrees of freedom, n, and evaluate the frequencies in terms of the integrals of motion. The typical motion uniformly explores an invariant torus { an n-dimensional subspace of the 2n-dimensional phase space allowed by the conservation laws. These features of the typical motion are stable against small perturbations that destroy integrability.

Further, we identify certain special values of integrals of motion for which the number of independent frequencies, m, become seless than the number of degrees of free-

dom . For these degenerate cases, we were able to explicitly reduce them otion of the BCS and central spin m odels with n degrees of freedom to that of same systems with only m degrees of freedom. The solution progressively simpli es as the number of independent frequencies decreases. For example, solutions characterized by a single frequency (m = 1), i.e. periodic trajectories, are given by trigonom etric functions; degenerate solutions with two independent frequencies (m = 2) are given by a combination of trigonom etric and elliptic functions (see also Refs. 11,30 and the end of Section IV) etc.

Periodic solutions (m = 1) occupy a special place among degenerate solutions. As we show in Section IV, they reproduce the BCS solution for the ground state and excitations of the BCS model.

However, it should be emphasized that, unlike the general solution, degenerate solutions are nonrepresentative of the dynamics of the BCS and central spin models and, with the exception of the ground state, are expected to be unstable.

The paper is organized as follows. In Section II, we use a mean eld approximation to map the BCS and central spin models onto equivalent classical models. Section III contains an explicit general solution for the dynamics of both problems. In Section IV, we consider degenerate solutions. Section V discusses some open problems and possible applications of our results.

II. MEAN FIELD APPROXIMATION

Our starting point is the mean eld approximation, which enables the mapping of the BCS and central spin models onto equivalent classical nonlinear systems. We also derive the equations of motion and describe the relationship between the BCS and central spin models.

The discussion of the mean eld is facilitated by representing BCS Hamiltonian (12) in terms of Anderson pseudospin-1/2 operators²⁷.

where n is the number of single-particle orbitals. Pseudospin operators are related to ferm ion creation and annihilation operators via

P seudospins are de ned on unoccupied and doubly occupied pairs of states jj "i and jj #i, where they have all properties of spin-1/2. Singly occupied pairs of states, on the other hand, do not participate in pair scattering and are decoupled from the dynam ics.

Our goal is to determ ine the time evolution according to H am iltonian (2.1) of an arbitrary initial distribution of pseudospins. The mean eld approximation consists in the replacement of the eld seen by each pseudospin in BCS H am iltonian (2.1) with its quantum mechanical average, $b_j(t) = (2_x(t); 2_y(t); 2_j)$, where (t) is the BCS gap function

In this approximation, each spin evolves in the selfconsistent eld created by other spins

Since equations (2.4) are linear in \hat{K}_j , we can take their quantum mechanical average with respect to the timedependent state of the system to obtain

where s_j (t) = $2h\hat{K}_j$ (t)i. Evolution equations (2.5) conserve the square of the average for each spin, i.e. $s_j^2 = const.$ If spins initially were in a product state³², $s_j^2 = 1$.

Note from equation (2.2) the following correspondence between components of \mathbf{s}_j (t) and the normaland anomalous (Keldysh) Green functions at coinciding times:

Equations (2.5) were derived 12 for phonon superconductors within the general framework of nonstationary E liashberg theory in the collisionless regime t . A linearized version of these equations was considered in Refs 12,27 and 33.

Due to the in nite range of interactions between spins in (2.1), the mean eld approximation is exact in the therm odynamic limit. For a system with a nite number, N, of particles (spins) we expect, based on an analysis of leading nite size corrections 35 to the mean eld, equations (2.5) to be accurate for large N at times t < t N, where t and > 0 do not depend on N.

W e see that s_j = $2h\hat{K}_j i$ have all properties of classical spins governed by a H am iltonian

and usual angular momentum Poisson brackets. Thus, the problem reduces to determining the time evolution of n classical spins according to Hamiltonian (2.6).

The BCS solution for the ground state corresponds to the minimum of (2.6) and is obtained by aligning each

spin in (2.6) antiparallel to the eld acting upon it. A pair excitation 34 (excitation of the condensate) of energy $\hat{y} + \frac{2}{0}$, where and 0 are the chemical potential and the equilibrium gap respectively, is obtained by ipping the spin q. The U (1) sym metry of the BCS order param eter is equivalent to the sym m etry of (2.6) with respect to uniform rotations of all spins around the z-axis. Due to this symmetry, spin con gurations that determ ine the ground state and excitations can rotate around the z-axis with a frequency 2 at no energy cost. In the presence of a particle-hole sym metry = 0 and these con gurations are stationary with respect to Hamiltonian (2.6) (see Section IV where we recover the BCS solution as a periodic case of the general time-dependent solution).

Next, we turn to the central spin model and its relationship to the BCS model. The central spin H am iltonian (1.3) turns out to be a mem ber of an integrable family of G audin magnets 25 { n H am iltonians of the form:

where $_{\rm j}$ and are arbitrary parameters. All Ham iltonians $\hat{H_q}$ commute with each other and with the z-component of the total spin, $\hat{L_z}$ / $_{\rm q}$ $\hat{H_q}$, for arbitrary $_{\rm j}$ and . The central spin model (1.3) coincides with $\hat{H_0}$ in equation (2.7) if we choose $_{\rm 0}$ $_{\rm j}$ = 2= $_{\rm j}$ and = B . Note that if a number of orbitals $_{\rm j}$ in (2.1) are degenerate, the magnitude of their total spin $_{\rm j=const}$ $\hat{K}_{\rm j}$ is conserved by Ham iltonian (2.1). In this case one can replace $\hat{K}_{\rm j}$! $_{\rm j=const}$ $\hat{K}_{\rm j}$ in Ham iltonians (2.1) and (2.7) and sum over nondegenerate orbitals only.

We see that for $\,=\,2=g$ the expression in the square brackets coincides with BCS Ham iltonian (2.1). Therefore, for $\,=\,2=g$, the BCS Ham iltonian commutes with all $\hat{H_q}$ and thus belongs to the same class of integrable models 25,26 .

In the same way as we did for the BCS model, we employ the mean eld approximation to derive classical Hamiltonians that govern the evolution of $s_j(t) = 2h\hat{K}_j(t)$ if for Hamiltonians (2.7):

The validity of the mean eld approximation for central spin model (1.3) is subject to similar considerations as for the BCS model (see the second paragraph following equation (2.5) and also Ref. 20).

Thus, the problem of determining the dynam ics of the BCS and central spin m odels reduces to solving equations of motion for H am iltonians H $_0$ and H $_{\rm BCS}$ in system (2.8). To obtain solutions for BCS (1.2) and central spin (1.3) m odels, one has to choose

H am iltonians (2.8) Poisson-commute with each other and with the z-commonent of the total spin J_z / $_q$ H $_q$. Each H am iltonian in system (2.8) describes an evolution of n spins in an 2n-dimensional phase space (two angles for each spin) and has n integrals of motion (the energy and the remaining H am iltonians from system (2.8)). Therefore, all H am iltonians (2.8) are classical integrable models.

III. THE SOLUTION

In the previous section we mapped the BCS and central spin models onto a classical integrable system (2.8). Nevertheless, even though Liouville's theorem 36 guarantees a form al integrability in quadratures of classical integrable models, an explicit solution for the evolution of the original dynamical variables is not always possible. Fortunately, this turns out to be not the case for the BCS and central spin problems. For these models, as detailed below, we were able to obtain an explicit general solution of equations of motion.

Before we proceed, let us discuss generic features 36 expected of the dynam ics of a classical integrable model with n degrees of freedom. The motion is conned by conservation laws to an n-dimensional subspace of the 2n-dimensional phase space. This subspace (invariant torus) is determined by initial values of integrals of motion and is topologically equivalent to an n-dimensional torus. The motion on the invariant torus is characterized by n angle variables, k and the corresponding angular frequencies, k (t) = kt + k (0). The frequencies depend only on integrals of motion, while constants k (0) are determined by initial values of remaining degrees of freedom. Since for most initial conditions all frequencies k are independent k 1, typical trajectories uniform by explore the entire torus. All these properties are not

a ected by small perturbations destroying integrability (K olm ogorov-A mold-M oser theorem).

Now we turn to the solution for the dynamics of the BCS and central spin models. The solution consists of two main steps. The rst one is a change of variables that casts equations of motion into the form of a known mathematical problem. In the second step, we use the solution of this problem to obtain dynamical variables $s_j(t) = 2h\hat{K}_j(t)$ is as explicit functions of time.

The change of variables is facilitated by de ning a 2 $\,$ 2 m atrix 38 that depends on dynam ical variables s_j and also on an auxiliary parameter u

Note that because L is Herm itian for real u, its eigenvalues are real and therefore the polynom ial Q_{2n} (u) is positive de nite on the real axis. We will often refer to the polynom ial Q_{2n} (u) as the spectral polynom ial.

Following an algebraic version of variable separation method, 39,40 we introduce n $\,$ 1 variables, $u_{\rm j}$, as zeroes of B (u) { one of the o $\,$ -diagonal matrix elements of L . Variables $v_{\rm j}$, canonically conjugate to $u_{\rm j}$, are given by one of the eigenvalues of matrix L at $u=u_{\rm j}$.

In equations (3.9) and (3.10) as well as in the rest of the paper, with no loss of generality, we shifted parameters $_{\rm j}$ in the BCS and central spin H am iltonians by a constant so that $_{\rm 0}$ = 0.

In the reminder of this section we obtain an explicit general solution for the expectation value of each (pseudo)spin, $s_j(t) = 2h\hat{K}_j(t)i$, as a function of time. In particular, this includes the expectation value of the central spin, $s_0(t)$, and the BCS gap function, (t) = gJ(t).

The solution is based on the observation that, with a help of elementary algebra, equations of motion (3.9) and (3.10) can be cast into a form of a known mathematical problem. Specically, one can rewrite equations (3.9) and (3.10) for variables $u_{\rm j}$ as

where the polynom ialQ $_{2n}$ (u) is de ned in equation (3.3). To obtain equations of motion (3.10) for the BCS Ham iltonian one has to choose

Di erential equations (3.11) constitute a well-known mathematical problem called Jacobi's inversion problem (see, for example, Ref. 31 and references therein). The solution of equations (3.11) can be expressed through hyperelliptic Abelian functions (multiple variable generalizations of ordinary elliptic functions. These functions are often encountered as solutions of integrable equations and have well known analytical properties. They are also implemented in standard mathematical software packages 2.



IV. DEGENERATE SOLUTIONS

Here we identify a class of \resonant" nonstationary solutions for the BCS and central spin models with n degrees of freedom (n spins or pseudospins) but only m < n independent frequencies.

While a typical dynamics of the BCS and central spin models with n (pseudo) spins is quasi-periodic with n

independent frequencies, it is clear already on physical grounds that there must be solutions with fewer frequencies. For example, the only \spatial" symmetry of the BCS ground state is the U (1) symmetry of the order param eter that translates into rotations of all pseudospins in Ham iltonians (2.1) and (2.6) around the z-axis. The corresponding trajectory in the phase space is a circle and, therefore, the motion is periodic with a single frequency (see also the discussion following equation (2.6) and below in this section).

Generally, one can show 36 that there are (resonant) tori with an arbitrary number m < n of independent frequencies in a vicinity of any point in the phase space. It should be noted though that the set of points for which m < n has a zero measure in the phase space just like the set of rational numbers on the real axis. Moreover, such points are typically unstable of and provide seeds of chaotic behavior in integrable systems. This occurs because small perturbations are able to destroy resonant toriand let the corresponding trajectories escape to other regions of the energy shell. In contrast, the majority of invariant tori with n independent frequencies are only slightly deformed by perturbations.

Interestingly, for the resonant (degenerate) cases considered here we were able to reduce the BCS and central spin models with a spins to same models with only m spins. For example, solutions with m = 2 frequencies can be obtained from the BCS and central spin models for only two spins etc. Further, we will see that one spin solutions (periodic tra jectories) are special am ong degenerate solutions in that they correspond to the BCS energy spectrum. The solution that corresponds to the ground state is further exceptional in that it is stable against conservative perturbations because it m in in izes the total energy. In this case, even though there is only one frequency, the trajectory cannot leave the resonant torus because the latter coincides with the energy shell. The same applies to the solution that minimizes the central spin Hamiltonian.

We start by determ ining conditions under which the number of independent frequencies is reduced. Since the frequencies are xed by initial values of integrals of motion, degeneracies occur only for special values of the integrals. On the other hand, a complete information about integrals of motion is encoded in the spectral polynomial $Q_{2n}(u)$ de ned in equations (3.3) and (3.4). Specially, we have seen in the previous section that the number of frequencies $q_{2n}(u) = q_{2n}(u)$. Evidently, the latter decreases by one when two roots of the polynomial $Q_{2n}(u)$ coincide. Thus, as detailed below, merging $Q_{2n}(u) = q_{2n}(u)$ roots of $Q_{2n}(u) = q_{2n}(u)$ we obtain solutions with $q_{2n}(u) = q_{2n}(u)$ frequencies.

W e see that degenerate solutions with m < n frequencies can be param eterized by m auxiliary spins both for the BCS and central spin model. This implies, for example, that a slight change of initial values of integrals of motion (4.8) will induce small oscillations along the remaining n m directions.

A special case of two spin solutions when the four coefcients of a positively de ned polynom ia \mathfrak{F}_4 (u) can be parameterized by three numbers, \mathfrak{F}_4 (u) = ((u ! \mathring{f} + 2 + 2) 2 4 2 2 , has been previously discovered in Ref. 11. The general two spin solution is obtained from equations (4.29-4.31), which are solved by setting n = 2 (g = 1) in equations (3.17), (3.21) and (3.22) where hyperelliptic functions now become ordinary elliptic functions.

Sim ilarly, one can obtain three, four etc. spin solutions (degenerate solutions with m=3;4 etc. frequencies) in terms of hyperelliptic functions of genus g=2;3 etc. However, as discussed in the beginning of this section, solutions with m< n frequencies are nonrepresentative of the dynamics anywhere in the phase space and are expected to be unstable in the sense of KAM theorem.

M oreover, we emphasize that degenerate solutions derived here are not all solutions with m < n independent frequencies. Indeed, it is clear that for a generic point in the phase space all roots of the spectral polynomial Q_{2n} (u) are distinct and, by continuity, the distance

to the closest point where two roots coincide is $\,$ nite. On the other hand, there are points with any number of frequencies arbitrarily close to any point in the phase space. Other solutions with $\,$ n $\,$ frequencies can be constructed using the reduction theory for hyperelliptic functions 46 .

Note also that degenerate solutions with m frequencies contain ones with fewer frequencies and can be further reduced to m 1, m 2 etc. Geometrically, they live on a 2m-dimensional surface in the 2n-dimensional phase space (see the remark below equation (421)). Surfaces with smaller m are embedded into ones with larger m. Interestingly, periodic trajectories that correspond to the BCS energy spectrum (m = 1) belong to all these surfaces.

V. APPLICATIONS AND OPEN PROBLEMS

Our results can be directly applied to the problem of decoherence within the central spin model. In this case, we believe, a complete exact answer can be obtained using asymptotics of hyperelliptic functions.

A nother possible application is to experim ents² on electron transport in spin blockaded sem iconductor double dots. In this connection, it m ight be useful to analyze

rst a simpler setup of a single dot connected to two polarized leads. This setup leads 47 to an integrable model very similar to the central spin model.

Further, it m ight be possible to use the BCS model (2.6) with few classical spins to describe a number of grains connected to each other by Josephson junctions.

O ther interesting applications include pairing phenom - ena in cold ferm ion gases¹ modeled either by BCS or Dicke model and in superconducting metals (see e.g. the discussion in Ref. 33). In these cases, a careful identication of observable robust features of the solution is needed.

An interesting open problem is the evaluation of leading nite size (quantum) corrections to the general solution obtained in this paper.
