Exact solution of the nonlinear laser passive mode locking transition

We present the rst statistical mechanics study of a passively mode locked laser which includes all the main physical processes, saturable absorption, Kerr nonlinearity, parabolic gain Itering and group velocity dispersion, assuming the soliton condition. We achieve an exact solution in the therm odynamic limit, where the ratio of the cavity length to the pulse width, the duty cycle, tends to in nity. The therm odynamics depends on a single dimensionless parameter , the ratio of the correlation length to the pulse width. The phase diagram consists of one ordered, mode-locked phase and one disordered, continuous wave phase, separated by a rst order phase transition at = 9. The model belongs to a new class of solvable statistical mechanics models with a non-trivial phase diagram . The results are obtained with a fully controlled transferm atrix calculation, showing rigorously that passive mode locking is a therm odynamic phase transition.

Introduction Form ation of ultrashort pulses in lasers by passive mode locking is an important branch of optics, both from the point of view of basic research and of practical applications. As such, it has been the subject ofm any theoretical and experim ental studies over several decades, see [1] for a review. Nevertheless, until recently the central question of the threshold power needed to trigger passive mode locking was standing without a satisfactory answer.

In several recent works [2, 3, 4] considerable progress was made toward resolving this issue by including the e ect of noise in a nonperturbative manner. The addition of a random element into the cavity electrodynamics turns the laser into a statistical physics system. A pplying methods of equilibrium statistical mechanics, it has been shown that su ciently strong noise destabilizes the pulses form ed by a saturable absorber, and that the process of pulse form ation is a rst order phase transition.

However, these results were all obtained in the context of models of the laser dynamics which assumed a simple form of spectral gain litering. Here, for the rst time, we tackle the full problem of passively mode-locked laser with a fast saturable absorber, quadratic gain litering, slow saturable gain, group velocity dispersion, and Kerr nonlinearity, assuming the soliton condition.

In the rst step of the theoretical analysis we construct an exact mapping from the statistical steady state of the laser electric eld to the therm al uctuations of a string with an unstable self-interaction. We show that the therm odynam ic limit is obtained when the laser cavity is much longer than one of the natural length scales, the pulse width or the correlation length. It is next show n that therm odynam ics is determ ined solely by the dimensionless ratio of the two natural length scales. We proceed to calculate exactly and explicitly the free energy, rst by physical, mean eld-like arguments, which are then established by a rigorous transfer matrix calculation. The free energy enables us to calculate all therm odynam ic quantities, including pulse power as a function of , and the therm odynam ic phase diagram, which consists of one ordered, mode locked phase for > 9, and one disordered, non-mode locked phase for < 9. Pulse form ation is a rst order phase transition. The pulsed con guration is metastable for 8 < < 9, while the continuous wave con guration is metastable for all > 9.

The model closely resembles equations which have been used extensively to study kinetics of phase transitions and critical phenom ena [5]. How ever, the opposite sign of the nonlinearity leads to markedly dierent phenom enology. The passive mode locking equation therefore belongs to a new class of statistical physics models.

Therm odynam ics of passively mode locked lasers. Our starting point is the master equation which governs the slow dynam ics of the complex envelope of the electric eld (x;t) in a cavity of length L [1, 2]

in O L with periodic boundary condition, Ζ where the real consants $_{\rm q}$ > 0, $_{\rm d}$, $_{\rm s}$ > 0, $_{\rm k}$ are the coe cients of spectral litering, group velocity dispersion, (fast) saturable absorption, and Kerr nonlinearity, respectively. Noise of spontaneous em ission and other sources is modelled by the random term which is a (complex) Gaussian process with covariance h (x;t) $(x^{0};t^{0})i = 2TL$ (x x) (t t). Finally, as shown in [3], the slow saturable gain g, may be chosen, without signi cant loss of generality, such that it sets the total intracavity powerk $k^2 = \frac{1}{L} \int_{0}^{K_L} dx j (x)^2 to a xed$ value P. g becom es then a Lagrange multiplier for the xed power constraint.

In this Letter we consider Eq. (1) in the special but important case that $_{s} + i_{k}$ is a real multiple of $_{g} + i_{d}$, known as the soliton condition. In this case one can de ne a Ham iltonian' functional [4]




FIG.1: A typical realization of the real part of the envelope of the electric eld in the laser cavity, in the mode locked phase (top) and in the continuous wave phase (bottom).

N ote that the power constraint is enforced explicitly, and that is independent of the in aginary terms in Eq. (1). The study of steady state preoperties of Eq. (1) is now reduced, as in [2, 3], to the that of an equilibrium statistical mechanics system with partition function Z.

The Hamiltonian functional H is almost identical to the critical Ginzburg-Landau (GL) functional, the paradigm for the e ective description of continuous phase transition [5]. In Eq. (2), however, in contrast with the GL functional, the coe cient of the quartic term is negative, making the null con guration unstable. The instability is countered by the power constraint, which acts nonlocally, and the therm odynam ics is consequently radically di erent from the GL one. In particular, the one-dimensional system exhibits an ordering transition, which is in possible in the one-dimensional GL m odel.

The character of the steady state distribution is determ ined by the strength of the ordering saturable absorber relative to the disordering noise. The system has two natural length scales: The pulse width $L_p = \frac{4}{_{s}PL}$ measures the e ect of saturable absorption, while the correlation length $L_c = \frac{qP}{_{LT}}$ measures the e ect of noise. In both cases, the e ect is stronger the smaller is the associated length scale. Thus, L_p is smaller the larger is $_{s}$ and is independent of T, while the converse is

true for L_c . The third length scale in the system, the cavity length L, is typically much larger than L_p and L_c in multimode lasers; we therefore study the statistical problem in the lim it L $L_p; L_c$, which serves as the therm odynamic lim it, neglecting sm all corrections of O ($L_p=L$) or O ($L_c=L$). Therm odynamic quantities, and in particular the mode locking threshold are therefore determined by the sole dimensionless parameter, the ratio = $4L_c=L_p=\ _sP^2=T$. Note that therm odynamics is independent of the spectral litering $_q$.

O ur analysis proceeds in the textbook approach of calculating the free energy $F = \log Z$ of the statistical mechanics problem Eqs. (3-4), from which other them odynam ic quantities follow. However, seeking to calculate the partition function we run into a common obstacle, namely that the functional integral in Eq. (4) is not well de ned. M athematically this is not a serious problem, since the invariant measure is well-de ned [6], but in order to use Z and F we need to give a precise meaning to the functional integral, as the continuum limit of a regularized version where the integration is nitedimensional. G iven a regularization scheme with N integration, we de ne the regularized partition function

where H_N and k_Nk are regularized versions of H and k k. The integration measure is multiplied by factors of $\frac{q}{LT}$ to make Z_N dimensionless, and by factors of a_N, a regularization scheme-and N dependent dimensionless constant, to make Z = $\lim_{N \to 1} Z_N$ nite. The limit is independent of the regularization scheme up to an unim portant multiplicative constant.

The rest of this Letter is devoted to the calculation of F, Eq. (9), and from it the phase diagram and therm odynam ic quantities, which all have simple algebraic expressions. It is shown that when > 9 the equilibrium is an ordered, mode-locked phase where the power P is divided between a single pulse and continuum uctuations, see the top panel of Fig. 1; when < 9 the equilibrium is a discodered phase for, where the electric eld consists only of spatially hom ogeneous uctuations, see the bottom panel of Fig. 1.

M can eld calculation of the free energy As a preliminary step towards the calculation of F we examine the problem in two solvable limits. In the rst, T ! 0, the evolution equation (1) approaches the noiseless dynamics without the random term . Then, as is well known, reaches an equilibrium in the form of a soliton-like pulse $_{\rm p}(z)=e^{i}\frac{P\,L}{2L_{\rm p}}$ such $\frac{z-z_0}{L_{\rm p}}$, with two initial conditions-dependent real parameters, the pulse position 0 $_{\rm Q}$ < L and phase 0 < 2.

In our context, $T \downarrow 0$ is the validity condition for the Laplace m ethod, otherwise known as the saddle point approximation, in Eq. (4), and the solitons $_{\rm p}$ take the role

of the saddle points. It follows that $Z = e^{H \left[p\right] = (LT)}$, so that the free energy when $L_c = L_p$ or 1 is

In the second solvable limit $_{\rm s}$! 0, H becomes quadratic and, after replacing the power constraint delta function by its Fourier integral representation, the functional integral in Eq. (4) becomes gaussian. The quadratic form is then diagonalized using the Fourier representations of , and we calculate Z in a regularization scheme where N is the number of Fourier modes kept (see Eq. (5)). The result of the gaussian integration is

U nder the assumption that L L_c , we can use the standard approximation methods of Euler-MacLaurin summation and saddle point integration to get the free energy in the limit L_c L_p or 1

A though the preceding expressions Eqs (6,8) for the free energy were obtained in lim iting cases, we now argue that F $_{\rm p}$, the pulse free energy, and F $_{\rm c}$, the continuum free energy, may combined into an expression for F valid for every . The argum ent is based on the follow ing assum ption: C on gurations which contribute signi cantly to Z are such that (z) = 0 (1) for most z, with possibly few narrow regions where $(z) = O(L=L_p)$, whose totalwidth is 0 (L_p). Let yP, 0 y 1 be the total power concentrated in regions where is large. For z values is small the nonlinear term in H is negligible, where and the existence of regions of large a ects the statistics of the small region only in that the total available power for uctuations is (1 y)P rather than P. The regions of small therefore contribute F_{c}_{j} $(1 y)_{P}$ to the total free energy. Sim ilarly, the regions of large are so narrow that noise induced uctuations make negligible contribution to the free energy in them, so that the large

regions contribute H []=(LT) to F. By the principle that F is m in in ized by the G ibbs distribution the large regions should be such that H [] is m in in ized, that is, will assume a soliton-like shape with total power yP, and contribute $F_p j_{P} \cdot y_P$ to F. We claim that since the sm all parameter in these arguments is $L_p=L$, they

become exact in therm odynam ic lim it. The total free energy is the sum of the pulse and continuum parts, m in in ized over values of y,




FIG.2: The function (;y) whose minimum with respect to y is the free energy as a function y for = 7;8;9;10 with higher values of corresponding to lower curves. Curves with two minima correspond to system s with a metastable state. W hen = 9 the values of (;) at the two minima are equal.

F can be used to easily derive other therm odynamic quantities. An order parameter which is nonzero if and only ifm ode locking occurs is $M = \frac{L_p}{L} \frac{F}{hj} \frac{d}{f} i$. M has dimensions of power, and is proportional to the experimentally measurable RF power [7]. It follows from Eq. (5) and the de nition of F that $j \frac{d}{f} = 2T \mathcal{Q}_s F$. Letting (;y) denote the target function in Eq. (9), and y() the minimizer, we calculate

The most important consequence of equation (10) is that mode locking occurs whenever the minimizer y() is greater than zero. (;) has the following behavior: For

Therefore, as is increased through = 9, M jumps discontinuously from 0 to $\frac{P}{9}R$; that is, the transition is rst order, the ordered phase is metastable when 8 < < 9, and the disordered phase is metastable for all > 9. The pulse power in the mode locked phase is y()P, as can be veried by calculating higher moment.

Transfer matrix calculation of the free energy W e turn to the transfer matrix calculation of Z which establishes our expression (9) for the free energy with a controlled derivation. For this purpose we consider a slightly generalized partition function Z with xed values of at the endpoints of the interval, (0) = i, (L) = f, and generalized free energy F = $\log Z$. In this calculation it is more convenient to use system parameters that do not depend on the system size, so we de ne

Like Z, Z needs to be de ned using a limiting procedure with a properly scaled functional measure. Let Z denote the lattice regularization of Z with lattice spacing . It satis as the identity

W e next expand the right-hand-side in powers of $$_{\rm f}$$ and perform the gaussian integration. This gives

an equation involving Z $\,$ and its derivatives. Taking then the continuum lim it $\,$! 0 gives the equation for Z $\,$

where the term with double $_{\rm f}$ derivative and the term with an L derivative were dropped, since they are 0 (L_p=L) with respect to the term s retained.

M ean eld arguments, similar to those presented above to obtain F, can be used to calculate F. Like F, F is the sum of a continuum contribution F_c where the non-linear term is unimportant, and a pulse term F_p where noise is unimportant. Since the continuum uctuations are a bulk property, F_c is independent of the boundary conditions to leading order, and in this order it is equal to F_c , which in the present parametrization reads

as before, (1 y) is the relative continuum power.

Like F_p , F_p is the negative of the maxim alvalue of the exponent in Eq. (11), subject to a given total power yP and the boundary conditions. However, the xed boundary conditions break the translation invariance, and the maxim ization is achieved when pulses are created near the boundaries. We use standard variationalm ethods to obtain the result: F_p is the minimum of four candidate function distinguished by the con guration of the boundary pulses labelled by the four possible sign choices in

In the sstam biguous sign the upper (lower) choice refers to the possibility that a pulse maximum lies at z > 0 (z < 0). The second sign choice refers sim ilarly to the position of a pulse maximum relative to the z = L boundary. is a Lagrange multiplier for the power constraint, given implicitly by

The total free energy F is obtained by minimizing the sum $F_p + F_c$ with respect to and the possible choices of sign, i.e., $F = \min_{i} F_c + F_p$.

It is left to show that this expression for F satis es the di erential equation (14). We demonstrate that each of the four possible sign choices satis es Eq. (14), from which the result follows immediately. To this end we de ne $= \frac{L^2}{4 P (1 y(1))^2}$, which is the value of which minimizes F for a given choice of sign, as determined from Eqs. (16-17) The derivatives of F then read

where the upper or lower sign choice corresponds to the second am biguous sign in (16-17). It is now straightforward to verify that F and its derivatives satisfy (14) for all sign choices, as was claimed, nishing the demonstration.
