0 -equilibrium generalization of the uctuation dissipation theorem for Ising spins and m easurem ent of the linear response function

We derive for Ising spins an o -equilibrium generalization of the uctuation dissipation theorem, which is form ally identical to the one previously obtained for soft spins with Langevin dynamics [L F C ugliandolo, JK urchan and G Parisi, JP hys.I France 4, 1641 (1994)]. The result is quite general and holds both for dynam ics with conserved and non conserved order parameter. On the basis of this uctuation dissipation relation, we construct an e cient numerical algorithm for the com – putation of the linear response function without in posing the perturbing eld, which is alternative to those of C hatelain [JP hys. A 36, 10739 (2003)] and R icci-Tersenghi P hys.Rev E 68, 065104 (R) (2003)]. A sapplications of the new algorithm, we present very accurate data for the linear response function of the Ising chain, with conserved and non conserved order parameter dynamics, nding that in both cases the structure is the same with a very sim ple physical interpretation. We also compute the integrated response function of the two dimensional Ising model, con rm ing that it obeys scaling (t;tw) ' tw aft (t=tw), with a = 0.26 0.01, as previously found with a dimensional method.

I. IN TRODUCTION

In the recent big e ort devoted to the understanding of system s out of equilibrium, of particular interest is the problem of the generalization of the uctuation dissipation theorem (FDT). The autocorrelation function C (t $^{\circ}$) of some local observable and the corresponding linear response function R (t $^{\circ}$) in equilibrium are related by the FDT

The question is whether an analogous relation exists also away from equilibrium, namely whether it is still possible to connect the response function to properties of the unperturbed dynamics, possibly in the form of correlation functions. A positive answer to this question exists when the time evolution is of the Langevin type. Consider a system with

an order parameter eld (x) evolving with the equation of motion

where B (x;t) is the determ inistic force and (x;t) is a white, zero-m ean gaussian noise. Then, the linear response function is simply given by the correlation function of the order parameter with the noise

where T is the tem perature of the therm albath and t t by causality. It is straightforward [1] to recast the above relation in the form

is the so called asymmetry. Eq. (4), or (3), qualies as an extension of the FDT out of equilibrium, since in the right hand side there appear unperturbed correlation functions and, when time translation and time inversion invariance holds, reduces to the equilibrium FDT (1). In Appendix I we show that this equation holds in the same form both for conserved order parameter (COP) and non conserved order parameter (NCOP) dynamics.

The next interesting question is whether one can do the same also in the case of discrete spin variables, where there is no stochastic dimensional equation and, therefore, Eq. (3) is not available. For spin variables governed by a master equation, this problem has been considered in recent papers by Chatelain [2], Ricci-Tersenghi [3], Diezem ann [4] and C risanti and R itort [5]. However, although important for computational and analytical calculations, their results, as we shall explain below, cannot be regarded as generalizations of the FDT in the sense of Eq. (4). In refs. [2,3], a scheme is presented where R $(t;t^0)$ is related to unperturbed correlation functions which, how ever, are not computed in the true dynamics of the system. Rather, as will be clarified in Section IV, these correlation functions are computed through an auxiliary dynam ical rule, instrume ental to the construction of an algorithm for the computation of R $(t;t^0)$. On the other hand, in refs. [4,5], R $(t;t^0)$ is related to quantities that can be extracted from the dynamics of the unperturbed system, but not all of them can be put in the form of correlation functions.

Instead, we have succeeded in deriving for Ising spin systems a genuine o equilibrium generalization of the FDT, which takes exactly the same form as Eqs. (4) and (5) and which holds, as in the Langevin case, for NCOP (spin ip) and COP (spin exchange) dynamics. Furtherm ore, using this result we have derived an e cient num erical method for the computation of the response function, without in posing the perturbing conjugate eld, which is alternative to those of refs. [2,3].

The paper is organized as follows: in Section II we introduce the form alism and derive the o equilibrium FDT. In Section III we introduce the dynamics in discrete time in order to develop a numerical algorithm based on the

uctuation dissipation relation. Section IV is devoted to a comparative discussion of our method with those of Chatelain and Ricci-Tersenghi. In Section V the algorithm is applied to the investigation of the scaling properties of the response function in the one dimensional Ising model with NCOP (Section VA) and COP dynamics (Section VB). As a further application of the method we study in Sec. VI the integrated response function of the Ising model in d = 2. In Section VII we make concluding remarks.

II.FLUCTUATION DISSIPATION RELATION FOR ISING SPINS

We consider a system of Ising spins $s_i = 1$ executing a markovian stochastic process. The problem is to compute the linear response $R_{i;j}(t;t^0)$ on the spin at the site i and at the time t, due to an impulse of external eld at an earlier time t^0 and at the site j. Let

be the magnetic eld on the j-th site acting during the time interval $[t; t^0 + t]$, where is the Heavyside step function. The response function then is given by [2,5]

and [s] are spin con gurations.

Let us concentrate on the factor containing the conditional probability in the presence of the external $eld p^{h}([s^{0}];t^{0}+tj[s^{0}];t^{0})$. In general, the conditional probability for t su ciently small is given by

where we have used the boundary condition $p([s];t]s^0;t) = [s];s^0;t$. Norm alization of the probability in plies

Furtherm ore, the transition rates must verify detailed balance

where H [s] is the H am iltonian of the system. In the following we separate explicitly the diagonal from the o -diagonal contributions in w ([s] ! $[s^0]$)

where we have used Eq. (10).

Introducing the perturbing eld as an extra term $H[s] = sh_j$ in the H am iltonian, to linear order in h the most general form of the perturbed transition rates $w^h(s] ! [s^0]$ compatible with the detailed balance condition is (see Appendix II)

where M ([s]; [s⁰]) is an arbitrary function of order h=T symmetric with respect to the exchange [s] [s⁰], and w⁰ ([s] ! [s⁰]) are unspeci ed unperturbed transition rates, which satisfy detailed balance. Notice that, since Eq. (11) reduces to an identity for [s] [s⁰], Eq. (13) does not hold for the diagonal contribution w^h ([s] ! [s]) which, in turn, can be obtained by the norm alization condition $_{[s^0]}$ w^h ([s] ! [s⁰]) = 0. In the following, for simplicity, we will take M ([s]; [s⁰]) = 0 and the role of a di event choice for M ([s]; [s⁰]) will be discussed in sec. IV.

Using Eqs. (9), (12) and (13) we obtain

Eqs. (26) and (27) are the main result of this paper. They are identical to Eqs. (4) and (5) for Langevin dynamics, since the observable B entering in the asymmetries (5) and (27) plays the same role in the two cases. In fact, Eq. (24) is the analogous of

obtained from Eq. (2) after averaging over the noise.

In sum m ary, Eq. (26) is a relation between the response function and correlation functions of the unperturbed kinetics, which generalizes the FDT.Furtherm ore, Eq. (26) applies to a wide class of system s. Besides being obeyed by soft and hard spins, it holds both for COP and NCOP dynam ics. Moreover, as it is clear by its derivation, Eq. (26) does not require any particular assumption on the ham iltonian nor on the form of the unperturbed transition rates.

III. DYNAM ICS IN DISCRETE TIME: THE NUMERICAL ALGORITHM

We now discuss the num erical in plem entation of the uctuation dissipation relation derived above, as a method to compute the response function without imposing the external magnetic eld (6). Let us recall that Eq. (22) was obtained letting $t \mid 0$

In the simulations of an N-spin system, time is discretized by the elementary spin updates. Measuring time in m ontecarlo steps, the sm allest available time = 1=N is the one associated to a single update. Then, in discrete time Eq.(29) reads

IV.COMPARISON W ITH DIFFERENT ALGORITHMS

Expressions for the response function in a discretized time dynamics have been derived previously by Chatelain [2] and Ricci-Tersenghi []. Restricting to transition rates of the heat-bath form and to the case of single ip dynamics they have obtained

where I() is the index of the site updated at the discrete time I(t;t) is a speci c sequence of I()'s between the times t_w and \overline{t} , s_{i}^{H} () = tanh [h_{i}^{H} ()] and h_{i}^{H} () is the local eld due to the spins interacting with s.

It is important to stress the di erences between Eqs. (33) and (32). Although in the r.h.s. of Eq. (33) there appears an unperturbed correlation function, this is computed in the ad hoc kinetic rule introduced for the purpose of evaluating the response function. In Eq. (32), instead, the average in the r.h.s. is computed in the true unperturbed dynamics of the system. This important di erence arises because of the presence of the delta function $_{iI()}$ in Eq. (33), which constrains to update at the time only the spin at the site j, where the external eld is applied. Then, in the averaging procedure, only the subset of dynam ical trajectories with I() = j are considered, while all the others get zero statistical weight, which is not what happens in the true unperturbed dynam ics. Eq. (33), therefore, although useful for the computation of the response function, is operatively restricted to a num erical protocol with a sequential updating satisfying the constraint in posed by the delta function _{j,I()}. The correlations functions appearing in this equation cannot be extracted num erically from the behavior of the original unperturbed system, and cannot be accessed in an experiment.

A nother di erence between Eq. (33) and Eq. (32) concerns the choice of M([s]; [s]). Our results are obtained with M ([s]; $[s^0]$) = 0. Instead, Eq. (33) corresponds to M ([s]; $[s^0]$) \neq 0. In fact, Eq. (33) assumes heat bath transition rates w ([s]! $[s^0]$) = fexp [H [s]=T]g=fexp [H [s]=T]+ exp [H [s]=T]g; expanding this expression to rst order in powers of h=T, and comparing with Eq. (13), one has

Retaining M ([s]; $[s^0]$) in Eq. (13) and following the same steps as for M ([s]; $[s^0]$) = 0, one nds the extra term

in addition to the quantities already present on the rh.s. of Eq. (26). This term cannot be related to correlation functions. It is generally believed that the large scale – long time properties of the dynamics (perturbed or not) do not depend too much, within a given universality class, on the form of the transition rates. Then one expects the corrections $R(t;t^0)$ introduced by di erent choices of M ([s]; [s]) to be negligible. Indeed, as will be shown in the following sections V,VI, numerical results obtained for the Ising model in d = 1;2 with the two algorithms are not sensitive to the choice of M ([s]; [s⁰]).

V.RESPONSE FUNCTION OF THE ISING CHAIN

As an application of the numerical method, we compute the autoresponse function R (t;t⁰) = R_{i;i}(t;t⁰) in the d = 1 Ising model, with and without conservation of the order parameter. We consider the system prepared in the in nite temperature equilibrium state and quenched to the nite temperature T > 0 at the time t = 0. Since the critical temperature vanishes for d = 1, the nal correlation length $_{eq}$ is nite and equilibrium is reached in a nite time $e_{q} = \frac{z}{eq}$, where z is the dynamic exponent. For deep quenches $_{eq}$ is large and, after a characteristic time t_{sc} , a well de ned non-equilibrium scaling regime sets in for $t_{sc} < t < e_{q}$, characterized by the growth of the domains with a typical size L (t) $t^{1=z}$. We study the scaling properties of the response function R (t;t⁰) when both t and t⁰ belong to the scaling regime.

A.N on conserved dynam ics

The linear response function in the model with single spin ip dynamics has been computed analytically [8[10]. This case, therefore, is useful as a test for the accuracy of the algorithm. In the aging regime t^0 t _{eq} the autoresponse function R (t; t^0) is given by [9]

where $I_n(x)$ are the modi ed Bessel functions.

In order to improve the signal to noise ratio, we have extracted R ($t;t^0$) from the integrated autoresponse function ($t;t^0 + ;t^0$) by choosing in the following way. Expanding for small we have

then, for a given level of accuracy, R (t;t⁰) can be obtained from (t; $t^0 + ;t^0$) = if is chosen appropriately small. Notice that, assuming scaling R (t;t⁰) = t ^(a+1)f (t⁰=t), from Eq. (37) one has that, for a given value of x = t⁰=t, the second term on the rhs. produces a relative correction R (t;t⁰)=R (t;t⁰) = (1=2) [f⁰(x)=f(x)](=t) of order =t. In our simulations we have chosen = 1 and, since the simulated times are t 100, we have always =t 10². In the following it is understood that all num erical results for R (t;t⁰) are obtained in this way.

In Fig. 1 we compare the num erical results obtained by means of the algorithm (32), for three di erent values of t, with the exact solution (36). We have also plotted the data obtained using the algorithm (33) of Ricci-Tersenghi [3], nding an excellent agreem ent between the curves generated by the di erent algorithm s and the analytical expression (36).

The physical meaning of the exact solution can be understood by replacing Eq. (36) with the simple interpolating form ula

obtained by replacing the Bessel functions with the dom inant term in the asymptotic expansion and by inserting t_0 as a regularization of R (t;t⁰) at equal times. For NCOP z = 2. W ith $A_2 = 1 = (\frac{1}{2})$ and $t_0 = 1 = (2)$ the simple algebraic form (38) gives a very good approximation of the exact solution all over the time domain, from short to large time separations. Rewriting Eq. (38) as

the physical meaning becomes clear, since L (t^0)¹ is proportional to the density of defects (t^0) at time t^0 , and R_{sing} (t t^0) can be interpreted as the response associated to a single defect. In other words, Eq. (39) means that the total response is given by the contribution of a single defect times the density of defects at the time t^0 . As a matter of fact, Eqs. (39) and (40) are the particular realization of a general pattern for the aging part of the response function [11]

The presence of the scaling function $f(t=t^0)$ in Eq. (41) for d > 1 can be explained as follows: in d = 1 interfaces are point like and the interaction between them always produces annihilation. This is accounted for by the defect density $L(t^0)^{-1}$, so $f(t=t^0)$ 1. In higher dimension, how ever, defects are extended objects whose interaction can produce a wealth of dimensions, which are globally described by a suitable scaling function $f(t=t^0)$.

B.Conserved dynam ics

The generality of the structure of Eqs. (39) and (40) m ay soon be tested by looking at the response function in the Ising chain with COP dynamics. While for NCOP the system enters the scaling regime almost immediately, since t_{sc} ' 1, for COP the time t_{sc} for the onset of the scaling regime is of the order of the characteristic time exp(4J=T) for the separation (evaporation) of a spin from the boundary of a domain. The equilibration ev time, instead, is given by _{eq} exp(10J=T) [12]. In order to have a large scaling regime, namely $_{eq}$ t_{sc}, it is necessary to take T=J1, and to choose $t_w > t_{sc}$. Simulations of the system in these conditions are excessively time dem anding with a conventionalm ontecarlo algorithm. Therefore we have resorted to the fast algorithm of Bortz, Kalos and Lebow itz [13], which is much more e cient at low temperatures. With a conventional algorithm a number of attempts proportional to ev is necessary on average before the evaporation of a spin from a domain occurs. Then, at low tem peratures, a huge am ount of attem pted m oves are rejected, causing a very low e ciency. The algorithm of Bortz, K alos and Lebow itz, instead, is rejection free: moves are always accepted and time is increased proportionally to the inverse probability associated with them . We stress that this is not an approximate kinetics, but a clever im plem entation of the exact dynam ics.




FIG.2. (t) in the d = 1 Ising model with COP, T = 0:3J and J = 1. The number of spins is N = 10^4 . The range of time used in the simulations for the computation of the response function is in between the vertical lines. The dashed line represents the asymptotic law (t) t¹⁼³.

From the unperturbed system the response function is extracted through Eq. (32), as in the case of NCOP. About the choice of , for COP the simulated times are t 10° and we can have =t 10° , as required for the correction term in Eq. (37) to be negligible, with = 10° . We have perform ed simulations with T = 0.3J, corresponding to t_{sc} ' 6 10 and eq ' 3 10° . In this conditions the scaling regime is very large. A ctually, after a very narrow initial regime, where single spins di use until they are adsorbed on an interface, no evaporations occur and the system is frozen up to times of order ev. In this time regime the density of defects (t) stays constant, as shown in Fig. 2. Then, for t[>] ev, the evaporation-condensation mechanism takes place and the system s gradually enters the scaling regime. The range of times explored for the computation of the response function is shown in Fig. 2. This has been chosen as a comprom ise between the necessity to go to the largest accessible times, in order to work well inside the scaling regime, and to speed up the simulation to have a good statistics. For COP, the observation of the asymptotic behavior (t) $t^{=z}$, with z = 3, requires very large time [14]. In the range of times explored for the computation of R (t;t⁰) the elective exponent $z_{eff} = [d \log (t)=d \log t]^{1}$ has reached the value $z_{eff} = 3:44$.




FIG. 3. R (t;t⁰) in the d = 1 Ising model with COP, T = 0.3J and J = 1. The number of spins is N = 10^4 , t⁰ = 10^7 ;2:5 10;5 10 (m cs) from top to bottom. Continuous curves are the plots of Eqs. (39,40). Fitting parameters are A₃ = 0.24;t₀ = 5 10.

We have plotted in Fig. 3 the numerical data for R (t;t⁰) together with the curves obtained from the analytical form (38), where we have substituted for z the above value of z_{eff} and we have used A₃ and t₀ as thing parameters. The comparison is good and suggests that the physical interpretation, behind the form (39) and (40) of the response function, applies also to the d = 1 Ising model with spin exchange dynamics [15]. We expect the more general form (41) to hold in higher dimension with COP.

VI.RESPONSE FUNCTION OF THE D = 2 ISING MODEL




FIG. 4. $(t;t_w)$ in the d = 2 Ising model with NCOP, T = J = 1. The number of spins is N = 1600^2 , $t_w = 1$ 10; $t_w = 1.5$ 10; $t_w = 2$ 10; $t_w = 2.5$ 10; $t_w = 3$ 10; from top to bottom. Circles represent data obtained with the algorithm of Eq. (32), continuous lines are the results with the Ricci-Tersenghim ethod (33).

As a further application of the numerical method, we compute the zero eld cooled magnetization (ZFC) (t;t;) = $(t;t;t_w]$) in the d = 2 Ising model with NCOP, quenched from the in nite temperature equilibrium state to a temperature below T_c . This quantity has already been measured both by applying the perturbation [11,16{18}] or by means of the algorithm of Ricci-Tersenghi [3]. In Fig. 4 we compare results obtained with our method and with that of Ricci-Tersenghi, for several values of t_w in the scaling regime. The agreement between the two algorithms is excellent also in this case. The equivalence of the two algorithms both in d = 1 and in d = 2 suggests, recalling the discussion at the end of Sec. IV, that di erent choices of M ([5]; [3]) do not produce signi cant di erences.

Let us comment on the behavior of $(t;t_w)$. As it is well known, in the late stage of phase-ordering the interior of the growing domains is equilibrated, while interfaces are out of equilibrium. Then, a distinction can be made between bulk and interface uctuations. A coordingly, for the ZFC one has [21{23]

Here $_{st}(t;t_w)$ is the contribution from the bulk of dom ains, which behaves as the equilibrium response $_{eq}(t;t_w)$ in the ordered state at the tem perature T. This quantity, starting from zero at $t = t_w$, saturates to the value 1 M², M being the equilibrium magnetization. The other term appearing in Eq. (42), namely the additional aging contribution due to the interfaces, is much less known. It is expected to scale as

In previous studies [11,17,18], an auxiliary dynamics, which prevents ips in the bulk, was used in order to extract the aging part of the response in Eq. (42). Here, instead, we have chosen a dient technique to isolate $_{ag}(t;t_w)$: We compute the full $(t;t_w)$ in the G lauber dynamics working at a su ciently low temperature where $_{st}(t;t_w)$ is negligible. In fact, by choosing T = J, the asymptotic value of $_{st}(t;t_w)$ is 1 M² ' 0:0014, much sm aller than the computed values of $(t;t_w)$ in the range of times considered. Then one has $(t;t_w)'_{ag}(t;t_w)$.

Besides this di erence, previous results [11,17,18] on $_{ag}(t;t_w)$ were obtained with the usual method where a perturbation is applied. The strength h of the perturbation must be chosen su ciently small to work in the linear regime. However, by reducing h the signal to noise ratio lowers, and the results get worst. Then one usually runs a series of prelim inary simulations in order to determ ine the largest value of h compatible with the requisite of working in the linear regime. W hile this point may be subtle, in the result presented in this paper the limit h ! 0 is taken analytically in the derivation of the algorithm.




FIG.5. The same data of Fig. 4 obtained with the algorithm of Eq. (32) plotted for xed values of x against t_w . Straight lines are power law best ts. In the inset the data collapse for t_w^a (t; t_w), with a = 0.26, is shown.

We have extracted a from the data of Fig. 4 by plotting $(t;t_w)$ against t_w with $x = t=t_w$ held xed. The results are shown on a double logarithm ic plot in Fig. 5. A coording to the scaling form (43), for di erent values of x the data m ust align on straight lines with the same slope a. This is very well compatible with the curves of Fig. 5, indicating that scaling is obeyed. Computing a as the slope of these curves we nd a = 0.26 0.01. This result agree very well with the value found in [11,17,18]. Once this exponent is known, one obtains data collapse by plotting t_w^a (t; t_w) against x, as shown in the inset of Fig. 5, con ming the validity of the scaling form (43).

VII.CONCLUDING REMARKS

In this paper we have derived a generalization of the FDT out of equilibrium for systems of Ising spins, which takes exactly the same form of the FDT generalization previously derived [1] for soft spins, evolving with Langevin dynam ics.

We have shown that this uctuation dissipation relation, which reduces to the usual FDT when equilibrium is reached, is obeyed in complete generality both by systems with COP and NCOP. In addition to the theoretical interest, as a contribution to the understanding of the FDT in the out of equilibrium regime, our result is promising also as a convenient tool for the computation of the linear response function in num erical simulations without applying the perturbation, along the line of refs. [2,3]. With standard methods, the requirement to work in the linear regime, namely with an adequately small perturbation, sometimes is very subtle and hard to be checked. This problem is avoided by this new class of algorithm s. M oreover, the statistical accuracy of the results is, for com parable quu times, m uch better because sim ulations of perturbed system s usually require additional statistical averages over realizations of the (random) perturbation. We have demonstrated the high quality of the results produced by our algorithm by computing the response function of the Ising model in d = 1 and the integrated response function in d = 2. In d = 2 our results agree with those obtained with the algorithm of ref. [3] and with previous simulations perform ed applying the perturbation. We con m that (t;t) obeys a scaling form (43) with a = 0.26 0.01, in agreement with previous determ inations [11,17,18] of this exponent. In d = 1, for NCOP our results are in excellent agreement with the exact analytical solution and with the simulation m ade with the algorithm of ref. β]. In the case of COP, where no analytical solution is available, we have obtained results which substantiate the existence of the common structure (39,40) of the response function for COP and NCOP. These results show that the algorithm is e cient enough to give access to the direct measurement of the impulsive response function R ($t;t^0$), which is too noisy to be computed with standard methods. For this reason, previous numerical studies [11,16,19,20] have been necessarily directed to the investigation of the integrated response functions, such as the therm orem anent m agnetization or the zero eld cooled magnetization, which are easier to compute. However, as discussed in detail in [11], it is quite delicate a task to extract the properties of R ($t;t^0$) from those of the integrated response functions. Therefore, the feasibility of a direct computations of R ($t;t^0$) is an important development in the eld, which is expected to solve a number of problem s still open [11] on the scaling behavior of R ($t;t^0$) for d > 1.


