Fractional Flux Periodicity in Doped Carbon Nanotubes

An anomalous magnetic ux periodicity of the ground state is predicted in two-dimensional cylindrical surface composed of square and honeycomb lattice. The ground state and persistent currents exhibit an approximate fractional period of the ux quantum for a specic Fermi energy. The period depends on the aspect ratio of the cylinder and on the lattice structure around the axis. We discuss possibility of this nontrivial periodicity in a heavily doped arm chair carbon nanotube.

In the Aharonov-Bohm (AB) e ect, the phase of wavefunctions is modulated by a magnetic eld, thereby manifesting the quantum nature of electrons. One of the direct consequences of the AB e ect in solid state physics is the persistent current in a mesoscopic ring^{1,2,3,4}. The persistent current is an equilibrium current driven by a m agnetic eld threading the ring, and it generally shows the ux periodicity of 0 = hc=e. On the other hand, there exist some systems where the period becomes a general fraction of 0, revealing an interference e ect between channels. At present, theoretical investigations of the fractional ux periodicity has been done in a twodimensional (2D) system composed of a square lattice and in a one-dimensional (1D) system. Cheung et al. found that a nite length cylinder with a speci c aspect ratio exhibits the fractional ux periodicity in the persistent currents. The same con guration with an additionalm agnetic eld perpendicular to the cylindrical surface was analyzed by Choiet alf. They reported that a fractional ux periodicity appears in the persistent currents. Its period is mainly determined by the additional perpendicular ux, but is also dependent on the number of lattice sites along the circum ference. We have shown in the previous paper that torus geometry exhibits the fractional ux periodicity depending on the twist around the torus axis and the aspect ratio. As for 1D system s, Kusmartsev et al.8 reported on fractional AB e ect in a certain lim it of the Hubbard model and Jagla et al.9 found that correlations change the fundam ental periodicity of the transmittance of an AB ring with two contacts. In 1D, there is only one channel and therefore there exists no coherence e ect between channels; hence the origin of the fractional ux periodicity diers from that of twodim ensional system.

However, since these geom etries have not yet been realized experim entally, it is in portant to exam ine if existing materials with cylindrical geometry can be used to detect such an interference e ect. In this paper, we will show that an approximate fractional ux periodicity appears in a honeycomb lattice cylinder, which is realized in a single wall carbon nanotube (SWNT) 10 . The fractional periodicity requires a heavy doping, shifting the Ferm i energy up to the energy of the transfer integral (2.9 eV).

The persistent current in doped nanotubes was also theoretically exam ined by Szopa et al. 11 , though they do not mention the fractional periodicity.




FIG. 1: (left) Geometry of a 2D cylinder in the presence of the AB ux, . (right) We consider 2D cylinders composed of a square and an arm chair nanotube.

Here we consider the interference e ect in a 2D cylinder (Fig. 1) composed of a honeycomb lattice, and calculate the ground state energy and the persistent current. The persistent current (I_{pc} (N $\,$)) is defined by differentiating the ground state energy (E $_0$ (N $\,$)) with respect to the magnetic full ux penetrating through a hollow core of the cylinder (See Fig. 1) as I_{pc} (N $\,$) (E $_0$ (N $\,$)=0 . We show that the fraction of full ux period ($_0$ =Z) depends on the aspect ratio of a cylinder: 1=Z = n= l_T for a doped (n;n) arm chair SW NT with l_T being the number of unit cells along the cylindrical axis. Persistent current can be observed experimentally via the induced magnetic moment of the system, which was recently demonstrated in a SW NT by M inot et al 12 .

First we consider a nite length 2D cylinder composed of a square lattice, as studied by Cheung et al^5 . The length of the cylinder and the circum ferential length are N a and M a, respectively, where a is the lattice constant. By solving the nearest-neighbor tight-binding H am iltonian with hopping integral t, we obtain the energy eigen-

value as

In the presence of the AB $\,$ ux parallel to the cylinder axis, E $_{\rm nm}$ changes according to the gauge coupling which can be obtained by substituting m $\,!\,$ m $\,$ N $\,$ where N is the number of $\,$ ux, de $\,$ ned by N $\,$ = $_0$ (see Fig.1).

W hen we consider a half- lling system (E = 0), the ground state energy E $_{0}$ (N) is given by

where $A_n = \frac{M}{2} - 1 = \frac{n}{N+1}$ and [x] represents the largest integer smaller than x. From Eq. (2), the persistent current is expressed as

For M 1, we can rewrite Eq. (3) as

where I_0 = 2et=(M sin $_{\overline{M}}$) and we ignored the correction of 0 (M 2) to the right hand side. The coe $\,$ cient, C $_j$ is given by

When the aspect ratio satis $\ es\ M=2\ (N+1)=1=Z\ w$ ith integer Z , $\ cos(2\ Z\ A_n)=1$ holds for all n and C $_j$ satises $C_{j+Z}=C_j$. Furthermore, in the limit of N $\ 1$, C $_Z$ becomes large compared with C $_1$; $_Z$; C since they are proportional to O (1=N) and C $_Z$ / O (N). Since only j=Z;2Z; are dominant in Eq. (4), we get approximate fractional ($_0=Z$) periodicity of I_{pc} when M=2(N+1)=1=Z which becomes exact in the long length limit N $\ 1$, as was found by C heung et al.

Let us apply this result to doped arm chair SW NT. The carbon nanotubes can be speci ed by the chiral vector, $C_h = na_1 + ma_2$, and the translational vector, $T = t_1a_1 + t_2a_2$, where (n;m) and $(t_1;t_2)$ are integers and $a_1;a_2$ are sym metry translational vectors on the planar honeycomb lattice 10 with $ja_1j^2 = ja_2j^2 = 2a_1$ a. The chiral vector C_h speci es the circum ference of the cylinder, and the unit cell of the nanotube is dened by two mutually perpendicular vectors C_h and T. The length of the cylinder is speci ed by a vector $\frac{1}{2}T$. We decompose

the wave vector as K = $_1$ K $_1$ + ($_2$ = l_T)K $_2$ where $_1$ and $_2$ are integers, and the wave vectors K $_1$ and K $_2$ are dened by the condition 1 : C $_h$ K = 2 , C $_h$ K = 0, T K = 0 and T K = 2 . With these de nitions, the energy eigenvalue of the valence electrons can be expressed by

where $V \ (= 2.9 eV)$ is the transfer integral for nearest-neighbor carbon atoms and the variables X and Y are dened by

where N $_{\rm C}$ = m t $_{\rm l}$ n t $_{\rm l}$. This implies that the motions around the axis ($_{\rm l}$) and along the axis ($_{\rm l}$) couple with each other.

W ithout doping (i.e., at half-lling), the energy dispersion relation of carbon nanotube has only two distinct Ferm i points called K and K 0 Ferm i points. In this case only two channels touch the Ferm i level and the ground state energy shows the AB e ect with the periodicity of $_0^{13,14}$ and corresponding situation has reported experim entally 12,15 . We consider a special doping which shifts the Ferm i level from 0 to E $_{\rm F}=V^{11}$ (the case of E $_{\rm F}=V$ can be analyzed in the same way and the results are the same because of the particle-hole symmetry). The energy dispersion relation around the Ferm i level is approximately given by

W e note that the energy dispersion relation is sim ilar to that of the square lattice except for the factor of $\cos Y$. Here, we adopt the arm chair SW NTs (n = m) because we can set t_1 = 1 and t_2 = 1 and therefore X is proportional to only $_1$ and Y to $_2$, which results in that $\cos X$ + $\cos Y$ become set the energy dispersion relation of a square lattice.




FIG .2: G round state energy as a function of the ux for (n;n) arm chair SW NT . (a) n = 30 (diam eter 4 nm) with two di erent lengths: l_T =n = 3 (length 22 nm) (solid curve), l_T =n = 9 (dashed curve), and (b) n = 80 (diam eter 10 nm) with two di erent lengths: l_T =n = 0:6 (length 11.6 nm) (solid curve), l_T =n = 1.2 (dashed curve). We o set the origin of the energy for comparison.

We rst show the numerical results of the ground state energy E_0 (N) for the doped arm chair SW NT. In Fig. 2(a), we plot E_0 (N) of doped am chair (30;30) ASW NTs with dierent lengths. The ground state energy shows an approximate fractional ux periodicity depending on the aspect ratio de ned by 1 = n. We can see that the approximate fractional periodicity ($_0$ =Z) corresponds to $Z = l_T = n$. However, there also exists the approximate fractional ux periodicity for a shorter nanotube, $\frac{1}{4}$ < n^7 . In Fig. 2(b), we plot the ground state energy for (80;80) arm chair SW NT with $\frac{1}{4}$ = 48 11:6[nm]) and $\frac{1}{4}$ = 96 ($\frac{1}{4}$ Tj 23:2[nm]). The approximate fractional periodicity corresponds to 1=Z = 1=3 and 1=6, respectively, in which $L_T = n$ is 3=5and 6=5.

Now we derive the fractional ux periodicity of persistent current in doped arm chair SW NTs analytically

with use of the result for the square lattice. Equation (1) for the square lattice is similar to Eq. (9) for the doped SW NT.Although there remains a factor of cosY dierence, it does not a lect the fractional periodicity; we can analytically show below that the fractional periodicity $_0$ =Z occurs when l_T =n = Z is an integer. To see this, it is useful to consider a hypothetical energy dispersion,

This energy eigenvalue corresponds to multiplying the factor josn = (N + 1)j to the E $_{\rm nm}$ (N) for the square lattice. The corresponding persistent current can be expressed by multiplying C $_{\rm j}$ in Eq. (4) by the factor of josn = (N + 1)j.




FIG. 3: Occupied states are shown in gray color in the Brillouin zone for the energy dispersion relations; (a) $2V \ \text{jcosY} \ \text{j(cosX} + \text{cosY})$ in Eq. (10) and (b) $2V \ \text{cosY} \ \text{(cosX} + \text{cosY})$ in Eq. (9).

Thus the persistent current for Eq. (10) still exhibits the fractional periodicity depending on the aspect ratio. To compare Eq. (9) with Eq. (10), we consider the dierence

between the ground state energies for the two energy dispersions. Figure 3 shows the occupied states (gray color) for (a) the hypothetical energy dispersion of Eq. (10) and (b) that for doped SW NT. From this gure, it follows that the dierence of ground state energies is a constant independent of N , because it corresponds to the sum of energy of all states for dispersion Eq. (10) within the re-Χ and =2Y . This shows that the persistent current in the doped arm chair SW NTs has the same periodicity as the square-lattice cylinder after the replacement t! V, M! 2n and N+1! l_T ; the period is thus given by $_0$ =Z for an integer value of $Z = I_T = n$. Moreover, even when $I_T = n$ is equal to a rational number Z = q for coprime integers Z and q, such as $l_T = n = 3=5$, the system shows an approximate fractional ux periodicity $_0$ =Z. It is because in Eqs. (5) and (11) C_z ; C_{2z} ; are much larger than otherowing to $cos(2 Z A_n) = 1$.

Let us comment on the magnetic eld B_n for (n;n)arm chair SW NT which corresponds to $_0$ = 4 10 7 [gauss α]. For n = 100 (diam eter is about 13 nm), B_n is about 30T, which is experimentally attainable. For the fractional periodicity, the period becomes 30T=Z, which is easily achieved in experiments for larger Z. Although Z can be large in the long length \lim it of an arm chair SW NT (L_T periodic motion of the electron along the axis of long nanotubes may be a ected by decoherence e ect such as lattice deform ations or defects. It is also valuable to comment on the magnetic moment (orbit) of the system 12. The magnetic moment can be calculated directly from the persistent current as $_{\text{orb}\,\text{it}}=\,\text{SI}_{\text{pc}}\,\text{(N}\,\,\,\,\text{), where}$ S is the cross-sectional area of the tube (S = $f_h f = 4$). When $l_T = n = Z$ (Z is an integer), we estimate that the maximum amplitude of the magnetic moment scales as $_{\text{orb}\,\text{it}}=_{\text{B}}=0$ (1) n^2 , where $_{\text{B}}=6$ 10 2 [m eV =T] is the Bohrmagneton.

The Ferm i energy (E $_{\rm F}$ = V 2:9eV) for doped SW NT for the fractional ux periodicity m ight be difcult for chem ical doping, whereas it m ight be possible for electrochem ical doping; a recent experiment of electro-chem ical gating achieves Ferm i energy shift of order $1 {\rm eV}^{16}$.




FIG .4: G round state energy of a weak doped (E $_{\rm F}=~{\rm V}$ =10) chiral nanotubes. We consider (60;30) chiral nanotube with $\rm l_T=15$ (solid curve) and (70;30) with $\rm l_T=5$ (dashed curve). The origin of the energy has been shifted to facilitate comparison.

Finally we point out that the fractional nature can be seen even for the smaller Ferm i energy. In Fig. 4 we plot E $_0$ (N) with a weak doping (E $_{\rm F}$ = V =10) for for (60;30) (solid curve) and (70;30) (dashed curve) chiral nanotube with $\rm l_{\rm f}$ = 15 and $\rm l_{\rm f}$ = 5, respectively. These curves clearly show some coherence excts. Thus a reproducible coherence pattern of the magnetic moment may be obtained as a function of magnetic eld for doped SW NTs.

It is not easy to obtain of a SW NT with the diameter of 4nm. Thus we generally need a multi-wall carbon nanotube in which the current ows only few outermost

layers. In this case we need to consider an elect of a nite thickness of layers. If the periodicity comes from the some interlayer coupling, complex coherence elect would appear. In fact, there are several experimental reports on an approximately fractional ux periodicity in magneto-resistance 17,18,19 . Bachtold et al. 17 observed an oscillation with a period $_0\!=\!10$. It not be explained by the Al'tshuler-Aronov-Spivak theory which predicts the period of $_0\!=\!2^{17,18}$. At present moment, our results do not account for these oscillations, which will be a future work.

In conclusion, we calculated numerically and analytically the fractional periodicity of the ground state energy and persistent currents in 2D cylinders composed of a square and doped arm chair SW NT.A doped arm chair SW NT also exhibits the fractional periodicity when they are doped to $E_{\rm F}=V$. The fraction ($_0$ =Z) depends on the aspect ratio given by Z = $l_{\rm T}$ =n, where $l_{\rm T}$ is the number of unit cells along the cylindrical axis. An experimental investigation of the AB elect in a doped SW NT gives a key to understand this special coherence phenomenon.
