Finite di erence lattice Boltzmann model with ux limiters for liquid-vapor systems

In this paper we apply a nite dierence lattice Boltzmann model to study the phase separation in a two-dimensional liquid-vapor system. Spurious numerical e ects in macroscopic equations are discussed and an appropriate numerical scheme involving ux limiter techniques is proposed to minimize them and guarantee a better numerical stability at very low viscosity. The phase separation kinetics is investigated and we not evidence of two dierent growth regimes depending on the value of the uid viscosity as well as on the liquid-vapor ratio.

I. INTRODUCTION

Lattice Boltzmann (LB) models approach physical phenomena in uid systems using a phase-space discretized form of the Boltzmann equation [1, 2, 3, 4, 5]. Conservation equations are derived by calculating moments of various order of this equation [6, 7, 8, 9, 10, 11, 12]. After the publication of the rst LB model which exhibits phase separation [13, 14], LB models were widely used to investigate the complex behavior of single-or multi-component/phase uid systems [3, 5] and refer mainly to isothermal systems [15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25]. This limitation comes from the constant value of the lattice speed c₁ which in LB models is related to the temperature T, the lattice spacing s and the time step t through two separate relations

where $c_s = \frac{p}{k_B T = m}$ is the isotherm all speed of sound for an ideal uid, m is the mass of uid particles, is a constant depending on the geometry of the lattice, and k_B is Boltzm ann's constant [5, 26].

A coording to the \collide and stream "philosophy of LB models, uid collides in the lattice nodes and thereafter moves along the lattice links in a lapse towards

neighboring nodes with the speed c1 given by Eq. (2) [2, 3, 4, 5]. Such a relationship is no longer considered in nite di erence lattice Boltzmann (FDLB) models [27, 28, 29, 30, 31] which start directly from the Boltzm ann equation and have a better num erical stability. In such models there is more freedom to choose the discrete velocity set, as done recently in the therm alFD LB model ofW atariand T sutahara [32] where the possibility of having di erent sets of velocities allows to release the constraint of constant tem perature. A lso, the use of FD LB models is promising, e.g., when considering LB models for multicomponent uid systems, where the masses of the components are not identical and Eq. (1) would lead to di erent lattice speeds. In this context, FD LB m odels may be viewed as a convenient alternative to interpolation supplemented LB models [33, 34, 35].

FD LB m odels, as well as LB m odels, are known to introduce spurious terms in the mass and momentum conservation equations, which are dependent on the lattice spacing s and the time step t [31]. The behavior of an isothermal uid system subjected to FD LB simulation is governed by the apparent values of the viscosity and/or di usivity. The expression of these quantities with respect to s and t depends on the nite di erence scheme used in the FD LB model. Consequently, the choice of the numerical schemem ay alter signicantly the macroscopic behavior of the uid system observed during simulations as well as the numerical stability. This problem still lacks necessary clarication and should be always considered in order to recover the correct physical interpretation of simulation results.

The purpose of this paper is to investigate these num erical aspects by using a FD LB m odel addressing the phase separation kinetics in a van der W aals uid. Phase separation in liquid-vapor systems has not received as much attention as in binary uids [36]. Under the hypothesis of dynamical scaling the late time kinetics can be characterized in terms of a single length scale R (t) which grows

according to the power law R (t) t, where is the growth exponent [37]. The late time growth, when hydrodynam ics is neglected, is expected to be described by the A llen-C ahn theory which gives a growth exponent

= 1=2 [38]. When hydrodynamics comes into play, the liquid-vapor system behaves similarly to binary uids so that a growth exponent = 2=3 is expected [36]. Previous numerical studies used molecular dynamics simulations [39, 40] and a LB model based on a free energy functional [41, 42, 43]. In molecular dynamics simulations it was found evidence for the growth exponent 1=2 [39, 40]. By using the free-energy LB model, Osborn et al. [41] found the growth exponents 2=3 and 1=2 at low and high viscosity, respectively, independently on the system composition. Mecke and Sofonea [42, 43], using the same algorithm for an osymmetric system, found a crossover from 2=3 to 1=2 at low viscosity, and 1=3 at high viscosity. We will compare results of our model with the aforementioned ones.

To model the liquid-vapor system, a standard force term [13, 14, 25] is added to the discretized Boltzmann equations. The resulting FDLB model is described in Section II. In Section III we introduce two numerical schemes, namely, the rst order upwind ference scheme and a higher order one which uses ux lim iters [44, 45]. There we show the di erence between FDLB,\collide and stream "LB and volum etric LB m odels [46, 47]. We thereafter discuss the spurious num erical e ects these schemes introduce in the uid equations. Section IV reports the simulation results, where special attention was given to the e ects of the num erical schemes on estimation of the growth exponent. In order to clarify the phenomenology and estimate accurately the exponent, we monitored the size of domains R (t) by using three independent measures. A discussion about the m ethod and results ends the paper.

II. THE MODEL

The 2D FDLB model follows the LB model for non-ideal uids [13, 14, 21, 48, 49]. The starting point is provided by the set of N partial derivatives equations resulting from the discretization of the Boltzmann equation on a square lattice L when the collision term is linearized using the BGK approximation [50]. In non-dimensional form, this set reads

point and T_c is the critical tem perature. W ith this choice of reference quantities, the dim ensionless speed is [51]

where = $T=T_R$ is the dimensionless temperature and the constant equals 1=3 for the square lattice we use (see later for details on the lattice) [31]. If we take the system size as the reference length l_R , we get the reference time t_R from the condition $t_R \, c_R = l_R$. The non-dimensionalized lattice spacing is dened by the number of lattice nodes N we choose along the non-dimensionalized system length L

The particle distribution functions f_i f_i (x;t) are dened in the nodes x of the square lattice L . In the D 2Q 9 m odel we use in this paper, N = 8 and the velocities e_i are [2, 3, 4, 5]

The equilibrium distribution functions $f_i^{eq} = f_i^{eq} (x;t)$ are expressed as series expansions of the M axwellian distribution function, up to second order with respect to the local velocity u = u (x;t), whose C artesian components are u = [52]:

The local density n = n (x;t), as well as the components of the local velocity u which enter Eq. (7), are calculated from the distribution functions as follows:

are the non-dim ensionalized pressures of the ideal and the van der W aals uid, respectively [51]. With the equation of state in the form (13), the critical point is located at = 1 and n = 1. The parameter controls the surface tension [25]. The mass and momentum equations are recovered from Eqs. (3) after using the standard Chapman - Enskog procedure up to second order with respect to Knudsen number Kn = c = L. These equations read [4, 5, 25]

is the physical value of the kinem atic viscosity [31]. The particular num erical scheme used to solve Eqs. (3) may introduce a spurious viscosity term that adds to the physical value, as seen in the next section. Finally, we note that the force term (11) allows to recover the Navier – Stokes equation (15) where the pressure p^w appearing on the rhs. is subjected to the van der W aals equation of state (13).

III. FIN ITE DIFFERENCE SCHEMES

A. First-order upw ind scheme

The set of phase space discretized equations (3) may be solved numerically by using an appropriate nite difference scheme de ned on the lattice L. Simple second-order schemes like the centered one or the Lax-Wendro scheme [44, 45, 53] are unstable because of large values of the density gradient which may occur in the interface regions separating the liquid and vapor phases of the van der Waals uid. The rst-order upwind scheme, which is also used in LB models [2, 3, 4, 5], is a good candidate because of its stability. When associated to the forward time stepping rule, this scheme gives the following updating rule for the distribution functions de ned in node

As discussed in Ref. [31], nite di erence schem es introduce spurious num erical terms in the conservation equations. This happens because the real evolution equations recovered (up to second order in space and time) from the updating rules (17) are

Thus, the nite di erence scheme introduces spurious terms, depending on the quantity (), in both the conservation equations (compare with Eqs. (14)-(15)), while the physical value (16) of the kinematic viscosity is replaced by the apparent value [31]

One could use s, t, and c such that = , s = c t and rem ove spurious term s in the Eqs. (23)-(24). In this




FIG. 1: Characteristics lines on the square lattice, for the directions e_1 (a) and e_5 (b).

case it would be $_{\rm ap}=c^2$ (+ t=2). In order to maintain the apparent value of the viscosity close to the physical one and allow very small values of , one should require t . Since the condition = is equivalent to ask N = L=c t, one should have N $^>$ 10 when $^<$ 10 , being c'L'1. This would require a huge computational e ortwhen doing 2D or 3D simulations using the rst order upwind FDLB model. Higher order ux limiter schemes provide a possibility to overcome this problem giving a better stability. As we will see further, these schemes in prove the accuracy of the FDLB simulations with respect to the upwind scheme, for the same value of the number N of lattice nodes.

As a matter of comparison we recall that the \collide and stream "LB model is equivalent to an upwind FD LB model, when also the relaxation term is calculated on the characteristics line [31] and the choice s=c t is adopted. The resulting apparent value of the viscosity is $_{\rm ap}=c^2$ (t=2). For this reason the \collide and stream "LB model su ers mainly from the lack of stability when ' t=2 so that very low values of viscosity cannot be accessed [25].

B. Flux lim iter schem es

Figure 1 shows two characteristics lines on the square lattice involving the distribution functions $f_1(x;t)$ and $f_5(x;t)$, respectively. For convenience, we denote $g_{i;j}^k$ the value of the quantity g_i in node j at time t=k t. A coording to the general procedure to construct high order Total Variation D in inishing (TVD) schemes using ux limiters [44, 45, 53] we rewrite the updating rule (17) in a conservative form using two uxes [54, 55, 56]

The ux limiter ($_{i,j}^{n}$) introduced in (27) is expressed as a function of the sm oothness

In particular, the second order Lax – W endro scheme is recovered for ($_{i;j}^{n}$) = 1. The upwind scheme, described in the previous subsection, is recovered as another particular case, when ($_{i;j}^{n}$) = 0. A wide choice of ux limiters are at our disposal in the literature [44, 45, 53]. LB simulations reported in this paper were done using the Monitorized CentralDierence (MCD) limiter [44]

but other lim iters give qualitatively sim ilar results.

Eqs. (26) satisfy the global particle and momentum conservation. When using the rst order upwind scheme, the spurious terms introduced in the mass and momentum conservation equations are linearly dependent on the lattice spacing s. Since ux limiter schemes are adapting them selves to the local smoothness (29) of the distribution functions, it is rather cumbersome to derive analytical expressions of the spurious numerical term in these cases. LB simulations of disusion phenomena done using ux limiter schemes suggest a second order dependence of the value on the lattice spacing s [57] such that $= (s)^2 = 2cL$ and the apparent value of the kinematic viscosity (25) becomes

When the lattice spacing is a small quantity, the use of ux lim iter schemes is expected to improve the accuracy of FDLB simulations as well as the stability.

A di erent approach that allows to avoid spurious terms in the conservation equations is provided by the volum etric LB scheme introduced in Ref. [46] which satises detailed balance and achieves the desired order of accuracy. We will refer to the fractional version of the aforementioned scheme constructed in the case of a homogeneous uid on a uniform mesh [47] since we are using a regular and uniform lattice. In the scheme proposed in Ref. [47] the value of the viscosity can be reduced with respect to the "collide and stream" LB and the Courant-Friedrichs-Levy number CFL = c t= s can be smaller

than 1. M oreover, some unphysical spurious invariants are removed. Our scheme can have very small values of viscosity since the numerical contribution to the value of viscosity, proportional to , can be reduced and made much smaller than the physical term, proportional to , without having stability problems. This depends on the fact the in nite dierence schemes the values of s and t can be set independently from the value of c. Our choice of t and s is such to guarantee that the CFL number is much less than 1 and that the unavoidable spurious terms, introduced by the numerical scheme and proportional to (), can be done as small as desired.

IV. SIM ULATION RESULTS

In this Section we report the results of our simulations. For all runs we used N = 1024, s = 1=256, and $t = 10^5$. In the following, lengths are expressed in units of lattice spacing and time is expressed as the product of algorithm steps by t. All quenches below the critical tem perature were to the tem perature = 0.79where the coexisting densities are $n_{liquid} = 1.956$ and $n_{\text{vapor}} = 0.226$. Each simulation was started with small uctuations (0:1%) in the density about a mean value \hat{n} that was either symmetric ($\hat{n} = 1:09$, liquid fraction = 0:5) or slightly o -sym m etric ($\hat{n} = 1:0$, = 0:45). The parameter controlling the surface tension was set 10⁶ to have an interface thickness of spacings. The viscosity was varied by changing . We xed an upper bound of by the following argument. It is well known that the continuum hypothesis and the Navier - Stokes equation are valid only for small values of the Knudsen number Kn [58]. Since Kn = c = L and c' L' 1 in our simulations, this means $^{<}$ 10². We im plem ented the upwind and the ux limiter schemes and compared results when $= 10^4$. In this case the spurious num erical contribution of the upw ind scheme is larger than the physical one. Numerical contributions get negligible when the ux limiter scheme is considered instead. Therefore one expects to observe qualitative and quantitative di erences. We used also the value $= 10^3$ with the ux limiter scheme to access a higher viscosity regime.

In order to have dierent and independent tools to estimate the domains size we used the following quantities: R_1 (t), the inverse of the length of the interfaces of domains, measured by counting lattice points where the order parameter (x;t) = n(x;t) it is such that (x;t) $(x^0;t) < 0; R_2$ (t), the inverse of the rst moment of the spherically averaged structure factor




FIG. 2: Evolution of dom ains size recovered for $\,=\,10^4$, $\,=\,0.5$ with the $\,ux$ lim iter scheme: R $_1$ (4), R $_2$ (), R $_3$ (). R's are measured in lattice spacings and R $_1$ has been multiplied by 4,000,000 to be shown in the same plot. The straight line has slope 2=3.

with \sim (k;t) the spatial Fourier transform of the order param eter (x;t). The angle brackets denote an average over a shell in k space at xed k. The last quantity R₃(t) is de ned as the inverse of the rst m om ent of the spherically averaged structure factor of the uid velocity

with $C_u(k;t) = \langle j_2(k) j_2^2 \rangle$. In all the gures R_1 was multiplied by 4;000;000 to be shown in the same plot with R_2 and R_3 .




FIG. 3: Contour plots of a portion 512 512 of the whole lattice of the density n in the case with = 10^4 , = 0.5 and ux lim iter scheme. Color code: black/white! liquid/vapor.

In Fig. 2 we present the three m easures of dom ains size as function of time for the case $= 10^4$ with ux limiter scheme, and symmetric composition. It is interesting to note that R₂ and R₃ have the same trend, with a similar prefactor. This feature holds for all the runs we considered. This last point is not obvious a priori. A fter a swift in it ial grow th the evolution of all quantities suggests the existence of the growth exponent 2=3. This is in accordance with previous studies on symmetric liquid-vapor systems at low viscosity [41] when hydrodynamic ow is operating. In this regime hydrodynamics is the mechanism to get domains circular since the ow is driven by the di erence in Laplace pressure between points of di erent curvature on the boundary of dom ains. This remark is con med when looking at con gurations of the density n. In Fig. 3 we show contour plots of a part of the whole system at consecutive times. The vapor bubble in the down left comer at t = 12, while evaporating, is rounded by the ow as it can be seen by comparing it with the shape at t = 15.




FIG .4: Velocity structure factor C $_{\rm u}$ (k) at time t = 15 in the case with = 10 4 , = 0.5 and ux limiter scheme. C $_{\rm u}$ (k) is in arbitrary units and the wavelength is measured in lattice spacings.

An indication about the velocity $\,$ eld comes from the structure factor C $_{\rm u}$ (k;t). In Fig. 4 we plot it at time t = 15. It exhibits a structure at a scale comparable with system size. All velocity components decay becoming small at low wavelengths and contributing little to the overall dynamics. A small bump can be seen at wavelength 8 corresponding to capillary motion at interface length scale. A similar behavior was observed in binary uids [59].





FIG. 5: Evolution of dom ains size in the case with $= 10^4$, = 0.5 and the upwind scheme: R₁ (4), R₂ (), R₃ (). R's are measured in lattice spacings and R₁ as been rescaled by 4,000,000 to be shown in the same plot. The straight line has slope 1=2.




FIG. 6:0 rderparam eter (dashed line) and velocity m odulus u (full line) pro les are shown along the line taken at y = 256 lattice spacings from bottom at time t = 20 for the upwind scheme (upper panel) and ux limiter scheme (lower panel) with = 10^4 , = 0.5.

In the case with the upwind scheme the estimation of the growth exponent is more dicult since data are noisy and none of the R's shows a clear trend. From Fig. 5 it seems the system enters a late regime characterized by an exponent consistent with the value 1=2. We believe that this behavior is due to spurious term s in the macroscopic equations that are considerably larger when using the upwind scheme than in the case with ux limiter. These terms produce a numerical di usivity when they are not negligible. This is con med by the analysis of the velocity elds in the two cases. In Fig. 6 we plot the order parameter and velocity modulus u along a horizontal cross section of the system taken at the same long time. Two comments are in order here. It is quite unavoidable to have spurious velocities at interfaces where density gradients are present with LB models (irrespectively of the particular model used [60]). And also the present model shows this unpleasant feature. Nonetheless it is evident that the ux lim iter scheme allows to dum p considerably these spurious contributions. Indeed, with ux limiter the maximum value of velocity at interface is 0:13 (M $a = u = c_s = 0:14$) while with the upwind it is about 2 times larger being 0:23 (Ma = 0:26). The high

value of the M ach num ber M a m akes the expansions (7) less reliable with the upw ind scheme.




FIG. 7: Evolution of dom ains size in the case with $\,=\,10^{-3}$, $\,=\,0.5$ and $\,ux$ lim iter scheme: R $_1$ (4), R $_2$ (), R $_3$ (). R 's are measured in lattice spacings and R $_1$ as been multiplied by 4,000,000 to be shown in the same plot. The straight line has slope 1=2.

Due to the better performance of the ux limiter scheme we decided to adopt it for further simulations. In Fig. 7 we plot the three measures of domains size as function of time for the case $= 10^3$ with symmet-




FIG. 8: Contour plots of a portion 512 512 of the whole lattice of the density n in the case with $= 10^3$, = 0.5 and ux \lim iter scheme. Color code: black/white! liquid/vapor.

ric composition. A fiter initial growth all the quantities suggest the existence of the growth exponent 1=2. This is in accordance with previous studies on liquid-vapor systems at high viscosity [41] at symmetric composition when growth is expected to be described by the Allen-Cahn theory of interfaces dynamics which gives an exponent 1=2 [38] and hydrodynamics is not operating. Due to limits imposed by system size we cannot access very long times to probe whether the hydrodynamic regime is the late regime as previously argued [41]. Fig. 8 shows

density contourplots at consecutive times. Growth seems to be mainly driven by evaporation of vapor domains.




FIG. 9: Evolution of dom ains size in the case with $\,=\,10^4$, $\,=\,0.45$ and $\,ux$ lim iter scheme: R $_1$ (4), R $_2$ (), R $_3$ (). R 's are m easured in lattice spacings and R $_1$ as been multiplied by 4,000,000 to be shown in the same plot. The straight lines have slopes 2=3 and 1=2.

Finally, we considered the case of an o sym m etric system with a liquid fraction = 0.45. In Fig. 9 we plot the three measures of domains size as function of time for the case = 10^4 . A fter the initial growth all the




FIG. 10: Contour plots of a portion 512 512 of the whole lattice of the density n in the case with = 10 4 , = 0.45. Color code: black/white! liquid/vapor.

quantities suggest the existence of a grow th exponent 2=3 which quite soon changes to 1=2. In previous studies with a free-energy LB model it was found the growth exponent to be 2=3 with liquid fraction = 0:31 [41] and 2=3 crossing over to 1=2 at = 0:17 [42]. The problem of o -sym m etric liquid-vapor phase separation was recently addressed in Ref. [61]. There it was pointed out that in the case of a dispersion of liquid drops in vapor, the growth should proceed with an exponent 1=2 and the result was proven in the case of highly asymmetric composition with = 0:1. We believe that we are probing a regime similar to that seen in two-dimensional binary uidswhere, once hydrodynam ics ow has made dom ains circular, A llen-Cahn growth takes over [36]. This interpretation seems to be con med by con qurations of the system, presented in Fig. 10. They show that liquid drops in the vapor matrix are almost circular at t = 6 so that the hydrodynam ic mechanism is no more e ective.

V. CONCLUSIONS

The correct choice of the num erical scheme is essential to recover the real physics of a uid system subjected to LB simulations. In the case of a liquid-vapor system we have seen that simulation results exhibit signicant changes when the numerical contribution of the nite difference scheme to the apparent value of the transport coecients becomes comparable with the expected physical value. The numerical contribution of the restorder upwind scheme is linearly dependent on the lattice spacing

s and switches to an higher order for the ux limiter scheme. Since s < 1, the ux limiter scheme reduces the computing e ort in terms of required lattice nodes and gives physical results which are more accurate for the same number of lattice nodes per unit length. Spurious velocities at interfaces can be considerably dam ped and very low viscosity systems can be simulated preserving num erical stability. The main limitation comes from the requirem ent of a small time step when very low values of viscosity are needed. To give an idea of the CPU time we report that our code takes 6 hours to perform 10⁵ algorithm steps by using 32 X eon 3.055 GHz processors on the IBM Linux Cluster 1350 at CINECA [62] with Myrinet IPC network and the Portable Extensible Toolkit for Scienti c Computation (PETSc 2.1.6) developed at Argonne National Laboratory, Argonne, Illinois

The model allowed to clarify the picture of phase separation in liquid-vapor system. We found that the growth exponent depends on either the uid viscosity and the system composition. When liquid and vapor are present in the same amount, the growth exponent is 2=3 and 1=2 at low and high viscosity, respectively. When the liquid fraction is less abundant than the vapor one, we can access a late time regime at low viscosity. In this regime the hydrodynamic transport is no more elective so we are able to see the crossover from the exponent 2=3 to 1=2 which is characteristic of the Allen-Cahn growth mechanism.

Finally, we note that our results as well as previous ones have been obtained in the case of isotherm al systems. It would be interesting to incorporate the energy

conservation equation into the model to allow non uniform temperatures in the liquid-vapor system undergoing phase separation.
