Controllable quantum spin precession by Aharonov-Casher phase in conducting ring

Abstract

We investigate quantum spin transport in a structure of conducting ring, embedded in textured electric eld, with two leads, and obtain an exact solution for the problem. The spin precession induced by the Aharonov-Casher phase is studied. It is shown that the spin-polarized current and its polarizability can be controlled by the electric eld. As a result the polarizability is a function of the geometric phase which originates from the spin-orbital interaction in the ring.

In the recent years spin transport has attracted considerable interests because of its potential applications in sem iconductor electronics and quantum computation^{1,2,3}. How to control or to modulate spin polarized current is one of important steps in the investigation of spin coherence in electronic systems. Datta and Das⁴ proposed a spin eld-electronic systems. Datta and Das⁴ proposed a spin eld-electronic transistor (FET), in which spin polarization of charge carriers precesses when the charge carriers transmit through a 2D sem iconductor channel between a ferrom agnetic spin injector and a ferrom agnetic spin collector. It is well known that, in sem iconductor heterostructures, the spin-orbit or Rashba interaction makes spin-orbit splitting of the conduction electron energy band. Such splitting produces spin precession while the electrons go through the sem iconductor channel. Experimentally, the Rashba coupling can be adjusted by an electricely eld such that a spin-polarized current injected from the source can be spin-dependently modulated on its way to the drain by an external gate^{5,6}. Other proposals were recently reported^{7,8,9,10,11}. However more sophisticated structures are conceivable where current modulation could arise from the spin interference.

The conventional Aharonov-Bohm (AB) e ect is anticipated to modulate the charge current. It was shown that a non-uniform magnetic eld may also control the polarization direction of spin current¹². The Aharonov-Casher (AC) e ect¹³ originates from the spinorbit coupling between the moving magnetic polar and the electricella. It is expected to im plem ent the spin current modulation manifested by AC e ect. Quantum coherent transport in a structure of the AC ring with two leads was discussed by many authors 14,15,16,17,18. It was found that the AC ux can lead to interference phenomena as the AB observable AC oscillation in the conductance. With an electrice eld as a parameter, it is expected to study the precession of spin current for interfering electrons manifested by the geom etric properties of the ring. In the present paper we establish the connection between quantum spin polarizability and spin precession in the quantum transport in a AC ring, such that it is controllable through the external electric eld by means of AC e ect. We present an exact solution for the problem and focus on the spin aspect of quantum transport. Assume the ring embeds in a symmetric textured electriceld with an arbitrary tilt angle as shown in Fig. 1. In the AC ring, the magnetic moment of charge carriers is in uenced by the electric eld through the spin-orbit interaction and there is an energy splitting between spin-up and -down electrons. The local spin orientations on the ring are determined by a spin cyclic evolution over the ring. When electrons travel through each arm of the ring,

the wave functions of electrons acquires spin-dependent Aharonov-Anandan (AA) phases¹⁹, which is the geometric part of the AC phase. Without specializing the direction of spin-polarized injection, we calculate the spin-dependent transmission coeccients analytically. In the Landauer fram ework of ballistic transport²⁰, it is shown that the spin polarized current and its polarizability can be controlled by the electricelled via AC phase. Our result shows that the AC ring can act as a tunable spin switch by adjusting the electricelled.

In the ring, the one-particle H am iltonian for non-interacting electrons with a m om entum p is given by

where = g $_{\rm B}$ a magnetic moment of charge carrier, $_{\rm B}$ the Bohr magneton, g the gyromagnetic factor, c the velocity of light in vacuum and $_{\rm i}$ (i = 1;2;3) the Pauli matrices. The linear term of the electric eld in the Hamiltonian, (E p); represents the spin-orbit coupling and is proportional to the electric eld. In the cylindrical coordinate, the textured electric eld can be written as E = E (cos f sin f). The eigen functions of given Hamiltonian (1) are given by $_{\rm n}$; = $\frac{1}{2}$ ein where

where T stands for the transpose and denotes spin up and down along the direction of unit vector = (sin cos ; sin sin ; cos): is de ned by tan $_1 \pm (1 + !_3)$ with $!_1$ (E a=~c) sin and $!_3$ (E a=~c) cos . The corresponding eigenvalues are E_n ; = $\frac{^2}{^2 2m \, a^2}$ n $_{AC} = 2$; where n is an integer. $_{AC} = 0$ ($_0 = \frac{p}{!_1^2 + (1 + !_3)^2}$) are the AC phases which are acquired while the two spin states evolves in the presence of the electric eld^3 .

A ssum e that electrons are free electrons in two leads and have the momentum κk : The energy is given by $E = \kappa^2 k^2 = 2m$. When an electron is transported along one arm in the clockwise direction from the input intersection A, it acquires an AC phase $_{AC} = 2$ at the output intersection B. And the electron acquires a phase $_{AC} = 2$ in the counter-clockwise direction along the other arm. Thus the total phase changes around the loop is $_{AC}$. In the ring the electric eld may change the momenta of the electrons into the same energy as in

the leads in two different spin states $\ , k_1 = k + \ _{AC} = 2$ a and $k_2 = k \ _{AC} = 2$ a; where the subscripts 1;2 denote the clockwise and counter-clockwise direction, respectively. a is the radius of the ring. It is worth to point out that $k_1 \ k_2 \ a = \ _{AC}$ is independent of the momentum of incident particles. This phase difference leads two branches of wave functions to intervene at the output intersection (x ranges from 0 to a in two arms of the ring). The wave function in two arms of the ring can be written as

We have assumed that a polarized electron is injected to left electrode from ferrom agnetic source and travel in the x direction, and the spin state of the injected electron is $_{i}$ = $(\cos ; \sin)^{T} e^{ikx}$: For a general considerations the wave functions in the two arms can be expressed in terms of the rejection and transmission of electrons when they transport through the ring in presence of the spin-orbital interaction. The wave functions of the electron in the left and right electrodes are

where r and t are the spin dependent re ection and transm ission coe cients, respectively. In the linear response regime of the Landauer fram ework²⁰, the quantum mechanical transm ission amplitude is related to two-probe conductance. The spin-dependent conductance through the ring is expressed in term of the transm ission probability $T = \frac{1}{2} \int_{0}^{2} as$ $G = (e^2 = h)T$: To calculate the transm ission probability through the AC ring, were use the local coordinate system for each circuit such that the x coordinate is taken along the electron current. The origin of each local coordinate is taken at each intersection. The choice of the coordinate origin is trivial because it only a ects an extra phase factor on the transm ission amplitude. Thus the Gri th's boundary condition²² gives that at each intersection the wave function is continuous and the current density is conserved. A firer some

tedious algebra, we obtain the transmission coe cient t:

The coe cient probability was obtained for two special cases by Choi et al. For instance when = 2; c_n ; $= d_n$; = 0. In this sense only the component of $_+$ remains and there is no spin ip. Our general expression shows that the transmission probability is independent of the incident spin state. Both expressions in Eqs. (8) and (9) are determined by the AC phase, the spin and kinetic state of the incident particles, and the electric eld. It is noticed that there is a special case that the transmission coe cients become zero and all incident wave rejects from the ring when $\sin k$ and a = 0. To illustrate the main physics in the problem, we present some numerical calculation for several physical quantities. For an InAs ring with a = 1 m, the Fermi velocity v_F is approximately a = 10 cm s⁻¹ and a = 10 m. The number is tunable for k and the size of the ring. Thus in the numerical calculation we take a = 60.239.

Following the Landauer formula, the spin-resolved current is given by $j = VG = V(e^2 = h)T$: One of the interesting observations is that

which is determined by the AC phase as well as the radius of the ring. It depends on the energy of incident particles, but is independent of the initial spin state. Thus the electric eld can modulate the transmission charge current through the AC phase. In Fig. 2, we plot je versus the magnitude E and direction angle of the electric eld.




FIG. 3: The polarized spin current j_s with unit V e $_B$ =h varies with respect to the electric eld E with unit \sim c= a and its direction tilt angle with unit .

In Fig.3, we plot the polarized spin current versus the electric eld m agnitude E and direction angle: The transm ission polarized spin current is controlled by the tilt angle as well as the m odulation analogous to the transm ission charge current.

To see this modulation clear, we introduce a dimensionless polarizability P to describe the polarization degree along the spin S_z axis of the transmitted current through the AC ring, which is defined by

P is independent of the mass m and momentum \sim k of the incident charge carriers for a large ka. This is an important advantage for the device application. P is similar to the spin injection rate dened in ferrom agnetic/sem iconductor/ferrom agnetic heterostructures and can be measured experimentally. Thus P is simply determined by only. For the incident state i, the spin polarized tilt angle is 2 and the polarizability $P = P_0 = \cos 2$. We see that the transmitted polarizability is modulated by . In the case the transmitted current is just modulated by the AC phase, and is spin-independent. We plot the spin polarizability P versus E and in Fig.4 for the case = 0. From the denition of it is equal to when the electric eld E is very large. It is obvious that the spin polarizability approaches to a constant with increasing of electric eld strength for a certain angle. This mechanism is different from Datta and Das's proposal, where is the phase difference of two spin states determines spin precession. In the present paper, the role of phase difference $k_1 = k_1 = k_2$ of two spin eigenstates between the source and drain just controls the transmission coefficients and does not a feet the spin polarizability.

This theory can be applied to a simple device to control the polarized spin current following D atta and D as' proposal. The sem iconductor hetrostructure is replaced by a conducting ring to connect the source and drain. The gate voltage is applied to control the electriceld exerting on the ring as shown in Fig. 1 (b). In this case $E = E \hat{z}$, i.e., $E = E \hat{z}$, i.e., $E = E \hat{z}$. A ssum e a spin-up electron ($E = E \hat{z}$) is injected from ferrom agnetic source and passes though the AC ring. For a large electric eld $E \sim c=a$; !=2 and P=1: The polarization direction of incident electron with spin up can be ipped into spin down. One of the advantages of the device is either the transmission probability or polarizability of the transmitted current is tunable by the electric eld. A similar device was proposed by N itta et al. Except for the electric eld, an magnetic eld is also applied to split energy levels in the ring. A coording to the present theory the electron spin can evolve a tilt angel even in absence of an external magnetic eld.

In sum mary, we have obtained an exact solution for the quantum transport in a AC ring with two leads and shown that the quantum spin transport is modulated by the electric eld. The AC phase may control the transmission current, and the spin of electron evolves an tilt angle after passing through the ring. The angle is determined by the electric eld and the size of the ring, but independent of the energy of incident particles. Following Datta and Das, we propose that the device of AC ring with two leads can serve as a spin transistor. The spin-resolved current can be well controlled by the voltage gate.
