COUPLING AND DEPHASING IN JOSEPHSON CHARGE-PHASE QUBIT W ITH RADIO FRE-QUENCY READOUT

A bstract

The C ooper pairbox qubit of a two-junction-SQ U D con guration enables the readout of the qubit states by probing the e ective Josephson inductance of the SQ U D. This is realized by coupling the qubit to a high-Q tank circuit which induces a small alternating supercurrent in the SQ U D bop. The e ect of a small (but nite) geom etrical inductance of the bop on the eigenstates of the system is gured out. The e ect of qubit dephasing due to quadratic coupling to the tank circuit is evaluated. It is shown that the rate of dephasing in the vicinity of the magic points is relatively low unless the Josephson junctions form ing the qubit are rather dissim ilar. In the vicinity of the avoided level-crossing point such dephasing is always signi cant.

1 Introduction

The readout device is a critical component of any potential quantum computing circuit. For the Josephson qubits there is a number of sensitive cryogenic devices available (SQ U ID s, switching Josephson junctions, single electron transistors and traps, etc.) enabling the readout of the qubit state. However, operation of these devices is usually associated with a signi cant exchange of energy between detector and qubit, so in order to avoid fast decoherence the detector must be reliably decoupled from the qubit at the time of quantum manipulation. Recently, the class of Josephson qubit detectors based on the measurement of the reactive component of electrical signals related to nonlinear behavior of the Josephson inductance has been extensively studied [1, 2, 3, 4]. Due to speci c coupling to the qubit variables




Figure 1: Electric circuit diagram of the charge-phase qubit. The core of the qubit is the superconducting ring of sm all inductance L including two sm all tunnel junctions of capacitances C_1 and C_2 and Josephson coupling energies E_{J1} and E_{J2} , respectively. The sm all island between the junctions is polarized by charge on sm all gate capacitance C_g . The ring is inductively (mutual inductance M) coupled to an rf-driven parallel tank circuit. Voltage across the tank circuit is read out by a (presum ably cold) pream pli er which is not shown.

and non-dissipative characteristics of the Josephson supercurrent, these circuits can have a much weaker backaction and, therefore, cause lesser decoherence. M oreover, these circuits may possibly enable quantum nondem olition measurements of a Josephson qubit [5].

In this paper, we consider the charge-phase qubit [1] com prising a m acroscopic superconducting ring including two small Josephson junctions with a small island in between (see Fig. 1), i.e., a Cooperpair box [6] of SQUID con quration. This setup is, in principle, similar to that of Quantronium [7], in which, however, a larger additional Josephson junction was inserted in the superconducting loop for the purpose of readout by switching this junction into a nite-voltage state. In our case, the ring of inductance L is inductively coupled to the tank circuit that enables both phase control and readout of the qubit. The special convenience of this simple setup is that it can function even without uncoupling the tank circuit from the qubit. It has recently been shown that operation of this qubit in the so-called magic points made it possible to decouple (in linear approximation) both the diagonal and the o -diagonal components of the variables of the measuring system (environment) from the qubit [3]. Moreover, the resonance shape of the noise spectrum allowed signi cant reducing relaxation and, in principle, perform ing single shot m easurem ents. Here we analyze the quadratic e ect of this noise and show that dephasing caused by this e ect in the vicinity of the magic operation points is sm all, provided the qubit is su ciently symmetric.

2 Qubit param eters and the model

For the vanishingly small value of inductance L the behavior of the charge-phase qubit is primarily determined by the relationship between the energies associated with the island and the junctions. These are the Coulomb energy of the island, $E_c = e^2 = 2C$, and the Josephson coupling energies of the junctions, $E_{J1;J2} = hI_{c1;c2} = 2e$, where $C = C_1 + C_2 + C_g$ is the island's total capacitance including the capacitances of the individual junctions C_1 and C_2 and the gate capacitance $C_g = C_{1;2}$; $I_{c1;c2}$ are the nom inal values of the Josephson critical currents. We assume that

where $_0 = h=2e$ is the ux quantum, E_{J0} and $I_{c0} = (I_{c1} + I_{c2})=2$ are the average Josephson coupling energy and the average critical current, respectively. The coupling energies of individual junctions are almost sim ilar, $E_{J1} = E_{J2}$, so the values of the dimensionless parameters $j_{1;2} = E_{J1;J2}=2E_{J0} = 0.5$, while $j + j_2 = 1$. The junction capacitances are also assumed to be almost sim ilar, $C_1 = C_2$, and the dimensionless parameters $_{1;2} = C_{2;1}=C = 0.5$, while $_1 + _2 = 1$. The qubit island is capacitively coupled to the gate voltage source V_g which controls the polarization charge $Q_0 = C_g V_g$. The inductively coupled coil L_T carrying current I induces the external magnetic ux $_e = (_0=2)_e = M$ I applied to the qubit loop and produces the sum phase bias $'_1 + '_2 = _e$. The core Ham iltonian includes the charging (kinetic) energy and Josephson (periodic potential) term,

where the operator n of the num ber of excess C ooper pairs on the island is

The operators of the island phases are $' = ('_1 \quad '_2)=2$ and = ' + (), where the angle deviation due to asymmetry of the junctions $= \arctan[(j_1 \quad j_2)\tan(=2)]$. The amplitude of the elective Josephson coupling energy of two junctions is equal to

The two lowest eigenvalues of energy, $E_0 (Q_0;)$ (ground state) and $E_1 (Q_0;)$ (rst excited state), with corresponding eigenstates jDi and jLi, form the basis suitable for qubit operation. In this basis the H am iltonian Eq. (2) takes the diagonal form

where energy $(Q_0;)$ h = $E_1 = E_0$ and z is the Paulimatrix. The energy landscape is 2e periodic in Q_0 and 2 periodic in . The plots can be found elsewhere (see, for example, Refs.[7] and [8]). The reverse Josephson inductance of

the qubit in the ground (excited) state $L_{0,1}^{1}$ is determ ined by the local curvature of the corresponding energy surface,

Depending on the value of the ratio $E_{J0}=E_c$ and the relationship between the Josephson energies of the junctions, $j_1=j_2$, the inductance $L_{0;1}$ can take either positive or negative values in di erent points on the Q₀- plane. In the so-called magic points (extrem um or saddle points), i.e., A (Q₀ = 0; =), B (Q₀ = 0; = 0) and C (Q₀ = e; = 0), the absolute values of $L_{0;1}^{-1}$ achieve local maxim a, while in the avoided level-crossing point D (Q₀ = e; =) its value is the largest [8]. Speci cally, in point D, where elective coupling is small, E_J () = $j_{E_{J1}}$ $E_{J2}j = E_c$, these values for two states are equal to [9]

The drive frequency $!_{rf}$ (close to the resonance frequency of the tank circuit $!_T = (L_T C_T)^{1=2}$ $k_B T=h$) is much lower than the qubit frequency , so the induced classical oscillations of phase are adiabatic. Due to coupling to the ring, the elective inductance seen by the tank circuit is [10]

As a result, the resonance frequencies take the distinct values for the ground and excited states, $!_{0;1} = (L_e^{(0;1)}C_T)^{1=2}$, and this property is used for the radio frequency readout of the qubit [1].

3 E ect of nite inductance of the ring

The problem of the inductance e ects in the persistent current ux qubits had been addressed by Crankshaw and Orlando in Ref. [11] where the corrections to the energy level values of these qubits were found. Recently, Maassen van den Brink had analyzed the nite inductance e ect in the three-Josephson-junction jubits considering the self-ux as a "fast variable" [12]. He had shown that for sm all inductances this e ect is merely reduced to renorm alization of the individual Josephson coupling energies entering the system H am iltonian.

In the case of the charge-phase qubit, the sum phase is also no longer a good variable. Instead, its combination with the normalized circulating current (which is a quantum -m echanical operator) is controlled by the external ux $_{\rm e}$,

The operator of the circulating current can be presented as [8]

In the given basis, the operator \cos is diagonal and \sin is o -diagonal, so the amplitudes of the longitudinal (I_k) and transversal $(I_?)$ components of current I_s are

Note that the operator I_s is diagonal for arbitrary values of parameters Q_0 and only if the junctions are identical, i.e., $j_1 = j_2$ and $_1 = _2$, so $I_2 = 0$.

The additionalm agnetic energy term in the system Ham iltonian is

The kinetic energy term associated with the charging of the chain of the qubit junctions connected in series, H_e = ($_0=2$)²C⁻²=2, where C = C_{qubit} + C_{stray}. A lthough the capacitance between the ends of the SQUID loop C_{stray} depends on the sam ple layout, it clearly dom inates over the rst term, C_{qubit} = C₁C₂=C which is typically about 1 fF [13]. The resonance frequency !_L = (LC)¹⁼² of the oscillator form ed by L and C is therefore relatively low. A sum ing h!_L k_B T, but still !_L !_{rf} we recover classical behavior of . In this case it is su cient to take into account only the magnetic term associated with the circulating current given by Eq.(13).

The phase variable is a single-valued function of $_{\rm e}$ for arbitrary values of Q $_0$, provided L is su ciently small, viz.,



O ne can see that for an alm ost sym m etric qubit $(j_1 \quad j)$ the condition of sm allness of inductance L, i.e. $_L < 4jj_1 \quad jj$ is more stringent than that for ordinary rf SQUIDs, i.e. $_L < 1$ [14].

To derive the dependence ($_{\rm e}),$ one can solve Eq.(9) by iteration. The 1st step gives the expression

Then the corresponding one-dimensional Schrodinger equation,

is again of the type describing a quantum particle moving in a periodic potential. In the case of L = 0, this potential is harm onic and the equation is of the M athieu type [15]. In the case of nonzero L, the potential energy includes a (sm all) second harm onic admixture. The eigenvalues and eigenfunctions of this equation are found by num erical methods.

Figure 2 shows the two low est eigenvalues of energy (the qubit levels) computed from the Schrodinger equation Eq. (17). For the given parameters of the qubit and not very small value of $_{\rm L}$, the subsequent terms of iteration give substantially smaller correction. One can see that similar to the conclusion of Ref. [11], the rst order e ect of inductance reduces to the lowering of both energy surfaces, E₀ and E₁. The correction to the level spacing Eq. (5) is, however, very small: $! + _{\rm L}$; $_{\rm L}$ As can be seen from Fig.2, the e ect of the deformation of the energy surfaces is most appreciable in the region of small e ective Josephson coupling combined with charge degeneracy, e.g., in the vicinity of point D. A round the magic points A and – especially – B and C, which are most suitable for qubit operation, the change of local curvature of the surfaces is rather small.

4 Qubit dephasing

The term in the system H am iltonian which describes coupling of the qubit and the variable $_{e} = M I_{f}$ associated with the external ux noise induced in the ring by the tank circuit is given by

where corresponding matrix elements are denoted by

The remarkable property of the coupling described by Eq.(19) in plies that the longitudinal term , U_z / I_k , vanishes in the optimal points A, B, C and D, i.e. where sin $_e = 0$ (see Eq.(11)) [16]. The transversal term , U_y / I_2 , in these points is, how ever, nonzero, and its low-frequency () noise component can dephase the qubit due to renorm alization of the level spacing [17], ! $(^2 + U_y^2)^{1-2} + U_y^2=2$, yielding the diagonal term

The problem of qubit dephasing due to quadratic longitudinal coupling to the environm ent was addressed by M akhlin and Shnim an in Ref. [17] where they focused on the experim entally relevant 1=f and the Johnson-N yquist noise power spectra. Here we extend thism odel to our case of a structured bath (low -frequency resonance tank circuit).

For white noise I_f associated with losses in resistance R_T , the power spectrum density S (!) of variable $_e$ is simply found from the network consideration. Neglecting small detuning of the tank due to coupling to the qubit ring (! $_0$! $_1$! $_T$) we arrive at the expression,

where $Q = !_T C_T R_T = R_T = !_T L_T$ is the quality factor. A ssum ing that the noise is G aussian we nd the power spectrum density of uctuations of the variable $(e)^2$ (see, for example, Ref. [18]),

where $k = M = (LL_T)^{1=2}$ is the dimensionless coupling coe cient.

To evaluate Q, for typical parameters of the qubit (leading for the operation points A, B and C to the value ($=E_{J0}$)³ 10) let us assume that the quality factor of the tank circuit is Q = 300 while the product k^2 Q_L = 10 which ensures su cient resolution in determining the resonance frequencies !_{0,1}. Taking the value of ratio $E_{J0}h!_T = (k_B T)^2$ 0:1 (with $E_{J0} = 100$ eV, $!_T = 2 = 100$ MHz and T = 1K) we get an estimate: Q, = 10² ($I_{c0} = s_{01}I_2$)⁴.

In the optim algoints A and D , the amplitude $I_{?}\ \mbox{(see Eq.(12))}$ is equal to

Sum m arizing, the order-of-m agnitude estim ates for parameter ${\tt Q}$, in dimension points are

For the Josephson junctions with a reasonably high symmetry in their parameters, say 10% (e.g., j = 0.1), the expected value of Q, in points A, B and C greatly exceeds the level 10^5 which should be su cient for realization of active schemes for compensation of decoherence. In contrast to these gures, the value achieved in the avoided level-crossing point D is relatively low.

5 Conclusion

We have shown that qubit dephasing due to nonlinear coupling in the vicinity of magic operation points is relatively weak if asymmetry of the junction parameters is su ciently small and the elective temperature of the tank circuit su ciently low. Since this temperature is associated with the backaction noise of a pream - plier, its noise gure should be su ciently low, as, for example, in the case of a cold sem iconductor-based amplier or a dc-SQUID-based ampli er [20]. Further improvement (if necessary) of the charge-phase qubit with radio frequency readout can be achieved by using a stage ensuring variable coupling between the ring and the tank circuit. This could be, for example, a ux transformer with a variable transfer function [21].

In conclusion, su ciently symmetric parameters of the junctions make it possible to e ectively protect the charge-phase qubit against dephasing caused by its coupling to the radio-frequency readout circuit. The dom inating mechanism swhich may still cause appreciable dephasing in this kind of qubit are most likely related to intrinsic characteristics of the Josephson junctions (see, e.g., Refs. [22, 23]).
