Nonequilibrium e ects created by stationary current injection in layered d-wave superconductors forming a stack of intrinsic Josephson junctions are studied. Starting from a nonequilibrium G reen function theory we derive microscopic expressions for the charge-in balance (di erence between electron- and hole-like quasi-particles) on the superconducting layers and investigate its in uence on the quasi-particle current between the layers. This nonequilibrium e ect leads to shifts in the current-voltage curves of the stack. The theory is applied to the interpretation of recent current injection experiments in double-mesa structures.

I. IN TRODUCTION

In the strongly anisotropic cuprate superconductors like $B_{12}Sr_2CaCu_2O_{8+}$ (BSCCO) the superconducting CuO_2 layers together with the intermediate insulating material form a stack of Josephson junctions. In the presence of a bias current perpendicular to the layers the intrinsic Josephson e ect manifests itself in a multi-branch structure of the IV-curves, 1,2,3,4,5 where on each branch a di erent number of junctions is in the resistive state.

In the resistive state high frequency Josephson oscillations at a nite dc-voltage are accompanied by a dccurrent which is carried mainly by unpaired electrons (quasi-particles), while in the superconducting state it is carried mainly by Cooper pairs. Therefore, on a superconducting layer between a resistive and a superconducting junction the bias current has to change its character from quasi-particle current to supercurrent. This creates a non-equilibrium state on this layer with a nite quasi-particle charge and a change of the condensate charge. The quasi-particle charge is characterised by a distribution function with di erent num bers of electronlike and holelike quasi-particles, while the change of the condensate charge, the number of paired electrons, can be described by a shift of the chemical potential of the condensate.

In recent experiments such non-equilibrium e ects have been observed in layered d-wave superconductors.6 In a rst type of experim ents Shapiro steps produced by high-frequency irradiation have been measured in mesa structures of BSCCO with gold contacts. Here a shift of the step voltage from its canonical value hf/ (2e) was observed, which can be traced back to a change of the contact resistance due to quasi-particle charge on the rst superconducting layer. In another type of experim ents current-voltage curves have been investigated for two mesas structured close to each other on the same base crystal (see Fig.7 below). Here an in uence of the current through one mesa on the voltage drop through the other mesa has been measured which is caused by charge in balance on the rst common superconducting layer of the base crystal. In a recent paper⁷ we have explained these e ects by using a sem iphenom enological approach based on a m icroscopic non-equilibrium G reen function theory^{8,9} for layered superconductors.

In this paper we will present the full m icroscopic theory for stationary charge-in balance e ects in intrinsic Josephson systems. In order to be specic, we apply the theory rst to an experiment, which in this form has not yet been done, but is conceptual simpler then the double-m esa injection experim ent m entioned above. W e consider a m esa as shown in F ig. 1 with two norm allelectrodes on top. Through one electrode a stationary bias current is applied creating a charge in balance on the st superconducting layer. At the other electrode a voltage is measured as function of the bias current through the rst electrode with zero current through the second electrode. This experiment is similar to the classical experin ent by Clarke,¹⁰ where a strong current in jected into a bulk superconductor creates quasi-particles. By two other electrodes, one norm al junction and one Josephson junction, a voltage is detected at zero current which m easures the di erence between the chem icalpotential of quasi-particles and condensate. In our case the junction between the norm alelectrode and the st superconducting layer is the norm al junction, the coupling between the rst superconducting layer and the next superconducting layers is the Josephson junction. This experiment allows to determ ine the charge in balance and (with further theoretical input) its relaxation rate. A fter this investigation we return to the discussion of the double-m esa in jection experiment.

Nonequilibrium e ects in bulk-superconductors have been studied a long time ago. For an overview see the text-book by Tinkham¹¹ and the review-articles edited by Langenberg and Larkin.¹² The basic concepts of charge-inbalance have been developed by Tinkham and Clarke,^{10,13} Pethick and Sm ith.¹⁴ The theory has been worked out using a non-equilibrium G reen function approach by Schmid and Schon,^{15,16} and Larkin and O vchinnikov.^{17,18} M icroscopic nonequilibrium theory of layered superconductors was considered rst by A rtem enko¹⁹ and later by G rafet al.²⁰

Nonequilibrium e ects in intrinsic Josephson system have been investigated theoretically already




FIG. 1: M esa-structure used for 4-point m easurem ents consisting of a stack of superconducting layers with two norm al electrodes on top.

in various contexts using di erent methods and approximations.^{21,22,23,24,25,26,27,28,29} In Refs. 21,28 the in uence of charge-coupling on Josephson plasma oscillations has been investigated, in the approach used in Refs.^{23,24,26} a systematic perturbation theory in the scalar potential on the layers has been performed. In these theories charge in balance is considered only indirectly as far as it is induced by uctuations of the scalar potential. The present theory which uses non-equilibrium G reen functions is more general. Here charge in balance is taken into account as an independent degree of freedom, and therefore the results are di erent from those of earlier treatments.

Here we apply this theory to stationary processes in layered d-wave superconductors. Due to the weak coupling between the superconducting layers the total charge created by the bias-current is non-zero. Therefore we have to treat charge uctuations of the condensate and quasi-particles as independent quantities. The d-wave character of the order-parameter allows quasi-particle tunnelling also at low voltages and temperatures. Furtherm ore it allows the relaxation of charge-im balance by elastic scattering processes (in purity scattering within a layer). On the other hand the weak coupling between the layers leads to a partial decoupling of the kinetic equations for the G reen functions in di erent layers, making this system a particularly sim ple exam ple for the application of nonequilibrium theory in superconductors.

In the following section we start with general considerations concerning the Josephson e ect in layered superconductors and the de nition of charge-imbalance. We then form ulate the basic kinetic equations describing stationary nonequilibrium e ects in intrinsic Josephson systems and calculate the charge imbalance m icroscopically. We show how these e ects can be measured by discussing the above mentioned 4-point experiment and the coupled two-mesa system. Finally we discuss the in uence of charge-imbalance on the IV-curves of a stack of junctions.

II. GENERALISED JOSEPHSON EQUATIONS

We consider a system of superconducting layers with indices n and order parameter $_n(t) = j$ jexp (i $_n(t)$) with time-dependent phase $_n(t)$. We de ne the gauge invariant phase di erence as:

where $A_z(z;t)$ is the vector potential in the barrier. Here e denotes the elementary charge. The charge of the electron is e.

For the time derivative of $n_{j,n+1}$ we obtain the generalized Josephson relation:

where $_{n}$ (t) is the electrical scalar potential.

The quantity $\sim_{-n,n+1} = 2e(V_{n,n+1} + {}_{n+1} - {}_n)$ is the total energy required to transfer a Cooper pair from layer n to n + 1, e _n can be considered as the shift of the chem – ical potential of the superconducting condensate with respect to an average chem ical potential , i.e. the num ber of particles in the condensate is controlled by + e _n. For equilibrium superconductors $\sim_{-n} = 2e_n$, _n = 0, and one has the usual Josephson relation $\sim_{-n,n+1} = 2eV_{n,n+1}$.

The generalised Josephson relation (2) for a stack of Josephson junctions can be written in another way show-ing explicitly the electric eld distribution between the layers. We split the total charge uctuation on a layer $_{n} = {}_{n}^{c} + {}_{n}^{q}$ into a contribution ${}_{n}^{c}$ from particles in the condensate and a contribution ${}_{n}^{c}$ from unpaired electrons (quasi-particles) describing charge-im balance. The charge uctuation of the condensate can be expressed directly by the change of the chemical potential on layer n:

where N (0) is the (two-dimensional) density of states for one spin direction at the Ferm i energy. It is convenient to express also the uctuation of quasi-particle charge by som e quasi-particle potential $_n$, dening

W hile in bulk superconductors charge neutrality leads to =, this is not the case in weakly coupled layered superconductors.

W ith help of (7) and the M axwell equation (d is the distance between the layers)

with a = $_0 = (2e^{2}N \ (0)d)$. It shows that the Josephson oscillation frequency is determined not only by the voltage in the same junction but also by the voltages in neighboring junctions. The coe cient a has already been introduced by K oyam a and Tachiki,²¹ how ever in their theory charge in balance e ects described by the quasi-particle potential $_n$ have not been considered.

For a barrier in the superconducting state the time average $h_{n,m+1}$ i vanishes, while for a barrier in the resistive state $\sim h_{n,m+1}$ i=2 is the electrochem ical potential di erence. A similar equation also holds for the contact with the norm al electrode. Denoting the norm al electrode, which is assumed to be in equilibrium by n = 0, we have

In the case of a stack in contact with a norm all electrode on top, where all internal barriers are in the superconducting state we nd for the rst superconducting layer $_1$ aV + $_1$. This result follows from Eqs. (2, 9, 10) in the limit a 1. Note that the total voltage of the stack is V = $_{n \to n; n+1} \sim = (2e)$.

In order to describe transport between the layers we need also an expression for the current density. In our previous $papers^{6,7}$ we have used

which is approximately valid in the stationary case (no displacement current). The rst term is the current density of Cooperpairs. The rest is the quasi-particle current density, which is driven not only by the electrochemical potential di erence, but contains a di usion term proportional to the quasi-particle density di erence. In the following the current expression will be derived from the microscopic theory.

F inally we need some theory describing the creation and relaxation of quasi-particle charge in order to calculate the charge-imbalance potential n. In our previous papers we have used a relaxation time approximation. In the stationary case we obtained

describing the balance between charge-in balance creation by the in- and outgoing quasi-particle currents and relaxation into therm al equilibrium inside the layer. It will be the main task of this paper to derive such a relation from a microscopic theory.

III. KINETIC EQUATIONS

For the m icroscopic description we start from equations of motion for the spectral (retarded and advanced) and Keldysh G reen functions in Nambu space (for details see the appendix A). Nonstationary corrections to the spectral functions are small, and these functions can be taken in equilibrium. The Keldysh function contains the necessary information about the nonequilibrium distribution functions. In our model we consider d-wave superconductivity on each layer within the BCS-approximation, elastic in purity scattering inside the layer and tunnelling between neighboring layers in low est order. Then it is possible to form ulate equations of motion for the G reen function G_n^{K} (K;t_1;t_2) for each layer n with a tunnelling self-energy containing the coupling to the neighboring layers.

Furtherm ore we introduce quasiclassicle G reen functions, which are obtained by integrating the G reen function over the kinetic energy $_{k} = _{k}$. Performing in addition a Fourier transformation with respect to the time di erence = t_{1} to at xed central time t = $(t_{1} + t_{2})=2$ we obtain (see the appendix B) the following kinetic equation for the quasiclassical K eldysh function g_{n}^{K} (\hat{k} ;t;) in N am bu space:

where $_n$ (t) is the gauge invariant scalar potential Eq.(4). (\hat{k}) is the superconducting order parameter with d-wave symmetry. We have applied a gauge transformation such that on each layer the superconducting order parameter has the same phase (in our case it is real). The quantities ^ are self-energies due to impurity scattering and tunnelling, which will be specified later. The curly brackets denote a convolution in time and frequency space. In the stationary case, which we consider in the following, we will neglect the time dependence. Then the convolutions are simple products, the dependence.

dence on n (t) drops out, and we obtain the basic equation

These equations will be used in the following to determine the distribution functions () and () describing the non-equilibrium state. In particular, Eq.(27) describes the balance between the relaxation of quasiparticle charge due to impurity scattering within a layer and its creation by the tunnelling current (see Eq.(43) for the result in a special case).

IV. CALCULATION OF THE CHARGE IM BALANCE

We consider potential scattering from random ly distributed in purity centers and tunnelling to the neighboring layers in lowest order. In order to calculate the self-energies and scattering integrals we need expressions for the retarded and advanced G reen functions. Here we use the results from equilibrium (this can be justi ed by studying the corresponding equations of motion in the low frequency lim it).

A. Retarded and advanced G reen functions

The retarded (advanced) quasi-classical G reen functions in equilibrium have the form :

C. Tunneling

If we neglect additional phase uctuation, the phase difference is $n_{,n^{0}}(t) = {0 \atop n_{,n^{0}}} + n_{,n^{0}}t$, where ${0 \atop n_{,n^{0}}}$ is the static phase di erence, which is determ ined by the supercurrent, and $n_{,n^{0}}$ is proportional to the electrochem ical potential di erence between the two layers.

For the tunnelling matrix element we have to assume a partial conservation of momentum in order to obtain Josephson coupling between di erent superconducting layers with d-wave order parameter. This, however, is not relevant for the tunnelling of quasiparticles, which will be discussed here primarily. In the following we will model the tunnelling matrixelement near the Fermi surface by N (0) $f_{k^0k}f = t(\hat{k};\hat{k}^0)$ with h $(\hat{k}) t(\hat{k})i \in 0$.

The most simple case to study nonequilibrium e ects is the tunnelling between a norm alelectrode and a superconducting layer, which willbe discussed in the following. Results for quasi-particle tunnelling between two superconducting layers will be given in the appendix. In the case of tunnelling with a norm alelectrode only the norm al G reen functions contribute to the tunnelling self-energy, which is tim e-independent. W riting $v = \frac{n}{n} \frac{n}{n} = 2$ we obtain

These results will be used to calculate the tunnelling contributions to the scattering term s (27,28) in the kinetic equation. Denoting the superconducting layer by n, the norm allayer by n^0 , replacing the spectral function on the norm allayer by $u^0() = 1$, and neglecting term s of order t we nd

In order to determ ine the charge-in balance on the superconducting layer in the stack we also need the quasiparticle contribution from tunnelling into the neighboring superconducting layer with the barrier in the superconducting state. As will be shown in the Appendix, this contribution vanishes if we neglect term s of order $_{\rm t}$.

D. Solution of the kinetic equation

Inserting now the di erent contributions to the scattering term from potential scattering Eq.(34) and tunnelling Eq.(40) into Eq.(27) we obtain the follow ing equation determ ining the distribution function $(\hat{k};)$ on the superconducting layer:

The rhs. of this equation describes charge in balance generation by tunnelling of quasi particles. The lhs. describes charge in balance relaxation due to impurity scattering. Taking an angular average and de ning

where $^{0}()$ is the distribution function on the normal layer, which is assumed to be in equilibrium. This sim – ple relation is only true as long as we neglect inelastic scattering, which is necessary for a relaxation of quasiparticles into the condensate.

E. Charge-im balance

Equation (43) is the main result of the paper. The function \sim () describes the charge of quasi-particles with energy on the superconducting layer. It is related to the quasi-particle potential introduced in the phenom enological theory in the following way: The quasiclassical expression for the charge density is

Relation of $(\hat{k};)$ to the "clean limit" chargeimbalance distribution function $_k$ in k-space is given in Appendix D. The relaxation rate () describes the relaxation into therm al equilibrium of the di erence between electron and hole-like quasi-particles due to im purity scattering. It replaces the relaxation rate 1 = q in Eq.(12). The r.h.s. of Eq.(43) contains the tunnelling of quasi-particle charge from the norm al electrode into the superconducting layer due to the applied voltage. It is sim ilar but not equal to the tunnelling current at the same energy . In the tunnelling current (see below) the function R () is replaced by the density-of-states function u(). In the absence of im purity scattering one nds R () = 1=u() in agreement with Ref.13.

V. CALCULATION OF THE TUNNELLING CURRENT

In order to m easure the charge-in balance induced by the quasi-particle injection we also need an expression for the current, in particular between the norm alcontact and the rst superconducting layer. Quite generally the current between neighboring layers n and n^0 in lowest order in the tunnelling matrix element can be written as

In the stationary case (constant applied voltage) we neglect the time dependence of the G reen functions on the central time and use a Fourier transform ation with respect to the time di erence as de ned above. Furtherm ore we restrict ourselves to the tunnelling between the norm allayer and the rst superconducting layer. Then only the norm al G reen functions contribute and we obtain (with $v = n_{\rm gn} = 2$) the usual expression for the quasi-particle current density

This is another important result. The current between neighboring layers n and n^0 is the sum of two parts containing the distribution functions () and () respectively. The current j (v) is the quasi-particle current driven and created by the electro-chem ical potential difference between the two layers. The current j (v) describes the di usion current driven by the charge in balance. Both current contributions depend on the density of state u() of the two layers.

For the further application to the tunnelling between a norm allelectrode and a superconducting layer it is convenient to denote by j the current ow from the norm all electrode to the superconducting layer and by V the voltage drop in this direction (i.e. v = eV). W ith u^0 () = 1, $^0 = 0$, 0 () = $_0$ () = tanh(=(kT)) for the norm all layer, and exploiting the fact that u() and () are even functions, while () is an odd function of we obtain for the current contributions:

Here we have replaced the tunnelling rate by some average $t = h(\hat{k};\hat{k}^0)$ i and have de ned the ohm ic resistance $0 = 4e^2N(0) t^{=\sim}$. Then the current driven by the nonequilibrium distribution of quasi-particles can be




FIG .2: Spectral function (tunnelling density of states) calculated for a d-wave superconductor with im purity scattering.

VI. RESULTS

For our model calculations we use a d-wave order parameter with an angular dependence of the usual form $(\hat{k}) = (T) (\hat{k})$ with $(\hat{k}) = \cos 2_k$. The tunnelling matrix element will be parametrised as $t(\hat{k};\hat{k}^0) = 1 + 2_k(\hat{k}) (\hat{k}^0)$. This simplifies the averaging procedure: the parameter 1 enters the norm al tunnelling probability while the parameter 2 determines the Josephson coupling.

A. Tunneling current and charge im balance




FIG .3: Tunnelling current $j_0 = \ _0$ [n V] as function of the applied voltage.

In Fig.2 we show well-known typical results for the spectral function (tunnelling density of states) u() at low tem peratures with a self-consistently determ ined self-energy i () for the two limiting cases of Born scattering and in the unitary limit. Note that in the unitary limit the spectral function stays nite for ! 0. This function will be needed as input for the following calculations of the tunnelling current and the charge-in balance relaxation. Fig.3 shows the corresponding normalized tunnelling current j₀ (V) = $_0$ calculated from Eq.(52) between a normal electrode and a superconducting layer as function of the voltage-drop V between the normal electrode and the superconducting layer.




FIG. 4: Relaxation rate for the charge-in balance due to in - purity scattering as function of energy.




FIG.5: Charge in balance potential generated on a superconducting layer in contact with a norm al electrode as function of the applied voltage (a) and the tunnelling current $j_0 = _0$ (b)

Now we turn to the calculation of charge in balance. In Fig.4 the frequency dependence of the relaxation function () is shown for low temperatures. The frequency dependence relaxes the available phase-space for elastic scattering processes from electron-like into hole-like quasi-particles at the energy . With help of this function we calculate from Eq.(54) the charge in balance potential

generated on a superconducting layer in contact with a norm al layer. Fig. 5a shows (V) as function of the voltage V between the norm al electrode and the superconducting layer.

As V cannot easily be measured directly, we express it by the corresponding current density. The resulting function (j) de ned by (j) = (V) with $j = j_0 (V)$ given by Eq.(52) is shown in Fig. 5b. It depends on the ratio $_{t=p}$ between the average tunnelling rate and the potential scattering rate. The nonlinear dependence on the current rejects to some extent the nonlinear current

voltage curve.

B. Experiment with two normal electrodes

Now we apply the theory to the basic experiment, where one superconducting layer is in contact with two normal electrodes. Through the st electrode with area F_1 a current I_1 is applied, which creates a charge in balance $_s$ on the superconducting layer. At a second electrode the voltage V_2 is measured with no current owing. We assume that charge in balance spreads even by over the whole superconducting layer of size F. Then the charge in balance potential created on the superconducting layer is given by $_s = (F_1 = F)$ (j_1), where $j_1 = I_1 = F_1$ is the current density through the electrode (1), with (j) dened above and shown in Fig.5b.

In order to determ ine the voltage V_2 m easured at the second electrode we use the current equations (52, 53) and exploit the condition that no current is owing, $j_2 = j_0 (V_2)_{0.5} = 0$, i.e. we have a compensation of the quasi-particle current driven by the voltage and




FIG.6: Voltage measured at the second electrode as function of the injection current through the rst electrode.

Thus we obtain V_2 as function of j_1 . Results are shown in Fig. 6 for the case of a very smalltest electrode, $F_2 = F$, $F_1 \ ' \ F$. Note that in this channel the electrochem ical potential drop is only between the normal electrode and the rst superconducting layer, all the other barriers in the stack have $_{n,n+1} = 0$. Furthermore, if the electrodes are in equilibrium, the total voltage equals the total electrochem ical potential, thus V_2 is the total measured voltage.

C. Double-m esa experim ent




FIG. 7: Position of resistive barriers in the double-mesa experiment

In this experiment which is described in detail in Ref.6 two sm allmesas are structured close to each other on top of a common basemesa and contacted with separate gold electrodes. Through the rstmesa a variable current I_1 is injected while at the second mesa the voltage V_2 is measured for xed current I_2 . Normally the voltage V_2 is independent of the current I_1 as long as all junctions in the basemesa are in the superconducting state. In some cases, how ever, a sm all additional voltage V_2 (I_1) is observed. This happens, if the lowest junctions in the two mesas are in the resistive state (see Fig.7b) and generate a charge-imbalance on the rst common superconducting layer of the basemesa, which then depends on both currents.

If we want to apply the m icroscopic theory to this situation we have to calculate the charge-in balance on a superconducting layer in contact with another superconducting layer with the barrier being in the resistive state.

Furtherm one we have to add to the tunnelling current the average Josephson current. In system s with a large M c-C um ber parameter this contribution is small. We will neglect it in the following.

In a rst approximation we may treat the junctions between the two mesas and the base mesa as if they were normal electrodes. In this case the only modi cation is the nite current through the second mesa. The charge im balance potential generated on the rst superconducting layer of the base mesa is

where $j_0(V)$ is the current-voltage function (52). The voltage shift $V_2(I_1) = V_2(I_1)$ V_2 , is the di erence between the voltage measured at the second mesa for xed current I_2 , when the last barriers in the rst and second mesa are in the resistive state (Fig.7b), and the constant voltage V_2 , when only the last barrier of the second mesa is in the resistive state (Fig.7a). Expanding $j_0(V)$ around the voltage V_2 as $j_0(V_2 + V_2) = j_0(V_2) + V_2(V_2)$ we obtain:

This approximation can be improved if we take into account that the last layers in the small mesas are in the superconducting state. Then we have to include the frequency dependent density of states $u^0()$ of these layers both in the calculation of the quasi-particle current




FIG. 8: M odi ed charge in balance potential generated on a superconducting layer by resistive junction as function of the tunnelling current.

densities and in the charge in balance function (). Let us denote the modi ed quasi-particle current by j_0 (V) and the modi ed charge-in balance potential function by $^{\sim}(j)$ (explicite form ulas are given in the Appendix), then the voltage shift V $_2$ (I $_1$) measured at the second mesa is given by

where $\sim (V) = dj_0 (V) = dV$. Its current dependence is proportional to the function $\sim (j)$, which is shown in Fig.8. The shape of the functions (j), Fig.5b and $\sim (j)$, Fig.8 is similar. The curve obtained in the weak scattering limit (solid line) also has great similarity with the experimental results.⁶ The parameters used in our calculations are typical for these materials. We did not perform a t to the experimental data, since this would require an additional parameter for the Josephson coupling. Of course all the curves end at the critical current.

D. In uence of charge-im balance on the current-voltage curves

The same form alism can be applied to calculate the inuence of charge-im balance on the current-voltage curves in a stack of Josephson junctions. For instance, for a stack of junctions with one junction in the resistive state inside the stack (not adjoining the norm alelectrodes) the current is given by

where V is the voltage drop across this barrier. The factor 2 comes from the charge-in balance potential created on the two superconducting layers adjoining the barrier in the resistive state. The corresponding voltage shift for a given current j is then

where V is the voltage for a single junction. This shift can be measured directly as di erence between the voltage of two isolated junctions in the resistive state and two neighboring resistive junctions in the stack. This generalises our results obtained with the phenom enologicaltheory⁷ using an ohm ic quasi-particle IV-curve. Note that this (very small) voltage shift in the IV-curves does not depend on the parameter a (called in Refs.7,21 describing charge uctuations of the superconducting condensate. These will be of im portance in dynam ical effects like the Josephson plasm a resonance and in optical experiments.²⁸

VII. SUMMARY

In this paper we have developed a comprehensive microscopic theory for stationary nonequilibrium e ects in intrinsic Josephson systems starting from a nonequilibrium Green function theory for layered d-wave superconductors. W e investigated the charge-im balance generated on a superconducting layer by current in jection and derived results for the charge-in balance distribution function and the nonequilibrium quasi-particle current between superconducting layers. The theory uses basic nonequilibrium concepts developed earlier for bulk superconductors and is applied here to layered dwave superconductors forming a stack of Josephson junctions. Specic for layered superconductors with small tunneling rate between the layers is the con nement of charge-in balance on single superconducting layers. Specic for d-wave superconductors with vanishing gap is the relaxtion of charge-in balance due to elastic in purity scattering, which is the dom inant relaxation mechanism at low energies. In distinction to an earlier sem iphenom enological theory by the authors we considered here the energy dependence of the charge-in balance distribution function and its relaxation, leading to nonlinear current-voltage realtions.

W e applied the theory to the calculation of nonequilibrium e ects in current injection experiments with 4 contacts. In particular, we calculated the voltage between a norm al electrode and a superconducting layer for zero current as function of the current through a second electrode. This voltage measures directly the charge in balance potential generated on the superconducting layer. W e then applied the theory to recent double-mesa experiments. Thus we were able to explain the non-linear dependence of the voltage measured at one mesa on the current through the second mesa.

The same form alism can also be applied to calculate the in uence of charge in balance on the current-voltage curves in a stack of Josephson junctions, which should be observable as di erence in the voltage between different con gurations of a given number of resistive junctions in the stack. We note that the shift of the chem ical potential of the condensate leads do a redistribution of the voltage between di erent superconducting layers, but this has no in uence on the total current-voltage curves. Charge oscillations in the condensate and the resulting coupling between the layers will how ever be in portant for dynam ic e ects like the dispersion of the longitudinal Josephson plasm a resonance and in som e optical experim ents. These dynam ic e ects will be investigated in a forthcom ing publication.

For the contribution from tunnelling to the scattering term in the kinetic equation we then nd:

Note that all the contributions depending on the phase di erence ' drop out. The remaining term s vanish if we neglect term s of order t which are of higher order in the tunnelling probability.

b) T unnelling between two superconducting layers with the barrier in the resistive state.

In this case also the anom alous G reen functions contribute to the dc current. As this contribution involves the coherent part of the tunnelling matrix element and will be sm all in the lim it of large M cC um ber param eters, we neglect it in the following. However, we have to take into account the frequency dependent density of states $u();u^{p}()$ on both superconducting layers. We want to apply the theory to calculate the charge-in balance on a superconducting layer n which is coupled on one side to a superconducting layer n⁰ in a stack with barriers in the resistive state and on the other side to a superconducting layer with the barrier in the superconducting state. A s the layer n⁰ is between two barriers in the resistive state with equal quasi-particle current we can neglect the charge-in balance 0 on this layer. Then we obtain the contribution to the scatterng term from tunnelling between n and n^0 :

APPENDIX D:CHARGE IM BALANCE OF QUASI-PARTICLES

In order to make contact with the traditional theory of charge in balance let us sum marise the basic de nitions and concepts of charge-in balance as introduced by T inkham and C larke^{10,11,31,32}.

In the BCS theory the total charge (in units of the electron charge, factor 2 from spin) is

where $u_k^2 = \frac{1}{2} (1 + {}_k = E_k), v_k^2 = (1 + {}_k = E_k) = 2$ are the usual coherence factors, ${}_k = {}_k$, $E_k = {}_k^2 + {}_k^2$ is the quasi-particle excitation energy. The rst term is the condensate charge Q^c, the second term is the quasi-particle charge Q, f_k is the quasi-particle distribution function. In equilibrium $f_k = 1 = (\exp(E_k = T) + 1)$ and hence Q vanishes (for particle-hole symmetry).

A nonequilibrium state can be described by a shift of the chem ical potential and a change of the distribution function f_k . A shift of the chem ical potential leads to a shift of the excitation energy in k-space, $_k$! $_k$ + and hence to a change of the condensate charge by:

Thus Q depends on the di erence in the num ber of electron- and hole-like quasi-particles. W hile $f_{k_{>}} = f_{k_{<}}$ describes charge-in balance, the combination $f_{k_{>}} + f_{k_{<}}$, for instance, enters the self-consistency equation for the gap ${}_{k}$.

These distribution functions are introduced here for well-de ned quasi-particles with in nite life-time. In a m icroscopic theory based on nonequilibrium G reen functions these are replaced here by the frequency-dependent distribution functions () and (). In our case we nd the following correspondence for > 0:
