# Enhancem ent of magnetic order in the incommensurate phase of M g-doped C uG eO $_{\rm 3}$

We present elastic neutron scattering results at high magnetic elds for Mg-doped  $CuGeO_3$ . For low magnesium concentrations, where a spin-Peierls phase is present, we nd an enhancement of the long range antiferrom agnetic order in the structural incommensurate phase induced by a high magnetic eld. In the incommensurate phase, the Neeltem perature increases with eld leading to a gain in the magnetic Bragg peak intensity at low temperatures. We also nd that the magnetic Bragg peaks remain commensurate even though the structure is incommensurate at high magnetic elds due to the form ation of solitons. We interpret these results in terms of the solitons form ed at high-magnetic elds e ectively acting as doped in purities. Our results point to a strongly disordered ground state with the the antiferrom agnetic order localized around in purity sites.

#### 1. Introduction

In purity doping of low-dimensional magnetic system s often results in non-intuitive ground states and critical behavior di ering from that of the pure or parent material. In this respect, doped CuGeO<sub>3</sub>, with Cu<sup>2+</sup> ions forming a one-dimensional (ID) chain network along the caxis, has generated much interest recently. CuGeO<sub>3</sub> was the rst inorganic material discovered to undergo a spin-Peierls transition.<sup>1)</sup> In the Peierls state the copper atom s form dimer pairs and a gap opens in the magnetic excitation spectrum. The spin coupling is dominantly along the chain direction [001] with  $J_c = 10.5 \text{ m eV}$ , compared to couplings of -0.1 m eV and 1.0 m eV perpendicular to the chains along the a and b directions, respectively.<sup>2)</sup> The excitations have been shown to be wellm odelled by a singlet ground state with an excited triplet state.<sup>3)</sup> D ue to the strong 1D nature of the spin interactions, it is not expected that the spins should order at low tem peratures, consistent with experimental results in the pure system .<sup>4)</sup>

O ne of the m ost unique aspects of  $C \cup G \in O_3$  is the ability to introduce in purities on di erent lattice sites in a very controlled m anner. This is a particular advantage of this inorganic system over previous organic system s where it was extremely di cult to dope in purities system atically. The introduction of a sm all amount of in purities on either the Cu or the G e site has been shown to result in a long-range antiferrom agnetic (AF) ordered state at low

tem peratures.<sup>5)</sup> R egardless of the impurity and the dopant site the overall phase diagram s are qualitatively identical as a function of doping. At low impurity dopings long-range AF order is observed to coexist with the dimerized spin-Peierls state until a critical concentration where the dimerized state is replaced with a uniform long-range magnetic ordered phase. D espite the apparent similarity between the phase diagram s of all doped impurities it has been found that non-magnetic impurities and spin-1 impurities produce slightly diment ground states with the moment pointing along the [001] direction for the nonmagnetic case and the [100] direction in the case of a spin-1 impurity.<sup>6)</sup>

The phase diagram at zero magnetic eld for Cu<sub>l x</sub> M g<sub>x</sub>GeO<sub>3</sub> has been studied in detail with both x-ray and neutron scattering techniques. In this system the doped nonmagnetic M g<sup>2+</sup> ions occupy the Cu<sup>2+</sup> sites. The critical properties of both the magnetic and structural distortions have been investigated by Nakao et al. and N ishi et al. using susceptibility and neutron di raction measurements?<sup>(8)</sup> These studies found the presence of a dimerized long-range AF ordered state at lower M g concentrations and a uniform AF phase at higher concentrations with the absence of any spin-Peierls order or dimer structure. The boundary of these phases takes place around x<sub>c</sub> 2.5 % M agnesium doping. The structural phase diagram has also been carefully studied using x-rays for a variety of in purities and concentrations.<sup>9(12)</sup> The excitation spectrum for the low temperature N eel state has also been mapped out and found to be in good agreement with theory for disordered spin-Peierls system s.<sup>13)</sup>

At high magnetic elds the dimerized phase becomes unstable to the formation of domain walls or solitons. In the pure undoped material this is a rst order transition which occurs at an applied magnetic eld of 12.5 T and is characterized by the splitting of the spin-Peierls superlattice peaks into pairs of incommensurate peaks.<sup>14,15</sup> W ith doping this rst order commensurate to incommensurate transition becomes a continuous or second order transition and has been studied in detail for M g, Zn, and N i doping using high resolution synchrotron x-ray scattering techniques.<sup>16,17</sup> Excitations above the incommensurate transition have been studied in the pure system and, in contrast to the soft modes in classical incommensurate structures, three gapped modes were clearly observed at high magnetic elds.<sup>18</sup>

In this work, we study the e ect of in purities on the high-magnetic eld incommensurate phase using single crystals of  $Cu_{1 x} M g_x GeO_3$  with x = 0.02 and 0.04. We is not that the solitons formed at high magnetic elds essentially act as in purities breaking the chains and enhancing the magnetic order. To con im this picture we have compared our results at low M g dopings (x = 0.02) in the dimerized phase to those of higher dopings (x = 0.04) where a spin-Peierls state is absent and a uniform antiferrom agnet is formed. These results point to the in purity induced AF order being localized around in purity sites.




Fig. 1. DC magnetization plotted as a function of temperature for both (a) x = 0.02 and (b) x = 0.04 samples. The applied eld is 0.1 T aligned along the c direction. The Neel and spin-Peierls transitions are labelled for the 2 % sample. The 4 % only displays N eel order.

## 2. Experim ental D etails

Single crystals of Cu<sub>1 x</sub> M g<sub>x</sub>G eO<sub>3</sub> with x = 0.02 and 0.04 were grown using the oating zone m ethod.<sup>19)</sup> Stoichiom etric concentrations of CuO, M gO, and GeO<sub>2</sub> were ground into powder, and then feed rods were prepared by annealing under O<sub>2</sub> ow at 900 C for 12 hours. The crystals were grown in an image furnace under O<sub>2</sub> ow along the a direction with a growth rate of 0.5 mm /hour. The grown crystals had a self-cleaving surface perpendicular to the growth direction. The crystals were 0.5 cc in volume and were characterized by m easurem ents of the DC m agnetization and heat capacity. D etails and discussion of the sam ple characterization are given in the next section.

N eutron scattering experiments were conducted at the E1 therm al and V2 cold neutron spectrom eters located at the BER II research reactor, HM IBerlin. An Oxford vertical cryomagnet was used to reach temperatures as low as 1.6 K and applied magnetic elds as high as  $_{0}$ H 14 T. The sample was mounted in the magnet with the cleaving face pointing down




Fig. 2. DC magnetization plotted as a function of applied magnetic eld up to 14 T. The magnetic eld is aligned along the a direction. The anomaly associated with the transition to the incom - mensurate phase is clearly visible in the 2 % sample at 9.5 T, while no anomaly is observed in the 4 % sample.

so that Q positions of the form (OK L) lay within the scattering plane. For both spectrom eters a pyrolytic graphite (002) re ection was used as a monochrom ator and analyzer. At the cold neutron instrum ent (V1) the incident neutron energy was set at  $E_i = 3.5 \text{ m eV}$  and collim ation

xed at 60'-S-60'-60' (S denotes sam ple). The therm also pectrom eter (E1) was congured with  $E_i = 13.9 \text{ meV}$  and a collimation of 40'-40'-S-40'-open. To the liter out higher order neutrons on the cold instrument a nitrogen cooled beryllium. Iter was used on the scattered side and on the thermal instrument a graphite there was used on the incident side. The lattice constants obtained at base temperature were b = 8:41 A and c = 2:95 A, corresponding to the reciprocal lattice units  $b = 0:75 \text{ A}^{-1}$  and  $c = 2:13 \text{ A}^{-1}$ .

## 3. Sam ple C haracterization

The crystals were characterized based on the transition temperatures measured by magnetization and heat capacity. DC M agnetization measurements are shown in Fig. 1 for both




Fig. 3. Cp/T plotted as a function of tem perature for both 2 % and 4 % samples at zero applied magnetic eld. The 2 % sample clearly shows both N eeland spin-P eierls transitions. The 4 % only shows a transition to N eelorder. The high tem perature dependence is discussed in the text.

sam ples and were m ade using the Q uantum D esign ACM S system .An applied m agnetic eld of  $_0H = 0.1$  T was aligned along the [001] direction. The x = 0.02 sam ple shows both a broadened but clear spin-Peierls transition at around 11 K and a N eel tem perature of 2.5 K indicating the coexistence between the two phases and presence of dimerized AF order. The x = 0.04 sam ple shows no sign of a spin-Peierls transition as only a clear N eel transition at 4.3 K is observed. The physical properties of both of these sam ples are consistent with the previously established phase diagram .<sup>20)</sup> To check the hom ogeneity of the sam ples, we have con rm ed that the m agnetization at both the top and bottom of the crystal rod, obtained from the cating zone furnace, were the sam e, indicating a very uniform M g concentration throughout the crystal. The data for these low eld m agnetization results are also consistent with previous studies using highly sensitive SQUID m agnetom eters.

From the magnetization as a function of applied eld we clearly identify the commensurateincommensurate phase transition. Figure 2 shows the DC magnetization as a function of applied eld at 1.8 K, below the N celtem perature of the 2 % sample. For these measurements, the magnetic eld was aligned along the [100] direction, the same eld con guration as used in our neutron experiments. The top panel of Fig. 2 (2 % sample) shows a clear break at 9.5 T. This transition has been shown to be associated with the commensurate to incom – mensurate transition in previous studies in Sidoped CuGeO<sub>3</sub> which shows a dimerized AF phase.<sup>22)</sup> The bottom panel of Fig. 2 shows the DC magnetization as a function of applied

eld for the 4 % sam ple with no sign of any break or transition at high magnetic elds. This behavior is consistent with a uniform AF phase where the spin-Peierls phase, and hence the com mensurate-incom mensurate transition, is absent.

Heat capacity at constant pressure, C<sub>p</sub>, was measured using the Quantum Design heat capacity option, which utilizes the relaxation technique. The results are displayed in Fig. 3 with the 2 % sample in the upper panel and the 4 % sample in the lower panel. Heat capacity is a particularly useful and important characterization technique as it can be done in zero eld. Previous magnetization results using a sensitive SQUID magnetom eter have shown that even a sm all applied magnetic eld can have a large e ect on the spin-Peierls transition<sup>1</sup>.

Figure 3 shows that the 2 % sam ple displays the presence of two transitions, the higher tem perature transition associated with the form ation of the spin-Peierls phase, and the low tem perature transition is the form ation of AF order. The spin-Peierls phase can be well understood in terms of BCS theory with a gap opening in the excitation spectrum. Therefore, the heat capacity should show a discontinuity with an exponential decay at low tem peratures. This behavior is qualitatively seen in Fig. 3 below  $T_{SP}$  13 K but due to the limited tem – perature range below the spin-Peierls transition a detailed twas not possible. Because of the presence of in purities, the spin-Peierls transition is broadened compared to the pure material.<sup>24)</sup> The lower panel of Fig. 3 shows heat capacity results for the 4 % sam ple which show s no sign of a spin-Peierls transition at high tem peratures but a clear transition, associated with the form ation of long-range AF order, is observed at low tem peratures. It is interesting to note from Fig. 3 that the 2 % sam ple has a much broader N eel transition than in the 4 % sam ple and points to a more disordered ground state in the 2 % sam ple than the 4 % sam ple. This assertion will be discussed in m ore detail in Sec.V.

The high tem perature values of  $C_p$  in both the 2 % and 4 % sam ples agree very well and with those of previous heat capacity m easurements for sam ples with similar dopants.<sup>24)</sup> W e have t the high tem perature heat capacity data to the form  $C_p = T + {}_1T^3 + {}_2T^5$ , the sam e model used by 0 sero et al. The term linear in tem perature, T, is characteristic of a 1D AF systems with  $= 2N k_B^2 = 3J \cdot {}^{25}$  The term proportional to T<sup>3</sup> is associated with the phonon contribution to the heat capacity. Fitting this equation to the high tem perature heat capacity data for the 4 % sam ple gives  $= 47m J = m o IK^2$  im plying J 10 m eV in good agreement with previous measurements of the superexchange along the [001] direction and previous heat capacity data. Based on the combination of heat capacity and magnetization




Fig. 4. Transverse scan through the magnetic Bragg peak at applied elds of 0 and 14 T along the [100] direction. The peak positions of the structural incom mensurate peaks are marked by arrows.

we have extracted the spin-Peierls transition tem perature of  $T_{SP} = 11$  K for the 2 % sample and N celtem peratures of  $T_N = 2.5$  K and 4.3 K for the 2 % and 4 % samples, respectively. These values are in good agreement with the comprehensive study of M asuda et al. indicating the good quality and hom ogeneity of the samples.<sup>26)</sup>

## 4. Neutron Scattering Results

## 4.1 Commensurate Magnetic Peak in 2 % Sample

Cold neutron di raction was perform ed to study the eld dependence of the magnetic order in the 2 % sample. The results are summarized in Fig. 4 showing the magnetic Bragg peak pro le scanned along the c direction at 1.6 K with  $_{0}$ H = 0 T and 14 T, well above the commensurate to incommensurate phase transition. One of the most striking features is the large increase in intensity at high magnetic elds. This will be discussed in more detail in the next section.

A nother surprising result illustrated in Fig. 4 is the fact that the magnetic B ragg peak remains commensurate in the high eld structural incommensurate phase. A Gaussian t to the data shows no sign of any broadening as a function of applied eld. X-ray studies of M g-doped CuGeO<sub>3</sub> have shown a large splitting of the structural superlattice B ragg peaks into incommensurate positions along the c direction indicating the formation of antiphase domains characteristic of a breaking of the dimer bonds.<sup>17)</sup> M g-doped CuGeO<sub>3</sub> with an impurity concentration of 2 % has been studied using high resolution synchrotron x-ray scattering and the position of the incommensurate structural B ragg peaks at 11 T are marked in Fig. 4. Christianson et al.<sup>16)</sup> measured the distance between the incommensurate peaks, de ned as




Fig. 5. The Bragg peak intensity plotted as a function of applied m agnetic eld for both the 2 % and 4 % samples. The enhancement of the magnetic Bragg scattering clearly occurs at the incommensurate transition at 9.5 T.

the incom m ensurability parameter , to be 0.014 rlu at 11 T. Since the spins couple antiferrom agnetically, if the m agnetic structure also form ed antiphase dom ains with the same spatial m odulation as the structure the m agnetic B ragg peak should also split with 0.007 along the same direction. It is clear from F ig. 4 that no such splitting or broadening is present in the incom m ensurate phase. This is a very surprising result as this suggests that the spatial m om ent distribution within the sam ple is not strongly coupled to the bulk structure. Further discussion of this point in the context of im purities will be presented later.

## 4.2 Enhancement of Magnetic Bragg Scattering in the Incommensurate Phase

To investigate the enhancement of the magnetic Bragg peak illustrated in Fig. 4 we have studied the intensity of the magnetic Bragg peaks as a function of applied magnetic eld for both the 2 % and 4 % sample using therm alneutrons. The essential results at low temperatures for the two dopings studied is summarized in Fig. 5. For the dimerized AF 2 % sample a suppression of the peak intensity is observed followed by a signi cantenhancement of the peak




Fig. 6. The upper panel plots the m agnetic B ragg peak intensity as a function of tem perature for both 0 and 14 T.A large increase in the N eel tem perature is observed. The low er panel plots the m agnetic B ragg peak intensity at 2.8 K as a function of eld showing that the increase in the N eel tem perature starts at around the critical eld.

intensity at the incom mensurate transition. This is contrast to the uniform AF 4% sample, displayed in Fig. 5 (b) which only shows a suppression at low elds and a relatively constant behavior at higher elds. This comparison unambiguously shows that the enhancement is associated with the high-magnetic eld incommensurate phase.

The suppression of the peak intensity at intermediate elds is clearly present for both the 2 % and 4 % samples and therefore is not unique to the dimerized antiferrom agnet. A possible origin of this suppression was suggested by G renier et al.<sup>22)</sup> based on m agnetization data. They proposed that the attenuation in B ragg intensity was due to the creation of free spins around the impurities. We observe a larger fractional suppression of the AF B ragg peak intensity for the 2 % sample than the 4 % sample. In the context of the model proposed by G renier et al. this suggests that m agnetic order is largely associated with the impurities and therefore is more delicate in the dimerized AF 2 % sample. A sim ilar model has recently been proposed by G lazkov et al. to explain ESR data taken at low m agnetic elds<sup>23)</sup>




Fig. 7. The magnetic B ragg peak intensity plotted as a function of temperature showing the N  $\approx$  1 temperature at both 0 and 14 T. There is no change in the N  $\approx$  1 temperature for the x= 0.04 sample as a function of eld.

We have determ ined the  $Cu^{2+}$  m on ent direction in both the commensurate and incommensurate phases by measuring the integrated magnetic intensities at the (0;1;0:5), (0;1;1:5) and (0;3;0:5) positions in each of the four quadrants. As noted earlier, the introduction of impurities into  $CuGeO_3$  has been found to alter the spin ground state and therefore it is important to see if the moment direction changes as a function of magnetic eld. In the commensurate phase we nd the moment direction to be along [001], consistent with our loweld DC magnetization, and we nd no change in the incommensurate phase. Therefore the enhancement cannot be accounted for by a change in the moment direction.

The top panel of Fig. 6 plots the A F peak intensity as a function of tem perature for the 2 sam ple at applied m agnetic elds of 0 T and 14 T. This illustrates that the enhanced scattering is associated with a large increase in the N eel tem perature. We have checked this result for other incident wavelengths eliminating the possibility of it resulting from a spurious process such asmultiple scattering. The low erpanel of Fig. 6 plots the peak intensity at T = 2.8 K, just above the zero eld N eel tem perature, as a function of applied m agnetic eld. There is a clear break followed by an enhancement at the incommensurate transition again showing that the enhancement of magnetic order is connected directly to the incommensurate phase transition. These results for the 2 sam ple contrast to the eld dependence of the N eel tem perature for the 4 sam ple displayed in Fig. 7 where no change in the N eel tem perature is observed at low and high magnetic elds. This comparison also demonstrates that the enhancement of the magnetic B ragg peak is associated with the commensurate transition mensurate transition.

This result is consistent with the high resolution synchrotron x-ray data of Christianson

et al. Even though x-rays are not directly sensitive to the N eel order it was noted in that experim ent that the N eel tem perature could be measured by a broadening of the superlattice structural B ragg peaks associated with the spin-Peierls phase at low tem perature. The high m agnetic eld data are suggestive of an increase in the N eel tem perature, the result we have found here.

It is also interesting to note that the low temperature Bragg peak intensity in the 2 % sample does not saturate by 1.9 K at zero eld and even at high magnetic elds where we can study temperatures several degrees below the N eel temperature. This di ers from the behavior of the 4 % sample when the peak intensity appears to saturate at low temperatures. This result m ay suggests a considerable am ount of disorder in the dimerized antiferrom agnet seen in the 2 % sample. This point will be discussed further in the next section.

#### 5. Discussion and Conclusions

The most important results of the present study are the absence of incommensurate AF order and the enhancement of the commensurate AF order in the structural incommensurate phase. In this section we discuss these features in terms of impurity elects caused by Mg doping and soliton formation by magnetic eld.

SR m easurements have been interpreted on the basis of an inhom ogeneous ordered moment distribution throughout the sample for both Zn-and Si-doped CuGeO<sub>3</sub>.<sup>27)</sup> Based on this result a model was suggested where the moment size varies strongly and is peaked around the in purity sites. Such a ground state has also been suggested based on neutron scattering results.<sup>28)</sup> In a detailed study of Zn doped CuGeO<sub>3</sub> the ordered moment was only  $0.2_{\rm B}$  at 1.4 K with no sign of saturation of the magnetic Bragg intensity. A lso, overdam ped magnetic excitations were observed around the magnetic Bragg peaks, suggesting an unusual ground state of magnetic order possibly incorporating considerable structural disorder. These facts suggest that the AF ordered moment detected in the present study mainly comes from regions around the in purity sites. Since the in purities act to break the dimer bonds at low temperatures the structure around the in purities will remain commensurate even at high magnetic

elds. Therefore, the commensurate magnetic structure in both the structurally commensurate and incommensurate phases can be understood if the static AF order is strongly pinned and localized around impurities.

This model is also supported by our low - eld data showing a suppression of the magnetic Bragg peak intensity with increasing eld. If the magnetic order is associated with local droplets with an elective spin S = 1=2 around in purities, then long-range order is formed when the droplets become highly correlated. In the presence of a magnetic eld the antiferrom agnetic correlation between each droplet will be suppressed as the spin associated with the droplet will tend to align with the magnetic eld. The properties measured here for M g doped CuGeO<sub>3</sub> bear a strong similarity to that measured in doped the Haldane material

Pb (N  $i_{1} \times M g_x V_2 O_8$ ).<sup>29)</sup> However, in that system a complete disappearance of the Neel order was observed for applied elds of only 3-5 T for x = 0.02. Therefore, in M g doped CuGeO<sub>3</sub> the antiferrom agnetic droplets around the impurity are more strongly correlated than that in the H aldane system . A possible reason for this may be the strong interchain coupling in CuGeO<sub>3</sub>.

This picture also provides an elegant explanation for the enhancement of the magnetic B ragg peaks in the structural incommensurate phase, induced by high eld. In the incommensurate phase, solitons are formed which break the dimerbonds. The solitons therefore have the analogous elect of impurities with the main dilerence being that the solitons are mobile. Since impurities drive magnetic order an enhancement of the magnetic B ragg peak occurs in the incommensurate phase by the soliton formation.

O ur dimerized AF sam ple has an in purity concentration of 2 %, as characterized by heat capacity and DC m agnetization, therefore in plying an in purity orbroken chain every 50 C u<sup>2+</sup> ions. At 11 T the incommensurate splitting, , has been measured by synchrotron x-rays to be 0.014 rlu.<sup>16)</sup> By directly applying a 1D model of antiphase domains this would in ply solitons every 1=(2) or 40 C u atom s. This means the 11 T eld creates a number of solitons which is equivalent to a 2.5% in purity doping. Therefore, at high magnetic elds, the e ective in purity concentration, a sum mation of chemical in purity and solitons, practically doubles essentially pushing the in purity concentration to 4 %. This argument is veri ed by the fact that the N eel temperature of the 2% sam ple in the 14 T eld is identical to the N eel temperature for 4 %.

The enhancem ent of AF order can be understood in terms of competing order parameters. As an example, we consider the Landau theory of K ohno et al.<sup>30)</sup> for competition between superconductivity and antiferrom agnetism order parameters. It was found that a staggered m on ent would emerge in the vicinity of the impurity site where the superconducting order parameter is suppressed. This is exactly the case in M g doped C uG eO <sub>3</sub> where the impurities are the doped M g as well as the solitons in the high m agnetic eld incommensurate phase. D ue to the generality of Landau theory the superconducting order parameter in the above theory can be replaced with that for the spin-Peierls order parameter. Thus it is straightforward to see that the impurities of M g ions and solitons suppress the spin-Peierls order and enhance the m agnetic order in this Landau theory.

O ur results m ay also be a direct test of theories involving in purity doped S = 1=2 chains. The case of in purities doped into a S = 1=2 chains has been solved using eld theory and simulated by M onte C arlo techniques by Eggert and A eck.<sup>31,32)</sup> In this work it was found that the stable xed point was an open chain and staggered m om ents would appear near the open end. This theory directly applies to the impurity doped CuGeO<sub>3</sub> where the dopants or the solitons can be the open end of the chain. For the particular case of the CuGeO<sub>3</sub> a

solution to the spin problem has been suggested by Saito and Fukuyam a.<sup>33)</sup> They found that the staggered magnetization could be written in terms a quantum phase variable (x), which is a solution of the Sine-G ordan equation, and that magnetic order would form around a dom ain wallofdim erization caused by an impurity. This theory can be directly applied to the presence of solitons and clearly illustrates the analogous elects of impurity doping and the form ation of solitons.

The two main results of this high eld experiment are the presence of a commensurate magnetic Bragg peak in both the low eld commensurate and the high eld incommensurate phases and the large enhancement of the magnetic Bragg peak in the incommensurate phase only. We have obtained these results from a comparison of a dimerized sample to that of a uniform antiferrom agnet by changing the Mg concentration. The results are consistent with solitons formed at high magnetic elds elds elds elds at in purities. These results are consistent with theories based on competing order parameters and in purity elds in S = 1=2 chains.
