Itinerant m etam agnetism induced by electronic nem atic order

It is shown that metam agnetic transition in metals can occur via the formation of electronic nem atic order. We consider a simple model where the spin-dependent Ferm i surface instability gives rise to the formation of an electronic nem atic phase upon increasing the applied Zeem an magnetic eld. This leads to two consecutive metam agnetic transitions that separate the nem atic phase from the low - eld and high - eld 'isotropic' metallic phases. Possible connection to the physics of the bilayer Ruthenate, $Sr_3Ru_2O_7$, is also discussed.

Introduction; In terms of structural properties of matter, liquid crystals of molecules have intermediate form s between the solid and liquid phases. C om m on examples of these 'soft' form s of matter include the smectic and nem atic phases that have spontaneously broken unidirectional translational and rotational sym m etries, and broken rotational symmetry, respectively [1]. It is m uch less appreciated, how ever, that strongly interacting electron systems can give rise to electronic liquid crystalphases where the electronic structure rather than the structural properties of the system is 'soft' [2]. For instance, in two-dimensional electron systems, the Wigner crystal and hom ogeneous electron liquid phases arise in the sm all and high density lim its. One can ask whether an intermediate form of electronic structure arises in this case. The discovery of quantum Hall nem atic phase in two-dim ensional electron gas (2DEG) in high Landau levels [3] clearly shows that the answer is a mative. In this system, the broken rotational symmetry of the nem atic phase is dem onstrated in a series of transport m easurements B].

W hen electrons reside in the lattice, broken translational and rotational sym m etries would correspond to the broken point group sym m etry of the underlying lattice. It has been suggested that som e of these electronic sm ectic and nem atic phases may play an important role in the physics of strongly correlated electron system s [2]. W hile one m ay try to understand these phases by following the studies of structural liquid crystals, nam ely introducing topological defects in the sm ectic and nem atic phases, it turns out that a di erent approach m ay be m ore useful in the case of electronic system s. This am ounts to studying the Ferm i surface instability of electrons upon tuning the interaction strength in a novel channel and/or other param eters of the system [4, 5].

An e ective model in this spirit that incorporates the two-body interaction between quadrupolar density of electrons has been proposed and analyzed [4, 6, 7, 8, 9]. It was shown that, in the lattice, the transition to the nematic phase as a function of chemical potential is generically rst-order §, 9]. This leads to abrupt changes in various physical properties including the Ferm i-surfacetopology change from a closed to an open Ferm i surface and H all constant [8, 9]. On the other hand, there have been several studies of extended H ubbard m odels that reveal the existence of nem atic phases in some parameter space of the m odels [5, 10, 11, 12]. The direct connection between two approaches is not known, but as will be m entioned later the e ective quadrupolar m odel seem s to be consistent with the conditions under which the nem atic phases are seen in the studies of extended H ubbard m odels.

In this paper, we consider itinerant metam agnetism arising from the form ation of a nem atic phase. Metam agnetism in metals refers to a jump in magnetization from a low magnetization state to a high magnetization state as an external magnetic eld increases. The transition is rst order and associated with a jump in the relative volume of the spin-up and spin-down Ferm i surfaces. In principle, this transition does not have to involve spontaneous breaking of the discrete rotational symmetry of the lattice. Here we show that metam agnetic transition in metals can occur due to the form ation of a nem atic phase where only the spin-up (or spin-down) Ferm i surface spontaneously breaks the discrete rotational symmetry.

We study a generalized e ective H am iltonian on the square lattice with the quadrupolar-density interaction including the spin degree of freedom. As the magnetic

eld increases, the Ferm i surface volum e of the spin-up Ferm i surface increases and when the spin-up Ferm i surface gets close to the van-H ove singularity, the nem atic distortion of the spin-up Ferm i surface occurs via a rstorder transition. This leads to the abrupt change in the spin-up Ferm i-surface topology from a closed to an open Ferm i surface while the spin-down Ferm i surface changes continuously. As emphasized in Ref [9], this is an exam ple where the so-called Lifshitz transition [13] of noninteracting system s, which involves a continuous quantum transition between two states with topologically distinct Ferm i-surface structures without breaking any lattice symmetry, is avoided in interacting system s. W hen the magnetic eld increases further, another rst-order transition occurs; the spin-up Ferm i surface changes from an open to a closed Ferm i surface. The discrete rotational symmetry is now restored in the high-

eld phase. It is shown that two consecutive rst-order transitions accom pany the jumps in the magnetization, leading to two m etam agnetic transitions. The transition turns into second order [9] at some nite temperature and the nem atic phase is bounded above by second order transition. This behavior is rem in iscent of that suggested for the unusual phase near the m etam agnetic quantum critical end point of $Sr_3Ru_2O_7$ [14, 15, 19] and we will discuss possible application of ourm odelto thism aterial.

E ective H am iltonian; The e ective H am iltonian is based on symmetry considerations such that the resulting order param eter theory has the correct symmetries. In the case of classical liquid crystals, the directions parallel and anti-parallel to the rod-like m olecule do not make di erence. As such, the nem atic order param eter can be represented as a quadrupolar (second order sym metric traceless) tensor built from the spatial directions. In two-dimensions, it changes sign under a rotation by =2 and is invariant under a rotation by . In similar spirit, one can construct a quadrupolar order param eter for electronic system s using the momentum operators of electrons, i.e., $\hat{Q}_{ij} = \hat{p}_i \hat{p}_j - \frac{1}{2} \hat{p}^2_{ij}$. The attractive interaction between quadrupolar densities will lead to the alignm ent or anti-alignm ent of electronic m om enta (they are equivalent just like the case of classical liquid crystals), namely the form ation of the nem atic order.

The simplest generalization of this idea to the electrons with spins on the square lattice leads to the following e ective Ham iltonian. We also introduce the external magnetic eld, H_{ext} , so that the e ective Ham iltonian only has the Ising degree of freedom in the spin space.

where $h = {}_{B} H_{ext}$ and ${}_{B}$ is the Bohrm agneton. Here ${}_{k}$ is the single particle dispersion and is the chemical potential. On the square lattice, ${}_{k} = 2t(\cos k_{x} + \cos k_{y})$. A s discussed in Ref. [9], the inclusion of the next-nearest hopping does not change the qualitative picture, so we will not include this term for simplicity. \hat{Q} (q) is the lattice analog of the quadrupolar density tensor [4] constructed from the momentum operators and has the following form in the square lattice.

Here the interaction, $F_2(q)$, can be any arbitrary short-ranged interaction such that $F_2(q)$! $F_2 < 0$ in the $q ! 0 \lim it$.

Some remarks on this model are in order. In the studies of extended Hubbard models, it was found that the nematic order (or Pomeranchuk instability) arises when there exist attractive (repulsive) interaction between electrons in the same (di erent) patches via forward scattering [5, 9]. This is consistent with our effective Ham iltonian where the form factor of the interaction, $F_2(\cos k_x \ \cos k_y)(\cos k_x^0 \ \cos k_y^0)$ provides an attractive interaction between electrons from the same region near (;0), and a repulsive interaction between an electron near (;0) and another near (0;). Thus it appears that our electrive Ham iltonian may be related to the low energy lim it of extended Hubbard models in some param eter regim e.

M ean Field Theory; It is su cient to concentrate on the q! 0 lim it of the interaction by letting $F_2(q)$!

 $F_{2,q;0}$ with $F_2 > 0$. In order to obtain mean eld theory, the quartic interaction is decoupled via the following order parameters.

The e ective single particle dispersion for each spin degree of freedom now becomes

W hen a non-zero solution for and^{0} exists, the spin-

Ferm i surface will spontaneously break the discrete rotational sym metry of the lattice. It turns out that ⁰ is always zero in our simple model so that the deform ation of the Ferm i surface occurs along the sym metric axes of the underlying lattice. Thus we will set ⁰ = 0 from now on.

The grand canonical free energy density in the mean eld theory, F (;h; "; $_{\#}$) = F $_{\#}$ + F $_{\#}$, is given by

where D () is the density of states of the renorm alized single particle dispersion relation for each spin degree of freedom and has the following functional form.

where K (x) is the elliptic integral of the rst kind and N₀ = 1=(2²t). Note the persistence of the logarithm ic van H ove singularities at $(=2)^2 = = 2^2$ that are rem nants of the van H ove singularity of non-interacting system s.

T his leads to non-analytic behavior of the free energy at $(=2)^2 = = \frac{2}{\pi}$ or $(=\pm 2)^2 = = \frac{2}{\pi}$.

As the external magnetic eld increases, " ($_{\pm}$) increases (decreases) and when the spin-up Fermi surface gets close to the rst Brillouin zone boundary, the non-analytic behavior of F. near the van Hove lling, ($_{=}2$)² = $_{=}^{2}$, leads to the rst order transition to the nem atic phase or the abrupt deform ation of the spin-up Ferm i surface. Here the spin-down Ferm i surface is far away from the van Hove lling so that the spin-down Ferm i surface only changes gradually.

N em atic O rder and M agnetization; At the zero tem perature, the free energy, $F = F_* + F_{\#}$ can be further simpli ed when ; =2 < 2t and F for each spin degree of freedom has the following form [9].

where all energy scales are in units of 2t for sim plicity and -independent term s are dropped.

The free energy is investigated as a function of the applied magnetic eld, h, for a given chem ical potential . W e start with a closed Ferm isurface. A sthem agnetic

eld, h, increases, the spin-up (spin-down) Ferm i surface volum e increases (decreases). For small magnetic elds, there is no spontaneous breaking of the lattice sym m etry in the Ferm i surfaces. W hen h reaches the value that makes the spin-up Ferm i surface gets close to the van H ove singularity, the nem atic order parameter for the spin-up electrons jumps to a nite value, " \notin 0. This represents a rst order transition from a closed to an open spin-up Ferm i surface. As h further increases, another

rst order transition occurs such that " abruptly jumps down to zero and the lattice symmetry is restored. To summarize, a nematic phase exists in $h_1 < h < h_2$ and is bounded by two rst order transitions from (to) the low (high) eld 'isotropic' phases.




FIG.1: The nem atic order parameter, ", as a function of Zeem an magnetic eld, h, for $F_2N_0 = 0.1$ and = 0.16 in unit of 2t at T = 0




FIG.2: The magnetization, M, as a function of Zeem an magnetic eld for $F_2N_0 = 0.1$ and = 0.16. Two sharp m etam – agnetic transitions are due to the phase transitions between the 'isotropic', (a) and (c), phases and the nem atic state, (b). The inset shows the up-spin and down-spin Ferm i surfaces in the nem atic and 'isotropic' phases. Note that the down-spin Ferm isurface volum e gradually decreases as the Zeem an magnetic eld increases, while the up-spin Ferm i surface changes abruptly at the nem atic-'isotropic' transitions.

The behavior of the nem atic order parameter for the spin-up Ferm i surface as a function of h is shown in Fig.1. Here we choose =(2t) = 0.16 and $F_2N_0 = 0.1$. Notice the order parameter jumps to a nite value at $h_1 = 0.0428$ and jumps down to zero at $h_{\hat{p}} = 0.277$. The behavior of the magnetization, $M = B_k (nc_k^Y \cdot c_k \cdot i)$ $nc_{k\#}^Y \cdot c_k \cdot i)$, as a function of magnetic eld is shown in Fig.2. Note that the magnetization jumps up at h_1 and h_2 . Thus there exist two consecutive metam agnetic transitions. The corresponding Ferm i surfaces in three di erent regions are shown in the inset in Fig.2. In principle, the nem atic phase in $h_1 < h < h_2$ will exhibit an isotropic transport properties. In real system s, how ever, there will be dom ains with two possible orientations of the open Ferm i surface for spin-up electrons.

Possible Applications to Experiments; Metam-

agnetism occurs quite often in complex materials, but recent experiments on the bilayer nuthenate, $Sr_3Ru_2O_7$, seem to provide rather unique opportunity to look at the interplay between quantum uctuations and metam agnetism [14, 15]. Early experiments on $Sr_3Ru_2O_7$ suggest that the metam agnetic critical end-point can be pushed down to zero temperature by changing the direction of the magnetic eld [4, 15]. In this case, one expects that the uctuations near the critical end point is inherently quantum mechanical [16, 17]. Indeed many signatures of quantum critical behavior are seen at nite temperatures near the putative m etam agnetic quantum critical end point [14, 15].

M ore recent experiments [18] on much cleaner samples, how ever, show that the system avoids the zero temperature quantum critical end point when the angle of the magnetic eld gets very close to the 'critical' value. Instead of sustaining large quantum uctuations, the system undergoes two consecutive rst order transitions and the magnetization jumps at each transition [18]. It has been recently suggested [19] that a magnetic eld can tune an itinerant system so that the majority-spin Ferm i surface lies close to a van H ove point which may lead to a spin-dependent P om eranchuk instability [20] which is destroyed by further application of the magnetic eld.

At the phenom enological level, our simple model gives rise to a similar behavior. In the experiment, h_1 and h_2 are quite close while our mean eld theory gives a relatively wide region of the nem atic phase. However, the window of the nem atic phase decreases as the value of F_2N_0 decreases. This quantitative feature can also change if one considers a di erent band structure or introducing an explicit interaction between spin-up and spindown electrons. On the other hand, we need an attractive quadrupolar density interaction to get the nem atic phase in a range of magnetic elds while the origin of this interaction in real system is not clear. Thus it is not easy to make a direct connection between ourm odel and the experimental results on $Sr_3Ru_2O_7$. One can imagine, how ever, that when the metam agnetic uctuations becom every large, the Ferm isurfaces get soft [14] and the dom inant term in the low energy e ective Ham iltonian m ight look like what we have studied.

Sum m ary and D iscussion; In this paper, we consider a magnetic-eld-tuned transition at zero temperature between an 'isotropic' (up to the discrete rotational symmetry of the lattice) and a nematic phase where the spin-up (or spin-down) Ferm i surface spontaneously breaks the rotational symmetry of the lattice. Such a transition on the lattice is generically rst order and naturally gives rise to metam agnetism with the jump in the magnetization across the 'isotropic'-nematic transition. The rst order transition turns into second order at som e nite temperature so that the nematic phase is bounded

above by second order transition [9].

M ore speci cally, we consider a simple model of a quadrupolar density interaction between electrons in Zeem an magnetic eld. As the magnetic eld increases, the Ferm i surface volume of the spin-up (spin-down) electrons increases (decreases). W hen the spin-up Ferm i surface gets close to the van Hove lling, a rst order transition to a nem atic phase occurs. In the nem atic phase, the spin-up Ferm i surface spontaneously breaks the rotational symmetry of the lattice and becomes an open Ferm i surface. As the magnetic eld increases further, another rst order transition happens. In the high eld phase, the lattice sym metry is restored and the spin-up Ferm i surface becomes closed again. It is shown that the magnetization jumps at each transition between nematic and isotropic phase. Note that, in this case, the occurrence of the nematic order is the source of the metamagnetism.

In order to obtain these results, we assumed an attractive interaction between the quadrupolar densities of electrons. How this interaction can be generated in a more m icroscopic model is an interesting question and a subject of future study.
