D isorder in D iluted Spin System s

The in uence of substitutional disorder on the magnetic properties of diluted Heisenberg spin systems is studied with regard to the magnetic stability of ferrom agnetic diluted sem iconductors (DMS). The equation of motion for the magnon Green's function within Tyablikov approximation is solved numerically for nite systems. The resulting spectral density is then used to estimate the magnetization and Curie temperature of an in nite system. This method is suitable for any form of a ferrom agnetic exchange interaction. Besides di erent lattices and spin magnitude S, exchange interactions of di erent range are exam ined. The results show that, for short-range interaction, no magnetic order exists below the critical percolation concentration, whereas a linear dependence of the C urie tem perature on the concentration of spins is found for ferrom agnetic long-range interaction.

I. IN TRODUCTION

The discovery of ferrom agnetism in (III,M n)-V diluted magnetic sem iconductors 14 (DMS) has attracted considerable attention among scientists during the past years $^{5\{10\}}$ The great interest in these materials is motivated by the idea of using their spin degrees of freedom in conjunction with their electronic degrees to build new electronic devices ranging from fast nonvolatile memories to quantum computers (spintronics) $^{11\{17\}}$ How ever, progress has been in peded by the fact that most of the DMS studied so far have a Curie temperature $T_{\rm C}$ below room temperature 3,4,7,18,19 .

For the developm ent of ferrom agnetic DMS with desired properties such as high Curie temperatures, the theoretical understanding of the magnetism in these materials plays an important role. In DMS, a small fraction of the non-magnetic host-sem iconductor ions is substituted by ions, which carry a localized magnetic moment (spins). These magnetic ions are mainly random ly distributed over the lattice sites of one of the host-sem iconductor species. This positional disorder breaks the translational symmetry of the crystal and thus greatly com plicates the theoretical description of the material.

One of the substitutional disorder present in diluted spin system swas B rout in the late 1950s.²⁰ Since then, various attempts have been made to tackle the problem of including the disorder into the theoretical description of ferrom agnetism in diluted spin systems. Many approaches^{21{37} combine mean-eld or spin-wave theories with con gurational-averagem ethods, which not only rely on uncontrolled approxim ations with respect to the disorder, but also encounter di culties when applied to spin system s^{38} . Som e use M onte-C arlo sim ulations^{39{47}, which make the sim pli cation of classicalspins instead of quantum spins. O ther approaches are based on percolation theory $^{48\,\{50}$ or replica m ethods 51,52 , but these treat the magnetism itself only on a mean-eld level. However, one must properly take into account the positional disorder of the spins and their quantum nature to obtain reliable predictions about the magnetic properties of diluted spin system $\rm s.^{40,41,53,54}$

In this article, we will present an approach, which is based on the Tyablikov approximation⁵⁵ to the Heisenberg model and uses num erical studies of nite systems to estim ate spontaneous m agnetizations and Curie tem peratures of the corresponding systems in the therm odynam ic lim it. It should be mentioned here that the idea of using num erical studies of nite spin systems in spin-wave-type approximation is not new .^{56{58} A coording to our know ledge, how ever, the obtained spectral densities have never been used before to calculate spontaneous magnetization and Curie temperatures. The presented approach is suitable for any form of ferrom agnetic exchange interaction. W ithin this approach, we are able to treat the quantum uctuations of the spins within random -phase approximation. It means that our approach goes beyond the classical-spin approxim ation and the mean-eld theory, which notoriously overestim ates ferrom agnetic stability. Furtherm ore, we are able to treat the positional disorder of the spins num erically exact in contrast to approaches employing con gurationalaverage m ethods.

This article is organized as follows: In section II, we will generalize the Tyablikov approximation to spin systems without translational symmetry. Section III is concerned with the numerical studies we performed on the basis of the generalized Tyablikov approximation. In subsection IIIA, we will explain the algorithm we used for our numerical studies. In the following subsections, we will discuss the results we obtained for systems with ferrom agnetic short-range, ferrom agnetic long-range and oscillating long-range exchange interactions. In section IV, we will conclude the article with a summary and proposals for future work.

II. THE MODEL

To study the magnetic properties of a material with a concentration c 2 [0;1] of atom s carrying a localized

m agnetic m om ent, we consider a lattice with a fraction c of the lattice sites occupied by a spin. W e assume the dynam ics of these spins to be described by the isotropic H eisenberg H am iltonian

Here, i and j label the occupied lattice sites and $S_i = (S_i^x; S_i^y; S_i^z)$ is the spin operator of the localized m agnetic m om ent at lattice site i with lattice vector R_i . The spins { whose total number is denoted by N { interact via a H eisenberg exchange coupling with exchange parameters J_{ij} obeying $J_{ij} = J(\Re_i \quad R_j)$ and $J_{ii} = 0$. In addition, the H am iltonian contains a Zeem an coupling of the spins to a hom ogeneous external magnetic eld B = (0;0;B).

The Tyablikov approxim ation⁵⁵ has been developed for and very successfully applied to concentrated spin systems with translational symmetry. In the following, we will generalize the Tyablikov approximation to derive expressions for the magnetization and the Curie temperature for diluted spin systems, where we can not presuppose translational symmetry. Thereby, we will keep the form of the appearing expressions as close as possible to those known from the usual Tyablikov approximation. How ever, the absence of translational symmetry com plicates the evaluation of the derived expressions, as will be seen later.

W e will rst consider spins with S = 1=2. In this case, the magnetic properties of the system can be studied by use of the retarded magnon G reen's function

containing the step operators $S_i = S_i^x \quad iS_i^y$. The equation of motion for G_{ij} (E) reads

Making the Tyablikov approximation, which consists in decoupling the higher Green's function on the rhs. of (3), and assuming a uniform magnetization hS_{ii} (0;0; hS^{2} i), one obtains after rearrangement:

In the follow ing, it is convenient to interpret this equation as a m atrix equation:

Here, the Hamilton matrix H, which is dened by its matrix elements H_{ij} = $\prod_{ij}^{N} \prod_{n=1}^{N} J_{in}$ J_{ij}, has been introduced.

In order to solve equation (5) for G , one has to diagonalize H . In the concentrated case, this can be done by a Fourier transform ation because of the translational sym – m etry of the system . For a diluted system , translational sym m etry is absent, and hence, no generalm ethod exists for this task. However, for a nite system the H am ilton m atrix can be diagonalized num erically. Since H is H erm itian, this diagonalization yields N real eigenvalues E $_{\rm r}$ with eigenvectors, which can be chosen to form an orthonorm al basis. For notational convenience, we will use indices r and r⁰ to refer to m atrix elem ents in this 'H -diagonal' basis, whereas we retain i and j to refer to m atrix elem ents in the 'site-diagonal' basis, where m atrix indices are identi ed with site labels.

A fler going to the ${\rm H}$ -diagonal basis, one obtains for the magnon G reen's function:

From this expression, one can read o the magnon spectral density $S_{rr^0} (E) = (G_{rr^0} (E)) = :$

Thus, the energies $E_r = g_{J-B} B = 2 \sim hS^z i E_r$ are the excitation energies of the elementary excitations of the system s, which we call m agnons.

To obtain the local magnon spectral density $S_{\rm ii}$ (E), one has to transform $S_{\rm rr^0}$ (E) back to the site-diagonal basis. However, this may yield di erent $S_{\rm ii}$ (E) for different lattice sites i. This contradicts the assumption of a uniform magnetization, since $S_{\rm ii}$ (E) and $hS_{\rm i}^{\rm z}$ i are connected by the spectral theorem :

where = $1=k_B T$ with k_B as the Boltzm ann constant and T as the tem perature. One can circum vent the problem by abandoning the simpli cation of a uniform magnetization at the cost of having to solve a system of N non-algebraic equations in an iterative procedure, where one has to diagonalize an N N matrix similar to H in each step. Here, a numerically less demanding approach is taken, which we believe to capture the important physics of the system : W e consider hS^z i an approximation for hS^z_i i and use the site-averaged spectral density

A fier inserting (9) and doing som e rearrangements, this yields:

From this equation, one obtains an expression for the Curie temperature by linearization with respect to $hS^{z}i^{59}$:

Note that for translationally invariant systems, the indices r can be identied with the wave vectors of the rst Brillouin zone, and thus the expressions (12) and (13) reduce to the standard Tyablikov form ulae for concentrated spin systems.

For general S-values, an analogous derivation using a set of G reen's functions 60 instead of the G reen's function (2) alone leads to the implicit equation

for the magnetization. Here, the average magnon number

has been used as a convenient abbreviation. The Curie temperature is then given by

for general S-values.

In the following we will only consider systems in an in nitesim alexternal magnetic eld $B = 0^+$ just to break rotational invariance and therefore, usually drop terms including the B - eld explicitly.

III. NUMERICAL STUDIES OF FINITE SYSTEMS

A. A lgorithm

The equations (12) to (16) are of no practical use for the calculations of the magnetic properties of the system unless one can compute the eigenvalues E_r of the Ham ilton matrix H. As already mentioned above, the Fourier transformation, which is the weapon of choice for concentrated spin systems, does not work for diluted systems, because translational symmetry is absent. How – ever, for a nite system, we can diagonalize the Ham ilton matrix numerically to obtain its eigenvalues. Compared to con gurational average methods, the numerical diagonalization has the advantage that no approximations with respect to the disorder are needed. Furtherm ore, the spins can be treated quantum mechanically and the sim pli cation to classical spins as in usual M onte C arlo sim ulations is not necessary.

The algorithm we used in our numerical studies of nite system s is as follows: First of all, the system parametersmust be xed. These are the concentration c of spins on the lattice, the exchange parameter J (R) as a function of the distance R between two spins and the size and geometry of the system. The next step is to decide by the help of a pseudo-random -number generator which lattice sites of the system are occupied by a spin. Now that the positions of all occupied lattice sites in the system are known, the exchange parameters $J_{ij} = J$ ($\Re_i \quad R_{ij}$) between occupied lattice sites i and j can be calculated, and hence, the matrix elements H_{ij}. Now, the matrix H can be diagonalized numerically using standard diagonalization routines for large matrices.

For the shape of the sinulated samples, we chose a cuboid lattice section, which we closed to a torus to eliminate surface e ects. To avoid multiple- and self-interaction due to the periodic boundary conditions, we cut o any long-range interaction at a distance half the system size. We chose the size of the samples such that for each concentration we obtained approximately the maximal number of spins in the system that we could handle (ca. 14000 spins on an AM D A thlon PC, 2G H z CPU, 1 GB RAM). For simplicity, we only considered the case that each lattice site is occupied by a spin with probability c independent of the occupation of neighboring sites. However, if one is interested in clustering effects, a di erent routine to distribute the spins on the lattice could be used.

To decrease statistical errors, we averaged the eigenvalue distribution, i.e. S_{ii} (E), over several simulated system s with equal system parameters, but di erent pseudo-random distribution of the spins. Test calculations showed that this averaging seems hardly necessary for the large sam ples we used, which is due to the self-averaging property of the site-averaged localm agnon spectral density S_{ii} (E)³⁸. As a trick to smoothen the eigenvalue spectra, we sometimes used slightly di er-

ent sam ple geom etries for di erent simulation runs and weighted the obtained eigenvalue distributions with their num ber of lattice sites⁵⁷. Further weighting was not necessary, since for a xed system size the probability of generating a certain distribution of spins with the used algorithm coincides with the statistical weight of this distribution among those having an equal num ber of lattice sites.⁶⁴

The disadvantage of the num erical diagonalization is that only nite systems can be treated, but there is no spontaneous magnetization in the isotropic Heisenberg model for any nite system .^{65,66} The Tyablikov approxim ation preserves this property, which is seen in our calculations by the fact that, due to its structure, H has at least one zero-eigenvalue, which has a nite spectralweight for nite systems. More precisely, the num ber N zeros of zero-eigenvalues of H equals the number N clusters of clusters of spins connected by a non-zero exchange interaction for systems with only ferrom agnetic N_{clusters} for system s containinteraction and N_{zeros} ing antiferrom agnetic interaction.⁶⁷ Hence, (12) and (13) always yield zero for the spontaneous magnetization and the Curie tem perature, if the com puted eigenvalues of the simulated samples are used directly as input. In order to obtain a nite spontaneous magnetization and Curie tem perature, one has to go to in nite system s. However, the eigenvalue distribution of a su ciently large nite system represents a good approximation to the eigenvalue distribution of the corresponding in nite system except for energies close to zero, where the discreteness of the eigenvalue spectrum of the nite system com es into play. W e solved this problem by shifting the zero-eigenvalues of H slightly to higher energies, which will be explained in m ore detail in the following subsection.

B. Short-R ange Interaction

As rst application we investigate system s of spins on a simple cubic (sc) lattice with nearest-neighbor interaction only:

H ere, a denotes the nearest neighbor distance and $J^{\, U}$ the nearest neighbor interaction strength.

In gure 1, we plotted the spectral density for di erent concentrations c of spins. The spectral density is zero for all E < 0 for all concentrations, which is due to the fact that H is positive sem ide nite for system s with purely ferrom agnetic interactions. The calculations for the concentrated system show the well-known sym m etric shape of a sim ple cubic density of states. D ilution increases the spectral density for low er energies at the cost of the spectral density at higher energies. For concentration above c 0.5, the spectral density stays


sm ooth, whereas for lower concentrations, peaks at certain energies (E =2~hS^ziJ⁰ = 0;1;2;2 2;:::) become apparent, which constitute the whole spectral density for c< 0.3. The sm ooth part of the spectral density can be attributed to one large percolating cluster of spins, which has a quasi-continuous spectrum. This percolating cluster only exists above the critical percolation concentration c_p , which is c_p^{SC} 0.3 for the sin ple cubic lattice with nearest-neighbor interaction.^{68,69} The peaks stem from sm aller clusters, which contain a considerable fraction of the spins only for concentrations around and below c_p and which have a discrete spectrum.

To obtain non-zero Curie temperatures from the obtained H -eigenvalues of nite systems, we used a small energy to shift the eigenvalues close to zero slightly to higher energies. To be more speci c, we used

for practical reasons. The e ect of this shift on the Curie temperature T_c is illustrated in gure 2. Let us rst discuss the curves for c = 1, where the num erically obtained data for nite systems can be compared with the analytical results for the in nite system . For N = 1, the Curie temperature has a nite value at = 0 and is quite insensitive to small shifts J⁰. For large enough but nite N, the calculated C urie tem perature rapidly rises from $T_c = 0$ at = 0 to a value comparable to the in nite system at $J^{=}N$. In this steep region, $T_{\rm C}$ () is dominated by the shifted zeroeigenvalue, which has a spectral weight $w_{zeros} = N^{-1}$, and T_{c} () $\frac{2}{3} \sim^{2} S (S + 1) N$. For $J^0 = N$, how ever, the shifted zero-eigenvalue becom es less in portant, and



the curves of the nite system and the in nite system are alm ost identical. Hence, the Curie temperature for the nite system with c = 1, large N and $J^0 = N$ J^0 approximates the Curie temperature for the in nite system with c = 1 very well. Furthermore, for large N and $J^0 = N$ J^0 , the results are quite insensitive to the actual choice of .

For c < 1, the situation is more complicated. Firstly, there are no exact analytical results for T_C we could com pare our num erical results with. Furtherm ore, for an exchange interaction with nite range, there is always a nite fraction of spins in smaller clusters. Hence, always a nite fraction w_{zeros} = N_{zeros}=N of eigenvalues is zero. Therefore, T_C () maintains a nite slope / w_{zeros} w_{zeros}J⁰ even for very large N as is seen in for gure2(b). This problem could be avoided if only the percolating cluster, which is the only cluster that can support long-range order in the system, were considered in the calculation of T_c. How ever, identifying and rem oving all the eigenvalues due to sm aller clusters is num erically quite dem anding. M oreover, for concentrations well above the critical percolation concentration, the number of sm aller clusters is very sm all 68 and thus w_{zeros} 1. Hence, the behavior of $T_{\rm C}$ () is dom instead by the eigenvalues of the percolating cluster for $w_{zeros}J^0$ and J $c > c_p$ and is not very sensitive to changes in for as seen in gure 2 (b).

For c. c. most or all eigenvalues are due to sm aller clusters and therefore, the applicability of the presented m ethod m ay be questioned. However, since a large frac- $\frac{2}{3}$ ~²S (S + 1) , tion of the eigenvalues is zero, $T_{\rm C}$ () which simply means that T_{C} 0 for small . This agrees with percolation theory⁶⁸ , from which follows that $T_{C} = 0$ for $c < c_{P}$, since there can not exist any longrange ordering in the system . Therefore, we believe that the Curie tem perature calculated using the eigenvalues of a large nite system and a shift chosen such that J⁰=N J^0 gives a good estimate for the Curie temperature of the corresponding in nite system for nite dilution, too. In the following, all given values for the Curie tem perature and spontaneous magnetization refer to $= 0.01 J^0$, which corresponds for system s with 14000 to a Curie temperature $T_{\!C}$ () just outside the steep region at small $\,$.

The Curie temperature $T_{\rm C}$ we calculated for various concentrations is shown in gure 3. Below c = 0:3, the Curie temperature is practically zero in accordance with percolation theory. Above c = 0:3, the Curie temperature increases with increasing concentration and reaches its maximum value $k_{\rm B}\,T_{\rm C}$ = 2:61S (S + 1) $^{2}\rm J^{0}$ at c = 1 in good agreement with the analytical result of $k_{\rm B}\,T_{\rm C}$ = 2:64S (S + 1) $^{2}\rm J^{0}$.

The question of the e ect of the substitutional disorder at nite dilution on the Curie temperature is connected to the question, how one de nest he ordered system for nite dilution. Placing the remaining spins of the diluted system on an articial lattice with an appropriate lattice constant to regain translational invariance




FIG.2: Curie temperature T_c as function of the energy shift used for the low-lying eigenvalues of H for dierent number N of spins in the system for (a) c = 1 and (b) c = 0.7




FIG .3: Curie tem perature $T_{\rm C}$ as function of the concentration c for nearest-neighbor interaction on an sc lattice

would give a Curie temperature merely depending on how one alters the nearest-neighbor exchange interaction strength with increasing lattice constant. The virtual-crystal approximation, which is widely used to incorporate dilution e ects because of its simplicity, would give T_C (c) = cT_C (1), which is certainly wrong for low c in the case of an exchange interaction with nite range.

The reduced magnetization as a function of tempera-




FIG. 4: Reduced m agnetization $hS^{z}i=hS^{z}i$ (T = 0) as function of reduced temperature $T=T_{C}$ for nearest-neighbor interaction on an sc lattice for various concentrations c for (a) S = 1=2 and (b) S = 5=2

ture is shown in gure 4 for several concentrations. For lower concentrations, the magnetization curves show a more linear decrease with temperature. This e ect is less pronounced for higher spins. Any anom alous curvature can not be found.

C. Ferrom agnetic Long-R ange Interaction

The experimental fact of C unie temperatures of more than 100 K in DMS such as $Ga_{1-x}Mn_xAs$ with concentrations as low as 0.05 of magnetic atom $s^{1,70,71}$ implies that the exchange interaction between the localized moments is not only quite strong, but must be very long-ranged in these materials. To study the in uence of the range of a ferror agnetic exchange interaction on the stability of the ferror agnetic phase with respect to dilution we choose

Here, n is the number of the outerm ost shell with nonzero exchange interaction (or the outerm ost shell that is taken into account for the spin-spin interaction in the calculations), a is again the nearest-neighbor distance and J^0 the nearest-neighbor interaction strength. For n=1, we recover the case of pure nearest-neighbor interaction, which we discussed in the last subsection. For $n\ !\ 1$, we have a long-range interaction with algebraic fall-o . In this case, there is always only one cluster even for - nite dilution, and we do not encounter com plications due to sm aller clusters in the calculation of the Curie tem – perature.

In gure 5, we plotted the Curie temperature T_c as function of the concentration c for di erent ranges n of the exchange interaction. We perform ed calculations for the sc and fcc lattice structure, but no qualitative di erences could be found between them . As expected, a decreasing value of the threshold concentration, above one nds a nite Curie tem perature, is found with increasing range n of the interaction. M oreover, the observed values of the threshold concentration agree quite well with the corresponding critical percolation concentration, which is a lattice-structure- and interaction-rangedependent quantity.68,69,72 Furtherm ore, the results show that the exchange interaction must have a range beyond the fourth shell to obtain a nite Curie tem perature for concentration values of c 0:05, which are typical of the recently studied DMS.This is consistent with the values n 5 for the fcc and n 6 for the sc lattice obtained by the form ula



with $f_{geom}^{sc} = 2.4$ and $f_{geom}^{fcc} = 2.4 = \frac{p}{2}$, which is based on percolation arguments.⁴⁸

For n = 1, the Curie tem perature is essentially linear in the concentration for both lattice structures. Hence, a sm all, but nite value is found for the Curie tem perature even for very low concentrations. Thus, it seems that the applicability of the virtual-crystal approximation is restored in the limit n ! 1 . However, calculation for other form s of ferrom agnetic long-range exchange interactions show that the perfect linear dependence $T_{\rm c}$ / c is a peculiarity of the exchange interaction (19), although the proportionality seems to be roughly ful led for all ferrom agnetic long-range exchange interactions. Note that placing the remaining spins of the diluted system on an arti cial lattice with an appropriate lattice constant a (c) $/ c^{1=3}$ and changing the exchange parameter according to eq. (19) gives a Curie tem perature T_c / $c^{4=3}$ in contrast to the observed T_c / c.

W e also calculated m agnetization curves for di erent concentrations and exchange-interaction ranges for the sc and fcc lattice structure. However, since any unusual features of the m agnetization curves have not been observed, we will refrain from an extensive discussion of these.

D. O scillating Long-R ange Interaction

It is believed that the ferrom agnetism in DMS is carrier-induced, with holes in the valence band of the host sem iconductor mediating the interaction between the localized moments of the impurity atom s. One feature of such an indirect exchange mechanism is that it may give rise to a long-ranged e ective exchange interaction J (R) which is non-monotonous as function of the spin-spin distance R and even may be ferrom agnetic for some, but antiferrom agnetic for other values of R. To study such an oscillatory exchange interaction, we choose

In gure 6, we plotted the site-averaged local m agnon spectral density $S_{ii}(E)$ for di erent concentrations. A l-though the exchange interaction (21) contains antiferrom agnetic interactions, the concentrated spin system has a saturated ferrom agnetic ground state and a low - tem perature ferrom agnetic phase with a Curie tem perature of $k_B T_C$ 1:6- $^2 J^0$. However, as soon as the concentration is decreased from c = 1, the spectral density becom es non-vanishing for E < 0. Thise ect is stillsm all

for high concentrations, and one could try to use the computed eigenvalues to calculate C urie tem peratures by using a small shift of the low est eigenvalues, but already at interm ediate concentrations the negative H -eigenvalues substantially contribute to $S_{\rm ii}$ and certainly can not be ignored any m ore. This means that we can not compute any spontaneous magnetization or nite C urie tem perature for such system s with our method.

The results observed for the exchange interaction (21) can be generalized. Eigenvalues $E_{r} < 0$ of the H am ilton matrix H occur for all system swith c < 1 and antiferrom agnetic components in the exchange interaction. These negative eigenvalues stem from the fact that at nite dilution there are always some spins in the system which predom inantly couple antiferrom agnetically to the other spins of the system . As a result, the saturated ferrom agnetic state is not the ground state of the diluted system and hence, is therm odynam ically unstable against creation of magnons. However, the Tyablikov approxim ation with the assumption of a uniform magnetization is a reasonable approximation to the Heisenberg model only for a saturated ferrom agnetic ground state, and therefore, the presented m ethod fails for oscillatory exchange interactions. Note that these considerations rule out a highly oscillating exchange interaction for materials which are ferrom agnetic despite a low concentration of m agnetic atom s. Form aterials with highly oscillating exchange interaction, one rather expects a spin-glass-like phase at low concentrations instead of a ferrom agnetic one.⁵²

IV. SUMMARY

The aim of this article was to study the magnetic properties of diluted spin system s. Our rst step was to generalize the Tyablikov approximation to spin system s without translational symmetry to account for the substitutional disorder present in such systems. The resulting equation of motion for the magnon G reen's function was then solved numerically for nite spin systems. The obtained spectral densities were then used to estimate the C urie tem perature and the spontaneous magnetization of the corresponding in nite system.

C om pared with otherm $ethods^{21{37,39}{50}}$, our approach has the advantage that the spins are treated quantum – m echanically within the Tyablikov approximation, which goesbeyond mean-eld and classical-spin approximation, and { apart from the simplication of a uniform magnetization { no approximations are needed with respect to the substitutional disorder. Furtherm ore, the numerical e ort as well as the analytical is fairly low in our approach.

O ur calculations for short-range exchange interactions show no magnetic order below the critical percolation concentration in accordance with percolation theory. For ferrom agnetic long-range exchange interactions, the calculation show a linear dependence of the Curie tem perature on the concentration of spins. Hence, a nite Curie tem perature is found even for very low concentrations. For systems with oscillating long-range exchange interaction, the presented method fails to give answers due to the lack of a ferrom agnetic ground state at nite dilution. For ferrom agnetic materials with concentrations of magnetic atoms as low as c 0.05, these results in ply that the elective exchange interaction must be very longranged, but can not oscillate strongly with the inter-spin distance.

In this article, we have shown that our approach gives quite reasonable results for a variety of model system s with ferrom agnetic ground state. The next step should be an application to real substances. To attack the problem of ferrom agnetic DMS, for example, the presented method may be combined with a theory for the electronic degrees of freedom, which provides the values for the e ective exchange interaction between the localized m om ents. Furtherm ore, the m ethod can be extended to account for a site-dependent m agnetization of the localized m om ents. H ow ever, this will highly increase the numerical e ort. Clustering and other forms of chemical ordering m ay be easily included into the m odel to m ake it more realistic for materials, in which these play a role. M oreover, the m ethod could then be used to analyze of the e ects of chem ical short-range order on the m agnetic properties. This know ledge could be very useful for the development of new materials, in which one can in uence the distribution of the magnetic atom s by choosing certain preparation param eters and hence, obtain certain desired magnetic properties. Furthermore, it should be investigated whether the presented m ethod, in particular the treatment of the zero-eigenvalues, could be put on a m theoretical basis.
