D ynam ics and therm odynam ics of a sim ple m odel sim ilar to self-gravitating system s: the HMF m odel

Abstract. We discuss the dynam ics and therm odynam ics of the H am iltonian M ean Field m odel (HMF) which is a prototypical system with long-range interactions. The HMF m odel can be seen as the one Fourier component of a one-dimensional self-gravitating system. Interestingly, it exhibits m any features of real self-gravitating system s (violent relaxation, persistence of m etaequilibrium states, slow collisional dynam ics, phase transitions,...) while avoiding complicated problem s posed by the singularity of the gravitational potential at short distances and by the absence of a large-scale con nem ent. We stress the deep analogy between the HMF m odel and self-gravitating system s by developing a complete parallel between these two systems. This allows us to apply m any technics introduced in plasm a physics and astrophysics to a new problem and to see how the results depend on the dim ension of space and on the form of the potential of interaction. This comparative study brings new light in the statistical mechanics of self-gravitating systems. We also mention simple astrophysical applications of the HMF model in relation with the form ation of bars in spiral galaxies.

1 Introduction

The statistical mechanics of systems with long-range interactions is currently a topic of active research in physics because it diers in many respects from that of more fam iliar systems with short-range forces that are extensive (Dauxois et al. 2002a). Am ong long-range interactions, gravity is probably the most important and most fundamental example (Padmanabhan 1990, Chavanis 2002a). However, the statistical mechanics of self-gravitating system s initiated by Antonov (1962) and Lynden-Bell (1968) is complicated due to the divergence of the gravitational force at short distances and to the absence of shielding (or con nem ent) at large distances. These di culties are specic to the gravitational force and not to the longrange nature of the interaction. Therefore, it may be of conceptual interest to consider simpler system swith longrange interactions to distinguish what is speci c to the gravitational force and what is common to systems with long-range interactions.

A toy model of system s with long-range interactions is the so-called HMF (Ham iltonian Mean Field) model. It consists of N particles moving on a circle and interacting via a cosine binary potential. This can be seen as a onedimensional plasm a where the potential of interaction is truncated to one mode. This model is of great conceptual interest because it exhibits many features present in more realistic system swith long-range interactions such as gravitational systems. In addition, it is su ciently simple to allow for accurate num erical simulations and analytical results.

To our know ledge, what is now called the HMF model was rst introduced by Konishi & Kaneko (1992). They found that a cluster is form ed in som e cases and that the system remains uniform in other cases. Inagaki & Konishi (1993) realized that the K onishi-K aneko system is nothing but the one Fourier component of a one-dimensional selfgravitating system and explained the form ation of clusters as an instability similar to the Jeans instability in selfgravitating system s described by the V lasov equation. Inagaki (1993) studied the therm odynam ical stability of the Konishi-Kaneko system and identi ed the existence of a second order phase transition at a critical tem perature T_c. Above T_c the only statistical equilibrium state is uniform, whereas below T_c this uniform state looses its therm odynam ical stability and clustered states appear. In order to justify his results dynam ically, Inagaki (1996) developed a \collisional" kinetic theory of the K on ishi-K aneko system based on results of plasm a physics and proposed to m odel the dynam ics of the system by the Lenard-Balescu equa-

tion for a one dimensional plasm a truncated to one mode. However, as we shall see, his conclusions dem and further discussion.

The same model was considered at about the same time by Pichon and Lynden-Bell (Pichon 1994) who gave an astrophysical application of this model in relation with the form ation of bars in galactic disks. In their approach, the stars follow rigid elliptical orbits with eccentricity e. If i represents the inclination of ellipse i and its angular velocity, the torque exerted by an orbit to the other can $^{1}d_{1} = dt = @_{12} = @_{1} where$ ¹ is the adibe w ritten abatic m om ent of inertia of the inner Lindblad orbit and $_{12} = GA^2 \cos 2(1)$ is the e ective alignem ent potential. At high tem peratures, the orbits are alm ost uniform ly distributed in space and the system is in a disk phase (see Fig. 4). How ever, below som e critical tem perature T_c, the ellipses tend to align to each other and form a bar (see Fig. 5). Those bars are reported observationally in real galaxies. Pichon and Lynden-Bell studied the linear stability of these bars with respect to the V lasov equation and proposed that the clustered phase could result from a process of violent relaxation, a concept introduced by Lynden-Bell (1967) to explain the regularity of collisionless stellar system s such as elliptical galaxies.

also appeared in statistical mechanics (Antoni & Ru o 1995). In that context, the motivation was to devise a sim ple model with long-range interactions keeping the richness of m ore realistic system s while being am enable to a full analytical and num erical treatem ent. Excitingly, this simple model displays a lot of interesting features (violent relaxation, persistence of metaequilibrium states, slow collisional relaxation, phase transitions,...) also present in other system s with long-range interactions such as stellar system s and 2D vortices (Chavanis 2002a). The properties of the HMF model have been studied in great detail in a lot of recent papers (see D auxois et al. 2002b for a review). Despite its oversim plication, the HMF model can be seen as a pedagogical model to take a step into the physics of system s with long-range interactions. It is said som etim es to represent the \harm onic oscillator" of system swith long-range interactions. This probably explains its popularity.

In the present paper, we shall emphasize the connection between the HMF model and the results established in astrophysics and plasm a physics. In particular, we will adapt the m ethods developed for 3D self-gravitating system s to the case of a one-dimensional system of particles with cosine interactions. The motivation of this extension is two-fold. The rst is to show that the results obtained in astrophysics and plasm a physics can have applications in other domains of physics, including the HMF model (this has not been su ciently appreciated by workers in that eld since the early work of Inagaki). The second is to stress the analogies and the di erences which appear in long-range system s as we change the dimension of space and the potential of interaction. Am ong the analogies between 3D self-gravitating systems and the HMF model, we note: the concept of violent relaxation and the slow

collisional dynam ics. A m ong the di erences, we note: the equivalence of statistical ensembles for the HMF model (contrary to 3D gravitational system s), the existence of second order phase transitions (instead of rst order or zeroth order phase transitions for 3D gravitational system s) and the vanishing of the collision operator at the order 1=N in the BBGKY hierarchy contrary to the Coulom bian or New tonian case.

The paper is organized as follows. In Sec. 2, we consider the statistical equilibrium states of the HMF model in both m icrocanonical and canonical ensem bles. W e synthesize previously known results and we derive explicit criteria of therm odynam ical stability for the uniform phase as well as for the clustered phase. We also describe corrections to the mean-eld approximation close to the critical point. In Sec. 3, we consider a one-dimensional gaseous system with cosine interactions (the analogue of a \gaseous star") described by the Euler equations with a barotropic equation of state. W e discuss in particular the equivalent of the Jeans instability. In Sec. 4, we consider the collisionless evolution of the HMF model (the analogue of a \stellar system ") described by the V lasov equation and discuss the concept of violent relaxation and m etaequilibrium states. We interprete these quasi-equilibrium states The Konishi-Kaneko system , now called the HMF model, as particular stationary solutions of the V lasov equation on the coarse-grained scale resulting from phase mixing and incom plete violent relaxation.W e regard T sallis func- $\frac{1}{\mathbf{R}^{1}}$ (f^q f)d dv and Boltzm ann func $tionalS_{\alpha}[f] =$ f ln fd dv as particular H-functions in $tionalS_{B}$ [f] = the sense of Trem aine et al. (1986) associated with polytropic and isotherm ald istributions.W e study the dynam ical stability of stationary solutions of the V lasov equation and compare with the dynam ical stability of stationary solutions of the barotropic Euler equations. This is the same type of comparison as between \gaseous systems" and \stellar system s" in astrophysics. In that respect, we discuss the equivalent of the Antonov rst law (Binney & Trem aine 1987) for the HMF model. We derive a criterion of nonlinear dynam ical stability for steady states of the V lasov equation of the form f = f() with $f^{0}() < 0$ is the individual energy, and show that it can where be written as a condition on the velocity of sound in the corresponding barotropic gas. This criterion is equivalent to the criterion obtained by Yam aguchiet al. (2004) but it is expressed di erently. W e also analyze the linear dynam ical stability of steady states of the V lasov equation and study the dispersion relation for isotherm al and polytropic distributions. In Sec. 5, we discuss the collisional evolution of the HMF model and explain why the kinetic theory is more complicated than for 3D Newtonian interactions. In particular, the Landau and the Lenard-Balescu collision term s vanish for 1D system s so that the evolution of the system as a whole is due to terms of order smaller than 1=N in the expansion of the correlation functions for N ! +1. This implies that the relaxation time is larger than N $t_{\rm D}$ (where $t_{\rm D}$ is the dynam ical time). By contrast, we can develop a kinetic theory at order 1=N to analyze the relaxation of a \test particle" in a bath of \ eld particles" with static distribution

 f_0 (v). The evolution of the distribution function P (v;t) of the velocity of the test particle satis es a Fokker-Planck equation.W e give explicit expressions for the di usion coe cient and the auto-correlation function and we com pare their expressions depending on whether collective effects are taken into account or not. W e also show that the auto-correlation function decreases exponentially rapidly in time with a rate coinciding with the dam ping rate of a stable perturbed solution of the V lasov equation. Finally, in Sec. 6, we discuss the case of self-attracting Brownian particles described by non-local Fokker-P lanck equations. This stochastic model is the canonical counterpart of the Ham iltonian N-body problem. It could be called the BMF (Brownian Mean Field) model. We study the dynamical stability of steady states of the non-local Sm oluchowski equation and solve this equation num erically to show the form ation of a clustered state from an unstable hom ogeneous state due to long-range interactions.W ealso provide analytical solutions of the dynam ics close to the critical point T_c and for T = 0. All these models have an equivalent in the astrophysical literature and this paper stresses the analogies and di erences between self-gravitating system s and the HMF m odel. This com parative study brings new light in the statistical mechanics of self-gravitating system s by showing what is speci c to gravity and what is common to system swith long-range interactions.

2 Statistical equilibrium

2.1 The mean-eld approximation

W e consider a system of N particles moving on a circle and interacting via a cosine binary potential. This is the so-called HMF model. As explained in the Introduction, this model can also describe a system of stars moving on elliptical orbits, each orbit exerting a torque on the others. Fundam entally, the dynam ics of this system is governed by the H am ilton equations

where $_i$ is the angle that m akes particle/ellipse i w ith an axis of reference and k is the coupling constant (sim ilar to the gravitational constant G). In the rest of the paper, we shall refer to this system as a \stellar system "; this is to emphasize the analogies with real 3D stellar system s whose dynamics is also governed by H am iltonian equations with long-range interactions. We have also generalized the usual HMF m odel to a population of particles with di erent m asses m $_i$. However, in m ost of the paper, we shall assume that all the particles have the same m ass m = 1. The m ulti-species HMF m odel will be discussed speci cally in Sec. 7.

The evolution of the N-body distribution function is governed by the Liouville equation

where $F_i = \frac{k}{2} P_{j=1}^N \sin(i_j)$ is the force experienced by particle i. Any distribution of the form $P_N = (H)$ (E H) is a stationary solution of the Liouville equation. For N 1 (xed) and t ! +1, this system is expected to reach a statistical equilibrium state due to the developement of correlations between particles (this will be referred to as a \collisional" relaxation). As is custom ary in statistical mechanics, we shall assume that the equilibrium N-body distribution function is described by the microcanonical distribution

expressing that all accessible m icrostates (with the right values of energy and m ass) are equiprobable.W hether this is indeed the case has not been proved rigorously as it relies on a hypothesis of ergodicity, so this statem ent is essentially a postulate.

For system sw ith long-range interactions (self-gravitating system s, 2D vortices, HMF model,...), it can be shown that the mean-eld approximation is exact in an appropriate thermodynamic limit. This can be shown for example by considering an equilibrium BBGKY-like hierarchy (Chavanis 2004b,2005). For the HMF model, the thermodynamic limit is N ! +1 in such a way that the properly normalized energy = 8 $E = kM^2$ and tem perature = kM =4 are xed, where M = N m is the totalm ass. These control parameters are similar to those, = $ER = GM^2$ and = GMm = R, describing 3D gravitational systems (see eq. Chavanis 2003a). In that limit

2.2 The Boltzm ann entropy

Wewish to determ in the macroscopic distribution of particles at statistical equilibrium, assuming that all accessible m icrostates (with given E and M) are equiprobable. To that purpose, we divide the -space f ; vg into a very large number of microcells with size h. W e do not put any exclusion, so that a m icrocell can be occupied by an arbitrary number of particles. We shall now group these m icrocells into m acrocells each of which containsm any m icrocells but rem ains nevertheless sm all com pared to the phase-space extension of the whole system . We call the num ber of m icrocells in a m acrocell. C onsider the con guration $fn_i g$ where there are n_1 particles in the 1^{st} m acrocell, n_2 in the 2^{nd} m acrocelletc. U sing the standard com binatorial procedure introduced by Boltzm ann, the num ber of m icrostates corresponding to the m acrostate fnig, ie. its probability, is given by

up to som e unim portant additive constant. Then, the statistical equilibrium state, corresponding to the most probable distribution of particles, is obtained by maxim izing the Boltzmann entropy (14) at xed mass M and energy E, ie.

Thism axim ization problem de nesthem icrocanonical equilibrium state, which is the correct description for an isolated H am iltonian system .

We shall also consider the canonical description which applies to a system in contact with a therm ostat im posing its tem perature T.We will give an example of canonical system in Sec. 6 corresponding to B rownian particles in interaction described by stochastic (not H am iltonian) equations (BMF model). In the canonical ensemble, the statistical equilibrium state is obtained by minimizing the free energy $F_{\rm B}$ [f] = E [f] $TS_{\rm B}$ [f] at xed mass M and tem perature T, ie.

The relation between the Boltzm ann entropy S_B [f] and the density of states g(E) in the m icrocanonical ensem ble and between the Boltzm ann free energy F_B [f] and the partition function Z () in the canonical ensem ble is discussed in Chavanis (2004b,2005). The variational problem s (15) and (16) correspond to a saddle point approximation in the functional integral representation of g(E) and Z ().

The variational problem (15) has been rst investigated, in the HMF context, by Inagaki (1993).We review and precise the main results of his study and present an alternative derivation of the condition of therm odynam ical stability using methods sim ilar to those introduced by P adm anabhan (1990) and C havanis (2002b,2003a) for 3D self-gravitating system s. This will make the analogy between the two system s (stellar system s and HMF m odel) closer. This will also allow us to study the therm odynam ical stability of the clustered phase, while the analysis of Inagaki (1993) is restricted to the uniform phase.

2.3 The rst variations: the M axwell-Boltzm ann distribution

W e need rst to determ ine the critical points of entropy at xed m ass and energy.W e w rite the variational principle in the form

where = 1=T (inverse tem perature) and (chem icalpotential) are Lagrange multipliers enforcing the constraints on E and M . The solution of (17) is the mean-eld M axwell-Boltzm ann distribution

where depends on f through Eq. (8). The foregoing relation is therefore an integro-di erential equation. Integrating over the velocity, we obtain the mean-eld Boltzm ann distribution

The same distributions (18) and (19) are obtained in the canonical ensemble by cancelling the rst variations of free energy at xed mass, using F_{B} M = 0.Therefore,the critical points of the variational problem s (15) and (16) coincide. In the microcanonical ensemble, we need to relate the Lagrange multiplier to the energy E. This de nes a series of equilibria (E). In the canonical = ensemble, the inverse tem perature is assumed given and the corresponding (average) energy is obtained by inversing the graph (E). Of course, only the stable part of the series of equilibria is of physical interest, and de nes the caloric curve (see Sec. 2.5). We note that the equilibrium distributions (18) and (19) can also be obtained from an equilibrium BBGKY-like hierarchy in the therm odynam ic $\lim i N ! + 1$ de ned in Sec. 2.1 (Chavanis 2004b, 2005).

U sing the relation (9), the distribution of particles at statistical equilibrium is given by

The axis of symmetry is determined by the initial conditions. If B = 0, the density is uniform. This denes the hom ogeneous phase. If $B \notin 0$, we have inhom ogeneous states with one cluster at = 0 (if B < 0) or at = (if B > 0). The constant A is related to the mass by





Then x, and consequently B, is determined as a function of T by a simple graphical construction sketched in Fig. 1. We see that B = 0 is always solution although $B \notin 0$ is possible only if

F ig. 1. G raphical construction showing the appearance of a clustered phase below some critical temperature $T_{\rm c}$.




F ig. 2. O rder param eter B $\mbox{ (m agnetization)}$ as a function of the inverse tem perature.




Fig. 4. Stellar orbits in the \disk phase" for $T > T_{\rm c}$.





Fig. 5. Stellar orbits in the \bar phase" for T < T_c .

The function B (T) is shown in Fig.2 and its asymptotic behaviours are given in Sec. 2.4. Figure 2 displays a second order phase transition. We have a situation similar to a gravitational collapse below a critical temperature T_c or below a critical energy E_c . For $T > T_c$, the system is hom ogeneous. For $T < T_c$, the system form s one cluster around = 0 (for B < 0) or around = (for B > 0). At T = 0, the equilibrium state is a D irac peak = M () (for $B = B_{m ax}$). Density pro les are plotted in Fig.3 for di erent values of x = B (). U sing the stellar disk interpretation of P ichon & Lynden-Bell, we have represented som e stellar orbits in Figs. 4 and 5 by random ly choosing the orbits' angles with the equilibrium distribution ().



F ig. 3. Evolution of the density prole as temperature is decreased (from bottom to top).

2.4 The therm odynam ical param eters

The caloric curve/series of equilibria (E) is shown in Fig. 7. It displays a second order phase transition at (;) = (1;1). This is di erent from 3D gravitational system swhich rather display rst order and zeroth order phase transitions (see, e.g., Chavanis 2002c).


2.5 The second variations: therm odynam ical stability

To analyze the therm odynam ical stability of the solutions determ ined by the variational problem s (15) and (16), we use an approach sim ilar to that followed by Padm anabhan (1990) and Chavanis (2002b,2003a) in the case of 3D self-gravitating system s.We rst maxim ize S_B [f] at xed M [f], E [f] and (). 


Fig. 8. Dependence of the largest eigenvalue with the temperature. A negative value of corresponds to stability (${}^{2}S < 0$) and a positive value of corresponds to instability.

The eigenvalue equation is the same in the two ensembles. Hence, the stability criteria coincide, implying that the statistical ensembles (microcanonical and canonical) are equivalent. This is at variance with the case of 3D stellar system s (P adm anabhan 1990, C havanis 2002b,2003a).

We can study the solutions of Eq. (57) by decomposing q in Fourier series. For the mode n, we have $q_n = A_n \sin(n)$. For $n \in 1$, we get $_n = \frac{n^2}{M} < 0$ showing that these modes do not induce instability. For n = 1, we have $_1 = \frac{k}{4T}$ $\overline{_{M}}$. The uniform solution will be unstable if $_1 > 0$ yielding condition (27). Therefore, the uniform phase is stable for $T > T_c$ while it is unstable for $T < T_c$. By using the theory of linear series of equilibria (K atz 1978, 1980, 2003), applied here to a bifurcation point, we directly conclude from the inspection of Fig. 7 that the clustered phase will be stable for $T < T_c$ when the hom ogeneous phase becomes unstable.

M ore precisely, it is possible to solve Eqs. (54) and (56) analytically for the clustered phase in the lim it B ! 0, which is valid close to the critical point ($E_c;T_c$). The calculations are detailed in Appendix A. In the canonical ensemble (V = 0), it is found that the largest eigenvalue is

2.7 Correction to the mean-eld approximation close to the critical point

We can obtain the expression of the two-points correlation function from an equilibrium BBGKY-like hierarchy by closing the second equation of the hierarchy with the K inkwood approximation (C havan is 2004b,2005). This is valid to order 1=N in the therm odynamic limit de ned previously. For the HMF model, it is then possible to obtain an explicit expression of the correlation function in the hom ogeneous phase. W riting the two-body distribution function as

W e note that the correlation function diverges close to the critical point ! $_{\rm c}$ where the clustered phase appears and the hom ogeneous phase becom es unstable. This implies that the mean-eld approximation ceases to be valid close to the critical point. We expect a similar result for 3D self-gravitating system s although the situation ism ore di cult to analyze as (real) self-gravitating system s are always inhom ogeneous.

Note that without the correlations, we would have sim ply obtained hF²i = $\frac{k^2}{4}$ which corresponds to the high tem perature lim it (T ! +1) of Eq. (65).

For the HMF model, the variance (65) of the force is nite while the variance of the Newtonian force for 3D self-gravitating systems is in nite (Chandrasekhar & von Neum ann 1942). For the HMF model, the distribution of the force is norm al (Gaussian) while the distribution of the gravitational force in D = 3 is a particular Levy law called the Holtzmark distribution. On the other hand, for 2D point vortices, the variance of the velocity is a marginal Gaussian distribution intermediate between normal and Levy laws (Chavanis & Sire 2000). Therefore, these three system swith long-range interactions (self-gravitating system s, 2D vortices and HMF m odel) have their own specicities despite their overall analogies.

3 Gaseous system s

As indicated in the Introduction, the HMF model is sim ilar to stellar system s in astrophysics. In Secs. 4 and 5, we shall discuss the kinetic theory of the HMF model and obtain the equivalent of the V lasov and Landau equations that are used to describe the dynam ics of elliptical galaxies and globular clusters respectively. How ever, in order to facilitate the discussion and the comparison, it is useful to discuss st the dynamics of a one-dimensional barotropic uid system with cosine interactions described by the Euler equations. In astrophysics, these equations describe the dynam ics of barotropic stars. Stellar system s and barotropic stars are often treated in parallel due to their analogies (Binney & Trem aine 1987). In particular,

it is possible to infer su cient conditions of dynam ical stability for spherical stellar system s from the dynam ical stability of a barotropic star with the sam e density distribution. This constitutes the Antonov rst law. Therefore, it is also of interest to develop this parallel in the case of the HMF model. To have a similar vocabulary, the system s considered in this paper will also be called \stellar system s" and \gaseous stars" although they are only onedimensional and correspond to a cosine interaction.

3.1 Euler equations and energy functional

We consider a gaseous system described by the Euler equations

However, we shall see that there is a close connection between the stationary states of the V lasov and the Euler equations and that the lim its of dynam ical stability are the same in the two system s. Thus, the study of the Euler equation (which is simpler than the V lasov equation) brings many inform ation about the stability of stationary states of the HMF m odel with respect to the V lasov equation even if the Euler system does not describe dynam ically the HMF model.

It is straightforward to verify that the energy functional



In the case of 3D selfgravitating systems, the Jeans criterion selects a critical wavelength $_J$ (increasing with the temperature) above which the system is unstable against gravitational collapse. In the present context, where the interaction is truncated to one Fourierm ode n = 1, the criterion (92) selects a critical temperature below which the system is unstable. The generalization of the Jeans instability criterion for an arbitrary binary potential of interaction in D dimensions is discussed in Appendix C and in Chavanis (2004b). This generalization clearly shows the connection between the HMF m odel and 3D self-gravitating system s.

W e have added a constant term (proportional to the total m ass) in the polytropic energy functional (95) so as to recover the isotherm alenergy functional (90) for n ! + 1 . U nder this form, we note that the energy functional of a polytropic gas has the same form as the T sallis free energy F [] = E[] KS[] where plays the role of the q-parameter and K the role of a generalized tem perature. The same rem ark holds for 3D self-gravitating system s. H ow ever, this resem blance is essentially fortuitous and the m ark of a therm odynam ical analogy (C havan is 2003a; C havan is & Sire 2004b).

If we de ne the local tem perature by p() = ()T(), we obtain $T() = K()^{1-n}$ and $c_s^2() = T()$. We note that, for a polytropic distribution, the kinetic tem perature T() usually depends on the position while the polytropic tem perature K is uniform as in an isothermal gas. 

The trajectories (t) can then be expressed in term s of elliptic functions. The dynam ics of the forced Burgers equation is interesting as it develops \shocks" and \chevrons" (caustics) singularities (see Fig. 10). The Burgers equation also appears in cosm ology to describe the form ation of large-scale structures in the universe (Vergassola et al. 1994). A detailed description of this dynam ics is given by Barre et al. (2002) in the context of the repulsive HMF model. In that case, the forced Burgers equation (102) with sin(2) instead of sin models the short time dynam ics of the Ham iltonian N -body system . For the attractive HMF model (1), the short time dynamics can be modelled by the non-local Euler equation (67) with zero pressure p = 0.This is solution of the V lasov equation (see Sec. 4) with f(;v;t) = (;t) (v u(;t)). This singlespeed solution is valid until the rst shock. How ever, the connection with the localEuler equation (102) is not clear in that case because the hom ogeneous phase is unstable

which precludes the possibility of deriving (102) from (67) as is done in Barre et al. (2002) in the repulsive case. Note also that in the attractive HMF m odel (ferrom agnetic) we just have one cluser while the repulsive HMF m odel (anti-ferrom agnetic) shows a bicluster.

4 V iolent relaxation, m etaequilibrium states and dynam ical stability of collisionless stellar system s

W e now come back to the HMF model de ned by the H am ilton equations (1) and develop a kinetic theory by analogy with stellar systems. In particular, we emphasize the importance of the V lasov equation and the concept of violent relaxation introduced by Lynden-Bell (1967).

4.1 V lasov equation and H-functions

For system s with long-range interactions, the relaxation time toward the statistical equilibrium state (18) is larger than N t_D, where t_D is the dynamical time (Chavanis 2004b). A coordingly, for N ! +1, the relaxation time is extremely long and, for timescales of physical interest, the evolution of the system is essentially collisionless. More precisely, for t $t_{\rm relax}$ and N ! +1 (V lasov limit), the time dependence of the distribution function is governed by the V lasov equation

which has to be solved in conjunction with Eq. (8). This system of equations is sim ilar to the V lasov-Poisson system describing the dynam ics of elliptical galaxies and other collisionless stellar system s in astrophysics. Starting from an unstable initial condition, the HMF model (1) will achieve a m etaequilibrium state (on a coarse-grained scale) as a result of phase m ixing and violent relaxation (B inney & Tremaine 1987). This metaequilibrium state is a particular stationary solution of the V lasov equation. Since it results from a complex mixing, it is highly robust and nonlinearly dynam ically stable with respect to collisionless perturbations. The process of violent relaxation and the convergence of the distribution function toward a stationary solution of the V lasov equation has been illustrated num erically by Yam aguchi et al. (2004) for the HMF model. This is similar to the violent relaxation of stellar systems in astrophysics and 2D vortices in hydrodynam ics (see Chavanis 2002a).

O ne question of great importance is whether we can predict the m etaequilibrium state achieved by the system as a result of violent relaxation. Lynden-Bell (1967) has tried to make such a prediction by resorting to a new type of statistical m echanics accounting for the conservation of all the C asim irs imposed by the V lasov equation. This theory was developed for the gravitational interaction, but the general ideas and form alism apply to any system with long-range interactions described by the V lasov equation. In the non-degenerate limit, he predicts a Boltzm ann distribution of the form \overline{f} e where the individual mass of the particles does not appear. Lynden-Bell (1967) also understood that his statistical prediction is limited by the concept of incomplete relaxation. The system tries to reach the most mixed state but, as the uctuations become e weaker and weaker as we approach equilibrium, it can settle on a stable stationary solution of the V lasov equation which is not the most mixed state. In order to quantify the importance of mixing, Trem aine et al. (1986) have introduced the concept of H-functions

where C is an arbitrary convex function. The H-functions calculated with the coarse-grained distribution function f increase as a result of phase mixing in the sense that S[f(;v;0)] for t > 0 where it is assumed S[f(;v;t)] that, initially, the system is not mixed so that $\overline{f}(;v;0) =$ f (;v;0). This is similar to the H -theorem in kinetic theory. However, contrary to the Boltzm ann equation, the V lasov equation does not single out a unique functional (the above inequality is true for all H -functions) and the tim e evolution of the H -functions is not necessarily m onotonic (nothing is in plied concerning the relative values of H (t) and H (t⁰) for $t;t^0 > 0$). On the other hand, any stationary solution of the V lasov equation of the form f = f() with $f^0() < 0$ extrem izes a H -function at xed m ass and energy. If, in addition, it m axim izes S at xed E , M, then it is nonlinearly dynam ically stable with respect to the V lasov equation. In astrophysics, such distribution functions depending only on the energy describe spherical stellar system s. This is a particular case of the Jeans theorem (Binney & Tremaine 1987).For a 1D system such as the HMF model, this is the general form of inhom ogeneous stationary solutions of the V lasov equation. Therefore, we expect that the H-functions will increase during violent relaxation until one of them (non-universal) reaches its maximum value at xed mass and energy when a stationary solution of the V lasov equation is reached (this is not necessarily the case in astrophysics since the system can reach a steady state that does not depend only on energy). Note that the Boltzm ann and the T sallis functionals are particular H-functions (not therm odynam ical entropies in that context) associated with particular stationary solutions of the V lasov equation: isotherm alstellar system s and stellar polytropes (Chavanis & Sire 2004b). All these ideas, rst developed for stellar system s, apply to other system swith long-range interactions such as the HMF model.

4.2 N onlinear dynam ical stability criterion for the V lasov equation

The theory of violent relaxation explains how a collisionless system out of mechanical equilibrium can reach a steady solution of the V lasov equation on a very short tim escale due to long-range interactions and chaotic m ixing.Since this metaequilibrium state is stable with respect to collisionless perturbations, it is of interest to determ ine a criterion of form al nonlinear dynam ical stability for the V lasov equation. For the HMF m odel, this has been considered by Yam aguchi et al. (2004) using the Casim ir-Energy m ethod. We shall propose another derivation of the stability criterion which uses a form alanalogy with the therm odynam ical analysis developed in Sec. 2 and which is also applicable to the clustered phase. This approach is sim ilar to the one developed by Chavanis (2003a) for 3D stellar system s.

Let us introduce the functional S = ^K C (f)d dv where C (f) is a convex function. This functional is a particular C asim ir so it is conserved by the V lasov equation. The energy E and the mass M are also conserved. Therefore, a maximum of S at xed mass M and energy E determines a stationary solution f (;v) of the V lasov equation that is nonlinearly dynam ically stable. We are led therefore to consider the maximization problem

We also note that F[f] = E[f] TS[f] (where T is a positive constant) is conserved by the V lasov equation. Therefore, a minimum of F at xed mass M is nonlinearly dynamically stable with respect to the V lasov equation (F is called an energy-C asim ir functional). This corresponds to the form alstability criterion of H olm et al. (1985). This criterion can be written

To study the nonlinear dynam ical stability of collisionless stellar system s, we are thus led to consider the maxim ization problem s (106) and (107). These are sim ilar to the conditions of therm odynam ical stability (15) and (16) but they involve a more general functional S [f] than the Boltzm ann entropy. In addition, they have a completely di erent interpretation since they determ ine the nonlinear dynam ical stability of a steady solution of the V lasov equation, not the therm odynam ical stability of the statistical equilibrium state. Due to this form alresem blance, we can develop a therm odynam ical analogy (Chavanis 2003c) and use an e ective therm odynam icalvocabulary to investigate the nonlinear dynam ical stability of a collisionless stellar system . In this analogy, S plays the role of an e ective entropy, T plays the role of an e ective tem perature and F plays the role of an e ective free energy. The criterion (106) is similar to a condition of microcanonical stability and the criterion (107) is similar to a condition of canonical stability.

We also note that the stability criterion (106) is consistent with the phenom enology of violent relaxation. Indeed, the H-functions increase on the coarse-grained scale while the mass and the energy are approximately conserved. Therefore, the metaequilibrium state is expected to maximize a certain H-function (non-universal) at xed mass and energy. In that interpretation, f has to be viewed as the coarse-grained distribution function \overline{f} , not the distribution function itself. The point is that during mixing D \overline{f} =D t $\underline{6}$ 0 and the H-functions S [\overline{f}] increase. Once it

has mixed D \overline{f} =D t = 0 so that S- $[\overline{f}]$ = 0. Since \overline{f} (;v;t) has been brought to a maximum \overline{f}_0 (;v) of a certain H – function and since S $[\overline{f}]$ is conserved (after mixing), then \overline{f}_0 is a nonlinearly dynam ically stable steady state of the V lasov equation.

4.3 First variations: stationary solutions of the V lasov equation

Introducing Lagrange multipliers as in Sec. 2.3, the critical points of the variational problem s (106) and (107) are given by

We note also that for each stellar system with f = f(), there exists a corresponding barotropic star with the same equilibrium density distribution. Indeed, de ning the density and the pressure by $= {R_{+1} \atop 1} f dv = ()$, $p = {R_{+1} \atop 1} f v^2 dv = p()$, and eliminating the potential between these two expressions, we nd that p = p(). D ue to the analogy between stellar system s and barotropic stars, it becomes possible to use the results obtained in Sec.3 to study the stationary solutions of the V lasov equation (104). In particular, the transition from hom ogeneous (B = 0) to inhom ogeneous ($B \notin 0$) solutions is again given by the criterion (75). Now, in the case of stellar systems, it is more relevant to express this criterion in terms of the distribution function. U sing the identity (299), the criterion (75) determ ining the appearance of the clustered phase is equivalent to

W e will soon see how this quantity is related to the dielectric function of a gravitational plasm a.

4.4 Second variations: the condition of nonlinear dynam ical stability

W e shall investigate the form al nonlinear dynam ical stability of stationary solutions of the V lasov equation by using the criterion (107). This criterion is less re ned than the criterion (106) because all solutions of (107) are solution of (106), but the reciprocal is wrong in general. In particular, for long-range interactions, the optim ization problems (106) and (107) may not coincide. In therm odynam ics, this corresponds to a situation of ensemble inequivalence (see Bouchet & Barre 2004). Therefore, the criterion (107) can only give a su cient condition of nonlinear dynam ical stability for stationary solutions of the V lasov equation of the form f = f() with $f^{0}() < 0$. This corresponds to the criterion of form al nonlinear dynam icalstability given by Holm et al. (1985). The more re ned criterion (106) has been introduced by Ellis et al. (2002) in 2D hydrodynamics (for the 2D Euler-Poisson system) and applied by Chavanis (2003a) in stellar dynam ics (for the V lasov-P oisson system).

To obtain a managable criterion of dynam ical stability, we use the same procedure as the one developed in C havanis (2003a). We shall not repeat the steps that are identical. We rst minim ize the functional F [f] at xed tem perature and density (). This gives an optimal distribution f (;v), determined by $C^0(f) = \frac{v^2}{2}$ (), which depends on the density () through the Lagrange multiplier (). Then, after some manipulations, we can show that the functional F [] = F [f] can be put in the form

where p() is the equation of state determ ined by C (f) according to Eqs. (111) and (112). We now need to m inim ize F [] at xed mass. (114) returns the condition of hydrostatic equilibrium (70) and the positivity of the second variations leads to the stability criterion

< 0 linked to the eigenvalue equation (77). Therefore, the criterion of form alnon linear dynam ical stability (107) for the V lasov equation (stellar system s) is equivalent to the criterion of form al nonlinear dynam ical stability (69) for the Euler equations (gaseous barotropic stars).

U sing the results of Sec. 3, we conclude that the uniform phase is form ally nonlinearly dynam ically stable with respect to the V lasov equation when

W hen the inequality is reversed, the uniform phase is a saddle point of F at xed mass M and we shall see that it is linearly dynam ically unstable. U sing the identity (299), the nonlinear criterion (115) can be rew ritten as

Indeed, the stability of the clustered phase can be investigated by solving the eigenvalue equation (77) for the equation of state speci ed by the function C (f), and investigating the sign of .

4.5 About the Antonov st law

As discussed previously, the criterion (107) providing a condition of nonlinear dynam ical stability for a stellar system with f = f() and $f^{0}() < 0$ is equivalent to the criterion (69) determ ining the nonlinear dynam ical stability of a barotropic star with the same equilibrium density distribution. On the other hand, we have already indicated that the criterion (107) is less re ned than the criterion (106) which is believed to be the strongest criterion of nonlinear dynam ical stability for stationary solutions of the V lasov equation of the form f = f() with $f^{0}() < 0$. In general, the criterion (107) just provides a su cient condition of nonlinear dynam ical stability. Thus, we can \m iss" stable solutions if we use just (107) instead of (106) [said di erently, the set of solutions of (107) is included in (106)]. From these remarks, we conclude that \a stellar system is stable whenever the corresponding barotropic gas is stable" but the converse is wrong in general. This is the so-called Antonov rst law in astrophysics (Binney & Trem aine 1987). Our approach provides an extension of the Antonov rst law to the case of nonlinear dynam ical stability (while the usual Antonov rst law corresponds to linear dynam ical stability). Furtherm ore, by developing a therm odynam ical analogy, we have provided an original interpretation of the nonlinear Antonov rst law in terms of \ensembles inequivalence" for systems with long-range interactions (Chavanis 2003a) .

For 3D self-gravitating system s, we know that the ensem bles are not equivalent so that the criterion (107) is more restrictive than the criterion (106). In that case, (107) is just a su cient condition of nonlinear dynam ical stability (de nitely).Forexample, using the criterion (69), it can be show n that polytropic stars with index n < 3 are nonlinearly dynam ically stable with respect to the Euler equations while polytropic stars with index 3 < n < 5are dynamically unstable (polytropes with index n > 5have in nite mass). Therefore, using the \canonical" criterion (107), we can only deduce that stellar polytropes with index n < 3 are nonlinearly dynamically stable with respect to the V lasov equation. However, using the \m icrocanonical" criterion (106), we can prove that all stellar polytropes with index n < 5 are nonlinearly dynam ically stable with respect to the V lasov equation. Polytropes with index 3 < n < 5 lie in a region of \ensemble inequivalence" (in the therm odynam ical analogy) where the \speci c heat" is negative (C havanis 2003a).

For the HMF m odel considered in this paper, we believe that the criteria (106) and (107) determ ine the same set of solutions so that the ensembles are equivalent in that case (no solution is forgotten by (107)). We have shown in Sec. 2 that this is at least the case for isotherm al distributions. If we take for granted that this equivalence extends to any functional (105), we conclude that, for the HMF model, \a stellar system is stable if, and only if, the corresponding barotropic gas is stable". This would be the HMF version of the nonlinear Antonov rst law. In that case, the stability lim its obtained for the Euler equation in Sec. 3 can be directly applied to the V lasov equation (they coincide). C learly, it would be of great interest to derive general criteria telling when the ensem bles are equivalent or inequivalent, depending on the form of the functional (105) and on the form of the potential of interaction u (r r^{0}).

4.6 The condition of linear stability

W e now study the linear dynam ical stability of a spatially hom ogeneous stationary solution of the V lasov equation described by f = f(v). This problem was rst investigated by Inagaki & Konishi (1993) and P ichon (1994) and m ore recently by Choi & Choi (2003). We shall com plete here their study. W riting the perturbation in the form f $e^{i(n}$!t) and using standard m ethods of plasm a physics, we obtain the dispersion relation

4.7 Particular examples

W e shall now present explicit results for particular stationary solutions of the V lasov equation.W e consider the case of isotherm al stellar system s and stellar polytropes.

4.7.1 Isotherm al stellar system s

W e consider the H-function



O byiously, the relation (134) between the growth rate and the tem perature of an isotherm al stellar system is di erent from the corresponding relation (93) valid for an isotherm algas (they coincide only at T = 0). A similar

distinction is noted in the case of 3D self-gravitating systems. In particular, Fig. 11 can be compared with Fig. 5.1 of B inney & Tremaine (1987). Moreover, in the unstable regime, a gaseous medium supports sound waves with pulsation $! = (T T_c)^{1=2}$ that are not attenuated. By contrast, in a stellar medium at $T < T_c$, there exists solutions with no wave $(!_r = 0)$ for which the perturbation is damped exponentially. O ther solutions with $!_r \notin 0$ probably exist but they are more di cult to investigate analytically. This is left for a future study.

The relations (134) and (139) have been obtained previously by Choi & Choi (2003) using a slightly di erent approach. Our derivation emphasizes the close link with results in plasm a physics. In addition, our form alism will be used in Sec. 5.4 to show that the damping rate of a perturbation is equal to the exponential decay of the tim e auto-correlation function of the force. The generalization of these results for an arbitrary form of long-range potential is given in Chavanis (2004b).

4.7.2 Stellar polytropes

W e consider the H function

where q is a real number. This functional has been introduced by T sallis (1988) in non-extensive therm odynam – ics. The aim was to develop a generalized therm odynam – ical form alism to describe quasi-equilibrium structures in complex m edia that are not described by the Boltzm ann distribution. In this sense, S_q [f] is interpreted as a generalized entropy and its maxim ization as a condition of (generalized) therm odynam ical stability. In the context of V lasov system s, we shall rather interprete S_q [f] as a particular H -function (see Sec. 4.1) and its maxim ization as a condition of nonlinear dynam ical stability ¹. Its maxim ization at xed mass and energy leads to a particular class of nonlinearly dynam ically stable stationary solutions of the V lasov equation called stellar polytropes. The fact that the criteria (106) and (107) of nonlinear dynam ical stability are sim ilar to criteria of generalized therm odynam ical stability is the mark of a therm odynam ical analogy (C havanis 2003c, C havanis & Sire 2004b).

Stellar polytropes are described by the distribution function

Physical polytropic distribution functions (see C havanis & Sire 2004a) have > 0 and q 1 (i.e. n 1=2) or 1=3 < q 1 (i.e. n < 1).

expressed in term s of f (;v) is either a H -function (dynam ics) or the reduced form of entropy $S_q[$] (thermodynamics) for two levels in the dilute lim it. In any case, it is not clear why non-ergodic e ects could be encapsulated in the simple functional S_q[] introduced by T sallis. T sallis entropy is \natural" because it has m athem atical properties very close to those possessed by the Boltzm ann entropy and it is probably relevant to describe a certain type of mixing and non-ergodic behaviour as in the case of porous m edia and weak chaos (it m ay be seen as an entropy on a fractal space-tim e). How ever, m any other types of pron-ergodic behaviour can occur and other functionals S = C ()d dvd could be relevant. O bservation of stellar system s, 2D vortices and quasi-equilibrium states of the HMF model resulting from incomplete violent relaxation do not favour T sallis distributions in a universal manner. O ther distributions can emerge. In fact, we must give up the hope to predict the m etaequilibrium state in case of incom plete relaxation.We must rather try to construct stable stationary solutions of the V lasov equation in order to reproduce observed phenom ena. The H-functions (105) can be useful in that context. An alternative procedure is to keep the Lynden-Bell form of entropy unchanged and develop a dynam ical theory of violent relaxation (Chavanis et al. 1996, Chavanis 1998) in order to take into account incom plete m ixing through a variable diffusion coe cient related to the strength of the uctuations. In that case, non-ergodicity is explained by the decay of the uctuations of driving the relaxation, not by a complex structure of phase-space. Generalized entropies are not necessary in that case.

¹ If we were to apply T sallis therm odynam ics in the context of violent relaxation, we would need to introduce the negrained distribution of phase levels (;v;) [which is the relevant probability eld in that context] and replace the Lynden-Bell entropy $S_{L:B_{R}}[] =$ ln d dvd (Lynden-Bell 1967) by $S_q[] = \frac{1}{q - 1} (q)$)d dvd as suggested in Brands et al. (1999). In that case, S_{g} [] can be regarded as a generalized entropy trying to take into account non-ergodicity and lack of com plete m ixing in collisionless system s with long-range interactions. In that point of view, the parameter q measures the e ciency of mixing (q = 1 if the system mixes well which is im plicitly assumed in Lynden-Bell's statistical theory). In the two-levels approximation f 2 f0;1g and in the dilute limit f 1, S_q [] can be expressed as a_R functional of the coarsegrained distribution function f d = of the form $S_q[\overline{f}] = \frac{1}{q-1} (\overline{f}^q)$ f)d dv. In this sense, polytropic laws are stable laws since they keep the same structure as we pass from phase space f = f () to physical space = () as noticed in Chavanis (2004d). This is probably the only distribution en pying this property. Sim ilarly, com paring (142)-(7) and (148) the \free energy" in phase space F [f] = E [f] T_0S_q [f] (where $T_0 = 1$ =) becomes F [] = E [] K S [] in physical space. M orphologically, the polytropic tem perature K plays the same role in physical space as the tem perature $T_0 = 1$ = in phase space.



We also emphasize that, using the criterion (115) we have obtained the condition of nonlinear dynam ical instability (156) for stellar polytropes with almost no calculation. Of course, the same result can be obtained from the criterion (116) by explicitly performing the integral. The criterion of nonlinear dynam ical stability (115) that we have found is simpler, albeit equivalent. Moreover, it has a more physical interpretation since it is expressed as a condition on the velocity of sound in a gas with the sam e density distribution as the original kinetic system.





There are di erent m ethods to obtain a kinetic equation for the distribution function f (;v;t). One possibility is to start from the N-body Liouville equation and use projection operator technics. This method has been followed by K andrup (1981) for stellar systems and by Chavanis (2001) for the point vortex gas. We shall rst consider an application of this theory to the HMF model (Chavanis 2003b). In the large N lim it and neglecting collective effects, the projection operator form alism leads to a kinetic equation of the form

Unfortunately, Eq. (168) remains too complicated for practical purposes and we will have to make simplications. If we consider a spatialy hom ogeneous system for which the distribution function f = f(v;t) depends only on the velocity, and if we implement a Markovian approximation, the foregoing equation reduces to

This equation can be considered as the counterpart of the Landau equation describing the \collisional" evolution of stellar system s such as globular clusters (in that case, the system is not hom ogeneous but the collision term is often calculated by making a local approximation). The Landau collision term can also be obtained from the BBGKY hierarchy at the order O (1=N) by neglecting the cumulant of the three-body distribution function of order 1=N 2 (see Chavanis 2004b). For the HMF model, and for one dimensional systems in general, we nd that the Landau collision term vanishes. This is because the di usion term (rst term in the r.h.s.) is equally balanced by the friction term (second term in the r.h.s.). A similar cancellation of the collision term at order 1=N is found in the case of 2D point vortices when the pro le of angular velocity is monotonic (Dubin & O'Neil 1988, Chavanis 2001, Dubin 2003). Therefore, after a phase of violent relaxation, the system can remain frozen in a stationary solution of the V lasov equation for a very long time, larger than N $t_{\mbox{\tiny D}}$. Only non-trivial three-body correlations can induce further evolution of the system . How ever, their e ect is di cult to estim ate. Note that the collision term of order 1=N m ay not cancelout in the case of inhom ogeneous system s and for the multi-species HMF model (see Sec. 7).

5.2 The evolution of a test particle in a therm albath: the Fokker-P lanck equation

Equations (168) and (169) can also be used to describe the evolution of the distribution function P (v;t) of a test particle evolving in a bath of eld particles with static distribution function $f_1(v_1)$. In that case, we have to consider that the distribution function of the bath is given, i.e. $f_1 = f_0(v_1)$. The evolution of P (v;t) is then governed by the equation

as in the theory of B row nian motion (R isken 1989). We note in particular that the friction coe cient is given by the E instein formula = D. However, in the present context, the di usion coe cient depends on the velocity and, in the ballistic approach that we have considered, is given by

5.3 Collective e ects: the Lenard-Balescu equation

The kinetic theory developed previously (Chavanis 2003b), while useful as a rst step, is how ever inaccurate because it is based on a ballistic approximation and ignores collective e ects which are non-negligible for the HMF model close to the critical tem perature (Bouchet 2004). In the case of 3D stellar systems, collective e ects have only a weak in uence on the kinetic theory and they are often neglected. This implicitly assumes that the size of the system is smaller than the Jeans length (recall that the Jeans length plays the role of the critical temperature in the present context). In general, collective e ects can be taken into account by developing a kinetic theory as in the case ofplasm as (Ichim aru 1973). Noting that the HMF m odel is the one Fourierm ode of a one dim ensional plasm a, Inagaki (1996) proposed to describe the collisional evolution of the system by the corresponding form of the Lenard-Balescu equation. It can be written




Fig. 15. Dependence of the diusion coecient D (v) on the velocity v for dierent values of the inverse temperature = c. The normalization constant is $D_0 = \frac{nk^2}{4} (=2)^{1-2}$ corresponding to D (0) for = 0.W enote that D (0) increases as increases and that it diverges at the critical point = 1.







(185) for v ! +1 and tends to $\frac{k^2}{4}$ (=2)¹⁼²=(1 $\frac{2}{7}$ for v ! 0 and < 1. At the critical temperature = 1 it diverges as D (v) $\frac{k^2}{2}$ (=2)¹⁼²=(v²) for v ! 0. Its behaviour is represented in Fig. 15.

The expression (190) of the di usion coe cient was obtained by Bouchet (2004) in a di erent manner, by analyzing the stochastic process of equilibrium uctuations. This approach was then generalized to an arbitrary distribution function by Bouchet & Dauxois (2004), leading to equation (189). In fact, form ulae (189) and (190) correspond to the one dimensional version of the di usion coefcient computed in plasm a physics (Ichim anu 1973) when the potential of interaction is truncated to one Fourier mode. The general expression of the di usion coe cient and of the Fokker-P lanck equation is given in Chavanis

(2004b) for an arbitrary potential of interaction in D dimensions.

We emphasize that the previous results are valid for an arbitrary distribution function f_0 (v) of the bath provided that it is stable with respect to the V lasov equation. This is because, as we shall see, the relaxation time of the \ eld particles" (bath) towards statistical equilibrium (M axwellian) is longer than the relaxation time of a \test particle" towards f_0 , so that the distribution function f_0 of the bath can be considered as \frozen". The general expression of the di usion coe cient can be written

(153) where and T are uniform). A nother example is provided by the water-bag m odel for which an explicit expression of D (v) can be given. U sing Eqs. (164), (165) and (166), it can be written conveniently as

The di usion coe – cient diverges when the velocity of the particle v is in phase with the frequency < v₀ of the wave arising from the slightly perturbed distribution of edd particles (see Sec. 4.7.3). This divergence occurs because, for the water bag distribution, there exists purely oscillatory modes for a wide range of tem peratures. In general, the di usion coe cient (189) diverges only at the critical point for v = $!_r$ with $f^0(!_r) = 0$; this precisely correspond to the criterion of marginal stability (120). For example, for the gaussian distribution, we recover the divergence at T = T_c for v = $!_r = 0$.

5.4 The auto-correlation function

We note that for high temperatures (i.e., ! 0), Eq. (190) reduces to the expression (185) found in the ballistic approach developed in Sec. 5.2. This is because, in that lim it, collective e ects are weak with respect to the pure ballistic motion and ' 1 according to Eq. (128). How ever, the behaviour of the correlation function is di erent. Indeed, a direct analysis (C havanis 2004b) shows that the tem poral auto-correlation function of the force is given by

The exponential decay of the correlation function corresponds to the M arkovian lim it of the stochastic process, thereby justifying the M arkovian approximation in the kinetic theory. This is quite dierent from the correlations of the gravitational force which decay as t⁻¹ (C handrasekhar 1944). This slow decay may throw doubts on the validity of the ordinary Landau equation, based on a M arkovian approximation, used to describe stellar systems (see K andrup 1981 for a detailed discussion). For the HM F m odel, the decay exponent () depends on the temperature. It diverges like $2T \ln T$ as T ! +1. This is why the correlation function is gaussian in the treatem ent neglecting collective e ects (see Sec. 5.2). On the other hand,

 $(8\text{=}kM~\text{j}^{=2}$ (T $~T_c)$ as T $!~T_c^+$, so that the correlation function decreases very slow ly close to the critical tem perature. This may invalidate the M arkovian approximation close to the critical point. The Fokker-P lanck equation (184) with the di usion coe cient (190) has been recently investigated by B ouchet & D auxois (2004). In this paper, using the rapid decay for large v of the di usion coe – cient (190), the num erically observed (Yam aguchi 2003, P luchino et al 2004) anom alous algebraic decay of the velocity autocorrelation function is explained and algebraic exponents are explicitly com puted. For a large class of bath distribution function f_0 , thism ay also lead to anom alous di usion of angles .

5.5 The relaxation timescale

Let us consider the relaxation of a test particle in a thermalbath.Due to the rapid decrease of D (v) for large v, the spectrum of the Fokker-Planck equation (184) has no gap, and it exists no exponential relaxation time (see Bouchet & Dauxois 2004 for a detailed discussion). A time scale will how ever describe relative relaxation speeds for di erent values of the tem perature T.W e shall obtain an estimate of this time scale. Ignoring collective e ects in a rst step, this process is described by Eqs. (184)-(185). If the di usion coe cient were constant, we would deduce that the dispersion of the particles increases as h(v) $^{2}i = 2Dt$. Introducing the rm s velocity $v_m = hv^2 i^{1-2}$, we dene the relaxation timescale t_r such that h(v)²i = v_m^2 . This leads to $t_r = v_m^2 = 2D$. Since D depends on v, the description of + . However, contrary to the relaxation of a single particle in a therm albath, the relaxation time of the whole system N to because, as we have seen, the collision is not t_{relax} term cancels out at the order 1=N. Therefore, the relaxation time of the whole system is larger than N to . This is consistent with the nding of Yam aquchiet al. (2004) N^{1:7}to. who num erically obtain t_{relax}

It is interesting to compare this result with other system swith long-range interactions. For stellar system s, the Chandrasekhar relaxation tim e scales as t_{relax} $\frac{N}{\ln N}$ t_D. It corresponds to the N to scaling polluted by logarithm ic corrections. This is the relaxation time of a test star im mersed in a bath of eld stars as well as the relaxation time of the whole cluster itself (in the absence of gravotherm al catastrophe). For the point vortex gas, the collision term in the kinetic equation cancels out at the order 1=N when the pro le of angular velocity is monotonic. Therefore, the relaxation time of the whole system is larger than N $t_{\rm D}$. In fact, it is not clear whether the point vortex gas ever relaxes tow ards statistical equilibrium (C havan is 2002a, D ubin 2003). By contrast, the relaxation time of a test vortex in a therm albath of eld vortices scales as t_{relax} (Chavanis 2002a).

6 Self-attracting B rownian particles: the BM F m odel

The Ham ilton equations (1) describe an isolated system of particles with long-range interactions. Since energy is conserved, the fundam ental statistical description of the system is based on the microcanonical ensemble. It can be of interest to consider in parallel the case where the system is stochastically forced by an external medium . We thus introduce a system of B rownian particles with long-range interactions which is the canonical version of the H am iltonian system (1). This could be called the BMF (B rownian M ean Field) model. Likewise in the case of 3D N ew tonian interactions, a system of self-gravitating B rownian particles has been recently introduced and studied (see C havanis et al. 2002 and subsequent papers).

6.1 Non-bcalK ram ers and Sm oluchow skiequations

W e consider a one-dimensional system of self-attracting B rownian particles with cosine interaction whose dynam ics is governed by the N -coupled stochastic equations

In the therm odynamic lim it N ! + 1 with = kM = 4 xed, one can prove that the N particules distribution function factorizes and that the m ean- eld approximation is exact (C havanis et al. 2004b, C havanis 2004b). The evolution of the one particle distribution function is then governed by the non-local K ram ers equation

6.2 Linear stability

The stationary solutions of Eq. (212) are given by Eq. (19). They extrem ize the Boltzm ann free energy $F_B = E$ TS_B with (45) and (46) at xed mass and tem perature. Furtherm ore, only stationary solutions that m in im ize the free energy are linearly dynam ically stable with respect to the non-local Sm oluchow ski equation (C havanis 2003c). Therefore, therm odynam ical and dynam ical stability are clearly connected: the stable stationary solutions of Eq. (212) correspond to the canonical statistical equilibrium states in the mean-eld approximation.




Fig. 18. Eigenvalues of the Sturm -Liouville equation (220).

Starting from a hom ogeneous solution, there is rst a linear growth followed by an exponential relaxation towards the clustered state on a timescale =T. This is illustrated num erically in Fig. 26 and com pared with the time evolution of the non-local Fokker-Planck equation (212). The evolution is of course quite di erent since, as we have seen, the non-localFokker-P lanck equation displays an ex-T) 1 followed by ponential grow th on a timescale $(T_c$ an exponential relaxation on a tim escale (1=2) (T_c T) 1 . These timescales diverge as we approach the critical tem perature T_c while there is no critical tem perature for the local Fokker-Planck equation where B is xed. The numerical solution of Eq. (219) is shown in Fig 19 and the analytical solution (221) in Fig. 20 for two di erent values of








Fig. 21. Characteristics of Eq. (229). For t! +1, all the Fig. 23. Characteristics of the dam ped Euler equation (233) particles converge at = and a D irac peak is form ed.




Fig. 22. Evolution of the density pro le at T = 0 starting from a hom ogeneous distribution.








Fig. 25. For = 2 > 1, the homogeneous solution (disklike) is unstable and the system form s a cluster (bar-like). The evolution is longer than with the local Fokker-P lanck equation represented in Fig. 19 as also shown in the next gure and explained in the text.

equations (204). Despite all the sim pli cations introduced, this model remains a non-trivial and interesting model exhibiting a process of self-organization. In particular, it shows the passage from a hom ogeneous phase (disk-like) to a clustered phase (bar-like) under the in uence of longrange interactions. Interestingly, the large N lim it of this system is exactly described by an explicit kinetic equation (208) reducing to Eq. (212) for large times. By contrast, the kinetic equation describing the evolution of the HMF model (1) towards statistical equilibrium is not known as the collision term cancels out at the order 1=N within the approxim ations usually considered (see Sec. 5).




Fig. 24. Evolution of the density prole according to the non-Fig. 26. Evolution of the different modes a_n (t) for the nonlocal (full lines) and local (dashed lines) Fokker-Planck equations. The control parameters are = 2, x = 3:33.

7 The multi-species HMF model

We nally brie y comment on the generalization of the preceding results to the case of the multi-species HMF model. We thus return to the Hamiltonian equations (1) and account for the possibility of having particles with

di erent m asses. Stellar system s also possess a m ass spectrum, so this generalization has a counterpart in astrophysics.

Considering rst the statistical equilibrium state, a straightforward generalization of the counting analysis of Sec. 2.2 yields

The statistical equilibrium state is obtained by maxim izing the entropy (247) while conserving the total energy E and the mass M_a of each species of particles. This yields

which generalizes Eq. (18). Note that the inverse tem perature is the same for all species in accordance with the theorem of equipartition of energy. This clearly leads to a mass seggregation since the rm s. velocity of species a decreases with the mass: $hv^2 i_a = T = m_a$. More precisely, Eq. (249) in plies

where C_{ab} is a constant. Therefore, heavy particles will have the tendency to occupy regions of low energy. Recall, by contrast, that there is no mass seggregation in Lynden-Bell's statistical theory of violent relaxation for collisionless systems (see Sec. 4) since the mass of the particles does not appear in the V lasov equation (Lynden-Bell1967). It would be of interest to study these problem s of mass seggregation with the HMF m odel for which numerical simulations are simpler than with gravitational system s.

Considering now the collisional relaxation, a straightforward generalization of the Lenard-Balescu equation to a multi-species system yields

We now see that the collision term does not vanish anymore when there are at least two di erent species. The di usion and the friction experienced by a particle of one species are caused by collisions with particles of another species. Equation (251) can be rewritten in the suggestive form

These results are similar to those obtained by Dubin (2003) for the multi-components point vortex gas in two dimensions.W hen the pro le of angular velocity is non-m onotonic, the vorticity pro le evolves under the e ect of long-range collisions caused by a process of resonance (D ub in & O 'N eil 1988, Chavanis 2002). When the prole of angular velocity is monotonic, there is no evolution for the single-species system . An evolution is, how ever, possible for the distribution function of each species in the multi-components system . In a sense, at the order 1=N , the kinetic theory of the point vortex gas (evolution of the single-species system when the angular velocity pro le is non-monotonic) is interm ediate between the kinetic theory of stellar system s (evolution of the single-species system in any case) and the kinetic theory of the HMF model (no evolution of the single-species system).

Therefore, the results of D ubin (2003) can be directly transposed to the present context. In particular, we note that the total distribution function $_{a} f_{a} (v;t) = f (v)$ is stationary so that the conservation of energy is trivially satis ed. 0 n the other hand, a H -theorem can be proved for the entropy (247), i.e. S- 0. The equality S- = 0 corresponds to vanishing currents

We can use these results to study the relaxation of a test particle of mass m in a bath of eld particles with mass mf. Neglecting collective e ects for simplicity, we nd that the equivalent of the Fokker-Planck equation (184) is now

8 Conclusion

In this paper, we have given an exhaustive description of the HMF model that recently appeared in statistical m echanics as a simple m odel with long-range interactions sim ilar to self-gravitating system s. The originality of our approach is to o er an overview of the subject and to see how di erent models (Hamiltonian, Brownian, uids,...) are related to each other. Other studies concentrate in generalon a specic aspect of the problem .We think that putting all the models in parallel is illum inating because they are closely connected to each other so that a uni ed (and aesthetic) description can be given. These connections were previously noted by one of us (PHC) in the case of 3D self-gravitating systems and it was natural to extend these results to the HMF model. A more general approach is given in Chavanis (2004b) for an arbitrary potential of interaction in D dimensions. The present paper can be seen as a particular application of this general formalism for a one dimensional potential truncated to one m ode. Them ain interest of the HMF m odel in this context is to yield simple explicit results.

A nother originality of our approach is to emphasize the connection between the HMF model and self-gravitating system s (and 2D vortices) although this link is only sketched in other papers, except in the early work of Inagaki. M any concepts and technics that are well-known in astrophysics have been rediscovered for the HMF model, sometimes with a di erent point of view. This is true in particular for the notion of violent relaxation and m etaequilibrium states. In statistical mechanics, this has been approached via a notion of \generalized therm odynam ics" (T sallis 1988) although it was understood early in astrophysics (Lynden-Bell 1967, Trem aine et al. 1986) that these m etaequilibrium states correspond to particular stationary solutions of the Vlasov equations on a coarsegrained scale (Chavaniset al. 1996, Chavanis 2003a). Thus, our dynam ical interpretation of T sallis functional as a particular H-function di ers from the therm odynam ical interpretation given by Boghosian (1996), Latora et al. (2002) and Taruya & Sakagam i (2003).

Concerning the interest of the HMF model for astrophysicists, we have shown that it exhibits the same types of behaviors as 3D self-gravitating systems while being much simpler to study because it is one dimensional and avoids complicated problems posed by the divergence of the gravitational potential at short distances and the absence of a large-scale con nem ent. Thus, it distinguishes what is common to long-range interactions and what is speci c to gravity. This comparative study should bring new light in the statistical mechanics of self-gravitating system swhich has long been a controversial subject. O ther simplied models of gravity have been introduced such as the parallel planar sheets of Camm (1950), the concentric spherical shells of Henon (1971) or the toy models of Lynden-Bell & Lynden-Bell (1977) and Padm anabhan (1990). These toy models have often allowed advances in the description of more realistic self-gravitating systems that are di cult to study in full detail. We think that,

sim ilarly, the HMF model should nd its place in the astrophysical literature.

Another interest of the HMF m odel is to allow to study in great detail what happens close to the critical point. In the HMF model, the potential is truncated to one mode n = 1 and there exists a critical tem perature $T_c = kM = 4$ below which the uniform phase is unstable. For in nite hom ogeneous self-gravitating systems, there is a continuous spectrum of modes but there exists a critical wavelength $_{J} = (T = Gm)^{1=2}$ (depending on the temperature) above which the system is unstable. A Iternatively, if we x the size of the system (for example by placing it in a box of radius R), the maximum wavelength is R and the Jeans instability criterion now determines a critical tem perature T_c GmM = (R) below which the system becomes unstable (we have used J = R and $M = R^3$). In fact, in the case of box-con ned gravitational system s, wemust consider that the gaseous phase is inhom ogeneous and use a m ore precise stability analysis (C havan is 2002b) yielding $T_c = GmM = (2.52R)$. These remarks show that the critical tem perature in the HMF model plays exactly the same role as the critical tem perature in nite isotherm alspheres.Now, in the fram ework of the HMF m odel, it is possible to study how the mean-eld results are altered close to the critical point due to collective e ects. This is more complicated for self-gravitating systems because they are inhom ogeneous. How ever, on a qualitative point of view, we expect sim ilar results: divergence of the twopoint correlation function like in Eq. (61), divergence of the force auto-correlation function like in Eq. (64), alteration of the di usion coe cient and increase of the relaxation time like in Eq. (190), increase of the decorrelation time like in Eq. (197) ... These problems are di cult to study for self-gravitating system s but they are of considerable in portance. They have never been discussed in detail. because it is usually implicitly assumed that the system size is much smaller than the Jeans scale (or the temperature much larger than T_c) so that collective e ects are neglected and the dielectric function is approximated as

' 1. The present simpli ed study is a rst step to understand the failure of the mean-eld approximation close to the critical point and it can thus nd important applications in theoretical astrophysics. Note that uctuations in isothermal spheres close to the critical point have been studied by K atz & O kam oto (2000) and C havanis (2005).

F inally, we have given an astrophysical application of the HMF m odel in relation with the formation of bars in spiral galaxies, following the original idea of Pichon and Lynden-Bell. This simple m odel is consistent with the phenom enology of structure formation which results from a competition between long-range interactions (gravity) and thermal motion (velocity dispersion). It is sometimes argued that the moment of inertia ¹ of stellar orbits can be negative (Pichon 1994). In that case, we must consider Eq. (1) with k < 0. This corresponds to the repulsive (anti-ferrom agnetic) HMF m odel. Now, Barre et al. (2002) have observed that this m odel leads to the formation of a bicluster. In the stellar disk analogy, the equivalent of the \bicluster" would be two bars perpendicular to each other. We do not know whether this type of structure is To order 0, we have observed in astrophysics.
