H elical vortex phase in the non-centrosym m etric C eP t_3 Si

We consider the role of magnetic elds on the broken inversion superconductor $C e^{p} t_{3}Si$. We show that upper critical eld for a eld along the c-axis exhibits a much weaker param agnetic e ect than for a eld applied perpendicular to the c-axis. The in-plane param agnetic e ect is strongly reduced by the appearance of helical structure in the order param eter. We nd that to get good agreement between theory and recent experimental measurements of H_{c2} , this helical structure is required. We propose a Josephson junction experiment that can be used to detect this helical order. In particular, we predict that Josephson current will exhibit a magnetic interference pattern for a magnetic eld applied perpendicular to the junction norm al. We also discuss unusual magnetic elects associated with the helical order.

The recently discovered heavy ferm ion superconductor $C \in P t_3 Si^1$ has triggered m any experimental and theoreticalstudies^{2,3,4,5,6,7,8,9}. There are two features which have caused this attention: the absence of inversion sym m etry; and the comparatively high upper criticalm agnetic eld (H_{c2}). Broken inversion symmetry (parity) has a pronounced e ect on the quasiparticle states through the splitting of the two spin degenerate bands. This in uences the superconducting phase, which usually relies on the formation of pairs of electrons in degenerate quasiparticle states with opposite m om entum. The availability of such quasiparticle states is usually quaranteed by time reversal and inversion symmetries $(parity)^{10,11}$. It is relatively easy to rem ove time reversal symmetry, e.g. by a magnetic eld, and the physical consequences of this have been well studied. However, parity is not so straightforwardly manipulated by external elds. Superconductivity in materials without inversion center therefore provides a unique opportunity in this respect.

The large H $_{\rm c2}$ 4T in C eP t₃Si^{1,8} in plies that the Zeem an splitting must be non-negligible below T_c = 0:75K (the estimated paramagnetic limit is at H $_{\rm P}$ 1:2 T). In a magnetic eld, this superconductor has to form C ooper pairs under rather odd circum stances. In particular, it is no longer guaranteed that a state with momentum k at the Ferm i surface has a degenerate partner at k. The state k would rather pair with a degenerate state

k + q and in this way generate an inhom ogeneous superconducting phase. We argue below that recent H_{c2} m easurem ents⁸ suggest that this is the case in CePt₃Si. These m easurem ents show that, while the upper critical

eld is basically isotropic close to T_c , a sm all anisotropy appears at lower temperature⁸ (H $_{\rm C2}^{\rm c}$ =H $_{\rm C2}^{\rm ab}$ = 1:18 at T = 0). The apparent absence of a param agnetic limit in C ePt_3Si can be explained by lack of inversion symmetry even if the pairing has s-w ave symmetry^{2,12,13}. However, these works indicate that suppression of param agnetism is very anisotropic and the application of this theory to C ePt_3Si would indicate no param agnetic suppression for the eld along the c-axis, but a suppression for the eld in-plane (H $_{\rm p}^{\rm ab}$ 1:7T). The relative lack of anisotropy

in the experim ental data is surprising in this context.

In this letter we exam ine the mixed phase close to the upper critical eld. U sing the crystal symmetry of $CePt_3Si$, we show that the high-eld superconducting phase has pronounced di erences for eld-directions paralleland perpendicular to the c-axis. For the eld parallel to the c-axis, the param agnetic limiting is basically absent and the vortex phase is quite conventional. W hile for the perpendicular eld direction, the eld can induce a phase which gives rise to an additional phase factor in the many body wavefunction $e^{iq} R$ with q perpendicular to the applied eld: a helical vortex phase. We also propose a Josephson junction experiment that can be used to detect this helical phase factor and discuss a transverse m agnetization related to the helical phase.

We use the single particle H am iltonian XH₀ = [_{k 0} + g_k + _B H]_{sl0} $C_{ks}^{y} c_{ks^{0}}$ (1)

where $c_{k_s}^{\vee}$ (c_{k_s}) creates (annihilates) an electron with momentum k and spin s. The band energy $_{k} = _{k}$ measured relative to the chemical potential , g_{k} is introduces the antisym metric spin-orbit coupling with as a coupling constant (we set $hg_k^2 i = 1$ where h:i is an average over the Ferm i surface), and $_{\rm B}$ B gives the Zeem an coupling. The crucial term in Eq.1 is g_k which is only permitted when inversion symmetry is broken (g_k satis es $q_k = g_k$ due to tim e reversal sym m etry). This term destroys the usual two-fold spin degeneracy of the bands by splitting the band into two spindependent parts with energies E_{k} = k jg_kj. The spinors are determined by the orientation of the corresponding g_k . The general pairing interaction is

expressed in the usual spin basis. We will work in the large limit so that the pairing problem becomes a real

two-band problem in the diagonal spinor () basis. To

nd the pairing interaction in the basis, we diagonalize the single particle H am iltonian after which the two-band pairing interaction, for H = 0, is written in spinor form as

where = $k \quad k^{\circ}$ and A = (1 $\hat{g}_k \quad \hat{g}_k \circ)$ where we have taken $g_k = jg_k j \sin_k \cos_k ; \sin_k \sin_k ; \cos_k$. Note that even for a spatially isotropic interaction, the two-band solution has both a spin-triplet and a spinsinglet gap function when $\notin 0$ (this is a consequence of the broken parity sym metry¹³). We will consider the lim it >> B H and keep only term sup to order B H = (a good approximation for CePt_3Si). We restrict ourselves to choices of V (k;k⁰) that corresponds to spinsinglet pairing in the = 0 lim it. This restriction allow s us to use Eq. 3, even if H \notin 0, which considerably sim – pli es the notation.

W ith the two band pairing interaction of Eq. 3, the linearized gap equation becomes

The factors \hat{g} in Eq. 3 do not appear because of Pauli exclusion and the assumed singlet form of V (k;k⁰) in the

= 0 limit. We denote the density of states on the two Ferm i surfaces by $N_+ = N \cos^2(=2)$ and $N = N \sin^2(=2)$. We can write (k;q) = (q)f(k), where Eq. 5 in plies that (k;q) + (q) = 0. With (k;q) = (q) and the proper Fourier transform of the gap equation keeping gauge invariance, we not the following equation determ ining the upper critical eld

The upper critical eld H_{c2} is found by expanding (R) = $_{n}a_{n-n}(R)$ ($_{n}(R)$ are the usual Landau levels).

In the following we take a spherical Ferm isurface. For C ePt₃Sithis will not be the case, but the overall geometry of the Ferm isurface does not qualitatively change our results. We also take $g_k = \frac{1}{3=2}(k_y;k_x;0)$ as the lowest order term in k allowed by symmetry and consider the case V $(k;k^0) = V_0$ for isotropic s-wave pairing. Our re-

sults will hold for any pairing sym m etry as the G inzburg Landau (GL) theory discussed later will dem onstrate.




FIG.1: Upper critical elds for CePt₃Siwith elds along the c-axis and in the plane. The actual in-plane H $_{\rm c2}$ will lie between the two extremes shown. The elds of the helical order on H $_{\rm c2}$ can be quite pronounced. These calculations are for $_{\rm M}$ = 3.

For the eld along the c-axis, \hat{g} H = 0 so H_{22} is independent of the Zeem an eld and there is no param – agnetic e ect (note that in principle there can be a param agnetic e ect since there are q_k allowed by symmetry that contain a g_z component⁷, however such terms are expected to be sm all). The solution of the upper critical

eld problem is identical to that carried out by Helfand and W ertham er¹⁴ and is plotted in Fig. 1. However, for elds perpendicular to the c-axis unusual properties occur, which can be best illustrated by a GL theory with free energy density

where $a = a_0 (T_c^0 T), D = (D_x; D_y), n$ is the unit vector

oriented along the c-axis, and $B = r A \cdot Eq.6$ applies

to all possible pairing sym metries with a single com plex order parameter, as discussed also by Sam okhin⁷. The lack of inversion symmetry allows for the existence of the term proportional to (for a discussion of other related term s see Ref. 15). This term induces a spatially modulated solution in a uniform magnetic eld. The GL equation for the order parameter \sim (R) = $e^{iq} R$ (R) in a eld is identical to the zero- GL equation with (R), where

(a m icroscopic expressions for q is given below). Consequently, the upper critical eld solution in the G L lim it is

(R) = $_0$ (R) e^{iq} R. We call this phase the helical vortex phase. The helical order coincides with an increase in the upper critical eld (B = H):

The expression for the supercurrent density is

where J_0 is the usual supercurrent density in the GL limit and $m = \frac{m}{e}n \quad J_0$ is the magnetization due to the

term Eq.6. The usual boundary condition on the order parameter is given by J = 0 through the boundary. The appearance of m in Eq.9 is highly unusual in GL theory and has some consequences that are discussed later. Note that if j j and B are spatially uniform then J = 0 for q given by Eq.7; the helical phase carries no current. The possibility of this helical order has been raised in the context of thin Im or interface superconductivity where the vector potential can be neglected^{16,17,18}. As discussed below, we nd here that it can play a very im portant role in the vortex phase.

The increase in H $_{\rm c2}$ due to the appearance of the helical plays an important role in the m icroscopic theory. Since

for f (k) = 1 this gives $ql_{H} = 0.373 \text{ M} \cos \frac{p}{H = H_{c2}^{0}}$ where $M = \frac{P}{2H} \frac{0}{c_2} = H_P$ is the M aki parameter, H_{c2}^0 is the upper critical eld for $_{\rm B}$ = 0 (this coincides with the H $_{c2}$ for the eld along the c-axis), and H $_{P}$ = = $(_{B}^{P} \overline{2})$. For f (k) = k_{x}^{2} k_{y}^{2} , Eq. 10 gives q_{H}^{2} = 0:418 M $\cos \frac{P}{H=H_{c2}^{0}}$. The enhancement of H_{c2} due to the helical order can be substantial as Fig. 1 show s. Our num erical results show ql_{H} can be larger than one, which in plies that the helical wavelength becom es less than the spacing between vortices. Fig. 1 is for M = 3 which is slightly smaller than M = 3.8 that follows from the m easurem ents of R ef. 8. The helical order changes with varying \cos . For \cos = 0 the density of states are the same on both Ferm i surfaces and no helical order appears (labelled 'in-plane (no helical)' in Fig.1); while for $\cos = 1$, $q_{\rm H}$ is maximum (this corresponds to the curve labelled 'in-plane (helical)' in Fig. 1). For all other possible values of cos , the H_{c2} curve lies between these two extremes. The limit cos = 1 is unlikely since this in plies that the density of states of one of the two bands vanishes. How ever, if the elem ents of the pairing interaction V; in Eq.5 are di erent in magnitude from each other, then a large $q_{\rm H}$ can still arise for $\cos = 0$.

C om paring our result with the H $_{c2}$ -m easurement by Yasuda et al.⁸ for CePt₃Si, we nd that only taking the e ect of the spin-orbit coupling into account would not account for the relatively large value of the in-plane H $_{c2}$ 2.8T) at T = 0. Here, paramagnetic limiting should reduce the value to below 2 T.We can, how ever, explain the increased H $_{c2}$ by including the helicity.

We have also exam ined the behavior of the Abrikosov parameter $_{\rm A}$ = hj (R) $^{\dagger}_{\rm J}$ i=hj (R) $^{\dagger}_{\rm J}$ i² in connection with the possible vortex lattice structures. We nd a possible structural transition from a stretched hexagonal lattice at high temperatures to a stretched square lattice at low temperatures. The origin of this transition is related to the two-dimensional inhom ogeneous state discussed in Refs. 18,19,20. Note that the helical order discussed above is distinct from that discussed in these works. The physics discussed in Refs. 18,19 does not play a signi cant role in CePtsSibecause the value of M is too small. How ever, if M >> 1 then the vortex physics becom es very exotic.




FIG .2: Josephson junction geometry for the observation of a helical phase.

We have not discussed the direct experimental verication of the helical phase. Since helicity of the order parameter is related to its phase, an interference experiment based on the Josephson e ect would provide the most reliable test. Here we propose to consider a Josephson junction between two thin lm superconductors (Fig. 2), one (1) with and the other (2) without inversion symmetry (for C ePt₃Si the c-axis is perpendicular to the lm).

For a magnetic eld applied in the plane of the lm perpendicular to the junction and with the superconductor (2) is oriented so that the helicity q is perpendicular to the eld; we nd this gives rise to an interference e ect analogous to the standard Fraunhofer pattern. For this experiment, the lm must be su ciently thin that the magnetic eld and the magnitude of the order parameter are spatially uniform.

To illustrate this, consider the following free energy of the junction

Setting the junction length equal to 2L, and integrating yields a maximum Josephson current of

This, combined with the result of the microscopic theory near T_c (for an isotropic interaction) that $qL = 2.4 \cos_M H_0 L = 0$ (where $0 = 0.18 v_F = T_c$) demonstrates that the Josephson current will display an interference pattern for a eld perpendicular to the junction. N ote that in the usual case the Fraunhofer pattern would be observed for a magnetic eld perpendicular to the thin

In . Furthermore, for a su ciently large in-plane eld,

so that $jR_j > 1$ (which implies $I_J = 0$), the arguments of Ref. 21 imply that the application of an additional magnetic eld along the surface norm alwill lead to an asymmetric Fraunhofer pattern.

A less direct probe of the helical order is to look for the related transverse magnetization that appears in Eq.9. There are two situations for which this can be observed. The rst is in a thin lm with a supercurrent owing along \hat{x} and a surface norm all along \hat{y} . In this case a magnetization will exist along otin
otin
otin
altothe lm). This situation is a generalization of an experim ent originally proposed by Edelstein²². We estimate jm j = $\frac{3}{4}$ cos n_{s B} v_s=v_F 0:02 G auss assuming $v_s = v_F = 2$ 10⁴, cos = 1 = 3, and $n_s = 1$ 10²⁸ m³. The second is in the vortex lattice phase for a eld applied along the c-axis. In this case, a calculation valid near H_{c2} gives $m = \frac{m}{2}n - J_0$, where J_0 is the usual supercurrent for the Abrikosov vortex lattice. Near the vortex core, m is directed radially outward, perpendicular to the applied eld.

We have considered the role of magnetic elds on the non-centrosymmetric superconductor CePt₃Si. Using a two-band theory with a Rashba spin-orbit interaction, we have shown that the upper critical eld for the eld along the c-axis behaves as if it would in a conventional superconductor independent of the param agnetic (Zeeman) eld. We have further shown that while there is a param agnetic limiting e ect form agnetic elds applied in the basalplane, this e ect can be strongly reduced by the appearance of a helical order. Our theory agrees with the experimental measurements of H_{c2} , despite a relatively strong Zeem an eld, provided this helical order exists. Finally, we have proposed a Josephson junction experim ent that can unam biguously identify the helical order and discussed the appearance of a transverse m agnetization related to the helical order.
