## O rder param eter sym m etries for m agnetic and superconducting instabilities: B ethe-Salpeter analysis of functional renorm alization-group solutions

The Bethe-Salpeter equation is combined with the tem perature-cuto functional renorm alization group approach to analyze the order parameter structure for the leading instabilities of the 2D t-t<sup>0</sup> Hubbard model. We nd signi cant deviations from the conventional s-, p-, or d-wave form s, which is due to the frustration of antiferrom agnetism at small and intermediate t<sup>0</sup>. W ith adding a direct antiferrom agnetic spin-exchange coupling the eigenfunctions in the particle-hole channel have extended s-wave form, while in the particle-particle singlet pairing channel a higher angular momentum component arises besides the standard d<sub>x<sup>2</sup></sub> y<sup>2</sup>-wave component, which attens the angular dependence of the gap. For t<sup>0</sup> closer to t=2 we nd a delicate competition of ferrom agnetism and triplet pairing with a nontrivial pair-wavefunction.

It is by now well established that the superconducting order parameter in high-T<sub>c</sub> compounds is well described by a (cosk<sub>x</sub> cosk<sub>y</sub>)-m om entum dependence: it is largest at the Ferm i surface (FS) points close to (;0) and (0; ) and vanishes at the FS crossings on the Brillouin zone (BZ) diagonals. A couratem easurem ents of the gap function, however, revealed a slight deviation from this  $d_{x^2} = w$  ave m on entum dependence [1], with a atter angular dependence near the nodal points. The sym metry and the details of the momentum dependence of the superconducting order parameter are closely related to the structure of the e ective attractive interaction between the electrons. The precise momentum dependence of the energy gap therefore contains valuable inform ation about the underlying pairing mechanism, for which antiferrom agnetic (AFM) spin uctuations are a viable candidate for cuprates [2{5].

A nother type of unconventional superconductor is the layered nuthenate  $Sr_2RuO_4$  [6], which most likely has triplet pairing with p-wave symmetry [7]. It was proposed that the pairing in this material results from ferrom agnetic (FM) spin uctuations [8,9]. A lthough inelastic neutron scattering has so far been unsuccessful to detect signi cant low-energy FM spin uctuations [10], this idea nds support from the enhanced tendencies towards ferrom agnetism in the electron doped compound  $Sr_2 \times La_xRuO_4$  [11] and in isoelectronic  $Ca_2RuO_4$  under hydrostatic pressure [12].

The important role of AFM and FM uctuations as a possible driving source of singlet and triplet superconductivity, respectively, was emphasized early on in the pioneering work in Refs. [13{15]. Recently, the interplay of antiferrom agnetism and d-wave superconductivity (dSC) and ferrom agnetism and p-wave superconductivity (pSC), respectively, was reconsidered within the t-

t<sup>0</sup> Hubbard m odelusing functional renorm alization-group (fRG) techniques [16{20]. Early versions of fRG [16{18], which used the momentum cuto procedure, were unable to search for ferrom agnetism . This draw back is overcom e in the tem perature-cuto fRG approach (TCRG) [19], which proved successful in describing both, AFM and FM instabilities together with singlet- and triplet superconducting pairing in the weak-coupling t-t<sup>0</sup> H ubbard m odel and its extensions in a broad parameter range [19{21]. In the previous fRG analyses it has been a common practice to assume order parameter structures, which have the form of square lattice basis functions with  $s_{-}$ ,  $p_{-}$  or d-wave symmetry [16{21]. Although it was recognized that in the RG ow of the order parameter susceptibilities also the momentum dependence acquires speci c corrections to their initial form [17,19{22], these corrections were so far not analyzed in detail. Indeed, actual order param eter structures m ay have admixtures of di erent symmetry components, and it is necessary to develop an unbiased m ethod to determ ine their precise m om entum dependence.

In the present paper we use the Bethe-Salpeter equations to extract eigenfunctions and eigenvalues of the e ective interaction in the particle-particle (pp) or the particle-hole (ph) channel { sim ilarly as in previous quantum M onte C arlo studies [23]. Here we consider a com – bination of the Bethe-Salpeter equations and the fRG approach. We choose the T C RG version [19] as the m ost suitable tool, because the e ective m odel obtained within this schem e does not contain any unintegrated degrees of freedom even at the interm ediate stages of the RG ow.

W e apply this procedure to identify the order param – eter structure for the leading instabilities of the 2D t-t<sup>0</sup> extended Hubbard model H = H ( $4t^0$ )N with

where  $t_{ij} = t$  for nearest neighbor (nn) sites i and j and  $t_{ij} = t^0$  for next-nn sites ( $t; t^0 > 0$ ) on a square lattice; for convenience we have shifted the chemical potential

by  $4t^0$ . In Eq. (1) we have included a direct nn spin exchange interaction J;  $S_i = c_i^y$   $c_i = 2$ ; and denotes the Pauli matrices. While such an interaction is generated from the on-site C oulomb repulsion at strongcoupling, we add it here as an independent interaction in the weak-coupling regime, where the RG scheme is applicable.

We follow the many-patch fRG version for one-particle irreducible G reen functions as proposed in Ref. [19]. This TCRG scheme uses the temperature as a natural cuto parameter and accounts for excitations with momenta far from and close to the FS, which is necessary for the description of instabilities arising from zero-momentum ph scattering, e.g. ferrom agnetism. Neglecting the frequency dependence of the vertices, which is expected to have m inor relevance in the weak-coupling regime, the RG di erential equation for the interaction vertex has the form [19]

where is a short notation for sum m ations over interm ediate m om enta and spin,

and  $f_T$  (") is the Ferm i function. The upper sign in Eq. (3) is for  $L_{\rm ph}$  and the lower sign for  $L_{\rm pp}$ , respectively. Eq. (2) has to be solved with the initial condition  $V_{T_0}(k_1;k_2;k_3;k_4) = U$ ; the initial tem perature is chosen as large as  $T_0 = 400t$ .

W e discretize the momentum space in N  $_{\rm p}$  = 48 patches using the same patching scheme as in Ref. [19]. This reduces the integro-di erential equations (2) and (4) to a set of 5824 di erential equations, which were solved numerically. The evolution of the vertices with decreasing temperature determines the temperature dependence of the susceptibilities according to [19,24]

m denotes one of the possible channels: ph spin (phs), which traces FM and AFM instabilities, ph charge (phc) for the Pomeranchuk instability (PI) [25] or d-density wave (DDW) [26], or pp for superconducting singlet and triplet instabilities;  $q_m = Q = (;)$  for AFM and DDW and  $q_m = 0$  otherwise. In the following we use the notation m  $q_m$  to denote the speci c channel. The index r in Eq. (4) represents the symmetry of the corresponding channel. The upper signs and pp-indices in Eq. (4) refer to the superconducting instabilities (dSC and pSC), and the lower signs and ph-indices refer to the charge and m agnetic instabilities.

The three-point vertices  $R_k^{m,r}$  can be considered as vertices describing the propagation of the electron in a static external ed; their diagram matic representation is shown in Fig. 1. The initial conditions at  $T_0$  for Eqs. (4) are  $R_k^{m,r} = f_k^{(r)}$  and m,r = 0, where the function  $f_k^{(r)}$  belongs to one of the irreducible representations of the point group of the square lattice (A<sub>1g</sub> or B<sub>1/2g</sub>), e.g.

with a norm alization coe cient A =  $(1=N)^{p}_{k} f_{k}^{2}$ . The momentum dependence of the vertices R<sup>m</sup><sub>k</sub><sup>r</sup> changes during the RG ow and at low temperatures it is expected to reject the momentum dependence of the ground-state order parameter of the selected symmetry. However, these vertex functions depend on the initial choice of the functions  $f_{k}^{(r)}$ , and therefore they can not serve as an unbiased tool to obtain the structure of the ground-state order parameters.

To perform an alternative analysis, which is not based on the know ledge of the wave functions at high tem peratures, we consider the solution of the Bethe-Salpeter equations [23] v

where ph and pp denote irreducible vertices in ph and

pp channels, respectively. Exploiting the connection to reducible vertices, Eqs. (7) can be rewritten as [23]

where lenum erates eigenvalues and -functions for a given channel m. The reducible vertices  $\stackrel{T}{\underset{m}{}}(k;p)$  can be directly extracted from the fRG ow according to Eq. (5).

The value  $_{m\ ;1}$  = 1 corresponds to an ordering instability with the symmetry of the eigenfunction  $_{k}^{m\ ;1}$ . Therefore, tracing the temperature dependence of eigenvalues and -functions allows to identify both, the leading instabilities and their concomitant order parameter structure. We stop the fRG ow at the temperature T\_{X}, where the maximum interaction vertex  $V_{m\ ax}$  maxfV  $(k_{1};k_{2};k_{3};k_{4})g$  reaches the value 20t.  $T_{X}$  should be understood as a crossover temperature into a renormalized classical regime with exponentially large correlation length [21], we have veriled that the following results for the eigenfunctions are only weakly dependent on the choice of  $T_{X}$ .

Eigenfunctions and eigenvalues of the Bethe-Salpeter equations provide more detailed information than can be obtained from the momentum dependence of the three-point vertices  $R_k^{m,r}$ , which determine the order-parameter susceptibilities according to Eq. (4). Unlike the vertices  $R_k^{m,r}$ , the solutions of the Bethe-Salpeter equations do not depend on the initial choice of the functions  $f_k^{(r)}$  and, therefore, do not require a priori the know ledge of the symmetry of the leading instability.

The three-point vertices

described by the diagram of Fig. 1 can be obtained directly from the solutions of the Bethe-Salpeter equations. Expanding the functions  $f_k^{(r)}$  in terms of eigenfunctions of the Bethe-Salpeter equation and using Eqs. (8), we obtain

The vertices  $\mathbb{R}_{k}^{m,r}$  found in this way, however, do not necessarily coincide with those obtained directly from the RG procedure, Eq. (4), because generally the one-loop approximation does not exactly reproduce the solution of the corresponding Bethe-Salpeter equation. The only case when the three-point vertices  $\mathbb{R}_{k}^{m,r}$  and  $\mathbb{R}_{k}^{m,r}$  coincide is the ladder approximation when either only the pp-channel or one of the ph-channels in Eq. (2) is retained. N evertheless, as we will see below, the results for the vertex  $\mathbb{R}_{k}^{m,r}$  from Eqs. (4) are qualitatively sim ilar to those found from Eq. (10).

It is clearly established from Eq. (10) that  $\mathbb{R}_{k}^{m,r}$  (and similarly  $\mathbb{R}_{k}^{m,r}$ ) is actually a mixture of dimensional event

eigenfunctions  ${}_{k}^{m;l}$ , whose weights are proportional to  $l=(1 \ m;l)$  with coe cients determ ined by the overlap of the eigenfunction with  $f_{k^0}^{(r)}$ . If one of the eigenvalues  ${}_{m;l}$  is much closer to unity than all the others, the corresponding term in the sum over l in Eq. (10) is expected to dom inate and  $\Re_{k}^{m;r}$  essentially coincides with the corresponding eigenfunction  ${}_{k}^{m;l}$ .

Below we discuss the results of the num erical solution of the Bethe-Salpeter equations and com pare them to the results for the three point vertices  $R_k^{m,r}$  for di erent param eter regimes. We start in Fig. 2 with results at the van Hove (vH) band lling ( = 0) for small f = 0:1t, J = 0, and U = 2t. The AFM phsQ instability has the largest eigenvalue at  $T_X$  in agreem ent with previous fRG work based on the analysis of order parameter susceptibilities [19]. The corresponding eigenfunction (Fig. 2c) has a slight variation around the FS with an enhancem ent near (;0) and (0; ), which most likely originates from the vH singularity nature of these points. The eigenfunctions in the subleading phc0 and pp0 channels are sizable near (;0) and (0; ;) only. Although the eigenvalue of the zero-m om entum ph instability in the charge channel (phc0) is relatively sm all at  $T = T_X$  ( ' 0:5), it rapidly increases at low tem peratures. The corresponding eigenfunction (Fig. 2d) is antisymmetric with respect to 90 rotation, thus providing the possibility for the Pomeranchuk instability with a spontaneous d-wave like deformation of the FS [27,28]. The eigenvalues for the PI at  $t^0 = 0.1t$  are larger than those at  $t^0 = 0$  (not shown),

which supports the conclusion of Ref. [28], that a nite value of  $t^0$  at vH band llings enhances the tendency to-wards a Pom eranchuk instability.

The momentum dependence of the three-point vertices R $_k^{m\,;r}$  is qualitatively similar to the leading eigenfunctions in the pp0 and phsQ channels, however with a smaller variation around the FS. In the phcO channel we observe a stronger di erence of the vertex  $R_k^{phc;d-w\,ave}$ , which has almost the  $d_{x^2\ y^2}$ -wave form, from the corresponding eigenfunction of the Bethe-Salpeter equation.

To investigate the role of t<sup>0</sup>-induced frustration of antiferrom agnetism, we turn on a sm all direct exchange interaction J = 0.3t to strengthen the AFM correlations, and decrease simultaneously the value of U to 1:5t in order to rem ain in the weak-coupling regime. Fig. 3 shows the resulting changes. At nite J the eigenfunctions in the pp0 and phc0 channels are essentially nonzero all around the FS, how ever they are atter than the  $d_{2} \sqrt{2}$  wave function. The eigenfunction in the phsQ channel is of extended swave form. The eigenvalue for the phc0 channel is smaller than at J = 0, implying that stronger antiferrom agnetism weakens the tendency towards a Pom eranchuk instability. Sim ilarly to the J = 0case, we observe a smaller variation of the vertices  $R_{k}^{m,r}$ around the FS, than in the momentum dependence of the corresponding eigenfunctions of the Bethe-Salpeter equation.

W ith increasing  $t^0$  to 0.3t (Fig. 4) the largest eigenvalue occurs in the singlet dSC channel. The pp0 pair wavefunction maintains its shape with a slight deviation from the  $(\cos k_x \quad \cos k_y)$ -form, i.e. a attening near the BZ diagonal. In the phsQ and phc0 channels we observe again a weaker momentum variation of  $R_{\mu}^{\mu}$ . The ver-

tex  $R_k^{pp0,dwave}$  instead is very close to the shape of the corresponding Bethe-Salpeter eigenfunctions in the pp0 channel.

For  $t^0 = 0.45t$  a ferrom agnetic instability is expected [19,20], and we start again with the vH band lling case for = 0. We increase the interaction strength to U = 3t, since the corresponding crossover temperatures for the FM instability are lower. The largest Bethe-Salpeter eigenvalues arise in the FM (phs0), pSC (pp0 triplet) and AFM channels (phsQ). Remarkably, the wavefunction in the triplet pp0 channel deviates signi cantly from the sin  $k_x$  form (see Fig. 5b), but its eigenvalue remains sm aller than the eigenvalue for ferrom agnetism. This deviation is also well reproduced by the corresponding momentum dependence of the vertex R  $_{k}^{pp0,p-wave}$ .

On moving away from the vH band lling at f = 0.45t, we observe a further increase of the eigenvalue in the triplet pairing channel (Fig. 6), which how ever rem ains smaller than the eigenvalue of the ferrom agnetic instability at the lowest temperature we can safely reach in the fRG ow. Simultaneously, the eigenfunction in the triplet superconducting channel slightly distorts tow ards the wave function  $f_k^{(p-wave)}$ , but strong deviations persist in both, the eigenfunction of the Bethe-Salpeter equation and the vertex R  $_{k}^{pp0,p-wave}$ . Singlet superconductivity, which was not among the dom inant instabilities at = 0, is also signi cantly enhanced for > 0. There are two eigenfunctions, which are symmetric and antisymmetric with respect to re ection at the BZ diagonalwith alm ost equal eigenvalues in the pp singlet channel. B oth eigenfunctions are essentially nonzero at (;0) and (0, ) only, and therefore not expected to be stabilized therm odynam ically. Because of the presence of two

nearly-degenerate eigenfunctions, the three-point vertex R  $_k^{\rm pp0;d-w\,ave}$  in this case substantially deviates from the momentum dependence of the leading eigenfunction.

In conclusion, we have investigated the symmetry of the leading instabilities of the 2D t-t<sup>0</sup> Hubbard m odelusing as a novel tool the com bination of the Bethe-Salpeter equation and the fRG approach. A though in most cases the leading instabilities coincide with those from susceptibility based analyses, the true shape of the eigenfunctions signi cantly di ers from the s-, p- or d-wave basis functions. At small t<sup>0</sup> we nd in particular a attening of the eigenfunction in the pairing pp0 channel near the nodes { in qualitative agreem ent with experim ental data for cuprates [1]. The addition of a direct spin exchange interaction to the Hubbard model at weak-coupling was essential to reproduce a  $(\cos k_x - \cos k_y)$ -like form of the superconducting gap at low and intermediate  $t^0$ . The instability towards triplet pairing at larger t<sup>0</sup> also shows a substantial deviation from the standard p-wave  $\sin k_x$ form. In many cases we have investigated, the eigenfunctions of the Bethe-Salpeter equations strongly deviate from the corresponding three-point vertices  $R_k^{m,r}$ which enter the order parameter susceptibilities, due to either a qualitative di erence of the eigenfunctions from the basis functions  $f_k^{(s;p;d)-wave}$ or the presence of severalalm ost degenerate eigenfunctions. The proposed new technique m ay provem ost useful in future studies ofm agnetic and superconducting instabilities without presupposing a special momentum dependence of the candidate order param eters.
