A model of phase uctuations in a lattice d-wave superconductor: application to the C ooper pair charge-density-wave in underdoped cuprates

We introduce and study an XY -type m odel of therm aland quantum phase uctuations in a twodimensional correlated lattice d-wave superconductor based on the QED 3 e ective theory of high tem perature superconductors. General features of and selected results obtained within this model were reported earlier in an abbreviated form at (Z. Te sanovic, cond-m at/0405235). The model is geared toward describing not only the long distance but also the interm ediate lengthscale physics of underdoped cuprates. In particular, we elucidate the dynam ical origin and investigate speci c features of the charge-density-wave of C ooper pairs, which we argue is the state behind the periodic charge density modulation discovered in recent scanning-tunneling-microscopy experiments. We illustrate how M ott-H ubbard correlations near half- lling suppress super uid density and favor an in compressible state which breaks translational symmetry of the underlying atom ic lattice. We show how the form ation of the Cooper pair charge-density-wave in such a strongly quantum uctuating superconductor can naturally be understood as an Abrikosov-Hofstadter problem in a type-II dual superconductor, with the role of the dualm agnetic eld played by the electron density. The resulting A brikosov lattice of dual vortices translates into the periodic m odulation of the B ogoliubov-deG ennes gap function and the electronic density. We num erically study the energetics of various A brikosov-Hofstadter dual vortex arrays and compute their detailed signatures in the single-particle local tunneling density of states. A 4 4 checkerboard-type modulation pattern naturally arises as an energetically favored ground state at and near the x = 1=8 doping and produces the local density of states in good agreem ent with experim ental observations.

I. IN TRODUCTION

Several recent experim ents^{1,2,3} support the proposal that the pseudogap state in underdoped cuprates should be viewed as a phase-disordered superconductor⁴. The e ective theory based on this view point was derived in Ref. 5: 0 ne starts with the observation⁶ that in a phase uctuating cuprate superconductor the Cooper pairing amplitude is large and robust, resulting in a short cok¹ and sm all, tight cores for singly herence length quantized (anti)vortices. As a result, the phase uctuations are greatly enhanced, with hc=2e vortex and antivortex excitations, their cores containing hardly any electrons, quantum tunneling from place to place with the greatest of ease, scram bling o -diagonal order in the process { incidentally, this is the obvious interpretation of the Nemst e ect experiments². Simultaneously, the largely inert pairing amplitude takes on a dual responsibility of suppressing multiply quantized (anti)vortices, which require larger cores and cost m ore kinetic energy, while continuously maintaining the pseudogap e ect in the single electron excitation spectrum. The theory of Ref. 5 uses this large d-wave pairing pseudogap to set the stage upon which the low -energy degrees of freedom, identi ed as electrons organized into Cooper pairs and BdG nodal ferm ions, and uctuating hc=2e vortexantivortex pairs, mutually interact via two em ergent noncom pact U (1) gauge elds, v and a . v and a couple to

electronic charge and spin degrees of freedom, respectively, and m ediate interactions which are responsible for the three m a jor phases of the theory^{5,7}: A d-w ave superconductor, an insulating spin-density wave (SDW, which at half-lling turns into a M ott-H ubbard-N eel antiferrom agnet), and an interm ediate \algebraic Ferm i liquid", a non-Ferm i liquid phase characterized by critical, powerlaw correlations of nodal ferm ions.

In the context of the above physical picture, the recent discovery in scanning tunneling m icroscopy (STM) experiments^{8,9,10} of the *lectron* crystal", manifested by a periodic modulation of the local density of states (DOS), and the subsequent insightful theoretical analysis¹¹ of thism odulation in term softhe pair densitywave, com es not entirely unexpected. Such m odulation originates from the charge Berry phase term involving $v_0^{5,12}$, the time-like component of v, and the longdistance physics behind it bears some resemblance to that of the elementary bosons, like 4 He (Ref. 13). As the quantum phase uctuations become very strong, they occasion a suppression of the com pressibility of the underlying electron system, via the phase-particle num ber uncertainty relation ' N > 1, whose e ective theory manifestation is precisely the above charge Berry phase. Once the o -diagonal order disappears, the system inevitably tums incompressible and the diagonal positional order sets in, leading to a M ott insulating state. The resulting charge-density-wave of Cooper pairs (CPCDW)¹² causes a periodic m odulation of the electron density and the size

of the pseudogap and induces a similarly modulated local tunneling DOS. In this context, the observed <code>\electron crystal"</code> state⁹ should be identified as a CPCDW.

W hile the above CPCDW scenario is almost certainly qualitatively correct, the ultim ate test of the theory is whether it can explain and predict some of the speci c details of the modulation patterns as they are actually observed in cuprates. This brings us to the main them e of this paper. Typically, when constructing an e ective low energy theory of a condensed matter system, we are solely concerned with the long distance, low energy behavior. In the present case, how ever, this will not su ce. Them odulation in question is associated with length and energy scales which are interm ediate, between the short distance scale physics of a single lattice spacing and the ultimate long distance behavior. Our aim should thus be to construct a description which will be valid not only over very long lengthscales but also on the scale of several lattice spacings, which are the periodicities observed in experiments^{8,9,10}. Furthermore, we ideally should be aiming for a \bosonized" version of the theory, within which a mean-eld type approximation for the CPCDW state could be gainfully formulated. A natural question that needs to be answered rst is what should be the objects that play the role of these bosons?

One choice is to designate real-space pairs of electrons (or holes) as such \elementary" bosons and to endow them with some \manageable", i.e. pairwise and short-ranged, e ective interactions. Such a m odel indeed generically leads to a phase diagram with compressible super uid and incom pressible W igner crystal states just as our long-distance argum ent has suggested. This picture of real-space pairs arises within the SO (5)-based theory^{14,15}, where the low energy sector of the theory assumes the form of hard-core plaquette bosons with nearest and next-nearest neighbor interactions. W hen one is dealing with extrem ely strongly bound real space s-wave or d-wave pairs this is undoubtedly the natural choice. In our view, how ever, in cuprates one is faced not with the real-space pairs but with the momentum space Cooper pairs. Apparently, one encounters here an echo of the great historical debate on B latt-Schafroth versus BCS pairs { while certain long distance features are the same in both limits, many crucial properties are quite di erent¹⁶. To be sure, the Cooper pairs in cuprates are not far from the real-space boundary; the coupling is strong, the BCS coherence length is short, and the uctuations are greatly enhanced. Still, there is a simple litm us test that places cuprates squarely on the BCS side: they are d-wave superconductors with nodal ferm ions.

This being the case, constructing a theory with C ooper pairs as \elementary" bosons turns into a daunting enterprise. C ooper pairs in nodald-wave superconductors are highly non-local objects in the real space, and the e ective theory in terms of their center-of-mass coordinates will re ect this non-locality in an essential way, with com plicated intrinsically multi-body, extended-range interactions. The basic idea behind the QED₃ theory⁵ is that

in these circum stances the role of \elem entary" bosons should be accorded to vortices instead of C ooper pairs. Vortices in cuprates, with their small cores, are simple real space objects and the elective theory of quantum uctuating vortex-antivortex pairs can be written in the form that is local and far simpler to analyze. In this dual language the form ation of the CDW of Cooper pairs translates { via the charge Berry phase discussed above { to the fam iliar A brikosov-H ofstadter problem in a dual superconductor^{12,17}. The solution of this problem intimately rejects the non-local character of Cooper pairs and their interactions, and the specic CPCDW modulation patterns that arise in such theory are generally different from those of a real-space pair density wave. These two lim its, the Cooper versus the real-space pairs, correspond to two di erent regim es of a dual superconductor, rem in iscent of the strongly type-II versus strongly type-I regim es in ordinary superconductors. This di erence is fundam ental and, while both descriptions are legitim ate, only one has a chance of being relevant for cuprates.

A well-inform ed reader will im m ediately protest that the key tenet of the QED₃ theory is that we cannot write down a useful \bosonized" version of the theory at all { the nodal BdG ferm ions in a uctuating d-wave superconductor must be kept as an integral part of the quantum dynam ics in underdoped cuprates. This, while true, mostly rejects the central role of nodal ferm ions in the spin channel. In contrast, the form ation of CPCDW is predom inantly a charge sector a air and there, provided the theory is reexpressed in terms of vortex-antivortex uctuations { i.e. properly \dualized" { the e ect of nodal ferm ions is less singular and de nitely treatable. This gives one hope that a suitably \bosonized" dual version of the charge sector m ight be devised which will provide us with a faithful representation of underdoped cuprates. This is the main task we undertake in this paper.

To this end, following a brief review of the QED₃ theory in Section II, we propose in Section III a simple but realistic XY -type m odel of a therm ally phase- uctuating d-wave superconductor. Starting from this model we derive its e ective C oulom b gas representation in term s of vortex-antivortex pairs. This representation is employed in Section IV to construct an e ective action for quantum uctuations of vortex-antivortex pairs and derive its eld theory representation in term s of a dual type-II superconductor, incorporating the e ect of nodal ferm ions. In Section V, we discuss some general features of this dual type-II superconductor and relate our results to the recent STM experiments^{8,9,10}. This section is written in the style that seeks to elucidate basic concepts at the expense of overbearing m athem atics; we hope the presentation can be followed by a general reader. After this we plunge in Section VI into a detailed study of the dual A brikosov-H ofstadter-like problem which arises in the mean-eld approximation applied to a dual superconductor and which regulates various properties of the CPCDW state. This particular variant of the AbrikosovH ofstadter problem arises from the said charge Berry phase e ect: In the dual representation quantum bosons representing uctuating vortex-antivortex pairs experience an overall dual magnetic eld, generated by C ooper pairs, whose ux perplaquette of the (dual) CuO₂ lattice is set by doping: $f = p=q = (1 \ x)=2$. Finally, a brief sum mary of our results and conclusions are presented in Section V II.

II. BRIEF REVIEW OF THE QED 3 THEORY

The purpose of this section is mainly pedagogical: Before we move on to our main topic, we provide some background on the QED₃ e ective theory of the pairing pseudogap in underdoped cuprates. This will serve to motivate our interest in constructing an XY-type model of uctuating d-wave superconductors and to make a casual reader aware of the connection between the theoretical notions discussed in the rest of this paper and the actual physics of real electrons in CuO₂ planes. The readers well versed in the art of construction of e ective eld theories or those already familiar with the approach of Ref. 5 can safely jump directly to Section III.

The elective theory 5 of a strongly uctuating $d_{x^2\ y^2} - w$ ave superconductor represents the interactions of ferm ions with hc=2e vortex-antivortex excitations in terms of two non-compact emergent gauge elds, v and a^i . The Lagrangian $L=L_{\rm f}+L_0$ is

Its menacing appearance notw ith standing, the physics behind (1) is actually quite clear. In L_f , which is just the electrive d-wave pairing Lagrangian, the original electrons c (x), with the spin quantized along an arbitrary direction f, have been turned into topological fermions = ("; ") through the application of the FT transform ation: ($c_r; c_{\#}$) ! (exp (i'_A) "; exp (i'_B) "), where

 $\exp(i'_{A}(x) + i'_{B}(x))$ equals $\exp(i'(x))$, the center-ofmass uctuating superconducting phase (see Ref. 5 for details). The main purpose of this transformation is to strip the awkward phase factor exp(i' (x)) from the center-of-mass gap function, leaving behind a d-wave pseudogap amplitude and two gauge elds, v and aⁱ, which m in ic the e ects of phase uctuations. The Jacobian given by $L_0[v;a^1]$ (2) insures that the uctuations in continuous elds v and aⁱ faithfully represent con gurations of discrete (anti)vortices. Note that topological ferm ions do not carry a de nite charge and are neutral on the average { they do, however, carry a de nite spin S = $\frac{1}{2}$, re exting the fact that the spin SU (2) symmetry remains intact in a spin-singlet superconductor. As a consequence, the spin density operator $S_z = C_{"}C_{"}$ Q⊧C# = . . # # is an invariant of the FT transform ation.

The two gauge elds, v and aⁱ, are the m ain dynam ical agents of the theory. They describe the interactions of ferm ionic BdG quasiparticles with vortex-antivortex pair excitations in the uctuating superconducting phase '(x). A U(1) gauge eld v is the quantum uctuating super ow and enters the non-conserved charge channel. In the presence of the external electrom agnetic eld A , one has v ! v eA everywhere in L_f (1) (but not in L_0), to maintain the local gauge symmetry of M axwell electrodynamics. The Jacobian L_0 (2) is the exception since it is a purely mathematical object, generated by the change of variables from discrete (anti)vortex coordinates to continuous elds v (and a^i).v appearing in L_0 contains only the vortex part of the super ow and is intrinsically gauge invariant. This point is ofmuch im portance since it is the state of the uctuating (anti)vortices, m an ifested through L_0 [v; a^i], which determ ines the state of our system as a whole, as we will see m om entarily.

By comparison to v, an SU (2) gauge eld a^i is of a more intricate origin. It encodes topological frustration experienced by BdG quasiparticles as they encircle hc=2e vortices; the frustration arises from the 1 phase factors picked up by ferm ions moving through the spacetime led with uctuating vortex-antivortex pairs. These phase factors, unlike those produced by super ow and emulated by v, are insensitive to vorticity and depend only on the spacetime con guration of vortex loops, not on their internal orientation: if we picture a xed set of closed loops in 2+1-dim ensional spacetim e we can change the orientation of any of the loops any which way without a ecting the topological phase factors, although the ones associated with super ow will change dram atically. This crucial symmetry of the original problem dictates the manner in which aⁱ couples to ferm ions in the above e ective theory⁵. Its topological origin is betrayed by its coupling to a conserved quantum number { in spin-singlet superconductors this is a quasiparticle spin { and the absence of direct coupling to the nonconserved charge channel. By strict rules of the e ective theory, such m in im alcoupling to BdG quasiparticles is what endows aⁱ with its ultim ate punch at the low-




FIG.1: The phase diagram of cuprates following from the QED₃ theory. Under the T_{Nemst} dome, the Nemst e ect experiments² indicate strong vortex-antivortex uctuations; this is where the conditions for the applicability of the theory are met. As the doping is reduced, the superconducting ground state is followed by an \algebraic" Ferm i liquid, a non-Ferm i liquid state described by the sym metric phase of QED $_3$ and characterized by critical, power-law correlations²³. At yet lower doping, the BdG chiral sym metry is broken, resulting in an incom m ensurate antiferrom agnet (SDW), which eventually m orphs into the N eelantiferrom agnet at half- lling. D epending on material parameters (anisotropy, strength of residual interactions, degree of interlayer coupling, etc.) of a particu- $\operatorname{lar} \operatorname{H} \operatorname{T} \operatorname{S}$ system , the transition between a superconductor and a SDW could be a direct one, without the intervening chiral sym m etric ground state. The way CPCDW , the m ain subject of this paper, ts into this phase diagram is detailed later in the text.

est energies. W hile in this limit v { which couples to ferm ions in the non-m inimal, non-gauge invariant way { turns massive and ultimately irrelevant, a^i ends up generating the interacting infrared (IR) critical point of QED₃ theory which regulates the low energy ferm iology of the pseudogap state.

L (1) manifestly displays the U (1) charge and SU (2) spin global symmetries, and is useful for general considerations. To perform explicit calculations in the above theory one must face up to a bit of algebra that goes into computing L_0 [v;aⁱ]. The main technical obstacle is provided by two constraints: i) the sources of aⁱ should be an SU (2) gauge equivalent of half- ux D irac strings, and ii) these sources are permanently con ned to the sources of v , which them selves are also half- ux D irac strings. The con ned objects form ed by these two half-string species are nothing but the physical uctuating hc=2e vortex excitations. These constraints are the main source of technical hurdles encountered in trying to reduce (1) to a more manageable form { nevertheless, it is in perative they be carefully enforced lest we lose

the essential physics of the original problem . The constraints can be solved by introducing two dual com plex elds $(x) = j j e^{i}$ and $s(x) = j s j e^{is}$ to provide coherent functional integral representation of the halfstrings corresponding to v and aⁱ, respectively. In this dual language the half-strings are simply the worldlines of dual bosons and $_{\rm s}$ propagating through (2 + 1)dimensional spacetime. It is important to stress that this is just a mathematical tool used to properly couple vortex-antivortex pair uctuations to the electronic degrees of freedom { readers less intim ate with the technology of dualization will nd it explained in detail in the Appendix. Here A_d and ⁱ are the charge and spin dual gauge edds, respectively, having been introduced to enforce the two

At this point, one should take note of the following convenient property of L (1,3), one that will prove handy repeatedly as we go along: A_d and i provide { via the above coupling to v and aⁱ { the only link of communication between the ferm ionic matter Lagrangian L_{f} and the vortex-antivortex state Jacobian L₀. This way of formulating the theory is more than a mere mathematical nicety: It is particularly well-suited for the strongly uctuating superconductor which nonetheless does not belong to the extrem e strongly bound lim it of real-space pairs, when they can be viewed as \elementary" bosons. Such extrem e lim it of \preform ed" pairs orpair \m olecules" is frequently invoked, inappropriately in our view, to describe the cuprates. Were the cuprates in this extreme limit, there would be no gapless nodal quasiparticle excitations, the situation manifestly at odds

with the available experimental information¹⁹. In addition, such dem ise of nodal fermions would rob the e ective low energy theory of any spin degrees of freedom, a most undesirable theoretical feature in the context of all we know about the cuprates.

In a superconductor, the vortex-antivortex pairs are bound and the dual bosons representing vortex loop worldlines are in the \norm al" (i.e., non-super uid state): $h = h_{s} = 0$ (see the Appendix). Consequently, both dual gauge elds are A_d and ⁱ are massless; this is as it should be in the dual norm alstate. This in plies that upon integration over A_d and i both v and a^i will be massive: $L_0 ! M_0^2 v_0^2 + M_2^2 v^2 + (v ! a)$, where M_0^2 / M_2^2 $_{
m d}$, the dual correlation length. As advertised above, the massive character of v immediately makes the system a physical superconductor: If we introduce a static external source vector potential A ex (q), the response to this perturbation is determined by the ferm ionic m ean - eld" stiness originating from L_f and the intrinsic" sti ness set by L₀, whichever is smaller. In a strongly uctuating superconductor this in practice means L_0 . The mass M_2^2 (x;T) of the Doppler gauge eld v in L_0 is electively the helicity modulus of such a superconductor and determ ines its super uid density $_{\rm s},$ reduced far bellow what would follow from L $_{\rm f}$ alone. In a similar vein, the mass M $_0^2$ (x;T) of v_0 sets the com pressibility of the system c, again far smaller than the value for the non-interacting system of electrons at the sam e density:

where E_0 is the ground state energy and $f^{jj}_f(q;x;T)$ and f(q;x;T) are the current-current and density-density responses of the ferm ionic Lagrangian L_f , respectively.

Evidently, the \intrinsic" sti ness of v as it appears in L₀ encodes at the level of the e ective theory the strong M ott-H ubbard short-range correlations which are the root cause of reduced com pressibility and super uid density and enhanced phase uctuations in underdoped cuprates. This is entirely consistent with the spirit of the e ective theory and should be contrasted with the application of a Gutzwiller-type projector to a mean-eld BCS state, to which it is clearly superior: In the latter approach one is suppressing on-site double occupancy by a local projectorm in icking correlations that are already included at the level of the renorm alized \m ean-eld" ferm ionic Lagrangian L_f in (1), i.e. they are built-in into f^{jj} and f (6). In this approach the superconductivity is always present at T = 0 as long as the doping is nite, albeit with a reduced super uid density. In contrast, within the e ective theory (1), the microscopic M ott-H ubbard correlations are additionally echoed

by the appearance of well-de ned vortex-antivortex excitations, whose core size is kept small by a large pairing pseudogap . Such vortex-antivortex excitations further suppress super uid density from its renormalized $\mbox{mean-}$ eld" value and ultimately destroy the o -diagonal long range order (ODLRO) altogether { even at T = 0 and nite doping { all the while remaining sharply de ned with no perceptible reduction in .

As the vortex-antivortex pairs unbind, the superconductivity is replaced by the dual super uid order: h i f 0, h $_{\rm s}$ i \oplus 0, and v and aⁱ turn massless: L $_0$! $c_0 (r v_0)^2 + c (r v_1^2 + (v ! a), where (x; T ! 0) is the$ superconducting correlation length, c_0 and c are num ericalconstants, and we have used radiation gauge r = 0. Physically, the massless character of v and aⁱ describes the admixing of free quantum vortex-antivortex excitations into the ground state of the system which started as a d-wave superconductor. Now, it is clear from Eq. (6) that the response to A ex (q) is entirely determ ined by L₀. Them assless character of v in L₀ in plies the vanishing of the helicity modulus and super uid density, despite the fact that the contribution from Lf to both remains nite and hardly changes through the transition. Sim ilarly, the response to A_0^{ex} (q) vanishes as well, since v_0 is now massless. Thus, the system simultaneously loses super uidity $(_{\rm s}! 0)$ and turns incompressible $(_{\rm c} \quad g \quad jq^2 j! 0)$ for doping sm aller than som e critical x_c .

Note that the theory⁵ predicts a universal relation between the super uid density $_{\rm s}$ and the uctuation diamagnetic susceptibility $_{\rm dia}$ in underdoped cuprates, as T ! 0. Right before the superconductivity disappears, for x > x_c, the discussion surrounding Eq. (6) in plies $_{\rm s}$ M²₂ 1= $_{\rm d}$. Sim ilarly, in the region of strong superconducting uctuations for x < x_c, M²₂ in (6) is replaced by c q² as is clear from the previous paragraph. The prefactor c is nothing but the diamagnetic susceptibility dia c . A ssum ing that the superconducting correlation length and its dual are proportional to each other,

d, one nally obtains dia s^{1} . In the case where strong phase uctuations deviate from \relativistic" behavior, the dynam ical critical exponent $z \notin 1$ needs to be introduced and the above expressions generalized to $s M_{2}^{2} = 1 = \frac{z}{d}$, dia 2 z, and dia $s^{(z-2)=z}$. Experimental observation of such a universal relation between s and dia would provide a powerful evidence for the dom inance of quantum phase uctuations in the pseudogap state of underdoped cuprates.

The non-locality is the penalty we pay for staying faithful to the underlying physics: W hile the topological origin of aⁱ dem ands coupling to the conserved SU (2) spin three-currents, its sources are perm anently con ned to D irac half-strings of the super ow D oppler eld v, which by its very de nition is a noncom pact U (1) gauge eld (see below). The manifestly SU (2) invariant form (1) subjected to these constraints is therefore even m ore elegant than it is useful.

The situation, however, can be remedied entirely by a judicious choice of gauge: $a^1 = a^2 = 0$, $a^3 = a$. In this \spin-axial" gauge { which amounts to selecting a xed (but arbitrary) spin quantization axis { the integration over $_i$ can be performed and L_0^a (7) reduces to a simple local M axwellian:

where is the dual order parameter of the pseudogap state, i.e. the condensate of loops formed by vortexantivortex creation and annihilation processes in (2+1)dimensional Euclidean spacetime. This is the quantum version of the K osterlitz-T houless unbound vortexantivortex pairs and is discussed in detail in the Appendix. The elective Lagrangian $L = L_f + L_0 [v;a]$ of the quantum uctuating d-wave superconductor nally takes the form :

The above is just the standard form of the QED₃ theory discussed earlier⁵. It resurfaces here as a particular gauge edition of a more symmetric, but also far more cumbersome description { fortunately, in contrast to its high symmetry parent, the Lagrangian (9) itself is eminently treatable²⁰.

A com m itted reader should note that the ultim ate noncom pact U (1) gauge theory form of L (9) arises as a natural consequence of the constraints described above. O noe the sources of v and a are con ned into physical hc=2e vortices, the non-com pact U (1) character is the shared fate for both. W hile we do have the choice of selecting the singular gauge in which to represent the Berry gauge eld a, there is no sim ilar choice for v, which m ust be a noncom pact U (1) gauge eld. It is then only natural to use the FT gauge and represent a as a non-com pact U (1) eld as well, in order to straightforw ardly enforce the con nem ent of their respective sources²¹. The non-com pactness in this context re ects nothing but an elem entary property of a phase- uctuating superconductor: The conservation of a topological vortex charge ($n = 0 = (e_{A}, p)^{22}$.

W e end this section with the following remarks: In explicit calculations with (9) or its lattice equivalent, it is often useful to separate the low energy nodal BdG quasiparticle excitations from the rest of the electronic degrees of freedom by linearizing ${\rm L}_{\rm f}$ near the nodes. The nodal ferm ions ;, where = 1, 1, 2 and 2 is a node index, can then be arranged into N four-component BdG -D irac spinors following the conventions of Ref. 5, where N = 2 for a single C uO₂ layer. These massless D irac-like objects carry no overall charge and are at zero chem ical potential { re ecting the fact that pairing in the particle-particle channel always pins the d-wave nodes to the true chem ical potential { and can be thought of as the particle-hole excitations of the BCS \vacuum ". They, however, can be polarized and their polarization will renorm alize the uctuations of the Doppler gauge eld v, the point which will be emphasized later. Furtherm ore, the nodal ferm ions carry spin S = $\frac{1}{2}$ and interact strongly with the Berry gauge eld a to which they are minimally coupled. In contrast, the rest of the electronic degrees of freedom, which we label \anti-nodal" $_{ih}$ i, where h i = h12i, h21i, h12i, and ferm ions, h21i, are combined into spin-singlet C ooper pairs and do not contribute signi cantly to the spin channel. On the other hand, these anti-nodal ferm ions have nite density and carry the overall electric charge. Their coupling to v is the dynam ical driving force behind the form ation of the CPCDW .M eanwhile, the nodal ferm ions are not a ected by the CPCDW at the leading order { their low energy e ective theory is still the sym m etric $Q \ge D_3$ even though the translational sym m etry is broken by the CPCDW 12 .

The presence of these massless D irac-like excitations in L_f is at the heart of the QED₃ theory of cuprates⁵. QED₃ theory is an elective low energy description of a uctuating $d_{x^2} = v^2$ -wave superconductor, gradually los-

ing phase coherence by progressive adm ixing of quantum vortex-antivortex uctuations into its ground state. All the while, even as the ODLRO is lost, the amplitude of the BdG gap function remains nite and largely undisturbed as the doping is reduced toward half-lling as depicted in Fig. 1. How is this possible? A nodal d_{x^2} v^2 wave superconductor { in contrast to its fully gapped cousin or a conventional s-wave superconductor { possesses two fundam ental sym m etries in its ground state; the fam iliar one is just the presence of the ODLRO, shared by all superconductors. In addition, there is a m ore subtle symmetry of its low energy fermionic spectrum which is exclusively tied to the presence of nodes. This symmetry is emergent, in the sense that it is not a sym metry of the full microscopic Ham iltonian but only of its low energy nodal sector, and is little m ore than the freedom intrinsic to arranging two-com ponent nodal BdG spinors into four-component massless D irac ferm ions⁵ { by analogy to the eld theory we call this sym metry chiral. The QED₃ theory rst form ulates and then answers in precise mathematical terms the following question: can a nodal d_{x^2} v^2 -wave superconductor lose ODLRO but nonetheless retain the BdG chiral sym m etry of its low energy ferm ionic spectrum ⁵? In conventionalBCS theory the answer is a straightforward \no": as the gap goes to zero all vestiges of the superconducting state are erased and one recovers a Ferm i liquid norm al state. How ever, in a strongly quantum uctuating superconductor considered here, which loses ODLRO via vortex-antivortex unbinding, the answer is a rem arkable \yes". The chirally symmetric, IR critical phase of QED₃ is the explicit realization of this new, non-Ferm i liquid state of quantum m atter, with the phase order of a d_{x^2} v^2 -wave superconductor gone but the chiral symmetry of fermionic excitations left in its wake. W hile these excitations are incoherent, being strongly scattered by the massless Berry gauge eld, the BdG chiral sym metry of the low energy sector rem ains intact²³. Im portantly, as interactions get too strong { the case in point being the cuprates at very low dopings { the B dG chiral sym m etry w ill be eventually spontaneously broken, leading to antiferrom agnetism and possibly other fully gapped states^{5,7}. Nonetheless, the BdG chiral sym m etry breaking is not fundam entally tied to the loss of ODLRO : di erent HTS m aterials are likely to have dierent T = 0 phase diagram s with larger or smaller portions of a stable critical \norm al" state { described by the symmetric QED₃ { sandwiched between a superconductor and an antiferrom agnet (SDW) (Fig. 1). In all cases, provided our starting assumption of the predom inantly pairing nature of the pseudogap is correct, the sym m etric QED 3 em erges as the underlying e ective theory of underdoped cuprates, echoing the role played by Landau Ferm i liquid theory in conventionalm etals.

III. THERMAL (\CLASSICAL") PHASE FLUCTUATIONS




FIG. 2: CuO₂ lattice represented by thick black lines (vertices are copper atom s and oxygens are in the m iddle of each bond). The nodes of the blue lattice (thin solid lines) represent sites of our \e ective" X Y m odel (14), with the phase factor exp(i'_i) located at each blue vertex. The dual of the copper lattice is shown in red dashed lines. The nearest neighbor coupling on the blue lattice is denoted by J (blue link) and the two next-nearest neighbor couplings are J_1 (red link) and J_2 (black link). Generically, $J_1 \notin J_2$ and the translational sym m etry of the blue lattice is broken by the \checkerboard" array of \red" and \black" plaquettes, as is evident from the gure. This doubles up the unit cell which then coincides with that of the original (black) CuO₂ lattice, as it should be.

Our st goal is to introduce an XY model type representation of thermal (or \classical") phase uctuations. To this end we st observe that in cuprates, we are dealing with a d-wave superconductor on a tightly bound two-dimensional CuO₂ lattice (the black lattice in Fig. 2). The simplest starting point is the lattice d-wave superconductor (LdSC) model discussed in detail by Vafek et al.¹⁸. The model describes fermions hopping between nearest neighbor sites hiji on a square lattice with a renormalized matrix element t and contains a nearest neighbor spin-singlet pairing term with an e ective coupling constant $_{\rm e}$ adjusted to stabilize the d_{x²} y² state with the maximum pairing gap :

where () denotes various residual interaction term s. c^v and c_i are creation and annihilation operators of som e e ective electron states, appropriate for energy scales below and around , which already include renormalizations generated by integration of higher energy con gurations, particularly those associated with strong M ott-Hubbard correlations. Thise ective LdSC model is phenom enological but can be justi ed within a more microscopic approach, an exam ple being the one based on a t J-style e ective H am iltonian. The com plex gap function is de ned on the bonds of the CuO_2 (black) lattice: $ij = A_{ij} \exp(i_{ij})$. The amplitude A_{ij} is frozen below the pseudogap energy scale $\$ and equals A $_{ii}$ = along horizontal (vertical) bonds. Thus, the d-w ave character of the pairing has been incorporated directly into A_{ij} from the start.

W hat remains are the uctuations of the bond phase $_{ij}$. It is advantageous to represent these bond phase uctuations in terms of site uctuations by identifying exp(i $_{ij}$)! exp(i'_k), where '_k is a site phase variable associated with the middle of the bond hiji. Consequently, we are now dealing with the set of site phases '_k located at the vertices of the blue lattice in Fig. 2. Note that the blue lattice has twice as many sites as the original CuO₂ lattice or its dual. This is an important point and will be discussed shortly.

We can now integrate over the ferm ions in the LdSC model and generate various couplings among phase factors exp (i'_k) residing on di erent \blue" sites. The result is the m inim alsite XY -type model H am iltonian representing a uctuating classical lattice d-wave supercon-

The couplings beyond next-nearest neighbors are neglected²⁴ in (14). Such m ore distant couplings are not important for the basic physics which is of interest to us here, and their e ect can be simulated by a judicious choice of J_1 and J_2 { the reader should be warned that the situation changes when T ! 0 as will be discussed in the next section. K eeping J_1 and J_2 , how ever, is essential. If only J is kept in (14), the translational sym m etry of the blue lattice would be left intact and we would nd ourselves in a situation more symmetric than warranted by the microscopic physics of a d-wave superconductor. In this sense J_1 and J_2 or, more precisely, their di erence J_1 $J_2 \in 0$, are dangerously irrelevant couplings and should be included in any approach which aims to describe the physics at interm ediate lengthscales.

In general, near half-lling, J, J_1 and J_2 tend to be all positive and mutually di erent. This ensures that the ground state is indeed a d-wave superconductor (the reader should recall that d-wave signs had already been absorbed into A_{ij} 's so the ground state is an XY ferrom agnet instead of an antiferrom agnet { the antiferrom agnet would be an extended s-wave state.). The explicit values of J, J_1 and J_2 can be computed in a particular m odel. In this paper we treat them as adjustable param – eters.

A . Vortex-antivortex C ou lom b gas representation of H $_{\rm X~Y}^{\rm d}$

The fact that $J_1 \in J_2$ breaks translational symmetry of the blue lattice. This is as it should be since the blue lattice has twice as many sites as the original CuO₂ lattice. This is an important point to which we will return shortly. Now, how ever, let us assume for them oment that $J_1 = J_2$. This assumption is used strictly for pedagogical purposes. Then, the blue lattice has a full translational symmetry and it is straightforward to derive the e ective C oulom b gas representation for uctuating vortexantivortex pairs. Here we follow the derivation of R ef. 25. The cosine functions in (14) are expanded to second order and one obtains the elective continuum theory:

where E_c C is the core energy. Note that the integrals in the rst part of (20) include only the regions outside vortex cores (the size of which is \vec{a}).

How is the above derivation a ected if we now restore $J_1 \in J_2$, as is the case in real cuprates? The long distance part remains the same since J_1 J, enters only at the O (k^4) order of the gradient expansion of cosine functions in (14), i.e. $J_1 = J_2 \in 0$ a ects only the terms denoted by () i_{h} H (15). So, the strength of the C oulom b interaction between (anti)vortices in H $_{\rm v}$ (20) is still given by $J = J + J_1 + J_2$. The core energy changes, however. This change can be traced back to (17) and (18); depending on whether the vortex core is placed in a red (i.e., containing the red cross in Fig. 2) or a black plaquette of the blue lattice, the constant of integration C will generally be di erent. This is just the re ection of the fact that for $J_1 \in J_2$ the original translational sym metry of the blue lattice is broken down to the checkerboard pattern as is obvious from Fig. 2. So, Eq. (18) must be replaced by:

G (r; r^0) is just the electrostatic potential at point r produced by a vortex charge at r^0 . Since not all locations for r^0 are equivalent, there are two constants of integration $C_r \in C_b$ ($C_r \quad C_b \quad J_1 \quad J_2$), corresponding to whether r^0 is in the red or black plaquettes of the blue lattice (Fig. 2). Retracing the steps leading to the C oulom b gas representation we nally obtain:

where $E_c^{r(b)}$ are the core energies of (anti)vortices located in red (black) plaquettes and $E_c^r = E_c^b = J_1 = J_2 \cdot E_c^{r(b)}$ are treated as adjustable parameters, chosen to best reproduce the energetics of the original H am iltonian (14). The explicit lattice version of (20) follows from Ref. 26, where a duality transform ation and a M igdal-style renorm alization procedure have been applied to the XY m odel:

In (23) s(r) = 0; 1(2; 3;:::) and r are sum m ed over the red (R) and black (B) sites of the lattice dual to the blue lattice in Fig. 2. Eq. (23) can be viewed as a convenient lattice regularization of (22). It is rederived in the Appendix with the help of V illain approximation.

We can also recast H $_{\rm V}$ in a form which interpolates between the continuum (22) and lattice (23) C oulom b gases. For convenience, we now limit our attention to only 1 vortex charges (vortices and antivortices) since these are the relevant excitations in the pseudogap regime. The underlying lattice in (23) is \sm oothed out" into a periodic potential V (r) whose m inim a are located in the plaquettes of the blue lattice (at vertices of the dual blue lattice). The precise form of V (r) can be computed in a continuum m odel of realistic cuprates involving local atom ic orbitals, self-consistent com putations of the pseudogap , etc. and is not im portant for our purposes; only its overall symmetry m atters and the fact that it is su ciently \sm ooth". This nally produces:

If $\mathbf{E}_c^{\mathbf{r}} = \mathbf{E}_c^{\mathbf{b}}$, the periodicity of V (r) coincides with that of the blue lattice { the value at them inimum is basically $\mathbf{E}_c^{\mathbf{r}} = \mathbf{E}_c^{\mathbf{b}}$. On the other hand, if $\mathbf{E}_c^{\mathbf{r}} \in \mathbf{E}_c^{\mathbf{b}}$ as is the case in real cuprates, V (r) has a checkerboard symmetry on the blue lattice, with two di erent kinds of local extrem a; the red one, at energy set by $\mathbf{E}_c^{\mathbf{r}}$ and a black one, at energy $\mathbf{E}_c^{\mathbf{b}}$ (this is all depicted in Fig. 2).

The most important consequence of these two di erent local extrem a of V (r) is that there are two special locations for the position of vortices; on the original CuO₂ lattice of Fig. 2 these correspond to vortices either residing in its plaquettes or at its vertices. On general grounds, we expect one of these positions to be the absolutem inim um while the other assumes the role of either a locally stable minim um or a saddle point with an unstable direction. Whether $E_c^r < E_c^b$ or the other way around and whether the higher energy is a local minim um or a saddle point, however, can be answered with certainty only within a modelm orem acroscopic than the one used here. In particular, a speci c analysis of the electronic structure of a strongly correlated vortex core is necessary which goes far beyond the XY-type model used in this paper. For our purposes E_c^r and E_c^b can be treated as adjustable parameters and it su ces only to know that the m icroscopic physics selects either the red or the black plaquettes in Fig. 2 as the favored vortex core sites and relegates the other to either the m etastable or a weakly unstable status.

IV. QUANTUM PHASE FLUCTUATIONS

The previous discussion pertains to the thermal (or classical) 2D XY model. The key di erence from the usual C oulom b gas representation for vortex-antivortex pairs turned out to be the inequivalence of vortex core positions on the blue lattice (Fig. 2), which served to recover the translational sym metry of the original C uO $_2$ lattice. This e ect was represented by the blue lattice potential V (r) in the vortex H am iltonian (24).

To obtain the quantum version of the uctuation problem or an e ective (2+1)D XY -type model we need to include the imaginary time dependence in $'_{i}$! $'_{i}$ (). In general, this will result in vortex-antivortex pairs propagating through im aginary (Euclidean) time, as vortex cores move from one plaquette to another through a sequence of quantum tunneling processes. There are two aspects of such motion: The rst is the tunneling of the vortex core. This is a \m icroscopic" process, in the sense that a detailed continuum model, with self-consistently computed core structure, is needed to describe it quantitatively. For the purposes of this paper, all we need to know is that one of the nal components characterizing such a tunneling process is the m ass" M of the vortex core as it moves through imaginary time²⁷. This implies a tem

in the quantum mechanical vortex action, where $r_{i}^{v(a)}$ () is the position of the ith (anti)vortex in the CuO₂ plane at time . Note that M is here just another parameter in the theory which, like J, J_1 , and J_2 , is more m icroscopic than our m odel²⁷. However, the m icroscopic physics of the cuprates clearly points to M being far sm aller than in conventional superconductors. Cuprates are strongly k 1 coupled system s, with a short coherence length and the vortex core of only several lattice spacings in size. Consequently, there are only a few electrons \inside a core" at any given time, making (anti)vortices \light" and highly quantum objects, with strong zero-point uctuations. Furtherm ore, the core excitations appear to be gapped²⁸ by the combination of strong coupling and local M ott-H ubbard correlations^{29,30,31,32,33}. This has an im portant in plication for the second component of the core tunneling process, the familiar Bardeen-Stephen form of dissipation, which is such a ubiquitous and dom inating e ect in conventional superconductors. In conventional

system s the core is hundreds of nanom eters in diam eter and contains thousands of electrons. M is large in such a superconductor and, as a vortex attem pts to tunnel to a di erent site, its motion is dam ped by these thousands of e ectively norm al electrons, resulting in signi cant Bardeen-Stephen dissipation and high viscosity. The motion of such a huge, strongly dam ped ob ject is e ectively classical. Vortices in underdoped cuprates are precisely the opposite, with small M, the Bardeen-Stephen dissipation nearly absent and a very low viscosity. In this sense, the quantum motion of a vortex core in underdoped cuprates is closer to super uid ⁴H e than to other, conventional superconductors³⁴. We are therefore justied in assuming that it is adequately described by (25) and ignoring sm all vortex core viscosity for the rest of this paper³⁵. The special feature of the cuprates, how ever, is the presence of gapless nodal quasiparticles away from the cores which generate their own peculiar brand of (weak) dissipation { such e ect is discussed and included later in this section.

The second aspect of the vortex propagation through in aginary time involves the motion of the super ow velocity eld surrounding the vortex outside its core, i.e., in the region of space where the magnitude of is approxin ately uniform . This is a long range e ect and, unlike the vortex core energies, m ass, or B ardeen-Stephen dissipation, exhibits certain universal features, shared by all superconductors and super uids. For exam ple, in superuid ⁴He this e ect would result in a M agnus force acting on a vortex. In a superconductor, the e ect arises from the time derivative of the phase in the regions of uniform . The origin of such time derivative and its physical consequences are most easily appreciated by considering an ordinary (ctitious) strongly uctuating s-wave superconductor with a phase factor $\exp(i_{i}())$ at each site of the CuO₂ lattice. For reader's bene t we discuss this case rst as a pedagogical warm -up for what lies ahead.

A. Pedagogical exercise: quantum uctuating s-w ave superconductor

A fler perform ing the FT transform ation and forgetting the double valuedness problem (ignoring the Berry gauge eld a) since we are concentrating on the charge channel, the quantum action will contain a purely in aginary term (see Section II):

where $n_i _{i i}$. It is useful to split the electron density into its average and the uctuating parts: $n = n_* + n_{\#} ! n + n$. The average part is unimportant for the spin-wave phase due to the periodicity of i() in the interval [0;]. In the vortex part of the phase, how ever, this average density acts as a magnetic $ux \frac{1}{2}n$ seen by (anti)vortices¹³. This rst time derivative is just

the charge Berry phase and it couples to (half of) the total electronic charge density. A fler the ferm ions are integrated out, the uctuating part of the density will simply generate a $-\frac{2}{1}$ term whose sti ness is set by the ferm ionic compressibility.

For simplicity, we will not ignore the charge Berry phase and set $n = 0 \pmod{2}$. This results in a (2+1)D XY model:

where $K = (K_0; K; K)$ and W is a real Hubbard-Stratonovich three-vector eld. The integral over the free eld can be carried out, producing the constraint $\emptyset = W = 0$. The constraint is solved by dem anding that $W = \emptyset = A_d$, where A_d will soon assume the meaning of the dualgauge eld. The vortex part is now manipulated into:

where the integration by parts and $(0)_r = 2$ n have been used and n is the vorticity in the (2+1) dimensional spacetime (vorticity, by its very nature, is conserved: @ n = 0). Now, we use the standard transition from Feynm an path integrals to coherent functional integrals³⁶. A relativistic vortex boson complex eld (x) is introduced, whose worldlines in (2+1) dimensional spacetime coincide with uctuating vortex loops (see the Appendix for a more detailed account). The rst term in (29) is just the current of these relativistic vortex particles coupled to a vector potential A . Furtherm ore, vortices have som e intrinsic line action dsS_0 , coming from core terms (and/or lattice regularization) which supply the (2+1) kinetic term . In the end, one obtains a dual Lagrangian:

where g > 0 is a short range repulsion describing the penalty for vortex core overlap. The mass term will in general be spatially modulated, rejecting the underlying

lattice potential, as in (24). A detailed derivation of the above dual Lagrangian can be found in the Appendix.

It is useful to underscore the follow ing relation between the steps that led to (30) and the form alism discussed in Section II, which is coached in the language closer to the original electrons: O nly the familiar long range B iot-Savart (anti)vortex interactions, mediated by dual gauge eld A_d , arise from the ferm ionic action in Section II and Refs. 12,38. This corresponds to large regions of space where the pseudogap is large and approximately uniform. In contrast, sm all (anti)vortex core regions, where

m ight exhibit signi cant non-uniform ity, supply the the core kinetic part (25), vortex core energy and the short range core repulsion term (g), which are all stored in the Jacobian" for v and a gauge elds. This is significant since it enables us to deal rather straightforw ardly with the charge Berry phase which now must be restored.

First, notice that the self-action of A_d, which was introduced in this section through a Hubbard-Stratonovich decoupling in Eq. (28), actually follows \m icroscopically" from the integration over the ferm ions and the gauge eld v in Section II and¹². There A_d was introduced as a eld enforcing a -function constraint [(0 v)= n]but the physics is precisely the same, the form ald i erence being just the order in which we integrate the fermaionic matter. Once we restore the Berry phase term (i=2) d^3xn (@)_v back to the action, we note that in the form alism of Section ${\rm II} \mbox{ and}^{12}$ none of the $\mbox{ elds in the dual Lagrangian}$ (30) couples to it directly. Instead, it is v_0 that enters the Berry phase via the -function constraint 0 ! v_0 . The Berry phase term will then a ect (30) via the coupling of v_0 to the spatial part of A_d , i.e., the dual magnetic induction $B_d = r$ Ad.

The above observations suggest that it useful to separate out the saddle point part of v as: v ! iv+ v. The saddle point part v is determined by minimizing the total action (the $\$ " sign is chosen so that v₀ couples to the electron density as a chem ical potential). Of course, if there were no Berry phase term we would have v = 0. W ith the Berry phase term included v = 0 but v_0 is now nite. Observe from Eqs. (1,2) of Ref. 12 that the saddle point equation for $v_0 \sin p \ln p$ reduces to: $\frac{1}{2}n = B_d = r$ A_d (note that, relative to our notation, dual gauge eld in Ref. 12 is rescaled as $A_d ! 2 A_d$). So, with the Berry phase included, the nal form of the dual theory still remains given by Eq. (30) but must be appended by the constraint $\frac{1}{2}$ hn (x) i = hB_d (x) i.

One immediately recognizes (31) as the Abrikosov-Hofstadter problem for a dual type-II superconductor { we are in type-II regim e^{37} since small compressibility implies large dual G inzburg parameter $d_1 = \frac{1}{K_0} \frac{1}{1 + \frac{1}{C}} \frac{1}{c}$ { subjected to the overall (dual) magnetic eld

ux per plaquette of the dual lattice, f, given by f =p=q = (1 x)=2, where x is doping. Note that at halflling n = 1) f = 1=2. The solution that m in imizes (31) at half-lling is a checkerboard array of vortices and antivortices in , with the associated modulation in $B_d(r) = \frac{1}{2}hn(r)i$, as discussed in Refs. 12,38. This is nothing but the dual equivalent of a CPCDW in an s-wave superconductor at half-lling, with a two-fold degenerate array of alternating enhanced and suppressed charge densities on sites of the original lattice. An overwhelm ing analytic and num erical support exists for this state being the actual ground state of the negative U Hubbard m $odel^{39}$, the prototypical theoretical toy m odel in this category. This gives us con dence that the meanled approximation captures basic features of the prob-

lem .

uctuating d-w ave superconductor B. Quantum

The above pedagogical exercise applies to an idealized strongly uctuating s-wave superconductor and its associated ordinary (2+1)D XY model. W hat about our dwave lattice superconductor (LdSC) and its e ective XY type m odel (14), with the bond phases m apped into site phases on the blue lattice? Again, we go from exp(i ij) to exp (i' $_{\rm k}$) as before. The cosine part of (27) is replaced by H $_{\rm X~Y}^{\rm d}$ (14) and is handled in the same way as for the classical case. This will ultim ately result in a modulated potential V (r) of Eq. (24). In the context of the dual theory (30) this will translate into a position-dependent m ass term m² (r) j (x) j² in the dual Lagrangian (30) except now this mass term has the checkerboard symmetry on the blue lattice, with m $_{\rm r}^2$ in the red plaquettes di erent from $m_{\rm b}^2$ in the black plaquettes ($m_{\rm r}^2 = m_{\rm b}^2$ $E_c^r E_c^b$). Including the constraint on the overall dual induction B d seems to complete the process.

A las, the situation is a bit more involved. First, the tim e derivative part and the Berry phase are more com plicated. The di culty arises since the bond superconducting phase ii of a LdSC couples in a more com plicated way to the site ferm ionic variables. However, we can still deal with this by enlisting the help of the FT gauge transform ation which screens the long-range part of $_{ij}$ by $\frac{1}{2}$ $_{i} + \frac{1}{2}$ $_{j}$, where $_{i}$ are the phases in the ferm ionic elds. A fler this transform ation (we are again ignoring a which we can put back in at the end) one obtains $i\frac{1}{2}n_i$ @ i at each site of the CuO₂ lattice. This translates into $\frac{1}{8}n_i$ @ $_i + \frac{1}{8}n_j$ @ $_j$ for each bond hiji of the CuO₂ lattice. This bond expression can be rewritten as:

The expression (32) seems too good to be true and it is { the replacement $_{ij}$! $\frac{1}{2}_{i}$ + $\frac{1}{2}_{j}$ holds only far away from vortices, when the phases change slow ly between nearby bonds (sites). In general, the bond phase of the LdSC will not couple to the electron densities in a sim ple way suggested by (32). Still, we have gained an important insight; its coupling to the overall electron density represented by the leading term in (33) is e ectively exact. This follows directly from the electrodynam ic gauge invariance which m and ates that both regular and singular con gurations of the phase must have the same rst time derivative in the action. For arbitrarily smoothly varying phase, with no vortices present, the replacem ent $_{ij}$! $\frac{1}{2}$ $_{i}$ + $\frac{1}{2}$ $_{j}$ is accurate to any desired degree and the Berry phase given by the leading term in (33) follows. Incidentally, this result is not spoiled by the higher order term s, represented by () in (32), since they do not contribute to the overall dual magnetic eld, by virtue of $n_j = 0$. W e, however, cannot claim with the same ni degree of certainty that ij is in a sim ple relationship to variations in the electronic densities on sites i and j as (32) would have it^{40} . Instead, we should view ίj in (33) as a Hubbard-Stratonovich eld used to decouple the $\frac{2}{1}$ term in the quantum action. This makes i_{ij} inherently a bond eld whose spatial modulation translates into variation in the pseudogap and will be naturally related to the dual induction B_d below⁴¹. This is different from our pedagogical s-wave exercise where the m odulation in B $_{\rm d}$ was directly related to the variation in the electronic density.

The second source of complication is more intricate and relates to the fact that, as T ! 0, we must be concerned about nodal ferm ions. In the s-w ave case and the nite tem perature d-wave XY -type model (14) we know that coupling constants J, J1, J2, and so on, are nite or at least can be made so in simple, reasonably realistic models. In general, we need to keep only several of the nearby neighbor couplings to capture the basic physics. There is a tacit assumption that such expansion is in fact well-behaved. In the quantum d-wave case, how ever, the expansion in near neighbor couplings is not possible { at T = 0 its presum ed analytic structure is obliterated by gapless nodal ferm ions. Naturally, after the electrons are integrated out we will still be left with some e ective action for the phase degrees of freedom $_{ij}$ () but this action will be both non-local and non-analytic in terms of (32) di erences of phases on various bonds. The only option

appears to be to keep the gapless ferm ionic excitations) contains higher order derivatives and is typin the theory. This in itself of course is perfectly ne but it does not advance our stated goal of \bosonizing"

the CPCDW problem a least bit. Note that the issue here is not the Berry gauge eld a and its coupling to nodal ferm ions { even when we ignore coupling of vortices to spin by setting a ! 0 and concentrate solely on the charge sector as we have done so far, the gapless BdG quasiparticles still produce non-analytic contributions to the phase-only action. In short, what one has here is more than a problem; it is a calam ity. The im plication is nothing less but that there is no usable XY type m odel for the charge sector of a quantum d-wave superconductor, the optim istic title of the present paper notw ithstanding.

Fortunately, there is a way out of this conundrum . While indeed we cannot write down a simple XY-like model for the uctuating phases it turns out that the dual version of the theory can be modied in a relatively straightforward way to incorporate the non-analyticity caused by nodal ferm ions. To see how this is accom plished we go back to Section II and use our division of electronic degrees of freedom into low-energy nodal (;) and \high-energy" anti-nodal ferm ions, tightly bound into spin-singlet Cooper pairs ($_{ih}$ i). In agine for a m om ent that we ignore nodal ferm ions altogether, by, for example, setting the num ber of D irac nodal avors N ! 0 (in a single CuO_2 plane N = 2). Exact integration over anti-nodalelectrons c , i leads to an XY -type model precisely of the type discussed at the beginning of this subsection. Since anti-nodal electrons are fully gapped the e ective Ham iltonian has the conjectured form (14) with nite couplings J, J_1 and J_2 , and with higher order term swhich decay su ciently rapidly. The explicit values of J, J_1 and J_2 at T = 0 m ight be di cult to determ ine but not more so than for an s-wave superconductor. Furtherm ore, since anti-nodal ferm ions carry all the charge density, the Berry phase term remains as determined earlier and so does the timelike stiness of 'i. Derivation of the dual theory proceeds as envisioned, with all the short range e ects stored in vortex core term s and ultimately in m² (r), and with only remaining long range interactions mediated by the dual gauge eld A_{d} . We now restore nodal ferm ions (N \neq 0); as already em phasized, the only coupling of nodal ferm ions to the dual theory is via the gauge elds v and a. Since we are ignoring the spin channel we can neglect a. As far as v is concerned, including nodal ferm ions leads to a non-local, non-analytic correction to its sti ness, expressed as

where K is determined by anti-nodal electrons. Q (q) is the contribution from nodal fermions, linear in q and in general quite complicated. We give here few simpler limits: $Q_{00}(0;!_n) = cj!_n j Q_{0i} = Q_{i0} = 0$, $Q_{xx}(q;0) = Q_{yy}(q;0) = cq, Q_{xy}(q;0) = Q_{yx}(q;0) = cq sgn(q_x;q_y)$, where $q_y = max(j_x;j_y)$, $q_x = min(j_x;j_y)$ and $c^{2}=16 \ \overline{2}^{43}$.

In the language of dual theory, this translates into a

modied self-action for the dual gauge eld:

where K + N Q] ¹ is the tensor inverse of K . This action is clearly more complicated than its ΝO M axwellian s-wave counterpart but nevertheless decidedly manageable { most importantly, the part of the dual action involving dual boson eld remains unaffected. Note that nodal ferm ions induce subleading but still long-ranged interactions between vortices, in addition to the fam iliar B iot-Savart interactions. These interactions have square symmetry on the blue lattice, reecting their nodal origin. Furtherm ore, when Ad is integrated over, they will produce a peculiar dissipative $j!_n jv_0^2$ which describes the dam ping of collective term quantum vorticity uctuations by gapless nodal quasiparticles. The importance of this e ect is secondary relative to the mass term for v₀ which is always generated by antinodal ferm ions, basically because the density of states N (E) for nodal ferm ions vanishes as E ! 0. How ever, given the sm allness of traditional Bardeen-Stephen core viscosity this \nodal" mechanism is an important source of dissipation of vortex motion in underdoped cuprates. Since our focus in the present paper is dual mean-eld theory, this dissipative term will play no direct role.

A rm ed with the above analysis we can nally write down the Lagrangian of the quantum XY -type m odel describing a LdSC:

where the sum s run over sites i of the blue lattice and the notation is the same as below Eq. (14), $f_i =$ $\frac{1}{8}(n_k + n_j)$ with k; j being the end sites of bond i, the time-like phase stiness K₀ results from the Hubbard-Stratonovich integration over ij as detailed above, and L_{core} contains core terms coming from a small region around the (anti)vortex where itself is signi cantly suppressed, an example being (25). The explicit form of L_{nodal} [cos(' i 'j)] in the XY model language is unknown but it is a non-analytic, non-local functional of $\cos('_{i} \quad '_{j})$; its e ect will be incorporated once we arrive at the dual description, following the above arguments. Note that the short range parts of cosine functions and time derivative in (35) will be subsumed into L_{core} once we go to continuum or Villain representations of the problem, as described elsewhere in the paper. Furtherm ore,

observe that at half-lling the dual ux per plaquette of the blue lattice has an intrinsic checkerboard pattern: f = 1=2 for black plaquettes and f = 0 for red plaquettes. This is a direct consequence of '() being a bond phase, residing on the blue lattice sites in Fig. 2, its Berry phase given by Eq. (33). Thus, in the quantum problem, the Berry phase combines with the next-nearest neighbor bonds (for $J_1 \notin J_2$) in breaking translational symm etry of the blue lattice down to the checkerboard pattern of Fig. 2. The average ux through the unit cell on the blue lattice is f = 1=2 which is just as it should be since there are two plaquettes of the blue lattice per single plaquette of the original black lattice and the dual ux per plaquette of the CuO₂ lattice is f = 1=2 at half-lling.

It is now straightforward to derive a dual representation of (35) by retracing the path that led from (27) to (30). In this fashion we obtain the dualLagrangian of the (2+1)D XY m odel appropriate for a strongly uctuating d-wave superconductor near half-ling⁴⁴:

Ad satis es the constraint arising from the where @ charge Berry phase. The dual Lagrangian for a d-wave superconductor (36) di ers from its s-wave counterpart (30) in the following important respects: i) the periodicity of the mass potential is di erent and re ects the checkerboard periodicity on the (dual) blue lattice set by our vortex core potential V (r), ii) the self-action for the dualgauge eld contains non-local, non-analytic contribution of nodal ferm ions, iii) the modulation of the dual ux B_d relates to the variation in the pseudogap ii (as opposed to the electronic density n_i) via the constraint B_d (r) (1=16)h ij (r)i, and iv) at doping x, the overall dual ux through the unit cell of the blue lattice imposed by the Berry phase constraint is f = p=q = (1 x)=2, com prised of f = p=q = (1 x)=2x)=2 at a black plaquette and f = 0 at a red one. We therefore expect the results for stable CPCDW states to be di erent from those of a hypothetical strongly uctuating s-wave superconductor. Also, note that K $_0$ is now set by K_0 hj ij ji, which is still related to ferm ion com pressibility⁴⁰ and still relatively sm all since the basic aspect of our approach is that am plitude uctuations in ij are suppressed. This im plies our dual superconductor rem ains in the type-II regime ($_{\rm d}$ 1= K₀ 1).) denotes higher order term swhich have been $\frac{2}{r}$ Finally, (neglected. For those readers who nd the above road to (36) perhaps a bit too slick, we give a detailed step-bystep derivation in the Appendix.

An important point should be noted here: The neglected higher other terms () involve higher order netic terms, additional intermediate range interactions, short range current-current interactions and numerous other contributions. All are irrelevant in the sense of critical behavior. In our problem, how ever, we are not interested only in the critical behavior. In particular, we would like to determ ine the charge modulation of the CPCDW on lengthscales which are not extremely long compared to the CuO₂ lattice constant. These additional terms could be important for this purpose. Particularly signi cant in this respect are the higher order corrections to the Berry phase (32) which, while not a ecting the value of overall f, do in uence the form of the e ective dual A brikosov-H ofstadter problem that ensues.

The strategy of keeping a large num ber of otherwise irrelevant term s is not a practical one. W e w ill therefore introduce a simpli cation here which is actually quite natural and allow sus to retain the essential realistic features of the originalm odel and m aintain the particle-hole sym m etry as well. Consider a situation w here m 2 (r) in (36) is very strongly m odulated. This is a \tight-binding" lim it, universally considered appropriate for cuprates, and we can simply view quantum (anti)vortices as being able to hop only between the nearby plaquettes of the blue lattice, as is clearly implicit in (35). Furthermore, we assum e that the two extrem a in m 2 (r) are separated by an energy scale larger than such hopping. This is a perfectly , reasonable assum ption since it illustrates an already im – portant characteristic of our e ective model, the fact that red and black plaquettes of the blue lattice are intrinsically not equivalent (by the form of the Berry phase and $J_1 \in J_2$). Under these circum stances we can rewrite the dual Lagrangian in a tight-binding form :

We have also assumed that it is the red plaquettes to include t_{bb} explicitly. The assumption $E_r = E_b$ appears naturally warranted by the overall symmetry of the problem but, should the details of m icroscopic physics intervene and reverse the situation in favor of the black plaquettes, all one needs to do is exchange labels r b (note that $m_r^2 < 0, m_b^2 > 0$ in a dual superconductor).

The resulting tight-binding dual H am iltonian:

will be analyzed in two limits: for t_{rr} $t_{rb}^2 = j_n r_r^2$ m_b²j in which case we can simply set t_{rb} ! 0, the electrice Hofstadter problem assumes the form equivalent to the standard s-wave case de ned on the sites of the red lattice (Fig. 2). Im portantly, how ever, the relation between the modulation in B $_{\rm d}$ and $_{\rm ij}$ remains di erent from the s-wave case and peculiar to a d-wave, as explained above. We will call this lim it an H1 m odel. Sim ilarly, in the opposite case t_{rr} t_{rb}=jm ² m²_bjwe can set trr ! 0 and obtain an e ective Hofstadter problem with hoppings between red and black sites only. Note that this situation is not equivalent to the standard s-wave case: In order to hop from one red plaquette to another a vortex must go through a black site, picking up a Peierls phase factor di erent from the one for a conventional direct red-to-red hop. In considering these Peierls factors we must exercise caution since the \assisted" hops between red plaquettes pass directly through the dual uxes f = p=q = (1 x)=2 located on black sites. By in nitesim ally displacing the said ux, one is back to the situation where all closed paths of hops are composed of uxes f = p=q = (1 x)=2 through black and f = 0through red plaquettes of the blue lattice. The resulting Ham iltonian has an exact particle-hole symmetry around half-lling (x ! x), as it should. W e call this the H2 m odel. Finally, still in the lim it t_{rr} $t_{rb}^2 = jm_r^2 m_b^2 jw$ ith t_{rr} ! 0, we can \spread" the dual ux so it is uniform by distributed throughout each blue lattice plaquette and equal f = p = q = (1 x) = 4. In this situation, dubbed an H 3 m odel, the x ! x sym m etry is obeyed only approxin ately, for small x (near half-lling), but this is all we are interested in. We have established by explicit com putations that the H3 m odel satis es the particle-hole symmetry at some Hofstadter fractions f while it does not appear to do so at others; it is for this reason that we tend stay away from the H3m odel in this paper. The reader should note that the issue of how to dealw ith dual uxes when hopping through black plaquettes arises only in tight-binding m odels H 2 and H 3 (but not H 1!) { the originaldualLagrangian (36) is free of such issues and has manifest x ! x symmetry. The down side, of course, is that such a continuum theory is farm ore di cult to

solve, both analytically and num erically.

The Ham iltonian (38), in its three editions H1, H2, and (to a limited extent!) H3, de nes probably the sim plest dual version of the Hofstadter problem which appropriately builds in the d-wave character of the uctuating lattice superconductor and the essential phenom enology of the pseudogap state in underdoped cuprates. The ex-) can still be used for ne-tuning (for extra term s (am ple, $g ! g_r; g_b$, additional $j_r f j_b f$ repulsions, etc.) but the important particle-hole symmetry around halflling is already present without them . All the detailed num erical calculations reported in the latter pages of this paper and described in Ref. 12 use the mean-eld version of (38) and the three models based on \pm , H1 (t_{rr} $(38)_{rb}^2 = jn_r^2 m_b^2$) and H2 and H3 (t_{rr} t_{rb}²= jn_r² m_b²), as the point of departure.

V. DUAL SUPERCONDUCTOR AND COOPER PAIR CDW IN UNDERDOPED CUPRATES




FIG.3: Quantum uctuations of vortex-antivortex pairs. xy-plane is the CuO₂ layer and -axis shows direction of im aginary time. Vortices (arrows pointing upwards) and antivortices (arrow spointing dow nw ards) are alw ays created and annihilated in pairs. Note that the structures arising from linked creation-annihilation events form oriented loops carrying 1 vorticity. These bops are just the virtual particle-antiparticle creation and annihilation processes in the quantum vacuum of the relativistic bosonic eld (x), as described in the text and the Appendix. is our dual order parameter: In a physical superconductor such vorticity loops are nite and h i = 0. Note that the intersections of such nite loops with the xy-plane at any given time de ne a set of bound vortex-antivortex dipoles in the CuO $_2$ layer. The superconducting order is lost when vortex-antivortex pairs unbind and the average size of the above vorticity loops diverges { som e of the loops becom e as large as the system size. This is the pseudogap state, with h i \in 0. The reader should note the following am using aside: The above gure can easily be adapted to depict the low energy ferm ionic excitations of theory (1). The creation and annihilation processes now describe spin up (arrows pointing upwards) and spin down (arrows pointing downwards) quasiparticle excitations from the BCS-type spin-singlet vacuum . The loops carry a well-de ned spin and can be though of as relativistic BdG D irac particles/antiparticles { their m assless character in a nodald-wave superconductor in plies the presence of loops of arbitrarily large size. These ferm ionic loops move in the background of uctuating vortex loops discussed above, their mutual interactions encoded in gauge elds v and a. This is a pictorial representation of the theory (1).

The previous sections concentrated on the derivation of the e ective quantum XY-type m odel for phase uctuations in underdoped cuprates and its dual counterpart (36) and (37). In this section we pause to take stock of where we are with respect to the realworld and to consider som e general features of the physical picture that em erges from Eqs. (36,37). First, the dual superconductor (36) describes the physics of strongly uctuating superconductors in terms of a complex bosonic eld , which creates and annihilates quantum vortex-antivortex pairs viewed as \charged" relativistic particles (vortices) and antiparticles (antivortices) { this is depicted in Fig. 3. The conserved \charge" is just the vorticity associated with these topological defects, +1 for vortices and -1 for antivortices, and the gauge eld coupled to it is nothing but A_d. Physically, A_d describes the fam iliar logarithm ic interactions between (anti)vortices. W e stress that the dual description is just a convenient m athem atical tool: Its main advantage is that it allows a theorist to access a strongly quantum uctuating regime of a superconductor, where the super uid density $_{s}$ at T = 0 can be very small or even vanish, while the pairing pseudogap remains large. According to the theory of Ref. 5 this is the regime that governs the properties of the pseudogap state in underdoped cuprates. This regime is entirely inaccessible by m ore conventional theoretical approaches which use the mean-eld BCS state as the starting point around which to compute uctuation corrections.

The dual superconductor description predicts two basic phases of cuprates: h i = 0 is just the familiar superconducting state. Quantum and thermal vortex-antivortex pair uctuations are present (and thus hj j² i $\stackrel{6}{=}$ 0) but these pairs are always bound, resulting in a nite, but considerably suppressed super uid density. As vortex-antivortex pairs unbind at some doping x = x_c, the super uid density goes to zero and the superconducting state is replaced by its dual counter-




FIG. 4: The schematic phase diagram of underdoped cuprates in the theory of R efs. 5,12. T denotes the pseudogap tem perature (T). Dual superconducting order (nite h i) implies the absence of the true, physical superconductivity. Conversely, the absence of dual order (h i = 0) corresponds to the physical superconductor. The shaded area represents the region of coexistence between a strongly uctuating superconductor and a CPCDW state, which will generally occur in the dual theory. This region of \supersolid" behavior is characterized by h i = 0 but nite hj 2 ji, which is modulated within the CuO₂ layer according to our theory of a dual superconductor. The precise size of a coexistence region, however, is di cult to estimate from the mean-eld theory and a more elaborate approach, including uctuations and Ad, needs to be employed. Finally, the nite tem in perature phase boundary of the CPCDW (dashed-dotted line) should not be taken quantitatively apart from the fact that it is located below T .

part, h i \in 0. The meaning of dual OD LRO is actually quite simple: Finite h im eans that vortex bops (bops of vortex-antivortex pairs being created and annihilated in (2+1) dimensional spacetime) can now extended over the whole sample, i.e. the worldline of a dual relativistic boson can make its way from any point to in nity (see Fig. 3). The presence of such unbound vortex-antivortex excitations directly im plies vanishing helicity modulus and thus the absence of the M eissner e ect and $_{\rm s} = 0$ (see Section II for details). The phase diagram of a dual superconductor as it applies to cuprates is shown in Fig. 4.

In the dualm ean-eld approxim ation, just as in a con-

ventional one, we ignore uctuations in and m in im ize the action specied by (36) with respect to a complex function (r). In a physical superconductor ($x > x_c$) (r) = 0. For $x < x_c$, the minimum action corresponds to nite (r). However, since the charge Berry phase translates into a dual magnetic eld B_d this nite (r) must contain N $_{\rm d}$ vortices, where N $_{\rm d}$ is the number of the dual ux quanta piercing the system. Note that this number is nothing but half of the total number of electrons $N_d = N = 2$, the factor of one half being due to the fact that we are considering Cooper pairs. In a tight binding representation (37) this implies a dual ux f = p=q = (1 x)=2 per each CuO_2 unit cell. The presence of such vortex array in (r) will be accompanied by spatial variation in $B_d(r)$, which translates into the m odulation of the pseudogap $_{ij}$ and thus into a CDW of Cooper pairs (CPCDW). Consequently, in the vocabulary of the dualm ean-eld approximation, the question of form ation and the structure of the CPCDW is equivalent to nding the Abrikosov vortex array on a tight binding lattice, i.e. the Abrikosov-Hofstadter problem de ned by (37,38). The form ation of CPCDW results in

a modulation of the local tunneling DOS and one is led to identify the <code>\electron</code> crystal" state observed in STM experiments^{8,9,10} as the CPCDW.

O ur task is to determ ine the speci c pattern in which the vortices in (r) arrange them selves to m inim ize the expectation value of the dual H am iltonian (38). O noe this is known we can determ ine the m odulation in the dual induction B_d and the structure of the CPCDW follows from the B_d $_{ij}$ correspondence. In this section we are interested in general qualitative results and we therefore focus on the H1 m odel where such results are m ore transparent. The H2 and H3 m odels turn out to be m ore opaque and have to be studied num erically as soon as one is away from half-ling.

The solution of the Abrikosov-H ofstadter problem is obtained as follows: one rst sets g = 0 in (38) and nds the ground state of the resulting quadratic H ofstadter H am iltonian H_d (g = 0) given by

At ux f = p=q the ground state is q-fold degenerate and we denote it by ^(q)(r). One then turns on nite g, form s a linear combination of these degenerate states $_{q} q^{(q)}(r)$, and determ ines variationally the set of coe cients $f_{q}g$ which m in in izes the full H am iltonian (38). W ith $f_{q}g$ xed in this fashion the only remaining degeneracy in the ground state consists of lattice translations and rotations. Once the ground state ⁽⁰⁾ is found, the m agnetic induction B_{d} follows from M axwell equation:

All quantities in (40) are de ned on the blue lattice of Fig. 2: is a lattice derivative, j and A $_{d}$ are link variables, and B $_{d}$ = A d is a site variable. The detailed de nitions of all these objects are given in the next section. The non-local, non-analytic self-energy for the dual gauge eld in (37) was replaced by an elective Maxwellian (K ! K) { this approximation is valid for weak modulation Bd. We should (0) stress that this way of determ ining the ground state and dual induction $B_d(\mathbf{r})$ is valid only if K_0 is su ciently sm all so that the dualG inzburg param eter d 1= K~0 is su ciently large { in underdoped cuprates this is a justi ed assumption since strong M ott-H ubbard correlations strongly suppress all charge density uctuations. At higher modulation, i.e. for interm ediate values of d, the nodal contribution becom es m ore signi cant and its intrinsic square symmetry (see discussion around Eq. (34)) will act to orient B_d relative to the blue lattice.

If this is the case, the interplay between this $\$ all "effect and the one arising from the Abrikosov-Hofstadter problem itself can lead to interesting new patterns for the CPCDW state; a detailed study of such an interplay is left for the future. Finally, from $B_d(r) = B_d(r) = f$ we obtain i_j which can be fed back into the electronic structure via the expressions given in Section II.

Notice that the above method of solving the problem corresponds to the strongly type-II regime of a dual superconductor (_d 1). In this lim it, the CPCDW pattem is primarily given by the dual supercurrent j in the Maxwell equation (40), itself determ ined by the solution to the Abrikosov-Hofstadter problem (39). The modulation in B_d only rejects this pattern of vortices in j (40), and the dual magnetic energy is only a small fraction of the Abrikosov-Hofstadter condensation energy. Imagine now that we ask the following question: W hat are the interactions among vortices in that have resulted in ⁽⁰⁾ being the ground state of the Abrikosov-Hofstadter problem? This question is analogous to the one inquiring about the interactions that have led to the triangular lattice of vortices in the continuum version of the problem, i.e. the interactions inherent in the famed Abrikosov participation ratio A. In both cases, these are far from pairwise and short-ranged { they are in fact intrinsically multi-body interactions, involving two-, three-, and multiple-body terms, all of comparable sizes and all long-ranged⁴². They can be thought of as the interactions among the center-of-m ass coordinates of Cooper pairs. This should be contrasted with the picture of real-space pairs, interacting with som e sim ple, pairwise and short-ranged interactions. The pair density-wave patterns in this case are determined not by the charge Berry phase and the Abrikosov-Hofstadter problem but by the W igner-style crystallization. This is precisely the opposite lim it of the M axwell equation (40), in which it is the dualm agnetic energy that determ ines the pattern rather than simply re ecting the one set by the A brikosov-H ofstadter condensation energy, encoded in (0), and communicated by j. This is clearly seen in the W igner crystal lim it: consider an array of real-space pairs xed in their positions. Such particles carry a unit dual ux and are completely invisible to vortices. As a result j = 0 and (40) turns into the m inim ization of the dualm agnetic energy. In the real-space pair lim it this dual magnetic energy is nothing but the original assumed interactions between the pair bosons: $\frac{1}{2} \int_{ij} V(\mathbf{r}_{j} - \mathbf{r}_{j}) = \frac{1}{2} \int_{ij} d^{2} r d^{2} r^{0} B_{d}(\mathbf{r}) V(\mathbf{r} - \mathbf{r}^{0}) B_{d}(\mathbf{r}^{0}), \text{ since}$ $B_d(\mathbf{r}) = (\mathbf{r} + \mathbf{r})$, where $fr_i g$ are the pairs' positions { this is just the m in im ization of the potential energy in the W igner problem . Consequently, the two descriptions, that of the C ooper pairs versus the real-space pairs, correspond to the two opposite lim its of (40, 39), the rst to the strongly type-II, the second to the strongly type-I lim it of a dual superconductor. The density-wave pattems associated with these two limits are generally different and can be distinguished in experiments.

We now resume our discussion of the Abrikosov-




FIG.5: Left panel: the circles depict the checkerboard array of vortices in forming the ground state of H am iltonian H 1 at half-lling (f = 1=2 per plaquette of the atom ic lattice). The empty black plaquettes are actually occupied by dual antivortices, brought into existence by a simple geometric constraint on the phase of in such a checkerboard array. The full green circles denote \dual vortex holes"⁵, i.e. the dual vortices that are m issing relative to the half-lling checkerboard pattern once the system is doped to x = 1=8 (f = 7=16). The centers of these green circles form a square which de nest the 4 elementary block of 7 dual vortices (black circles) per 16 sites of the CuO₂ lattice discussed in text. R ight panel: the most general distribution of m odulations _{ij} consistent with the vortex pattern just described. The green \crosses" correspond to \dual vortex holes". In general, there are six⁴⁸ phenom enological param eters _{ij} shown in di erent colors. The num ber of inequivalent sites of the black lattice is also six (see Fig. 7).

Hofstadter problem. The sim plest case, for all models, is f = 1=2 or x = 0. For the H 1 m odel, the (anti)vortices prefer red plaquette locations and r will be large com pared to b, which can be safely ignored. The resulting dual vortex array at half-lling is depicted in Fig. 5. The structure is a checkerboard with vortices in r located on alternating black plaquettes. There is a single dual vortex per two unit cells of the CuO_2 lattice, as expected for f = 1=2. Such close packing of dual vortices results in \empty" black plaquettes actually being occupied by dual antivortices (manifestation of the fact that our f = 1=2 H ofstadter problem does not break the dual version of time reversal invariance). There is, how ever, no modulation in bond variables ij located on vertices of the blue lattice due to its peculiar relation to dualm agnetic induction B_d { all blue sites are in a perfectly symmetric relation to the dual vortex-antivortex checkerboard pattern on black plaquettes, as is obvious from Fig. 5. This implies $i_{ij} = 0$ and the pseudogap remains uniform despite (r) = 0. From this one would tend to conclude that there will be no CPCDW and no modulation in the local DOS. Still, there is a clear lattice translational symmetry breaking in the dual sector as evident from Figs. 5 and 6. Consequently, if we go beyond the leading derivatives, for example by including corrections to the Berry phase discussed around (26), we expect that a weak checkerboard m odulation will develop in quantities like the electron density n_i . The above is a special feature of the uctuating LdSC which, how ever, is altered when we include the spin channel in our consideration. The Berry gauge eld a must then be restored { its coupling to nodal ferm ions induces antiferrom agnetic order at half-lling and thus breaks the above symmetry in the leading order by a commensurate spin-density wave $(SDW)^7$,⁵.

As the system is doped f decreases away form 1=2 according to f = p=q = (1 x)=2. The ground state energy of (38) is particularly low for dopings such that q is a small integer, (integer)² or a multiple of 2, re ecting the square symmetry of the CuO_2 planes. Such dopings are thus identied as \major fractions" in the sense of the A brikosov-H ofstadter problem . In the window of doping which is of interest in cuprates, these fractions are 7=16, 4=9, 3=7, 6=13, 11=24, 15=32, 13=32, 29=64, 27=64, :::, corresponding to dopings x = 0.125 (1=8), 0.111 (1=9), 0:143 (1=7), 0:077 (1=13), 0:083 (1=12), 0:0625 (1=16), 0:1875 (3=16), 0:09375 (3=32), 0:15625 (5=32), etc. 0 ther potentially prom inent fractions, like 1=4, 1=3, 2=5, or 3=8, are associated with dopings outside the underdoped regime of strong vortex-antivortex uctuations. In general, we expect that particularly low energy states correspond to fractions such that the pattern of dual vortices in can be easily accomm odated by the underlying CuO_2 lattice. Furtherm ore, we expect that the quartic repulsion in (38) will favor the most uniform array of dual vortices that can be constructed from the q-dimensional degenerate Hofstadter manifold. In the window of dopings one deals with in cuprates, these conditions single

out doping x = 0.125 (f = 7=16) as a particularly prom inent fraction. At x = 0.125 (q = 16), the dual vortex pattern and the accompanying modulation in B_d can take advantage of a 4 4 elementary block which, when oriented along the x (y) direction, ts neatly into plaquettes of the dual lattice, as depicted in Fig. 5. This 4 4 elem entary block em bedded into the original CuO_2 lattice and containing 7 dual vortices (f = 7=16) is clearly the m ost prom inent geom etrical structure am ong all the ones we have found in our study, both in its intrinsic sim plicity and its favorable com m ensuration with the underlying atom ic lattice. It is bound to be among the highly energetically preferred states in underdoped cuprates, as it is indeed found in the next section.




FIG.7: The local density of states (LDOS) of the lattice d-wave superconductor with the modulated bond gap function $_{ij}$ corresponding to the 4 d supercell structure of Fig. 5 at doping x = 1=8. The calculations are done within the LdSC model of phase uctuations. Note that the uctuations of the gauge elds v and a lead to sm all broadening of the peaks but produce no signi cant changes, as long as one is in the superconducting state. The parameters are t = 1.0, = 0.1 and the variation in from the weakest to the strongest bond is 25%. The portion enclosed within a rectangle is enlarged in the central panel. The numbers correspond to the locations of Cu atom s within a 4 d unit supercell on the CuO₂ lattice depicted on the right panel. Note that Cu atom labeled 1 coincides with the location of the "dual vortex hole" in Fig. 5 (full green circle) where is the weakest, while the one labeled 6 corresponds to the Cu atom in the center of Fig. 5 which is surrounded by four strongest 's. The radii of the red circles indicate the magnitude of LDOS at E = 0.27t (dashed line in the central panel). This

Before we turn to the details of this energetics, we investigate the signature in the electronic structure of the 4 elementary block. Such signature could be above 4 detected in the STM experim ents of the type perform ed in Refs. 8,9,10. To this end, we com pute the dual induction B_d associated with the pattern of 7 dual vortices in Fig. 5 and from it the spatial modulation of the d-wave pseudogap ii on each bond within the 4 4 supercell. W ith thus xed, we evaluated the local density of B dG ferm ion states of our LdSC model. The results are shown in Figs. 7-9. Note that we do our computations in the \supersolid" region of the phase diagram in Fig. 4. This enables us to use the BdG form alism with only moderate sm earing in the coherence peaks com ing from the gauge elds v and a and it also allows for rather direct com parison with experiments. The downside is that we have to assume that the modulation prole in B $_{\rm d}$ remains the sam e as determ ined from our dualm ean-eld argum ents. Considering the high symmetry of elementary block in Fig. 5 this appears to be a rather m inor assumption.

VI. DUALABRIKOSOVHOFSTADTER PROBLEM

In this section we present the results of num erical analysis of the H 1 m odel. W ithin this m odel the values of the m atter eld (r) on the black sites are suppressed by very large m_b^2 , and (r) e ectively lives on the lattice dual to the original copper lattice, that is on the red sites in F ig. 2. Therefore, the dual uxes reside inside the red plaquettes, shown in F ig. 11. In this section we will drop the subscript d in order to m ake notation m ore com pact and use A (r) for the vector potential corresponding to a uniform dual magnetic ux equal to f = p=q. M odulation of the eld, which will be determ ined num erically, is described by A (r). W ithin m ean-eld approximation, our problem then is reduced to m inim ization of the follow ing

where $_{\rm r}$ is the phase of the dual matter eld (r). Since the last term s in equations (44) can be identi ed as x and y components of the lattice curl, these are the lattice analogs of the (dual) M axwell's equations in two dimensions, providing explicit lattice realization of Eq. (40).

Before we present the results of the numerical computation, we will discuss brie y the structure of the solutions that should be expected on general symmetry grounds. In the limit of in nite d the gauge eld A does not uctuate, and only (r) should be varied in minimizing H_d. To understand why the solution for a general lling is inhom ogeneous consider rst a case of g = 0. Then the functional H_d simply describes a particle on a tight-binding lattice moving in a uniform magnetic eld \overline{f} . The corresponding H am iltonian is

The minimization of the functional H $_{\rm d}$ is closely related to nding the ground states of H am iltonian $\hat{\rm H}_{\rm H\,of}$.




FIG. 8: Left panel: The local density of states (LDOS) of the lattice d-wave superconductor with the modulated bond gap function $_{ij}$ corresponding to the 4 d supercell structure of Fig. 6 at doping x = 1=8. The parameters used are the same as in Fig. 7. Right panel: the local density of states at energy E = 0.27t (dashed line in the central panel). The radii of the circles are proportional to the LDOS at a given Cu atom. Note that inside the unit cell 4 d there are three (rather than six, as in Fig. 7) non-equivalent sites. Even in absence of any underlying theory, this pattern of modulation appears to correspond to CPCDW simply by visual inspection.

Note that in general there are six⁴⁸ distinct parameters controlling m odulations of the pairing pseudogap $_{ij}$. The number of non-equivalent (black) sites, how ever, is three (see Fig. 8).

Note that although the dual magnetic eld felt by the particles is perfectly uniform, the gauge-eld A (r) is not, regardless of the gauge used. Indeed, if this were the case the circulation of the vector potential A around the primitive plaquette would be zero by periodicity, which is not possible as the circulation is equal to the ux of the magnetic eld 2 p=q through the plaquette. Thus, the H am iltonian $H_{\rm Hof}$ does not commute with the usual lattice translation operators. Instead, as noted by Peierls long time ago, magnetic translation operators T_R , generating lattice translations, must be constructed in order to commute with $\hat{H}_{\rm Hof}$.

Unlike the ordinary translations, operators $T_{\rm R}\,$ do not commute. Rather, operators $T_{\rm R}\,$ form a ray representation of the translation group. The theory for irreducible ray representations of the translation group was constructed by B row n^{45} . A lternatively, one can use the magnetic translation group introduced by Zak^{46}, and use the ordinary representations of that group to classify the eigenstates of the H am iltonian.

On the lattice, the classi cation of the states is simple and for completeness, we demonstrate how the magnetic eigenstates can be constructed. Consider for example the Landau gauge $A_x = 0$, $A_y = 2$ xp=q, in which the unit cell spans q elementary plaquettes in \hat{x} -direction. Then the Peierls factors $A_{r,r+}$, shown in Fig. 10, are periodic modulo 2 with enlarged q 1 unit cell. The Ham iltonian now can be written as



Thus the problem of diagonalization is reduced to the diagonalization of q q matrix for each k. Note, however, that we did not exhaust all the information contained in the magnetic translation operators, apart from translations by q lattice spacings in x direction. Consider an




FIG. 9: The local density of states (LDOS) of the lattice d-wave superconductor with the modulated bond gap function ij corresponding to the 4 4 supercell structure of Fig. 5 at x = 1=8, com puted under the assumption of perfect particlehole symmetry for low-energy fermionic excitations. The parameters used are the same as in Fig. 7, with the exception of the broadening, which has been suppressed here in order to demonstrate that the nodes remain essentially una ected by CPCDW¹².

pattern of LDOS is very robust in our calculations and is precisely the tight-binding analogue of the checkerboard structure observed by Hanaguri et al⁹ (note that on a tight-binding lattice, the Fourier transform s at wavevectors 2 =4a₀ and 3 2 =4a₀ are not independent since 3 2 =4a₀ and 2 =4a₀ are equivalent). The sym metry of modulations in _{ij} corresponding to Fig. 5 in ply that there are only six non-equivalent sites within the 4 4 unit cell. Note that modulation pattern at energies above is actually reversed compared to the pattern at energies below . Finally, the nodes remain e ectively intact, in accordance

with R ef. 12. Finite LD OS at zero energy is entirely due to articial broadening used to en ulate nite experimental resolution. In the absence of such broadening, the LD OS remains zero within numerical accuracy (see Fig. 9).

eigenstate described by crystalm om entum k within the B rillouin zone and characterized with wavefunction g(x).




FIG.10: Left panel: the Peierls link variables A_{ij} in Landau gauge for q = 4. denotes 2 p=q. Both $A_{r;r+x}$ and $A_{r;r+y}$ are periodic in y-direction. A line $A_{r;r+y}$ increases monotonically with x, exp($iA_{r;r+x}$) is periodic with the unit cell shown by the dashed rectangle. Right panel: the dispersion E (k_x ; k_y) of the lowest H ofstadter band for p=q = 1=4 in units of t. There are q = 4 ground states at $k_x = 0$ and $k_y = 2$ j=q, where j = 0;1;:::;q 1. For q = 4 the energy of the ground states is $E_0 = 2^{1/2} 2t$.

O ccasionally, in the theory of magnetic translation groups, this is expressed by using a reduced Brillouin zone of size (2)²=q², then every band is said to be q-fold degenerate. As a typical example, a dispersion for p=q = 1=4 is shown in the right panel of Fig. 10.

In the gauge we just described, there are q degenerate m inim a described by wavefunctions $_{j}(x;y)$ that are located at $k_x = 0$ and $k_y = 2$ m p=q, where j = 0;1;2;:::(q 1). Therefore, su ciently close to the transition, the m inimum of the functional H_d should be sought as a linear combination of the q degenerate states

Note that (49) itself has G inzburg-Landau form with q order parameters C_j . In our case, the form of the matrix ⁽⁴⁾ is dictated by our \microscopic" Ham iltonian H_d and corresponds to the Abrikosov participation ratio (48). One could in principle generalize the theory by considering completely general form of ⁽⁴⁾ compatible with the overall symmetry requirements. Equation (49) is the most direct and convenient representation for numerical minimization of H_d in the limit of in nite d. However, in order to allow for intermediate values of d and to be able to analyze the impact of various short-ranged terms describing interaction of dual uxes $B_d(r)$, we also have opted to follow a slightly different route: The numerical results that are presented below are produced by direct numericalm inimization of functional (41) with respect to both the dual matter eld and the link variables A by imposing periodic boundary conditions on N_x N_y blocks with varying N_x and N_y . At least in the vicinity of the transition, the largest unit cellone has to consider is q q. It should be stressed that we found identical results using both approaches whenever direct com parison is possible (su ciently large d and no additional short-ranged interactions between the uxes).

W e perform num ericalm in in ization of functional (41) with respect to both the matter eld (r) and the link

variables A by in posing periodic boundary conditions on n m blocks with variable m and n. The number of independent variables grows as 3m n and the largest unit cells we were able to consider are 8 8. We used the conjugate gradient m inimization technique with as m any as 10^4 10^5 random ly chosen di erent starting points.




FIG.11: Left panel: Any link of the black lattice (thick solid lines), which corresponds to $_{ij}$, is shared by two dual plaquettes shown in red. W ithin H1 m odel, therefore, the enhancement or suppression of $_{ij}$ is determined by the average of the uxes trough the neighboring plaquettes of the dual lattice (red dashed lines). Central panel: distribution of B_d at half lling. In units of t, the parameters used are $_{d}^{2} = 30.0$, m² = 1.0, and g = 2.0. The energy per site is 3:695. R ight panel: distribution of B_d at p=q = 1=4. In units of t, the parameters used are $_{d}^{2} = 30.0$, m² = 1.0, and g = 2.0. The energy per site is 3:564.

W e rem ind the reader that since the dualm atter eld variables (r) in the H1 m odel live on the on red sites, the dual uxes $B_d(r)$ reside inside the red plaquettes, shown in Fig. 11. Note that each link of the original copper lattice is shared by two red plaquettes and therefore the enhancement of the d-wave gap function should be interpreted as the average between the uxes at the neighboring dual plaquettes. Thus, at half-lling $f = \frac{1}{2}$ there is no modulation in and no charge density modulation emerging from our model H1 even though there is a checkerboard pattern in the dual ux. The checkerboard pattern remains the same for the entire range of param eters we were able to check. How ever, as explained in the previous section, since there is a de nite sym metry breaking in the dual sector by the checkerboard array of B_d (r) higher order derivatives and other term s not included in our dual Lagrangian are expected to generate




FIG.12: Left panel: The pattern of the dual uxes B_d for p=q=7=16 with periodic boundary conditions in 4 4 unit cell. The unit cell 4 4 is repeated four times in horizontal and vertical directions for presentation purposes. The energy per site is 3:193 in the units of t and the parameters of the model are the same as in the previous gure. The positive (negative) values of B_d are shown in red (black). R ight panel: the same but with 8 8 unit cell. The square lattice is distorted towards the triangular lattice. The energy per site is 3:208t and is lower by 0.5% compared to the square arrangem ent.

At eld characterized by f = p=q = 7=16, which within H1 m odel corresponds to doping x = 1=8, the structure of the con guration is considerably more com plex. W hen restricted to a 4 4 lattice, the resulting pattern is the square lattice of \crosses" separated by four unit cells, shown in Fig. 12. This con guration, however, is not the true global m in im um . If a larger unit cell for m odulations of the dual uxes is allowed, the energy can be 0:5% by distorting the ideal additionally lowered by square pattern. The lowest energy we found corresponds to the quasi-triangular lattice of crosses shown in the right panel of Fig. 12. The lowest energy state that we nd has the symmetry of this quasi-triangular pattern for all $\frac{2}{d}$ from 1:0 to 10^5 .

a weak checkerboard modulation to accompany $B_d(r)$.

The sm allness of the energy di erences, involving only few percents of the overall Abrikosov-H ofstadter energy scale, indicates that the state that em erges victorious can be changed by the additional short range interactions and derivative term s which we have routinely neglected. Not surprisingly, therefore, the precise energetics of various low energy Abrikosov-Hofstadter states is decided by details. We nd that inclusion of term s j (r) j⁶ and dual density-density interactions j (r) j² j (r +) j² with moderate coe cients does not change the patterns we described. On the other hand, the inclusion of the term s describing short-ranged interactions between the dual uxes produces signi cant e ects. An example of the typical pattern obtained by replacing the self-interaction term




FIG.13: Left panel: The pattern of the dual uxes B_1 for the H ofstadter-A brikosov problem at f = 7=16 (x = 1=8) obtained for the 8 8 unit cell. The parameters of the model are $\frac{2}{d} = 30.0$, $_0 = 6.0$, $_1 = 12.0$, $m^2 = 1.0$, and g = 2.0. The 4 4 checkerboard symmetry of the pattern is precisely what is shown in Fig. 7. Right panel: The distribution of modulations in the pairing pseudogap ij corresponding to the pattern of uxes shown on the left panel. This \tartan" pattern has the symmetry of Fig. 5 with \dual vortex holes" coinciding with black \crosses".

is shown in Fig. 13. The parameters $_0$ and $_1$ in (52) are chosen to make the distribution of the dual ux som ewhat sm oother than what is dem anded by (51) only. This su ces to bring the energy of the square pattern in Fig. 13 from just above to just below that of the quasitriangular pattern of Fig. 12. It is tem pting to speculate that this slight additional \sm oothening" of the dual ux represents the combined e ects of nodal fermions and C oulom b interactions present in real system s. Note that the sym m etry and the qualitative features of this pattern coincide with our 4 4 \elementary" block conjectured to be the likely CPCDW ground state in the previous section (see Figs. 5 and 6). Once B_d (i) are translated into

ij the resulting pattern closely resembles the checkerboard distribution of local density of states of \electron crystal" observed in the STM experiments, as illustrated in Fig. 7.

Let us now consider this observed STM checkerboard pattern in more detail, in light of our theory. Obviously, our analysis being restricted restricted to the tightbinding lattice, we cannot describe the local density of

states (LDOS) at positions between the sites of Cu lattice { the peaks in our theoretical LDOS are always located on top of Cu atom s. In contrast, the STM m easurem ents by H anaguri et al.⁹, have m uch better spatial resolution and can im age the actual continuous atom ic orbitals. Our tight-binding lattice results for LDOS (r, E) could be viewed as \coarse-grained" representation of the LDOS g (r; E) observed experim entally:

where the integral extends over a square of size $a_0 = a_0$ centered around C u lattice site R . Equivalently, the true continuum LD O S signal could be obtained by broadening our lattice LD O S around each C u lattice site.

A prominent feature of the checkerboard pattern in STM measurements that has received much attention is the presence of a pronounced Fourier signal not only at wavevectors $\frac{2}{a_0} \left(\frac{1}{4}; 0\right)$ and $\frac{2}{a_0} \left(0; \frac{1}{4}\right)$, which correspond to the 4a₀ 4a₀ periodicity just described, but also at $\frac{2}{a_0} \left(\frac{3}{4}; 0\right)$ and $\frac{2}{a_0} \left(0; \frac{3}{4}\right)$. While it is tempting to asso-

ciate the 3=4 peaks with an entirely independent type of order, we note that for a periodic lattice of identical $4a_0 - 4a_0$ tiles, the Fourier transform is a discrete series with wavevectors $Q_{n_x,n_y} = \frac{1}{4} \frac{2}{a_0} (n_x;n_y)$, where n_x and n_y are integers, irrespective of how complex is the internal structure of each tile. For a general structure of the tile all of the harm onics $(n_x;n_y)$ are present, and there is no a priori reason for the Fourier coe cients with $n_x = 3$, $n_y = 0$ to be particularly small. The presence of a large signal at $Q_{3;0}$ is only natural, and no more unexpected than the weakness of Fourier harm onics at $Q_{2;0}$ and $Q_{0;2}$.

Next, in order to describe and compare the Fourier transform sof spatially broadened LD 0 S patterns in Figs. (7-9) and tunneling LD 0 S observed in experiments⁹, we introduce a simplem odel which approximates each bright spot inside the primitive $4a_0$ $4a_0$ tile as

Parameter equals zero if the real-space LDOS peaks are centered at the Cu lattice sites, while = 1=3 if the maxima of all peaks, except for the centralone, are displaced from their commensurate positions on top of Cu atoms { this is how the experimental data were interpreted in Ref. 9. We will show that for a wide range of parameters J; A; B; C, and arbitrary 0 < < 1=3 the Q_{3;0} peaks are much stronger than peaks at Q_{2;0}, although to explain other features of Fig. 2 in Ref. 9, the \commensurate" choice = 0 appears to be more natural. of g_{m} ; 0, denoted by g_{m} ; 0, is contained in the st factor of (54). When = 0 (commensurate position of the peaks), this factor is a periodic function of m with period four, while for = 1=3 the said period is equal to three. Table I summarizes the factors g_{m} ; 0 for the two cases.

W e start our analysis with the incommensurate case




FIG.14: Left panel: Function g(r) used to emulate the LDOS signal with parameters J = 7.0, a = 1.0, b = 0.5 and c = 0.2. Center panel: Regular modi ed Bessel function $I_m(J)$ shown as a function of its index m for several values of xed J. Right panel: Fourier coe cients $g(q_x; 0)$ for LDOS pattern shown in the left panel. The reader should com pare this with the sim ilar plot in Fig. 2 of Ref. 9.

= 1=3. The third column of Table I implies that in this case $g_{1;0}$ and $g_{2;0}$ are equal and smaller than the component $g_{3;0}$, as shown in the third column of the table. Experimentally, however, the Fourier component at $Q_{1;0}$ (the 1=4 peak) is roughly of the same magnitude as $Q_{3;0}$, and it is the component at $Q_{2;0}$ that is the weakest. To account for particularly small $g_{2;0}$ g_{1;0} one has to select the value of J such that the monotonic function I_m (J) decreases rapidly in the region between m = 1 and m = 2, Fig. 14 indicates that this is the case for 3 < J. This choice, however, also dram atically suppresses the Fourier transforms at m = 3 and m = 4, both of which are rather large in experiments.

W hile the qualitative features of the Fourier transform ed experim ental LDOS could possibly be reconciled with = 1=3 by ne-tuning parameters A;B, and C, the situation m ight in fact be better described by assum - ing the commensurate location of the peaks, in registry with Cu atoms (= 0); see the second column the Table I. In this case, harm onic m = 2 is autom atically

suppressed compared to the 1=4 and 3=4 Fourier components. The suppression of Fourier component at 2=4 can be qualitatively understood as follows: This Fourier com ponent is determ ined by the overlap of the LDOS signaland $\cos(2\frac{2}{4a_0}x)$. O by busy, the maxim a of the LDOS signal correspond to alternating maxim a and minim a of $\cos(2\frac{2}{4a_0}x)$ and destructive interference of the two functions occurs. For harm onics 1=4 and 3=4 (and of course for 4=4) the overlaps are signi cant and their Fourier coe cients are larger. Peaks corresponding to larger values of m are strongly reduced due to the monotonic dependence I_m (J) of the Fourier transform on m. This suppression can serve as an estimate of parameter J: visually, the last discernible peak in Fig. 2 of Ref. 9 appears at $Q_{5:0}$, which places J in the range of 5 10 (see right panel of Fig. 14). In the right panel of Fig. 14 the spatial Fourier transform s of the LDOS (53) with parameters J = 7, A = 1, B = 0.5, and C = 0 and com mensurate placement of the peaks = 0 is shown. This example illustrates that them a jor features of the Fouriertransform ed LDOS obtained by Hanaguri et al.9 are robust properties of an elementary tile of size $4a_0$ $4a_0$ and nine peaks occupying commensurate locations at sites of the Cu lattice as depicted in our Figs. (7-9): the large m agnitude of 3=4 peak is simply a higher harm onic describing the characteristic intra-tile structure.

VII. CONCLUSIONS

O ur main goal in this paper is to devise a more realistic description of a strongly quantum and thermally uctuating d-wave superconductor, based on the theory of Ref. 5. Such description applies not only to long distance and low energy properties, which are the primary domain of⁵, but also to intermediate lengthscales, of order of several lattice spacings, and to energies up

to the pseudogap scale . This enables us to use the theory to address the experim ental observations of R efs. 8,9,10. The charge m odulation observed in those experin ents is attributed to the form ation of the Cooper pair CDW, the dynamical origin of which is in strong quantum uctuations of vortex-antivortex pairs. These quantum superconducting phase uctuations relect enhanced M ott-Hubbard correlations in underdoped cuprates as doping approaches zero. Quantum uctuating hc=2e (anti)vortices \see" physical electron as a source of a half-quantum dualmagnetic ux and the theory of the CPCDW can be form ulated as the Abrikosov-Hofstadter problem in a type-II dual superconductor¹². An XYtype model of such a dual superconductor appropriate for a lattice d-wave superconductor is constructed, both for therm aland quantum phase uctuations. The specic translational symmetry breaking patterns that arise from the dual A brikosov-H ofstadter problem are discussed for various dopings x, which determ ines the dual ux per unit cell of the CuO_2 lattice via f = p=q = (1)x)=2. In turn, the spatial modulation of the dual magnetic induction B_d corresponding to these A brikosov-H ofstadter patterns is related to the modulation in the gap function of the lattice d-wave superconductor and is used to compute LDOS observed in STM experiments. A good agreem ent is found for x = 1=8 (f = 7=16), which is the dom inant fraction of the Abrikosov-Hofstadter problem in the window of dopings where our theory applies.

APPENDIX A:TW O ALTERNATIVE DERIVATIONS OF DUAL ABRIKOSOV HOFSTADTER HAM ILTONIAN

In this Appendix we present two di erent and selfcontained derivations of the dual Abrikosov-Hofstadter Ham iltonian (37,38), either one of which can serve as an alternative to the derivation given in the main text. The rst approach is som ew hat more detailed and in a sense m ore \m icroscopic" since it uses a quantum vortexantivortex Ham iltonian as a springboard to derive the e ective dual eld theory (36). In turn, such vortexantivortex Ham iltonian in principle can be derived from the (still unknown) fully m icroscopic theory of cuprates. Incidentally, this derivation is the (2+1) dim ensional analoque of the 3D case presented in the Appendix of Ref. 6. The second derivation follow sthe fam iliarV illain approxim ation to the XY model and applies it to our specic situation. The Villain approximation is less \realistic" but provides a transparent and system atic way of deriving dual representations of XY -like m odels.

In both derivations the starting point is the e ective (2+1)D X Y model of a quantum uctuating d-wave superconductor:

where $'_{i}$ () is the uctuating phase on a site of the blue lattice in Fig. 2, the rst (im aginary) term is the charge Berry phase corresponding to the overall ux f through a plaquette the blue lattice, J is the nearest neighbor XY coupling, $J_{1(2)}$ are the next nearest neighbor XY couplings along red (black) diagonals, L_{nodal} is the contribution of nodal ferm ions, and $\mathrm{L}_{\,\mathrm{core}}$ denotes core contributions arising from sm all regions around vortices where the pairing pseudogap is signi cantly suppressed { this, for example, generally includes the mass term (25), the energy cost of core-core overlap, the Bardeen-Stephen core dissipation, etc. The reader should bear in mind that the last e ect is small in cuprates, as explained in the main text, and will be neglected in the Appendix. Furtherm ore, we are neglecting vortex interactions with the spin of low energy nodal ferm ions, represented by the Berry gauge eld a; this is justi ed away from the critical point. The results below are easily adapted to the extended s-wave pairing symmetry. Similarly, both

derivations are straightforwardly applied to a yet simpler case, a uctuating s-wave superconductor:

We recognize Z_v^d as equivalent to a partition function of two species of non-relativistic quantum bosons expressed in the Feynm an path integral representation over particle worldline trajectories. These vortex and antivortex bosons have identical mass M and carry dual charges + 2 and 2, respectively, through which they couple to a dynamical gauge eld A_d . The dual photons of A_d m ediate long range \electrodynam ic" interactions between the bosons, which are just the fam iliar Biot-Savart interactions between (anti)vortices. In addition, the particles interact through an assortm ent of short range interactions contained in H^{d}_{core} (A8). Furtherm ore, L_{nodal} describes the interactions generated by nodal D irac-like ferm ions which will be included explicitly once we arrive at the dual representation of (A 12), as detailed in Section IV.Finally, the vortex potentialV (r) contains in portant inform ation about the underlying lattice structure and the sym m etry of the order param eter, as emphasized throughout the text.

We have derived Z_v^d as a continuum limit approxim ation to the partition function ${\rm Z}_{\rm X~Y}^{\rm ~d}$ (A 3) of the quantum XY type model (A1). Actually, in real cuprates and in all other physical system s, the opposite is true: It is the quantum XY-type representation that is an approxim ation to Z_v^d . Z_v^d captures the general description of the quantum vortex-antivortex system, applicable to all superconductors and super uids whose order param eter is a complex scalar. To appreciate this, in agine that for each given con guration of the phase, with (anti)vortex positions xed in Euclidean spacetime, the microscopic action of a physical system is minimized with respect to the amplitude, after all other degrees of freedom have been integrated out. The subsequent sum mation over all distinct (anti)vortex positions leads to precisely Z_{v}^{d} as the nalresult (again, we rem ind the reader that the core dissipative term s will also generically appear in Z_{v}^{d} but, being sm all in underdoped cuprates, are neglected here as explained in the main text). In practice, this procedure is di cult to carry out explicitly and the actual values of various terms that enter Z_v^d are hard to determ ine from \ rst principles". This is particularly true for core-core interaction terms appearing in H ^d_{core}. For our purposes it will su ce to approximate $V^{(2)}(\mathbf{r};\mathbf{r}^{0})$! g (r \mathbf{r}), where q > 0, and drop the rest.

There is one crucial feature which distinguishes Z_v^d from the standard Feynm an partition function: The vortex and antivortex quantum bosons are not conserved.

As particles make their way through in aginary time, vortices and antivortices can annihilate each other; similarly, they can also be created at an instant in time; this is depicted in Fig. 3. All such processes of creation and annihilation proceed in pairs of vortices and antivortices. Consequently, while the individual number of vortices and antivortices is not conserved, the vorticity, measured by dual charge $e_d = 2$, is conserved and the gauge symmetry associated with A_d is always maintained (unless, of course, it is spontaneously broken by a dual Higgs mechanism in dual super uid). In other words, these nonrelativistic (anti)vortex bosons propagate through spacetime permeated by a vortex-antivortex condensate, of strength v.

Feynm an path integrals are beautiful but di cult to calculate with. Following the standard mapping⁴⁷ we can express Z_v^d as a functional integral over complex elds $_v(r;)$ and $_a(r;)$, which are the eigenvalues of vortex and antivortex annihilation operators, respectively, in the basis of coherent states:

where the m eaning of various term s is straightforward in light of our earlier discussion; we have consolidated the notation so that $e_d = 2$, $K = (K_0; J; J)$, the chem ical potential for vortices is v = a, and g describes the short range core-core repulsions. The \vortex-antivortex pairing" function v is crucial since it regulates the frequency of vortex-antivortex pair creation and annihilation processes.

The form of Z_v^d can be further simplied by exploiting the vorticity conservation law. The dual partition function Z_d (A18) is the nalresult of this subsection. It describes the system of relativistic quantum bosons of mass m and charge $e_d = 2$ in a magnetic eld $B_d = r = A_d^{(0)}$. The virtual particleantipatticle creation and annihilation processes in the vacuum of this theory are nothing but quantum vortex-(rantivortex pair excitations evolving in imaginary time $(\sec(106)3)$. In the \norm all vacuum, m² > 0, the average size of such pairs is m^{-1} . This is just the superconducting ground state of physical underdoped cuprates. For $m^2 < 0$, this \norm al" vacuum is unstable to a Higgs phase, with a nite dual condensate hi. The vortex-antivortex pairs unbind as in nite loops of virtual particle-antiparticle excitations of permeate this dual Higgs vacuum { this is the pseudogap state of cuprates. The integration over the Hubbard-Stratonovich eld produces a short range repulsion $\frac{1}{2}$ (4j $\sqrt{2}$)gj j⁴ follow ed by an assortm ent of other short range interactions including V (r), powers of j j higher than quartic and various derivatives. All these additional interactions are irrelevant in the sense of long distance behavior but might play som e quantitative role at interm ediate lengthscales. For sim plicity, we shall mostly ignore them in this paper. Finally, with the change of notation $4j_v jg ! g$ and L_{nodal} incorporated into the self-action for A_d as detailed in Section IV, the dual Lagrangian in (A18) reduces to L_d (36). The arguments in the text can then be followed $_{17}$ to arrive at H d (37,38).

2. H_d in the V illain approxim ation

A useful approximation to the ordinary XY model is due to Villain. In this approximation the exponential of the cosine function is replaced by an in nite sum of the exponentials of parabolas. We will illustrate this approximation rst for the 2D case and follow up with the (2+1)D quantum XY-like model.

a. Classical (therm al) phase uctuations

Here we apply the Villain approximation to our classical XY model of a phase uctuating two-dimensional d-wave superconductor (14). Note that in the absence of the next nearest neighbors interactions, a similar expression (A 85) contained no quadratic terms $l^2(r)$ and the core energy $\frac{1}{v(0)}l^2(r)$ was introduces by hand. In the present case, the di erence E_c^0 of the core energies on the black and red sites is nite due to the anisotropic next nearest neighbors interactions. How ever, the average magnitude is still zero within our model, and here we also need to introduce a constant average core energy term $\frac{1}{v(0)}l^2(r)$. Thereby we replace $E_c^0()$ in (A 128) by

Since aij is ultimately given by the (half of) phase di erences (' $_{i"}$ ' $_{j"}$) (' $_{i\#}$ ' $_{j\#}$) { expressed in term s of $_{ij}$'s { its con gurations are non-com pact, i.e. m onopole free, by construction.
