A bstract^y

We consider a model of a D-dimensional tethered manifold interacting by excluded volume in \mathbb{R}^d with a single point. Use of intrinsic distance geometry provides a rigorous denition of the analytic continuation of the perturbative expansion for arbitrary D, 0 < D < 2. Its one-loop renormalizability is rst established by direct resummation. A renormalization operation R is then described, which ensures renormalizability to all orders. The similar question of the renormalizability of the self-avoiding manifold (SAM) Edwards model is then considered, rst at one-loop, then to all orders. We describe a short-distance multi-local operator product expansion, which extends methods of local eld theories to a large class of models with non-local singular interactions. It vindicates the direct renormalization method used earlier in part I of these lectures, as well as the corresponding scaling laws.

1. INTERACTING MANIFOLD RENORMALIZATION: A BRIEF HISTORY

As can be seen in the set of lectures in this volume, which presents an extended version of [1], the statistical mechanics of random surfaces and membranes, or more generally of extended objects, poses fundamental problems. The study of polymerized membranes, which are generalizations of linear polymers [2,3] to two-dimensionally connected networks, is emphasized, with a number of possible experimental realizations [4,5,6,7,8], or numerical simulations [9,10]. From a theoretical point of view, a clear challenge in the late eighties was to understand self-avoidance (SA) elects in membranes.

The model proposed in [11,12] aim ed to incorporate the advances made in polymer theory by renormalization group (RG) methods into the eld of polymerized, or tethered, membranes. As we saw in part I of these lectures, these extended objects, a priority two-dimensional in nature, are generalized for theoretical purposes to intrinsically D { dimensional manifolds with internal points $x \in \mathbb{R}^D$, embedded in external d-dimensional space with position vector $\mathbf{r}(x) \in \mathbb{R}^d$. The associated continuum Hamiltonian H generalizes that of Edwards for polymers [2]:

performed via the direct renormalization method adapted from that of des Cloizeaux in polymer theory [14], as we explained in part I.

Only the polymer case, with an integer internal dimension D=1, can be mapped, following de Gennes [15], onto a standard eld theory, namely a $(^2(r))^2$ theory for an n-component eld (r) in external d-dimensional space, with n! = 0 components. This is instrumental in showing that the direct renormalization method for polymers is mathematically sound [16], and equivalent to rigorous renormalization schemes in standard local eld theory, such as the Bogoliubov {Parasiuk {Hepp{Zimmermann(BPHZ) construction [17]. Formanifold theory, we have to deal with non-integer internal dimensions D, $D \in 1$, and no such mapping exists. Therefore, two outstanding problems remained in the theory of interacting manifolds: (a) the mathematical meaning of a continuous internal dimension D; (b) the actual renormalizability of the perturbative expansion of a manifold model like (1.1), in plying the scaling behavior expected on physical grounds.




Fig. 1: (a) A D \rightarrow m anifold interacting with an impurity located at point 0 in R^d; (b) interaction with an Euclidean hyperplane of dimension D⁰ in R^{d⁰}, with d⁰ = d + D⁰.

In [18], a sim pler m odel was proposed, of a crum pled m anifold interacting by excluded volume with a xed Euclidean subspace of \mathbb{R}^d [19]. The simplied m odel H am iltonian introduced there reads:

with a pointwise interaction of the Gaussian manifold with an impurity located at the origin (Fig. 1a). Note that this Hamiltonian also represents interactions of a uctuating

(possibly directed) manifold with a non uctuating D 0 -Euclidean hyperplane of R $^{d+D}$, r then standing for the coordinates transverse to this subspace (Fig. 1b). The excluded volume case (b>0) parallels that of the Edwards model (1.1) for SA-manifolds, while an attractive interaction (b<0) is also possible, describing pinning phenomena. The (naive) dimensions of r and b are respectively [r] = [x] with a Gaussian size exponent

For xed D and , the parameter d (or equivalently ") controls the relevance of the interaction, with the exclusion of a point only e ective for d $d^2 = D = .$ Note that in this model the size exponent is not modified by the local interaction and stays equal to its G aussian value (1.6), whereas the correlation functions obey (non-G aussian) universal scaling laws.

For D = 1, the model is exactly solvable [18]. For D \in 1, the direct resum mation of leading divergences of the perturbation series is possible for model (1.5) and indeed validates one-loop renormalization [18]. This result was also extended to the Edwards model (1.1) itself [20].

A study to all orders of the interaction model (1.5) was later performed in [21], [22]. A mathematical construction of the D-dimensional internal measure d^D x via distance geometry within the elastic manifold was given, with expressions for manifold Feynman integrals which generalize the -parameter representation of eld theory. In the case of the manifold model of [18], the essential properties which make it renormalizable to all orders by a renormalization of the coupling constant were established. This led to a direct construction of a renormalization operation, generalizing the BPHZ construction to manifolds (see also [23] [24].)

Later, the full Edwards model of self-avoiding manifolds (1.1) was studied by the same methods, and its renormalizability established to allorders [25], [26]. Eective calculations to second order in "(\two-loop" order) were performed in [27]. The large order behavior of the Edwards model (1.1) was nally studied in [28].

The aim of part II of these notes is to review some of these developments.

2. M AN IFOLD MODEL WITH LOCAL INTERACTION

2.1. Perturbative expansion

In this chapter, we study the statistical m echanics of the sim pli ed m odel H am iltonian (1.5). The m odel is described by its (connected) partition function




Fig. 2: Interaction points x_i ; insertion point x_0 for the external m omentum $\tilde{\kappa}$.

The structure of divergences of the generic term I_N will be studied in detail in the next sections. They will be shown to be only local divergences, obtained by letting any interaction point subset coalesce. Here, the leading divergence is evaluated as follows.

Thus the one-loop renormalizability of the manifold model has been directly established by direct resum mation of the perturbation expansion [18].

This is con med by consideration of the vertex function (2.2). The same evaluation of (2.20) gives, after successive contractions of pairs of points in the determ inants in (2.19), (2.20), the leading divergence:




Fig. 3: Passage from Euclidean coordinates x_i to the complete set of squared distances a_{ij} .

2.5. A nalytic continuation in D of the Euclidean measure

Integrals like (2.17) or (2.20), written with Cartesian coordinates, are a priori meaningful only for integer D. Up to now, we have only formally extended such integrals to non-integer dimensions. A ctually, an analytic continuation in D can be performed by use of distance geometry [22]. The key idea is to substitute for the internal Euclidean coordinates x_i the set of all mutual (squared) distances $a_{ij} = (x_i x_j)^2$ (Fig. 3).

This is possible for integrands invariant under the group of Euclidean motions (as in (2.17) and (2.20)). For N integration points, it also requires, before analytic continuation, D to be large enough, i.e., D N 1, such that the N 1 relative vectors spanning these points are linearly independent.

We do not he graph G as the set G=f1;:::;N g labelling the interaction points. Vertices i 2 G will be rem nants of the original Euclidean points after analytic continuation, and index the squared distance matrix $[a_{ij}]$. The change of variables fx_ig_{i2G} ! a $[a_{ij}]_{\substack{i< j\\ij2G}}$ reads explicitly [22]:

For integer D $_{G}$ G j 2, although the change of variables from x_{i} to a_{ij} no longer exists, Eq.(2.44) still reconstructs the correct m easure, concentrated on D -dim ensional submanifolds of R $_{G}^{N-1}$, i.e., P_{K} = 0 if D $_{G}$ K j 2 [22]. For example, when D ! 1 for N = 3 vertices, we have, denoting the distances jij = $_{G}^{P}$ G a ij:

which are D-dimensional extensions of the Schwinger -parameter representation. We now have to study the actual convergence of these integrals and, possibly, their renormalization.

2.6. A nalysis of divergences

Large distance infrared (IR) divergences occur for manifolds of in nite size. One can keep a nite size, preserve symmetries and avoid boundary elects by choosing as a manifold the D-dimensional sphere S_D of radius R in R^{D+1} . This amounts [22] in distance geometry to substituting for P_G (a) the \spherical polynomial P_G^S (a) P_G (a) + $\frac{1}{R^2}$ det ($\frac{1}{2}$ a), the second term providing an IR cut-o, such that $a_{ij}=4R^2$. In the following, this IR regularization will simply be ignored when dealing with short-distance properties, for which we can take P_G^S P_G . This was also the case when evaluating leading divergences in the sections above.

The complete description of the possible set of divergences is then obtained from the following theorem of distance geometry [29]:

Schoenberg's theorem . For 0 < < 1, the set $a = [a_{ij}]_{i,j}^{i,j}$ can be realized as the set of squared distances of a transform ed simplex in R^N , whose volume P_G (a) is positive, and vanishes if and only if at least one of the mutual original distances itself vanishes, $a_{ij} = 0$.

This ensures that, as in eld theory, the only source of divergences in I_G and $I_G^{(0)}$ is at short distances. Whether these UV singularities are integrable or not will depend on whether the external space dimension $d < d^2 = D = \text{ or } d > d^2$.




Fig. 4: Factorization property (2.50).

The geometrical interpretation of (2.50) is quite simple: the contribution of the set G splits into that of the contracting subgraph P multiplied by that of the whole set G where P has been replaced by its root p (Fig. 4), all correlation distances between these subsets being suppressed. The factorization property (2.50) is the generalization, to an arbitrary set P of contracting points, of the factorization encountered in (2.32) for the contraction of a pair of points. This is simply, in this interacting manifold model, the rigorous expression of an operator product expansion [22].

The factorization property (2.50) does not hold for = 1, preventing a factorization of the m easure (2.44) d $_{\rm G}^{(D)}$ (a) itself. Still, the integral of the m easure, when applied to a factorized integrand, does factorize as:

This fact, explicit for integer D with a readily factorized measure $\frac{Q}{d} \times_i$, is preserved [22] by analytic continuation only after integration over relative distances between the two \com plem entary" subsets P and G = P.

2.8. R enorm alization

A rst consequence of factorizations (2.50) and (2.51) is the absolute convergence of Z $_{\rm N}$ and Z $_{\rm N}^{(0)}$ for " > 0. Indeed, the super cial degree of divergence of Z $_{\rm N}$ (in distance

units) is (N 1)", as can be read from (2.49), already ensuring the super cial convergence when "> 0. The above factorizations ensure that the super cial degree of divergence in Z_N or $Z_N^{(0)}$ of any subgraph P of G is exactly that of Z_{Pj} itself, i.e., (Pj 1)"> 0. By recursion, this ensures the absolute convergence of the manifold Feynman integrals. A complete discussion has recourse to a generalized notion of Hepp sectors and is given in [22]. In the proof, it is convenient to rst consider D large enough where $d_G^{(D)}$ is a non-singular measure, with a xed considered as an independent variable 0 < < 1, and to then continue to D = 2 + 2 + 0 < 0 < 2, corresponding to the physical case.

When "= 0, the integrals giving Z_N and $Z_N^{(0)}$ are (logarithm ically) divergent. A nother consequence of Eqs. (2.50) and (2.51) is thus the possibility to devise a renormalization operation R, as follows. To each contracting rooted subgraph (P;p) of G, we associate a Taylor operator $T_{(P,p)}$, performing on interaction integrands the exact factorization corresponding to (2.50):

In manifold theory, we de near roted forest as a set of rooted subgraphs (P;p) such that any two subgraphs are either disjoint or nested, i.e., never partially overlap. Each of these subgraphs in the forest will be contracted toward its root under the action (2.52) of the corresponding Taylor operator. When two subgraphs P P are nested, the smallest one is contracted rst toward its root p, the root p of P being itself attracted toward p if p happened to be in P. This hierarchical structure is anticipated by choosing the roots of the forest as compatible: in the case described above, if p 2 P, then p p. F in ally, the renormalization operator is written as a sum over all such compatibly rooted forests of G, denoted by F:

Here W is a necessary combinatorial weight associated with the degeneracy of compatible rootings, W (F) = ${}^{\rm p}_{\rm post}$ 1= ${}^{\rm p}$ (p) j with P (p) being the largest subgraph of the forest F whose root is p. An important property is that, with compatible roots, the Taylor operators of a given forest now commute [22]. The renormalized amplitudes are dened as

The same operation R acting on I_G leads automatically by homogeneity to R $[I_G] = 0$ for ${}^t\!\!Gj$ 2. We state the essential result that now the renormalized Feynman integral (2.54) is convergent: $Z_N^{R} = 0$. A complete proof of this renormalizability property is given in [22] the analysis being inspired from the direct proof by Bergere and Lam of the renormalizability in eld theory of Feynman amplitudes in the -representation [30].

The physical interpretation of the renormalized amplitude (2.54) and of (2.53) is simple. Equations (2.51) and (2.52) show that the substitution for the bare amplitudes (2.49) of the renormalized ones (2.54) amounts to a reorganization to all orders of the original perturbation series in b, leading to the remarkable identity:

This actually extends to any vertex function, showing that the theory is made perturbatively nite (at "=0) by a full renormalization of the coupling constant b into Z itself, in agreement with the denition of the second virial coecient g (2.23) above. From this result, one establishes the existence to all orders of the W ilson function (2.37)

describing the scaling properties of the interacting manifold for "close to zero, and which has a nite limit up to "=0 [22]. For ">0, an IR xed point at b>0 yields universal excluded volume exponents; for "<0, the associated UV xed point at b<0 describes a localization transition.

This demonstrated how to de ne an interacting manifold model with continuous internal dimension, by use of distance geometry, as a natural extension of the Schwinger representation for eld theories. Furthermore, in the case of a pointwise interaction, the manifold model is indeed renormalizable to all orders. The main ingredients are Schoenberg's theorem of distance geometry, insuring that divergences occur only at short distances for (nite) manifolds, and the short-distance factorization of the generalized Feynman amplitudes. This provided probably the rst example of a perturbative renormalization established for extended geometrical objects [22]. This opens the way to the renormalization theory of self-avoiding manifolds, which we now sketch.

3. SELF-AVOID IN G MANIFOLDS & EDWARDS MODELS

3.1. Introduction

In this part, we concentrate on the renormalization theory of the model of tethered self-avoiding manifolds (SAM) [11,12], directly inspired by the Edwards model for polymers [2]:

with an elastic Gaussian term and a self-avoidance two-body -potential with excluded volume parameter b > 0. Notice that in contrast with the local interaction model (1.5) studied in x2, the interaction here is non-local in \m anifold space" \mathbb{R}^{D} .

The nite upper critical dimension (u.c.d.) d^2 for the SA interaction exists only for manifolds with a continuous internal dimension 0 < D < 2. For D ! 2, $d^2 ! + 1$. Phantom manifolds (b=0) are crumpled with a nite Hausdor dimension $d_H = 2D = (2D)$, and $d^2 = 2d_H$. The "-expansion about d^2 performed in [11,12,13], and described in part I above, was directly inspired by the des C loizeaux direct renormalization (DR) method in polymer theory [14]. But the issue of the consistency of the DR method remained unanswered, since for $D \in I$, model (3.1) cannot be mapped onto a standard ($I^2 = I^2 + I^2$

The question of boundary exects in relation to the value of the conguration exponent also requires some study [13]. It caused some confusion in earlier publications [11,12,13]. In part I of these lectures, we showed that a nite self-avoiding patch embedded in an in nite Gaussian manifold has exponent = 1 for any 0 < D < 2; $D \in 1$. Here the cases of closed or open manifolds with free boundaries will be considered.

3.2. Renorm alizability to rst order

The validity of RG m ethods and of scaling laws was rst justied at leading order in "through explicit resum mations in [20], in close analogy to the procedure described in x23 above for the —interaction impurity model. We shall not repeat all the arguments here, but comment on some signicant results.

Let us consider the spatial correlation function $[r(x) \quad r(0)]^2$: For a Gaussian (in - nite) manifold it equals

When truncated to this order, their solutions are exactly the resum med expressions (3.13) and (3.10). Turning things around, the direct resum mation of leading poles in "indeed establishes one-loop renormalizability [18,20].

3.3. Renorm alizabilty to all orders

We brie y describe below the form alism that allows to prove the validity of the RG approach to self-avoiding manifolds, as well as to a larger class of manifold models with non-local interactions. (See [22], [26], for further details.). This form alism is based on an operator product expansion involving multi-local singular operators, which allows a system atic analysis of the short-distance ultraviolet singularities of the Edwards model. At the critical dimension d?, one can classify all of the relevant operators and show that the model (3.1) is renormalizable to all orders by renormalizations (i) of the coupling b; and (ii) of the position eld r. As a consequence, one establishes the validity of scaling laws for in nite membranes, as well as the existence of nite size scaling laws for nite membranes. The latter result ensures the consistency of the DR approach.

A peculiar result, which distinguishes manifolds with non-integer D from open linear polymers with D = 1, is the absence of boundary operator multiplicative renormalization, leading to the general hyperscaling relation for the conguration exponent

valid for nite SAM with 0 < D < 2, $D \in 1$. Note that this hyperscaling value is also valid for closed linear polymers (see, e.g., [31].) This result is valid for closed or open manifolds with free boundaries, and has the same origin as the result = 1 obtained in part I for a nite SA patch embedded in an in nite manifold (see I. x2:2:2 and x2:2:3:)

3.4. Perturbation theory and dipole representation




Fig. 5: The dipole representing the interaction in (324).




Fig. 6: Dipole and charges representing bi-local operators and external vertex operators in (3.23).

Note that a proper analytic continuation in D of (329) and (331) is insured, as in Section 2 above, by the use of distance geometry, where the Euclidean measure over the x_i is understood as the corresponding measure over the mutual squared distances $a_{ij} = jx_i \quad x_j j^2$, a distribution analytic in D [22].

3.5. Singular con gurations and electrostatics in $\mathbb{R}^{\mathbb{R}}$

Singular fx_ig con gurations, with = 0, still exist when Q is degenerate, which happens when some dipoles are assembled in such a way that, with appropriate non-zero




Fig. 7: The notions of \atom s" and \m olecules", built up from dipoles.




Fig. 8: A general diagram with two external points and three internal dipoles, representing bi-local interactions $_{a}$ (a); \m olecules" describing singular con gurations with one (b), two (c,d) and three (e) \atom s". (b,c,d) give UV divergences, (e) does not.

charges, they still can build neutral atom s. This requires some of the points x_i to coincide and the corresponding dipoles to form at least one closed loop (Fig. 7). This ensures that the only sources of divergences are short-distance singularities, and extends the Schoenberg theorem used above.

3.6. M ulti-local O perator P roduct Expansion

A singular con guration can thus be viewed as a connected $\mbox{molecule}$ " (Fig. 7), characterized by a set M of $\mbox{atom s}$ " p with assigned positions x_p , and by a set L of links a between these atom s, representing the dipolar constraints C_a associated with the

a d($\mathbf{r}(\mathbf{x}_{2a})$ $\mathbf{r}(\mathbf{x}_{2a-1})$) interactions. For each p, we denote by P_p the set of charges i, at \mathbf{x}_i , close to point p, which build the atom p and de ne the relative (short) distances $y_i = \mathbf{x}_i$ \mathbf{x}_p for i 2 P_p (Fig. 8).

The short-distance singularity of $^{d=2}$ is then analyzed by performing a small y_i expansion of the product of the bilocal operators $_a$ for the links a 2 L, in the Gaussian manifold theory (Eq. (3.23)). This expansion around M can be written as a multi-local operator product expansion (MOPE)

Here $A_p(x_p)$ $A^{(r_p;s_p)}$ $[r_x;r(x_p)]$ is a local operator at point x_p , which is a combination of powers of x-derivatives and eld r, of degree s_p in $r(x_p)$ and degree r_p s_p in r_x . $(r_x)^{q_p}$ denotes a product of q_p derivatives with respect to r, acting on $r_p(x_p)$. The symbol $r_p(x_p)$: "denotes the normal product subtraction prescription at $r_p(x_p)$ which, in a Gaussian average, amounts to setting to zero any derivative of the propagator $r_p(x_p)$ at coinciding points $r_p(x_p)$. where C^{A_p} fy_i; K_i g is a monom ial in the fy_i; K_i g's, associated with the operator A_p , of similar global degree r_p in the fy_ig's, and s_p in the f K_i g's. The product ⁰ is over all constraints a 2 L but one.

The MOPE (3.33) follows from the expression (3.24) in terms of free eld exponentials plus constraints, and is established in [26].




Fig. 9: \M olecules" M producing (a) the one-body local elastic term = : $(r r_p)^2$; and (b) the two-body SA interaction term = $^d (r_p r_p)$.

3.7. Power counting and renormalization

The MOPE (3.33) allows us to determ ine those singular congurations which give rise to actual UV divergences in the manifold integrals (3.29) or (3.31). Indeed, for a given singular conguration M, by integrating over the domain where the relative positions $y_i = x_i - x_p$ are of order $y_i j^<$, we can use the MOPE (3.33) to obtain an expansion of the integrand in (3.23) in powers of . Each coecient C ... gives a contribution of order , with degree! given by power counting as

with $_0$ = (2 D)=2 < 1 and r_p s_p . Whenever! 0, a UV divergence occurs, as a factor multiplying the insertion of the corresponding operator.

At the upper critical dim ension $d^2=2D=_0$,! become sindependent of the number J j of dipoles, and is equal to the canonical dimension! of $\int_{p2M}^R d^D x_p fx_p g$ in the Gaussian theory.

Only three relevant multi-local operators , with! 0 and such that the corresponding coe cient does not vanish by symmetry, are found by simple inspection. Two of these operators are marginal (! = 0) at d^2 : (i) the one-body local elastic term: $(r r_p)^2$; obtained for M j= 1 (q= 0, r= s= 2); (ii) the two-body SA interaction term $(r_p)^2$; itself, obtained through singular congurations with M j= 2 atoms (and with q= r= s= 0 for p and p^0) (see Fig. 9).

A third operator is relevant with ! = D, i.e., the identity operator 1 obtained when M = 1 (q= r = s = 0). It describes insertions of local \free energy divergences

along the manifold, proportional to the manifold volume, which factor out of partition functions like (3.19), to cancel out in correlation functions (3.23), as already explained in part I, x2.22:

The above analysis deals with super cial UV divergences only. A complete analysis of the general UV singularities associated with successive contractions toward \nested" singular con gurations can be performed [26], using the same techniques as in [22] (II. $\times 2.8$ above). A basic fact is that an iteration of the MOPE only generates multi-local operators of the same type (3.34).

The results are [26]: (i) that the observables (3.23) are UV nite for $d < d^2$ (D), and are m erom orphic functions in d w ith poles at $d = d^2$; (ii) that a renorm alization operation R, sim ilar to the subtraction operation of x 2:8 above [22], can be achieved to rem ove these poles; (iii) that this operation amounts to a renormalization of the H amiltonian (3.1).

M ore explicitly, the renormalized correlation functions $\sum_{l=1}^{P} e^{iq_1 x_R (z_1)}$ have a nite perturbative expansion in the renormalized coupling b_R , when b_R is the average w.r.t the renormalized H am iltonian

Here is a renormalization (internal) momentum scale, necessary for in nite manifolds, $"=4D-2d_0; Z(b_k)$ and $Z_b(b_k)$ are respectively the eld and coupling constant renormalization factors, singular at "=0.

At rst order, one nds by explicitly calculating $C^{(r r)^2}$ and C that [26]

with $A_D = [S_D (2 D)=2]^{-1}$. For quantities which do not stay nite in the in nite manifold limit V + 1, like partition functions, a shift in the free energy (i.e., an \additive contexterm " in H_R), proportional to V, is also necessary.

Expressing the observables of the SAM model (3.1) in terms of renormalized variables $\mathbf{r}=\mathbf{Z}^{1=2}~\mathbf{r}_{_{\!\!R}}$, $\mathbf{b}=\mathbf{b}_{_{\!\!R}}$ "=2 $\mathbf{Z}_{_{\!\!D}}$ $\mathbf{Z}^{d=2}$, one can derive in the standard way RG equations involving W ilson's functions W ($\mathbf{b}_{_{\!\!R}}$) = $\frac{\varrho}{\varrho}$ $\mathbf{b}_{_{\!\!R}}$ $\mathbf{b}_{_{\!\!R}}$, ($\mathbf{b}_{_{\!\!R}}$) = 0 $\frac{1}{2}$ $\frac{\varrho}{\varrho}$ $\ln \mathbf{Z}_{_{\!\!D}}$. A non-trivial R xed point $\mathbf{b}_{_{\!\!R}}^2$ / " such that W ($\mathbf{b}_{_{\!\!R}}^2$) = 0 is found for " > 0. It governs the large distance

behavior of the SA in nite manifold, which obeys scaling laws characterized by the size exponent. The value obtained in this approach, = $(p_{\rm g}^2)$, coincides with that obtained at rst order in " in Eq. (3.7) above [11-13, 20].⁴

3.8. F in ite size scaling and direct renorm alization

The direct renormalization formalism considered in part I, and in II. x32 above, deals with nite manifolds with internal volume V, and expresses scaling functions in terms of a dimensionless second virial coe cient (3.12) $g = (2 R^2 = d)^{d=2} Z_{2;c} = (Z_1)^2$, where $Z_1(V) (= Z = Z_0)$ and $Z_{2;c}(V)$ are respectively the one- and (connected) two-membrane partition functions, and R is the elective radius of the membrane.

When dealing with a nite closed manifold (for instance the D-dimensional sphere S_D (II.x2:6 and [22]), characterized by its (curved) internal metric, the massless propagator G gets modied. Nevertheless, from the short-distance expansion of G in a general metric, one can show that the short-distance MOPE (3.33) remains valid. The expansion then extends to multi-local operators of the form (3.34), with local operators A (x) which may involve the Riemann curvature tensor and its derivatives, with appropriate coe cients C_{iii} [26]. Still, the coe cients for those operators that do not involve derivatives of the metric stay the same as in Euclidean at space.

At d^2 , UV divergences still come with insertions of relevant multi-local operators with! 0. When 0 < D < 2, the operators involving curvature are found by power counting to be all irrelevant. Thus the at in nite membrane counterterms Z and Z still renormalize the (curved) nite membrane theory. Standard arguments parallel to those of [16] for polymers then help to establish the direct renormalization formalism (see [26]). The second virial coe cient g(b;V) (as any dimensionless scaling function) is UV nite once expressed as a function $g_R(b_R;V)$ of $b_R(and)$. Then the scaling functions, when expressed in terms of g(b) obey RG ow equations, and stay nite up to " = 0. The expansion at the origin of the massless propagator G on a curved manifold reads in R iem ann normal coordinates $G(x)' G(x) = \frac{j x j^2}{2D}$: $(r r)^2$:, with $G(x) / j x j^2$ the propagator in in nite at space, and next order term sO $(j x j^4)^D$) proportional to the curvature and subdom in ant for D < 2; the normal product (: :) is still dened w.r.t. in nite at space, and gives explicitly for a nite manifold with volume V: $(r r)^2$: = 1=V.

3.9. Hyperscaling

Let us rst consider a closed manifold. As mentioned above, the renormalization of partition functions for a (nite) SAM requires a shift ($f_D X^D$) of the free energy, proportional to the manifold volume V, and corresponding to the integration of a local contact divergence in the bulk. The con guration exponent is then de ned by the scaling of the partition function 6

A consequence of the absence for closed SAM, for 0 < D < 2, of relevant geom etrical operators other than the point insertion one, is the general hyperscaling law (3.17) relating to : 1 = d = D: Indeed, from (3.38), Z_1 is simply multiplicatively renormalized as Z_1 (b; $V) = Z^{d=2}Z_1^R$ (b, V^D). This validates the hyperscaling hypothesis that Z_1 is $V^{d=D}$. Eq. (3.17) can been checked explicitly at order "for the sphere S_D and the torus T_D .

For an open SAM with free boundaries, and when 1 D < 2, the boundary operator R $d^D_{boundary}^1 x 1$ is relevant, requiring a boundary free energy shift ($f_D_1 x^{D-1}$). Since this does not enter into the bulk MOPE, it does not modify the renormalizations of r and b. Furthermore, only for integer D=1 is it marginally relevant [13], as explained in part I; thus for $D \in I$ the hyperscaling relation (3.17) remains valid. Only for open polymers at D=1, do the corresponding (zero-dimensional) end-point divergences enter the multiplicative renormalization of Z_1 , and becomes an independent exponent. In polymer theory, an independent exponent actually appears for each star vertex [32].

Previous calculations [11,12,13] did not involve the massless propagator G on a nite manifold with Neumann boundary conditions, but the simpler propagator G (3.28), corresponding to a nite SA patch immersed in an in nite Gaussian manifold. The same non-renormalization argument, as explained in [13] and in part I, yields = 1 for non-integer D.

When D = 2, operators involving curvature and boundaries become relevant, and (3.17) is not expected to hold, either for closed or open manifolds.

⁶ Here we consider Z_1 (V) exp(f_D X D) $Z=Z_0$; i.e., the dimensionally regularized partition function, which includes the free energy shift (see I.x222).

3.10. -point and long-range interactions

The above form alism is actually directly applicable to a large class of manifold models where the interaction can be expressed in terms of free eld exponentials with suitable neutrality constraints C_a fK_ig. Examples of such interactions are the n-body contact potentials, or the two-body long-range C oulomb potential 1=jr $r^0 j^{d-2}$, represented by modified dipolar constraints CfK_ig = jKj $^{2-d}$ (K + K⁰). In these models the MOPE involves the same multi-local operators as in (3.34), with coe cients (3.35) built with the corresponding constraints C_a .

As an application of the MOPE, one nds that for a polymerized membrane at the point where the two-body term bin (3.1) vanishes, them ost relevant short-range interaction is either the usual tricritical three-body contact potential, with u.c.d. $d_3^2 = 3D = (2 D)$, as for ordinary polymers [33], or the two-body singular potential r^d (r^d) with u.c.d. $d_2^2 = 2(3D 2) = (2 D)$. The latter is the most relevant one when D > 4 = 3 (see [34]).

The very absence of long-range interactions in the MOPE shows that those interactions are not renormalized. When considering charged polymerized membranes with a two-body Coulomb potential for instance, the only (marginally) relevant operator at the upper critical dimension is the local elastic energy density: $(r \cdot r)^2$; which indicates that only r is renormalized. As a consequence, one can show that = 2D = (d - 2) exactly, generalizing a well-known result for polymers [35].

We did not address here other interesting issues: the approach to the physical D=2 case from the D<2 manifold theory [27,36], numerical simulations of 2D polymerized membranes [10], or the question of the actual physical phase (crumpled or at) of a two-dimensional polymerized membrane in d-space [37]. We have concentrated instead on those more fundamental aspects of renormalization theory, that have been driven by the fascinating properties of these uctuating polymerized membranes.
