## A bsence of C oexistence of Superconductivity and A ntiferrom agnetism of the H ole-D oped Two-D im ensional Extended t J M odel

The possibility of coexistence of superconductivity (SC) and antiferrom agnetic long range order (AFLRO) of the two-dimensional extended t Jm odel in the very underdoped region is studied by the variational M onte-C arb (VMC) m ethod. In addition to using previously studied wave functions, a recently proposed new wave function generated from the half-lled M ott insulator is used. For hole-doped systems, the phase boundary between AFLRO and d wave SC for the physical parameters, J=t=0.3,  $t^0=t=0.3$  and  $t^0=t=0.2$ , is located near hole density  $_c=0.06$ , and there is no coexistence. The phase transition is rst-order between these two hom ogeneous phases at  $_c$ .

Correlation between the d-wave SC and AFLRO is one of the critical issues in the physics of the hightem perature superconductivity (HTS)[1, 2]. Early experim ental results showed one of the comm on features of the HTS cuprates is the existence of AFLRO at tem perature lower than the N eel tem perature  $T_N$  in the insulating perovskite parent com pounds. W hen charge carriers (electrons or holes) are doped into the parent com pounds, AFLRO is destroyed quickly and then SC appears. In most therm odynam ic measurements, AFLRO does not coexist with SC [3]. However, this is still a controversial issue. Recent experiments such as neutronscattering and muon spin rotation show that the spin density wave (SDW) may compete, or coexist with SC under the external magnetic eld [4, 5, 6]. Remarkably, elastic neutron scattering experiments for underdoped  $Y B a_2 C u_3 O_x$  (x = 6:5 and 6:6,  $T_c = 55K$  and 62:7K, respectively) show that the commensurate AFLRO develops around room temperature with a large correlation length 100A and a sm all staggered m agnetization 0:05 B [7, 8, 9]. These results suggest that AFLRO m o m ay coexist with SC but the possibility of inhom ogeneous phases is not com pletely ruled out.

For the theoretical part, the two-dimensional (2D) t-J model is the rst model proposed [10] to understand the physics of HTS. Anderson proposed the resonatingvalence-bond (RVB) theory for the model about one and a half decades ago. The theory is reexam ined again [11] recently. The authors compared the prediction of the RVB theory with several experimental results and found the theory to have successfully explained the main features of cuprates. This so called \plain vanilla" theory did not consider the issue of AFLRO, which must be addressed at very low doping. From analytical and numerical studies of the t J model, it was shown that at half-lling, the d wave RVB state with AFLRO is a good trial wave function (TW F). In this case, SC correlation is zero because of the constraint of no-doubleoccupancy. Upon doping, the carriers becom em obile and SC revives while AFLRO is quickly suppressed. How ever, if the doping density is still sm all, AFLRO will survive. Thus SC and AFLRO coexist in the very underdoped regim e[12, 13, 14, 15, 16]. Exact diagonalization (ED) up to 26 sites show that both SC and AFLRO are enhanced by the external staggered eld. This result also in plies these two orders can coexist hom ogeneously in a 2D t J m odel[17]. However, the regime of AFLRO predicted by these studies extend to larger doping than the experimental results. The robustness of the coexistence of SC and AFLRO seems to be inconsistent with experim ents[18].

There are several experim ental and theoretical studies suggesting the presence of the next- and third-nearestneighbor hopping term s  $t^0$  and  $t^{00}$  in cuprates. For example, the topology of the large Ferm i surface and the single-hole dispersion studied by ARPES [19], and the asymmetry of phase diagrams of the electron-and holedoped cuprates can be understood by introducing these term s. Further, these longer range hopping term s m ay be essential for the large enough  $T_c$  for the t J type m odels [20, 21]. In this paper, we'd like to dem onstrate the phase diagram constructed by VMC results of the extended t J m odel. The trialW F's for very underdoped system s are generalized from the single-hole and slightlydoped W F proposed by Lee et al.[22, 23]. The results for the hole-doped case show there is no coexistence of d wave pairing and AFLRO when the next- and thirdnearest neighbor hopping term s are introduced. And the

phase boundary of AFLRO is pushed to lower doping density.

The Hamiltonian of the extended t J model is

where  $t_{ij} = t, t^0$ , and  $t^{00}$  for sites i and j are nearest, next nearest, and the third nearest neighbors. < i; j >in H<sub>J</sub> means the spin-spin interaction occurs only for nearest neighbors.  $c_{i;} = (1 \quad n_{i;}) c_{i;}$ , satis es the nodouble-occupancy constraint. At half-lling, the system is reduced to the H eisenberg H am iltonian H<sub>J</sub>. As carriers are doped into the parent com pound, H<sub>t</sub> is included in the H am iltonian.

First we exam the phase diagram of the t J model, that is,  $t^0 = t^{00} = 0$ . Following Ref.[15, 22], three mean-eld order parameters are introduced: the staggered magnetization  $m_s = hS_A^z i = hS_B^z i$ , where the lattice is divided into A and  $B_p$  sublattices, the uniform bond order parameters =  $h \quad c_i^y c_j i$ , and d wave RVB (d RVB) one =  $hc_{j\#}c_{i^m} \quad c_{j^m}c_{i\#}i$  if i and j are n.n. sites in the x direction and for the y direction. The Lee-Shih W F, which is the mean-eld ground state W F is

where N<sub>s</sub> is the total number of sites and  $A_k = (E_{\nu}^{(1)} +$  $_{k}$ ) =  $_{k}$  and B  $_{k}$  = (E  $_{k}^{(2)}$   $_{k}^{+}$ ) =  $_{k}$  with E  $_{k}^{(1)}$  =  $\binom{2}{k} + \binom{2}{k}^{1=2}$  and  $E_k^{(2)} = \binom{+2}{k} + \binom{2}{k}^{1=2}$ . Here  $_k =$  $\frac{3}{4}$  ( $\cos k_x$   $\cos k_y$ ). Energy dispersions for the two SDW bands are  $_{k} = [(_{k} + )^{2} + (Jm_{s})^{2}]^{1=2}$ with k = $2(t + \frac{3}{8}J)(\cos k_x + \cos k_y) \cdot a_k = k c_k + k c_{k+Q}$ and  $b_k = {}_k q_k + {}_k q_{k+Q}$ , where Q = (;),  ${}^{2}_{k} = \frac{1}{2}$ f1 [(  $_{k}$  + )=(  $^{+}_{k}$  + )]g and  ${}^{2}_{k} = \frac{1}{2}$ f1 + [(  $_{k}$  + )=( + + )]g, are the operators of the lower and upper SDW bands, respectively. is the chem ical potential which determ ines the num ber of electrons. Note that the sum m ation in Eq.(2) is taken over the sublattice B rillou in zone (SBZ). The operator P<sub>d</sub> enforces the constraint of no doubly occupied sites for cases with nite doping.

For the half led case, = 0 and the optim al variational energy of this TW F obtained by tuning and m<sub>s</sub> in the VMC simulation is 0.332J per bond which is within 1% of the best estimate of the ground state energy of the Heisenberg model. For the case of pure AFLRO without , energy per bond is about 3 to 4% higher. Upon doping, there are two m ethods to modify the TW F: one is to use the SDW bands with a nonzero , the other is to create charge excitations from the half-

led ground states. For the form erm ethod, the TW F is optimized by tuning  $m_s$  and  $\ldots$  Note that for larger

doping densities, AFLRO disappears (m  $_{\rm s}$  = 0) and the W F reduces to the standard d RVB W F.For the latter m ethod, the W F is the \sm allFerm ipocket" state j \_pi:

 $k \ge Q_p$  m eans the k points in the Ferm i pocket  $Q_p$  are not occupied. For example, for 4 holes in 12 12 lattice,  $Q_p = f(=2; =2); (=2; =2)g$ . The number of holes is twice of the number of k-points in  $Q_p$  and is identical to zero in Eq.(3). In general, for the ground state the set  $Q_p$  should be determ ined variationally. Yet as we expect, it agrees well with the rigid band picture in the slightly doped cases as in Ref.[23].




FIG.1: hM i (full symbols) and  $P_d^{ave}$  (empty symbols) for J=t=0.3,  $t^0 = t^{00} = 0$  (circles) and  $t^0=t=0.3$ ,  $t^{00}=t=0.2$  (triangles) for hole doped 12 12 lattice.

The staggered m agnetization hM i  $\frac{1}{N_s}h^{r}_{j}e^{iQ}R_{j}S^{z}_{R_{j}}i$  and the d-wave pair-pair cor- $\frac{1}{N_s}h_{i}^{y} R_{i} R_{i+R}i$ relation  $P_d(R)$ = where  $R_{i} = C_{R_{i}} (C_{R_{i}+\hat{x}\#} + C_{R_{i}+\hat{x}\#})$ C<sub>R i ŷ#</sub>) C<sub>R i</sub>+∳# are measured for J=t = 0.3 and  $t^0 = t^{00} = 0$  for the 12 12 lattice with periodic boundary condition.  $P_d^{ave}$ is the averaged value of the long-range part (jR  $\Rightarrow$  2) of  $P_{\rm d}$  (R ). The resulting hM i (full circles) and  $P_{\rm d}^{\rm ave}$  (empty circles) are shown in Fig.1.

It can be seen in Fig.1 that in the underdoped region for the J=t = 0.3,  $t^0 = t^{00} = 0$  case, AFLRO (fill circles) coexists with SC (open circles) for  $_{\rm C}$  10%, which is smaller than the weak-coupling mean-eld result 15% [15], but still larger than the phase boundary of AFLRO determ ined by experiments  $_{\rm C} < 5\%$ . The energies of j  $_{\rm LS}$  i are lower than those of j  $_{\rm P}$  i for all doping densities in this case. This result is also consistent with the results reported by H im eda and O gata [16]. The VMC result isom ore realistic than the weak-coupling one. It may result from the rigorous no-double-occupancy constraint that suppresses the AFLRO faster than the

constraint-relaxed m ean- eld approxim ation.

Now we exam ine the phase diagram for J=t = 03,  $t^0=t = 0.3$  and  $t^0=t = 0.2$ . For this case, the W F Eq.(2) is modiled by replacing by  $+ 4\frac{1}{v} \cos k_x \cos k_y + 2t_v^0 (\cos 2k_x + \cos 2k_y)$  due to the second and third nearest neighbor hopping terms.  $t_v^0$  and  $t_v^{00}$  are variational parameters.  $t_v^0$  and  $t_v^{00}$  are not necessarily equal to the bare values  $t^0$  and  $t^{00}$  because the constraint strongly renormalizes the hopping am plitude. On the other hand, the e ect of  $t^0$  and  $t^{00}$  on j  $_P$  i is the choice of k-points in Q<sub>p</sub>, and the form of Eq.(3) is not changed.




FIG.2: Energy di erence per site between the two wave functions j  $_{\rm P}$  i and j  $_{\rm LS}$  i for t<sup>0</sup>=t = 0:3 and t<sup>00</sup>=t = 0:2 in 12 (full circles) and 16 16 (open squares) lattices.

The optim alwave functions for di erent densities are determ ined by m in in izing the variational energies am ong j  $_{p}$  (m  $_{s}$ ; ;fQ  $_{p}$ g)i and j  $_{LS}$  (m  $_{s}$ ; ;t $_{v}^{0}$ ;t $_{v}^{0}$ ; )i. The differences of the energies of best j  $_{P}$  i and j  $_{LS}$  i for various hole densities are shown in Fig.2. hM i (full triangles) and P  $_{d}^{ave}$  (open triangles) for 12 12 lattice are shown in Fig.1.




FIG. 3: Pair-pair correlation  $P_d(R)$  (circles) and hole-hole correlation H (R) (triangles) of j  $_{LS}$  i (full sym bols) and j  $_{pi}$  (open sym bols) for 8 holes in a 12 12 lattice.

It can be seen that level crossing occurs at  $_{\rm h}$  0.06. j  $_{\rm p}$  i has lower energy below the critical density. To show j  $_{\rm LS}$  i and j  $_{\rm p}$  i belong to two di erent types of W F, we calculate the overlap of them.  $(\frac{h_{\rm LS}j_{\rm p}i}{j_{\rm LS}j_{\rm p}j})$ is only 0.0113(4). The alm ost orthogonality of the two wave functions in plies that the ground state W F's switch at the critical density. A nother evidence is shown by the correlation functions of the two wave functions shown in Fig.3. It is clear that the holes in j  $_{\rm p}i$  repeleach others and pairing is very small, while the behavior is opposite for j  $_{\rm LS}i$ .

For  $_{\rm h}$  < 0.06, j  $_{\rm p}$ i is the ground state W F and hM i is a little larger than the t<sup>0</sup> = t<sup>00</sup> = 0 case while P<sub>d</sub><sup>ave</sup> is suppressed by one order of magnitude. Thus there is AFLRO but no SC in this regime. The behavior is quite di erent from j  $_{\rm LS}$  i for the same doping regime for t<sup>0</sup> = t<sup>00</sup> = 0 case, whose P<sub>d</sub><sup>ave</sup> coexists with hM i. The possible reason is that the W F j  $_{\rm p}$ i gains energy (short-range e ect) from its d RVB feature as j  $_{\rm LS}$ i, yet  $P_d^{ave}$  is greatly suppressed by replacing by  $Q_p$  to control the density. This replacement seems to make the W F decoherent for pairing.

For h larger than 0.06, the RVB state (m  $_{\rm s}$  = 0 in j  $_{\rm LS}$  i) optimizes the energy.  $P_d^{\rm ave}$  increases and hM i drops to zero sharply. Unlike the  $t^0 = t^{00} = 0$  case there is no region optimized by j  $_{\rm LS}$  i with non-zero m  $_{\rm s}$ . In conclusion, there is no coexistence of AFLRO and SC for the  $t^0$ =t = 0.3; $t^{00}$ =t = 0.2 case. These parameters are close to the values for YBCO and BSCO com pounds[24].

In sum mary, for the extended t  $J m odel, we proposed a new WF j _pi for the underdoped regime which has lower variational energy than the traditional WF with coexisting AFLRO and SC. This WF is constructed under the framework of RVB. The new wave function has AFLRO but SC is largely suppressed and there is no coexistence of AFLRO and SC in the underdoped regime of the hole-doped extended t <math>J m$  odel. The variational phase diagram shows better agreement with experimental results for the underdoped HTS cuprates.

Note that in this study we only consider the hom ogeneous states. Since the phase transition comes from the level crossing of the two classes of states at the critical density  $_{\rm c}$  = 0.06, it is a rst order phase transition. It is quite natural to have inhom ogeneity in the system near the critical point[25]. It may also lead to other more novel inhom ogeneous states such as stripe phase[26]. A nother interesting result of our study is that the non-coexistence of SC and AFLRO is much more robust for system s with larger values of t<sup>0</sup>=t and t<sup>00</sup>=t such as YBCO and BSCO [24]. For LSCO where t<sup>0</sup>=t and t<sup>00</sup>=t are smaller, the tendency toward coexistence is larger and the possibility of inhom ogeneous phase will become e much more likely.
