M ott-insulator phase of coupled 1D atom ic gases in a 2D optical lattice

We discuss the 2D Mott insulator (MI) state of a 2D array of coupled nite size 1D Bose gases. It is shown that the momentum distribution in the lattice plane is very sensitive to the interaction regime in the 1D tubes. In particular, we not that the disappearance of the interference pattern in time of ight experiments will not be a signature of the MI phase, but a clear consequence of the strongly interacting Tonks-G irardeau regime along the tubes.

Rem arkable developments in atom ic cooling and trapping have triggered the interest in strongly correlated atom ic systems [1,2,3,4,5]. In particular, the physics of cold atoms in periodic potentials induced by laser standing waves (optical lattices) has attracted a major attention, mostly due to its links to solid state physics [6], and due to the observation of the super uid (SF) to Mottinsulator (MI) transition [7] in Munich experiments [8].

The reduction of spatial dimensionality in these systems is now a "hot topic", in particular with regard to the creation of 1D gases, where the interaction between particles becomes more important with decreasing the gas density. For low densities or large repulsive interactions the system enters the strongly-interacting Tonks-Girardeau (TG) regime, in which the bosons acquire ferm ionic characteristics [9] and dynam ical and correlation properties drastically change [10, 11, 12, 13]. This regim e requires tight transverse trapping, low atom num bers, and possibly the enhancement of interactions via Feshbach resonances [3, 10, 14]. In this sense, 2D optical lattices are favorable, since the on-site transverse con nement can be made very strong and for su ciently small tunneling rate each lattice site behaves as an independent 1D system. Recent experiments on strongly correlated 1D gases have been perform ed along these lines [15, 16, 17, 18].

These studies motivate the analysis of an interesting physics in a (2D) array of coupled 1D Bose gases. In a 2D lattice the coupling is provided by the inter-site tunneling, and each lattice site is a 1D tube led with bosonic atoms. This regime is easily achievable experimentally by lowering the lattice potential, and it represents the bosonic analog of 1D coupled nanostructures [19]. As was rst shown by E fetov and Larkin [20], for in nitely long 1D tubes at zero temperature any in nitesimally small tunneling drives the system into the superuid phase. The gas then enters an interesting crossdimensional regime, in which it presents 1D properties in a 3D environment [21, 22]. For 1D tubes of nite length L, at su ciently small tunneling rate the system can undergo a cross-over from such anisotropic 3D super uid

state to the 2D M ott insulator state [22]. Strictly speaking, this 2D M I phase requires a commensurable lling of the tubes, i.e. an integer average number of particles N per tube. Then the system of nite-length tubes at zero temperature is analogous to that of in nite tubes at a nite temperature T, and the critical tunneling $t_{\rm c}$ for the T = 0 cross-over to the M I phase can be obtained from the nite-temperature results of Ref. [20] by making a substitution 1=T ! L [23].

This Letter is dedicated to the analysis of correlation properties of this 2D M ott insulator. We show that the m om entum distribution is crucially modi ed by a combined e ect of correlations along the 1D tubes and intertube hopping. For the case of a weakly interacting gas in the tubes, the phase coherence is maintained well inside the M I phase. This is similar to the situation in 2D and 3D lattices, studied by means of Quantum Monte Carlo calculations [24] and investigated experim entally through the observation of an interference pattern after switching o the con ning potential [8]. However, an increase of the interaction between particles in 1D tubes reduces the inter-tube phase coherence and attens the momentum distribution in the transverse direction (s). In particular, the interference pattern observed in Ref. [8] should be largely blurred if the 1D tubes are in the TG regime. This e ect can be revealed in current experiments. Rem arkably, the disappearance of the interference pattern will not be a signature of the MI phase, but a clear consequence of the strongly interacting regime for 1D tubes.

In the following we consider a Bose gas at zero tem perature in a 2D optical lattice, such that every lattice site can be considered as an axially homogeneous 1D tube of nite size L, with N=nL being the number of particles per tube, and n the 1D density. The tunneling between neighboring tubes is characterized by the hopping t, which depends on a particular lattice potential and atom ic species employed. We label tubes by the index j and denote by x the coordinate along the tubes.

The action describing the coupled tubes has the form :

where $_{j}$ (x;); $_{j}$ (x;) are complex bosonic elds associated with the j-th tube, the symbol < ij > denotes nearest neighbors, and S_{j} is the action describing the physics along the j-th tube.

In the absence of tunneling, there are no correlations between di erent tubes, and the one-body G reen function is diagonal:

The presence of tunneling between neighboring tubes, provided by the second term on the rhs of Eq. (1), modies the momentum distribution. Above a critical tunneling amplitude t_c the system undergoes a cross-over from the M I to an anisotropic 3D SF phase [22]. This cross-over and the M I phase can be analyzed within the random phase approximation (RPA) [25], successfully used in the studies of coupled spin chains [26]. Decoupling the tunneling term in the action (1) by using the Hubbard-Stratonovich transform ation and keeping only the leading quadratic terms, yields the RPA Green function in the momentum-frequency representation:

with $q = (q_y; q_z)$ being the quasim omentum in the lattice plane, $T(q) = 2t(\cos q_y a + \cos q_z a)$, a the lattice constant, and $G_0(k;!)$ the Fourier transform of the G reen function (2) (hereinafter we put $\sim = 1$):

The long-wavelength behavior of the G reen function $G_0(x; \cdot)$ can be found using Luttinger liquid theory [27]. At zero tem perature, employing a conformal transformation in order to take into account the nite size L of the tubes [25], we obtain:

where = v_s + ix, and v_s is the sound velocity. The interactions enter Eq.(5) through the factor d = 1=4K related to the interaction-dependent Luttinger param eter K . The Fourier transform of Eq. (5) yields

where the quantity I (p;) is expressed through the hypergeom etric function $_3F_2$:

with p = kL=2 and = !L=2 v $_{\rm S}$ being the dimensionless momentum and frequency. Integrating Eq. (6) over $_{\rm R}^{\rm I}$ one obtains the momentum distribution N $_{\rm O}$ (kL=2) = d!G $_{\rm O}$ (k;!)=2 in the absence of tunneling:

which behaves as p^{2d-1} for p & 1. The Luttinger liquid description employed here is valid for low momenta k - n. A coordingly, the dimensionless axial momentum p = kL = 2, which is an integer number, should satisfy the inequality p - N. The momentum distribution (8) represents the fraction of particles in the state with momentum p = kL = 2.

The critical tunneling t_c for the M I to SF cross-over is obtained as the value of t for which the denom inator of Eq. (3) vanishes for zero m om enta k and q and zero frequency ! . W e thus have

Note that with t_c from Eq. (9), the G reen function G in Eq. (3) becomes a universal function of the dimensionless quantities t=tc, p, qa and . For the TG regime of 1D bosons in the tubes, the Luttinger parameter is K = 1 and d = 1=4. Then, as the chemical potential is = $m v_s^2 = {}^2n^2=2m$, from Eq.(9) we obtain $t_c=$ ' 0.05N $^{3=2}$. For the weakly interacting regime, the Luttingerparam eter in the 1D tubes is $K = (n=m g)^{1=2}$ and Eq.(7) gives I(0;0) = 16 K 1. In this regime the chem ical potential is = $m v_s^2 = ng$, and Eq.(9) then yields $t_c = '$ (1=16)N 2 (as expected from the meaneld calculations for a 2D lattice of zero-dim ensional sites [28]). These results are in qualitative agreem ent with the recent calculations of Ho et al. [22]. One clearly sees that strong correlations along the tubes drastically shift the boundaries of the M I phase.

The m om entum distribution for the coupled 1D tubes in the M I phase, N (q;k), is obtained by integrating the G reen function (3) over the frequency. Our calculations show that only the lowest axial mode for which the momentum k=0, is signicantly a ected by the tunneling. The physical reason is that the k=0 mode is approaching the instability on approach to the critical tunneling t_c , whereas $k \in 0$ modes are still far from instability. This is




Figure 1: Transverse momentum distribution for k=0 at $t=t_c=0.3$ for K=1 (solid), K=4 (dotted), and K=25 (dashed). In the gure we have chosen $q_V=q_Z=q$.




Figure 2: Transverse m om entum distribution for t=t_c = 0.3, at K = 1 (solid), K = 4 (dotted), and K = 25 (dashed), for N = 50 (a) and N = 500 (b). In the gures we have chosen $q_V=q_z=q_z$

re ected in the resonance character of the G reen function (3) for k=0 and t! t_c . Our results in Fig. 1 show that the transverse distribution N (q;0) corresponding to the k=0 axial mode is non- at for any interaction regime along the tubes. In contrast, for $k \in 0$ the quantity T (q)G₀ (k;!) is always small. Therefore, expanding the rhs of Eq. (3) in powers of T (q) up to linear order and integrating over! we obtain an almost at transverse momentum distribution for $k \notin 0$ modes: N (q;p)=N (0;p) = 1 (A $d=4p^2$ d) (t=t_c) (2 $= \frac{1}{1+2} y$; $= \frac{1$

term is always very small.

We now turn to the discussion of the transverse quasim om entum distribution N $_{?}$ (q) = $_{k}$ N (q;k). The sum mation over the axial modes changes the picture drastically compared to the distribution for a given k. As only the k = 0 component is signicantly a ected by the tunneling, one can rewrite Eq. (3) in the form :

In the second term on the rhs of Eq.(10) we may use the G reen function $G_0(0;!)$ following from Eqs. (6) and (7). For k=0 (p=0), one can put the hypergeom etric function ${}_3F_2=1$ in Eq.(7), which gives I(0;) ' $4\ d=(d^2+2)$. Om itted terms give a very small relative correction of the order of $d^3<1=4^3$. Hence, using Eq.(9), for the G reen function at k=0 in the absence of tunneling we have $G_0(0;!)=d^2=4t_c(d^2+2)$. Then, integrating Eq.(10) over , sum ming over the axial modes R^2 , and in posing the normalization condition R^2 d! R^2 d! R^2 for the rst term on the rhs, we obtain the transverse momentum distribution

norm alized by the condition (a=2) 2 R $d^2 \mbox{qN}_{?}$ (q) = N .

In Fig.2 we depict the results of Eq. (11) for dierent values of N and the Luttinger parameter K. Due to the prefactor in the second term on the rhs of Eq. (11) the transverse m om entum distribution strongly depends on the interaction regime along the tubes.

For the weakly interacting regine (d $\,$ 1), the distribution N $_2$ (q) is not at even deeply inside the M I phase. Similar results have been obtained by means of Q uantum M onte C arlo calculations [24] for the case of lattices of zero-dimensional sites. In our case, only for rather low tunneling (t=t_c $\,$ 0:1) the quasimomentum distribution becomes at, and switching o the lattice potential should lead to a blurred picture as that observed by G reiner et al. [8]. Non- at distributions in the M I phase as those of Fig. 2 will manifest them selves through the appearance of interference peaks in the same type of experiment.

On approach to the TG regime, the quasimomentum distribution becomes progressively atter. The main reason for this behavior is that when the system becomes more interacting, the k=0 component is more depleted, contributing less to the total quasimomentum distribution. Therefore, if the 1D tubes approach the strongly interacting TG regime, in experiments as those of Ref. [8] the interference pattern will be essentially smeared out. One may expect a partial destruction of the interference pattern even form oderate values of the Luttinger parameter (see, e.g., the case K=4 in Fig. 2).

The random phase approximation used in our calculations, was shown to be a good approximation for a wide range of param eters of coupled one-dim ensional Heisenberg spin chains [26]. Here we give yet another estimate for the applicability of RPA, relying on the Ginzburg criterion adapted to a quantum phase transition at zero tem perature. We compare uctuations of the order param eter in a volum e determ ined by the correlation radius extracted from the G reen function (3), with the scale on which the non-linear e ects become important. The latter is obtained from the four-point correlation function of each tube. We have found that RPA is adequate for B (d), where B (d) has been obtained num erically from the four-point correlation function. In the case of the Tonks-G irardeau regime along the tubes, we have 0:1, and it decreases signi cantly with decreasing d and entering the Gross-Pitaevskii regime.

In conclusion, we have considered a bosonic gas in a 2D optical lattice of nite 1D tubes at zero tem perature, focusing our attention on the momentum distribution in the M I phase. We have shown that the strong correlations along the 1D tubes signi cantly modify the quasim om entum distribution in the lattice plane. We have found that in the M I regime only the lowest momentum along the tubes is a ected by the inter-site hopping, and hence only this component contributes to the form ation of interference fringes. Consequently, the larger the interactions are (larger depletion) the less pronounced is the visibility of the interference fringes. In particular, for the TG regime in the tubes, the quasim om entum distribution becomes progressively atter, leading to an observable blurring of the interference pattern after expansion. This e ect can be observed in current time of ight experim ents, and can be used to reveal a clear signature of the strong correlations along the sites.
