Interplay of instabilities in mounded surface grow th

We numerically study a one-dimensional conserved growth equation with competing linear (Ehrlich-Schwoebel) and nonlinear instabilities. As a control parameter is varied, this model exhibits a non-equilibrium phase transition between two mounded states, one of which exhibits slope selection and the other does not. The coarsening behavior of mounds in these two phases is studied in detail. In the absence of noise the steady-state con guration depends crucially on which of the two instabilities dom inates the early time behavior.

The phenomenon of formation and coarsening of mounds in epitaxially grown thin lm s [] is a subject of much recent experim ental [2, 3] and theoretical [4, 5, 6] interest. Traditionally, the form ation of mounds has been attributed to the presence of an Ehrlich-Schwoebel (ES) step-edge barrier [7,8] that hinders the dow nw ard m otion of atom s across the edge of a step. This leads to an e ective \uphill" surface current [9] that has a destabilizing e ect, leading to the form ation of mounded structures. The ES mechanism is usually represented in continuum growth equations as a linear instability [9] that is controlled by higher-order nonlinear term s. In ES-type m odels, the characteristics of the coarsening process, in which the typical lateral size of the m ounds grows in time, depends on the details of the model. In these models, slope selection occurs (i.e. the slope of the mounds remains constant during coarsening) only if the \ES part" of the slope dependent surface current has one or m ore stable zeros as a function of the slope.

In our earlier work [10, 11] on a class of spatially discrete, conserved, one-dim ensional (1d) m odels of epitaxial growth, we found a mechanism of mound formation and coarsening with slope selection that is di erent from the conventional ES mechanism. We studied the spatially discretized Lai-Das Sama equation [12] of MBE grow th and an atom istic model [13] that provides a discrete realization of the dynam ics described by this equation, and found the occurrence of a nonlinear instability [14] in which isolated pillars or grooves grow in time if their height or depth exceeds a \critical" value. W hen this instability is controlled by the introduction of an in nite num ber of higher order gradient nonlinearities, these models show, for a range of parameter values, the formation of mounds with a well-de ned slope that remains constant during the coarsening process. These results dem onstrate that m ound form ation and power-law coarsening with slope selection can occur in the absence

of an ES instability.

In most experimentally studied systems, however, it is believed that the ES step-edge barrier is present, although it may possibly be very weak. It is, therefore, important to understand how the behavior of our models would be modi ed when the ES mechanism is incorporated in their kinetics. To address this issue, we have studied, using num erical integration, a spatially discretized 1d growth equation in which a linear ES-type instability is present in conjunction with the nonlinear instability mentioned above. The main results of this study are as follows. Depending on the values of the parameters appearing in the model, we nd two di erent m ounded states. If the param eters are such that the nonlinear instability is the dom inant one, then the behavior of the system is similar to that found in our earlier studies [10, 11]: it exhibits the form ation of triangular mounds and power-law coarsening with slope selection. If, on the other hand, the linear instability is dom inant, then the system exhibits a di erent kind of mounded state in which the mounds have a cusp-like shape and they steepen during the coarsening process. We call these two mounded states \faceted" and \cusped", respectively. As the parameters are changed, the system undergoes a dynam ical phase transition from one of these m ounded states to the other.

We study a spatially discretized 1d version of the fourth order conserved grow th equation, proposed in the context of MBE grow th [9, 12], in which the nonlinear instability [14] is controlled using a control function [10, 11] of the form proposed by Politiand V illain [5] and a linear instability of the form proposed by Johnson et al. [2] to represent the ES e ect is also included. Thus, the equation of motion of the interface height in appropriately non-dimensionalized form is written as:

where h_i is the non-dimensionalized height variable at lattice site i, and \hat{r} and \hat{r}^2 are the lattice versions of the derivative and Laplacian operators, respectively, calculated using the nearest neighbors as outlined in our

earlier papers [10, 11]. In Eq.(1), c_1 , c_2 and are constants (model parameters), and i(t) represents uncorrelated random noise with zero mean and unit variance. Our results are based on numerical integration of this equation in 1d, using a simple Euler scheme [14] in which the time evolution of the height variables is given by

In all our calculations, the value of the parameter c_2 was held xed at unity, and q and were varied. Our results are obtained for di erent system sizes, 40 \mathbf{L} 1000, with periodic boundary conditions. We do not nd any signi cant L-dependence. We have used a time t=0.01 for most of our studies and checked that step very sim ilar results are obtained with smaller values of t. The results obtained by using a more sophisticated algorithm [15] closely match with those of our Euler scheme for a small enough t. We have also checked that the basic features of our results rem ain unaltered if other boundary conditions (such as \ xed" and \zero- ux" boundary conditions considered in our earlier work [10, 11]) are used.




FIG.1: Dependence of the morphology on the initial conditions in the absence of noise. Main plot: the critical value of h_0 (see text) as a function of the nonlinearity parameter for $c_1 = 0.01$. This critical value is approximately given by $h_0 = 21$ = (solid line). Upper inset: \faceted" morphology for $h > h_0$. Lower inset: \cusped" morphology for $h < h_0$.

We rst describe the results obtained in the absence of the noise term . In this case, we nd that if the parameter c_1 is su ciently small, then the long time behavior of the interface depends on which of the instabilities dom inates at early times. In order to characterize this, we considered initial congurations with a single pillar of height h_0 on an otherwise at interface, and studied the long-time behavior as a function of h_0 . We nd that when h_0 is suf-

ciently small, so that the nonlinear instability is not initiated, the linear instability dom inates the time evolution and the resulting morphology is mounded without slope selection. If on the other hand h_0 is large enough to seed the nonlinear instability, then mounds with a \magic" slope result. This is illustrated in Fig. 1 which shows typical congurations obtained in the two cases: slope selected mounds (\faceted") in situations where the height of the central pillar is greater than a critical value and mounds without slope selection (\cusp" like) otherwise. Fig. 1 also shows the dependence of the critical value of h_0 on , the strength of the nonlinearity. We nd that this critical value is approximately given by A = , A < 21, with a weak dependence on the parameter c_1 .

This \bistable" behavior is found only if the control parameter c_1 is su ciently small. O therwise, the system evolves to the cusped morphology even if the initial con-

guration has a high central pillar. Thus, the faceted morphology is found in the zero-noise simulations only if $c_1 < c_1^{\rm sp}$ () (the superscript sp denotes \spinodal", see below) and the initial con guration is su ciently rough to seed the nonlinear instability. This behavior may be understood from a linear stability analysis. In both faceted and cusped growths, the nite-sized system evolves, at long times, to a profile with a single mound




FIG. 2: The interface proles at three dilerent times (t= 100,4000 and 256000) in a run with noise starting from a at state for an L = 400 sample with = 4:0 and $c_1 = 0:05$. A double log plot of the interface width W as a function of time t, averaged over 15 runs for L = 1000 samples in the presence of noise, and a power-law t are shown in the inset.




FIG. 3: Interface pro les at three di erent times (t= 200, 4000 and 2560000) in a run starting from a at state for an L = 400 sam ple with = 4.0 and $c_1 = 0.01$. A double log plot of the interface width W as a function of time t, averaged over 15 runs for L = 1000 sam ples in the presence of noise, and power-law ts to the early and late-time data are shown in the inset.

which is a xed point of the noiseless dynamics. Examples of such proles (obtained from simulations with noise which slightly roughens the proles) are shown in Figs.2 and 3. These xed points can also be obtained by calculating the h_i for which $g_i=0$ for all i, where g_i is the term multiplying t on the right-hand side of Eq.(2). The local stability of the faceted xed point may be determined from a calculation of the eigenvalues of the matrix $M_{ij} = (eg_i=eh_j \text{ evaluated at the xed point. We not that the largest eigenvalue of this matrix crosses zero at a <code>\spinodal"</code> value, <math display="inline">c_1 = c_1^{\rm sp}()$ (see inset of Fig. 6), signaling an instability of the faceted prole. Thus, for $0 < c_1 < c_1^{\rm sp}()$, the dynamics of Eq.(2) without noise admits two locally stable invariant proles: a cusped pro-

le w ithout slope selection, and a faceted one w ith slope selection. D epending on the initial state, the no-noise dynam ics takes the system to one of these two xed points. For example, an initial state w ith one pillar on a at background is driven by the no-noise dynam ics to the cusped xed point if the height of the pillar is sm aller than a

critical value (m entioned earlier), and to the faceted one otherw ise. The dependence of c_1^{sp} on the nonlinearity param eter is shown in Fig. 6. Such a \spinodal line" does not exist for the cusped xed point.

We have studied in detail the process of coarsening of the mounds in the two di erent (faceted and cusped) grow th modes. In these simulations, the initial con guration is obtained by setting $h_1 = h_0 r_1$ where r_1 is a random number uniform by distributed between 1 and 1. If $c_1 < c_1^{\rm sp}$ and h_0 is su ciently large to initiate the nonlinear instability, the system evolves to a faceted structure; a cusped structure is obtained otherwise. The results reported here were obtained from averages over 20 such runs with di erent initial con gurations. In the region of parameter space, $0 < c < c_1^{\rm sp}$ (), where the faceted phase is locally stable, the mounds coarsen in time with the slope of the mounds remaining constant. In this case,




FIG. 4: Double log plots of the width W (full line) and the average of the maximum slope s_m (dash-dotted line) as a function of time t, for faceted grow th with slope selection in the absence of noise. This data are for $= 4.0, c_1 = 0.01$, and L = 800, averaged over 20 initial conditions. In this case the grow th exponent = 0.5 0.01 (the dashed line is the best power-law t) and the steepening exponent = 0.

the average m ound size R (t) is obviously proportional to the interface width W (t). As shown in Fig 4, the interface width in this grow th m ode increases as a power-law with time in the long-time coarsening regime, while the slope of the mounds remains constant in time. The exponent that described this power-law coarsening behavior, W (t) / R (t) / t , is found to be close to 0.5. The coarsening of mounds in the cusped regime (i.e. for $c_1 > \, c_1^{\rm sp}$ () and any initial con $\,$ guration, and $_{\rm G} < \, c_1^{\rm sp}$ () and su ciently smooth initial con gurations) is qualitatively di erent. In this growth mode, both the interface width and the average slope s(t) of the cusp-like mounds (as well as the maximum slope s_m (t)) increases with time as a power law in the coarsening regime: W (t) / t , and s(t) / t. This im plies that the average m ound size also increases with time as a power law: $R(t) / t^n$ with




FIG.5: Variation of width W (full line) and the average of the maximum slope, s_m (dash-dotted line) as a function of time t on a log-log scale for cusped growth in the absence of noise (= 4:0, $c_1 = 0:05$, and L = 800 averaged over 20 initial conditions). The growth exponent is = 0:54 0:02, and the steepening exponent = 0:2 0:02. Best power-law ts are shown by the dashed lines.

In the presence of noise, the steady state behavior is independent of the initial condition. When the control parameter c_1 is su ciently large, the nonlinear instability is completely suppressed and the route to mounding is similar to the linear instability dominated behaviorm entioned above, the congurations being slightly roughened versions of their noiseless counterpart. This is illustrated in Fig.2 where the interface proles in a typical run starting from a at state for L = 400, = 4.0 and c = 0.05are shown at times t = 100 (early time regime), t = 4000(coarsening regime) and t = 256000 (steady state). The




FIG.6: Phase diagram for a L = 200 system, where the critical values of the control parameter c_1 are shown as functions of . The critical value c_1^{sp} (c_1^{cr}) above which the faceted phase is unstable (m etastable) is shown by squares (triangles). The dashed lines are guides to the eye. Left Inset: Zero crossing of the largest eigenvalue of the stability m atrix of the faceted xed point as a function of c_1 (= 4:0, L = 200). R ight Inset: The probabilities P_1 (circles) and P_2 (inverted triangles) (see text) as functions of c_1 with = 5:0 and L = 200.

inset shows the interface width W as a function of t, averaged over 15 runs for L = 1000 sam ples. The averaged data show W / t , = 0.5 0.01 in the coarsening regime. The average slope of the m ounded interface grows as s(t) / t , with = 0.18 0.02 and hence the coarsening exponent is n = 0.32 0.03.

As the value of c_1 is decreased below a critical value holding xed, the nonlinear instability dom inates over the linear one. At early times in runs starting from a at state, the interface is self a ne and the interface width shows power law scaling with an exponent close to 0.37. A stim e progresses isolated pillars with height $h_0 > h_{m \text{ in}}$, where $h_{m in}$ is the minimum height of such a pillar above which the nonlinear instability is operative, make their appearance through random uctuations. The time evolution of the interface beyond the point of occurrence of the instability is similar to that in the noiseless situation. In Fig. 3 we present snapshots of an L = 400sample for = 4:0 and $c_1 = 0:01$ at dierent stages of growth: t = 200 (before the onset of the instability), t = 4000 (coarsening regime), and t = 2560000 (steady state). The inset shows a plot of the interface width as a function of time, obtained by averaging over 15 runs for L = 1000 sam ples. The averaged data show a power-law growth regime with exponent 0:37 0:01 before the onset of the instability and a second power-law coarsening require with W / t, = 0:49 0:02.

A dynam ical phase transition at $c_1 = c_1^{cr}() < c_1^{sp}()$ separates these two kinds of growth modes. To calculate $c_1^{cr}()$, we start a system at the faceted xed point and follow its evolution according to Eq.(2) for a long time (typically $t = 10^4$) to check whether it reaches a cusped steady state. By repeating this procedure many times (typically 100 runs), the probability, $P_1(;c_1)$, of a

transition to a cusped state is obtained. For xed , P_1 increases rapidly from 0 to 1 as c1 is increased above a critical value. Typical results for P_1 as a function of c_1 for = 5.0 are shown in the right inset of Fig. 6. The value of c_1 at which $P_1 = 0.5$ provides an estimate of c^{cr}. A nother estimate is obtained from a similar calculation of P_2 (; c₁), the probability that a at initial state evolves to a faceted steady state. As expected, P_2 increases sharply from 0 to 1 as c1 is decreased (see right inset of Fig. 6), and the value of c_1 at which this probability is 0.5 is slightly lower than the value at which $P_1 = 0.5$. This di erence re ects nite-time hysteresis e ects. The value of ξ^r is taken to be the average of these two estimates, and the di erence between the two estimates provides a measure of the uncertainty in the determ ination of c_1^{cr} . The phase boundary obtained this way is shown in Fig. 6, along with the results for c_1^{sp} .

The scaling behavior in the coarsening regime in the presence of noise is the sam e as that found in the noiseless case. The qualitative behavior in the faceted phase is similar to that found in our earlier work [10, 11] on thism odelwithout the ES term . The ES term , how ever, has an important e ect: it changes the coarsening exponent from 0.33 to 0.5. A model very similar to the one considered here was studied by Torcini and Politi [16] for parameter values deep in the cusped regime (small , large c_1). The mounded morphology we nd in this regime is similar to that found in their study. Our results for the exponents and n are slightly di erent from the values (= n = 1=4) reported by them . This is probably due to crossovere ects { we have found values of n closer to 1/4 if sm aller values of and/or larger values of c_1 are used.

In sum m ary we have shown that a nonlinear instability in our spatially discrete grow th m odel in which the linear ES instability is also present m ay, for appropriate param eter values, lead to m ound form ation with slope selection and power-law coarsening. This is qualitatively di erent from the behavior in the parameter regime where the ES instability dom inates: the system exhibits m ound form ation in this regime also, but there is no slope selection. The coarsening exponent has di erent values in these two regimes which are separated by a line of rst-order dynam ical phase transitions. The ES part of the surface current in our model does not vanish for any non-zero value of the slope. Therefore, the slope selection we nd in the regime where the nonlinear instability is dom inant is qualitatively di erent from that in ES-type m odels and is a true example of nonlinear pattern form ation. The noiseless version of our model exhibits an interesting dependence on initial conditions: the long-time behavior depends on whether the inhom ogeneities in the initial con guration are su cient to seed the nonlinear instability. Both kinds of mounding behavior found in this study have been observed in experim ents, and ourm odel m ay be relevant in the developm ent of an understanding of these experim ental observations. How ever, more work is required to establish a connection between our results
