# Interplay of instabilities in $m$ ounded surface grow th

#### Abstract

We num erically study a one-dim ensional conserved grow th equation with com peting linear (E hrlich-Schw oebel) and nonlinear instabilities. As a control param eter is varied, this model exhibits a non-equilibrium phase transition between two m ounded states, one of which exhibits slope selection and the other does not. The coarsening behavior ofm ounds in these tw o phases is studied in detail. In the absence of noise the steady-state con guration depends crucially on which of the tw o instabilities dom inates the early tim e behavior.

The phenom enon of form ation $a^{-1}$ coarsening of $m$ ounds in epitaxially gror in lm $\mathrm{m} u \mathrm{ch}^{2}$ recent experim enta: and theoretica: interest. T raditionally, the form ation ofm ounds nas.oeen attributed to thr ence of an Ehrlich-Schw oebel (ES) step-edge barrie: that hinders the dow nw ard $m$ otion of atom s across the eage of a - $\quad$. This leads to an e ective \uphill" surface current that has a destabilizing $e$ ect, leading to the form ation of $m$ ounded structures. The ES mechanism is usually represent in continuum grow th equations as a linear instability that is controlled by higher-order nonlinear term s . In ES-type m odels, the characteristics of the coarsening process, in which the typical lateral size of the $m$ ounds grow $s$ in tim $e$, depends on the details of the $m$ odel. In these $m$ odels, slope selection occurs (i.e. the slope of the $m$ ounds rem ains constant during coarsening) only if the \ES part" of the slope dependent surface current has one or m ore stable zeros as a function of the slope.

In our earlier work
on a class of spatially discrete, conserved, one-am ensional (1d) m odels of epitaxial grow th, we found a $m$ echanism of $m$ ound form ation and coarsening w ith slope selection that is di erent from the conventional ES m echanism. We stur the spatially discretized Lai-D as Sarm uation of M BE grow th and an atom istic $m$ ode that provides a discrete realization of the dynam ics aescribed by this equatio .nd found the occurrence of a nonlinear instability in which isolated pillars or grooves grow in tim e if tneir height or depth exceeds a \critical" value. W hen this instability is controlled by the introduction of an in nite num ber of higher order gradient nonlinearities, these $m$ odels show, for a range of param eter values, the form ation of $m$ ounds $w$ ith a well-de ned slope that re$m$ ains constant during the coarsening process. These results dem onstrate that $m$ ound form ation and power-law coarsening w th slope selection can occur in the absence
of an ES instability.
In m ost experim entally studied system s , how ever, it is believed that the ES step-edge barrier is present, although it $m$ ay possibly be very weak. It is, therefore, im portant to understand how the behavior of our m odels would be modi ed when the ES m echanism is inconporated in their kinetics. To address this issue, we have studied, using num ericalintegration, a spatially discretized 1d grow th equation in which a linear ES-type instability is present in conjunction $w$ ith the nonlinear instability $m$ entioned above. The $m$ ain results of this study are as follows. Depending on the values of the param eters appearing in the $m$ odel, we nd two di erent $m$ ounded states. If the param eters are such that the nonlinear instability is the dom inant one, then the behavior of then is sim ilar to that found in our earlier studies it exhibits the form ation of triangular m ounds and power-law coarsening w ith slope selection. If, on the other hand, the linear instability is dom inant, then the system exhibits a di erent kind of $m$ ounded state in which the m ounds have a cusp-like shape and they steepen during the coarsening process. We call these two mounded states \faceted" and \cusped", respectively. As the param eters are changed, the system undergoes a dynam icalphase transition from one of these m ounded states to the other.

W e study a spatially discretized 1d version of the fourth order conserved equation, proposed in the context $\quad$ BE grow th in which the nonl stability is controllea using a control tion of the form proposed by P olitiand V illair and a ar instability of the form proposed by Johnson et al to represent the ES e ect is also included. T hus, the equation of $m$ otion of the interface height in appropriately non-dim ensionalized form is w ritten as:

$w$ here $h_{i}$ is the non-dim ensionalized height variable at lattice site $i$, and $\widetilde{r}$ and $r^{2}$ are the lattioe versions of the derivative and Laplacian operators, respectively, calculated using the nearest neighbors as outlined in our
earlier paper $\quad$ In Eq $C_{1}, C_{2}$ and are constants (m ode $\perp$ param eters), and $i(t)$ represents uncorrelated random noise $w$ th zero $m$ ean and unit variance. O ur results are based on num erical integ inn of this equation in 1d, using a sim ple Euler schem in which the tim e evolution of the height variables is given by

In all our calculations, the value of the param eter $\mathrm{C}_{2} \mathrm{w}$ as held $x e d$ at unity, and $\Phi$ and were varied. O ur results are obtained for di erent system sizes, 40 L 1000, w th periodic boundary conditions. We do not nd any signi cant L-dependence. We have used a time step $t=0: 01$ for $m$ ost of our studies and checked that very sim ilar results are obtained with sm aller values of
$t$. The result tained by using a m ore sophisticated algorithm closely $m$ atch $w$ ith those of our Euler scheme for a sm all enough $t$. W e have also checked that the basic features of our results rem ain unaltered if otherboundary conditions (such as $\backslash$ xed" and \zerc " "oundary conditions considered in our earlier work are used.

W e rst describe the results obtained in the absence of the noise term. In this case, we nd that if the param eter $c_{1}$ is su ciently sm all, then the long tim e behavior of the interface depends on which of the instabilities dom inates at early tim es. In order to characterize this, we considered in itialcon gurationsw ith a single pillar of height ho on an otherw ise at interface, and studied the long-tim e behaviorasa function of $h_{0}$. We nd thatwhen ho is suf-
ciently sm all, so that the nonlinear instability is not initiated, the linear instability dom inates the tim e evolution and the resulting $m$ orphology is $m$ ounded $w$ thout slope selection. If on the other hand $h_{0}$ is large enough to seed the nonlinear instability, then $m$ ounds $w$ th a $\backslash m$ agic" slope result. This is ilhustrated in Fig which shows typicalcon gurations obtained in the tw o cases: slope selected $m$ ounds ( $\backslash$ faceted") in situations where the height of the central pillar is greater than a critical value and m orunds w ithout slope selection (\cusp" like) otherw ise. $F$ io also show s the dependence of the critical value of $h_{0}$ on , the strength of the nonlinearity. We nd that this criticalvalue is approxim ately given by $\mathrm{A}=, \mathrm{A} \quad 21$, w ith a weak dependence on the param eter $\mathrm{C}_{1}$.

This \bistable" behavior is found only if the control param eter $C_{1}$ is su ciently sm all. O therw ise, the system evolves to the cusped m orphology even if the initialcon-
guration has a high central pillar. T hus, the faceted m onphology is found in the zero-noise simulations only if $c_{1}<c_{1}^{\text {sp }}()$ (the superscript sp denotes \spinodal", see below) and the initial con guration is su ciently rough to seed the nonlinear instability. T his behavior $m$ ay be understood from a linear stability analysis. In both faceted and cusped grow ths, the nite-sized system evolves, at long tim es, to a pro le w ith a single m ound

which is a xed point of the noiseless dynam ics. E xam ples of such pro les (obtained from sim ulationsw th noion which slightly roughens the pro les) are shown in F ig an These xed points can also be obtained by calculating the $h_{i}$ forw hich $g_{i}=0$ for all $i$, where $g_{i}$ icthe term $\mathrm{multiplying} t$ on the right-hand side of Eq. The local stability of the faceted xed point $m$ ay be deter$m$ ined from a calculation of the eigenvalues of the $m$ atrix $M_{i j}=@ g_{i}=@ h_{j}$ evaluated at the xed point. We nd that the largest eigenvalue of this $m$ atrix crosses zom at a \spinodal" value, $\mathrm{C}_{1}=c_{1}^{\text {sp }}(\mathrm{l})$ (see inset of F ig signaling an instability of the facetednm le. Thus, tor $0<c_{1}<C_{1}^{s p}()$, the dynam ics of $E q \quad w$ thout noise adm its tw o locally stable invariant pro les: a cusped pro-
le w ithout slope selection, and a faceted one w ith slope selection. D epending on the initialstate, the no-noise dynam ics takes the system to one of these tw o xed points. For exam ple, an initialstatew ith one pillar on a atbackground is driven by the no-noise dynam ics to the cusped
xed point if the height of the pillar is sm aller than a critical value ( $m$ entioned earlier), and to the faceted one otherw ise. The dependen $ص$ ค $\mathrm{f}_{1}^{\mathrm{sp}}$ on the nonlinearity param eter is show $n$ in $F$ is not exist for the cusped xed point.

W e have studied in detail the process of coarsening of the $m$ ounds in the two di erent (faceted and cusped) grow th m odes. In these sim ulations, the initial con guration is obtained by setting $h_{i}=h_{0} r_{i}$ where $r_{i}$ is a random num ber uniform ly distributed betw een 1 and 1. If $c_{1}<c_{1}^{s p}$ and $h_{0}$ is su ciently large to initiate the nonlinear instability, the system evolves to a faceted structure; a cusped structure is obtained otherw ise. The results reported here were obtained from averages over 20 such runs w ith di erent intial con gurations. In the region of param eter space, $0<c<c_{1}^{\text {sp }}()$, where the faceted phase is locally stable, the $m$ ounds coarsen in tim e w ith the slope of the $m$ ounds rem aining constant. In this case,

the average $m$ ound size $R(t)$ is obviously pmnortional to the interface width $W$ ( $t$ ). As show $n$ in $F$ is the interface $w$ idth in this grow th $m$ ode increases as a pow er-law $w$ ith time in the long-tim e coarsening regim e, while the slope of the $m$ ounds rem ains constant in time. The exponent that described this power-law coarsening behavior, $W$ ( $t$ ) / $R(t) / t$, is found to be close to 0.5 . $T$ he coarsening ofm ounds in the cusped regim e (i.e. for $c_{1}>c_{1}^{\text {sp }}()$ and any initialcon guration, and $\Phi<c_{1}^{\text {sp }}()$ and su ciently sm ooth initial con gurations) is qualitatively di erent. In this grow th m ode, both the interface $w$ idth and the average slope $s(t)$ of the cusp-like m ounds (aswellas them axim um slope $s_{m}(t)$ ) increasesw ith tim e as a power law in the coarsening regim e: $W(t) / t$, and $s(t) / t$. This im plies that the average $m$ ound size also increases w ith time as a pow er law: $R(t) / t^{n}$ w ith

$=0: 20: 02$, im plying that the coarsening exponent is $\mathrm{n}=0: 34 \quad 0: 04$.

In the presence of noise, the steady state behavior is independent of the initial condition. W hen the control param eter $C_{1}$ is su ciently large, the nonlinear instabilty is com pletely suppressed and the route to m ounding is sim ilar to the linear instability dom inated behaviorm entioned above, the con gurationsbeing slightly roughened versian of their noiseless counterpart. This is illustrated in $F$ is here the interface pro les in a typicalrun starting from a at state for $L=400,=4: 0$ and $\Phi=0: 05$ are show $n$ at tim est $=100$ (early tim e regim e), $t=4000$ (coarsening regim e) and $t=256000$ (steady state). The

inset show $s$ the interface $w$ idth $W$ as a fiunction of $t$, averaged over 15 runs for $L=1000$ sam ples. $T$ he averaged data show $W / t,=0: 5 \quad 0: 01$ in the coarsening regim $e$. The average slope of the $m$ ounded interface grows as s(t)/t,w ith $=0: 18 \quad 0: 02$ and hence the coarsening exponent is $\mathrm{n}=0: 32 \quad 0: 03$.

As the value of $c_{1}$ is decreased below a critical value holding $x e d$, the nonlinear instability dom inates over the linear one. A t early tim es in runs starting from a at state, the interface is self a ne and the interface width show s power law scaling w ith an exponent close to 0.37 . A stim e progresses isolated pillars w ith height $h_{0}>h_{m}$ in, $w$ here $h_{m}$ in is the $m$ in im um height of such a pillar above $w$ hich the nonlinear instability is operative, $m$ ake their appearance through random uctuations. The tim e evolution of the interface beyond the point of occurrence of the instabilu is sim ilar to that in the noiseless situation. In Fig ve present snapshots of an $L=400$ sample for $=4: 0$ and $c_{1}=0: 01$ at di erent stages of grow th: $t=200$ (before the onset of the instability), $t=4000$ (coarsening regim e), and $t=2560000$ (steady state). The inset show s a plot of the interface width as a function of tim e, obtained by averaging over 15 runs for $L=1000$ sam ples. $T$ he averaged data show a power-law grow th regim e w ith exponent 0:37 0:01 before the onset of the instability and a second power-law coarsening regim e w th $W / t,=0: 490: 02$.

A dynam ical phase transition at $c_{1}=c_{1}^{c r}()<c_{1}^{s p}()$ separates these two kinds of grow th m odes. To calculate $c_{1}^{\text {cr ( ), we start a system at the facetod } x e d ~ p o i n t ~}$ and follow its evolution according to Eq for a long time (typically $t=10^{4}$ ) to check whether II reaches a cusped steady state. By repeating this procedure $m$ any tim es (typically 100 runs), the probability, $P_{1}\left(; C_{1}\right)$, of a
transition to a cusped state is obtained. For xed , $\mathrm{P}_{1}$ increases rapidly from 0 to 1 as $C_{1}$ is increased above a critical value. Typical results for $P_{1}$ as a function of $C_{1}$ for $=5: 0$ are show $n$ in the right inset of F ig The value of $c_{1}$ at which $P_{1}=0: 5$ provides an estim ate of $c_{1}^{c r}$. A nother estim ate is obtained from a sim ilar calculation of $P_{2}\left(; C_{1}\right)$, the probability that a at initial state evolves to a faceted steady state. A s expected, $\mathrm{P}_{2}$ increases shamity from 0 to 1 as $\mathrm{C}_{1}$ is decreased (see right inset of F ig and the value of $c_{1}$ at which this probability is 0.5 is slightly lower than the value at which $P_{1}=0: 5$. This di erence re ects nite-tim e hysteresis $e$ ects. The value of $\mathcal{q}^{r}$ is taken to be the average of these two estim ates, and the di erence betw een the two estim ates provides a $m$ easure of the uncertainty in the determ ination of $c_{1}^{c r}$ The phase boundary obtained this way is shown in $F$ id along w ith the results for $c_{1}^{\text {sp }}$.

The scaling behavior in the coarsening regim e in the presence of noise is the sam e as that found in the noiseless case. The qualitative behavior in the fo ase is sim ilar to that found in our earlier work on this m odelw thout the ES term. The ES term, now ever, has an im portante ect: 边 changes the coarsening exponent from 0.33 to 0.5 . A m odel very sim ilar to the $\cdots$ considered here was studied by Torcini and Politi for param eter values deep in the cusped regim e (sm all
, large $c_{1}$ ). The $m$ ounded $m$ orphology we nd in this regim e is sim ilar to that found in their study. O ur results for the exponents and $n$ are slightly di erent from the values ( $=\mathrm{n}=1=4$ ) reported by them. This is probably due to crossovere ects \{ we have found values of $n$ closer to $1 / 4$ ifsm aller values of and/or larger values of $C_{1}$ are used.

In sum $m$ ary we have show $n$ that a nonlinear instability in our spatially discrete grow th m odelin w hich the linear ES instability is also presentm ay, for appropriate param eter values, lead to $m$ ound form ation $w$ ith slope selection and power-law coarsening. This is qualitatively di erent from the behavior in the param eter regim ew here the ES instability dom inates: the system exhibitsm ound form ation in this regim e also, but there is no slope selection. $T$ he coarsening exponent has di erent values in these two regim es which are separated by a line of rst-order dynam ical phase transitions. The ES part of the surface current in our model does not vanish for any non-zero value of the slope. Therefore, the slope selection we nd in the regim ew here the nonlinear instability is dom inant is qualitatively $d i$ erent from that in ES-typem odels and is a true exam ple of nonlinear pattem form ation. The noiseless version of our m odel exhibits an interesting dependence on initial conditions: the long-tim e behavior depends on whether the inhom ogeneities in the initial con guration are su cient to seed the nonlinear instability. Both kinds of $m$ ounding behavior found in this study have been observed in experim ents, and ourm odel $m$ ay be relevant in the developm ent of an understanding of these experim entalobservations. H ow ever, $m$ ore w ork is required to establish a connection betw een our results
and those of experim ents.
