P hase transitions in the pseudogap Anderson and K ondo m odels: C ritical dim ensions, renorm alization group, and local-m om ent criticality

The pseudogap K ondo problem, describing quantum in purities coupled to ferm ionic quasiparticles with a pseudogap density of states, (!) / j! j, shows a rich zero-tem perature phase diagram, with di erent screened and free m om ent phases and associated transitions. We analyze both the particle-hole sym m etric and asym m etric cases using renorm alization group techniques. In the vicinity of r = 0, which plays the role of a lower-critical dimension, an expansion in the K ondo coupling is appropriate. In contrast, r = 1 is the upper-critical dimension in the absence of particle-hole sym m etry, and here insight can be gained using an expansion in the hybridization strength of the A nderson m odel. As a by-product, we show that the particle-hole sym m etric strong-coupling xed point for r < 1 is described by a resonant levelm odel, and corresponds to an interm ediate-coupling xed point in the renorm alization group language. Interestingly, the value r = 1=2 plays the role of a second lower-critical dimension in the particle-hole sym m etric case, and there we can m ake progress by a novel expansion perform ed around a resonant level m odel. The di erent expansions allow a complete description of all critical xed points of the m odels and can be used to com pute a variety of properties near criticality, describing universal local-m om ent uctuations at these in purity quantum phase transitions.

I. IN TRODUCTION

Non-trivial xed points and associated phase transitions in quantum in purity problems have been subject of considerable interest in recent years, with applications for impurities in correlated bulk systems, in transport through nanostructures, and for strongly correlated lattice models in the fram ework of dynam ical mean-eld theory. M any of those impurity phase transitions occur in variations of the well-known K ondo model¹ which describes the screening of localized magnetic moments by m etallic conduction electrons. A paradigmatic example of an interm ediate-coupling impurity xed point can be found in the two-channel K ondo e ect.

N on-m etallic hosts, where the ferm ionic bath density of states (DOS) vanishes at the Ferm i level, o era di erent route to unconventional in purity physics. O fparticular interest is the K ondo e ect in so-called pseudogap system $s^{2,3,4,5,6,7,8}$, where the ferm ionic bath density of states follows a power law at low energies, (!) / N₀ j! f(r > 0). Such a behavior arises in sem in etals, in certain zero-gap sem iconductors, and in system s with long-range order where the order param eter has nodes at the Ferm isurface, e.g., p-and d-wave superconductors (r = 2 and 1). Indeed, in d-wave high-T_c superconductors non-trivial K ondo-like behavior has been observed associated with the magnetic m om ents induced by non-magnetic Zn in purities^{9,10}. Note that the limit r ! 1 corresponds to a system with a hard gap.

The pseudogap K ondo problem has attracted substantial attention during the last decade. A number of studies^{2,3,4} employed a slave-boson large-N technique; signi cant progress and insight came from numerical renorm alization group (NRG) calculations^{5,6,7} and the local m om ent approach⁸. It was found that a zerotem perature phase transition occurs at a critical K ondo coupling, J_c , below which the impurity spin is unscreened even at low est temperatures. A loo, the behavior depends sensitively on the presence or absence of particle-hole (ph) asymmetry, which can arise, e.g., from a band asymmetry at high energies or a potential scattering term at the impurity site. A comprehensive discussion of possible xed points and their therm odynamic properties has been given in Ref. 6 based on the NRG approach.

Until recently, analytical know ledge about the critical properties of the pseudogap K ondo transition was lim ited. Previous works employed a weak-coupling renormalization group (RG) method, based on an expansion in the dimensionless K ondo coupling $j = N_0 J_K$. It was found that an unstable RG xed point exists at $j = r_{i}$ corresponding to a continuous phase transition between the free and screened m om ent phases². Thus, the perturbative computation of critical properties within this approach is restricted to smallr. Interestingly, the NRG studies' showed that the xed-point structure changes at 0:375 and also at $r=\frac{1}{2}$, rendering the relevant r = rcase of r = 1 in accessible from weak coupling. In the p-h sym m etric case, for $r = \frac{1}{2}$ the phase transition was found to disappear, and the impurity is always unscreened independent of the value of J_K . In contrast, in the asym – m etric case the phase transition is present for arbitrary r > 0. Num erical calculations^{6,7} indicated that the critical uctuations in the p-h asym metric case change their character at r = 1: whereas for r < 1 the exponents take non-trivialr-dependent values and obey hyperscaling, exponents are trivial for r > 1 and hyperscaling is violated. These ndings suggest to identify r = 1 as upper-critical \dim ension" of the problem , whereas r = 0 plays the role of a low er-critical \dim ension". As known, e.g., from the critical theory of magnets¹¹, the description of the transitions using perturbative RG requires di erent theoretical form ulations near the upper-critical and low er-critical dim ensions, i.e., the 4 theory and the non-linear sigm a model in the magnetic case.

In this paper, we provide a comprehensive analytical account of the phase transitions in the pseudogap Anderson and K ondo m odels, including the proper theories for the critical \dim ensions". This is made possible by working with the Anderson instead of the K ondo m odel { the degrees of freedom of the Anderson model turn out to provide a natural description of the low -energy physics at the quantum phase transitions near $r = \frac{1}{2}$ as well as close to and above r = 1. We shall consider epsilontype expansions in the hybridization, the on-site energy, and the interaction strength. Those expansions lead to di erent theories for the p-h sym m etric and asym m etric cases. Interestingly, in the pseudogap K ondo m odel the phase transitions near the lower-critical and uppercritical dimension are not adiabatically connected, as the xed point structure changes both at r = r and $r = \frac{1}{2}$. Thus the present quantum in purity problem has a more complicated ow structure than the critical theory of m agnets, where the (2 +) and (4)) expansions are believed to describe the same critical xed point.

In the p-h symmetric case of the pseudogap K ondo problem the line of non-trivial phase transitions term in the nates at two lower-critical dimensions (!), r = 0 and $r = \frac{1}{2}$. Near $r = \frac{1}{2}$ we nd an expansion around a non-interacting resonant level model, together with perturbative RG, to provide access to the critical xed point, with the expansion being controlled in the small parameter $(\frac{1}{2} - r)$, see Sec. IV. Interestingly, the weak-coupling expansion for the K ondo model, presented in Sec. III, provides a di erent means to access the same critical xed point, but with the small parameter being r; the two expansions can be expected to match.

In the p-h asymmetric case an expansion can be done in the hybridization around the valence- uctuation point of the Anderson model. Bare perturbation theory is su cient for all r > 1; for r < 1 a perturbative RG procedure is required to calculate critical properties, with the expansion being controlled in the sm all parameter (1 r). In particular, this identi esr = 1 as the upper-critical dimension of the (asymmetric) pseudogap K ondo problem, and consequently observables acquire logarithm ic corrections for r = 1. A brief account on the p-h asymmetric case and the expansion around r = 1 has been given in a recent paper¹². We note that the ow of the asym metric And erson model in the metallic case, r = 0, was discussed by Haldane¹³: here all initial parameter sets with nite hybridizations ow towards the strong-coupling (singlet) xed point.

For all cases listed above, we show that the critical properties of the Anderson and K ondo m odels are identical, and we calculate various observables in renorm alized perturbation theory. To label the xed points, we will follow the notation of R ef. 6.

Before continuing, we emphasize that standard tools for m etallic K ondo m odels, such as bosonization, B ethe ansatz, and conform al eld theory, are not easily applicable in the present case of a pseudogap density of states, as the problem cannot be described using linearly dispersing ferm ions in one dimension. Furtherm ore, integrating out the ferm ions from the problem, in order to arrive at an e ective statisticalm echanics model containing im purity degrees of freedom only, cannot be perform ed easily: the ferm ionic determ inants arising in (1 + r) dimensions cannot be simply evaluated. This implies that the pseudogap K ondo m odel does not m ap onto a one-dim ensional (e.g. Ising) model with long-ranged interactions, in contrast to e.g. the spin-boson m odel¹⁴. Indeed, the phase transitions in the pseudogap K ondo m odel and the sub-ohm ic spin-boson model are in di erent universality classes¹⁵. Therefore we believe that our combined RG analysis provides a unique tool for analyzing the pseudogap K ondo problem .

A. M odels

The starting point of our discussion will be the singleimpurity Anderson model with a pseudogap host density of states, $H = H_A + H_b$:

where we have represented the bath, H_b, by linearly dispersing chiral ferm ions q_k , sum mation over repeated spin indices is implied, and c (0) = dk k f q_k is the conduction electron operator at the impurity site. The spectral density of the c (0) ferm ions follows the power law j! f below the ultra-violet (UV) cuto ; details of the density of states at high energies are irrelevant for the discussion in this paper. The four possible in purity states, jei for the empty and jdi for the doubly occupied state. P rovided that the conduction band is p-h sym metry can be considered as SU (2) pseudospin, i.e., the full symmetry of the model is SU (2)_{spin}

SU (2)_{charge}. A sym m etry of the high-energy part of the conduction band has the sam e net e ect as a sym m etry of the impurity states; we will always assume that the low – energy part of the band is a sym ptotically sym m etric, i.e., the prefactor of j! f in the DOS is equal for positive and negative !.

The transform ation

converts all particles into holes and vice versa, form ally " $_0$! (" $_0$ + U $_0$), V $_0$! V $_0$. Physically, the roles of the states j"i and j#i are interchanged, as well as the states jei and jdi. It is useful to consider another transform ation,

which transform sj"i\$ jdi, j#i\$ jei. Here, the spinful doublet of in purity states is transform ed into the spinless doublet and vice versa, i.e., the two SU (2) sectors are interchanged.

In the so-called K ondo limit of the Anderson model charge uctuations are frozen out, and the impurity site is mainly singly occupied. V is Schrie er-W ol transformation one obtains the standard K ondo model, $H = H_K + H_b$, with

where the impurity spin S is coupled to the conduction electron spin at site 0, s (0) = $c^{y}(0)$ $_{0}c \circ (0)=2$, and

is the vector of P auli m atrices. The K ondo coupling is related to the param eters of the A nderson m odel (1) through:

The Kondo limit is reached by taking U_0 $\ ! \ 1$, "_0 $\ !$

1 , V_0 ! 1 , keeping $J_K \,$ xed. In the absence of p-h sym metry the Schrie er-W ol transformation also generates a potential scattering term in the elective K ondo model $\!\!\!\!\!\!\!\!\!$.

In the absence of an external magnetic eld all above models preserve SU (2) spin symmetry. Spin anisotropies turn out to be irrelevant at the critical xed points, see Appendix D. The e ect of a magnetic eld will be brie y discussed in Sec. V III.

B. Summary of results




FIG.1: Schematic RG ow diagrams for the particle-hole symmetric single-impurity Andersonmodelwith a pseudogap DOS, (!) / j! j. The horizontal axis denotes the renorm alized on-site level energy " (related to the on-site repulsion u by u = 2"), the vertical axis is the renorm alized hybridization v. The thick lines correspond to continuous boundary phase transitions; the full (open) circles are stable (unstable) xed points, for details see text. All xed points at nonzero " have a m irror in age at ", related by the particle-hole transform ation (3). a) r = 0, i.e., the fam iliar m etallic case. For any nite v the ow is towards the strong-coupling xed point (SC), describing K ondo screening. b) $0 < r < \frac{1}{2}$: The local-moment xed point (LM) is stable, and the transition to symmetric strong coupling (SSC) is controlled by the SCR xed point. Forr! 0, SCR approaches LM, and the critical behavior at SCR is accessible via an expansion in the Kondo coupling j. In contrast, for $r ! \frac{1}{2}$, SCR approaches SSC, and the critical behavior can be accessed by expanding in the deviation from SCR, i.e., in " = u=2. c) $\frac{1}{2}$ r < 1: v is still relevant at u = 0. However, SSC is now unstable w rt. nite u. At nite v, the transition between the two stable xed points LM and LM ' is controlled by SSC (which is now a critical xed point!).d) r 1: v is irrelevant, and the only transition is a level crossing (with perturbative corrections) occurring at v = u = 0, i.e., at the free-im purity xed point (FImp).




FIG. 2: Schematic RG ow diagram for the maximally particle-hole asymmetric pseudogap Anderson impurity model. The horizontal axis denotes the on-site in purity energy, ", the vertical axis is the ferm ionic coupling v, the bare on-site repulsion is xed at $u_0 = 1$. The symbols are as in Fig. 1. a) r < r < 1: v is relevant, and the transition is controlled by an interacting xed point (ACR). As r! r 0:375, p-h symmetry at the critical xed point is dynamically restored, and ACR merges into the SCR xed point of Fig. 1 { this cannot be described using the RG of Sec.V. In the m etallic r = 0 situation, studied by Haldane¹³, the ow from any point with v $\stackrel{\bullet}{\bullet}$ 0 is towards the screened singlet xed point with " = 1.b) r 1:v is irrelevant, and the transition is a level crossing with perturbative corrections, occuring at v = " = 0, i.e., the valence-uctuation xed point (VF1).

Our main results are summarized in the RG ow diagrams in Figs.1 and 2, for the p-h symmetric and asymmetric cases, respectively.

In the symmetric case, the ranges of exponent values $r = 0, 0 < r < \frac{1}{2}, \frac{1}{2}$ r < 1, and r 1 lead to quite different behavior, and are shown separately in Fig.1. No transition occurs for r = 0: for any non-zero hybridization the ow is towards them etallic K ondo-screened xed point (SC). This well-known xed point can be identied as the stable xed point of a resonant levelm odel; we argue below that this is actually an interm ediate-coupling xed point.

For $0 < r < \frac{1}{2}$, sm all values of the hybridization leave the impurity spin unscreened provided that " $_0 < 0$, i.e., there is a stable local-moment xed point (LM) corresponding to "= 1, v = 0. A transition line at negative ", with an unstable xed point (sym metric critical, SCR) at nite v, J'j separates the ow towards LM from the ow to the sym metric strong-coupling xed point (SSC). The strong-coupling xed point displays its intermediatecoupling properties now in a nite residual entropy and a nitem agneticm oment, see Sec. IV B.Asr! 0 the SCR

xed point m erges with LM , in a m anner characteristic for a low er-critical dimension, i.e., with diverging correlation length exponent. A second critical xed point SCR' exists for " > 0 which separates the symmetric strong-coupling phase (SSC) from one with a free charge doublet (LM ').

As $r ! \frac{1}{2}$ the symmetric critical xed points merge with the strong-coupling one, again in a manner characteristic for a low er-critical dimension. For $r \frac{1}{2}$ the xed points SCR and SCR' cease to exist; the strong-coupling SSC xed point becomes infrared unstable, and controls the LM { LM' transition. Finally, the structure of the ow changes again at r = 1: for r ! 1 the unstable strong-coupling xed point (SSC) moves towards v = 0, i.e., the free-in purity xed point (FImp), and for r = 1no non-trivial xed point remains.

Form axim alp-h asymmetry, realized in the Anderson m odel through $U_0 = 1$, one has to distinguish exponent ranges r = 0, 0 < r r, r < r < 1, and r1. In the metallic case r = 0 any non-zero hybridization generates ow to strong coupling with complete screening { the strong-coupling xed point is the same as in the p-h sym m etric situation, as p-h sym m etry is m arginally irrelevant at strong coupling. For all r > 0 the situation is drastically di erent: sm all V0 leaves the m om ent unscreened, whereas large V0 directs the ow tow ards a new, p-h asym m etric, strong-coupling xed point (ASC). The character of the critical xed point separating the two phases depends⁶ on r: for 0 < r < r p-h symmetry is restored, and the critical xed point is the one of the p-h symmetric model. For r < r < 1 there is a separate critical xed point (ACR) which is p-h asymmetric, i.e., located at nite v and ". Forr! 1 the critical xed point m oves tow ards v ! 0, and for r 1 the phase transition becom es a level crossing (with perturbative corrections), controlled by the valence-uctuation xed point (VFl), see Fig. 2.

We nally discuss the general case of nite p-h asym m etry, m ore details will be given in Sec.VI. Power counting shows that LM (SSC) are always (un) stable w.r.t. ph asym m etry. The sym m etric critical SCR xed point is stable w.r.t. p-h asymmetry for small r. In contrast, for $r < \frac{1}{2}$ SCR is unstable towards p-h asymmetry, as it is close to SSC in this regime. This requires the existence of a speci c r value where this change in character occurs: the is precisely r = r0:375 where p-h asymmetry at SCR is marginal⁶. Upon increasing r beyond r the p-h asymmetric critical xed point (ACR) splits o from SCR. In other words, upon approaching r from large r the ACR xed point moves towards smalle ective p-h asymmetry, and at r = r ACR merges into SCR, im plying p-h sym m etry is dynam ically restored. As stated above, the description of ACR using an expansion around VFlconsequently breaks down as r! r⁺. Neither from num erics⁶ nor from the present RG are there indications for the existence of a second asymmetric critical xed point besides ACR; thus, the critical properties for nite p-h asymmetry are always equivalent to the ones of a

modelwith maxim alp-h asymmetry.

Taken together, the above observations show that r = 0 plays the role of a low er-critical dimension: as $r ! 0^+$, the correlation length exponent diverges, and the second-order transition turns into a K osterlitz-T houless transition at r = 0. Interestingly, in the symmetric case the correlation length exponent also diverges as $r ! \frac{1}{2}$, and the transition between LM and SSC disappears for $r \frac{1}{2} : r = \frac{1}{2}$ is a second low er-critical dimension for the p-h symmetric problem. In the asymmetric case, there is a transition between LM and ASC for all r > 0, and r = 1 is equivalent to the upper-critical dimension, above which the critical xed point is non-interacting (actually a level crossing).

C. Outline

The rest of this paper is organized as follows: Sec. II introduces the observables to be evaluated in the course of the paper, together with their expected scaling behavior near criticality. In Sec. III we brie y review the standard weak-coupling perturbative RG for the K ondo

model, which is suitable to describe the quantum phase transition for small r. Sec. IV discusses the particlehole symmetric Anderson model. Starting from the noninteracting case, $"_0 = U_0 = 0$, we rst discuss the physics of the resulting non-interacting resonant level model { interestingly this can be identied with a stable intermediate-coupling xed point. We then use a perturbative expansion in U_0 to access the critical xed points for $r < \frac{1}{2}$. In Sec. V we turn to the situation with maximalp-h asymmetry, i.e., $U_0 = 1$, and show that an expansion in the hybridization provides access to the critical properties for r > 1 as well as for r < 1. In Sec.VIwe consider the case of general p-h asymmetry. Sec. V III brie y describes the e ect of a magnetic eld: the pseudogap model is shown to perm it a sharp transition as function of a eld applied to the impurity for couplings larger than the zero-eld critical coupling. In Sec.VII we compare the physics of the Anderson and K ondo m odels, arguing that the transitions in both m odels fall in the sam e universality classes. A brief discussion of applications concludes the paper. All renorm alization group calculations will employ the eld-theoretic RG scheme¹⁶ together with dimensional regularization and m in im al subtraction of poles, with details given in the appendices; one-loop RG results can equivalently be obtained using the fam iliarm om entum -shellm ethod.

II. OBSERVABLES AND SCALING

To establish notations and to pave the way for the RG analysis below, we introduce a few observables together with their expected scaling properties.

A. Susceptibilities

M agnetic susceptibilities are obtained by coupling an external magnetic eld to the bulk electronic degrees of freedom in H_b,

and to the impurity part H $_{\rm A}$, H $_{\rm K}$,

for the Anderson (1) and K ondo (4) m odels, respectively. The bulk eld H $_{\rm u}$ varies slow ly as function of the space coordinate, and H $_{\rm im \ p}$ is the magnetic eld at the location of the im purity.

W ith these de nitions, a spatially uniform eld applied to the whole system corresponds to $H_u = H_{imp} = H$. Response functions can be de ned from second derivatives of the therm odynamic potential, = T ln Z, in the standard way¹⁷: _{u;u} m easures the bulk response to a eld applied to the bulk, _{imp;imp} is the impurity response to a eld applied to the impurity, and _{u;imp} is the cross-response of the bulk to an impurity eld. The impurity contribution to the total susceptibility is de ned as

where $_{u,u}^{bulk}$ is the susceptibility of the bulk system in absence of the in purity. For an unscreened in purity spin of size $S = \frac{1}{2}$ we expect $_{im p}(T ! 0) = 1 = (4T)$ in the low-temperature limit, and this is precisely the result in the whole LM phase. A fully screened moment will be characterized by T $_{im p} = 0$; note that the SSC xed point displays a nite value of T $_{im p}$ for r > 0. At criticality $_{im p}$ does not acquire an anom alous dimension¹⁸ (in contrast to $_{loc}$ below), because it is a response function associated to the conserved quantity S_{tot} . Thus we expect a Curie law

where the prefactor C_{imp} is in general a non-trivial universal constant di erent from the free-in purity value S(S + 1)=3. Apparently, Eq. (9) can be interpreted as the Curie response of a fractional e ective spin¹⁹.

The local in purity susceptibility is given by

which is equivalent to the zero-frequency in purity spin autocorrelation function. In the unscreened phase we have $_{\rm loc} / 1=T$ as T ! 0; we can consider this as arising from the overlap of the local in purity m om ent with the total, freely uctuating, m om ent of S = 1=2, and so write

The quantity m $_{\rm bc}$ turns out to be a suitable order param eter^{6,7} for the phase transitions between an unscreened and a screened spin: it vanishes continuously as t! 0, where t is the dimensionless measure of the distance to criticality; in the K ondom odelt = $(J_{\rm K} \ J_{\rm c})=J_{\rm c}$, whereas in the Anderson modelt = $(V_0 \ V_0_{\rm c})=V_{0_{\rm c}}$. Thus, T $_{\rm loc}$ is not pinned to the value of 1/4 for t < 0 (in contrast to T $_{\rm im\,p}$). Rem arkably, m $_{\rm loc}$ = 0 at the SSC xed point for r < 1, although T $_{\rm im\,p}$ = r=8 there.

The phase transitions occurring for 0 < r < 1 are described by interacting xed points, and thus obey strong hyperscaling properties, including !=T scaling in dynam - ical quantities²⁰. For instance, the local dynam ic susceptibility will follow a scaling form

which describes critical localmoment uctuations, and the local static susceptibility obeys

Here, is a universal anom abus exponent, which controls the anom abus decay of the two-point correlations of the inpurity spin, and $_{1,2}$ are universal crossover functions (for the speci c critical xed point and for xed r), whereas $B_{1,2}$ are non-universal prefactors. Furtherm ore,

is the correlation length exponent, describing the ow away from criticality: when the system is tuned through the transition, the characteristic energy scale T , above which critical behavior is observed, vanishes as 20

the dynam ical critical exponent z can be set to unity in the present (0 + 1)-dimensional problem . Note that at criticality, t = 0, the relation (13) reduces to $_{\rm loc}$ (T) / T $^{1+}$.

Hyperscaling can be used to derive relations between critical exponents. The susceptibility exponent and the correlation length exponent of a speci c transition are su cient to determ ine all critical exponents associated with a local magnetic eld^7 . In particular, the T ! 0 local susceptibility away from criticality obeys

which can be derived from a scaling ansatz for the in – purity part of the free energy⁷. The last relation in plies the order parameter vanishing as

Note that hyperscaling holds for all critical xed points of the pseudogap K ondo problem with 0 < r < 1.

B. Impurity entropy

In general, zero-tem perature critical points in quantum impurity models can show a nite residual entropy [in contrast to bulk quantum critical points where the entropy usually vanishes with a power law, S (T) / T^y]. For the models at hand, the impurity contribution to the low-tem perature entropy is obtained by a perturbative evaluation of the therm odynam ic potential and taking the tem perature derivative. This will yield epsilon-type expansions for the ground state entropy S_{imp} (T = 0), with explicit results given below.

N ote that the impurity part of the therm odynam ic potential will usually diverge with the cuto , i.e., we have $_{im\,p} = E_{im\,p}$ T $S_{im\,p}$, where $E_{im\,p}$ is the non-universal (cuto -dependent) impurity contribution to the groundstate energy. However, the impurity entropy $S_{im\,p}$ is fully universal, and the UV cuto can be sent to in nity after taking the temperature derivative of $_{im\,p}$.

Therm odynam ic stability requires that the total entropy of a system decreases upon decreasing temperature, $Q_T S(T) > 0$. This raises the question of whether the impurity part of the entropy, $S_{\rm imp}$ has to decrease

C. T m atrix

A n important quantity in an Anderson or K ondom odel is the conduction electron T matrix, describing the scattering of the celectrons o the impurity. For an Anderson model, the T matrix is just given by T (!) = $V_0^2 G_f(!)$ where G_f is the full impurity f electron G reen's function. For a K ondo model, it is useful to de ne a propagator G_T of the composite operator $T = f^{Y} f \circ c \circ$, such that the T matrix is given by T (!) = $J_K^2 G_T$ (!). As with the local susceptibility, we expect a scaling form of the T matrix spectral density near the interm ediate-coupling xed points similar to Eq. (12). In particular, at criticality a power law occurs:

Remarkably, we will not the exact result $_{\rm T} = 1$ r for r < 1, i.e., for all interacting critical xed points considered in this paper the T matrix follows T (!) / ! ^r. NRG calculations have found precisely this critical divergence, for both the symmetric and asymmetric critical points^{5,23}. At the trivial xed points (LM, ASC) the behavior of the T matrix follows from perturbation theory in the hybridization to be T (!) / !^r.

Notably, the T matrix can be directly observed in experiments, due to recent advances in lowtemperature scanning tunneling microscopy, as has been demonstrated, e.g., with high-temperature superconductors^{23,24,25}.

D. Phase shifts

Fixed points which can be described in terms of free fermions can be characterized by the s-wave conduction electron phase shift, $_0(!)$, which can be related to the conduction electron T matrix through $_0(!) =$ argT (!). A decoupled in purity simply has a phase shift $_0 = 0$, whereas a p-h symmetric K ondo-screened in purity in a metallic host has a low-energy phase shift of $_0(!) = \frac{1}{2}$ sgn(!). A detailed discussion for the pseudogap model has been given in R ef. 6, in the body of the paper we will simply quote the results.

III. W EAK-COUPLING RG FOR THE KONDO MODEL

In this section we brie y sum marize the weak-coupling RG for the pseudogap K ondo model (4), as rst discussed by W itho and Fradkin². Perturbative RG is performed around $J_K = 0$, i.e., the local-moment xed point (LM): this will allow to access the (p-h symmetric) critical xed point SCR, which is located close to LM for small DOS exponents r.

A. Lower critical dimension: Expansion around the local-moment xed point

The RG ow equation for the renorm alized K ondo coupling j, to two-loop order, reads²⁶

This yields an infrared unstable xed point at

which controls the transition between the decoupled LM and the K ondo-screened SSC phases. The small-j expansion (18) { which is nothing but the generalization of Anderson poorm an's scaling²⁷ to the pseudogap case { cannot give information about the strong-coupling behavior, and it can only describe critical properties for small r. (In the p-h symmetric case, the xed point structure does not change within the exponent range $0 < r < \frac{1}{2}$, thus the present expansion is in principle valid up to $r = \frac{1}{2}$.)

Adding a potential scattering term V_0 gives a nite p-h asymmetry. Under RG, we nd that V renormalizes to zero for r > 0, (V) = rV. Thus, within the range of applicability of the weak-coupling RG, p-h asymmetry is innelevant. (Strictly, this applies for r < r, see Ref. 6.)

B. Observables near criticality

W e quote a few properties of the critical regim e which have been determ ined in Ref. 26. Expanding the beta function (18) around the xed point value (19) yields the correlation length exponent :

A comparison of the above results with num erical data is given in Figs. 3, 5, 6, and 7 below.

M ost in portantly, the continuous transition controlled by the xed point (19), which exists only for r > 0, evolves smoothly into the K osterlitz-T houless transition at r = 0, j = 0, which separates the antiferrom agnetic and the ferrom agneticm etallic K ondo m odel. This is also indicated by the divergence of the correlation length exponent (20) as $r ! 0^+$. Thus, r = 0 can be identi ed as a low er-critical \dim ension" of the pseudogap K ondo problem. It is interesting to com pare the present expansion with the (2+) expansion for the non-linear sigm a m odel, appropriate form agnets close to the low er-critical dim ension. The expansion is done about the ordered m agnet, thus the LM phase with ln 2 residual entropy takes the role of the ordered state in the pseudogap K ondo problem.

IV. PARTICLE HOLE SYMMETRIC ANDERSON MODEL

In the follow ing sections of the paper we shift our attention from the K ondo m odel to the impurity Anderson m odel with a pseudogap density of states. This form ulation will provide new insights into the RG ow and the critical behavior of both the Anderson and K ondo m odels.

The coupling between in purity and bath is now the Anderson hybridization term, V_0 , which turns out to be marginal in a RG expansion around $V_0 = 0$ for the DOS exponent r = 1 (in contrast to the K ondo coupling J_K which is marginal for r = 0). As we will show in Sec. V, the Anderson m odel provides the relevant low energy degrees of freedom for the p-h asym metric pseudogap transition near its upper-critical dimension.

Interestingly, also the p-h symmetric version of the Anderson model allows to uncover highly non-trivial physics, in particular the special role played by the DOS exponent $r = \frac{1}{2}$, where the transition disappears in the presence of p-h symmetry. Thus we start our analysis with the particle-hole symmetric Anderson model (1), i.e., we keep $U_0 = 2"_0$ and discuss the physics as function of V_0 and $"_0$.

A. Trivial xed points

For vanishing hybridization, $V_0 = 0$, the symmetric Anderson model (1) features three trivial xed points: for $"_0 < 0$ the ground state is a spinful doublet { this represents the local-moment xed point (LM).For $"_0 > 0$ we nd a doublet of states (empty and doubly occupied), denoted as LM ' and related to LM by the p-h transform ation (3). Both LM and LM ' have a residual entropy of $S_{im\,p} = \ln 2$. At "₀ = 0 a level crossing between the two doublets occurs, i.e., all four in purity states are degenerate { this is the free-in purity xed point (F Im p), with residual entropy ln 4. The in purity spin susceptibilities are

the conduction electron phase shift is zero at all these xed points. The hybridization term, V_0 , is irrelevant at both the LM and LM ' xed points for r > 0, whereas for r = 0 it is marginally relevant, as shown by the RG in Sec. IIIA.

B. Resonant level model: Interm ediate-coupling xed point

It proves useful to discuss the $"_0 = U_0 = 0$ case, i.e., the physics on the vertical axis of the ow diagrams in Fig.1. This non-interacting system is known as resonant levelm odel, as the two spin species are decoupled. The problem can be solved exactly: the f electron self-energy is

where G_{c0} is the bare conduction electron G reen's function at the impurity location R = 0. In the low-energy lim it the f electron propagator is then given by

Before stating results for observables it is interesting to tackle the problem using RG techniques, with an expansion in the hybridization strength V_0 around the freeimpurity xed point (FIm p, $V_0 = 0$). We study the action

where c (0) is the bath ferm ion eld at the impurity position as above. Power counting w.r.t. the $V_0 = 0$ xed point, using dim [f] = 0, dim [c(0)] = (1 + r)=2, yields

i.e., the hybridization is relevant only for r < 1.

To perform RG within the eld-theoretic scheme¹⁶, we introduce a <u>penorm</u> alized hybridisation v according to $V_0 = (Z_v \ r = \overline{Z})v$, where is a renorm alization energy scale, and Z_v and Z are the interaction and eld renormalization factors. The RG ow equation for v is found to be

Remarkably, this result is exact to all orders in perturbation theory: the cubic term arises from the only self-energy diagram of the f ferm ions, and no vertex renorm alizations occur ($Z_v = 1$). This im plies that the low-energy physics of the non-interacting resonant level m odel is controlled by the stable interm ediate-coupling xed point located at

for 0 r < 1, which also applies to the fam iliar m etallic case r = 0.

The interm ediate-coupling nature of the stable xed point, with associated universal properties, is consistent with the results known from the exact solution of the problem, e.g., a universal conduction electron phase shift, a universal crossover in the tem perature-dependent susceptibility etc.

W e proceed with calculating a number of observables for the pseudogap resonant level model. Interestingly, this can be done in two ways: either (i) via the exact solution of the problem, i.e., by integrating out the c ferm ions exactly [leading to the propagator (26)], or equivalently (ii) by evaluating perturbative corrections to the F Im p xed point using the RG result (31), utilizing standard renorm alized perturbation theory, and noting that all corrections beyond second order in v vanish exactly within this scheme. Details of the calculation are in Appendix A.

We start with evaluating spin susceptibilities { note that we have kept two spin species in the model. The zero-tem perature dynam ic local susceptibility is proportional to the bubble form ed with two f propagators (26),

where the case of $r = \frac{1}{2}$ receives logarithm ic corrections, see below. The low-temperature limit of the impurity susceptibility is found to be

xed point (FIm p) with properties listed in Sec. IV A. The conduction electron phase shift near the Ferm i level, determ ined in R ef. 6, is

Interestingly, the resonant level model describes a screened in purity only in the metallic case. For the pseudogap case, r > 0, Eqs. (33) and (34) show that the impurity is only partially screened: in a model of free ferm ions we have a residual entropy! We will see below that the resonant level model xed point (31) can be identied with the symmetric strong-coupling xed point (SSC) of G onzalez-B uxton and Ingersent⁶, introduced for the p-h symmetric K ondo and A nderson models.

C. Expansion around the resonant level xed point

A fler having analyzed the behavior of the Anderson m odel in the non-interacting case, we proceed to study the stability of the resonant level xed point w r.t. a - nite interaction strength U_0 , keeping p-h symmetry. Im - portantly, this xed point, characterized by a nite hybridization strength between impurity and bath, is stable for sm allr [see Eq. (37)]; we conclude that it can be identiated with the SSC xed point of R ef. 6.

Numerical results^{5,6} indicate that the quantum phase transition between LM and SSC disappears as r is increased to $\frac{1}{2}$, where the p-h symmetric critical xed point (SCR) merges with the SSC xed point. We shall show that an expansion around the SSC xed point captures the physics of the SCR xed point for $r < \frac{1}{2}$. Thus, this expansion describes the same critical xed point as the weak-coupling expansion of Sec. III, but approaching it from $r = \frac{1}{2}$ instead of r = 0. (The r values 0 and $\frac{1}{2}$ are two lower-critical dimensions for the p-h symmetric pseudogap K ondo problem.)

The RG expansion below will be performed around an intermediate-coupling xed point, in contrast to most analytical RG calculations which expand around trivial (i.e. weak or strong-coupling) xed points. Strategically, one could think about a double expansion in V₀ and U₀. However, this is not feasible, as the marginal dimensions for both couplings are di erent, r = 1 and $r = \frac{1}{2}$, respectively. Therefore we choose to rst integrate out the c ferm ions exactly, and then use standard RG tools for the expansion in U₀.

Consequently, the starting point is the action

where the f fermions are now \dressed" by the conduction lines. A_0 is the non-universal number given in Eq.

(27), and we have assumed 0 < r < 1. The interaction term has been written in a p-h symmetric form. A note is in order regarding the cuto : The originalm odel had a UV cuto , and this sets the upper bound for the j! n j behavior of the f propagator (26), i.e., is now the energy cuto for the spectral density of the f ferm ions. The RG to be performed below can be understood as progressive reduction of this cuto (although we will use the eld-theoretic schem e where the cuto is implicitly sent to in nity at an early stage).

D in ensional analysisw rt. the $U_0 = 0$ situation, using dim [f] = (1 r)=2, results in

hence, for r > 1=2 the interaction term is relevant and the SSC xed point is unstable.

W e continue with the RG analysis of (36). To perform a perturbative expansion in U_0 using the eld-theoretic schem e^{16} , we introduce a renorm alized eld and a dim ension less coupling according to

where is a renorm alization energy scale as usual, and () is the bare scaling dimension of U; we have absorbed the non-universal number A_0 appearing in the dynamic term of the action (36) in order to obtain a universal xed point value of u.

The complete RG analysis, needed to determ ine the ow of u, is presented in Appendix B, here we restrict ourselves to the nal results. P-h symmetry prohibits the occurence of even powers of u in the beta function of u, therefore the lowest contributions arise at two-loop order. Remarkably, no singular propagator renorm alizations occur, thus

N ext-to-leading order contributions would require a fourloop calculation which we do not attem pt here. For positive , i.e., $r < \frac{1}{2}$, Eq. (41) yields a pair of unstable xed points at nite juj (in addition to the stable one at u = 0); the correlation length exponent of the transition, Eq. (43), diverges as $r ! \frac{1}{2}$. Thus, the behavior below $r = \frac{1}{2}$ is sim ilar to the standard behavior above a low ercritical dimension (e.g. in the non-linear sigm a model for bulk magnet case).

D. r = 0

Clearly, the unstable nite-u xed points predicted by the perturbative RG equation (41) do not necessarily exist for the m etallic case r = 0, as = 1 is possibly outside the convergence radius of the expansion. Indeed, the K ondo RG of Sec. IIIA shows that, at r = 0, the LM and LM' xed points are unstable w r.t. nite in purity coupling. As the resonant-level xed point at u = 0 is stable, we conclude that the ow is directly from LM (LM') to SC, and SC represents the familiar strong-coupling K ondo xed point, with com plete screening of the spin. The RG ow is in Fig.1a.

For r values smaller than $\frac{1}{2}$, both the v = v, u = 0 xed point (SSC) and the v = 0, j''j = 1 xed points (LM, LM') are stable, and should be separated by critical xed points. The RG equation (41) yields a pair of infrared unstable xed points at

with = 1 2r. These two xed points represent SCR and SCR', see the ow diagram in Fig.1b. Note that p-h symmetry also dictates that the ow trajectories out of the SSC xed point are horizontal in the u-v² diagram. Therefore, close to $r = \frac{1}{2}$ the SCR and SCR' xed points are completely described by the xed point coupling values v (31) and u (42).

For $r > \frac{1}{2}$ ($r = \frac{1}{2}$) the self-interaction u is a (marginally) relevant perturbation at the SSC xed point, and (41) does not yield additional non-trivial xed points. A s LM and LM ' are stable, we can conclude that the ow is from SSC directly towards LM (LM ') for positive (negative) U₀. Hence, SSC has become a critical xed point, controlling the transition between LM and LM ', which occurs at U₀ = 0 for any nite V₀. We shall not consider this transition in greater detail, apart from stating its correlation length exponent, 1 = ... Fig.1c displays the ow diagram arising from this discussion, being consistent with the numerical results of R ef. 6.

G. r 1

The physics of the symmetric Anderson model for r 1 is easily discussed: the hybridization term V_0 is irrelevant for all U_0 , Eq. (29). The free-impurity xed point (FIm p) is the only remaining xed point at $U_0 = 0$. It is unstable w.r.t. nite U_0 , and controls the transition




FIG. 3: Inverse correlation length exponent 1= obtained from NRG, at both the symmetric (squares) and asymmetric (triangles) critical points, together with the analytical RG results from the expansions in r [Sec. III, Eq. (20), solid], in $(\frac{1}{2}$ r) [Sec. IV, Eq. (43), dashed], and in (1 r) [Sec. V, Eq. (72), dash-dot]. The numerical data have been partially extracted from Ref. 7 using hyperscaling relations; for the symmetric model data are from Ref. 5.

between the two stable xed points LM and LM'. The resulting ow diagram is in Fig.1d.

H. Observables near criticality

Here we discuss critical properties of the SCR xed point, the properties of SCR' are identical when translated from spin to charge degrees of freedom. The correlation length exponent follows from expanding the beta function (41) around its xed-point value:

A comparison with results from NRG is shown in Fig.3. C lose to $r = \frac{1}{2}$, the analytical expression nicely matches the numerical results, however, higher-order corrections in the expansion quickly become important.

We continue with the quantities introduced in Sec. II. A susual for an expansion where the non-linear coupling has an infrared unstable xed point (as occurs above the lower-critical dimension in standard situations), the UV cuto needs to be kept explicitly, and intermediate quantities will diverge with the UV cuto (see e.g. the calculation of the impurity entropy). However, these divergences will cancel in the nal expressions for universal observables, and this is an important check for the consistency of our calculations.

1. Local susceptibility

The local susceptibility at the SSC xed point, i.e., at tree level, follows the power law $l_{\rm loc} / !^{1 2r} = !$. To obtain corrections to the tree-level result, one introduces




FIG.4: Feynm an diagram s for the sym metric A nderson impurity model, where the expansion is done in U_0 around the resonant level model xed point. Full lines are dressed f propagators with the self-energy arising from the conduction electrons already taken into account, i.e., with the propagator given in Eq. (26). a) Bare interaction vertex U_0 . b) Correlation function involving a composite (ff) operator (wiggly line), together with the rst perturbative correction. c) U_0 correction to the local susceptibility improper loc, open circles are sources. d) U_0 correction to $_{ugu}$, which contributes to the Curie term of the impurity susceptibility imp. D ashed lines are conduction electron lines, and the full dots are the V_0 vertices. e) U_0^2 contribution to the impurity free energy.

a $_{\rm loc}$ renorm alization factor, Z $\,$, from which one obtains the anom alous exponent according to

Note that $1 = +^{0}$, with de ned in Eqs. (12,13), due to the non-trivial structure of the problem already at tree level.

D i erent ways can be used to determ ine Z . Realizing that $_{\rm loc}$ is a correlation function of a composite (ff) operator leads to Z = Z_2^2 , where Z_2 is the renorm alization factor associated with (ff). Z_2 can be calculated from the correlation function shown in Fig. 4b, which receives a perturbative correction to $\,$ rst order in U_0 . A lternatively, $_{\rm loc}$ can be calculated directly, and a single diagram gives a contribution of order U_0 (Fig. 4c). Both ways lead to




FIG. 5: NRG data⁷ for the local susceptibility exponent, , de ned through $_{\rm loc}$ / T $^{1+}$, at both the symmetric (squares) and asymmetric (triangles) critical points, together with the renormalized perturbation theory results from the expansions in r [Sec. III, Eq. (23), solid], in ($\frac{1}{2}$ r) [Sec. IV, Eq. (47), dashed], and in (1 r) [Sec. V, Eq. (75), dash-dot].

where the rst term contains the tree level expression, and further O () terms arise from higher-order perturbative corrections. A comparison with NRG results is given in Fig. 5, where good agreem ent near $r = \frac{1}{2}$ can be observed.

2. Im purity susceptibility

For the impurity contribution to the uniform susceptibility we expect a Curie law, as discussed in Sec. II. At tree level, a term of Curie form does only arise from u_{ju} , with T $u_{ju} = r=8$. Both imp;imp and u;imp are less singular for r < 1, consistent with T $l_{bc} = 0$, see also Appendix A. Also note that u_{ju} is the only of the three terms where the non-universal number A_0 drops out.

We are interested in corrections to T $_{inp}$ to lowest non-trivial order in U₀, and consequently those corrections can only occur in $_{u,u}$. A single diagram contributes to rst order in U₀ (Fig. 4d), which gives




FIG. 6: Numerical data for the impurity susceptibility, T imp, at both the symmetric (squares) and asymmetric (triangles) critical points, together with the renormalized perturbation theory results from the expansions in r [Sec. III, Eq. (21), solid], in $(\frac{1}{2}$ r) [Sec. IV, Eq. (51), dashed], and in (1 r) [Sec. V, Eq. (85), dash-dot]. The thin line is the value of the SSC xed point, T imp = r=8. The numerical data are partially taken from Ref. 6; we have re-calculated the data points near r = 1, as the logarithm ically slow ow at r = 1 com plicates the data analysis.

where r=8 is the tree level contribution, and the O () represents higher perturbative term s as above. This result can be nicely compared to NRG data of Ref. 6, see Fig. 6.

3. Im purity entropy

The impurity entropy can be straightforwardly determ ined from a perturbative expansion of the impurity part of the therm odynam ic potential. The lowest correction to the tree-level value $S_{im\,p} = 2r\ln 2$ is of order U_0^2 . The corresponding contribution to the therm odynam ic potential, F ig. 4e, is given by

Unfortunately, we were not able to analytically

prove the convergence of the integral as ! 1 . We have therefore resorted to a num erical evaluation for nite




FIG.7: As Fig. 6, but for the impurity entropy $S_{im\,p}$; the NRG values at the SSC xed point are hardly distinguishable from ln 2. The perturbative expansions are in Eq. (22) (solid), Eq. (55) (dashed), and Eq. (89) (dash-dot); the thin line is the value of the SSC xed point, T im $p = 2r \ln 2$.

The two expansions for the entropy of the SSC xed point, (22) and (55), predict a sm all positive correction to ln 2 for $0 < r < \frac{1}{2}$, as shown in Fig. 7, consistent with the notion that entropy should decrease under RG ow ²¹. Results from NRG (Ref. 6 as well as ours) show that the deviation from ln 2 is tiny for all $0 < r < \frac{1}{2}$, which is in principle consistent with the analytical results. [A lthough we identi ed signatures of a r³ correction to S_{im p} = ln 2 in the sm all-r regime, the accuracy of our NRG procedure was insu cient to determ ine the prefactor²⁶.]

4. Conduction electron T matrix

In the Anderson model formulation of the impurity problem, the conduction electron T matrix is directly proportional to the physical f electron propagator. As shown in Appendix B, there are no singular propagator renormalizations in the present problem, Z = 1 (40). Thus, from Eq. (26) we have the exact result for the exponent of the T matrix,

which holds at the SCR and SCR' xed points, and (trivially) also at the SSC xed point. A result similar to Eq. (56) was derived²⁸ for the SCR xed point within the small-r expansion of Sec. III, in agreement with the notion that both expansions describe the same critical xed point.

V. MAXIMALLY PARTICLE HOLE ASYMMETRIC ANDERSON MODEL

In this section we consider a di erent limit of the pseudogap Anderson model (1), namely the model with maximal p-h asymmetry. This means that one of the four possible impurity states will be excluded: with U_0 ! 1 (keeping $"_0$ nite) this is the doubly occupied one, whereas with $"_0$! 1 (keeping U_0 nite) the empty state is excluded. As these two situation are related by the p-h transformation (2), we will form ulate the following for U_0 ! 1. The Ham iltonian can be written as

where j"i, j#i, and jei represent the three allowed in - purity states.

W e shall show that this in nite-U pseudogap Anderson m odel has a phase transition between a free m om ent and a K ondo-screened phase, which is accessible to perturbative RG techniques near r = 1. In particular, r = 1 plays the role of the upper-critical dimension. Furtherm ore, we will argue in Secs. VI and VII that the transitions in both the Anderson and the K ondo m odel with nite p-h asymmetry are in the same universality class, and are described by the RG presented below, provided that r > r .

A. Trivial xed points

For vanishing hybridization V_0 , the maximally asymmetric Anderson model features three trivial xed points: for $"_0 < 0$ the ground state is the spinful doublet (LM) with ln 2 entropy. For $"_0 > 0$ we have an empty-state singlet, which we can identify with the ASC state of the K ondo model (see below). The doubly occupied singlet state (labelled ASC') is related to ASC by the p-h transformation (2). For $"_0 = 0$ we have three degenerate im purity states, we refer to this as the valence- uctuation xed point (VF1), with entropy ln 3. The impurity spin susceptibilities are

A gain, the conduction electron phase shift is zero at these xed points due to the vanishing xed point value of the hybridization. The hybridization term, V_0 , is irrelevant at the ASC xed point for all r, and irrelevant at LM for r > 0.

B. Upper-critical dimension: Expansion around the valence- uctuation xed point

In the following we perform an expansion around the VF1 xed point, i.e., around $"_0 = 0$, $V_0 = 0$. This will give access to the properties of the ASC xed point, i.e., a critical xed point di erent from the one accessed by the RG calculations in Secs. III and IV.

To represent the three in purity states in the in nite-U Anderson m odel it is useful to introduce auxiliary edds for pseudo-particles, b_s (for the empty-state singlet) and f (for the spinful doublet). The required H ilbert space constraint $b_s^y b_s + f^y f = \hat{Q} = 1$ will be in plem ented using a chem ical potential $_0$! 1, such that observables ho^i i have to be calculated according to^{29,30}

where h:::i₀ denotes the therm alexpectation value calculated using pseudo-particles in the presence of the chem ical potential 0. Clearly, in the limit 0 ! 1 the term $h\hat{Q}i_0$ represents the partition function of the physical sector of the H ilbert space times $\exp(0_0)$. As detailed in Ref. 26, both numerator and denom inator of Eq. (59) have to be expanded in the non-linear couplings to the required order when calculating observables; how – ever, the denom inator does typically not develop logarithm ic singularities at the marginal dimension.

Furtherm ore, we need to introduce chem ical-potential counter-term swhich cancels the shift of the critical point occurring in perturbation theory upon taking the lim it of in nite UV cuto . Technically, this shift arises from the real parts of the self-energies of the b_s and f particles. We introduce the counter-term s as additional chem ical potential for the auxiliary particles,

We now proceed with an RG analysis of (61) which will allow to determ ine the critical properties for r $^<$ 1 { a brief account on this appeared in Ref. 12. The RG will treat the auxiliary elds f and $b_{\rm s}$ as usual particles and consequently determ ine their propagator renorm alizations, anom alous dimensions etc., but all diagram s are evaluated with $_0$! 1 which ensures the non-trivial character of the expansion. Renorm alized elds and dimensionless couplings are introduced according to

No renorm alizations are needed for the bulk ferm ions as their self-interaction is assumed to be irrelevant in the RG sense.

In contrast to the eld theories analyzed in Secs. IIIA and IV C (where the non-linear coupling is used to tune the system through the phase transition), the theory (61) contains two param eters, namely the tuning parameter $"_0$ and the non-linear coupling V₀. The RG is conveniently performed at criticality, i.e., we assume that $"_0$ is tuned to the critical line, and RG is done for the coupling v { this naturally results in an infrared stable xed point. To two-loop order we obtain the following RG beta function:

with the calculation given in Appendix C. Generally, the higher-order corrections to the one-loop result appear to be small in the present expansion. One can also consider the ow away from criticality, i.e., the ow of the tuning parameter ", either using S^2 insertions in the eld-theoretic formulation or explicitly within momentum – shell RG. The resulting correlation length exponent is in Eq. (72) below.

The structure of the above RG is very similar to the one of the $(4 \,)$ expansion of the 4 m odel for m agnets, where the mass term drives the transition, and the non-linear coupling has a non-trivial stable xed point at

criticality below four dimensions. Thus, the xed point with nite v (68) corresponds to the W ilson-Fisher xed point, whereas v = 0 is the analogue of the Gaussian xed point in the magnetic context, see Fig.2. The parameters v and " play the role of the interaction and the mass, respectively.

For r < 1 the trivial xed point v = 0 is unstable, and the critical properties are instead controlled by an interacting xed point at

At this asymmetric critical xed point (ACR), we nd anomalous eld dimensions $_{\rm b}$ = 2v² + 2v⁴, $_{\rm f}$ = v 2 + 2v 4 . The resulting RG ow diagram is shown in Fig. 2a. The ACR xed point (Fig. 2b) shifts to larger values of v², \mathbf{j} \mathbf{j} with decreasing r, and the expansion can be expected to break down for smallr. The num erical results of R ef. 6 show that this is the case at 0:375, where ACR merges with SCR, and p-h sym r metry is dynamically restored. Then, Eq. (61) together with an expansion in v, r yields the correct description of the critical properties for 0:375 r < r < 1. U singNRG we have numerically con med this expectation, ie, the properties of the critical xed point of the model (61) vary continuously as function of r for r < r < 1.

For all r 1, a phase transition still occurs in the asymmetric Anderson and K ondo models, but it is controlled by the non-interacting VF1 xed point at v = " = 0. For the marginal case r = 1, i.e., at the upper-critical dimension, we expect logarithm ic ow. In the following we explicitly keep the UV cuto , and discuss RG under cuto reduction ! . We restrict ourselves to criticality, where the RG beta function to one-loop order is

O bærvables can then be obtained by straightforward perturbation theory. Consider, e.g., the boson ælf-energy (Fig. 14c beløw):

F. Observables near criticality

W e start with the correlation length exponent, , of the asym metric critical xed point. In the eld-theoretic RG scheme it has to be determ ined via composite operator insertions into the action (61), which take the role of mass terms driving the system away from criticality. The lowest-order result for is

In the calculation of observables like susceptibilities etc. the UV behavior depends on whether we are above or below the upper-critical dimension r = 1. For r = 1the cuto has to be kept explicitly, as integrals will be UV divergent. This also im plies that hyperscaling is violated, and no !=T scaling in dynam ics occurs, as usual for a theory above the upper-critical dimension.

For r < 1 the UV cuto can be sent to in nity after taking into account the contributions of the counterterms (60), as the remaining integrals are UV convergent. This is in contrast to the expansions for r > 0 (Sec. III) and for r < 1=2 (Sec. IV), which are e ectively both above a lower-critical dimension, and where intermediate quantities can display UV divergencies. Notably, for all r < 1 expansions the low-energy observables are fully universal, i.e., cuto -independent, and hyperscaling is fullled.




FIG. 8: Feynman diagrams for the in nite-U Anderson model. Full/wiggly/dashed lines denote f /b_s/c propagators, the cross is the counter-term (60). a) Bare interaction vertex V_0 . b) V_0^2 contribution to the partition function, which also appears in the denom inator of Eq. (59). c),d) D iagrams entering the local susceptibility, $_{im \ p,im \ p}$, to order V_0^2 . e) V_0^2 contribution to $_{u;im \ p}$. f) V_0^2 contributions to $_{u;u}$.

The anom alous exponent associated with the local susceptibility is calculated as above by determ ining the $_{\rm loc}$ renorm alization factor, Z , using m inim al subtraction of poles, and then employing

! 0 { this leads to the absence of multiplicative logarithm s.

Above the upper-critical dimension, r > 1, we have simply = 0 and thus $_{loc} / 1=T$ or / 1=!. We shall explicitly demonstrate the calculation of the local impurity susceptibility using bare perturbation theory. To lowest non-trivial order, $_{loc}$ is given by the convolution of two f propagators (71), calculated with the self-energy to second order in V₀. Note that no vertex corrections occur to this order due to the structure of the interaction. When calculating $_{loc}$ the T ! 0 limit has to be taken with care, as the exponentially sm all tail in Im G_f(!) at ! < 0 contributes to $_{loc}$. One obtains for the imaginary part $^{00}_{loc}$ for T ! 0 and 1 < r < 2:

M oving away from criticality, one of the f , bs propagators looses its $(! _{0})$ contribution { for " > 0 (t > 0) this is G _{f} , indicating that free m on ent behavior is absent in this regime. Consequently, the zero-tem perature static local susceptibility is nite, but diverges upon approaching the critical point according to __{loc} / t^{r 2}. For t < 0, __{loc} / 1=T. Thus, the order parameterm __{loc} jumps at the transition point for r > 1.

2. Im purity susceptibility

The evaluation of the impurity susceptibility requires the summation of the diagrams in Fig. 8c{f, appearing in the numerator of the corresponding Eq. (59), and also a careful treatment of the denominator, as we are interested in terms being non-singular as function of r.

The diagram s are conveniently evaluated in in aginary time, e.g., the rst correction to $\lim_{i \to p; i \to p} \inf Fig. 8c$ gives

where all term shave to be multiplied by e $^{\circ}$ =2. Fig.8d are the contributions from the counter-term s (60), which evaluate to $_{\rm b}$ = 2 $_{\rm f}$ = $2V_0^2$. The denom inator, hQ^i_{\circ}, being 3e $^{\circ}$ to zeroth order in V_0 , receives corrections from the diagram in Fig.8b and from the counter-term s (60), resulting in

Note that interm ediate terms of the form T² have cancelled in numerator and denominator of Eq. (59). For r < 1 the momentum integrals are UV convergent, and do not develop poles in r, i.e., the poles present in the $\lim_{m \text{ p; im p}}$ diagrams have been cancelled by contributions from Fig. 8e/f. In the low-energy limit, the product

 $V_0^2 T^r$ approaches a universal value. Thus $_{im\,p}$ has indeed C urie form, with a fully universal prefactor depending on r only. For r > 1 the integrals require an explicit UV cuto, but no correction to the C urie term arises, as $(V_0^2 T^r)$ vanishes as T ! 0.

Perform ing the integral for r < 1 and expressing the result in term s of the renorm alized coupling v, the im purity susceptibility reads

3. Im purity entropy

The impurity contribution to the entropy can be derived from the free energy as above. At the VF1 xed point the entropy is $S_{im\,p} = \ln 3$, and the lowest-order correction is computed by expanding the free energy in v. Note that this correction vanishes for r 1, as v = 0 there.

The calculation of the in purity entropy in the presence of a constraint for pseudoparticles has been discussed in Appendix C of Ref. 26. The lim it $_0$! 1 suppresses all contributions from the unphysical part of the H ilbert space, in particular disconnected diagrams in the partition function. Rem arkably, this leads to the appearance of disconnected diagram s in higher-order terms of the expansion for the therm odynam ic potential . The second-order diagram for , shown in Fig. 8b, evaluates to

There is also a contribution to $\lim_{m p}$ from the counterterm s, but this is temperature-independent and does not contribute to the entropy. Taking the temperature derivative we nd:

A sexpected, the entropy correction is fully universal and nite in the lim it T ! 0. Inserting the xed point value of the coupling v into Eq. (88), we nd the impurity entropy as

NRG calculations⁶ have determ ined S_{imp} for r values below unity; a comparison is shown in Fig. 7. As with most of the observables obtained within the (1 r) expansion the agreem ent of the low est-order result with num erics is surprisingly good even for r values wellaway from unity, indicating that higher-loop corrections are sm all.




FIG.9: NRG results for a slightly p-h asym m etric Anderson m odelat r = 0.45 close to criticality (ACR). Param eter values are a hybridization strength V_0^2 (0) = 1, "_0 = 0:5, and $U_0 = 0.9949, 0.99493$ (dashed), 0.9949213, 0.9949215 (solid). The thin lines are for a p-h symmetric model very close to criticality (SCR), with $"_0 = 0.487$, $U_0 = 0.974$. The NRG runs were done using a discretization parameter of = 9, keeping $N_s = 650$ levels. The two-stage ow described in the text can be clearly seen, i.e., there is a small energy scale where the system ows from ACR to ASC or LM (solid: Т 10^{28} , dashed: T 10^{22}), and a larger scale T_{ACR} Т 10 $^{\rm 12}$ where the system $\,$ ows from SCR to ACR.a) Impurity susceptibility T imp.b) Impurity entropy Simp. The behavior of the entropy illustrates the point m ade in Sec.V F 3: S_{imp} (T) decreases as function of T , i.e., increases along the RG ow , for T < T < T_{ACR} due to S_{imp;ACR} > S_{imp;SCR}. This \uphill ow " does not violate therm odynam ic stability criteria, as the totalentropy (in purity plus bath) of the system still decreases under RG.

The results for the RG ow and the impurity entropy have an interesting corollary: Stability analysis shows that for $r < r < \frac{1}{2}$ the RG ow at criticality and small p-h asymmetry is from SCR to ACR. The entropy of SCR approaches $\ln 2$ as $r ! \frac{1}{2}$. Both NRG and the above expansion indicate that the entropy of ACR is larger than $\ln 2$ for $r < \frac{1}{2}$, Fig. 7. Thus we have $S_{im p,ACR} > S_{im p,SCR}$ for $r < r < \frac{1}{2}$, i.e., the in purity part of the entropy increases under RG ow (see also Fig. 9 below), in contradiction to the so-called g-theorem²¹! (This is not a fundam ental problem, as the present m odel has e ectively long-ranged interactions, and is not conform ally invariant, such that the proof of the g-theorem does not apply.)

4. Conduction electron T matrix

The T matrix in the Anderson model is given by T (!) = $V_0^2 G_f$ (!). The physical f propagator G_f is a convolution of the auxiliary f and b_s propagators, i.e., the propagator of the composite operator ($f^y b_s$). The anom abus exponent is obtained from

As in Ref. 28 we are able to determ ine an exact result for the anom alous exponent, valid to all orders in perturbation theory. The argum ent is based on the diagram m atic structure of the T m atrix, namely the relevant diagrams can be completely constructed from full v interaction vertices and full f=b propagators²⁸. This leads to the relation between Z factors

W hereas Eq. (92) applies to the p-h asymmetric xed point (ACR), and is valid for r < r < 1, the results of

Sec. IV H and Ref. 28 have established the same critical behavior for the T matrix for the symmetric xed point (SCR) for $0 < r < \frac{1}{2}$. Thus, we conclude that all critical xed points for 0 < r < 1 in the pseudogap A nderson and K ondo models display a T matrix behavior of Im T (!) / j! j^r.

The logarithm ic correction to the T matrix at r = 1 are evaluated in a manner similar to the one for the local susceptibility above. W ith $(v) = \frac{3}{2}v^3$ and $_T(v) = 3v^2$ { note that $_T = _f + _b$ only holds at one-loop level because $Z_v = 1$ at this order { we can integrate (90) to nd

Above the upper-critical dimension, r > 1, we have again $_T = 0$ and Im T (!) / (!).

VI. GENERAL PARTICLE-HOLE ASYMMETRY

Here we comment on the general case of nite p-h asymmetry. Starting with the trivial xed points, tree-level power counting shows that LM is stable w.r.t. p-h asymmetry, with a scaling dimension of r. In contrast, SSC is unstable towards ASC, and p-h asymmetry grows near SSC with a scaling dimension of r. Finally, at the free-impurity xed point (FImp) p-h asymmetry grows under RG with a scaling dimension of unity and the systems ow towards VF1. VF1 itself is stable w.r.t. a deviation from maximal p-h asymmetry.

In the r ranges where the RG expansions of this paper are perturbatively controlled, we can immediately come to conclusions about the stability of the critical xed points: SCR will be stable w.r.t. nite p-h asymmetry for r close to 0, but unstable for r close to $\frac{1}{2}$. Sim ilarly, for r close to or larger than unity, ACR is stable w.r.t. a deviation from maxim alp-h asymmetry, in other words it is safe to discard one of the two impurity states, jdi or jei, for the discussion of the critical properties, and to work with the perturbative expansion of Sec. V. O ne has to

keep in m ind that ACR m oves towards sm aller e ective p-h asymmetry (larger values of J) upon decreasing r, and the perturbative expansion around VFlbreaks down as r! r⁺ where p-h symmetry is dynamically restored.

The numerics of Ref. 6 gives no indications for additional xed points in the case of nite p-h asymmetry which would not be present in the maxim ally asymmetric model; our RG results are consistent with this. Thus, the critical properties of a pseudogap K ondo or Anderson model with general p-h asymmetry are always identical to the ones of the maxim ally asymmetric model of Sec.V.

For the RG treatment of a model with general ph asymmetry close to criticality one has to envision a two-step RG procedure, as usual in problems with different energy scales. Suppose we start near criticality from small hybridization and small p-h asymmetry. For r > r, the scaling dimension of p-h symmetry breaking term is largest: at tree level we have dim $[2"_0 + U_0] = 1$ and dim $[V_0] = (1)$ r)=2. Thus the initialm odelparam eters ow towards large p-h asymmetry rst. This ow drives the system into the regime described by the maxim ally p-h asym m etric Anderson m odelof Sec.V, thereby renorm alizing the parameters " and v. Then, the RG of Sec.V takes over, with a ow towards ACR, and nally to one of the two stable phases (if the system is not exactly at criticality). Thus, a low energy scale T and a higher scale T_{ACR} exist, where T_{ACR} characterizes the approach of the e ective p-h asymmetry towards the ACR xed point. Note that for r > 2 the fastest ow is the one of v to zero, i.e., the system quickly approaches the VF1 xed point. The described behavior is nicely borne out by NRG calculations for the Anderson model, see Fig. 9.

Finally, for r < r the initial ow is dominated by the decrease of p-h asymmetry { this cannot be captured by our Anderson model RG, but is contained in the K ondo treatment { and the system approaches SCR, before it nally departs to one of the two stable phases. If the system is on the strong-coupling side of the transition (t > 0), then the behavior near SCR is multicritical (see also Fig. 16a of Ref. 6): two low -energy scales exist which describe the departure of the ow from SCR, namely T (for the deviation of j from j) and a lower scale T_{ASC} (for the subsequent grow th of p-h asymmetry when ow - ing tow ards the ASC xed point).

W e note that a recent investigation of the pseudogap A nderson m odel³³ using the local-m om ent approach⁸ has found indications of a line of critical xed points in the p-h asym m etric case, param etrized by p-h asym m etry. W e believe that this is an artifact of the employed approximation scheme, as (i) NRG calculations strongly hint towards a single asym m etric critical xed point (for xed r), i.e., the xed-point level spectrum at criticality does not depend on the initial p-h asym m etry (e.g. the ratio $U_0="_0$), and (ii) our analytical RG shows that, at least near r = 1, the scaling dimension of p-h asym m etry is largest, and the sketched two-step RG (which directly leads to consider an in nite-U Anderson m odel to describe the critical behavior) is a controlled approach for arbitrary initial p-h asym m etry.

VII. RELATION BETW EEN ANDERSON AND KONDO MODELS

This section shall highlight the relation between the pseudogap Anderson and K ondo im purity m odels.

On the one hand, it is well-known that the Anderson m odel reduces to the K ondo m odel in the so-called K ondo lim it, see Sec. IA. This mapping covers the far left-hand side of the ow diagram s in Figs. 1 and 2, and suggests that the phase transition at sm all r in the Anderson m odel in this K ondo lim it is described by the K ondo RG of Sec. III.

On the other hand, we have argued that the ow of the K ondo m odel can be naturally understood in terms of the variables of the Anderson m odel. In particular, the RG expansions of Secs. IV and V, describing transitions of the Anderson m odel near $r = \frac{1}{2}$ and r = 1, also apply to the K ondo m odel. C learly, in thinking about this \m apping" of the K ondo to the Anderson m odel one has to view the Anderson m odel as an elective bw-energy theory of the K ondo m odel. The impurity states of this elective Anderson m odel are thus m any-body states obtained after integrating out high-energy degrees of freedom from the K ondo m odel, i.e., dressed impurity states.

A form al way to obtain an Anderson model from a K ondo model is a strong-coupling expansion: The j "i and j#i states of the Anderson model are bare in purity states, whereas jei and jdi represent the in purity with either a hole or an electron of opposite spin tightly bound to the im purity.

The above can also be made plausible in a slightly different way, in the following for a p-h asymmetric situation: Let us consider the K ondo problem with a hard-gap DOS³⁴: in the presence of p-h asym metry it shows a rstorder quantum transition, i.e., a level crossing, between a K ondo-screened singlet and a spin $\frac{1}{2}$ doublet state. A swe can understand the asym m etric pseudogap DOS as consisting of an asymmetric high-energy part and a (asymptotically) symmetric low-energy part, we can obtain an e ective theory for the pseudogap K ondo m odel by coupling the above m entioned three (m any-body) im purity states, obtained by integrating out high-energy degrees of freedom from the band, to the remaining low -energy part of the conduction electron spectrum . A crucial ingredient is now the p-h asym m etry of the original m odel. It is clear that upon integrating out the high-energy part of the bath two many-body singlet states arise, namely jei and jdi as discussed above. Due to the p-h asym m etry of the underlying m odel these two singlet states will have very di erent energies, such that we can discard the high-energy state in the low-energy theory. W ith this we directly arrive at an in nite-U pseudogap Anderson m odel.

W e conclude that the phase transitions of the pseudogap Anderson and K ondo models are in the same universality classes { this is supported by the numerical calculations of R ef. 6. For sm all r the phase transition is naturally described in the K ondo language of Sec. III, im plying that the critical xed point of the Anderson m odel is located in the K ondo lim it. In contrast, for larger r the form ulation in term s of the Anderson m odel provides the relevant degrees of freedom , in other words, both spinful and spinless (m any-body) in purity states play a role in the critical dynam ics.

VIII. FINITE MAGNETIC FIELD

Interesting physics obtains in the pseudogap K ondo and Anderson m odels in the presence of a nite m agnetic eld. We concentrate here on the e ect of a local eld, applied to the impurity only. Note that a nite eld




FIG.10: Schematic T = 0 phase diagram of the pseudogap K ondo m odel in a local magnetic eld B. At B = 0, there is a phase transition at $J_K = J_c$ between LM and a strong-coupling phase, SSC or ASC. Upon application of a eld, an unscreened spin becomes strongly polarized (POL), whereas a screened spin in a strong-coupling phase is only weakly polarized. Increasing the eld at $J_K > J_c$ drives a phase transition { such a transition is not present in the metallic case, r = 0. The phase diagram for a pseudogap Anderson model is similar. As discussed in the text, the zero-eld critical xed point is always unstable w.r.t. nite B in the RG sense; thus the two transitions are in general in di erent universality classes (which is already clear from symmetry considerations).

applied to the bulk can modify the low -energy behavior of the bath DOS due to Zeem an splitting; then, pseudogap K ondo physics survives only for energy scales above the Zeem an energy.

For T=0 and a metallic density of states, r=0,a local eld B only leads to a crossoveras function of $B=T_{\rm K}$, and allobservables evolve sm oothly from B=0 (screened spin) to large B (polarized spin). In contrast, for any r>0 and t>0 (i.e. $J_{\rm K}>J_{\rm c}$ in the K ondo model) there will be a zero-tem perature phase transition as function of the local eld between one phase with weak and one with strong in purity spin polarization, see Fig.10. We brie y discuss this phase transition in the following { it turns out that the variables of the Anderson model provide a natural language to analyze the problem . Remarkably, all ingredients needed for the discussion of the critical properties have already been calculated in the previous sections.

Strategically, we rst discuss the decoupled in purity, and then analyze the modi cations arising from the presence of the hybridization term. For the decoupled in purity, the local eld is trivially a relevant perturbation, with scaling dimension unity. Thus, in the low-energy limit the eld is e ectively in nite, and one of the two im purity states j"i, j#i can be discarded (we will discard j#i in what follow s).

A. A sym m etric Anderson m odel

In the p-h asymmetric case two impurity states have to be considered, namely j"i and jei. We discuss a level crossing transition of these two, tunable e.g. by varying the magnetic eld, and being coupled to conduction electrons. At the transition we are left with a (spinless) resonant level model, and the analysis for a pseudogap host density of states is in Sec. IV B. In particular, for r > 1 the phase transition is a level crossing with perturbative corrections, and for all 0 < r < 1 we have a continuous transition with a critical xed point identical to the interm ediate-coupling xed point of the resonant level model, Eq. (31). Thus, the properties of the transition evolve sm oothly as function of r for 0 < r < 1, in contrast to the zero- eld situation (!).

B. Sym m etric Anderson m odel

In the presence of p-h symmetry and magnetic eld, the decoupled in purity has three low energy states: j"i, jei, jdi. The resulting level-crossing transition is technically identical to the one of the zero- eld in nite-U Anderson model of Sec. V: the two situations can be mapped onto each other via the p-h transform ation (3). From Sec. V we can read o the properties of the eldtuned phase transition: For r > 1 we have again a level crossing with perturbative corrections. A RG expansion around the level-crossing xed point can be used to calculate the critical properties below r = 1. This expansion describes the physics for all r > r.

It is interesting to ask what happens for r < r. At r the broken level sym m etry is dynam ically restored at the critical xed point, meaning that for r < r the transition is controlled by a zero-eld critical xed point. From Secs. III and IV we know that for $r < \frac{1}{2}$ such an Anderson model transition with four degenerate in purity states is the sam e as described by the weak-coupling RG in the K ondo language. However, the mapping (3) shows that we have to consider a K ondo model of a charge pseudospin here, i.e., the corresponding Schrie er-W ol transform ation will project out the j "i and j #i states. In other words, in a p-h sym m etric situation w ith 0 < r < r, where the zero- eld transition is controlled by the SCR xed point, the nite- eld transition will be asym ptotically controlled by the SCR' xed point!

C. Kondo model

The above statement is consistent with a simple generalization of the weak-coupling RG of Sec. III to the case of nite eld. One easily nds that the eld is a relevant perturbation at the SCR xed point with a scaling dimension of unity, and the nite-eld transition is not accessible in a description using the K ondo m odel spin variables. (In contrast, the m agnetic eld is intelevant at SCR'.) In the Anderson m odel language, the local eld lifts the degeneracy of the m agnetic doublet j"i, j#i. It breaks the SU (2) sym m etry in the spin sector, and the e ect is clearly independent of the eld direction.

As discussed in Sec. IA, the p-h symmetric Anderson model display SU (2) symmetry also in the charge sector (charge pseudospin). This can be broken by choosing $U_0 \notin 2"_0$, corresponding to a pseudospin eld in z direction. C learly, a pseudospin eld in perpendicular direction will have the same e ect { this eld corresponds to a local pairing eld coupling to f"f#. Thus, the SU (2) pseudospin symmetry shows that the e ect of s-wave pairing correlations on the K ondo problem is similar to a particle-hole asymmetry, as argued in Ref. 35 using a completely di erent approach.

IX. CONCLUSIONS

In this paper, we have analyzed the zero-tem perature phase transitions in the pseudogap K ondo problem, characterized by a bath density of states (!) / j! j. U sing various perturbative RG expansions, formulated in the degrees of freedom of either the Kondo or the Anderson in purity model, we have developed critical theories for the phase transitions in both the p-h symmetric and asymmetric cases. We have established that r = 0 and $r = \frac{1}{2}$ play the role of two low er-critical dimensions in the p-h symmetric case, i.e., the non-trivial phase transition disappears both as r! 0^+ and r! $\frac{1}{2}$ with diverging correlation length exponent. In contrast, r = 1 is an upper-critical dim ension for the p-h asymmetric model. The transitions for 0 < r < 1 are described by interacting eld theories with universal local-moment uctuations and strong hyperscaling properties including !=T scaling of dynam ical quantities. In contrast, for r > 1 we nd a level crossing with perturbative corrections, and hyperscaling is violated.

In the p-h symmetric case, we found two dimensions, one around r = 0 and one around $r = \frac{1}{2}$, to describe the same critical xed point. In the presence of p-h asymmetry, a dimensional xed point emerges, which can be analyzed in an expansion around r = 1.

A part from the small-r expansion of Sec. III, all our theories were form ulated using the Anderson model language. This shows that the quantum phase transition between a screened and an unscreened moment in K ondotype models can be nicely interpreted by saying that the system uctuates between \possessing a moment" and \possessing no moment" { this is precisely what is described by the elective Anderson model at its valenceuctuation xed point.

W e have calculated a number of observables, with results being in excellent agreement with numerical data. In particular, we have found an exact exponent for the conduction electron T matrix, valid for all expansions used in this paper. We have also discussed the physics of the pseudogap K ondo problem in a local magnetic eld, where we have shown that { in contrast to the metallic K ondo e ect { a sharp transition occurs as a function of the eld.

A pplications of our results include in purity m om ents in unconventional superconductors^{9,10,23,25} and other pseudogap systems, like e.g. graphite. On the theoretical side, we expect that the analysis of quantum in – purity m odels using A nderson instead of K ondo m odel variables m ay be useful in a variety of problems. Thus, eld theories similar to ours can possibly be constructed for other in purity quantum transitions, and will also be useful for the study of lattice m odels in dynam icalm eaneld theory³⁶ and its extensions³⁷, where local quantum criticality can be captured using e ective single-im purity m odels.

APPENDIX A:THE NON-INTERACTING RESONANT LEVELMODEL

Here we provide a few details about the non-interacting resonant level model with a pseudogap density of states. The model is exactly solvable, and all properties can be directly evaluated using the dressed f electron propagator (26). The local susceptibility has been quoted in Sec. IV B. The T matrix is given by T (!) = $V_0^2 G_f$ (!); a brief discussion of spectral properties can also be found in the Appendix of R ef. 6.




FIG.11: Feynm an diagram s for the spin susceptibility of the non-interacting resonant levelm odel of Sec. IV B.D ashed/full lines denote c /dressed f propagators, respectively; the full dots are V_0 vertices, and the open circles are sources. a) $\lim_{m p \neq im p}$. b) $u_{jim p}$. c) u_{ju} . Note that the displayed diagram s give the exact results for the susceptibilities, as all self-energies are contained in the dressed f propagator.

We now sketch the calculation of $I_{im p}$ and $S_{im p}$. The diagram s contributing to $T_{im p}$ are in Fig. 11; note that these contain full f propagators, and no higher-order diagram s appear. Power counting show s that term s of 1=T form do only arise from $u_{;u}$; both $I_{im p}$; im p and $u_{;im p}$ are less singular. The evaluation of the diagram s in Fig. 11c gives

All factors of V_0 cancel exactly against the A_0 , and we obtain a quantity with a universal prefactor. The k integrals can be performed in the lim it of in nite UV cuto, followed by the M atsubara sum mations. The result is of C unie form, with

N ote that we have used the dressed f propagators (26) in their low energy form { due to their singular nature their high-energy properties are unim portant for the leading low tem perature behavior of the susceptibility.

The impurity entropy $S_{\rm im\,p}$ is directly calculated from the full f propagator (26). Performing the tr ln in the partition function gives

O ne can easily see that the T = 0 entropy contributions of $\ln (i!_n)$ and $\ln ji!_n$ jare identical, thus we have

T his is nothing but 2r times the entropy of a free spinless ferm ion, resulting in $S_{imp} = 2r \ln 2$.




FIG.12: D iagram s occurring in the perturbative RG for the non-interacting resonant level m odel of Sec. IV B. Here, full lines are bare f propagators. a) Bare interaction vertex V_0 . b) f self-energy.c) D iagram for the v^2 entropy correction.d) D iagram sentering the local susceptibility to order v^2 . W ithin the renorm alized perturbation theory scheme all corrections beyond second order in v vanish.

Interestingly, the above exact universal results can also be obtained in the fram ework of a RG expansion in the hybridization, i.e., in a form al expansion around r = 1. Here one exploits the intermediate-coupling nature of the xed point, by calculating observables using renormalized perturbation theory and employing the xedpoint value (31) of the coupling v. The necessary diagram s, Fig. 12, now contain bare (instead of dressed) f propagators. Technically, higher-order terms appear in this expansion, but upon interpreting the lowest-order result of renormalized perturbation theory (e.g. reexponentiating logarithms) these terms are completely summed up. Thus, within the RG fram ework the information about the non-trivial f scaling dimension is

contained in the coupling value v instead of in the propagator G_f. We brie y demonstrate the idea by evaluating the impurity entropy. As we expand around v = 0 (the F Imp xed point) we obtain a perturbative correction to the inpurity therm odynam ic potential which is of order V_0^2 (Fig. 12b). Taking the tem perature derivative leads to

APPENDIX B:RG FOR THE INTERACTING RESONANT-LEVEL MODEL

In this appendix we present details of the renorm alization group treatment for the symmetric Anderson model in the vicinity of $r = \frac{1}{2}$. It is based on an expansion around the SSC xed point, i.e., around a non-interacting resonant-levelm odel, with the interaction strength being the expansion parameter. Thus the expansion is done around an intermediate-coupling xed point (!).

The starting point is the action (36) derived in Sec. IV C, for 0 < r < 1. Importantly, the \bare" (i.e. $U_0 = 0$) f propagator in (36) behaves as $1 = (A_0!^r)$ at low energies, Eq. (26), as the conduction electrons have already been integrated out. The prefactor A_0 will be kept explicitly in the renorm alization steps. We employ the eld-theoretic RG scheme in order to determ ine the ow of the coupling renorm alized coupling u, introduced in Eq. (39), with dimensional regularization and m inim al subtraction of poles. As will be seen below, the lowest non-trivial renorm alizations arise at two-bop order.




FIG.13: D iagram s for the RG of the sym m etric Anderson in purity m odel, with notation as in Fig.4.a) U_0^2 self-energy contribution, which vanishes. b) One-loop vertex renorm alizations, which vanish due to p-h sym metry. c) Two-loop vertex renorm alizations { these are the only contributions to the beta function (41).

The needed diagram s arising in the RG treatment are displayed in Fig. 13. A number of observations can be made: (i) Hartree diagram s vanish due to the overallp-h symmetry of the model. (ii) Explicit calculation shows that the one-loop vertex renormalization diagram s, i.e., the u^2 corrections to u in Fig. 13b, do not develop poles. This also follows from the fact that the beta function cannot contain even powers in u due to p-h symmetry. (iii) Explicit evaluation shows that the f self-energy up to two-loop order, Fig. 13a, does not contribute singular propagator renormalizations. In other words, the eld renormalization factor is

to two-bop order. As we will argue below, this result is exact to all orders in perturbation theory. It implies that the f eld does not acquire an anom alous dimension, $_{\rm f} = 0$.

The two-loop diagrams for the renormalization of u can be divided into two groups of three each, displayed in the two lines of Figs. 13c. The diagram s in each group can be easily seen to be equal. Explicitly:

We now provide the proof for Z = 1, i.e., no singular propagator renorm alizations occur in the present problem . W hat is needed is p-h symmetry and the form of the bare propagator, G $_{\rm f}$ / ! $^{1=2}$ or G $_{\rm f}$ () / ¹⁼² in the low-energy lim it for $r = \frac{1}{2}$. We argue that no logarithm s arise when evaluating the self-energy at $r = \frac{1}{2}$. By power counting, all f self-energy diagram s in the dom ain give a result proportional to 3^{-2} . Let us discuss internal integrals arising in the evaluation (which could produce logs). In the rst step, those involve four G_{f} propagators due to the quartic interaction { here it is in portant that tadpoles do not contribute due to p-h sym m etry. Therefore, the integrand will behave as 2 , and logs cannot occur. In further steps, four propagators do not necessarily occur, but the power counting argum ent shows that each internal time still has to occur with a power of 2^2 . This shows that the integrands will always be more singular than 1= , and no logarithm sarise. C learly, such an argum ent cannot be constructed for the vertex diagram s, as they behave as $1 = at r = \frac{1}{2}$, and Fourier transform ation generically yields an pole.

Let us turn to the local susceptibility renormalization factor Z . As described in Sec. IV H, one can either determine the composite operator renormalization factor Z_2 and use $Z = Z_2^2$, or evaluate Z directly with the help of the perturbative correction to loc in Fig. 4c. In both cases, the f bubble diagram is needed. To leading order in the evaluates to

APPENDIX C:RG FOR THE INFINITE-U ANDERSON MODEL

The in nite-U Anderson model can be analyzed in the vicinity of r = 1 using an expansion in the hybridization strength. Here we describe details of the eld-theoretic RG, with the results appearing in Sec.V. Starting point is the action (61), written in terms of auxiliary elds f and b_s . The RG proceeds by perturbatively calculating renorm alizations to the propagators and vertices appearing in (61), which yields expression for the renorm alization factors de ned in Eq. (66).




FIG. 14: Diagrams for the RG of the in nite-U Anderson model. Notations are as in Fig. 8. a),b) Self-energies for f and b_s to two-loop order. The crosses denotes the counter-term s which cancel the real parts of the self-energy insertions. c) Two-loop vertex renorm alization; there is no contribution to one-loop order. d) Diagram s with mass insertions (squares), needed to determ ine the correlation length exponent.

The relevant diagram s are displayed in Fig. 14. Note that there is no one-loop contribution to the vertex renormalization. At one-loop order we have the graphs for the f and b self-energies. Evaluation of the rst diagram for the f self-energy in Fig. 14a gives:

We work at criticality, i.e., $"_0 = 0$. First the frequency sum can be performed, here the $_0 ! 1$ limit is important: it suppresses contributions from positive k. The remaining k integral is UV convergent, and we nally obtain

The other diagram s in Fig. 14a,b,c are evaluated in a similar manner. In the two-loop self-energies, the real part of the inner self-energy insertions, which diverges linearly with the UV cuto, is exactly cancelled by the corresponding counter-term.

APPENDIX D:SPIN AN ISOTROPIES

Thus far our discussion has been restricted to impurity models with full SU (2) spin symmetry. In this appendix we show that spin anisotropies, e.g. in the K ondo interaction, are irrelevant at all critical points considered.

For the weak-coupling RG of Sec. IIIA, form ulated in the variables of the K ondo m odel, we introduce K ondo couplings J_2 and J_z for the transverse and longitudinal part of the K ondo interaction. The RG equation (18), to one-loop order, generalizes to

For the m etallic case, r = 0, there is a line of xed points at $j_2 = 0$, $j_z < 0$, representing an unscreened m om ent. In contrast, for r > 0 only SU (2) symmetric xed points survive, namely LM with $j_2 = j_z = 0$ and SCR with $j_2 = j_z = r$. Thus, the symmetric critical xed point of the Anderson and K ondo models is stable w.r.t. SU (2) symmetry breaking.

Turning to the p-h asym metric model, we start from the in nite-U Anderson model (57) and introduce a spin dependence in the hybrization, $V_{0*} \in V_{0\#}$. As is easily seen via Schrie er-W ol transformation, for a generic ph asym metric conduction band this is equivalent to an anisotropic exchange interaction plus a local magnetic eld. W ithout loss of generality we restrict the following analysis to a p-h sym metric conduction band, where the eld term is absent. The RG equation (67), to one-loop order, generalizes to

Apart from the SU (2) symmetric xed point, $v^2 = \frac{2}{3}r$, there are two other xed points with $v_{\pi}^2 = r$, $v_{\#} = 0$ and $v_{\#}^2 = r$, $v_{\pi} = 0$ { these are, however, infrared unstable w r.t. nite $v_{\#}$ (v_{π}). Thus, the only stable critical xed point is the SU (2) symmetric one, which corresponds to the ACR xed point analyzed in Sec.V.
