The collective excitations in the Bose-Hubbard model in a trap are studied by means of numerical diagonalization in one dimension. The strength function is calculated for monopole and dipole perturbations, and moments of the strength function are utilized in order to obtain information about the collective behavior under external forces. In the super uid regime, the spectrum is found to be exhausted by one single frequency, while in systems that contain a M ott insulating plateau several frequencies are excited. An explanation of recent experimental notings in terms of a M ott plateau is suggested.

Recent years have seen a rapid development in the study of atom s con ned in optical lattices. One of the virtues of such systems is that they provide an almost perfect realization of the bosonic Hubbard model. Corrections such as nearest-neighbor interactions are under control and can be made very small, and furtherm ore, the parameters of the model are widely tunable experin entally. In the case of spinless bosonic atoms the Bose-Hubbard model is known to support a Mott transition, and it has also been dem onstrated experim entally by Greiner et al. [1] The addition of spatial con nem ent adds com plexity to the well-known Bose-Hubbard model. In these inhom ogeneous systems super uid and M ott insulating phases m ay coexist in spatially separated regions [2]. How ever, a good experim ental diagnostics is still lacking for the detection of this interesting type of state.

This paper wishes to forward the idea of using oscillatory modes in order to discrim inate between di erent types of m any-body state for these system s. Exciting oscillatory m odes is an experim entally well-developed technique for studying the many-body physics of trapped condensates in the absence of optical lattices and has recently been applied also to the case with an optical lattice present [3, 4, 5]. Physical lim its and basic dependences of the many-body eigenstates and energies were studied in an earlier paper [6] (cf. [7]). Here we wish to relate the eigenvalue spectrum to the collective oscillations of the system and pose the physical question, what happens when the system is perturbed? Just as in Ref. [6], a ve-particle system shall be studied using exact diagonalization, but the m ethods and concepts introduced here can be applied in num erical calculations using m ethods such as M onte C arlo, density-m atrix renorm alization group or mean-eld calculations.

The system under consideration is a gas of bosonic atom s, con ned in a harm onic trap superposed with an optical lattice form ed by standing laser waves. By making the trap su ciently tight in two directions, the system is e ectively made one-dimensional, and when the optical-lattice potential is su ciently strong the system is well described by the Bose-Hubbard Ham iltonian

The units are here chosen so that the tunneling strength is unity. U is the on-site interaction strength, !t is the trap frequency, and r is a dimensionless site index; the operators $a_r a_r^y$ destroy and create a particle at the site r, respectively, and obey Bose commutation relations. The sum subscripted < rr^0 > runs over all pairs of nearestneighbor sites as usual.

W e wish to know how the system responds to a perturbation of the type

where v(r) is a perturbing potential applied to the bosons. The strength function associated with the operator F is [8]

where k labels the many-body eigenstates of the system and E_k are the eigenenergies of the many-body system (in units where h = 1, and de ning the ground-state energy as the zero level).

In the present exact diagonalization study, the strength function can be obtained exactly. However, considering the outlook of using num ericalm ethods where larger system s can be treated, but the whole eigenvalue spectrum cannot easily be obtained, approxim ate m ethods m ust be considered. R efference [9] describes a m om ent m ethod (cf. [10, 11]) that is well suited for describing the excitation spectrum for con ned bosons in optical lattices. The m om ents of the strength function,

can, namely, be written as ground-state expectation values of commutators involving the Hamiltonian and the operator F. For the three moments that shall be used here, m₀, m₁ and m₂, one obtains

Them om ent m p has the dim ension of frequency raised to the pth power, times the dimension of F^2 , and therefore the quotients between di erent m om ents de ne frequencies: from the ones listed above we de ne $!_{10} = m_1 = m_0$, $!_{20} = (m_2 = m_0)^{1=2}$, and $!_{21} = m_2 = m_1$. In the case where only one eigenstate is excited by F , these m om ent-related frequencies coincide and are equal to the frequency of that state, but more generally, they take on values between the frequencies of those modes that are appreciably excited by F, and the spread between them is related to the spread of the strength function. O bserve that very little information about the individual excitation frequencies can be obtained from the moment calculation, except for the the fact that as p ! 1, the frequencies $!_{p,p-1}$ approach the lowest-lying eigenstate with a symm etry consistent with the perturbation F [9]. The three frequencies are, how ever, average excitation frequencies, in a sense that is made precise by considering their de nition:

and correspondingly for the other two frequencies. Furtherm ore, by writing m_0 as



it is clear that the zeroth m om ent is related to the probability for any excitation at all to happen, and it therefore gives inform ation about the amplitude of the oscillations excited by the perturbation.

Let us now explore in the setting of an exactly diagonalizable system the relation between the strength function and the m om ent-related frequencies $!_{pq}$. The details of the diagonalization scheme were explained in Ref. [6]. The system consists of N = 5 particles in one dimension subject to the Hamiltonian, Eq. (1). The perturbing potential is assumed to be on the form of Eq. (2) with the two choices of potential function

The exact strength function can be found by calculating the strength S_{k0} jkf jlif for each excited state k. The strength function for the nite system is a sum of delta functions, and can of course not be plotted, but it is visualized in Fig.1 by plotting a stem of height S_{k0} at the position E_k of each excited state. For Fig. 1 the parameters are chosen as $!_t = 0.3, U = 0.1$, describing a weakly interacting system in a shallow trap, and the perturbing potential v is chosen as the m onopole perturbation. It is seen that only two alm ost-degenerate modes are excited with appreciable strength. These are the two lowest-lying monopole modes, pli and Bi, at E₂ 0:5524 and E₃ 0:5776; the excitation of the latter is weaker by approxim ately a factor 10. The strength for the thirdstrongest excited state is weaker again by another factor

20. The strengths for the eigenstates that have dipole symmetry are suppressed by about ten orders of magnitude, which corresponds to the num erical accuracy of the algorithm. This system is an almost pure Bose-Einstein condensate, its density resembling a discretized Gaussian, as seen in the inset of Fig. 1. Each of the system 's collective modes is almost entirely exhausted by one many-body eigenstate or, as in the monopole case, an alm ost-degenerate pair of them .

Included in Fig. 1, as crosses, are the three m om entrelated frequencies $!_{pq}$, which can be calculated using only ground-state properties. It is seen that all three frequencies lie close together { the sym bols coincide alm ost completely so that only one is visible in the plot { and lie close to the main excitation frequency E_2 , as expected. The magnitude of the zeroth m om ent is $m_0 = 30.6515$; this number makes more sense when compared to values of m₀ for other parameter choices. It can be roughly interpreted to m ean that application of the potential v(r), which m eans quadrupling the trap potential in this case, yields a population transfer rate of m ore than order unity to excited states and the oscillations should be clearly visible.




FIG. 2: Sam e as Fig. 1, but here the perturbation has dipole sym m etry.

Figure 2 displays the results for the dipole excitation using the same parameters $!_t = 0.3, U = 0.1$. The picture is similar, but even simpler than in the monopole case: only one mode is appreciably excited, which in physical terms means that a perturbation with dipole




FIG.3: Same as Fig.1, but here the trap strength is $!_t = 1$ and the coupling is intermediate, U = 20. In the inset, the asterisks represent the quantum uctuations in the density m agnied by a factor 10.

sym m etry results in excitation of the lowest eigenstate of the m any-body system, and thus oscillation at one wellde ned frequency. The zeroth m om ent is m₀ = 1:9928, again of order unity.

A nother example is shown in Fig. 3. The parameter choice $!_t = 1$, U = 20 corresponds to a mixed state with a rudim entary M ott insulating plateau in the center. At the present there is very little understanding of the oscillatory modes in this type of regime and little hope for an analytical approach. The results for the strength function is displayed in the main panel of Fig. 3. C learly, the strength is now spread out over many eigenstates, although the largest strength is about a factor 10 larger than the next-largest. In experiment one can expect to observe a monopole oscillation with several frequencies, if




FIG. 4: Same as Fig. 1, but here the trap and the coupling are stronger, $!_t = 4$ and U = 100. In the inset, the asterisks represent the quantum uctuations in the density m agnied by a factor 100.

dam ping is weak enough and the precision is good enough to resolve the di erent frequencies. The results of the m om ent calculation are likewise included in Fig. 3. The three m om ent-related frequencies now di er appreciably, as expected from the spread of the excitation strengths. As noted above, the m om ent calculation does not give direct inform ation about the individual frequencies that are excited but the !_{pq} lie between the frequencies of the m ost strongly excited m odes. The zeroth m om ent for the M ott-plateau system is found to be m₀ = 1:9596. This indicates that again, excitation should result in visible oscillations.

The nalexample is in the limit of strong coupling in a tight trap, U = 100 and $!_t = 4$. This system is M ott insulating [6]. Figure 4 depicts the strength function and the m om ent-related frequencies for this system. Just as in the M ott-plateau case, the strength is distributed over several m odes, which shows up as a di erence between the m om ent-related frequencies. Observe, how ever, the m agnitude of the strength function: correspondingly, the zeroth m om ent is now very sm all, m₀ = 0.0094. The reason is that the ground state for this system is a pure Fock state in con guration space, and therefore an eigenstate of the m on fEq. (2), with very sm all corrections. This is of course a m anifestation of the insulating nature of this state.




FIG.5: Properties of the system as functions of the coupling U and the trap strength $!_t$. The latter has been swept from $!_t = 0.3$ to $!_t = 4$, and and U has varied as U = 20!_t through the sweep. The topm ost panel shows the three moment-related frequencies (from top to bottom $!_{10}$, $!_{20}$ and $!_{21}$) in units of the lowest monopole frequency E₂. The middle panel shows the magnitude of the zeroth moment m₀. The bottom panelplots the quantum uctuations in local density, $n^2 = hn^2 i \ hni^2$, at the point r = 0 (solid line) and r = 2 (dashed line). The units are the dimensionless units employed throughout the paper.

The nal gure is an overview picture. Figure 5 displays the three m om ent-related frequencies in units of the low est m onopole frequency E_2 ; the zeroth m om ent m₀; and the quantum uctuations in the local density at two points, all as functions of the coupling U and the trap frequency $!_t$. The data has been recorded along an oblique path through phase space along the line U = 20!_t, where $!_t$ has varied from the value 0.3 up to 4; this way, all the

phases discussed above could be sampled. For small U and !t, the system is super uid and the density uctuations are large. The moment-related frequencies stay close to each other and to the eigenfrequency E_2 . The decrease of the density uctuations in the centerm ost well signals the transition to a M ott-plateau state, and at the same time the frequencies begin to di er, but the zeroth m om ent is still above unity. The drop in m₀ com es at the same point as the drop in the uctuations in the second o -center site; this marks the transition to the M ott insulating state. In this nite system, the M ott transition is gradual.

Reference [5] reports on an experiment that measures the response to excitation of trapped bosons in a threedim ensional optical lattice. It is found that for a shallow lattice, which corresponds to a relatively small U com pared with the tunneling strength, one narrow frequency range is excited, just as expected for a trapped condensate. How ever, for larger U, a broad range of frequencies is excited with appreciable strength. This result, which is not easily interpreted in the fram ework of Bogoliubov theory, is in fact very similar to the present ndings for a system with a Mott plateau. The drastic di erence in size, dimensionality and method of excitation forbids quantitative com parison, but the qualitative sim ilarities are there: we have seen in this paper that the rise and broadening of the frequencies is characteristic of being in the vicinity of the M ott-plateau regime.

In conclusion, the strength function for the monopole and dipole excitations of the Hubbard model in a trap have been calculated, and with an outlook to treating larger systems, the moments of the strength function have been em ployed in order to extract inform ation about the excitation strengths and frequencies. It is seen in both the mom ent calculations and the full strength function how the nite system undergoes a transition between super uid, M ott plateau, and fully M ott insulating states. It is predicted that the experimental signature of a system containing a M ott plateau is the excitation of several frequencies with appreciable strength, while a strongly coupled system will not be excited at all because of its M ott insulating nature. B ased on the present ndings, it is suggested that the broad and strong resonance found in a recent experiment [5] is due to a M ott insulating plateau in the system .
